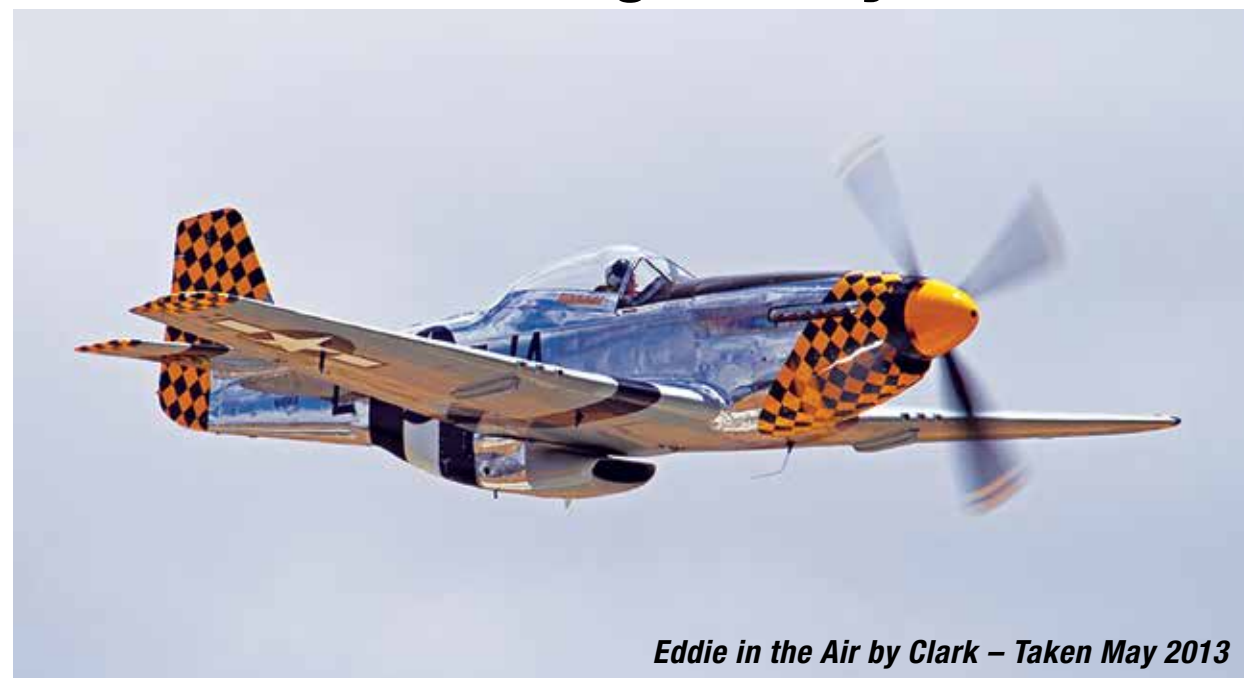

## Golden West Regional Fly-In

Golden West Regional Fly-in is gearing up for its 2016 event scheduled for Saturday, October 15, 2016, at the Yuba County Airport (MYV) located in Olivehurst. This is the second year at the time of the year that gets the event off the windy and very hot June weather period for the Northern California area that the event has experienced over the past several years.

Golden West 2016 will continue its successful stepping "back to the future" with an event that captures the old fashioned fun of a home town fly-in, with a one day event that crams, great food, education, hangar

flying and an experience geared towards introducing new generations to the fun side of aviation. Visitor participation is encouraged as the event includes a number of fun flying competitions, seminars, and exhibits with the focus on safety, education, and training.

The Young Eagles Program will be providing kids ages 8-17 with free, introductory flights to encourage their interest in aviation. This program is being conducted by members of the Experimental Aircraft Association (EAA). Pilots donate their time and their aircraft for this activity.

As part of the event,

the 5th Annual EAA Chapter Competition will be held in which Experimental Aircraft Association members from surrounding areas will bring in aircraft to compete against each other in a fun and entertaining competition. This actually tests the pilot's capabilities of handling their aircraft.

The "Drone Zone" introduced in 2015 was very successful and will be offered again. This activity is conducted within a large aircraft hangar. The public will have the opportunity to see drone racing by the Sacramento MULTIGP League and other flying activities. We will be focusing our efforts on

safety and the "Know Before You Fly Campaign" to continue to educate the public on flying model aircraft.

The Golden West Regional Fly-in will be open at 9:00 AM to 3:00 PM and is free to the public with a \$5 parking fee.

## Sutter County Wins Dismissal of Lawsuit

Filed by Former CAO, Again

For the second time, a federal judge has dismissed a lawsuit filed by former County Administrative Officer James Arkens against the County of Sutter, three sitting members of the Board of Supervisors and the county's auditor-controller.

This time, the judge said the suit cannot be refiled.

In May, former Sutter County Administrative Officer James Arkens filed suit in U.S. District Court against the County, supervisors Jim Whiteaker, Ron Sullenger, and Dan Flores, and Auditor-Controller Nate Black, alleging wrongful discharge, defamation, age discrimination, unlawful retaliation, and intentional and negligent infliction of emotional distress.

On July 25, U.S. Dis-

trict Judge William Shubb dismissed the lawsuit, but allowed Mr. Arkens an opportunity to refile certain of the allegations. In August, Mr. Arkens filed suit again, alleging constructive discharge, defamation, age discrimination, and retaliation.

This morning, Judge Shubb dismissed all remaining allegations against the county with prejudice, meaning they cannot be refiled.

"Reading the judge's ruling, it is clear there was no wrongdoing by anyone at the County and there was no factual or plausible basis for any of the allegations brought against the County, or the board members, or the auditor-controller," said Board Chairman Larry Munger. "We are very pleased with the

outcome, and looking forward to the important work we do as a Board of Supervisors."

Mr. Arkens was hired by the Board of Supervisors under a three-year contract which began in February, 2013. The Board of Supervisors announced in September of 2015 that it would not be renewing Mr. Arkens' contract when it expired in February of 2016.

"My issue with him was his management style, not anything else. I'm sorry Mr. Arkens reacted to our decision by creating a story about a conspiracy where none existed," said Supervisor Sullenger. "I'm happy the judge saw the truth of the situation."

"I have learned things usually fall apart when they have been held to-

gether with fabrications and deceit," said Supervisor Whiteaker. "Sutter County will move forward in its quest to find a new CAO that has effective leadership and vision for our County."

"It is unfortunate this claim was ever filed," said Supervisor Flores. "The employees of Sutter County are dedicated, and passionate about serving the citizens of the county. We have a great work environment where we share a common vision. We all look forward to welcoming a new CAO in near future who shares this vision."

"It's good to get these baseless allegations set aside so we can get back to focusing on the work of the county," said Auditor-Controller Black.

## Two Rabid Bat Cases in Sutter County

Two pet dogs residing in the County of Sutter are undergoing a six-month quarantine after being exposed to a sick bat that has been confirmed as rabid. The dogs' rabies shots had expired which necessitated the lengthy quarantine period. If at the end of the quarantine period the dogs are

deemed in good health, the quarantine will be lifted and the animals will resume their normal activities.

This is the second case of dogs encountering rabid bats in the past 40 days. The first case of exposure occurred between two other pet dogs and a rabid bat in

the area located between the City of Sutter and Meridian. Those dogs had current rabies vaccinations and have successfully completed a 30-day quarantine and have been released in good health.

Those owning dogs and cats who reside in Sutter County are strongly encouraged to vaccinate their animals for rabies through their local veterinarian.

## Msvl Tax Hike Smites Yuba Co Residents

Marysville City Council worked for three years to make the city a tax trap that lightened the wallets of consumers, particularly unaware travelers. The county and city were warned that there might be taxing confusion for businesses and consumers outside the city limits in Yuba County. Customers could be overcharged.

Now, just days after Marysville raised its sales tax rate to 8.5% on Oct 1, shoppers in Yuba County complained of being overtaxed by county businesses. Some say the businesses were misinformed by the state to raise the tax rate. However, not all businesses in the county charged the higher percentage.

Two years ago, a call to Treasurer / Tax Collector Dan Mierzwa to ask how the county knows the state is handling county vs. city sales taxes properly went unanswered. Supervisor Andy Vasquez then responded that the county hires a consultant to know those answers. Some may question why the county administrator and tax collector don't have knowledge of the sales tax system.

State taxing agencies have one job, collecting taxes. They can't even get that right.

Certain sales tax rates apply to everyone. However, the legislature allows counties, cities and some agencies to add additional taxes on those living or shopping in their jurisdictions. Since the state insists on a socialist system of collecting all monies, it has the task of untangling the snarl of different tax rates and then returning what is due to the proper jurisdiction.

In 2014, State Board of Equalization (BOE) member George Runner accused the Department of Motor Vehicles (DMV) of overtaxing consumers. Runner said in a letter to DMV director Jean Shiamoto, "I find it difficult to understand why your agency would knowingly continue to mischarge taxpayers when the BOE has developed an extremely accurate tool for determining tax rates at specific locations."

Runner estimated that in his district (includes Yuba-Sutter) alone more than 2.5 million Californians live in zip codes that have more than one tax rate. Unlike most transactions, the tax rate for a vehicle sale is based on the residence address provided to the DMV by the registered owner, not where the sale took place. Marysville people will pay an additional 1% on auto purchases compared to other county residents, no matter where the auto is purchased.

In response to Runner's letter, DMV staff contacted the BOE indicating a desire to respond to his concerns but warning a solution could be years away. A call to Max at Yuba City Toyota last week proved the BOE's system to be accurate. A Linda community address with a Marysville 95901 zip code was not charged the higher Marysville rate when using the BOE online program.

The fact that county consumers noticed the 1% tax overcharge is amazing. A Yuba County news release encouraged overcharged citizens to return to the merchant for a refund. The BOE told Supervisor Vasquez that their agency can return overcharged amounts to consumers if merchants refuse.

Marysville City Council hopes to collect \$1.5 million annually from the higher rate to offset plummeting retail sales within the city. Will locals change their buying habits by crossing into Linda or Yuba City to save 1%? County Supervisor Vasquez thinks so. He is advertising that shopping is less expensive in his district of Linda.

Marysville's tax trap lasts for 10 years. Consumers should think about where they are shopping and check the receipt for an accurate tax rate.



# Salmon Advocate, John McManus

John is the driving force behind the nationally known Golden Gate Salmon Association, which is a coalition of salmon advocates that includes commercial and recreational salmon fishermen, businesses, restaurants, tribes, environmentalists, elected officials, families and communities that rely on salmon. GGSA's mission is to protect and restore California's largest salmon producing habitat comprised of the Central Valley rivers that feed the Bay-Delta ecosystem and the communities that rely on salmon as a long-term, sustainable, commercial, recreational and cultural resource.

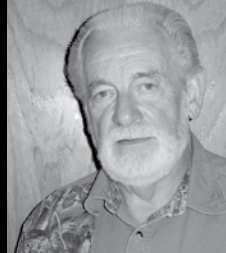
Currently, California's salmon industry is valued at \$1.4 billion in economic activity annually. The industry employs tens of thousands of people from Santa Barbara to northern Oregon. This is a huge economic bloc made up of commercial fishermen, recreational fishermen (fresh and salt water), fish processors, marinas, coastal communities, equipment manufacturers, the hotel and food industry, tribes, and the salmon fishing industry at large.

The 30 year old, 200+ members Rooster Tails Fishing Club of Northern California, Inc. is a non-profit organization that meets the third Friday of each month to educate, entertain, and enhance fishing experience. # FISHIN' TALK

We know several die-hard salmon anglers out there who will not fish, in the Feather River, with anything but a flatfish with a sardine wrap or by bouncing roe. Hello out there.....might be a good idea to throw out a spinner for a change. We have reports of salmon anglers fishing in the Feather, catching fish on a spinner. Old salts, like myself, always went with spinners in the Sacramento River and flatfish with a wrap in the Feather or of course drifting roe everywhere.

The Department of Fish and Wildlife planted catchable trout last week at Scott's Flat Reservoir which is located in Nevada County off of State Highway 20 above Nevada City. Turn off, to the right, at the Five Mile House. The road used to be gravel, but now is paved all the way to the water. Also, on the subject of planted trout, fish were also released in Lake Valley Reservoir which is located in Placer County.

While on the subject of planted trout, Englebright Reservoir has placed their trout pens in position and will be holding 2500 fish. These fish will grow until next spring, when they will be released. The fish should weigh around a pound and a half to two pounds by March 2017. Of course, this planting program is financed privately. By any means don't wait for next year to fish this reservoir. The Fall bite is underway and will be producing some nice trout for the dinner table. Brown trout are also in this body of water and can be found up into the area where the river comes into the reservoir.

The bass bite is still

on at Lake Oroville. Look for feeding fish off the steeper points and along the steep banks as they feed on smelt. We are told the bite is not as good as a couple weeks ago, but is still putting lots of bass in the boats.

Boots's fishing tip for the

week: Always fish the cut banks on trout streams. When all else fails, put a gob of red worms on your hook about 12 to 15 inches below a single split shot and just let the current place the offering in front of the fish.

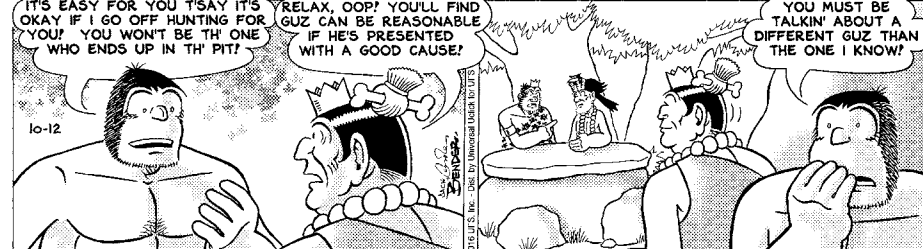

The 2nd annual Pumpkin Village will open to the public this weekend at the Colusa County Fairgrounds. Just as last year, it is free admission and free parking.

New this year, Pumpkin Village is now located on the northeast corner of the fairgrounds. "Volunteers have been preparing for the Village for several months and now the hard work is coming to fruition," said Colusa County Fair CEO Jonathan Howard.

"The giant hay pyramid is once again in place thanks to a generous donation from Shadinger Straw and Mark and Sandy Ottenwalter," said Howard,

adding that without the support and generosity of the community the Pumpkin Village wouldn't be possible.

"The pyramid is a huge draw", said Howard, "and we've added to the adventure this year with a giant spider web made of rope," he said. "We really wanted to add the web for the kids, and when Colusa County Farm Supply and T&P Huller and Sheller heard about it, they stepped up to make sure we got it," said Howard.

The Colusa County Fair Foundation has also developed an educational area for the Village, and Stueve Farms will return with its

petting zoo, pony rides, pallet slide and more.

A big draw last year was the face painting by Terry Stephens. She is coming back courtesy of Central Valley Gas Storage.

New this year is the Pumpkin Vine Raceway sponsored by Redding Oil & Superior Tire Service which features peddle kart racers in various sizes to fit the whole family. There are also new tomato-shaped train cars sponsored by Morning Star.

"We were really surprised last year when one of the biggest attractions turned out to be the corn kernel-filled sandbox," said Howard. "This year Western Milling will be donating the corn kernels."

The hay wagons are also back for trips to and from the newly added corn maze. The corn-cannon is back and ready to shoot corn over 100 yards, also if you enjoy shooting, there will be a paintball shooting gallery this year.

Without pumpkins there would not be a Pumpkin Village. Pumpkins are still only \$5 and all of the pumpkins were graciously grown and donated by the Etchepare Family. Sun-sweet provided the trailers to haul the pumpkins to the fairgrounds.

A lot of attractions from last year are returning in addition to many new attractions. Howard said that this has been a real community effort, and he is looking forward to another great year.

Almost 50 draft horse exhibitors – traveling from California, Oregon, Nevada, Idaho and British Columbia – competed for approximately \$30,000 in premium awards. The competitions took place during six performances over the four-day event.

The winner of the Ultimate Hitch competition was David and Patsy Cunningham of Meadowlake Belgians, from Carlton, OR.

Audrey Popoff of Unhitched Ranch, from Colton, CA was recognized as the outstanding lady driver for the third year in a row, accumulating high points to win the Susan Parnell High Point Perpetual Award.

The Teamster of the Year Award was presented to Mike Lorenzini, an honor bestowed upon him by the voting of his fellow team-

## Tip Receives State Peace Officers’ Award

Yuba-Sutter’s Trauma Intervention Program (TIP) received a Certificate of Appreciation from the California Peace Officers’ Association (CPOA) on October 3rd at the annual COPSWEST 2016 Conference in Sacramento. TIP was recognized

“for an action or service enhancing the image of the law enforcement profession.”

CPOA represents the entire spectrum of law enforcement, patrol officers to executives from 530 agencies in California. These include police and sheriff departments, highway patrol, campus police, regulatory agencies, specialized enforcement and the private sector.

TIP was submitted for recognition by Commander Shon Harris of the California Highway Patrol “for their support and services to victims, their families and first responders.”

Others recognition categories were Awards of Distinction for innovation in policing, Outstanding Cold Case, Outstanding Canine Capture, Awards of Valor, and the Sherman Block Law Enforcement Professional of the year.

Awards of Valor were presented to officers involved in three incidents. A CHP officer held onto a suicidal man hanging from a freeway overpass until help arrived. Four Los An-

geles County Sheriff Deputies were recognized for rescuing hostages held by an armed suspect. And, 8 officers from Redlands Police Department, San Bernardino Police and County Sheriff’s Department were honored for bravery while under fire from the suspects in the Inland Regional Center’s terrorist attack.

TIP has 15 regional chapters serving more than 250 cities. Yuba-Sutter TIP was established in December 1994 and has the highest per capita response rate of all chapters. Yuba-Sutter TIP has responded to nearly 10,000 requests for service since its inception.

TIP serves all first responders in Yuba and Sutter Counties, as well as Rideout Hospital. TIP is a nonprofit organization staffed by citizens trained to respond to 911 emergencies 24-hours-a-day, 365-days-a-year, arriving within 20 minutes of dispatch. ## The Events leading up to the 2005 Agreement between South Feather Water and Power and North Yuba Water District

North Yuba Water District (formally Yuba County Water District) was formed by legislative process on July 17, 1952. The original office was in Rackerby, California. The mission of YCWD was to provide agricultural water to the farms and ranches in the North Yuba Foothill Communities with the district’s boundaries.

About the same time during the 1950’s, four water districts, Oroville Wyandotte Irrigation District, Yuba County Water Agency, Yuba County Water District and Browns Valley Irrigation District were competing over water rights in the Feather/Yuba River Watershed.

Also, as a result of the 1955 Flood event on the Feather River, the land owners of Butte County decided to invest into a series of dams and power generating plants on the Feather River, an agreement with PGE and OWID to finance the project, with a 50 year bond repayment. This engaged Yuba County Water District and Oroville Wyandotte Irrigation District to agree to a series of contracts that were negotiated and formally signed in 1959. The 1959 agreement was negotiated between both districts to guide the use of combined water and power generating rights on both the Feather and Yuba River for 50 years until the bonds were paid off.

Yuba County Water District would have 3700 acre feet of water to serve their customers and Oroville Wyandotte Irrigation District would have 3720 acre feet of water to serve their customers. Additionally, YCWD has 4500 acre feet of water that was available at Kelly Ridge at an elevation of 450 feet on the Feather River. The maintenance of the Forbestown Ditch was split between both districts with OWID responsible for 75% and YCWD responsible for 25%. Net Power revenues were split between both districts with OWID receiving \$49.00/acre foot and YCWD receiving \$7.00/acre foot for power generation from PGE.

It was also agreed that the first \$1,000,000 in power revenues received by YCWD would be used to construct the Dobbins/ Oregon House Canal to convey irrigation water to the farmers and ranchers of these communities.

At the same time, OWID was serving raw water to their Forbestown Customers via the Forbestown Ditch. Because of the close vicinity of home septic systems, there was contamination of drinking water. Instead of OWID building the Domestic Water Treatment Plant in Forbestown, YCWD built it at the expense of the people in Oregon House/Dobbins. The canal was not built and the remaining Funds of the \$1,000,000 were used to purchase the first of a series of parcels that would eventually be called the New York Flat Reservoir properties.

In the early 1960’s, Yuba County Water Agency, also as a result of the 1955 flood event and the need to serve Yuba County Agriculture initiated the North Yuba River Development Project. This would be a series of dams and power generating plants along the North and Middle Fork of the Yuba River. As YCWA began this project, the DWR and the Federal Energy Regulatory Commission required additional water to be acquired to build the large concrete arch dam known as Bullards Bar. YCWA came to Yuba County Water District with a proposal to build the New York Flat Reservoir for Dobbins/Oregon House in trade for our water rights on Canyon Creek. Canyon Creek’s headwaters begin above La Porte and flow south into the North Yuba River above Camptonville on Hwy 49. The amount of water from Canyon Creek can be up to 300,000 acre feet/year to as little as 35,000 acre feet/year depending on snow pack and rainfall which enters the Yuba River and is stored in Bullards Bar Reservoir. Unfortunately, by time the North Yuba River Development project was constructed, there were no funds left to build New York Flat Reservoir for the people of Dobbins and Oregon House. The storage capacity of the New York Flat Reservoir was 14,000acre feet. The Yuba County Water Agency agreed to store the 14,000 acre feet in Bullards Bar for future development by Yuba County Water District.

To make matters worse, NYWD tried to float a bond measure to pay for the construction of the New York Flat Reservoir but it failed terribly. Several NYWD directors campaigned successfully against it because it would encompass the entire district in bond repayment for 50 years to serve the communities of Dobbins/Oregon House. Also, after NYWD was not able to put the water right on New York Flat to beneficial use, the Department of Water Rights took our water right away and now it is held in abeyance.

In 1977-78, there was a devastating drought and there was a moratorium placed on any further irrigation customers being served from NYWD. With the price of \$7.00/acre foot that NYWD was receiving from the South Feather Power Project, I petitioned the board to allow additional irrigation customers to come on board. Successfully, we were able to add 30 new customers to the irrigation system, each receiving .5 miners inch of water. Also, a customer Vinje, whose water was being conveyed through a drop in the canyon and wasting up to 10 miners inches of water to deliver 3inches. The Vinje Pipeline, a private pipeline, was installed that not only saved water, but an additional twelve new customers were added for the water that was being wasted.

In 2002, OWID protested our sale of water to Yuba City. This action is what eventually lead to the SWRCB ordering both YCWD and OWID to settle their differences and decide how in 2011, we would operate the South Feather Water and Power Project that we would both be 50% partners in net power revenues. In 2003, negotiations began with OWID/YCWD. YCWD was at a serious disadvantage since we were operating without a manager. Alan Lily, our Water Rights attorney, Director Olson and Director Cavaliere worked relentlessly to negotiate the best contract with OWID. Up to 2010, PGE paid for all the maintenance and repairs on the dams and power plants. After the new 2005 agreement would take place, OWID/YCWD would be 100% responsible for maintenance and repair. Additional, both districts had to agree to a reservoir operation plan, each district had to have a water conservation plan in place, and each district would be equally responsible for the FERC Relicensing of the project.

By this time OWID changed their name to South Feather Water and Power and shortly afterwards, YCWD changed our name to North Yuba Water District. The water rights of each entity were negotiated. SFWP would have 23,720 AF and NYWD would have 23,700 AF of water to put to beneficial use. SFWP transferred their water right permit 11518 which gave NYWD an additional 15, 500 AF of water and the water permit on Orleve Creek. NYWD would be 100% responsible for the repairs and maintenance of the Upper Forbestown Ditch and we would be responsible for the losses of water. The power revenues were calculated using historical rainfall for a period of 30 years. Within the first 3 years of operation after 2010, both NYWD and SFWP were to meet a contribution of \$7.5 million dollars to fund a contingency fund for operation and maintenance of the Power Project. The contingency was funded the first year, 2011. We had record rainfall and snow pack and both districts contributed \$7.5 million dollars the first year. Also, the revenues projected would have amply covered the cost of piping the Upper Forbestown ditch.

Unfortunately, the perfect storm hit. Hydroelectric power revenues are based on natural gas prices. Fracking has severely affected the price of natural gas and the power revenues were decreased. But more dramatically, the drought event of the last four years has severely affected the amount of water that is available to be used for power generation. Despite the drought, NYWD receives \$709,000 annually plus in 2013, received an additional \$303,000 and most remarkably, in 2014, received over \$2.2 million dollars in net power revenues.

Folks, in closing, all we need are one good year of rainfall and snowpack in the mountains and we will have enough money to build our pipeline.

In the meantime, I hope there are enough forward minded folks in our district that see the need to move forward now with a reasonable loan to get our pipeline in to convey clean, reliable water to our domestic customers and deliver enough agricultural water to Dobbins and Oregon House for today’s customers and the needs of the additional over 1500 annexed customers who have paid taxes for over 50 years who desire and deserve service from North Yuba Water District.

### BONDS

Bonds are IOU's. You loan someone their money and in return you get the IOU (the bond).

They have infinite possibilities as to the terms which states what you get back, when you get it back, what collateral (if any) you may have, any interest rate you may get and just about anything else one might see fit to include. The most common bonds are issued by sovereign governments, states, municipalities and corporations. They can be

insured or otherwise.

Unlike stocks, bonds are what I call linear investments.

Where stocks can rise or fall as they have no "face" value and investors can lose money based on that movement, bonds have a definite face value.

A \$100 bond always states \$100 as its face value. If an investor sells a bond before its maturity date (the date it is paid), the actual price one can sell it for can rise or fall. If an investor keeps the bond until it matures, the face value is what is paid. A \$100 bond will pay \$100. Any interest one might make (known as its coupon rate) can be paid throughout the bonds life (like yearly or otherwise) or it can be paid all at once when the bond is paid.

I call them linear investments because the face value of the bond remains

the same, and if the bond is held to maturity, this value does not change unlike a stock price which can change daily. Stocks have no face value printed on them unlike a bond which does.

The end result from owning a bond is you either get paid or you don't which is why I call them linear. Its value is a straight line. \$100 in equals \$100 out assuming you get paid of course. An issuer of a bond that can't pay is said to be in default and the investor can lose his money. The reason for default would likely be lack of funds. They borrower simply does not have the money to pay. If the bond goes into default, many things can happen, most of them bad.

The issuer can offer to renegotiate the bond and partially pay what it owes whereby the investor gets only some of his money back or the bond can be rolled over which means the maturity date is re-drawn to a later date by issuing a new bond with a new maturity date and perhaps new terms and conditions. A flat out total default means the investor gets nothing. If the bond is insured the insurer would be on the hook for the payment. If not, the investor might seek relief by way of the judicial system or wait in line if the borrower declares bankruptcy which on a defaulted issuer is highly likely if it can't renegotiate with its bond holders.

Bonds are commonly referred to as fixed income investments which means their yield can be somewhat predictable unless the bond terms are broken by the issuer. Bonds can be a way to diversify a portfolio and provide a source of predictable income.

As in most investments bonds have inherent risks. Investors should read the prospectus and financial sheets of the issuing entity, understand completely the terms and conditions of any debt instruments they are considering and consult an investment professional before investing.

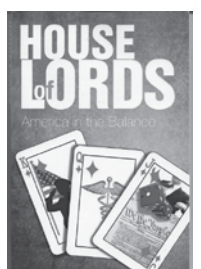

## Something's Rotten in Marysville

There is a foul odor emanating from Marysville - and it isn't coming from Ellis Lake.

The process to award two medical cannabis dispensary licenses was supposed to offer a level playing field to every applicant. However, David Lanza angrily proclaimed at a recent City Planning Meeting that "we had a deal" when his building was deemed out of compliance with the required setbacks.

Allegations are flying that Lanza was assured his building would get one dispensary license for funding the city's 1% tax increase measure. We still need to uncover why the Carpet Galore building was given favorable treatment. If it is true that the fix was in for both of these permits, did the city commit fraud by accepting \$3,706 non-refundable processing fees from multiple applicants who did not have a chance of being awarded a permit?

The whole process has been tainted from the beginning. A "medical arts" district was created where the potential dispensaries could be located (with extremely relaxed setbacks compared to the rest of the city). The map was revised three times to favor the two pre-selected applicants and to crowd out everyone else. The only problem is that they were so over-zealous, neither of the two pre-selected buildings qualified either.

An exemption was made for the Carpet Galore Building to qualify. The city granted permission to tear down the existing building and subdivide the lot so the back half meets the setbacks. This was arranged and approved BEFORE the permitting process even began.

Renovations at the Cargill Building, the property owned by David Lanza, are proceeding at break-neck speed despite the fact that they have been

turned down twice by the planning commission or that no permits have been issued to anyone yet. He is pushing hard for a variance that will favor his building and, more than likely, he will get it.

Worse, the applicants for both dispensary licenses are from out-of-town - one is even from out-of-state. Why does this matter? Because the lion's share of the profits made off of patients in our community will flow elsewhere rather than recirculating throughout our economy. Their incentive will not be patients' welfare, it will be to make as much money as possible. Making bad deals that benefit outside interests is one reason Marysville is on the verge of bankruptcy.

Then there is Measure F designed to tax the dispensaries at 15% and cultivation at \$25/square foot. The tax is to ensure any business engaged in medical cannabis pays their "fair share" of taxes. This is in addition to a 15% excise tax and \$9.25/ounce on dried flowers imposed by Prop 64, 7.5% state sales tax, and federal tax. Businesses will also have to secure very expensive local and state licenses, and various state agency permits.

Mayor Ricky declared that the City of Marysville was only interested in allowing medical dispensaries to alleviate the suffering of patients (although the ordinance allows for medical and recreational use). Prop 215 was created to ensure patients have safe and affordable access to medical cannabis. The upshot of all these taxes and fees is that it will have the unintended consequences of driving patients into the black market, and by being greedy, the city will end up realizing less tax revenues.

Furthermore, none of the tax money is des-

ignated to any specific purpose and can be spent wherever the city sees fit. It is likely that not one red cent will go toward reducing existing debt, and instead will be squandered on administration and enforcement.

This process needs to come to a screeching halt and we need to go back to the drawing board to devise an equitable plan. A FOIA needs to be filed that will reveal who David Lanza made his deal with and what it entailed, and if collusion is found, his building should be ruled ineligible and possible legal action should not be ruled out.

For these reasons, I urge you to vote no on Measure F and Prop 64.

Chancellor Houston of the Yuba Community College District is now asking For Authorization to fund a new \$33.5 Million bond through Measure Q on the November election ballot. The latest \$27.5 Million bond issuance under Measure J was just funded in March 2016 and hasn't even hit our property tax bill. You are asking for a new bond source to add to our already increasing tax bill, when not all of the money authorized under Measure J has yet to be funded. There is \$32.5 Million still available under Measure J to fund your mismanaged budget items. There is a reason that Measure J had a limit placed on the max amount you can tax us, we don't want to pay any more than the \$25 per \$100,000 of assessed value for the next 40 years. The money is there, you just have to wait until the value of our property increases to precession assessed values. I know it is easier to just keep asking for more money from the taxpayers instead of doing your job and budget with the \$157.5 Million we have already given you so far from Measure J. We have to wait and so can you. Vote NO on Measure Q.

## Gallagher's Water Bill Signed Into Law

AB 2551 will speed up construction timeline and save taxpayer dollars

Sacramento, Ca.

The Governor signed Assemblyman Gallagher's Assembly Bill 2551, a bipartisan measure that will help build crucial water storage projects like Sites Reservoir and Temperance Flat Dam, by allowing these projects to utilize alternative delivery methods during construction.

"Californians are frustrated that no new major water storage project has been built in decades. This bill will advance projects like Sites Reservoir which helps ensure that our cities, small towns and farms have access to a reliable supply of water," said Gallagher. "After several disappointments this legislative session, it's refreshing to help bring home a win for the North State."

With the passage of this new law, Sites Reservoir and two other major water storage projects will be able to utilize cost effective construction methods like design-build and construction management

at risk.

"AB 2551 is a major step forward for building desperately needed surface storage projects like Sites Reservoir by giving us flexibility in delivery methods that have the potential to reduce costs, save time, and ensure quality work," said Jim Watson, General Manager of the Sites Project Joint Powers Authority.

Even in 2015, an extremely dry year, Sites Reservoir could have captured an additional 660,000 acre-feed of water, enough to supply a million households for an entire year.

North State's Senator Jim Nielsen (R-Gerber) said, "This law will help ensure the promise made to the people of this state when they passed the Water Bond. It will help expedite the funding and construction of storage projects like Sites Reservoir."

Kim Vann, Chair of the Sites Project Joint Pow-

ers Authority has also expressed her support for this legislation, "On behalf of the Sites JPA, I would like to offer my sincere appreciation to Assemblyman Gallagher and Senator Nielsen for introducing this measure and working so persistently to ensure its passage. AB 2551 will reduce the cost of construction by millions of dollars while also dramatically speeding up the project timeline."

In November, 2014 Californians overwhelmingly passed Proposition 1, the Water Quality, Supply, and Infrastructure Improvement Act of 2014. This water bond included \$2.7 billion in funding for water storage projects. However, current law severely restricts the types of contracting public works projects may utilize. This could slow down construction and increase costs of crucial water storage projects that receive this funding.

## Food and Farm News

### Forest tree mortality brings ecological risk

The number of dead and dying pine trees in California forests could bring a conversion to chaparral habitat in the Sierra, experts say, leading to increased risk of wildfire and other implications. Millions of trees have died in recent years due to drought and beetle infestations, and analysts say shrubs could move in where trees have died. A California Forestry Association specialist says a "massive effort" will be needed to reduce fuels and replant trees.

### Rural tourism creates a balancing act

Autumn is a popular time to visit pumpkin patches and other such destinations, and the success of countryside tourism has led to a balancing act in some

California locations. As more people seek to visit rural areas, requests have increased to build event centers, wedding venues and other projects on agricultural land. A California Farm Bureau spokesman says it supports agritourism, but that building non-agricultural projects in the middle of farmland can bring problems.

### Forecasters predict more apples, fewer pears

You may pay a little less for apples and a bit more for pears this autumn. Orchards in Western states will produce more apples but fewer pears, according to a report from the U.S. Department of Agriculture. In California, the report predicts apple production will rebound by 44 percent compared to last year, whereas the total

pear crop will be down slightly. The average American eats about 17 pounds of fresh apples a year, and about two-and-a-half pounds of fresh pears.

### Cattle help breweries dispose of byproducts

As the number of California micro-breweries has grown, so has the accumulation of brewing byproducts. Disposing of those byproducts can be costly for breweries. But one of the byproducts known as "wet brewer's grain," can be fed to cattle. Later this fall, researchers will start a third year of testing with cows at a research center in the Sierra foothills, adding wet brewer's grain to their feed. So far, researchers say, the results have been promising.

## Area Jewish Settlers – 1849-1880 by Carol Withington



**Note: Over the following months, a "thumbprint" overview regarding Jewish pioneers who settled in our area will be presented. The time period will cover only 1849-1880. It is hoped that other researchers will expand on the information given. So, let's begin--**

### THE ARRIVAL

When news of the California Gold Rush reached the East Coast, many Jewish families looked to the American West as the "promised land".

Communities near the mines along with farming opportunities were quickly developing in California. Many of the Jewish settlers had left Central Europe during 1848 due to various revolutions. In addition, a "new economy" with its modernization began to disrupt the livelihood of small craftsmen such as merchants, seamstresses and tailors. Now, these gold-mining communities would open up new opportunities with even less competition.

Many Jewish migrants arriving to the West were extremely mobile--first settling in the East before actually taking roots in a community. According to research, close to 6,000 Jews joined with others in this quest to California during 1849-1854. In addition, an estimated 100-200 set up businesses and residences in the Yuba-Sutter area, primarily in Marysville.

Statistics indicate that approximately 17 percent of these Marysville settlers were originally from Prussia, followed by such countries as Germany, Poland, France, Austria, England, Sweden, Bavaria and Russia.

Among this active Marysville Jewish community were merchants Nathan Schneider, who established Schneider's Clothing in 1862 advertised as "the Home of Value"; and Isaac and Simon Glazier who opened the Old Corner Cigar Store on Second and D streets from 1851-1862. Philip Brown also advertised himself as "Marysville's leading tailor with his own specialty--White Labor Overalls" during this time period.

In addition, Jonas H. Marcuse founded the Western and Palace Cigar Store, and Union Lumber, established in 1852 by W.K. Hudson and Samuel Harryman was later purchased by H. J. Heim.

The mining community of Timbuctoo in Yuba County also included William Taklas who worked for his elder brother Marcus (Max's) clothing business as a trader. Other Jewish settlers in Marysville were Abraham Abraham clothing merchant; Henry Barnett, auctioneer; and Hiram Brown, tailor.

While some Jewish settlers permanently stayed in the area; others remained for a limited time before moving on the other communities. Among them were Julius and Fanny Brooks, who arrived in Marysville during the spring of 1855. At that time, Julius opened a general merchandise store.

It appears Fanny's brother Max Brooks had already settled in Yuba County and was an active member of the Marysville Hebrew Benevolent Society.

According to the October 25, 1856 Marysville Weekly California Express, "seventy couples assembled at the Marysville City hall to hold a dinner dance to benefit the Hebrew Benevolent Society. The local paper described the event as follows: "The music was exquisite. . . Never has there been a Ball in our city, where so much pain was taken, and with so much success to make each feel that he was a favored guest".

Over the next few years, Fanny gave birth to three children. Amelia, the oldest, died at age one and a half and was the second child Fanny had lost at a young age. In 1858 the family moved to Timbuctoo where Julius bought mining claims and opened a store selling such items as clothing, shovels, nails, pickaxes, tobacco and groceries. Their third child Eveline was born at that time.

Finding it difficult to make a living in that area, the family moved back to San Francisco. But still they wanted a place to put down roots. In the 1860s, the Brooks family moved once more. This time it was in Salt Lake City. Here they found success, eventually becoming the first Jewish settlers in Utah. While in Salt Lake City, Fanny kept boarders, ran a business and encouraged her husband to go into real estate. Over the years, the Brooks family became prosperous merchants and landowners.

Another individual who would settle briefly in Marysville was Prussian-native Edward Abraham Kusel. Born in 1824, Kusel came to America in 1852, first arriving in New York. He traveled West with an ox team to Placerville, first settling in Sacramento

where he worked as an upholsterer for a furniture shop. He then arrived to Marysville where he made canvas hose that was used for mining.

In the mid 1850s, Kusel became interested in photography, opening a gallery at 70 D Street where he sold ambrotypes and photographs printed on both paper and leather. During that time, he married Bertha Herlbronner. Their son Carolus (Carl) was born in Marysville in 1857.

Kusel later moved the family to Oroville where he continued selling both canvas hose as well as photography. In 1859 he opened a gallery on Broadway in Chico but also maintained the Marysville gallery. In addition, he set up a gallery in Sacramento where he sold Sun printing, ambrotypes and solar portraits.

Around 1870, Kusel sold all his galleries and opened a stationery and cigar shop in Oroville. Over the years, he became a prominent citizen in that city, exhibiting leadership in both the Jewish community and the community at large.

Both Jonas and Meyer Marcuse would also gain such prominence in Sutter and Yuba Counties.

Almost immediately after the Governor of California signed the Medical Marijuana Regulation Safety Act (MMRSA) bill package in 2015, county cultivation Bans swept across the State. Is this coincidence? Could this have anything to do with the attempted corporate takeover of the cannabis industry?

In order to block big business and the Teamsters Union while preserving small local farms, some counties are already reversing their bans and enabling county permitting. This creates more incentive for other counties to adopt a permitting program that enables local citizens to acquire cultivation and distribution licenses. In the past, the Sheriff of Nevada County has spoken about Nevada county migration which was his argument for enacting a ban there. The theory was that surrounding counties with bans would funnel the growers to Nevada County as they sought refuge. Now this theory describes the migration of illegal cartel criminals seeking refuge in counties with bans, while fleeing from counties that are gaining massive regulation funding from permits. In counties lacking permitting and regulation, criminals are sure to bring environmental destruction with them.

No one wants to see small local businesses destroyed by

big business corporate interest. The best way to stop this is by allowing the small local businesses to gain permits and licenses and be allowed to favorably compete with the likes of Monsanto, Pfizer, Southern Wine & Spirits, and the Teamsters Union. It's up to the Counties to choose who they rather see running the farms because there is no stopping the California cannabis industry which is estimated to reach a thirty five billion dollar value by 2020.

Is local government declaring they favor big business corporate farms more than small locally owned farms?

Ask your County elected Board of Supervisors (BOS) what

their plan is to control an escalating epidemic assaulting our Community!

Did you know it is estimated that \$160 Million a year flows into our local economy because of our local Cannabis? What is our BOS plan to replace this eroding local revenue source with their Ban?

Regulation will bring and legitimize 100's of good paying jobs to Yuba County. What plan do the BOS have for 100's of new good paying jobs, new tax/fee/permit streams and boosting our economy?

Did you know 70% of every dollar that is spent with Local Businesses stay in the Community?

Along with any sensible regulation of a crop come licenses and permits, paid for by the farmers, that provides the money for enforcement of the regulations. This will keep tax payers from having to pay for enforcement and reparation of criminal or destructive acts. Billions of dollars could be saved state wide and untold millions in small counties.

An extensive 2013 report from the University of California at Berkeley and Botek Analysis Corporation also found cannabis cultivation posed no greater environmental risk than any other California crop. The study notes that the best thing for California's waterways and environmental well being would be to regulate cannabis

production, thereby decreasing the number of "damaging practices by criminals and unregulated parties."

The Nature Conservancy of California also expressed concern for the environment stating "California needs to act swiftly to regulate." Then they suggested, "Marijuana growers should be responsible for any environmental damage they inflict."

The Nature Conservancy of California believes that Marijuana is the biggest cash crop in California with a value of roughly \$16 billion. 2018 legal California sales is projected at 4.4 billion while US box office movies average 3.5 billion annually.

California Department of Fish and Wildlife has only enough resources currently to inspect less than one percent of estimated cultivation sites. Prohibited keeps environmental damage from being properly regulated while wasting tax payers money. Crime and environmental damage MUST be regulated but requires a different source of funding.

Sensible regulation is the only thing that will redirect the money to local governments, communities, and tax paying farmers while cutting the financial legs out from under black market cartel and criminals.
