The Pink Tractor by Rod Hisken

This 1945 Ford 2N tractor was originally donated to the Alcouffe Center in Oregon House for auction by the Ferguson Family. The condition was not great and I had some doubt it would bring much money. As a cancer survivor, I wanted to say Thank You to those who helped me through the ordeal. Additionally, I became convinced that conversation about cancer is part of the healing process. The tractor was donated just a few weeks before the Vintage Tractor Days celebration in Oregon House.

I began telling my tractor buddies about my goal and sixteen friends immediately jumped in and started the restoration process. Jody Stover of Grass Valley, Rick Lopez of Loomis, and Paul Gaide of Orangevale took off two weeks and they spent very long days to have the job complete by the show. The Pink Tractor paint still smelled after it was unveiled. The audience present oohed and ahaad at the creation. I practically cried.

Les Schwab provided tires, Martin Auto Color supplied paint, Superior Radiator cleaned the gas tank and radiator many other businesses and people helped.

Tickets for the raffle were sold for a year. The Little Pink Tractor was on TV, in newspapers, the subject of conversation on radio and was present at many functions including a Black Tie Dinner. Ticket sales accrued over \$20,000 with half going to The Alcouffe Center and half went to the American Cancer Society. The tractor was won by a lady from Grass Valley. About six months later she called me and wanted me to buy the tractor back so its continued use in cancer attention functions could go on. I built a two tone pink hay ride wagon and she and her mother, a cancer survivor, sister were among the group on the trailer during the Penn Valley Rodeo Parade. The pair are still used to haul cancer survivors in functions.

The Pink Tractor is more than a cute tractor to my wife and I. It has taken on a spiritual aura for us. I will share a couple of stories. I showed the tractor at the Pre - Thanksgiving Parade in Loomis and during the parade four nuns in full habit came out into the street and blessed the Little Ford! After the unveiling, I was being asked by many people to take the tractor many places. My Grandson broke the axel on his Jeep so I hauled it to Grass Valley for him. I decided I needed a ledger to write down all the requests. I stopped by the KMart to buy a book. I asked the clerk and we found nothing that fit. All of a sudden I said, " Let's go over there ". I pointed to a place in the store. Up on arrival at the spot at eye level, the shelf had a two tone pink planning book with a cancer logo on it! I am not a regular church goer, but I became more convinced God works in mysterious ways.

The 2N Ford was made from about 1942 to 1947. The 9 N was downgraded during WWII to reduce the amount and type of materials being used. it had a crank start, iron wheels and no lights were allowed. The sales price was in the range \$1,100 and up. The three point hitch could lift 800 pounds. It weighed a little over 3,000 pounds. The little engine produced about 12 horsepower on the drawbar and 23 was claimed on the pto. The tractor was very popular with the women who did most of the farming during the war. The N series Ford was the largest selling tractor in North America.

Pink October begins

Pink October started in 1997 as a single 5K Race for Awareness. It has grown into 8 events (6 of which are in October). A large part of the outreach are low-cost mammograms and health screenings. The foundation has helped pay for utilities, rent and mortgages, even funeral expenses. over 350 women have been helped, not including the countless women who have benefitted from the top-notch imaging equipment in the Yuba-Sutter community which the Foundation has been blessed to make large contributions towards.

The Tamale Man

Bureaucrats claim their regulations help people. However, most rules are paternalistic meddling that costs businesses and consumers a fortune.

Rules cops patrol the streets insuring people conform. "This is too big, too far away, the wrong color, not permitted."

In Marysville, the tamale man shouts "TAMALES!" They are hot, tasty, and door to door. A friendly old man, he walks slightly stooped with a limp. A pleasant woman may be alongside and occasionally a young boy does some legwork. Tamale man is a good communicator though speaks no English.

Sadly, his days are numbered. In Marysville, a transient can defecate in your yard or sleep on the sidewalk, but the tamale man is the real law breaker. Learned government workers with handsome salaries are here to save us from this unschooled threat. There are many rules in this town if you want to earn a living, but few if you don't.

The tamale man is out of compliance. He can't even spell compliance. Most bureaucrats can't spell either, but they rule over the tamale man and us.

The tamale man sells to pay his bills. To his government- adversaries he is the enemy, an enemy to order, to rules and now a competitor to all the other tamale men that joined the system to stay in business. They had to rent buildings and pay the government to sell tamales.

Everyone must be kept in line by agencies and pay for protection. It's the mafia minus the accent.

Business people keep their mouths shut lest the man arrive to discover some problem jeopardizing their business investment. "Did you know this sign is...the doorway is...You can't sell that here. That permit is to be posted over here, not over there. Take that banner down. That's not allowed here."

The tamale man is a symbol of all that is wrong with a government- gone - wild. However, it wasn't always this way.

In about a century, early America became the most prosperous nation on earth. One major factor was that settlers benefitted from a century of benign neglect by their European Monarchs. Hardworking, personally sacrificing immigrants like the tamale man were free to invent, launch businesses and new products like no other country.

There were laws against theft, fraud and such, but few regulations and nearly no bureaucracy. The colonists knew no such freedom in their former land, but now were living an ocean away by slow boat from Monarch micro-managers. Business was booming.

Today, Americans are regulated, harassed, and nitpicked to death and their stuff afterwards. They still own their enterprises but government controls and regulates them. President Ronald Reagan called this fascism.

Many bureaucrats make their own rules on top of ordinances. Theses rule-pushers are powerful, not as individuals, but because of their authority to ding citizens.

Few business people have the time to verify what they are told. Is it lawful or is this requirement an arbitrary mandate of a city manager? If there is no compliance, there are fines, a costly standstill, or no permit.

Businesses learn how to play this game by offering gratuities and bribes to government officials to be left alone. Overregulation begets corruption.

Washington Market's Kairam Kumar in Yuba City says, "I work long days, take a nap, and then do it again. My three kids are in college." He says his biggest problem is government.

Though he has a license to sell alcohol his customers can't buy a 16 oz. beer from him. The city says so. His competitors can sell 16's.

The 'sandwich board' on the curb must go, but the state lottery sign can be curbside. Kumar can't be a good neighbor to the medical clinic next door by hanging their banner on his fence. The promo-ads attached to his storefront posts are forbidden but his competitors have them.

This government makes it easier for people like tamale man and Kumar to get welfare, food stamps, Section 8 housing, and disability payments than make a living.

The tamale man must obtain a business license, health certificate, proper signage and cart, tax ID number, fictitious name statement, bank account and pay sales taxes. What about the packaging? That's all wrong. And, who prepared those tamales?

The tamale man will be the next notch on the code enforcer's belt. The code enforcer was born and educated to bust tamale man. That's his noble contribution to humankind.

To those earning a living the whole situation stinks, but bureaucrats say "What smell?"

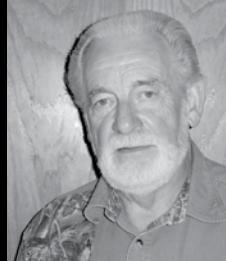

We are back from the hunting/fishing trip. We camped at Domingo's Springs above Chester. Fish were caught in Lake Almanor where Hamilton branch creek enters the lake. The rainbow trout averaged 14 to 16 inches. My attempt to put a couple brook trout in the pan for supper failed. The brookies were not interested in any of my flies. **Carl Malotte**, who lives in Lincoln, accompanied us and camped with us to fish while we hunted. He put all to shame with his **beautiful four and a half pound rainbow trout** which he caught trolling in the East Basin. Carl was trolling with his favorite set up which consists of a small flasher above a power bait/night crawler combination. The big fish, which measured a hair over 24 inches, hit while he was top lining about three feet down around 8:30 in the morning. Carl advised the trout swallowed the whole rig except for the blade. He also advised there were hundreds of minnows swimming all over the lake. These little fish, approximately one to one and a half inches long were probably chub or shad minnows. **See the photo on this page.**

Reports from the bay area tell us the salmon run will be a good one this year. The Feather and Sacramento Rivers will surely produce outstanding results due to the water levels this year. We hear from Lake Tahoe. The kokanee bite is slow but the mackinaw lake trout were hitting at both South Shore and North Shore. Fish were ranging from 2 to 8 pounds with the best bite being early morning. Anglers were having luck trolling and also mooching live minnows. Best bet is to start out at first light in around 120

to 140 feet down. Once the sun hits the water fish were being taken all the way down to over 400 feet. Following the constantly moving fish is the key.

The Department of Fish and Wildlife planted trout in Shasta County in both upper and lower Burney Creeks and in Upper Hat Creek. The only other county planted in the Northern part of the state was Siskiyou, with plants in Antelope Creek, Butte Creek, Orr Lake and Siskiyou Lake.

While we were camped above Chester the news around town was that Eagle Lake has really slowed down on the bite.

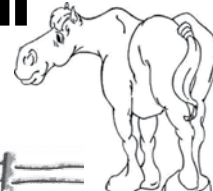
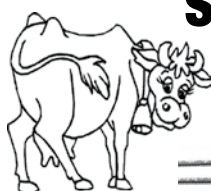

Things to Know Before Boarding the Haunted Paintball Hayride

Tickets for the Haunted Paintball Hayride at the Colusa County Fairgrounds are on sale now at the fair office, and online at www.colusa-countyfairgrounds.com.

Last year's Hayride was sold-out every night, so this year's event will have extended dates and hours.

The 20-25 minute ride will run from 7 pm to 11 pm on Friday and Saturday nights beginning September 30 and continuing every weekend through October.

Colusa County Fair CEO Jonathan Howard said that tickets are going fast, and to ensure a place on one of the specially equipped paintball wagons, patrons should purchase tickets in advance. "We just can't guarantee a place on a wagon if reservations aren't made before the event," he said.

There have been some changes made to the route of the ride this year, but some things remain as they were last year.

Howard said that answers to frequently asked questions (FAQ's) about the event can be found on the website, but that there are a few pertinent questions he'd like to answer.

"There seems to be a misconception that paintball shooters run on foot looking for targets," he said.

"Actually the shooters ride on wagons equipped with mounted paintball guns. Patrons riding the wagons are never targeted and will not be shot with paintballs, nor will they ever be touched by any of the actors, or be allowed to touch an actor. No special clothing is required other than wearing something com-

fortable," he said. "Keep in mind that rides will continue rain or shine, so dress appropriately for the weather," he added.

Riders are seated comfortably on the wagons. They do not have to sit on hay bales.

There are no age restrictions. "This is a family event," said Howard, adding however that it is not recommended for children under two due to the loud noises and disturbing images. Any child under 12 must be accompanied by an adult.

"Some people would like to come as a group and we will do our best to seat them together, but it could mean a longer wait in line," said Howard.

"Some people have asked if the ride is scary," said Howard. "Scare factor varies from person to person. If you frighten easily the answer is yes,

but we have done our best to make the hayride scary and frightfully fun," he said.

The cost is the same as last year; \$15 per person. Parking is free and wagons are boarded at the fairground entrance just south of the grandstands.

Howard warned however that riders will experience intense audio, lighting, extremely low visibility, strobe lights, special effects and/or sudden physical actions. "You should not take this ride if you suffer from heart conditions or are prone to seizures," he said.

The Fed has three key entities, the 12 Regional Banks (12 districts that cover the U.S. and are the operating arms of the Fed) the Federal Reserve Governors (the governing body of the Fed that reports to Congress) and the Federal Open Market Committee (FOMC) which is responsible for what is called Open Market Operations (OMO).

OMO refers to the buying and selling of government securities in the open market in order to expand or contract the amount of money in the banking system. It all sounds a bit technical but think of it as a gas pedal for the economy, or at least one of the gas pedals possessed by the Fed. Press on the gas pedal and away you go, lift off the pedal and things slow down.

So how does OMO act like a throttle on an economy, allowing it to speed up (improve economic conditions) or slow down (cool off an overheating economy from inflation)?

It all has to do with how inflation works. Simply put, increase the amount of money in an economy, conditions generally improve and prices tend to rise. Withdraw (reduce) the amount of money, the economy slows and prices tend to fall. OMO plays to this mechanism.

In one instance, the Fed's print up some money and buy debt that large U.S. banks are required to hold which are called "bank reserves". This debt may include U.S. Treasuries (Government IOU's) or debt from Fannie Mae or Freddie Mac, which is basically government backed mortgages. Large banks always hold vast amounts of both of these types of IOU's and agree to let the Fed's buy or sell these IOU's at any time as a part of the OMO program.

When buying, the Fed's give the banks money in exchange for their IOU's. The Fed's can also order the banks to do the reverse and buy IOU's from the Fed.

This back and forth selling or buying between the banks and the Fed either funnels more cash into the banking system (when the Fed's buy the debt) or take money out of the system (when the Fed's order the bank to buy the IOU's from the Fed). Incidentally the banks make a profit every time a transaction takes place because the Fed pays them a little bit extra when they are on the buy side of the equation.

A buy and a sell of the same IOU can happen overnight, meaning the Fed's sell the IOU one day then buy it back the next. These are called repurchase agreements or "overnight repos" for short. The repurchase agreements can also be much longer in duration.

When the Fed's buy IOU's, more money goes into the banking system and the gas pedal is pressed down. When the Fed's order the banks to buy IOU's from the Fed, money is taken out of the system and the pedal is lifted.

By adding or subtracting money from the banking system, the Fed's hope to control how much money is lent out to consumers and businesses thereby stimulating or slowing the

economy. Money is the fuel which drives the economy and by simply adding or subtracting vast amounts of it, the belief is it will act like an accelerator pedal and the economy will respond accordingly. Coupled with a variety of other tools at the Fed's disposal, they hope to control the economy in the direction they want it to go and at the instant they want it to go there.

Given the history of market crashes, economic blow ups and the severity of such events since the Fed's inception in 1913, I will leave it the reader to decide whether they actually accomplish this task.

Clean Water Act Enforcement Reform Needed

A report issued by a U.S. Senate committee documents how federal agencies overreach their authority to regulate farmland, according to the California Farm Bureau Federation, which said the report underlines the need for congressional action to reform the agencies' practices.

The report from the Senate Environment and Public Works Committee describes numerous incidents in which the U.S. Army Corps of Engineers and Environmental Protection Agency have tried to expand their authority to regulate what crops farmers grow and how they grow them, based on the agencies' interpretation of the Clean Water Act.

"A disturbing number of the cases described in the Senate report came from California," CFBF President Paul

Wenger said. "Farmers and ranchers here have seen firsthand that the abuses outlined in this report aren't theoretical—they're real."

Landowners' concerns stem from a rule the agencies finalized last year, known as the "waters of the United States" or WOTUS rule, which would bring more waterways under jurisdiction of the Clean Water Act. Although a federal court has temporarily halted enforcement of the WOTUS rule, landowners and their representatives say the Corps continues to enforce the act so narrowly that, as a practical matter, its actions mirror the intent of the new rule.

"We're grateful the Senate committee has highlighted the impact on farmers and ranchers caused by overzealous interpretation of the Clean Water Act," Wenger said. "Farmers

and ranchers want to do the right thing and protect the environment as they farm. But they shouldn't be tied up in knots by regulators for simply plowing their ground or considering a new crop on their land, and they shouldn't have their land declared off limits if they must leave it idle due to drought or other conditions beyond their control."

Wenger called on California's two senators to join efforts to clarify Clean Water Act enforcement and reform agency practices.

"Congress has the ability to restore balance to Clean Water Act enforcement," he said. "We urge our California members to help farmers grow food and protect the environment, free from fear of overreaching regulation."

West Nile Virus Cases in Sutter County in 2016

Two Sutter County adults have been confirmed with the neuroinvasive form of West Nile Virus (WNV) illness. Seven additional Sutter County residents have probable WNV infections, for a total of nine cases. 45% of Sutter County cases have the neuroinvasive form of WNV. All patients are currently recovering. Two asymptomatic WNV-positive blood donors have also been identified. Sutter County Public Health is continuing to investigate several additional possible cases of WNV. WNV activity is higher in 2016 than previous years. In 2015, a total of 2 cases were reported, with no deaths from WNV. There have been

a total of four WNV-related deaths in Sutter County, occurring in 2012 and 2014.

Most persons who become infected with WNV do not become ill, but develop immunity to WNV. Approximately one in five people who are infected with WNV will develop symptoms, such as fever, headaches, body aches, joint pain, vomiting, diarrhea or rash. Symptoms typically develop from 3 to 14 days after being bitten by an infected mosquito. Less than one percent of all infected people will develop the neuroinvasive WNV infection which is a serious neurologic illness with encephalitis or meningitis (inflammation of the brain and

surrounding tissues). The State of California West Nile virus webpage has information about WNV activity around the state by county, how to report dead birds, and how to protect against WNV. See <http://www.westnile.ca.gov/>

Risk for WNV infection from mosquito bites continues into late Fall for humans, horses, and other mammals. It is very important to always take the simple precautions that reduce the risk of mosquito bites and becoming infected with West Nile virus - whether at home, participating in outdoor activities, or traveling. The 4 "D"s is an easy way to remember how to prevent mosquito bites:

D - DEET - use DEET, picaridin, oil of lemon eucalyptus or IR3535. These are the EPA approved mosquito repellents to prevent bites; be sure to follow package instructions for age of person and how to apply

D - Dawn and Dusk - avoid going outdoors at dawn and dusk when the mosquitoes that carry WNV are most active

D - Doors and windows - make sure that the screens on your doors and windows are not broken or torn

D - Drain all standing water around the outside of your house - gutters, jar lids, tires, flower pot trays are some common places

The Sutter-Yuba Mosquito and Vector Control District continues to be active with mosquito control and monitoring mosquito activity and will continue until cold weather. The County Recorders' Association of California strongly supported this measure because prior to this enacted law there was no consistent practice for re-recording between counties.

This Month In Your Garden

October is a busy gardening month. It is the best time of the year to plant trees and larger shrubs. Why? It is actually best for several reasons. The soil retains warmth from the long hot summer into the winter months, the air begins to cool, top growth slows, deciduous trees and shrubs lose their leaves, but the root growth continues until the soil becomes cold. The things planted at that time will gain so much root growth, particularly trees, that they are nearly a year ahead of similar plantings done the following the January through May spring planting season. The fall planted deciduous tree has the advantage of putting out new roots without having to support the growth of new leaves, and even an evergreen tree or shrub is not expending the energy needed to put on new leaves because they are dormant.

We realize that some of the trees and shrubs may not may not have the sales appeal compared to the lush green growth of spring – but they will in just a few months. Fall leaves show the wear and tear from the full season's wind, heat and insect damage, but we do believe that making your selections and planting in the fall will benefit the tree or plant. If there is fall color to be had, you will see it, and know what to expect next fall.

Winter vegetables have been available for a little while now and should be planted soon in order to take advantage of the warm soil to get them started

and sturdy before the colder weather settles in. Small plants available will include cabbage, cauliflower, Brussels sprouts, broccoli, Swiss chard, kale, lettuce, spinach, collard greens, and probably others I have forgotten. Root vegetables such as beets, turnips, radishes and carrots are usually planted from seed. This is the time to plant all kinds of peas, such as regular pod peas and snow peas, too.

Like the winter vegetables, it is now the time to get winter annuals started so that they can have the advantage of the warmer soil to get them off to a good start and bloom well for you. Do it too late when the soil is cold, they will grow, but often are stunted, only to perk up as spring approaches. You are much more sure to get lots of flowers during the winter months by planting a bit earlier.

I think I mentioned wild flower seeds in September. There still is time to scatter them. It is always nice to coordinate scattering them with a shower from Mother Nature, but that can be hard to do considering her unpredictability. Maybe we will get lucky this year! When you do scatter them it is a good idea to mix them with some sand or other medium that will add some volume to help spread the seed over a wider area – some of them are very small! If there is a water source close by they can be helped along with a shower from your hose.

Bulbs for spring blooms are available

many places, including Bald Mountain Nursery. This is the time to get them in the ground for spring color. Daffodils, narcissus and tulips are what come into mind first for most people, and those will be offered in most displays. Larger displays will include many different kinds of bulbs such as hyacinths, allium, many kinds of lilies etc., too many to list here. We have a modest, but nice basic selection of bulbs

Now, just a few disjointed notes:

There should be adequate time to get a lawn established or ground cover planted before it gets too cold if you do it very soon.

If you weren't able to do fall fertilizing for trees and shrubs last month, do it now for any plants that still have green leaves.

Cooler weather and damp weather will encourage the snails – be ready with your snail bait and/ or traps.

If basins were created around trees for holding the irrigation water to better water the trees, be sure to cut the side to allow water to drain if we should have heavy rains this winter. It will avoid root rot.

This is a good time to divide (and maybe trade) perennials.

Farm groups call for Clean Water Act reform

Farmers and ranchers want to protect the environment, farm groups say, but enforcement of the federal Clean Water Act often leaves landowners "tied up in knots." The California Farm Bureau welcomed release of a U.S. Senate committee report Tuesday, which outlined how federal agencies have tried to expand their authority over farmland as they enforce clean-water rules. Farm Bureau called on Congress to reform how agencies enforce the law.

California leads in organic agriculture

Sales from California farms and ranches represent nearly 40 percent of the nation's organic agriculture, according to new figures from the U.S. Department of Agriculture. An annual survey put the value of California organic production at more than \$2.4 billion. In the national statistics, the top five organic commodities included milk, eggs, chickens, apples and lettuce.

Sorghum generates new interest

Growing demand for whole grains and gluten-free foods has boosted interest in sorghum,

and California researchers are in the midst of a multi-year study on how the crop grows in the state. Most sorghum produced in the U.S. comes from the Midwest and Plains states. In California, it's been grown mostly for livestock feed, but emerging markets and its ability to withstand drought have brought new attention to sorghum.

Facility boosts almond-processing capacity

As the almond harvest continues in Central Valley orchards, a growers' cooperative dedicated a new warehouse Tuesday that can store up to 60 million pounds of nuts. The Blue Diamond Growers cooperative hosted reporters and dignitaries at its new facility north of Modesto. The company says the warehouse forms part of the world's largest almond receiving facility, and allows almonds to undergo hands-free processing.

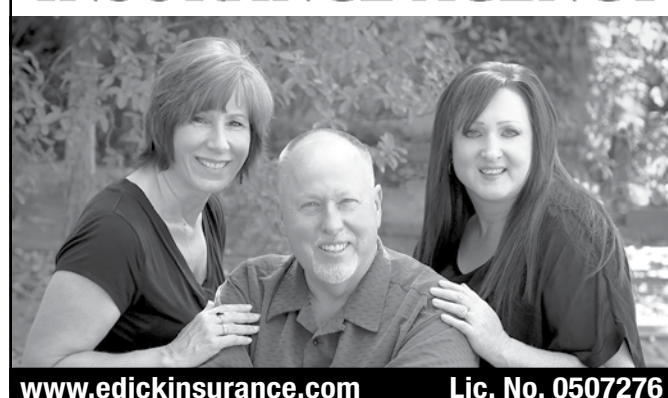
