The original Stand Down for the homeless veterans, now includes all veterans, active duty and their dependents, was modelled after the Stand Down concept used during the Vietnam War to provide a safe retreat for units returning from combat operations. At secure base camp areas, troops were able to take care of personal hygiene, get clean uniforms, enjoy warm meals, receive medical and dental care, mail and receive letters, and enjoy the camaraderie of friends in a safe environment. the opportunity to renew their spirit, health and overall sense of well-being. Stand Down is an intervention that was conceived from the ground up specifically for veterans. It is designed to transform the despair and immobility of homelessness into the momentum necessary to get into recovery, to resolve legal issues, to seek employment, to access health care and benefits, to reconnect with the community and to get off the streets. A very tall order for a three-day event.

More Hearings, Arrests, Concern in Sutter Sex Sting

News of more than 30-men arrested for seeking sex with 9, 13 and 14-year-old Sutter County girls has surprised and shocked the community. Knowing that thousands of children use Facebook and other social media families are feeling at risk and vulnerable.

Initial arrests began in February 2016 for the 10-month mission involving 4 counties and 8 agencies. Hearings for the defendants will continue into 2017.

California is leading the US in sex trafficking with Sacramento ranking as one of the most active cities in the nation. District Attorney Amanda Hopper says trafficking is the fastest growing enterprise in the world.

Many here are questioning why those apprehended were granted such low bail and remain free to solicit other girls. Others wonder if authorities thought to interview and protect any minor children belonging to those arrested and released.

When it comes to threats on children many want to skip the bail and get to the trial. In these cases the men have a right to bail according to DA's office.

Word that Judge Brian Aronson lowered bail on some due to his personal knowledge of those accused has folks bristling. Most bail amounts for the men range from \$5,000-50,000.

People are nervous. And, Judge Aronson, appointed by Governor Gray Davis to replace retiring Judge Timothy Evans in 2003, is not popular with law enforcement nor is he thought to be tough on crime.

In another high-profile sexual offense case Santa Clara Superior Court Judge Aaron Persky is facing a recall for sentencing freshman Stanford University swimmer Brock Turner to just 6-months in jail and 3-years probation vs a maximum 14-year term. Turner was discovered by two bicyclists raping an unconscious 22-year-old female behind a dumpster after a fraternity party.

The judge said he feared the "severe impact" that a stiffer sentence might have on the student athlete's future. Since the decision, 10 prospective jurors have refused to serve in Persky's courtroom. Persky has now decided to leave criminal court on September 6 to be reassigned to civil court.

Sutter DA investigators explain that if those accused actually had sex with a 9, 13 or 14-year-old girl, the bail would be 5 to 10 times higher. Fortunately, the sting was planned to prevent that scenario from occurring.

All of the subjects' charges were presented by investigators directly to Judge Aronson to obtain Ramey arrest warrants rather than taking the extra time and step to process them through the DA's office. This is where Aronson questioned some of the bail amounts.

Three more men have been arrested and more warrants are being issued to possibly bring to 40 the number of those accused of wrong-doing. A few of those arrested once coached young girls' baseball. Another taught school.

Many had records. Some had prior arrests for deviant sexual behavior such as masturbating in Happy Park or taking photos up girls' skirts.

One had been convicted and discharged from the Navy for child pornography. However, he still found employment with the State Energy Commission and served on the Yuba City Planning Commission.

The men utilized Facebook and Craig's List to gain access to the fictitious girls. They found 'Sophia' on Facebook. They discovered law enforcement posing as parents on Craig's List offering sex with their 9 and 13-year-old daughters.

Some predators promised and brought drugs to the hook-ups. They sent genital photos, conveyed explicit sexual dialogue and requested ongoing encounters.

Although not all the accused have identical charges, many with multiple charges could get a maximum 4 years incarceration and be mandated to register as a sex offender. However, some in law enforcement feel 3 years probation may replace the prison term.

With Sutter County and Yuba City law enforcement agencies severely short-staffed, DA Hopper presented an urgent request to the supervisors last week for an additional investigator in her office. The investigator would focus on sex trafficking cases since the sting uncovered a sexual frenzy of men ages 18-50 from inside and outside the community seeking to defile Sutter County children.

Supervisors Jim Whiteaker and Larry Munger preferred to postpone the decision citing budget concerns and opposed the request. However, Hopper received funding for her investigator for at least one year with yes votes from Supervisors Dan Flores, Ron Sullenger and Barbara LeVake. Four Gold Sox Players Honored by Great West League

Marysville, Ca. The Great West League today announced its list of awards recipients for the 2016 season. The All-Great West League team was voted on by league managers and the announcement was made by League President Ken Wilson.

The Marysville Gold Sox had two players receiving All-Team honors and two more received honorable mentions. Catcher Hunter Stratton was named to the All-GWL First Team and Relief Pitcher Kyle Merkel

was named to the All-GWL Second Team. Both players hail from San Diego State where they are attending college and looking to build on their successes for the Gold Sox this season.

First Team award recipient Hunter Stratton led the Gold Sox with a .309 batting average and tied for first on the team with 3 home runs. He also led the team in RBIs and tied for 3rd place in the GWL in that category.

Kyle Merkel finished the season with 10 saves, to lead both the Gold

Sox and the Great West League. He fashioned a 1.99 ERA out of the bullpen in 21 appearances which was the second most of any player in the GWL. Merkel also struck out 20 batters in 22.2 innings pitched.

Gold Sox players Dalton DeVries and Ryan McCarthy also received Honorable Mentions by the league. DeVries who will be attending The Masters University(Ca.) in the Fall and was second on the team in batting average with .280. The Gold Sox infielder also led the team in hits (56) and walks (29) and was 3rd and 2nd in the league, respectively in those categories. McCarthy plays ball at Yuba College and led the Gold Sox starters in ERA with 3.17. He pitched 54 innings across 13 games with 40 strikeouts. His record on the year was 7 wins to just 1 loss. "We are very excited to have our players part of this all league team and wish them the best in their upcoming college season in 2017", said GM Michael Mink.

Medford Rogues third baseman Spencer Steer was awarded the GWL Player of the Year and right handed pitcher Stuart Bradley of the Chico Heat was awarded Pitcher of the Year honors. Chico Heat Manager Fred Ludwig was named GWL Manager of the Year to go along with his team's league championship.

The release of water from Oroville Dam has improved the salmon bite. The release has dropped from over 9000 cfs to 6700 cfs. Reports tell us spinners are a good bet along with flatfish lures. My Grandson, T.J. Johnson, who resides in Tennessee, was here for the opening of archery deer season and also hit the Feather River last week in the red boat. He and my son Ted had three nice salmon on with two getting into the net. The fish were bright and clean with one ten and one eighteen pounder taken. The continued drop in water release will further improve the salmon fishing in the Feather River. Both fish taken into the boat were caught on flatfish and were caught above Boyd's Pump.

The water level at Lake Oroville continues to drop. The water capacity as of this writing is below 52 feet and dropping. This reduction in water does not seem to be bothering the bass population with fish being caught using drop shot worms in a variety of colors.

We hear from Stumpy Meadows Reservoir. The lake is holding at 80 percent with launching not being a problem with the current lake level. Trout are hitting flashers and worms around 35 feet.

The only boat ramp still open at Folsom Lake is the Hobie Cove ramp at Brown's Ravine. Fishing was slow last week.

Lake Almanor is putting out some nice fish in the east basin. Best bet is to hit the water early with a variety of lures, but reports tell us the trout are also cooperating just about all over the lake.

Eagle Lake, up near Susanville, has been putting smiles of happy faces with limits of 2 to 3 pound trout common. The fish are hitting in the Eagles

Nest area in 50 feet of water trolling at 20 to 30 feet down. We are told the shoreline of this natural lake is covered with thousands of minnows swimming all over the areas.

Well folks, get ready for the endangered yellow legged frog...Oh and don't forget the toad. It appears the Federal Government is once again going to change the lakes and streams, even maybe poisoning them as they did before, to protect the frog and the toad. As I recall, previously we lost a bunch of trout when finally it was decided the culprit was a fungus, at the tadpole stage that was causing the extinction of these creatures and not the trout population which was supposedly eating the tadpoles for breakfast, lunch and dinner. We wonder how far this will go this time..... stay tuned.

Boot's fishing tip of the week: Try floating the rivers at dusk, casting to shore with lures or plastic worms for huge striped bass.

Why I moved to Yuba-Sutter ... Art and Nature

When I first started visiting the Yuba Sutter area in the early 2000s to fish and hunt, I remember saying to myself that if I ever had the chance to move back to my home state of California from my then home in Washington, DC, I would really like to live in this outdoor paradise just north of Sacramento.

The only thing I wasn't sure about was the local arts scene. Along with tramping along in the woods and spending time on the water with a line out, I knew I'd have to have some contact with the art world. A love of the outdoors and art were both bred into me at an early age. You know, the professional photographer father who wanted to be Ansel Adams, who never missed with a shotgun and always caught the biggest fish and who listened to Beethoven and the Sons

of the Pioneers.

I knew that Sacramento just to the south and nearby San Francisco would have plenty to offer, but I really had no idea what to expect out here in the rice fields and almond orchards.

I had grown up in Los Angeles and from there moved to the nation's capital to work for about 20 years. I was used to a "big city" arts scene with art galleries, theatre, dance, live classical and popular music, opera, college music and theatre productions... the whole gamut.

Fast forward to 2008...a re-structuring of my company created an opportunity for me to, you guessed it, move back to California. I came out to house hunt in October, found a great home in Plumas Lake, had my offer accepted and in January of 2009 drove across country to return to my ancestral homeland and get settled.

I remember some of my first drives through Marysville noticing this funny looking pink building at 7th and E Street with something about "Arts Center" and wondering what it was all about. I started to read articles in the paper about the Borgamaria Lyric Opera performances at the center and monthly art gallery showings and re-

ceptions next door.

Guess I was looking for "the best of all possible worlds" and I knew that I had found it.

So just like the outdoor opportunities that were hard to miss, I quickly learned that the local arts scene was vibrant and very much alive thanks to groups like The Acting Company, Master Chorale and Yuba-Sutter Oratorio Society and the Tri-County Concert Association. Next thing you know, I'm producing a Rotary fundraiser concert with two classical music performers from Italy playing piano and organ duets. Then I volunteered to usher at the legendary Joaquina Calvo Johnson's last opera production, "The Marriage of Figaro," at the Burrows Center for the Arts. Yes, I could be comfortable here in my new home in Yuba Sutter.

2013 brought an invitation to serve on the Board of the Yuba Sutter Arts Council and a year later, I'm elected Board President. I helped guide us through an especially challenging time when we had to decide whether or not to sell off our beloved theatre and art gallery complex.

Well, we kept it. We're on sound financial footing and to this day our arts center continues to enable us to host a wide variety of events, performing arts programs and visual arts displays.

So Napa has its Music in the Vineyards summer programs, but we have our upcoming annual Harvest the Arts and lots more celebrating of our agricultural and outdoor heritage, along with our thriving arts scene. Get ready for Art Walk and much, much more.

The minimum age for senior discount fare and Dial-A-Ride service eligibility will increase from age 63 to 64 on September 1st. This change was approved in 2015 as part of a planned three-year incremental increase to ultimately match the Federal standard age of 65. The final increase to the minimum age of 65 for senior discounts will be effective next year on September 1, 2017. It's worth noting, this change has no effect on passengers who otherwise qualify for fare discounts and Dial-A-Ride service due to a disability.

This Month In Your Garden

September is a month that says goodbye to summer and hello to fall – usually the summer temperatures begin to cool down, but still, summer can't quite let go. Vacation time is over for most of us and schools are back in session and we return to familiar routines. It is a month of transition from one season to another that is recognized by the plant world as well all of us. In fact, plant behavior is one thing that makes the weather change obvious to us. Some things that have been blooming vibrantly begin to dwindle, leaves on trees begin to change color. As the sun moves further south we become aware that our days are definitely getting shorter. Plants begin to get ready for winter by storing food in their stems and/or limbs. This is the time to fertilize most everything in your yard. It should be done before too long because trees and deciduous plants can't utilize the fertilizer with no leaves. Once they have lost all of their leaves it is too late, and leaves that have begun to turn their fall color don't function as efficiently as nice green ones do. Then it is likely most of that the nutrient you applied will be lost into surrounding soil with rain or irrigating and will not be available to your intended target. Get ready to fertilize both evergreen and deciduous shrubs and trees, most of which can be done with an all-purpose balanced fertilizer such as 16/16/16. There are some that need specific fertilizers such as citrus and acid loving plants, and the response will be better if the proper fertilizer is used on those plants. Some spring blooming plants have already set their buds, and should not be fertilized until after they have completed their bloom cycle. Rhododendrons

and camellias are good examples – the buds are formed and on the plants now. Giving them fertilizer sends a message to grow, so they start putting on new leaves which can push the buds off. Keep that in mind when doing your fall fertilizing and let those early spring bloomers wait until they have finished blooming. If you have some in that category that should have set buds by now, but haven't, go ahead and fertilize them. It just might urge them to set buds a bit late.

If a winter vegetable garden is in your plans, it is time to start readying the space for it. If it is to go where a summer vegetable garden was, it is obvious that you are going to have to give up on those plants still there, even if they are productive. That hurts, I know. Maybe you can keep one especially good tomato plant! The plot for the winter garden should be free of weeds and the soil worked up some and depending on your soil may need some soil amendments. The winter vegetable starts may be available now, or they will be available soon. It is important to get them planted before temperatures start becoming really cold at night. The soil will stay warm for a while, so take advantage of that warmth to get your vegetable plants off to a good start. Planting in cold weather stunts the plants which have usually been grown in a green house. The same thing applies to planting winter bedding plants from a nursery – start them soon so that they become well established before temperatures become cold. Otherwise, they may just sit there doing just fine, but doing very little growing or blooming until the weather starts warming with the onset of spring, then flourish. Better to plant earlier and enjoy

them all winter, too.

September is a good time to plant ground covers from flats or lawns from seed. Usually the weather cools considerably as we work our way through September, with some spikes in temperature. The cooler temps make it much easier to keep them moist as they become established. They should have time to become to be well enough established to not be damaged by the coming cold weather. It is also time to think about scattering wildflower seed. Mother Nature scatters them about this of the year for our enjoyment the following spring, so follow her lead. The seed should be available at nurseries before long. They are generally scattered, as nature does, rather than being "planted", and if that can be done coinciding with a rain shower which will help the seeds to settle into the ground and help them to sprout more easily. Wildflower seed is usually a bit more expensive than other flower seed. Check out what seems a bargain price for a package of wild flower seed – it may contain a high percentage of grass seed rather than pure wild flower seed. Enjoy the onset of fall and hopefully cooler weather.

What is driving the Market

The Federal Reserve could potentially raise interest rates as soon as next month, New York Fed President William Dudley said, warning investors that they are underestimating the likelihood of increases in borrowing costs.

"We're edging closer towards the point in time where it will be appropriate, I think, to raise interest rates further," Dudley, who serves as vice chairman of the rate-setting Federal Open Market Committee, said Tuesday on Fox Business Network. Asked whether the FOMC could vote to raise the benchmark rate at its next meeting Sept. 20-21, Dudley said, "I think it's possible."

So here we go again. The markets seem tethered by an invisible

thread to what the Feds say and do, but mostly since what they say happens far more frequently than when they actually act, the "Fed Speak" has had tremendous sway on what markets do in its day to day movements.

Investors must be scratching their proverbial heads. One day the markets shoot higher on a particular news piece then the bottom falls out on some other news item.

It could be argued the markets react on both fundamental news and non-fundamental news which means it may not be so tied to what the economy is actually doing but tied to what the Federal Reserve is actually saying.

In my father's day, stock markets generally reflected what was expected to happen in the economy and the businesses in it. More specifically it was said the stock market told us what would happen in advance, like six or nine months in advance. Good business news and growth in earnings bolster investor confidence and subsequently they bought stocks.

Fast forward to today, and the markets seem not only concerned about what businesses will do but what the monetary authorities will say and do as well.

If businesses have positive growth, investors may perceive the Federal Reserve will raise interest rates, which is what they do to cool off an overheating economy. This fear of rising rates may spur a selloff in stocks, the exact opposite of what traditional stock market reaction would be in the face of good news in the business sector. Conversely if businesses start to suffer, and the economy shows signs of weakening, investors my think the Feds will drop rates, which is generally good for stocks, and the markets may rise despite a poor business environment.

Case in point: New York Fed President Dudley's remarks that rates could rise sooner than expected caused a significant sell off in stocks the day he made his speech. It is indeed a strange world we live in when the markets now react positively to negative business news and react negatively when businesses say they're doing better.

This "opposite reaction" compared to what markets had done in years past may be caused by the Federal Reserve's hyper activity in the markets of the world as they attempt to steer the economy where they think it should go. As the Feds have increased their activity and involvement in the economy over the decades in their belief they can control such a beast, it could be argued the cure may be worse than the disease.

Clear Waters for Cavaliere!

"After seemingly badgering their side's attorney to find significant fault against Director Cavaliere, President Skinner and Director Forguson ended the August 18, North Yuba Water District's Special Meeting with glum, disillusioned looks. Clearly, they so wanted to catch Director Cavaliere in some dastardly deed. They failed miserably and the public saw right through it. What was supposedly terrible was simply explained.

After the costly, lofty union accusations were presented, the two minor infractions against Director Cavaliere, who heard them for the first time tonight, were honestly described by both her and her attorney – Earlier this year, while in the office, Director Cavaliere asked office staff if they had found any cost-saving options for NYWD's banking and other expensive activities. While there, she went into a file cabinet to look at her own, private files. The staff felt harassed by her questions and "file cabinet-gate." The second issue happened last year, when Director Cavaliere forwarded an internal rate study email to members of the public, an email with information in it that the District's own attorney granted her permission to send.

President Skinner, with a perplexed face, asked the attorney several times for guidance on severe punishment. Nothing materialized. Director Forguson, grasping for straws and harrumphing more than usual, made a motion to send the entire investigation to the Grand Jury. No one seconded the motion. He then asked that the matter be rolled up into a censorship resolution, crafted by the District's expensive attorney, for next week's regular meeting. No one seconded it. Meeting adjourned.

It was obvious that these directors, and one community troublemaker, were hungry to publicly shame Director Cavaliere and to damage her reputation. It was a blatant waste of the District's time and our precious money, simply to gain an edge for November's election. While it's mandatory that union employees' grievances be recognized and investigated seriously, these petty complaints fuel some truly serious questions: Were the employees really behind this witch-hunt? Was someone influencing them to make more of an issue than really existed? Is an outsider stirring up trouble just to stack the board? Can the public sue the District for the money they've wasted? Probably not, but November is luckily right around the corner, isn't it?"

Cap-and-Trade Program Auction a Flop

The California Air Resources Board (CARB) held the eighth auction of greenhouse gas allowances on August 16, 2016. Today, CARB released the results. Senate Republican Caucus Chair - Senator Jim Nielsen (R-Gerber) - is-

sued the following statement:

"Of the 96 million credits available for sale by CARB, only 31 million were sold - a mere \$8.4 million to the state treasury.

"The cap-and-trade program is a failure - a

flop.

"We must end it. When SB 32 comes up in the Senate in the next week, we should reject this failed experiment that is adversely impacting Californians especially those who can least afford it."

SB 32 Not Good for Californians Nor Our Economy

The California Legislature voted to extend greenhouse gas mandates by passing Senate Bill 32. The measure, if signed by the Governor, would require the California Air Resources Board to impose regulations to ensure statewide greenhouse gas emissions are reduced to 40% (or higher) below the 1990 levels by December 31, 2030. Vice Chair of the Senate Budget Committee, Senator Jim Nielsen (R-Gerber) issued the following statement:

"The government will now have license to dictate the types of ovens, stoves and cars the public can buy.

"Not everybody can afford to drive an electric car. Our priorities are to put food on the table, and a roof over our heads and maybe, if there's anything left, to save for our family's future.

"Who can say what economic and social

impacts this sweeping law will have on Californians? This government agency has failed to study the effects of their regulations on our daily

lives. To grant them this extraordinary extension of authority for 14 more years will further damage our economy and destroy jobs."

Farmall Club

Most of the major tractor manufacturers sought to produce units that fit the diverse needs of the farm. Soil types, weather, climate, water availability, and acreage availability were all factors with which farmers dealt. John Deere produced the L series, Massey Harris made the Pony, Allis Chalmers contributed the G, Oliver presented the 44, and International Harvester manufactured the famous Cub.

These were designed for the small farm that needed a tractor for a variety of tasks .Mowing raking, pulling trailers, plowing, and cultivating garden crops were among the jobs. The one horse or one mule farm were the targets. Remember, that the highest number of farms in the late 30's and early 40's possessed 40 acres or less. It also took about 20 percent of the farm to produce food for the work animals.

The Farmall Cub was envisioned before WWII, but did not come to market until 1947. Production continued with evolutionary designs until 1981.

A so called "Super Cub was built in St. Dizier, France from 1955 to 1964.

The Cub was first known as the "Farmall X" or the "Baby Farmall". A two cylinder engine was considered for the 2/3 A. They planned to sell the Cub for \$400 while their costs were \$225. It was announced in 1945 and serial number 501 was the first Cub.

A L Head motor of 1.0L with four cylinders producing 10 HP was the

final candidate for power. It was a smooth running engine, somewhat quiet, and the engine was manufactured in house. Horsepower rose to 18 by 1975. It weighed 1477 to 2891 pounds depending on options.

There were about 245,000 Cubs and or variants produced. Base price was \$545.

Woods made a 5 foot for the Cub and it was a big seller.

Most Cubs had the manual lift and hydraulic lift was an option. Extra mounting brackets could be purchased for "Touch Control", or midmounted hydraulics for a forward cultivator.

International Harvester decided to purchase the Curtis Aircraft plant in Louisville, Kentucky and spent about \$55 million to redesign and modify the plant. It was close to the tobacco belt and had 48 acres under roof. Cubs, Super As, and Cs were manufactured at this site.

The Cub immediately became an international favorite. 501 was sold in Wisconsin and numbers 502,503,504,505, and 506 went to Mexico.

The Cub was one

of the longer lasting American Manufacturing Models rivaling the Beechcraft Bonanza. In 1975 it was sold as the International Cub and in 1979 the presentation became the New International Cub.

Evolutions of the Cub were the LoBoy, the Cub Cadet, an Industrial in the late 50s, and it was painted red, yellow, and a white demo came on line. A Variant Hi Crop was also available.

It was always a treat when Mr. Jensen or his oldest son would drive their Cub into my Dad's little corner store to buy gas . I never did get to drive but hope was eternal. The large Stahl family pooled their money from prune picking, walnut gathering, and almond shaking with one of those rubber padded handles to buy a Cub. 2015 Yuba County Crop Report

The total value of fruits and vegetables produced by Yuba County farms in 2015 came in at nearly \$232 million, a decrease of 17 percent from the previous year's record value estimate of \$280 million. The drop in agricultural value was primarily caused by lower pricing for many of Yuba County's top commodities.

"The extended drought and lower prices for many of our crops continues to pose significant challenges for our producers," said Yuba County Agricultural Commissioner Stephen Scheer. "Even with these lower numbers, our farm and ranch communities continue to be the backbone of the county's

economy." There were significant changes in crop values for 2015, led by walnuts (English), rice, and prunes. Walnuts maintained its status as Yuba County's top crop, generating over \$52 million in gross value. Rice held on as the number two crop in the county at over \$44 million. Prune production decreased from 2014 values to \$43 million, and milk prices experienced a significant drop in 2015 with a value of \$10 million.

Yuba County's agricultural impact goes far beyond the orchards, fields, farmers, and farm workers. Each dollar earned within agriculture fuels a more vigorous economy by stimulating additional

activity in the form of jobs, labor income and value added, such as generating business in banking, marketing, transportation, and other services. The agriculture value chain accounts for nearly three million jobs in California. The figures presented in this report are estimated gross values with no consideration of production costs and do not reflect net income to producers.

Farmers guard against citrus disease

As a pest known as the Asian citrus psyllid invades California, farmers prepare for the possibility the insect could carry a fatal plant disease into commercial citrus groves. At meetings around the state, citrus growers and packers are discussing response to potential discovery of the disease, known as HLB. The disease kills citrus trees and has caused serious damage elsewhere. In California, it has been limited to residential trees so far.

Supporters seek to keep biomass plants open

With dead trees and other wood waste piling up in California, agencies need a way to dispose of the waste efficiently. But biomass-power plants--which can burn the waste to create electricity--have been closing. Biomass power costs more than other renewable sources,

leading utilities to drop contracts with biomass plants. Supporters have been working with lawmakers to direct some state "cap and trade" funds toward maintaining biomass power.

Survey shows support for international trade

Trade policy has become an issue on the campaign trail, and a new survey says most voters favor fair trade. In releasing the survey results, the American Farm Bureau Federation said more than half of the respondents became more likely to support a multination trade agreement when told it would help foreign demand for U.S. farm goods. Farm Bureau supports the Trans-Pacific Partnership agreement, which would reduce trade barriers among participating nations.

Cheese purchase helps families in need

Patrons of food banks and pantries will benefit from a purchase

of 11 million pounds of cheese, announced Tuesday by the U.S. Department of Agriculture. USDA said it would provide the cheese to families in need, through its nutrition-assistance programs. The action will also reduce a cheese surplus that has reached a 30-year high and contributed to economic troubles for many dairy farmers.
