The 16 oz. Beer 'Nazis'

President Ronald Reagan said, "If fascism ever comes to America it will come in the name of liberalism. Fascism is private ownership, private enterprise but total government control and regulation."

One of the most noted Seinfeld episodes is the Soup Nazi based upon the real life Soup Kitchen in New York where the line of customers wraps around the block. Soup patrons wait up to ½-hour and face numerous rules and rudeness to acquire fantastic soup.

In the Seinfeld version, the Soup Nazi would arbitrarily forbid a patron soup or add extra charges to customers who waited patiently, complying with a myriad of eccentric rules.

"No soup for you," the testy owner would shout! "No soup for one year!"

The laughs erupted by juxtaposing the outlandish soup-man against the clientele's absurd craving for his soups. What makes it work is the customers' finagling and strategies to not offend the Soup Nazi. They seem to enjoy the ritual of abuse.

However, when the sitcom 'Soup Nazi' is the government with its nonsensical rules, regulations and opinions, the fun is gone. That's what President Reagan was getting at.

Former New York Mayor Michael Bloomberg ran out of city problems to target obesity, salt and sugar intake. He banned jumbo sugary drinks, those over 16 oz. People protested, but the masters always know best. Bureaucrats detest freedom and those who have minimal need for government.

It took the state's highest court to this time reject the violation of personal rights saying the city's Board of Health "exceeded the scope of its regulatory authority" in enacting the jumbo drinks proposal. But, the scary thought is that it was a split decision. Other judges thought it was government's role to tell people what they should eat, drink and how much.

Kumar Kairam, the owner of Yuba City's Washington Market is a victim of regulatory abuse.

He decided to add alcohol sales. The state's Alcohol Beverage Control (ABC) and Darin Gale, the city Community Development Director, concurred but Gale objected to the sale of single 16oz cans of beer. Gale says Kumar can sell a 24 oz. single, but not a 16 oz.

Selling 16 oz. 'singles' is bad for the neighborhood according to Gale. Kumar's store is in a residential area. There was no ordinance, no public debate, just Gale's perspective and ruling.

Kumar says another store one block away across from a park and apartments sells 'singles.' This smells of crony capitalism, a government via arbitrary rules and regulations creating winners and losers.

A popular request of customers, Kumar says he is the only store forbidden to sell 16 oz. singles. He is losing business while trying to put three kids through college.

"Where are your 16 ozers?!" He then has to explain over and over a rule that makes no sense to anyone and refer patrons to the store a block away.

Kumar pleaded with the city to reconsider, making numerous trips to City Hall to find someone to listen. A year passed, but he heard nothing.

The ABC and the chief of police have no problem with him selling 16 ozers. City officials said they tried to call him to convey their decision... "No 16 ozers for you!" However, no one took time to stop by for a visit.

Yuba City council candidate Jason Rikard heard about Kumar's plight. Rikard organized a gathering at the market. A video of the event made it to Facebook to inform the public about the government abuse.

Rikard says, "It has nothing to do with beer, but with the arbitrary decisions of city government. It was neither a city council nor the people's decision." Rikard argues that the 'singles' issue is another example of a government gone wild, interfering with our personal freedoms.

Kumar Kairam is the poster boy for hard work and determination. After arriving here he worked the fields and then mini markets. Eventually he could afford his own store. His most difficult challenge turns out to be government. It wasn't supposed to be this way.

We all have a special lure in our tackle boxes. My son Ted has a flatfish which is scratched up from the huge teeth in the mouth of the big salmon he caught years ago. As far as my tackle is concerned I have a white rooster tail lure that has since gotten rusty. However, I will keep it for all time due to the fact that that particular lure caught me some beautiful brown, grayling and rainbow trout fishing the Green River in Wyoming. My Uncle Tom had a special spinner made for the salmon in the Sacramento River. An old friend he met on the river made the spinner and my Uncle caught some nice salmon using

it. There are so many people out there who have a special lure, reel or rod. I have a fly rod which came from Spain and was flown from there to Beale Air Force Base on an SR 71. I have never used it and it is a treasure, along with the certificate, among my collections.

For the lures that we use regularly..... how long should we keep them and when should they be retired? Before we do this consideration should be made whether or not we wish to "display" an old lure. When a person sees a lure hanging from the work bench or stuck in a window shade in the den there is always a story attached to the

lure. Of course the story is in the anglers mind who owned and used that lure. The next time you see a lure on display if would be a good idea to ask for the story. I can guarantee some of those stories will be now only interesting but exciting as well.

Six Families Become Homeowners

Six North State families got keys to new homes this month after working for months to build them. Participants in Community Housing Improvement Program's (CHIP) mutual self-help housing performed walkthroughs of their homes with USDA Rural Development and signed final paperwork

on August 24.

Families build their homes in groups of five or six under the supervision of CHIP's construction staff. Each household dedicates at least 30 hours per week in labor towards building their new homes and help each other during the process, which takes about nine months. All homes must be finished before anvone moves in. House plans included 3-5 bedrooms priced under \$200,000, with no down payment, affordable monthly payments and low fixed interest rates. USDA Rural Development provides funding assistance for these programs. Builders from this program must make at or below 30 percent median income for the county in which they build, have decent credit, and earn enough income to make monthly payments on



The minimum age for senior discount fare and Dial-A-Ride service eligibility will increase from age 63 to 64 on September 1st. This change was approved in 2015 as part of a planned three-vear incremental increase to ultimately match the Federal standard age of 65. The final increase to the minimum age of 65 for senior discounts will be effective next year on September 1, 2017. It's worth noting, this change has no effect on passengers who otherwise qualify for fare discounts and Dial-A-Ride service due to a disability.

To reduce the impact of this change on our existing senior riders, anyone who has a currently valid Yuba-Sutter Transit senior eligibility photo identification card will remain eligible whether you have reached age 64 or not. If you are now 63 years old (or will be before September 1st) and have never registered for a photo ID card because you use other identification such as a driver's license or State ID card as proof of age, you have until August 31st to get a Yuba-Sutter Transit senior ID card to maintain your senior eligibility.



Food and Farm News

Estimate shows drop in farm income

The nation's farm sector will continue to face reduced profits this year, according to a new estimate from the U.S. Department of Agriculture. The department forecast declines in net farm income for a third straight year. The reduced value of dairy and other livestock products received most of the blame, although receipts for most crop segments are also expected to fall--including declines in receipts for vegetable, nut and fruit crops.

Processing-tomato harvest to be smaller

Fewer processing tomatoes will be harvested on California farms this vear. An updated crop estimate puts production at 12.8 million tons, down

11 percent from the previous year. The government crop report says drought and hot weather led the season to start early, and that tomatoes have faced more pest and disease pressure than they did a year ago. Processing tomatoes are used for products such as salsa, tomato sauce and ketchup.

Mushroom production increases

Americans continue to eat more mushrooms. Production of the main Agaricus variety rose 2 percent, and sales of specialty increased mushrooms 17 percent, according to the U.S. Department of Agriculture. Production of organic mushrooms also rose, and the proportion of mushrooms sold on the fresh market increased. California ranks second in

the nation in mushroom production, behind Pennsylvania.

Blending recycled water could benefit crops

Recycled water undergoes treatment before being used for crops and other purposes, and a newly published study seeks to determine the best treatment methods before irrigating crops. The study from the University of California, Riverside, evaluated ways to blend recycled water to produce water tailored for use on specific crops or grasses. The report says the blending process could yield recycled water that is affordable and provides nutrients crops

The economic truth is inflation slowly erodes your net worth, your paycheck (by decreasing what you can buy

with it) and most importantly, persistently drops consumers into lower and lower income classes.

It accomplishes this task by adhering to one economic truth. Although everything does go up in price including your income, that one truth is wages always lag behind the general increase of prices in everything else. That is the one fact that causes this otherwise feel good phenomenon to stealthily destroy all who live within its grasp. It appears you are getting ahead but in actuality the exact opposite is happening.

An example would be to imagine a two percent inflation rate where everything you buy goes up two percent a year. City of Yuba City Promoting **Business License Amnesty Program**

Noncompliant Businesses Can Register With City Without Penalty Through Oct. 19

The City of Yuba City is embarking on a promotional campaign to encourage all businesses to maintain regulatory compliance and operate with a current business license. All businesses operating with an expired license or without a license qualify under the temporary amnesty program and will not be charged late fees if they apply before Oct. 19.

A business license is required for anyone who does business in Yuba City, and it is easy to obtain one online or in person at City Hall. In July, the Yuba City City Council approved a business license amnesty period through which businesses and individuals can come into compliance. Applications can be downloaded at www.YubaCity.net/My-Business and submitted via the mail or delivered in person. After Oct. 19, any businesses or individuals found to be operating without a license will be subject to back fees and penalties.

penalties.

Business license fees vary by business type and gross receipts, in addition to an annual administrative fee. The fees contribute to the General Fund, which is the primary funding source for public

city services that benefit businesses' customers and the community.

In order to be fair to all, the City will be conducting a review of businesses operating within the City before the end of the year.

"We hope this temporary amnesty program will encourage owners to apply and avoid penalties, help protect consumers from unlicensed business activities, and support the city in providing essential services" said Finance Director Robin Bertagna.

The City has about 4,000 active business li-

censes on file. A new business license is valid from the start of the business to the end of the calendar year. Business license renewals are valid for one calendar year, from January to December. For businesses located in the City of Yuba City, Planning Department zoning approval is required as part

of the process.

Governor Signs Gallagher's Protest **Notice Transparency Legislation**

Governor Brown signed Assemblyman James Gallagher's (R- Plumas Lake) AB 2801 which would add transparency to the protest notice process by requiring written protests to be kept for a minimum of 2 years.

"AB 2801 will ensure that there is a uniform standard for how long protest notices must be maintained after the hearing at which they are considered. This way protests will be available if there is a request to examine them to ensure an accurate count," said Gallagher. "The protest notice process is essential to ensure taxpayers have an opportunity to object to and prevent rate increases on their utilities," Gallagher continued.

Before a public agency can adopt a rate increase for water, sewer, or refuse collection services, it must mail a notice to affected ratepayers and allow them to submit written protests to the increase. If a majority submits protests, the rate increase is tabled.

various Unfortunately, aspects of the protest tabulation and reporting process have generated complaints from ratepayers regarding a lack of transparency. Included among these are complaints about public employees losing protests, opening protests before the hearing, disclosing the names of persons who have protested, unjustifiably disqualifying protests, and erecting unnecessary procedural hurdles to discourage protests. AB 2801 was supported by the Howard Jarvis Taxpavers Association (HJTA), and will provide protection and additional transparency to taxpayers by ensuring protest procedures are similar to procedures already existing for assessment balloting and fee elections.

"AB 2801 adds necessary transparency to the protest process for water, sewer and garbage rate increases," said HJTA Legislative Director David Wolfe. "Taxpayers deserve access to these important public records after a rate increase hearing in order to monitor public agencies. This is especially true in the event of a close vote."

Did Jesus Give Information About When He Will Come In The Clouds? by Marcia Cecil

Has the mystery been revealed through Jesus, as well as various Biblical prophets and Biblical scholars? Look and search for clues.

Mark 13:32 tells us that Jesus said that "no man knows the day or the hour." That statement is a Jewish idiom for the Feast of Trumpets, a Jewish feast day, which marks the first day of the Jewish civil calendar, Tishri 1. As one man suggested, we in the United States would know that "Turkey Day" means Thanksgiving; we just wouldn't know which year. One could add that we would know that Thanksgiving is on the fourth Thursday in November, the eleventh month on the Gregorian calendar. We just wouldn't know the day of the month, until we knew which year to reference. The Jewish people understood His statement, regarding the

month and day. We also learn in 1 Cor. 15:52 about "in the twinkling of an eye, at the last trumpet..." The "twinkling of an eye" is a Jewish idiom for the moment of sunset. The Feast of Trumpets begins at sunset, when the new moon is seen. Then the trumpets are sounded. The 100th blast is one long blast on a shofar, a ram's horn, and for this feast, it is referred to as "the last trump." The trumpets are blown on both days of that two-day feast or referred to as one long day. It is two days, as sometimes, the new moon could not be seen on the 29th day of the last month of the civil year, so the next sunset, being the 30th day of the last month, it was declared to be the New

the harvest. Our modern technology enables us to know that the Jewish civil New Year, for

Year. It followed the end of

this year, is on our calendar for October 3rd - 4th. Since the Jewish days begin at sunset the previous evening, it would be October 2nd when the new moon is visible. On a web search, we can find that sunset, on October 2nd, is at 6:22 PM, in Jerusalem. Jerusalem is 10 hours ahead of us on the West Coast of the USA. Therefore, the time will be 8:22 AM here, that Sunday morning.

The first Jewish Feast of the Lord, for the year, Passover, was fulfilled precisely, with Christ's crucifixion. As the crucifixion began, at the third hour of the Jewish day (9 AM), the morning sacrifice of the lambs began. Several Psalms were sung, ending in Psalm 118. As the evening sacrifice was ending, at the ninth Jewish hour (3 PM), and the Jewish Rabbi had sacrificed the last lamb. that Rabbi said, as was the tradition, "It is finished!" The Lamb of God said, "It is finished!" and bowed his head, at that same moment.

The body of Jesus was in the grave, during the Feast of Unleavened Bread. His resurrection was on the Feast of First Fruits. Jesus sent the Holy Spirit to the church, at the culmination of the seven weeks of the Feast of Weeks, which was from the Feast of First Fruits to the fiftieth day, Pentecost. That is the last of the Spring Feasts of the Lord.

As precisely as the first four Feasts of the Lord were fulfilled and in order, the last three Feasts of the Lord, the Fall Feasts, will be fulfilled precisely and in order. The Feasts of Trumpets is the next one to be fulfilled. Jesus will, as the Bridegroom, come in the clouds.

This is a Jubilee Year. Jubilee years come every 50th

year. It is believed that this

is the 120th Jubilee year.

In 2017, on September 23rd, as is described in Rev. 12:1 and 5, the sign of the woman clothed with the sun and the moon at her feet and a crown of twelve stars will appear in the sky. This is according to computer programs, which can project the location of the sun, the moon, the stars, and planets in the sky, for any day in the past or in the future. This is the symbolic birth of the King of Kings. The Feast of Trumpets, in 2017, begins at sunset, in Jerusalem, on September 20th, as the feast is celebrated on September 21-22.

The Jewish Father of the Bridegroom would be the one to decide when to send his son for his bride, when the place for her was ready. The custom was to say, "Only my Father knows." The Bride, which is the church of believers in Jesus as Lord and Savior, needs to remember to do as Jesus said, to keep watch and be ready for that day, whenever it is that He is coming in the clouds for all who believe in Him as Lord and Savior. (1 Thess. 4: 16-17)

We learn in John 3: 16 "For God so loved the world, that He gave His only begotten Son, that whosoever believes in Him shall not perish, but shall have eternal life." Each person needs to confess sins, with a sincere, sorrowful heart, and with the intention to turn from sin. Everyone needs to return to God, with our hearts set on fire for God. Ethnic Cleansing or Genocide?

It used to be said in America that we went to war against other nations to save threatened countries from terrorism, or communism, or totalitarian forms of government which oppressed the masses. Along with this, it was also said that it was for the sake of safety or freedom or to usher in democracy in order that voting rights would be given to the people.

But in the last fifteen or so years, regime change in various middle east countries has been favored and supported by the West, and that support has come from Washington D.C. but also from the likes of people such as

multibillionaire George Soros who funded unrest in Egypt.

But how has Africa, Egypt, Iraq, Syria or Libya even benefited from any kind of support of regime change, and I may add here, how many thousands of ethnic minorities and Christians have had to either flee or have perished due to the ethnic cleansing or genocide brought on my the Islamic State?

Recently, the European Parliament unanimously passed a resolution in February, 2016 recognizing the Islamic State militant group's (ISIS) and their systematic killing and persecution of religious minorities in the Middle East as "genocide."

According to the 1948 UN Convention, genocide is killing, harming, imposing harsh conditions, restricting birth, and forcing adoption when the intent is to "destroy, in whole or in part, a national, ethnical, racial or religious group." Yes, we are talking mass murder.

The **Parliamentary** vote, which was decided by a show of hands at the session in the French city of Strasbourg, was the first time the body has recognized an ongoing conflict situation as genocide. The resolution states that those who intentionally commit atrocities for ethnic or religious reasons should be brought to justice for violations against international law, crimes against humanity, and genocide.

Additionally, Amnesty International and the UN Human Rights Commissioner have accused the Islamic State of committing "ethnic cleansing on a historic scale by "systematically targeting ethnic minorities" in northern Iraq. The former UN High Commissioner for Human Rights, Navi Pillay, said that the Islamic State" is systematically targeting men, women and children based on their ethnic, religious or sectarian affiliation and is ruthlessly carrying out widespread religious ethnic and cleansing in the areas under its control."

Now then, let us not forget that in the last few years starting with Egypt, the desire was for "regime change" which was encouraged by the present U.S. administration that has now left parts of Africa along with the Middle East in flames, and what has been the benefit from this action? There was none. And as for the peacemakers, where are they to be found?

Bronze Casting Workshop for Veterans

"I was moved after 9/11 to help Veterans, active duty service men and women and their families through Art-making," said Mr. Dilley." "I feel a profound responsibility to reach out and help our military population and share all the benefits that the artistic process gives," he added.

Lost-wax casting is a sculpting process developed thousands of years ago. The name refers to

the fact that the mold is



destroyed to remove the final cast item. Lost-wax casting was widespread in Europe until the 18th century, when a piecemolding process gained in popularity.

"How often does anyone, artist or non-artist, get to experience the process of making a bronze sculpture," said David Read, YSA Executive Director. "We've all seen bronze statues and been amazed by their grandeur and longevity," he added, "but now we can see them being made first-hand."

The community is invited to attend the workshops to learn more about this process and to see the Veterans' creations take shape. The final bronzes

will come back to Yuba-Sutter from the Foundry in October and will be featured in a gallery showing at YSA next March.

South Yuba River Citizens League Seeks **Volunteers for Community Cleanup**

Nevada City, CA -

For the 19th year, the South Yuba River Citizens League (SYRCL) will unite the community at its Yuba River Cleanup on Saturday, September 17th. Since 1998, Yuba lovers have rallied to remove 195,000 pounds of trash and recycling from the watershed.

"Keeping the river clean, safe and healthy requires all us who love the Yuba to be active stewards. I've taken complaints about the litter problem at the Yuba all summer. The time to do something is now. I'm inviting the community to join this high impact event. Dedicating a few hours of work on Sept 17 will make a significant difference for the health of the Yuba and Bear rivers." said Caleb Dardick, Executive Director of SYRCL.

According to Dardick, "This effort is supported by State Parks, the Forest Service, Bureau of Land Management, the Army Corps of Engineers, Nevada Irrigation District, the Cities of Grass Valley and Nevada City, Nevada and Yuba Counties, Waste Management, as well as dozens of businesses, clubs, and school groups. We're committed to working at 30 or more sites, we just need the volunteer power to do it." said Caleb Dardick, SYRCL's Executive Director.

Last fall, 761 volunteers participate in the Cleanup and removed nearly 15,000 pounds of recyclables from approximately 90 miles of river, creek and lake shoreline at sites within the Bear and Yuba River watersheds.

"This massive cleanup effort would not be possible without the dedication of hundreds of volunteers devoted to protecting our local waterways," said Jenn Tamo, SYRCL's Community Engagement Manager. "We invite you to join this incredible community effort! Register to volunteer online at yubariver.org."

On September 17th, volunteers will embark on a watershed-wide hunt to rid the river of everything from micro-garbage like cigarette butts, bottle caps, shards of glass, and dog waste, to large and outlandish items such as washers and trailers. After the Cleanup, volunteers are invited to the Volunteer Appreciation Party in Pioneer Park, Nevada City from 1pm-4pm to enjoy music, great company, and a nohost beer garden with tasty brews from Jernigan's Tap House, Three Forks Brewery, Crispin Cider Co., and Tahoe Mountain Brewery. Registered volunteers will receive a delicious complimentary lunch, donated in part by the BriarPatch Co-op.

Keeping the river from being trashed is more than a one-day-a-year activity. Since 2012, a group of dedicated volunteer River Ambassadors have spent every summer weekend educating folks at the four major river crossings about how to keep the river clean and safe. This dedicated team promotes an ethic of responsible, non-polluting use of the river by speaking one-on-one with visitors at crossings, beaches and on trails. Using a friendly, non-confrontational approach, River Ambassadors bring awareness to the polluting impacts of trash and dog waste, the dangers of broken glass, and the catastrophic potential of wildfire. To date, River Ambassadors have spoken to over 26,000 river-goers, removed 29,000 pieces of trash, and collected nearly 4,000 piles of dog waste. These advocates work diligently to keep our rivers healthy by providing dog waste and trash bags to recreationists, too.

"The River Ambassador program and Yuba River Cleanup produce tangible benefits to our community, but these efforts have real, concrete costs. Volunteers, and even those who can't make it to the Cleanup, can help support a clean river year-round by asking friends and family to sponsor their day of service. 
