## CPUC Corrupt and Lawless – Commentary

When Marysville resident Connie Walczak thought her water bill was exorbitant she called City Hall for an explanation. She had no idea her water was owned and delivered by a corporation, Cal Water Service.

She called Supervisor John Nicoletti. He wanted her to meet Cal Water's local manager Lee Seidel to resolve any misunderstanding.

For Walczak, there was no misunderstanding. Residents were being ripped-off. In just a few years, lawns and landscaping went from lush green to brown and dying. Water bills were exceeding costs for PG and E.

Walczak declined a political rope-a-dope from Nicoletti and Seidel. She instead contacted the California Public Utility Commission (CPUC). The CPUC was formed to protect and advocate for consumers against rate abuse by powerful utility monopolies. Walczak's interaction with CPUC was difficult, finally being shooed away to an online complaint process.

An intelligent and tech-savvy Walczak found the process archaic and hostile. Complaints had to be crafted by hand and the protocol was legally prickly. In her interaction with the Administrative Judge and Cal Water's attorney about her complaint she realized the two were chummy. There was a clique and she was on the outs.

A recent Cal Water memo to Marysville customers indicated rates were going up 25%, but the increase would be scrutinized by the independent CPUC. That had to be written with "tongue in cheek." The entire CPUC rate-hike application is a Kabuki Dance between well-to-do commissioners and wealthy utility executives.

In fact, the commissioners are known to rotate out to work for utilities and utility employees frequently join the CPUC. Commissioners and executives hobnob, attending conferences and parties together and even join up for international travel. Judges set to hear rate cases are also suspect.

Those left out are tens of millions of small people, the rate-payers.

The CPUC's slimy-side got national exposure when the feds investigated PG and E's 30-inch gas line explosion killing 8 and injuring 58 in San Bruno. And now, the California Department of General Services confirms a culture of greed and lawlessness.

General Services' previous review was in 1995 though agencies with purchasing authority are to be evaluated every 3 years. Does anyone in government follow the rules anymore?

CPUC regulators signed contracts with private law firms they were not permitted to execute, failed to maintain required paperwork and paid vendors even when work was not performed to specifications. They did not hold utility companies accountable for their agreements.

The Commission did not process contracts in a timely manner and neglected to properly account for gasoline cards used by its employees, among other deficiencies.

At a cost of more than \$12 million to ratepayers, the CPUC has hired at least 3 law firms to respond to requests, subpoenas, search warrants and other demands from federal and state agencies investigating the agency.

The legal help was solicited to defend commissioners accused of wrong-doing in the San Bruno debacle and the San Onofre Nuclear Power Plant mismanagement and premature closing. In both cases the CPUC is accused of being complicit in benefitting the utilities and burying ratepayers with millions in rate increases to cover power company losses.

Investigators are reviewing improper contacts between regulators and utility company executives, including lavish meals, trips abroad and secret negotiations related to open proceedings.

CPUC Director and former Southern California Edison President Michael Peevey left the commission in controversy after 2-six year terms, but he remains under investigation. Peevey is married to State Senator Carol Liu.

The search warrant for the Peevey – Liu home describes looking for evidence of improper ex-parte communications, judge-shopping for utilities, bribery, obstruction of justice and favors for preferential treatment.

Citizens and small businesses are paying the highest utility bills in the country while residing in a state laden with resources. No state compares to California's natural abundance. However, politicians and regulators prevent and / or manipulate the use of water, hydropower, natural gas and fossil fuels extraction, the development of desalination plants etc.

This state should have the cheapest not the most expensive utilities. Politicians, unions, lobbyists and big business have recreated a government run for them and by them.

Many residents are finding it easier to move than fight. Walczak moved to Plumas Lake where water is one-third the cost of Cal Water's. Others are leaving for other states where most everything is cheaper, regulations easier and sanity prevails in government.

## Nevada County is Broke

*Insolvent in Real World Most of State Agencies in Same Condition*

California is in the midst of an economic disaster. The last paragraph gives the size of the coming economic collapse in California: "With the required inclusion of unfunded pension liabilities on their financial statements, virtually every public entity in California as well as the state itself is now financially insolvent."

In the real world, those in charge would be indicted for hiding the facts from investors (taxpayers). The companies would be forced to close, be sold or reorganized. When honest financial reporting is made, the California recovery is just in the

delusional mind of the very confused Guv Brown..

This could be your city, school district or county, but it is the financial condition of Nevada County, "Nevada County's unrestricted net financial position went from a positive \$29 million at the conclusion of the 2013-14 fiscal year to a negative \$109 million in 2015 — a swing of \$138 million.

On paper, our county is anything but financially healthy — it is technically insolvent!

The unfunded liability in the miscellaneous pension plan is \$127 million; in the Safety Plan it is \$19 million, resulting in a total

debt of \$146 million. Add to that another \$36 million of unfunded liability in the county's "Other Post-Employment Benefit Plans (OPEB)," and the county faces a combined unfunded liability of \$182 million — or \$1,850 for every man, woman, and child residing in Nevada County. That doesn't even include the millions more of unfunded liabilities county taxpayers face in the pension plans of state employees, and school and fire district employees."

Maybe it is time to leave Dodge—before you are financially destroyed.

## California Marijuana Legalization Initiative on November Ballot

The California Secretary of State is reporting that a statewide ballot measure which, if approved by the voters, will legalize the recreational use of marijuana and the products of hemp has gained sufficient signatures to appear on the statewide Presidential Election Ballot November 8th.

The "Control, Regulate and Tax Adult Use of Marijuana Act" would designate state agencies to control and regulate the marijuana industry.

Under the Act, the state would impose a 15% excise tax on retail sales, and cultivation taxes of \$9.25 per ounce of flowers and

\$2.75 per ounce of leaves. Local governments would still maintain control and would be able to control, regulate, and tax products.

Medical marijuana would be exempted from taxation.

In addition, standards for packaging, labeling, advertising, and marketing restrictions would be established. Advertising and marketing to those under 21 would be prohibited.

Also under the Act, resentencing and destruction of records for prior marijuana offenses would be allowed.

The Legislative Analyst indicates the Act would result in "Net

reduced costs ranging from tens of millions to potentially exceeding \$100 million annually to state and local governments related to enforcing certain marijuana related offenses, handling the related criminal cases in the court system, and incarcerating and supervising certain marijuana offenders."

The Analyst's report continues with the statement of potential "Net additional state and local tax revenues potentially ranging from the high hundreds of millions of

# Gold Sox Win Series Against Crushers

Improve to 17-4 in the Great West League

Marysville, Ca. – The Marysville Gold Sox took two of three games from the Lodi Crushers over the weekend to improve to 17 – 4 in the Great West League on the season. Though the Gold Sox did drop their first game in Colusa Casino Stadium, they are still 9 – 1 at home on the year.

The Sox started the series with a thrilling extra inning win on Friday night. After going up 4 – 0 early, they pulled out a 5 – 4 victory at Tony Zupo Field in Lodi in the tenth inning. Steven Mercado finished 2 for 5 with two RBIs and Dalton DeVries and Hunter Stratton each had two hits as well. Austin Call and Jed Sprague each had RBIs in the win, but it was closer Kyle Merkel who came up big in the bottom of the 10th inning. Lodi loaded the bases with no outs, but Merkel got a groundball double play and induced another grounder to preserve the win.

One day later, the Gold Sox got on a bus and headed home to Marysville for Game 2 of the series, but dropped their

first game at Colusa Casino Stadium 11 – 7. The Sox and Crushers exchanged blows back and forth all game long, with the Gold Sox coming back from an early 5 – 2 deficit to tie the game at 5 runs apiece in the second. But the Crushers would take the lead for good in the fifth inning when they scored three more runs. Hunter Stratton led the way for the Gold Sox going 3 for 5 with a double and three RBIs. Kyle Hoffman went 3 for 5 and Darrell Doll and Ryan Weisenberg each finished 2 for 4 with a double and an RBI. Though the Sox didn’t pull out the win, fans were still treated to a fireworks display after the game sponsored by Feather Falls Casino.

The Gold Sox got back on track on Sunday after taking the bus back to Lodi to play at Tony Zupo Field. The 10 – 5 victory kept the Gold Sox three games up over the Medford Rogues in the Great West League. Starter Zach Kornely threw six innings of one run ball for the win. He gave up seven hits and recorded three strikeouts. Ryan Weisenberg led the way going 2 for 3 with two runs and Taggart Baxter went 2 for 3 with two walks and two runs. The big hit came off the bat of Darrel Doll though, who recorded a bases-loaded double in the sixth inning to drive in three runs and cap off a six-run rally that put the game out of reach for the Crushers.

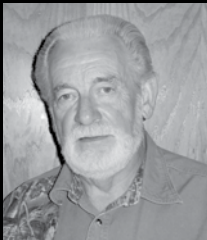

# FISHIN’ TALK

We hope everyone had a wonderful Fourth of July Holiday celebrating America’s birthday and that some of you got to get in some fishing.

With the hot weather upon us it is time to think about fishing lakes and reservoirs deep where all the fish go to find comfortable water temperatures. While on this subject remember to keep your minnow, jig or night crawler on the bottom. This is where you will find fish year round and not just during the summer months. I know for a fact that if you are not catching fish on a regular basis you are more than likely not on the bottom of the lake or reservoir. If you worry about snags and loosing gear you will not catch fish consistently. When you find fish on your electronics on or near the bottom, usually hanging out off of steep canyon walls, next to submerged tree stumps or large rocks, drop a line and go for the bottom and chum with minnows, night crawlers or jigs. When your weight hits the bottom raise your rod up and down as you move slowly over the area with your trolling

motor or kicker motor.

A report from Bullards Bar Reservoir tells us the bass fishing is slow at this time. However, the kokanee salmon are co-operating at the Willow Creek Arm. Anglers are having luck using dodger/hoochies.

Lake Oroville is down 26 feet from full capacity. For bass try the inlet of the North Fork of the Feather River. Spinners have been putting bass in the boat. Check the water temperature and fish in 62 degrees. If it is salmon you are after we suggest trolling near the dam in 30 to 70 feet of

water using hardware.

Scotts Flat Reservoir is almost full and both boats and bank fishing is producing trout and bass.

Catfish, bass and crappie are hitting at Collins Lake with some catfish being caught up to seven pounds and sunfish coming to the net as big as your hand.

Boots fishing tip of the week: When jigging for trout or bass it is not necessary to set the hook on a strike. Fish will usually hook themselves during the up and down motion of your rod.

dollars to over \$1 billion annually related to the production and sale of marijuana. Most of these funds would be required to be spent for specific purposes such as substance use disorder education, prevention, and treatment.”

The initiative required approximately 400 thousand signatures. Over 600 thousand were submitted.

California was the leader in legalizing medical marijuana in 1966. Since then, the District of Columbia and 22 additional states have followed suit,

Currently, four states, Alaska, Colorado, Oregon, and Washington, and the District of Columbia allow recreational use for adults.

Although opinion polls show voters leaning towards legalization, opponents have not been deterred. A growing number of public safety organizations are weighing in against legalization. They argue the risks of the drug outweigh the rewards and the Act would make marijuana more readily acces-

sible to juveniles.

The voters will ultimately decide the fate of the “Control, Regulate and Tax Adult Use of Marijuana Act,” but,

## Commercial Cannabis Cultivation on Ballot In Yuba County

In addition to the statewide ballot measure which would legalize marijuana for adult recreational use, Yuba County's voters will have another opportunity to vote on a countywide cannabis voter initiative on the November 8th Presidential Election Ballot.

The “Regulation of Commercial Medical Cannabis Cultivation and Related Activity” initiative qualified for placement before the voters when the Elections Office deemed 1242 of the submitted 2448 signatures sufficient.

A review of a summary from County Counsel indicates if passed, it will authorize commercial medical cannabis related activity within the county. It will

not before hearing months of rhetoric from proponents and opponents of legalization as both sides ramp up their campaigns.

require regulation of cultivation, manufacturing, distribution, and transportation of medical cannabis. In addition, all existing cannabis cultivation and commercial cannabis operations would be required to comply with the new regulations within 12 months of passage.

If approved by the voters, the summary indicates the regulations would establish specific zoning and establish criteria for permitting. The scale of all cannabis operations must be in compliance with California's Medical Marijuana Regulation and Safety Act.

Additionally, property owner authorization would be required if the cultivator is not the owner of record. There must be a legal residence on the property and the cultivator must provide a grow site plan, an irrigation plan, and maintain a legal water source.

Per Council's summary, “if the initiative is adopted it would be unlawful to engage in any commercial cannabis activity other than cultivation without first obtaining all required state and county licenses or permits.”

Much like the statewide ballot attempt for legalization of marijuana for adult recreational use, opponents and proponents of this initiative in Yuba County will provide ample opportunities for voters to hear each side of the issue before Election Day.

## PLUMAS RESOURCE ADVISORY COMMITTEE MEMBERS NEEDED

QUINCY, Ca. – Plumas National Forest officials are seeking to fill 15 seats on a federal advisory committee (RAC) responsible for selected projects on federal land within Plumas County.

“We have received interest from about ten individuals since January but need at least double that to fill existing vacancies and alternate slots,” said Acting Forest Supervisor Daniel Lovato. Deadline for applications is July 15, 2016.

Once appointed by the Secretary of Agriculture, the RAC will review projects to recommend for funding consideration by the Plumas National Forest Supervisor. Just under \$500,000 will be available for projects to be initiated by September 2017 and funding obligated by September 2018.

RACs were established as a provision of the Secure Rural Schools and Community Self-Determination Act of 2000. By law the four-year term, 15-member committee is composed of a wide representation of national forest interests organized into the three categories. An additional member is also appointed as a replacement should a committee member leave for any reason.

RAC projects must have broad community-based support with objectives that may include, but are not limited to, road, trail and infrastructure maintenance or obliteration; soil productivity improvements; improvements in forest ecosystem health; watershed restoration and maintenance; restoration, maintenance and improvement of wildlife and fish habitat; control of noxious and exotic weeds; hazardous fuels reduction; and reintroduction of native species.

Projects must be on public land but can occur on private land if it can be demonstrated that there is a benefit to public land resources.

## The Ponzi Scheme

The biggest scam on Wall Street involved a former head of the Nasdaq stock exchange Bernie Madoff.

He was convicted of running a Ponzi scheme named after investor Charles Ponzi. The Ponzi scheme is a simple one and an old scam. Much like a pyramid scheme, you simply claim outrageous returns, and pay investors interest on their money with money from new investors. No money is ever really made, you just take it from the new investors and give it to the older investors. You claim to be making money but in reality you are not.

The Madoff scam was one of the biggest headlines in the news at the time.

It was said schemes like this are what happens when easy money and credit pour out of the monetary authorities in the way of low interest rates and then finds its way into the latest and greatest of bubbles.

There are many disturbing facts surrounding this case, one being the Bernie Madoff was indeed the head of the Nasdaq stock exchange a few short years ago before the scheme surface at his firm, Bernard L. Madoff Investment Securities LLC in 1960, and Madoff was its

chairman until his arrest on December 11, 2008

He apparently learned his trade well heading up one of our most lucrative US stock exchanges.

You have to wonder when the former head of one of our biggest exchanges morphs into a crook, what kind of people are overseeing our retirement funds and stock account money.

Madoff's scheme netted somewhere in the area of 50 billion dollars or so.

Interestingly, the SEC, the regulatory agency which is supposed to police things like this, had received numerous reports about the possibility of scam and even looked into the firm multiple times and found nothing. That spawns the question, what kind of regulatory body is the SEC and how effective they really are.

The Congress is always calling for more regulations, but what good are more regulations when you miss obvious scams with the rules you do have.

More rules won't solve the problem if the authorities don't use those rules in their practice of oversight.

The SEC had plenty of ways to shut Madoff down should they have found something but they did not.

Did they simply look the other way? Did the proverbial "old boy" network have anything to do with the lack of discovery even though the complaints were numerous?

Although Madoff was hauled off to the hoosegow for his Ponzi-like scheme, most governments of the world could be said to operate the exact same scheme.

One example might be the Social Security system. This was originally and still labeled a trust fund which means our retirement money is supposed to be locked away, safe and sound and paid out when we retire.

But the Government spends all of it and has for years.

They just pay current entitlements with money

from new workers and put in IOU's to make up any shortfall. Sounds like

a Ponzi scheme to me, the exact same thing Madoff was forced to put on an orange jumpsuit for.

The money system of the Federal Reserve also has similar qualities.

The Federal Reserve prints money at will and buys Treasuries from another branch of the government. They then issue these Treasuries as IOUS. When the IOUS come due, they just buy back these IOUS with more printed money, in essence buying back its own debt with more debt.

This is similar to using new investor's money to pay old investors. The Feds take it one step further and conjures up more money from nothingness with a computer keystroke. Madoff himself never went that far!

It could be argued there is little difference between what Madoff did and what the U.S. Government does everyday. But Madoffs problem was he is not the U.S. government and also didn't own a printing press of which the US Government does.

Madoff's went to prison because of the way he handled other people money, illegally.

But that particular illegality isn't all inclusive to everyone and every institution.

The same type of thing is used to finance our country and many of our governmental programs. I guess the eyes of justice aren't so blind after all. It might be said they look the other way where the government is involved.

## Captain J.R. Rideout – his life and legacy

Part 1 by Carol Withington



When news reached the Marysville community in 1899 of the death of Captain James Ransom Rideout, age 71, many of his former friends and acquaintances were saddened. Although Rideout had not lived in the area for some time, they would recall the years he served as Captain of the freight and passenger boats that ran up the Sacramento and Feather rivers.

A native of Maine, Rideout made his mark in Yuba County as far back as 1867 when he was elected County Treasurer, serving for one term. Seven years later, Rideout, along with D.E. Knight and W.T. Ellis started a new line of steamers. They first purchased the "C.M. Small"-a stern-wheel, low-water boat, which was placed enroute to San Francisco. The next year, the trio built the stern-wheel "D.E. Knight" in Marysville.

Both the "C.M. Small" and the "D.E. Knight" were also used as freight boats. Each carried grain and produce to San Francisco and would return loaded with merchandise.

In addition, Knight, Ellis and Rideout owned four barges, which were towed by the steamers. They included the "Hope", the "Marysville", the "Sutter" and the "Paradise". Both steamers and barges would meet daily challenges especially during the late spring and summer months.

Because of the effects of mining debris which filled up the Yuba river, it was impossible for steamers or large barges to ascend the river and make a landing at Marysville during the dry seasons. All merchandise destined to Marysville either landed at Yuba City or on the opposite bank of the Feather river where a small freight

shed was built. From there, goods were taken to Marysville with teams.

It was somewhat better during the winter months or seasons of high water when boats were able to maneuver as far as the D Street bridge and land at the levee, thus saving the merchants of Marysville.

According to research, Rideout eventually moved to the Bay Area with his family. He last lived in Sausalito where he died. His survivors included brothers Norman Dunning Rideout and Benjamin Rideout of San Francisco; sisters Mrs. Justus Greely of Marysville and Mrs. Thresher of Stockton, along with his wife, two sons and a daughter, who at the age of 25 was already considered a "renowned" sculptor. Alice Rideout will be featured in an August edition.

Additionally, the home is within 200 feet of the nearest school bus stop where children are picked-up and dropped off 5 days a week.

There is no public transportation provided in this area and it is unknown how he will get into Marysville or Yuba City.

Another concern, this home is surrounded by orchards and, once in one of those orchards, he will

be able to travel through the area unnoticed and have unfettered access to the Saddle Back development within minutes

This area does not need a criminal from another county! Yuba County, Marysville and Yuba City should be extremely upset at any attempt the authorities make which will expose us and our neighbors to this unnecessary threat.

### Yuba-Sutter Mental Health Has New Name

Effective July 1, 2016, Sutter-Yuba Mental Health Services is going by a new name: Sutter-Yuba Behavioral Health.

For decades, residents of Sutter and Yuba Counties have received mental health and substance use disorder treatment at Sutter-Yuba Mental Health Services (SYMHS). The title of this long-time community service provider has made no mention of substance use disorder treatment.

On July 8, 2014 the Mental Health Advisory Board and the Substance Use Advisory Board decided to merge the two consumer, family, and community member-run boards and create one integrated advisory board. This new board was titled the Behavioral Health Advisory Board. Since this time, SYMHS has been steadily integrating mental health and substance use treatment programs.

By integrating these disciplines, services are being tailored to better address the needs of individuals with complex mental health and substance use challenges.

In addition, across the state, the merging of mental health and substance use disorder functions at the county level has increased the use of the term “behavioral” which succinctly bridges the traditional gap between the disciplines of mental health and alcohol and other drug treatment providers.

On May 24, 2016 the Sutter County Board of Supervisors approved a request to change the name of Sutter-Yuba Mental Health Services to Sutter-Yuba Behavioral Health, effective July 1, 2016.

In addition to the name change, Sutter-Yuba Behavioral Health has adopted a logo that encompasses the belief that each mind matters, that recovery from mental illness and substance use disorders is possible, and that we can be the catalyst to empower a healthy community. Our name will change, but our commitment to providing essential mental health and substance use disorder treatment services for our bi-county community is unchanging.

## Ben’s 47 8N

As one drives around the Yuba Sutter Basin, one will notice a plethora of road names after long time farming families. These families and their tools, efforts, work ethic and persistence helped to develop what we see today. If you go out north in District 10 you will see Mathews Lane, downtown it may be Oji Way, out on 20 Tarke Way is noticed.

This tractor belonged to Ben Goff a long time resident and businessman.

Ben began his mechanic career by working on the Wisconsin Engines of the Southern Pacific which used them for their little putt-putt cars that worked on the rails. After he left SP, he went to work at the King Dollar Tire Store at the corner of Plumas and 20. Ben became agitated

because of the way he was being treated. Ben was a wonderful man and possessed a keen sense of fairness. So, not to be outdone, he somehow acquired the property across the street and named his tire store "Queen Penny". He later used the name for his garage in Oregon House. Just about every time I go past the Queen Penny Tire Store I smile and remember what a great neighbor Ben was and how blessed I was to have him as a neighbor. The name outlasted him.

Ben used his 8N on his 20 Acres in Oregon House. Discing, mowing, digging post hole, pulling a trailer and generally improving his parcel were among its uses.

The 8 N was introduced in late 1947 but

is often suggested that it was introduced in 48. Manufacturing years and calendar years are not always the same. The serial number is just 292, which makes it a very early number. The features of the Ford made it a very popular tractor and there were about 524,000 produced. The engines offered were gasoline and distillate. Finding a distillate today would be a collector’s dream. The rated drawbar horsepower was 23.16 and the PTO was claimed at 27, but would only test 21. The three point hitch would lift about 800 pounds. The tractor weighed in a range of 2,400 to 4,043 depending on the options. Just wheel weights could make a considerable difference.

## Sutter County Receives Grant For Public Safety Programs

The Sutter County Board of Supervisors accepted a Homeland Security Grant for \$172,501 Tuesday, June 28 to provide training and equipment to six local agencies involved in emergency management response.

Funds from the 2015-2018 Homeland Security Grant will be distributed between the Sutter County Office of Emergency Management, Sutter County Public Health, Sutter County Sheriff’s Department, Sutter County Fire, Yuba City Police Department, and Yuba City Fire Department, according to Sutter County Emergency Operations and Loss Prevention Manager Lori Hersant.

The Board of Supervisors authorized the county to apply for the grant in September of 2015. The grant will provide: \$39,312 to the Sutter County Sheriff’s Department toward an upgrade of the base unit radio communication console; \$23,000 to Sutter County fire for personal protective equipment; \$20,000 to Sutter County Public Health for emergency preparedness training;

\$20,001 to Sutter County for the Emergency Operation Center IT equipment upgrade and training; \$40,000 to the Yuba City Fire Department for search and rescue equipment; and \$21,563 to the Yuba City Police Department for mobile radio enhancements.

Sutter County will receive \$8,625 for administering the Homeland Security Grant.

## High School Students Run Mock Council Meeting

After three weeks immersed in the inner workings of local government, 18 Yuba City high school students will graduate from a summer program after conducting a mock city council meeting. Since late May, students from Yuba City and River Valley High Schools have spent their weekdays at Summer @ City Hall (S@CH), learning from employees and elected officials about government's many career opportunities.

S@CH concluded with a mock council meeting in the Yuba City Council Chambers, followed immediately after by a graduation ceremony. During the mock meeting, the students ruled on three issues while serving in the assigned roles of city administrators, council members and citizens.

The students are incoming juniors and seniors who applied and interviewed for the opportunity to learn about government careers. From 8:30 a.m. to 3 p.m. each weekday, they have spent nearly 100 hours at City Hall and at City facilities to learn all that encompasses a job in government and the path it takes to achieve such a career.

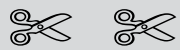
"We are honored to support our local students by demonstrating a career pathway in government," said Yuba City Coun-

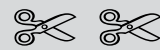
The S@CH program is funded by a Northern California Science Technology, Research, Engineering, Arts and Math (STREAM) Grant through the Sutter County Superintendent of Schools Office. Yuba City Unified School District partnered with the City of Yuba City to provide a teacher and curriculum. With funding already in place for the 2017 summer, the three agencies are excited to further this partnership next year and continue to provide a valuable real-life opportunity to area high school students.

River Valley High School teacher Lauren Ewert administered the daily classes, which included tours of every City facility, from the Water Treatment Plant to a Yuba City Fire Station; presentations by the majority of City department heads; and meetings with county officials and State Assemblyman James Gallagher and Senator Jim Nielsen. Each student also experienced two three-hour job shadows with City employees in jobs ranging from public works crew members and animal services to finance and the city manager's office.

"This isn't your standard summer school. These students recognized an invaluable learning opportunity and volunteered their time to study up on what could be their future," Ewert said. "It was incredible to witness a spark with every realization of the magnitude of possibilities."
