Rumley Oil Pull



The spectators of the Marysville Heritage Faire got a once in a life time experience at the tractor display area. They experienced the driving and running of a Rumley Oil Pull. The loud "Boom Boom" of the engine was a sound they will never forget! The 1929 Model W was a powerful tractor which was much smaller than that pictured. The Model W owned by Mr. and Mrs. John Ferris of Chico was featured on the cover of the Territorial Dispatch prior to the Faire.

The Rumley Company began in La Porte Indiana in 1853 and purchased the Advance Threshing Company in 1910 and in the process became Advance Rumley. They manufactured farm equipment and produced steam tractors. Steam had been on the scene for about 100 years but at this time was beginning to phase out. Steam tractors were very heavy, slow, took at least four cords of wood a day and many required 2,000 gallons of water a day. The supply task was monumental, particularly if you were in Kansas or other locations. One of the first tractors in the area was a large Case Steam which was in a shed west of Live Oak. My understanding is that it went back east to an auction.

The engineers of Advance Rumley felt that if they built a tractor somewhat like a steam tractor it would sell better, thus they looked like the 16-30 even though the power was an internal combustion engine. A variety of sizes were built and by 1928 they were producing the Do-All which looked more like a utility four wheel unit.

The Rumley Oil Pull was famous for reliability, power and economy of operation. The designers came up with a two cylinder horizontal engine (John Secor) and used a carb that fed water into the firing chamber that prevented pre- ignition and "knock (William Higgins). They decided to use an inexpensive fuel available in quantity at that time, kerosene. Kerosene needs a higher temperature for combustion and water would vaporize quickly, so they used oil to cool the engine. Thus , the name came into being "Rumley Oil Pull. In England it was called the Overtime. The pictured 16-30 weighs about 9,500 pounds, others exceeded 26,000 pounds. About 56,647 Rumleys were known to be built.

Because of their weight which caused a high soil impaction they were not popular for rice farming areas but we did have Rumley's in the area. Most commonly they were used in dry crops and were often used in groups pulling multiple plows. This tractor spent many years on the Godfrey Humann farm in Tehama County.

Weckman Target in Defamation Lawsuit

The co-authors of Yuba County's Measure A have filed a lawsuit in Yuba County's Superior Court against Clarence "Buck" Weckman.

They claim Weckman, the self-proclaimed leader of the opposition to Measure A, has made false statements about them in an ongoing battle over medical marijuana.

Measure A''s backers claim it would provide a fiscally responsible alternative to the current medical marijuana ordinance and would provide more than a \$1,000,000 annually for the county's general fund.

Weckman charges that Measure A is just a front for the commercialization of "pot."

In the suit filed May 12th, Yuba County resident Michelle Parsons and Butte County resident Angelique Perez claim the sole intention of Yuba County resident Clarence "Buck" Weckman in making the alleged false statements "was to harass, harm the plaintiffs, Plaintiffs' husband's business, shame them in front of their community and tointentionally and specifically harm their character and reputation."

The offending statements were allegedly made by Weckman at a debate forum held May 9th.

One statement, that Parsons property was the subject of a criminal search warrant obtained by the Yuba County Sheriff's Department after she had denied officers entrance, is refuted in court papers filed by the plaintiff's Attorney Charnel James. "The defendant (Weckman) knows that Plaintiff Parsons was never subject to criminal investigation or was she ever charged with a crime. He is also aware that her only issue she had with the county was a code enforcement issue, as he was at the code enforcement hear-

ing in front of the Board of Supervisors. These statements are false."

Charnel James works out of an office in Marysville.

James provided a copy of a cease-and-desist letter dated May 6th in which she claims Weckman was given ample notice a lawsuit would be filed against him if he failed to remove all references to Parsons on his websites and Facebook pages within 72 hours. The letter continues "Furthermore, any more personal attacks on my client will result in a lawsuit against you."

The suit also alleges the "Defendant (Weckman) has also published on his website specific allegations against Plaintiff Perez about criminal activity including selling drugs to children and making profits from criminal drug dealers. He specifically refers to the store owned by Plaintiff Perez, and it can only be inferred that she was the person he was speaking about in his website."

The lawsuit charges "Defendant (Weckman) knows that Plaintiff Perez is not a drug dealer, nor is she a criminal, and has stated such only to harass, embarrass, and harm her business."

Perez operates "Two Chicks, a garden supply store in Marysville.

In an interview, Parsons said "Weckman also acted with total disregard of the facts when he wrote "April 6, 2016: The backers of Measure A continue their attempt to shove down our throats outdoor commercial marijuana growing with up to 60 plants, filed a court case challenging the Arguments placed on June 7th sample ballot pamphlet. They wanted 13 of the Arguments against Measure A thrown out. Except for one small technicality, they lost the entire case. More Superior Court time and money spent in listening to their Pot induced ramblings."

Parsons said "In reality, Measure A's backers have not, at any time, filed a Superior Court challenge to the ballot arguments against Measure A. She said "It is indicative of another false claim by Weckman."

Weckman has also attacked the financing of Measure A. On a website which he founded, it is stated "The few medical marijuana users are being used as pawns by out of Yuba County and out of State Interests. Over \$20,000.00 has been contributed by these special interests from locations such as Reno, Nevada; New Washoe City, Nevada and Brooklyn, New York. They are also supported by an Attorney in Rapid City, South Dakota and a National pro marijuana

The Marysville Gold Sox today announced the signing of junior pitcher Zack Kornely from Abilene Christian University for the 2016 season.

The 6' 3" 205 pound right handed Kornely has pitched to a 5.02 ERA through 14 innings with 16 strikeouts to 6 walks in 2016 for the Wildcats. Kornely earned a spot on the NJCAA all-academic team in 2015 and was a first team all-state selection in high school as well as his district's pitcher of the year in North Richland Hills, Texas.

"Kornely is a guy that we're excited to work with to refine his pitch ability. Anytime you see a guy with more 1:1 K's to Innings Pitched you know right away that he has plus stuff. Food and Farm News

Farmers assess hail damage

In the wake of hailstorms that raced through California last week, farmers and agricultural officials will spend the coming days assessing damage. Peach growers in the Sacramento Valley say hail hit their orchards hard, ruining as much as 10 percent of the statewide canningpeach crop. Cherry farmers in the San Joaquin Valley say the storms hurt their fruit. Crop surveyors also report hail damage to tomatoes and cotton in the Central Valley.

California rice acreage recovers

The improved water outlook in Northern California has led to a recovery in rice planting. Farmers say that will help rural businesses such as rice

mills and seed sellers that suffered during previous, drought-reduced crops. California rice farmers say the improved plantings should also help them regain markets from farmers in other states and nations. A government crop report says farmers have planted about 40 percent of the California rice crop so far.

Study looks at history of carrots

In announcing their achievement in sequencing the carrot genome, researchers say they've traced domestication of the plant back more than 1,000 years--and that wild carrots may have coexisted with dinosaurs. The researchers say their genetic work could lead to further improvements in carrot nutrition. The crop already represents the richest source of vitamin A in the American diet. California farms grow more than 80 percent of the nation's carrot crop.

Student chefs learn about egg standards

Learning what distinguishes a Grade A or AA egg could make the difference in creating a successful meal, which is why student chefs at San Joaquin Delta College in Stockton received a briefing on egg standards from U.S. Department of Agriculture specialists. The USDA establishes quality standards for eggs and a variety of other agricultural products. At the Stockton seminar, specialists provided culinary students with tips on how to judge egg quality.



Collins Lake is again planting more trout this week. 2000 pounds of trout were released which had many anglers having a ball catching



the fish.

Bass fishing is still hot on Lake Oroville. The fish were just about hitting anything placed in the water in front of their nose.

Both bass and trout are on the bite at Scott's Flat Reservoir above Nevada City off of State Route 20. Apparently the Marina area has been the hot spot for rainbows using dough bait.

South Yuba River Citizens League, The Sierra Fund and Wolf Creek Community Alliance are hosting this exciting and educational event to celebrate the fun of fishing with kids of all ages, while raising awareness around which fish are safe to eat and which might be better caught and then released.

On May 21st, kids can join in on several fish-themed activities and games, while teens and parents will have an opportunity to talk with experts about fishing locations, the history of mercury in our watershed, health impacts of eating mercury contaminated fish, and how families can safeguard their children by choosing fish that are safe to eat.

Mercury and Fish

Understanding how to prevent mercury exposure through fish consumption is important because of the legacy of mining in the Sierra Nevada. Mercury was first introduced to this area during the Gold Rush for use in gold processing. Of the 26 million pounds

and getting into our fish.

Eating mercury contaminated fish is the primary human exposure pathway to mercury. This is particularly relevant in the Sierra, where elevated levels of mercury have been found in mining-impacted waterways, like the Bear and Yuba watersheds.

An Annual Volunteer Effort

In order to protect anglers and their families from eating mercury contaminated fish, South Yuba River Citizens League, The Sierra Fund and Wolf Creek Community Alliance organized a community volunteer event last July to post state-issued fish consumption advisories in the Bear and Yuba watersheds.

The advisories, issued by the California Office of Environmental Health Hazard Assessment, cover mercury in fish and offer "safe eating guidelines" for consuming fish from California's lakes and reservoirs. On July 11, 2015, volun-







visit the financial agreement. Rather than receiving just \$697,120 firm from the Rancheria, \$10 Yuba Co. Public Works fees indicates citizens would have received more like \$1.2 million in fees from a non-tribal development of similar size. Supervisors like Nicoletti. Griego and LeVake of L

letti, Griego and LeVake are comfortable taking contributions and then moving projects forward for donors. They have taken money from developers of the Magnolia Ranch in Yuba County and proposed projects in South Sutter County.

LeVake joined Sutter County board members in slowing down SMUD's (Sacramento Municipal Utility District) proposed Colusa-Sutter Transmission Project to bring cheaper and cleaner surplus power here from the Northwest. New lines would be needed through farmlands and rural areas. Some affected farmers are opposed to it due to the difficulty in working around the towers and power lines.

Although a potential benefit to businesses and residents SMUD's cheaper power would compete with local energy companies like Calpine. According to her campaign disclosure Supervisor LeVake's lobbying firm received between \$10,000 - \$100,000 in fees from Calpine and Calpine made a \$1,000 contribution to her election effort.

Congressman Doug La Malfa's campaign slogan says he is "One of Us." He once represented Yuba-Sutter in Sacramento but now has Congressional District 1 to the north and east. La Malfa's recent votes funding Planned Parenthood, Obamacare, and supporting the Trans-Pacific Partnership are confusing.

What does he mean by "Us?" His district is one of the most conservative in the state yet he received only a 68% conservative rating from Heritage Action Voting Scorecard. In contrast, Congressman Tom McClintock (Dist 4 - east and south of Yuba-Sutter) earned an 87% ranking.

No wonder so many don't vote. Politicians are faster than the eye can perceive. Comedian Will Rogers said, "America has the best politicians money can buy." Maybe that's how candidates enter office with thousands and retire with millions.



How We Got Here, Measures A and B

In 1979, the National Organization for Reform of Marijuana Laws (NORML) Executive Director, Keith Stroup, announced they (NORML) would use the medical marijuana issue as a "red herring to give marijuana a good name."

So the movement begins, leading to 1996, when California Voters passed Proposition 215. the so called Compassionate Use Act. Proposition 215, was written by many time arrested San Francisco drug dealer Dennis Peron and funded by George Soros, the billionaire financier of far left radical causes. Upon passage of Proposition 215, NORML's Executive Director, Allen St. Pierre, proclaimed, "In California, Marijuana has been defacto legalized under the quise of medical marijuana."

As written, Proposition 215 was unenforceable, creating a subculture of people/patients" "sick and a subculture of marijuana growers euphemistically referred to as "cannabis farmers," to provide "medicine" for the "sick people." I can unequivocally state that the motive of most "cannabis farmers" is anything but altruistic; it's more about padding their wallets.

What followed was a series of intertwining events that leads to Yuba County voters making a critical decision on the future of our life style in Yuba County: Measures A and B.

One of the authors of arguments for Measure A is a young woman who says that if not for "medical marijuana" she would be bedridden for life. She, and other qualifying "sick people," knows that under Yuba County's Ordinance 1542, they can produce enough marijuana to meet their personal needs. Yet, she promotes

Measure A which is nothing more than a veiled attempt to legalize unfettered, illegal commercial marijuana growing in Yuba County. As written, county officers and deputies cannot independently make compliance inspections unless there has been a written complaint by those living within 600 feet of the grown plants, even if those officers see a non-compliant grow site. It is a constitutional right that any citizen or non-citizen can make a complaint, in writing, verbally or anonymously. Also, law enforcement officers cannot, nor should not be mandated to not enforce the law, for offenses committed in their presence.

Measure B is sponsored by a Bay area longtime lobbyist for the legalization of marijuana for any purpose. In March 2008, he plead guilty to one count of conspiracy to manufacture a mixture substance containor ing marijuana, a federal, felony offense. A federal court judge gave him a 24 month sentence, followed by 5 years federal probation.

Measure B is a scheme to establish up to five marijuana dispensaries in Yuba County, combined with the two authorized by the Marysville City Council, for a total of seven dispensaries- about the same number of legal pharmacies in the entire county. Just how many "sick people/ patients" do we have in Yuba County that require medical mariiuana?

Measure B is so terribly flawed, space does does not permit me to point them all out, example: doesn't require background checks on dispensary workers; doesn't require any form of quality assurance or inspection to protect customers, (sick people/patients) from buying tainted or inferior products, etc.

Marijuana dispensaries, (pot shops) are notorious for illegally providing marijuana to young people under the guise of "medicine." For example, a law enforcement raid on a city of Chico marijuana dispensary revealed а total of 3,972 doctor recommendations; 2, 059 or 51% of the total were for "sick people/patients" under 30 years old; 210 or 4% for "sick people/ patients" in the 60 to 90 year old group. Need I say more?

The Measure B campaign posted shamefully, deceptive billboards in the area of Yuba College and one directly across the street from Marysville High school that states, "Because Health is Your Right, Yes on Measure B, Vote June 7th." Ironically, the State lawmakers just passed a law raising the age of tobacco sales from 18 to 21 to protect our youth from the proven cancer causing chemicals, which are many more times more concentrated in marijuana smoke.

In March 2016, the University of California Davis released a Study that mirrors many I have seen in my 36 year law enforcement career. One sentence summaries the UCD Study: "The results are consistent with findings from studies that have shown that Cannabis (marijuana) was associated with reduced income and education, increased welfare dependence, crime and lower relationship satisfaction."

Yuba City Water and Sewer Rate Proposals

On April 18 a public hearing-Prop 218 notices were mailed to Yuba City water and sewer users.

The notices alerted people to the dates of the Protest hearing- June 8 at 6 PM at Yuba City Council chambers.

The notice vaguely referenced that if a written protest by parcel owners or water or sewer users with "a respect to a majority of the parcels" were turned in by June 8 the rate increases will not be imposed. In the case of Yuba City water users this translates to about 9,000 protests to stop the increases. In the case of city sewer users roughly 8,000 protests are needed to stop the increases.

What are the proposed rate increases? For city sewer users the rates will increase 10% a year over the next five years. For single family customers the current bill of \$40.53 per month will increase to \$65.27 per month by the beginning of the fifth year. This is a cumulative increase of 61% over today's sewer charge.

For Yuba City water users the proposed rate increases are much more severe! How severe are they? Two factors are involved. Number one, minimum water users will now have a baseline of 11 units (HCFs) down from the old baseline of 15 HCFs. Secondly, you will be paying a lot more for that lower baseline.

For Yuba City water users that will utilize the new baseline of 11 HCF or less per month their water bill will be 2.49 times their present bill based on 11 HCFs. For those customers using 15 HCFs per month (the present baseline) by the beginning of the third year your bill will be 2.2 times your present bill. Yuba City customers with combined water and sewer can expect their minimum payments to be \$93.44 per month by the beginning of the third year. This increases to \$108 minimum by the beginning of the 5th year. These are insane increases!

Yuba City staff reports indicate their water sale revenues declined 19% in the last 6 months of 2015 due primarily to the drought and mandated water cutbacks. But the drought is easing. Even if revenues continue to be off by 19%

that hardly justifies a 149% increase in rates for minimum users by the end of two years. Where is the money really going? The city cites bond payments and increased maintenance costs as well. But anyway you slice it these increases are extremely excessive.

If you are a Yuba City property owner and/or a water or sewer rate payer, make up or get your hands on a protest ballot. Be advised that your protest needs to indicate a NO to both water and NO to sewer rate increases separately.

Bring these protests to the protest hearing by 6 PM on June 8 or hand deliver them to City Hall. Or mail them in time to meet that deadline. That would mean 5 days in advance which is June 3. Emails and faxes are not valid and will NOT count!

Circulate protests to neighbors and friends. Keep your fingers crossed. If people unite these rediculous rate increases will not be imposed.





Will Fed Raise Rates or go Negative?

So the big question on every bodies mind is will the Federal Reserve continue to raise rates at their next meeting, or stand pat in the face of the latest economic statistics?

Or will the newly announced "negative interest" rates, where banks actually charge depositors to hold their money, be implemented?

It is indeed a strange world we live in where the direction of interest rates and what the Fed will do runs the gamut from both north and south poles.

The markets at least for now seem to like what the Feds are doing as the Dow presses up once again on the 18,000 level, an area where it has never risen above. The average Joe at least on the surface appears to be treading water. I get this impression not from some economic statistic but just on the recent experience that everyone I talk to appears to be in some sort of motionless state of monetary limbo: not getting ahead yet still managing to hold onto a job, at least most of us anyway.

Commodities, the price of many of the basic materials and foodstuffs are rising a tad as indicated by the CRB index which tracks such things. It's up over 10% just since January. This could mean inflation is starting to ignite and that could spell pain for the pocketbooks of an American workforce where the majority of them are having at least some difficulty making ends meet. This constant struggle to pay household bills could be at least part of the reason Democratic moderate (some say socialist) Bernie Sanders is so popular. People are just tired of having a select few reaping the rewards and riding in the cart of the greatest country on Earth while the working majority seem to do most of the pulling.

After half a decade of trillions in stimulus and bailouts from the Feds and global central banks every-where to foster an economic recovery, the most obvious effect, besides stemming the economic tsunami that was 2008, is the US stock markets seemingly relent-less push from around 6500 on the Dow in 2009 to nearly triple that where we sit today.

Noticeably absent from the 6 year rally are banking stocks and energy. With unprecedented amounts of Fed money going into the banking sector (Federal Reserve release of information/ Bloomberg 2011) banking stock are off the lows they hit during the depth of the crisis, but they are nowhere near their previous highs prior to the crisis.

Energy stocks although recovered with overall market after 2010, the recent bloodbath in oil prices have hammered these stocks mercilessly.

With concerns regarding slowdowns in many areas of the world and even more talk of easy monetary policies from the European Central Bank and the Bank of Japan, and with close to one quarter of the worlds sovereign debt (government debt of major countries) now yielding negative rates (lenders get back less then loaned), an argument could be made the world is not yet out of the woods thrust upon it by the severe crisis of 2008/2009.

In the face of a rising market, more talk of monetary accommodation (low interest rates and more quantitative easing) struggling energy and banking sectors and economic stagnation or outright recession in many areas around the globe, there are indeed many economic currents and cross currents. The conflicting economic data that continues to pour in and how the world's central banks react to that data is making for one difficult market for investors and predicting what the central banks will do next is anyone's guess. I sometimes doubt central bankers even know themselves.



YSA will unveil the park and the murals during a dedication ceremony on Memorial Day, Monday, May 30 at 1pm.


David Read, Yuba Sutter Arts Board President said, "The empowerment of our Veterans in this project has been immeasurable, and we all know that



Speaker Series for Youth Wraps Up Its First Season Tom Browning, retired Fire Battalion Chief and current Fairgrounds Board Member, shares a near death experience and lessons learned

On August 11, 2014, while working on a fire in the Klamath National Forest. Tom Browning and two others were forced to take refuge in fire shelters while the fire burned over them. Tom, a retired Fire Battalion Chief, shared this near death incident on Tuesday night with more than 20 FFA and 4H students from Bear River and Nevada Union high schools as part of the

Nevada County Fairgrounds Foundation's Speaker Series. The series brings business education - through access to business leaders, life experiences, and leadership tips - to local high school students.

When faced with an adverse or dangerous situation, Browning's advice to the students is to "stay calm. You can't think when you panic or are overwhelmed. Being calm is contagious."

Browning has more than 40 years of firefighting experience, including 34 years with the City of Grass Valley Fire Department. He retired as a Battalion Chief in 2011. Since his retirement, he has been a member of the North San Juan Fire Protection District, where he serves as volunteer Battalion Chief. He is also a member of Nor-Cal Team II, a federal Inter

YCWA Calls for State Investigation of Disputed Water Rights

Marysville, Ca.

The Yuba County Water Agency (YCWA) has filed a complaint with California's State Water Resources Control Board (State Board), requesting that the State Board investigate the water rights claims of Cordua Irrigation District (Cordua). Cordua has not signed a new water supply contract after several months of discussions with YCWA to replace the contract that expired on April 30, 2016, and therefore, must rely upon their water rights for diversions from the Lower Yuba River. Cordua's previous contract provided water from YCWA's water rights.

Cordua is asserting a right to divert a significant amount of water from the Lower Yuba River, including stored water supplies released from YCWA's

New Bullards Bar Reservoir. Cordua's claims significantly exceed the district's water rights, as summarized in a 2003 water rights decision for the Lower Yuba River issued by the State Board. Cordua's illegal diversion or sale of these supplies could potentially harm the water rights and water supplies of other agricultural water districts in Yuba County as well as the water supplies available for salmon, steelhead and other fish and wildlife species. Moreover, Cordua landowners traditionally use a large amount of Yuba River water to flood their rice fields in the fall months for rice straw decomposition and waterfowl benefits. Under the existing 2003 State Board decision, the district has no water rights for these Previously, diversions. water supplies for these purposes were provided

under the contract between YCWA and Cordua (which has expired).

YCWA General Manager Curt Aikens said today, "The Yuba County Water Agency will take every necessary step to responsibly manage water rights and water supplies in Yuba County."

Aikens added, "Our action should be a clear signal that we are going to protect the rights of our local farmers, ranchers and the environment."

This is the second legal action YCWA has taken against Cordua. On April 15th, YCWA filed a lawsuit in Yuba County's Superior Court challenging Cordua's illegal steps to transfer up to 108,000 acre-feet of Yuba River water supplies, which would require groundwater pumping of up to 12,000 acre-feet per year over the next ninevears.

California Corporate Cannabis Corruption

Whether the citizens of California like it or not, big business and corporate interest are making their move to take over the cannabis industry in California. Approximately seven months ago the Governor of California signed the bills necessary to create the Medical Marijuana Regulation and Safety Act (MMRSA) which will establish statewide regulation of medical marijuana cultivation, distribution, and sales. The MMRSA creates a mandatory distribution system which was included as a result of big business lobbying that will allow corporate interest to have an effective stranglehold on the industry.

Vice global media recently interviewed Steven D'Angelo, founder of Harborside Health Center which is the largest medical marijuana dispensary in the nation. In that Interview D'Angelo exposes the corporate interest and their plans to takeover the cannabis industry in California. D'Angelo informs viewers and readers "Southern Wine & Spirits and the Teamster's Union wielded their political influence with California's legislature and executive branch." He goes on to say "The Teamsters and Southern Wine & Spirits rank among the largest political contributors to the legislature." D'Angelo also points out how the mandatory distribution system will cause the cost of products to double and will wipe out eighty percent of the small growers. Price inflation and eliminating the competition is of course key elements involved with the takeover of any market or product.

Recently, proponents of the Adult Use of Marijuana Act (AUMA) turned in over six hundred thousand signatures to gualify the initiative for the November ballot. The AUMA is being bankrolled by multi-billionaire Sean Parker who is the ex-president of FaceBook and cofounder of Napster. Parker isn't the only one trying to cash in on the cannabis industry. One of the biggest AUMA contributors is Climate Corp., which is owned by Monsanto, which is owned by Pfizer. Another major funding entity for the AUMA is Drug Policy Action which is a 501c4 non profit committee, which is the same thing as a "super pac." A super pac can take in unlimited funds from any group or corporation and not disclose the donor information. Hiding the source of what is known as political "dark money" is the main reason why there is growing controversy and disapproval of super pacs. It is a bad sign to see a super pac involved with silicone valley billionaires, even without the involvement of Monsanto and Pfizer.

Critics and opponents of the AUMA have several issues with the initiative. One of the largest being that something very sneaky and clever was hidden in the AUMA that gives the legislators the ability to amend and alter the initiative however they desire, AFTER it is made law by the voters. Some people find this completely unacceptable, especially when considering the source of the money responsible for creating the AUMA and enabling it to become law. It is well known that corporate money leads to political corruption. Big business lobbying will influence the legislators' amendments. Favorable changes made to the new law will be sold to the highest bidder. This is the very foundation of political lobbying. Big business and corporations do this for several reasons; exemption from being punished for environmental and civil damages, to eliminate competition, and to gain complete control of a market or product. The voters will likely get to decide the fate of the AUMA this November.

Almost immediately after the Governor of California signed the MMRSA bill package, county cultivation bans swept across the state. Is this coincidence? Could this have anything to do with the attempted corporate takeover of the cannabis industry? Is local government declaring they favor big business corporate farms more than small locally owned farms?

In order to block big business and the Teamsters Union while preserving small local farms, some counties are already reversing their bans and enabling county permitting. This creates more incentive for other counties to adopt a permitting program that enables local citizens to acquire cultivation and distribution licenses. In the past, the Sheriff of Nevada county has spoken about ban county migration which was his argument for enacting a ban there. The theory was that surrounding counties with bans would funnel the growers to Nevada county as they sought refuge. Now this theory describes the migration of illegal cartel criminals seeking refuge in counties with bans, while fleeing from counties that are gaining massive regulation funding from permits. In counties lacking permitting and regulation, criminals are sure to bring environmental destruction with them.

No one wants to see small local businesses destroyed by big business corporate interest. The best way to stop this is by allowing the small local businesses to gain permits and licenses and be allowed to favorably compete with the likes of Monsanto, Pfizer, Southern Wine & Spirits, and the Teamsters Union. Its up to the counties to choose who they rather see running the farms because there is no stopping the California cannabis industry which is estimated to reach a thirty five billion dollar value by 2020.

59th Annual Penn Valley Rodeo Stencils Create Activity Space

In 2012, Sutter County Public Health Education staff began implementing the Nutrition Education and **Obesity Prevention (NEOP)** program funded by the United States Department of Agriculture (USDA). In January 2016, a community mini grant proposal to purchase paint for the stencil kit was awarded to Sutter County Public




