## **Sutter Co Gets Management Umpire**

Sutter County Supervisors voted to add an internal auditor to Nathan Black's Auditor-Controller Office at their April 26 meeting. The County has been without the position since fiscal year 1991-1992 after Barbara LeVake, chairperson of that board, led an effort to cut the position from Robert Stark's Auditor-Controller office.

In late 1989, Robert Stark's internal auditor uncovered undisclosed losses on funds invested by County Treasurer Jim Stevens. County departments pool their idle funds to be managed by the treasurer.

The combined effect of hiding the loss and erroneously reporting it overstated revenue by \$366,586.03 according to Stark, the Grand Jury and private contract auditors. Stark made the accounting adjustment to reflect the negative impact to public funds.

County Administrative Offi-

cer (CAO) Larry Combs didn't want the findings made public. Eventually the Grand Jury investigated the Treasurer's Office, confirming the internal auditor's discovery. Bartig, Basler and Ray, Independent Auditors and CPAs also asked for a county response to "irregularities" in the Treasurer's office to "prevent the potential for abuse."

Following this revelation of treasurer blunders, internal auditor funding was purged until the board's recent reversal. Supervisors, some department heads and CAO Combs were upset with Stark's questioning of their methods of handling the public's money.

Lone voices like Stark and employee whistleblowers do not fare well when they expose government gone wild. Elizabeth Pollard, an employee of Victim Witness (VW), a department under the district attorney's office, was shamed, insulted and fired

for her exposing a misappropriation of VW funds.

Victim Witness assists survivors of crime. Pollard first went to District Attorney Carl Adams's assistant Jana McClung after discovering Adams spent VW funds for the DA's office. McClung promised a fix but did nothing.

Pollard then contacted Calif. Emergency Management Agency (Cal EMA). Following the resignation of Adams, a Cal EMA audit of a two-year period confirmed Pollard's findings and was uncontested by Jana McClung. More than \$80,000 was repaid to the state.

The county then quickly settled a Pollard lawsuit in closed session paying her \$150,000 for her loss and legal costs. Other state monies were misused by Adams to politically prosecute and harass Stark over a ten-year period.

## **LaMalfa and Friends Flip-Flop on Reservation Shopping**

Just when you think you understand reservation gaming rules they change. In 2000, 64.5% of Californians approved Proposition 1A, allowing Las Vegas style Class III gambling on reservations.

Prop. 1A allowed a Native American tribe to open a Class III casino if (1) the governor and the tribe reach an agreement on a compact, (2) the legislature approves the compact and (3) the federal government agrees to the compact.

As of July 2014, the governor, state legislature and federal government had approved compacts with 72 of the California's 109 federally recognized tribes. Also, as of July 2014, 58 tribes operated 59 casinos in California.

The rules seemed clear. However, add mega-money backers, politicians, lobbyists and loopholes suddenly appear. Reservation-shopping was born, though it looked exactly opposite to what the voters were promised with Prop 1A.

Over the last few years Congressman Doug LaMalfa from Richvale, and members of his Subcommittee on Indian, Insular and Alaska Native Affairs have been cutting a new path through casino regulations for tribes. LaMalfa's committee has been working hard to allow tribes to do an end run on the regulation process. In return they are receiving cash peace offerings.

Santa Inez residents are furious about it. The subcommittee is helping the Chumash Mission Tribe convert 1400 acres of prime farm land into housing. The Chumash already have a 138-acre reservation and casino, paying-out \$50,000 / month to each tribe member. Their current reservation is not adjacent to proposed development and members can afford to live all over the world.

Locally, Butte County's Enterprise Rancheria didn't like the competition of two casinos so they politically finagled a fresh location in Yuba County in spite of voters twice rejecting the idea (Measure G and Prop 48). The Estom Yumeka people received a go-ahead from the Bureau of Indian Affairs and Gov Brown, but the legislature did not give their compact a vote.

In February 2016, U.S. District Judge Troy L. Nunley ordered California to negotiate a new compact with Enterprise Rancheria within 60 days. Nunley said the state didn't act in good faith when it let the tribe's original deal expire without a vote in the legislature. Others counter that no action by the legislature is an action to decline.

In November 2015, U.S. Senior District Judge Anthony W. Ishii ordered California to reach a compact with the North Fork Rancheria of Mono Indians even though 60.96% of state voters rejected an earlier compact via Proposition 48. He ruled that the state's refusal to discuss the tribe's casino plans was a failure to negotiate in good faith under the Indian Gaming Regulatory Act (IGRA).

Now, countering these two judicial decisions, La Malfa's group of California lawmakers and other committee members known for fast tracking tribal casinos introduced a bill amending IGRA. It would require the process for approving off-reservation gaming in California adhere to state law.

LaMalfa's H.R. 5079, the California Compact Protection Act, states that the Department of the Interior may not approve a tribal gaming compact that has been rejected by state voters or not ratified by the state legislature.

Enterprise and North Fork Rancheria people are furious, thinking they paid all the money so the fix was in despite the wishes of the voters. Their pay-off may be outplayed by California congressmen facing angry voters who see their land rights and votes nullified by federal authorities and politicians.

Anti- reservation shopping Californians are celebrating what they see as a correct congressional action though it is being done for all the wrong reasons...to stay in power.

## **Loma Rica and Dobbins Elementary Schools Drinking Water Update**

In August 2015, the Marysville Joint Unified School District (MJUSD) received compliance notices from the Yuba County Environmental Health (YCEH) Department regarding the Lead/Copper Rule (LCR). Water samples from Loma Rica Elementary School identified lead being above the allowable maximum level. Dobbins Elementary School was identified as being above the allowed maximum levels of copper and lead in their water.

Since then, the MJUSD has taken numerous actions to adhere to the compliance notices:

1) The MJUSD has been providing bottled water to both school sites.

2) The MJUSD delivered via the US Postal Service a copy of the lead and/or copper consumer notices to the occupants (students/staff/parents) of the Dobbins and Loma Rica school sites with the following information:

- The lead tap sample result;
- The measured level and the definitions of lead action

level and max contaminant level goal;

- An explanation of the health effects of lead and copper in drinking water; and

- The MJUSD water system contact information.

3) The MJUSD has been working with a corrosion specialist, JDH Corrosion, to develop a mitigation plan. There are four viable solutions to meet the compliance standards:

- Switch to a new water supply (i.e., perhaps harder water with more mineral content).

- Install a water treatment system to coat the pipes internally.

- Replumb with new piping (i.e., PVC where code allows).

- Installation of point of use filters.

The MJUSD has hired a water treatment specialist, Culligan, to take lead and copper samples on behalf of the MJUSD to ensure samples are not compromised since they are taken by a trained and unbiased profes-

sional. There is a possibility the initial high levels may have been due to the MJUSD changing many faucets and drinking fountains at Dobbins and Loma Rica Elementary Schools, recommended by YCEH, before the samples were taken. After the LCR testing in April 2016, little to no lead was indicated in the water at Loma Rica Elementary School, and there was also a reduction in the copper level at Dobbins Elementary School.

The next set of water samples will be taken in May 2016 and compared to results from April 2016. If the results come back as non-detect or under the limits for LCR, the MJUSD will request a new compliance notice stating the water at both school sites are safe for consumption.

The MJUSD is hoping for a permanent resolution this summer. Until then, the MJUSD will continue to provide bottled water to both school sites.

## Sutter Co Gets Management Umpire

The state has not been informed of further grant abuses. New DA Amanda Hopper asked supervisors for an audit, but with no success. One payroll summary shows DA Adams using \$50,000 in drug abuse prevention grant funds to wage his legal assault against Stark.

Stark spent more than \$300,000 in his defense and his assistant Ronda Putman paid nearly \$100,000. Neither was offered county-funded legal help

though it is allowable. All charges including felonies were eventually dropped by Adams who told his office he was satisfied with breaking them financially. Putman lost her home.

The era of no internal auditor is a low point in Sutter County governance allowing leaders to do what was right in their own eyes. It cost taxpayers a fortune in mismanagement and runaway pension costs. Stark warned of both.

Citizens are accused to politicians and

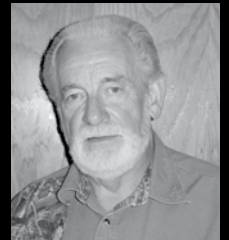
bureaucrats remaining silent about corruption, "taking the Fifth," or claiming "I have no memory." In little Sutter County a big decision by the board to delete the internal auditor and destroy the Auditor-Controller seems hard to forget.

Supervisor LeVake who says she can't recall her actions to terminate the auditor and Stark should argue her memory is great, just short. That's a true politician.

We noticed the Sacramento River has dropped some in the last couple of days. The current striper run will continue to show scores of boats and boat trailers at all boat ramps in the Yuba-Sutter area. With shad in the system anglers have options for these fighting fish or the bigger striped bass.

Congratulations go out to Rocklin angler **Steve Bohlman**. Steve was fishing at Collins Lake when he hooked a rainbow trout while fishing with a Thomas Buoyant lure. The "Big One" weighed in at 7 pounds 8 ounces. Lots of rainbow trout were taken last week ranging from 4 pounds to 6 pounds. Catfish are also on the bite with fish hitting live minnows, night crawlers and red worms. The catfish size has been from 3 to 9 pounds. Bass are also hitting lures and bait.

Apparently the Department of Water Resources (DWR) has been removing stripers from delta waters by the shocking methods. The fish are being placed in Bethany Reservoir. As far as we know this is being done because of water withdrawal via pumps to send the water south and to agricultural needs. As we all know, the fish are getting caught up in the pumps and killed. Since the striped bass were originally planted in this area by the former Department of Fish and Game it is sad to see what is going on. This removal

of some of the fish is not being done by the Department of Fish and Wildlife, but by the DWR.

The bass fishing at Bullard's Bar Reservoir is on the move at this time. Spotted bass are being caught from small fish in the 9 to 11 inch size to bigger bass up to around 8 pounds. The fish, along with perch and crappie can be found around the submerged brush and trees all around the lakes shoreline. With the reservoir standing at 90 percent capacity it is in excellent shape.

The shad, which were first reported in this column last week in the Sacramento River, are now showing up in the Feather and American Rivers. Reports tell us the shad fishing will be excellent this year and the fish will peak in mid-May and be around into the month of June.

The Department of Fish and Wildlife have planted catchable trout this past week, in Butte Creek, Icehouse Reservoir, Pillsbury Reservoir, Upper Hat Creek, South Fork of Battle Creek, Gurnsey Creek, Deer Creek and Collins Lake.

The insect hatch is underway at Lake Almanor which will produce scores of trout, salmon and bass caught by anxious anglers. If you go and troll with night crawlers remember to set up your hook so the tail of the worm is not free. For some reason the big browns in this reservoir hit crawlers more consistently with the worm entirely of the hook.

Boots fishing tip of the week: When it comes to frying striped bass fillets, you just cannot beat the mayonnaise, cracker crumb and garlic combination.

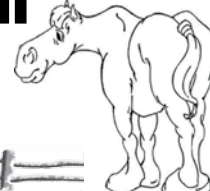

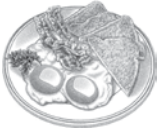

# No Voice – No Choice

## UNALIENABLE RIGHTS AT THE CROSSROADS

Historically, more often than not, there are many governments that make horribly wrong decisions which affect generations to come. Russia in the photo is one such country that has done this. ## This Month In Your Garden

The month of May has had a beautiful introduction to spring this year. April did give us some April showers that helped give us positive feelings about gardening in 2016, unlike the negative feelings of 2015 as we faced another season of drought, and that without the reservoirs, on which so many of us depend, not having filled because of the poor “rainy season”. We can see the more relaxed attitude toward gardening in our customers at Bald Mountain Nursery. We can all hope that Mother Nature trends back toward wetter weather to help renew our depleted water tables. We don't know, but we can hope that this is the “beginning of the end” of a long drought.

April and May are special months for gardeners – so many plants look so fresh and beautiful with things leafing out and others bursting into bloom. We can all enjoy them to the fullest now, knowing that many areas will be drying up before too long as our summer heat approaches. Summer annuals add much beautiful color to all the shades of green of various shrubs in the yard. Planting some nice containers with various colored annuals gives the freedom to place nice color wherever it is needed, and switching them around if for some special reason, like unexpected company is coming or a party is planned, etc. Snapdragons add lots of color plus height as do zinnias, petunias come in many colors and so does annual vinca, marigolds will add yellow and orange. Try alyssum, lobelia or portulaca for a trailing effect. Begonias, impatiens and violas are great for brightening shady areas. If it sounds like something

you would like to try, just use your imagination and have some fun with it. In the ground or in pots, they will provide colorful areas to the yard. Fertilize them occasionally or use a slow release fertilizer on them to keep them blooming, remembering that nutrients wash through plants in containers more quickly with frequent waterings.

The ever present weeds (at least for some of us) really make their presence known as they grow faster than anything else in the yard with the warming weather. I congratulate those of you who used pre-emergent to prevent weeds from sprouting. Because the weeds grow so quickly and are so invasive it is something that should be done soon. Other pests encountered at this time of year are aphids and the ants that farm them. The ants harvest the sticky substance left by the aphids. Aphids can be controlled safely by spraying with insecticidal soap. We have had a number of customers commenting on more snails than usual. They do their mischief at night, so you may not see them. Their most obvious trademark will be the irregular holes they make in leaves and they frequently leave a shiny trail. They can be hand picked if seen, or snail bait can be spread in the affected area. Putting some bowls that are set into the ground a bit and filled with beer will attract them and drown them. If you have citrus trees, watch for mealy bugs. They will start as small white spots just about anywhere on the plant but, they multiply into larger groups and may have the appearance of a fungus or scale. They can be sprayed with an insecticide such as Sevin, but you will need to add

a few drops of dish detergent to help penetrate their slightly fuzzy exterior. Catching them early definitely makes them easier to control.

Most camellias have finished blooming now. Clean up the old blooms that have fallen to the ground and dispose of them in the trash. They can harbor a fungus as they decompose that can spread a disease called petal blight to the plant that can cause the flower petals to turn brown. The spores can travel a good distance in the wind infecting other plants along the way.

As mentioned earlier in the season, watch your roses carefully for signs of powdery mildew, black spot, or rust. We have had the occasional rainy times followed by warm weather which is perfect weather for fungi. Treat them as soon as noticed because it is much easier to manage it early than when it is well established. Also mentioned earlier, planting ground covers from flats should be done fairly soon so that they can become somewhat established before we get into the really hot weather. The same applies to planting new lawns – it needs to be quite well established before the hot weather arrives or you will have quite a constant watering job while it becomes established. Enjoy our adequate water supply, but please apply your conservative methods.

## Who Will Operate and Maintain Sutter County’s Rehabilitated Feather River Levees?

Since the high water flood scare in 1986, the Sutter County Taxpayers Association (SCTA) has been at the forefront in pushing to fix our levees to protect citizens and property.

The Sutter Butte Flood Control Agency (SBFCA) was finally formed in 2007 as a joint powers authority. SBFCA is comprised of Sutter and Butte Counties, the cities of Biggs, Gridley, Live Oak and Yuba City, and Levee Districts 1 and 9. In 2010 SBFCA asked property owners in Sutter and Butte Counties to pass an assessment on their properties to fund the local share of a major, at the time, \$250 million (now \$300 million) project to fix the west bank of the Feather River levee from Star Bend south of Yuba City north to the Thermalito After Bay in Butte County.

Recognizing the importance of increasing flood protection for citizen safety and property, SCTA supported the assessment in return for assurance that a citizens oversight committee be formed to monitor SBFCA’s financial actions and to provide citizens information on the project. The Citizens Assessment District Advisory Committee (CADAC) was formed in September 2010. Each member of the 13-member SBFCA board is allowed to appoint one member to CADAC. Since formation in late 2010, the committee has had an active role in monitoring SBFCA’s activities.

Recently, however, it has become apparent that the SBFCA staff would like to reduce CADAC’s ability to obtain information concerning SBFCA actions. SBFCA staff has falsified information on CADAC’s activities in order to have SBFCA Board members remove and replace two active CADAC members. An illegal vote was held

on April 11 to elect a new chairman who had not attended a CADAC meeting in eight months -- in violation of the CADAC bylaws. Further, this was done at a meeting that was not properly noticed under the Brown Act.

These recent actions and others have raised concerns that SBFCA staff are working behind the scenes to give Levee District 1 the Operation and Maintenance (O&M) responsibility for the entire Sutter County stretch of rehabilitated levee once the work is complete. An O&M plan is required by the state. When questions are asked about the O&M plan, there is silence on what is being discussed.

SCTA believe the decision as to who should be in charge of O&M should be thoroughly discussed and decided by all of the representatives of the SBFCA agencies and with the community. And that is not happening.

Now let’s look at the players. The Levee District 1 Board is comprised of three people: Al Montna, Francis Silva and Charlie Hoppin. While LD 1 board members must be elected, past history and current activities would indicate they are generally hand-picked by Al Montna. Jon Munger works for Al Montna and Jon is the person who was illegally elected chair of CADAC at its April 11 meeting.

Another indicator that LD 1 is in line for the O&M is the plan for LD 1 to enroll in a 457 plan where employees can put extra money for their retirement. This was presented at the March 14 and April 11 LD 1 Board meetings. The district currently has two full-time and one part-time workers, so why the need for a 457 plan unless they are going to be hiring more employees? And, unless salaries are above average,

## Scapegoating, the Coward’s Ploy

North Yuba Water District (NYWD) is governed by a five-member board of directors. Three of the current directors have served about twenty years each while the other two are relatively new to the board. As is often the case on small district boards, one member consistently asks more questions, makes more suggestions, is always more thoroughly prepared, often seems to be the only member who, before each meeting, has read everything in the directors’ information package, and clearly takes the job seriously. Even a casual review of a few sets of NYWD board minutes will reveal clearly that one director asks more pertinent questions and makes more suggestions than the other directors combined. That fact seems to annoy the other four and perhaps creates a little embarrassment at their apparent lack of preparation.

Added to that is another important element of this story. In 2005, NYWD and South Feather Water and Power (SFWP) were required to negotiate and sign a contract as a pre-

requisite to the federal licensing of SFWP’s power facilities. NYWD had a water rights attorney working on this negotiation and upon reaching a final agreement our stalwart was one of three directors who voted to accept it. Some terms of that agreement did not go into effect until 2010 at which time it became apparent that not all terms of the agreement were beneficial to NYWD especially during a period of drought. Remember now that our stalwart director was just one of the three directors who voted to accept the 2005 agreement.

Jump ahead to 2015 and we find that three of the current directors (different from the three who voted to accept the 2005 contract), along with the manager and a few community members, have made hateful comments outside of meetings about our stalwart director. The comments have been made with a vehemence that is frightening. They blame her alone - yes, the only woman on the board - for saddling the district with the infamous 2005 agreement. Come on guys,

what workers can actually enroll in a 457 plan?

SCTA has concerns about giving the O&M to LD 1 because of past actions by LD 1. Levee District 1 violated CalPERS rules by not requiring its former general manager Bill Hampton, after retiring from Sutter County, to stop his CalPERS pension and be reinstated to CalPERS while employed by LD 1 from December 1996 to July 2015.

Additionally, LD 1 was very slow to take action concerning an extremely dangerous situation near Boyd’s Pump south of Yuba City. It was discovered in December 2005 during high water that there was water gushing through a badly rusted 24-inch steel Oswald Water District irrigation pipeline passing through the levee below ground-level and flowing into an irrigation ditch on the landside of the levee. Against all advice, this dangerous situation was allowed to exist through the 2006-2007 rainy season. Work to plug the pipe was not done until the summer of 2007, more than a year and a half after LD 1 was made aware of the problem.

Also of concern are the high assessment costs charged by LD 1. As an example, for a house in LD 1, residents pay more than \$11 a year, yet maintenance areas managed by State Water Resources, mostly charge pennies for maintenance.

The liability issue is of extreme importance. If the O&M is given to LD 1, do we Sutter County property owners have to accept liability if a flood, heaven forbid, occurs?

The public deserves an open and thorough discussion on this issue, addressing the options, the costs and the liability of the Operation and Maintenance plan.

there was a water rights attorney involved and a total of three directors voted to accept it. Why blame her for all the problems with the 2005 agreement? Actually, blame has been dumped on her for nearly all of the district’s current problems. She has become the district’s current scapegoat.

Why is that? Why create a scapegoat? Could that be the testosterone brotherhood’s attempt to ease their own feelings of discomfort or embarrassment as they sit quietly on their hands and observe their lady colleague engaged in meaningful discussions? If that is the case, here is a suggestion for the brotherhood. Remember the Boy Scouts’ motto, “be prepared”? Now is the time to put that idea to use. Read your information packet before each meeting and think about its contents. Work with your lady colleague, she may surprise you with some good ideas. Remember, scapegoating is a coward’s ploy that accomplishes nothing useful.

ate and maintain good public relations, how to interact comfortably with customers and the public in general. [Interesting tidbit: The Colantuono law firm that vetted Mr. Maupin for NYWD currently provides legal counsel for the Newhall Water District.]

In addition to a listing of previous places of employment Mr. Maupin’s application listed a BS degree in Business, yet to my knowledge, no diploma or other corroborating evidence has ever been presented. If evidence is not forthcoming, people are bound to conclude that the degree is a fabrication.

Directors please take note, you need to recognize these problems and to begin corrective action soon!

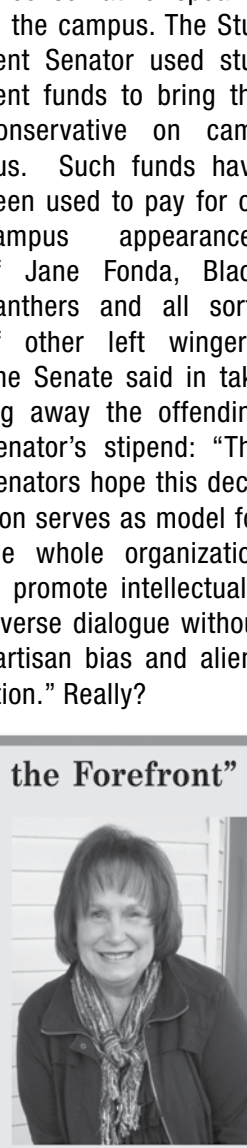

# 19 Sumptin Ford Tractor

Who Said, "You can't make a Silk Purse Out of a Sows Ear?"

If this old Ford Tractor could talk to you it would have a strange story to tell. I don't know much about it, but it's condition says about all you need to know.

The tractor came from Hollister to Browns Valley. George Deveraux of Superior Radiator acquired the tractor. It sat in his yard for a few years out in District 10. I have taken a number of tanks and radiators to George who does excellent work. One day he commented he had an old tractor and would I like to look at it. He said he was tired of looking at it and wanted it gone. I agreed to look at the tractor and made an appointment to look at the Ford. I hardly ever miss the opportunity to look in somebody's barn. However, I was not quite prepared for what I was to see. I now understood why he wanted it gone. It was a mess! It had an old loader, large amounts of concrete for wheel weights for traction, a severely "hookiefied" power steering system from a car power steering pump, some missing parts, some incorrect parts, grease and oil everywhere, poor rear tires, decaying misaligned front tires to name a few things. George said he would give me the tractor and I could do anything I wanted with it. He had another friend

who wanted the loader and I replied he had two weeks to get it off the old Ford.

I took my trailer with a winch on it to Georges' home and we proceeded to load the tractor with some effort. Black marks across his pavement and on the deck of the trailer from the rotting misaligned front tires. Numerous oil spots began to appear on the deck and were in full bloom by the time I got home. I was able to use my forklift to unload the tractor and put it in an out of the way place for some period of time to figure out what I was going to do.

In my warped way I think old tractors like old men need a job. If a tractor can be salvaged I try to do it. I decided that nothing could be better than to restore it and offer George a chance to drive it in the Marysville Veterans Day Parade. The tractor was also a great example of the inventiveness of farmers to modify things for the farm that they can't quite afford. Someone obviously wanting a loader tractor, so they went about making one from parts. The recently presented "Doodlebug" was a fine example of the 20s and 30s, this Ford was what farmers of the 40s might do.

I call this Ford my 19 Sumptin Ford. It now has

a 1939 Ford front end, a 2N engine, and a 8N rear end. It was also unique because it had a blue rear end. During the end of the 8N run there was a flaw. Ford recalled the units fixed the flaw and put them back out with blue differentials. So a blue and gray paint job seemed to be reasonable.

Quite a few hours, some money, and a lot of passion brought the tractor back to life. When it was finished, I put the tractor on the trailer and took it back to George so he could see it and the parade was not far away. I could see the look on his face when he came out of his shop and that was ample payment! "My god", it's a tractor again". A few other man type words came out for joy which were not suitable for publication came into the conversation.

I have already gone into some lengthy detail about the war and the 2N so I will not do it again. The basic information is that the 2N could lift 800 pounds with the three point, created about 12 horsepower on the drawbar and had 23 horsepower on the pto, and it weighed about 3,070 pounds depending on the options. The tractor new sold in the neighborhood of about \$1,100. The Ford N series was a very popular tractor and sold more units than any other tractor.

It has been fun for me to write these articles. I appreciate the Historic Faire and the Territorial Dispatch to provide the venue for these Vintage Tractors to step forward and take their place in the history of the Basin. 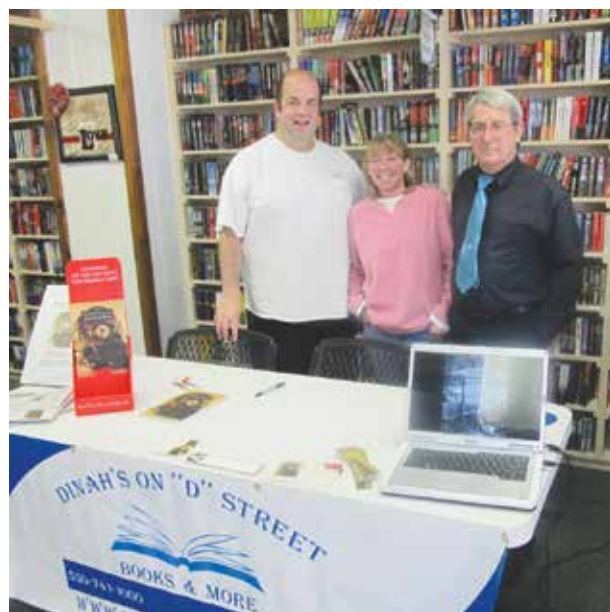
It's a sad time for book lovers and local authors. Dinah's book store on D Street will be closing by the end of May.

## Food and Farm News

### Spring storms cause concerns

It will take farmers a few days to gauge the impact of storms that brought wind, rain and hail to parts of the Central Valley in recent days. Farmers say the storms blew down some almond trees and came at a time when orchard crops such as cherries could be vulnerable. Prune growers say they lost much of their crop to earlier storms, which hit orchards during bloom in March. In some cases, farmers say there's not enough prunes on the

trees to justify harvest.

### Encouraging owls discourages gophers

To keep gophers from causing damage in vineyards, some California farmers have installed owl boxes to encourage barn owls to nest. A three-year study by a field researcher from the Pittsburgh Zoo shows the owls can be economical as well as effective, controlling rodents at a lower cost than trapping or other methods. Vineyards have been the main locations for owl boxes, but a number of farm-

ers with orchards and other crops have also started to use them.

### DNA tests help confirm content of pima-cotton products

Using DNA technology, manufacturers of pima cotton products can confirm that products labeled "100 percent pima cotton" meet that standard. After hearing reports that some overseas mills might be blending other cotton with pima, a marketing association contracted with a firm to conduct DNA tests to assure the integrity of pima products. California is the nation's top producer of pima cotton, which commands a premium price.

### Report details floriculture production

Two states--California and Florida--account for nearly half of the nation's production of floriculture crops, according to a new report from the U.S. Department of Agriculture. Floriculture includes production of bedding and garden plants, potted plants, cut flowers and other ornaments. The report estimates the wholesale value of U.S. floriculture production at nearly \$4.4 billion.
