

# The 56th Annual Nevada City Bicycle Classic

One of America's top cycling events celebrates its 56th anniversary this year and many of the nation's top cyclists are expected to be on hand.

The 56th Annual Nevada City Bicycle Classic will be held on Father's Day, Sunday, June 19, 2016, in historic downtown Nevada City.

The Nevada City Classic is one of the premiere sporting events in the Sierra foothills, the largest and oldest bike race on the West Coast, and the second-oldest race in the nation.

Historic Nevada City is draped with flags and bunting and provides a colorful backdrop as cyclists whiz through the downtown area, spokes flashing and crowds cheering. Several thousand spectators attend the traditional Father's Day event.

Senior and professional riders representing top U.S. cycling teams are expected to race in the men's 90-minute main event. Women's, Junior's and Master's races also are planned. Action begins at 1 p.m. and is usually complete by about 6:30 p.m.

# Sutter Co Sups Pension Increases Violated Gov Code

The Grand Jury (GJ) Report for 2015-16 accuses Sutter Co. Supervisors Jim Whiteaker, Casey Kroon, Dennis Nelson, Larry Munger and the late Dan Silva of violating numerous government codes in August 2004 when they deceptively increased county pensions 35% and made the benefits retroactive to the date of hire. County Administrative Larry Combs was the wizard behind the sleight of hand.

The impact of the backroom deal that fleeced taxpayers is severe. In 2001, there was a \$28,707,894 surplus in the county's retirement fund. By 2014, the surplus had become an unfunded debt of \$110,802,083, a \$140 million financial collapse in 14 years. Unfunded debt means that monies will be drained from other accounts to backfill over-promises.

The pension formula were increased from 2% of salary times the years of service to 2.7% of pay. The egregious aspect was that instead of the increase being effective August 31, 2004, the date of the vote, the supervisors made it retroactive to the date of hire.

The retroactive impact is equivalent to a private sector retiree at 30 yrs of service having \$600,000 in a retirement fund getting an additional bonus check of \$200,000 from his employer just before cleaning out his desk. He walks away \$200,000 richer.

For politicians it is always easy to be more generous with someone else's money, in this case Sutter County taxpayers.

The GJ says the supervisors violated the law repeatedly. They failed to disclose the cost via an actuarial statement describing the enhanced retirement package at a scheduled public meeting two weeks prior to approval. They disguised the controversial pension spike by including it in the Consent Calendar rather than honestly and legally showing it as an "item of business" on their board agenda. The board deceived taxpayers by describing the retirement boost in a convoluted fashion. (See actual wording below).

"7) Approval of Memoranda of Understanding for the General (A04-173), Professional (A04-174), and Supervisory Units (A04-175); Addenda to Memoranda of Understanding for the Fire Safety (A04-176) and Law Enforcement (A04-177); and Addendum to Salary and Benefit Agreement for Confidential Unit Employees (A04-178)."

There were no attachments to the agenda explaining the meaning of their mumbo jumbo. This was a planned snow job on

# Yuba County Hires Homeless Coordinator

Marysville, Ca.

Yuba County is stepping up efforts to address challenges associated with the region's homeless population with the hiring of a program manager dedicated to the complicated issue.

Chaya Galicia, who previously worked with the Salvation Army for 17 years, began working last week in the newly-created homeless coordinator position in the county's Health and Human Services Department. Galicia, who has also been president of the Yuba-Sutter Homeless Consortium since 2012, brings a deep understanding of local homeless projects, as well as



a proven track record of locating grant funding.

"Chaya is a great addition to our Yuba County team," said Yuba County HHS Director Jennifer Vasquez. "She has the right combination of experience and personality to lead future efforts in our community."

At the beginning of this year, Yuba County officials began holding regular meetings to determine the best way to deal with the increase of homeless encampments. especially those that spread quickly along with shores of the Yuba River. The meetings included discussions with homeless advocates, public and mental health officials, law enforcement, representatives from other regional governments and leaders from local organizations that work with the homeless.

"We have always had a significant number of homeless encampments in the Yuba-Sutter region but have seen a huge influx over the past year," said Yuba County Administrator Robert Bendorf. "The buildup of trash and waste from these camps has caused dire public health risks and severe environmental impacts along our rivers.

"We're not interested in kicking this can down the road. We need to do everything we can to direct the homeless toward services that could get them into permanent housing," he said.

Bendorf said the availability of federal funding makes it possible to hire Galicia without affecting the county's general fund.

Galicia will coordinate with numerous government and private agencies to connect the homeless with available services. These include locating service documents for veterans, connecting individuals with nutrition and medical services, short term housing for those moved out encampments and options for getting into long term housing.

Sutter County describes a Consent Calendar as follows: "The Consent Calendar groups together those items which are considered non-controversial or for which prior policy direction has been given to staff and that require only routine action by the Board. The Chairman will advise the audience that the matters may be adopted in total by one motion: however, the Board may, at its option or upon request of a member of the public, consider any matter separately."

Supervisors who are elected to protect the interests of citizens thought turning a surplus into \$110,802,083 of debt was 'non-controversial' and 'routine,' a mere 'policy' change. What is criminal is that they were caught red-handed and bullied their way out.

The GJ report says Auditor-Controller Robert Stark was at the meeting to protest the clandestine move and asked that the item be removed from the Consent Agenda warning that the pension change would bankrupt the county. His request was rejected.

Ratting-out the supervisors, Combs and complicit department managers triggered a political 'carpet bombing' of Stark and his assistant Ronda Putman that lasted 10 years. District Attorney (DA) Carl Adams misappropriated hundreds of thousands of dollars to criminally prosecute Stark and Putman. Adams eventually dropped all charges saying he was happy with financially ruining Stark.

The DA nearly succeeded, costing Stark over \$300,000 and Putman \$55,000 in legal fees.

The GJ report recommends a number of needed changes to county governance. Those include adopting policies, procedures and training that facilitate obeying the law. The Auditor – Controller should produce quarterly reports describing the state of the pension fund for public view. Hire an internal auditor to ensure compliance with county, state and federal rules. The GJ wants a county policy valuing transparency over expediency, especially concerning financial matters.

Sutter County citizens owe a debt of gratitude to the GJ for exposing the 2004 scam that will usher the county into bankruptcy. Now, two questions remain. Can the citizens sue the county to roll back the illegally passed pension excesses? And, will supervisors make amends with Stark and Putman by reimbursing their legal costs?



Let us not forget Father's Day is just around the corner on Sunday, June 19th. If your Dad or Grandpa is a fisherman plan on getting him a gift or card about fishing.

The opening weekend at Eagle Lake was not very successful for many of the anglers who fished there. In fact reports tell us just about everyone went home empty handed. One of the problems was the turnout of analers and boats....lots of boats. Things got so hectic that forest rangers were needed to direct both vehicle and boat traffic throughout the weekend.

Most of the planted trout went north last week to Siskiyou County. Waters planted were Cold Creek; Kelly Lake; McCloud River at Fowlers and Lower Falls; South Fork of the Sacramento River; Siskiyou Lake, Squaw Creek and Wagon Creek.

We talked to George who advised the bite at Enalebriaht Reservoir has been mostly confined to bottom fishing with dough bait or worms. Lots of fish are being taken off of the house boats in the marina, some hefty rainbows up to four pounds. He advised to fish around the marina or above the five mile zone due to the heavy boat traffic.

Up at Camp Far West Reservoir the lake has dropped to 89%, Bass are being caught on the bear river arm of the reservoir'

Scotts Flat Reservoir is still almost full. Trout have been caught on the point near the marina and bass were cooperating for anglers who fished along the rocky banks near the dam.

Boat ramps are open at Davis Lake, with the fishing being on the slow side. Reports have told us all camp grounds are open for business.

Lake Tahoe is still putting out some nice mackinaw lake trout. Charter boats have had excellent success both on the South and North Shore of this beautiful natural gem. Val and I will be heading up there in a couple of weeks for our annual vacation, which will include an early morning charter fishing trip. I will have a firsthand report when we return.

Stampede Reservoir is still down at 46 percent capacity. Fishing has been fair to good with some action with kokanee salmon.

We hear from our weather source. He advised us to expect a cooling off period, which will bring relief from the three, did get temperatures. This predication will to take place this week (Thursday or Friday) with temperatures dropping into the mid to high 80's. Now wouldn't that be nice.

Boots fishing tip of the week: With the hot weather in full swing the trout and other fish in reservoirs and lakes will be heading down deeper to find cooler water. Time to bring out the downriggers or fish at first light along the shoreline until the sun hits the water.



# **Kokanee Fishing with Vance Staplin**

The Rooster Tails Fishing Club monthly breakfast will be held at the Auburn Elks Lodge on June 17. This breakfast event is open to club members, spouses, and non-member guests. Doors to the Lodge will open at 7:00 a.m. to share fresh brewed coffee. A fantastic \$13 wideselection buffet breakfast is served at 8:00 am follow by a 9:00 am presentation featuring Kokanee fishing extraordinaire, Vance Staplin. Vance is the owner of Vance's Lures and has personally designed and tested his lures under real fishing conditions. His dodgers are longer and narrower than the standard 4/0 dodger used by most trout anglers. The raw stock used to manufacture

his dodgers is thicker than that used by other companies and sculptured for low drag plus providing a lot of 'kick' to trailing hutchies, grubs, and micro-spoons. In addition, he uses top of the line snaps, rings, holographic and UV coatings to enhance his lures.

The prolific and frequently finicky Kokanee fish is a miniature version of their sea-going cousin, the sockeye salmon. Although typically reaching less then sixteen inches in length, Kokanee are hard fighting and often display aerobatic antics that belie their size. Their fillets are bright orange-pink and considered by most as a delicacy. Kokanee can be found in multiple northern California waters including

Lake Pardee, Lake Berryessa, New Melones Reservoir, Wiskeytown Reservoir, Lake Don Pedro, Stampede Reservoir, Shasta, Lake Tahoe, just to name a few. Their watery homes are usually a minimum depth of forty-feet deep, but they can often be found in large schools at a hundred feet or more.




# Mickayla Friend Chosen for ACE Award



Marysville Charter Academy for the Arts (MCAA) senior Mickayla Friend has been chosen as the Sierra Pacific District of Exchange Clubs' A.C.E Award winner. The award, Accepting the Challenge of Excellence, recognizes high school students who have had to overcome great physical, emotional, or social obstacles and are now eligible for high school graduation. Mickayla was chosen from a group of Yuba County applicants to represent the Marysville Exchange Club. She was recognized at a luncheon at El Zarape restaurant in

Yuba City on April 20, 2016 and received a \$300 scholarship to help pay for her postsecondary education. Her application was forwarded to the Sierra Pacific District where she was selected as the winner at that level as well. She will receive an additional \$1,000 scholarship and will be honored at a luncheon at Feather Falls Casino in June. Her application is now being forwarded to the National Exchange Club where she will be competing against 31 other applicants from around the country for additional recognition. Mickayla was selected to apply for the A.C.E award because of the many obstacles she has faced throughout her life. Growing up, her home life was often in turmoil. Years of living in this type of situation eventually led to a defining moment in her life when she found the courage to speak out about her home situation in hopes of creating a more stable environment for herself. In addition to all the chaos in her home, Mickayla has experienced more than her share of loss. One specific example of this occurred in March 2014. She and her boyfriend were walking along the railroad tracks and were hit by a train. Her boyfriend was killed in the accident and she spent 5 days in a coma. Lucky to have survived the incident, she spent several weeks in the hospital. Despite experiencing such a tragic event, Mickayla returned to school a few months later to ensure she did not fall behind on her graduation requirements. As a result, she will be graduating with her class on June 2nd. She plans to attend Yuba College in the fall to pursue an Associate's Degree and eventually transfer to a 4-year university. It has not been an easy road, but Mickayla has persevered and has not allowed her circumstances to define her. It is an honor to recognize her for the A.C.E. Award.



## Only 2 AAA rated companies left

And now there is only 2, AAA rated companies that is. That's because, according to Bloomberg News, Standard and Poor's downgraded Exxon from AAA to AA+ leaving only Johnson and Johnson and Microsoft remaining with the coveted highest rating. Automatic Data Processing (ADP) lost its AAA rating earlier this month, downgraded to AA following its decision to spin off it's auto dealers services arm. ADP held the AAA rating since the mid 90's but now like Exxon, the rating is history. Exxon had held its rating for 67 years but like all good things, it came to an end last week.

More than 60 companies held the highest rating in the 1980's but that number has been dwindling. In 2008 there were only six AAA companies and now there are only the two.

Low oil prices have bludgeoned Exxon profits along with many other companies in the oil industry. Massive debt loads incurred by many oil producers while oil prices were soaring are now causing stress in the debt markets of the world as it is estimated 38% of private company debt is related to the energy Companies markets. borrowed funds from everywhere to produce oil when higher prices made it profitable to do so. Now that oil prices have hit historic lows,

paying off all the debt has been challenging for many.

More than a few energy companies have hit the skids. Both oil and coal producers are suffering from the rout in energy prices caused by a combination of environmental concerns, bad press, oversupply and falling demand from overseas markets. The problem is magnified because as prices drop, companies tend to want to produce more to pay the bills in lieu of shutting the doors, which further adds to the supply glut, pushing prices lower still.

Reduced in rating, Standard and Poor's added that Exxon's debt level has more than doubled in recent years due to share buy backs, dividend payments and capital spending in the face of falling profits. The rating company maintained its "stable" outlook on the energy giant.

With only two remaining AAA rated companies, you have to wonder what is transpiring in America over the last three decades to cause the vast majority of previously rated companies to fall from grace. Is it environmental, labor or regulatory costs that are bleeding balance sheets dry or is the overall economy suffering from macroeconomic maladies that are slowly pushing companies closer to the abyss?

With massive government stimulus in the form of monetary policy and ballooning government deficits adding even more money into the economy, one has to wonder where all the cash is ending up if not in the hands of our finest companies.

# Sutter Co Solar Project a Mess by Lou Binninger

(Sutter GJ Cont. from Page 1)

Sutter County's \$10.5 critiquing the \$9.1 milmillion project to install 10 solar arrays, install new HVAC and energy efficient lighting was improperly managed and the project is at a standstill costing taxpayers hundreds of thousands of dollars according to the Grand Jury 2015-2016 Report. In July 2015, an Appeal Democrat article "Faulty Bookkeeping for \$9m in Sutter County" by Andrew Creasey piqued the interest of the Grand Jury (GJ).

A subsequent GJ investigation found Sutter County in more of a mess than Creasey realized. The GJ faults the Board of Supervisors (BOS), County Administrative Officer (CAO) Jim Arkens and Assistant CAO Shawne Corley for excluding the Auditor-Controller and Treasurer from vetting the project,

lion loan and managing the finances. Arkens and Corley had exclusive access to the money in an escrow account with no oversight from the two officials elected by the citizens to be finance watch dogs.

On September 8, 2015, the BOS removed Arkens and Corlev from access to the escrow account and returned the duty to the Treasurer. Arkens and Corley no longer work for the county.

The BOS, Arkens and Corley said it saved time to avoid normal protocol and commonly accepted accounting practices. So, 'county leaders' thought it wise to exclude their two brightest finance people elected by the taxpavers.

Rather than buy the equipment, the BOS did a lease-purchase so they

could call the payments rent and avoid oversight. That still violates the law by ignoring the role of the treasurer and auditor according to government code.

In their 'urgency' to get the project going, supervisors did not properly evaluate the installations sites. The airport and mental health facility were chosen as two spots that would produce two-thirds of the project's power. However, problems arose with both locations hindering completion of the installations. New sites needed to be found. That meant a delay in utility savings earmarked to make annual loan payments of \$683,110 in 2015 and \$629,874 in 2016.

So, the county continues to incur high utility bills while paying on the loan thereby creating a cash flow problem. And, possessing solar equipment, but unable to use it has created an unrecoverable loss as years of sunshine have been wasted that could have energized county facilities at a low cost.

0n September 8, 2015, the BOS approved a resolution to amend the Escrow instructions the Master Leaseto Purchase Agreement due to unanticipated delays. The Resolution extends the date of completion of work and the disbursement of escrow funds to February 27, 2017. On that date another payment of \$655,978 will be due.

The GJ recommends that the BOS utilize the skills of the Auditor-Controller on future projects. And, the BOS should use the Treasurer as the sole agent of the county to handle funds. Adequate time for thorough research should be taken to prevent expensive delays, costing the County hundreds of thousands of dollars. Finally the GJ exhorts the BOS to hire an internal auditor to insure departments are in compliance with County Protocols and Procedures. The county has been without an internal auditor since 2002 after Supervisors scratched the position in their 2001 budget talks. Since that time the BOS and department directors have done whatever they wanted at the taxpayers' expense, often violating the law.

# **Sutter Co GJ Faults BOS Secrecy**

The Sutter County Grand Jury (SCGJ) 2015-16 Report faults the Board of Supervisors (BOS) for negotiating expensive contracts without public input and keeping the public ignorant of the details due to the board's lack of transparency.

The report says, "In Sutter County, labor negotiations are generally held behind closed doors where a professional negotiator is hired to bring the various entities together. Once an agreement is resolved, the proposal is brought forward for a vote by the BOS. The public is not involved in negotiations or made aware of the agreement until the agenda is published, which is generally the Friday prior to the board meeting on Tuesday evening. As a result, little time is given for the public to process and analyze how the agreement will affect the budget or County resources. Generally, there is no independent economic analysis provided."

The GJ lists two examples of secret negotiations creating a significant financial obligation for the citizens with minimal public review. On August 31, 2004, Supervisors Jim Whiteaker, Casey Kroon, Dennis Nelson, Larry Munger and the late Dan Silva violated numerous government codes to increase county pensions 35% and make those benefits retroactive to the date of hire. As a result, in 2014 the pension fund \$110,802,083 in was debt.

The GJ says, "There was no independent analysis provided. The supporting material was writby Lou Binninger

ten in an unclear manner, and by placing it on the consent calendar, public discussion was blocked." Further, Auditor-Controller Robert Stark's request to move the item to the public agenda for discussion was rejected. (See front page article "Sutter Co Sups Pension Increases Violated Gov Code").

"On February 25. 2014, a \$10,500,000 agreement with Chevron Energy Solutions was approved by the BOS. The agreement was made to build a series of solar arrays, upgrade HVAC systems, and provide other energy saving improvements to reduce the County's energy costs. The system was designed and rushed through for approval without an independent financial analysis and with only minimal public input. The BOS even denied the request by the Sutter County Auditor-Controller to delay the vote until further study on the financial impact of the project could be studied."(sic) ( See "Sutter Co Solar Project a Mess")

The SCJG recommends that the BOS adopt a Civic **Openness in Negotiation** (COIN) ordinance. The GJ report cites the 2012 City of Costa Mesa passage of a COIN ordinance to correct abuses of power by politicians. The objectives of the Costa Mesa COIN are:

1. Bring maximum sunshine [exposure] to the negotiations of the most expensive contracts in which the city enters.

2. Bring in a professional negotiator to represent the taxpayers' interest.

3. Give the public easy

access to the cost of each benefit under consideration.

4. Show the public each offer and counteroffer.

5. Allow for ample time for the public and media to examine the contract before it is approved by the legislative body.

Recognizing the need for more open government, Governor Brown signed Senate Bill No. 331. The bill encourages counties, cities and special districts to establish specific procedures for the negotiation and approval of significant contracts that would allow the public to be better informed.

Those jurisdictions adopting a COIN ordinance are required to use any of the following principles as a part of any collective bargaining process undertaken pursuant to the Meyers-Milias-Brown Act:

a. Preparation of an independent economic analysis describing the fiscal costs of benefit and pay components currently provided to members of a recognized employee organization, as defined in Section 3501 of the Government Code.

b. The completion of the independent economic analysis prior to the presentation of an opening proposal by the public employer.

c. Availability for review by the public of the independent economic analysis before presentation of an opening proposal by the public employer.

d. Updating of the independent economic analysis to reflect the annual or cumulative costs of each proposal made by the public employer or recognized employee organization. e. Updating of the independent economic analysis to reflect any absolute amount or change from the current actuarially computed unfunded liability associated with the pension or postretirement health benefits. f. The report from a closed session of a meeting of the public employer's governing body of offers, counteroffers, or supposals made by the public employer or the recognized employee organization and communicated during that closed session. g. The report from a closed session of a meeting of the public employer's governing body of any list of names of persons in attendance during any negotiations session, the date of the session, the length of the session, the location of the session, or pertinent facts regarding the negotiations that occurred during a session. The unionization of government employees and the purchasing of candidates by those unions have produced an incestuous relationship that corrupts government. Public exposure of negotiations by a COIN ordinance may at least show the citizens in advance how they are getting ripped off.







The term "Badge Engineering" or "Rebadging" means the application of a different brand, trademark, logo, or manufacturer's name to an existing product and subsequently marketing the variant as a distinct product.

Many of the present automobile companies make this a common practice. Whether it is Ford, GM, Honda, Dodge, Toyota, or several others makes little difference. Common examples

would be the Mitsubishi 3000 and the Dodge Stealth, the Honda Civic and the Acura ILX, and the Ford Expedition EL and the Lincoln Navigator are well known.

Prior to 1920 there were several hundred builders of tractors. When Henry Ford came out with the Model F Fordson in 1917 the "Tractor Wars" became active and continued to erode the numbers of manufacturing



companies to a much smaller amount. There were many companies making equipment but did not have a tractor.

One prime example was the Avery Plow Company.

The Cletrac Company manufactured crawler tractors and decided to present their small crawler on wheels, the only wheeled tractor they made. They called this new innovation the Cletrac General. The tractor was of tricycle design, low horsepower, and sold

rights to produce the unit and sold it as the Avery A. Avery added to their line with the R and the smaller V. Co Op produced the same tractor as did Massey Harris in Canada. Avery produced the tractor for sales catalog giant Montgomery Ward and it was called the Twin Row. Oliver bought out Cletrac and later sold to Minneapolis Moline. MM produced the R as the BF Minneapolis Moline. BF came from Benjamin Franklin

The Avery A was built from1943 to 1950. The power came from a 19

# **Food and Farm News**

#### Report shows continued drought impact on farms

Lingering drought and water shortages will cause up to \$1.5 billion in losses to California agriculture this year, according to a new report from CoBank. The agricultural lender says the losses will affect the state's farms. ranches and agricultural businesses. The report says the water situation has improved somewhat, but California farmers will still leave up to 350,000 acres of land unplanted due to water shortages.

## Supreme Court ruling benefits landowners

Farm groups welcome a U.S. Supreme Court ruling that broadens landowners' ability to challenge federal agencies. The court ruled unani-

mously that landowners can go to court when a federal agency tries to regulate their land under law meant to protect water. The American Farm says the rul-Bureau ing allows farmers and ranchers to have their day in court "when the government tells them they cannot plow a field or improve a ditch without a federal permit."

## **Timber operators see** reasons for guarded optimism

Improving sales of new homes helps the outlook for California timber producers. Timber operators say they're guardedly optimistic about the market. But they say the outlook can vary greatly, depending on the type of wood, where it's grown, forest health and other factors.

For example, the market for pine wood has dropped, in part due to a large supply of salvage logs from trees killed by drought or infestations of bark beetles.

#### Scientists test new tool against psyllid

A trap that mimics the wing buzzing of the Asian citrus psyllid shows promise in fighting the pest. The psyllid, which has been found in California, can carry a plant disease that kills citrus trees. Scientists in Florida say they have created a trap that lures male psyllids by reproducing the wing buzzing of a female. Researchers will test the trap in citrus groves this summer, hoping to create a new tool against the pest.

# **Bark Beetles Invade Trees at** the Nevada County Fairgrounds

Trees to be removed this week, before infestation impacts additional trees

A large grove of pine trees near the back parking lot of Gate 4 at the Nevada County Fairgrounds has been identified as infested with bark beetles and is scheduled to be removed this week.

"It's imperative that these trees be removed quickly before the overwintering young beetles mature and emerge as the next generation of adults," said Robert Ingram, a registered forester who inspected the trees at the Fairgrounds. "When the parent beetles enter the tree, they mate, the female lays eggs and they both die. When the young beetles mature and emerge, there will be 25 - 40 times more beetles, which will create a greater infestation on the Fairgrounds." Ingram, who has more than 35 years as a forester with Sierra Pacific Industries, pointed out that while the trees impacted look green, the beetles have already killed the tree inside and it is dead. By the time the tree has visibly died, it's too late to stop the

infestation and the bark beetles have moved to other trees in the area. "If we want to maintain the beauty and look of the Fairgrounds, it is imperative that we get rid of the infested trees now so that we can preserve what is left," he said.

"Because of the hundreds who walk our grounds each week, it's important that we let the public know of this challenge so they understand why the trees are being removed," said Rea Callender, CEO of the Nevada County Fairgrounds. "Because the trees still look alive, it appears we are taking down healthy trees; when, in fact, they have to be removed while the beetles are in the trees before they can spread to other trees. If we don't get rid of these bark beetles, it will change the look of our beautiful Fairgrounds." The Nevada County Fairgrounds, well-known for its trees, has already lost 33 trees this year because of the infestation of the bark beetle. The grounds are covered with Sugar Pine and

Ponderosa Pines, which are prone to bark beetle; and with several years of drought, coupled with the fact that many of the trees are old and weak, it makes them highly susceptible to the beetles.

To address the loss of the trees, the Nevada County Fairgrounds and the Fairgrounds Foundation are putting a reforestation program in place to begin replanting in the fall with trees that are less susceptible to bark beetle.

Because removing the trees and cleanup is costly, the Fairgrounds is looking into state grants available to help in the removal of trees. lf you'd like to contribute to the reforestation plan, please make any monetary donations to the Nevada County Fairgrounds Foundation. 

# **Annual Y-S United Way Food Drive Aims to Collect 20,000 Pounds**

Hunger in Yuba, Sutter and Colusa counties knows no holiday. That is the reason the Yuba-Sutter United Way annually conducts a major food drive for nine local food pantries that in turn provide tons of food per month to needy local families.

The donation of food and cash at the local food pantries is lowest this time of year, but the need is actually higher.

"Donations peak during November and December for the holiday season. However, the same needs are there the other 10 months of the year, with donations bottoming out in June and July," said Bob Harlan, executive director

of Yuba-Sutter United Way. The "Day of Action Food Drive" last June collected more than 16,000 pounds of nutritious, non-perish-

able food stuffs. "This year's event aims to be even bigger as we're hoping to collect in excess of 20,000 pounds of food," Harlan said.

The drive comes in two parts. First, there are currently 40 collection barrels in stores and government offices where they are conducting mini food drives. Then, on June 25 from 9:00 a.m. to 1:00 p.m., there will be five drop-off locations in Yuba, Sutter and Colusa counties.

New this year is a strong

push for cash donations as local food closets can purchase perishable and nonperishable foods from the Yuba-Sutter Food Bank for 19-cents or less per pound and they can purchase exactly what is needed for their inventory.

"While this drive doesn't solve the problem, it makes a sizeable dent in the demand. I urge all local residents to participate," Harlan Said. 100% of all cash and food collections will be given to nine local food pantries.

The model for the school house is the Old Sacramento School House Museum in Old Sacramento. SVM board trustee Dixie LaGrande is a docent at the Old Sacramento School House and is learning criteria to be used at the SVM exhibit.

It is anticipated by the SVM board that the school house will be used as an old-fashioned school classes learning center that can be utilized by Northern California schools for an affordable fee.

Once the restoration is completed it will be offered as a historic classroom venue for such events as school field trips, summer history camps and provide a display of education history in Colusa County.
