

# No Unemployment Check?

If you get laid off, there's a system that's supposed to help you get by: unemployment benefits. Whenever California stares down a pandemic or a possible recession, the partial wage-replacement program is one of the most important economic safeguards for workers.

But the benefits have become more difficult for workers to access, due to the program's design and

decisions made by California's embattled Employment Development Department. That's according to an in-depth report released from the Legislative Analyst's Office, a non-partisan agency that provides advice to the Legislature.

The report found that the benefits program's orientation toward businesses — which fund the benefits and have an incentive to keep costs down - led the department to emphasize holding down costs. Pressure from the federal government to avoid

errors led the department to try, however successfully, to minimize fraud.

The result: the department pursued lowering costs and hindering fraud over making it easy for workers to access benefits.

"Looked at individually, one of these policies might seem totally reasonable, either to limit fraud or minimize business costs," said Chas Alamo, the report's author and principle fiscal and policy analyst with the Legislative Analyst's office. "But

# SacRT Takes You Back to School for FREE

#### SACRAMENTO, CA (MPG) -

The Sacramento Regional Transit District (SacRT) is reminding students and families that with the RydeFreeRT program, students in transitional kindergarten through 12th grade can ride the entire SacRT transit network for free. The program includes SacRT buses, light rail and SmaRT Ride on demand microtransit services.

The RydeFreeRT program is available for any youth that live or go to school within SacRT's service area, which includes the cities of Sacramento, Elk Grove, Folsom, Citrus Heights, Rancho Cordova and parts of Sacramento County. Approximately 220,000 students in grades TK - 12th, home-schooled students, and foster and homeless youth are all eligible.

SacRT launched the RydeFreeRT program in October 2019, at that time, SacRT experienced a 127% increase in student ridership (pre-COVID-19). Over the last year, SacRT provided over 2.4 million free rides to youth across the region.

New RydeFreeRT cards for the 2022-2023 school year are distributed by schools and have a valid date from June 1, 2022, through June 30, 2023. For students that still need a RydeFreeRT card, visit SacRT's Customer Service and Sales Center located at

1225 R Street (adjacent to the 13th Street Light Rail Station) or Sacramento Public Libraries.

"Thanks to continued funding from the cities of Sacramento, Citrus Heights, Elk Grove, Folsom and Rancho Cordova as well as additional funding from the County of Sacramento, we are able to keep the RydeFreeRT program going into a fourth year," said SacRT General Manager/CEO Henry Li. "The fare-free program helps our region's youth by removing the transportation barrier to education, jobs, and healthcare."

"SacRT's award winning RydeFreeRT program for TK-12th grade students has benefited our community immensely and I could

not be happier it is continuing for a fourth year," said SacRT Chair and Citrus Heights Council Member Steve Miller. "With this program, we are increasing mobility options and school attendance, reducing congestion and greenhouse gases and creating new rider habits."

"RydeFreeRT has become a model that many transit agencies across the nation are trying to replicate," said SacRT Board Member and Sacramento City Councilman Jay Schenirer. "This is an investment in our future connecting youth to school, work, internships and other education and career opportunities. It's great to see so many young

riders on public transit!" "At Sac City Unified our

focus is on providing equitable access to high quality education. The costs and challenges associated with transportation can often create a significant barrier to that access," said SCUSD Chief Communications Officer Brian Heap. "The SacRT free transit program is a tremendous support tool for the district and our families. We have some middle and high schools where as many as one-third of students rely on SacRT to safely get them to and from school each day. Chronic absenteeism is a serious problem for schools, and we appreciate that our partnership with SacRT helps get more students to class every day."

**SACRAMENTO, CA (MPG)** - The American River College (ARC) athletics program was ranked fifth in the state of California - second in northern California - according to the final 2021-2022 rankings for California Community College Athletic Association institutions.

The rankings are part of the annual NATYCAA Cup, established in 2004 to recognize excellence in two-year college athletics based on success in championship competition across all sports.

The National Alliance of Two-Year College Athletic Administrators (NATYCAA) is a professional organization open to all two-year institutions throughout the country. NATYCAA Awards are designed to recognize and reward overall program excellence at the two-year college level. In the NATYCAA Cup, colleges are awarded points based on their teams' final positions in post-conference competition.

ARC scored 129 total points in 2021-22. Multiple sports reached state

championship competition in 2021-22, including women's volleyball, men's soccer, men's tennis, men's track and field, men's swim and dive, men's cross country, women's swim and dive, women's water polo and women's tennis.

# Keep Pets Safe During Hot Weather

**SACRAMENTO COUNTY, CA (MPG)** - Every year, Sacramento County residents do their best to keep cool during the summer heat. Failing to keep cool in extreme temperatures can cause adverse health effects for residents – both humans and animals.

Unlike humans, cats and dogs cannot sweat to keep cool; they cool their bodies off through panting and the pads of their feet. As a pet owner, it's important to take measures to keep them cool during high temperatures.

Here are some tips for keeping your pet safe from the heat:

Never leave your pet in a parked car: Even cracking a window won't protect your pets. It is against the law in California and could be punishable by a fine or imprisonment. A car can reach 120 degrees in just minutes; even if the windows are slightly open the car can still reach 102 degrees. A dog's normal temperature is 101.5 degrees; at 120 degrees your pet can suffer from heat exhaustion and die and at 107 degrees brain damage occurs. Check out this video on how hot it gets in cars.

**Avoid extreme heat:** When temperatures get above the 90s, take your pet inside. For outdoor pets, be sure to provide them with plenty of fresh, cold water in a tip-proof water dish and shade for them to cool down.

Don't exercise with your pets when it is too hot: Older and certain long-haired dogs can be particularly susceptible to heat, and hot asphalt can burn their paws. Exercise in the early morning or cool evenings and make sure both of you have plenty of water.

Use sunscreen: Pets get sunburned just like people, and if your pet has light skin or fur, they can be particularly susceptible to a painful burn, and even skin cancer. Use sunscreen on sensitive areas, such as ears or nose to make sure your pets are protected.

Secure your dog during transport: Make sure your dog is secured safely in your vehicle. Cross-tethering your dog with a rope or containing them via a kennel in the bed of your truck will help prevent the dog from falling or jumping from the vehicle. Also, please note that truck beds can get hot when exposed to

the sun and that can severely burn dog footpads. Transporting animals on a public highway or public roadway without properly securing them could be punishable by a fine.

Be your pet's lifeguard: While swimming can help pets get exercise without overheating, always supervise pets when swimming either in a pool or in waterways. Dogs can get tired swimming, particularly in rivers where they have to fight against currents. To avoid drowning, make sure they wear life jackets and keep them out of the water when flows are high.

If pets have been exposed to high temperatures...

Be alert for signs of heat stress including heavy panting, glazed eyes, a rapid pulse, unsteadiness, staggering gait, vomiting, or a deep red or purple tongue.

Immediately move your pet to the shade to gradually lower their temperature. Apply cool (not cold) water to the pet, and provide lukewarm or cool water to drink. Take your pet to a veterinary hospital immediately. It could save their life.






# Local Tennis Star Meets MealPro

- MealPro LLC, a Citrus Heights-based food preparation and delivery service for ready-made meal plans, has announced a partnership with a rising United States Tennis Association (USTA) men's tennis star, Jenson Brooksby, of Carmichael.

Brooksby is the first athlete brand ambassador for MealPro LLC, according to Andy Sartori, founder of MealPro.

Brooksby, 21, who goes by "JT," is the son of Glen and Tania Brooksby. The young, Sacramento-based, tennis star recently stopped by MealPro headquarters in Citrus Heights at 7433 Greenback Lane, Suite A, and took time to play a round of tennis with Sartori.

While he's home training, MealPro will deliver to him a custom weekly meal package especially tailored to the high nutritional needs of a competitive professional tennis player. He will also collaborate with MealPro on the creation of his own line of meals for other tennis players like himself.

Brooksby was a top-ranked collegiate tennis recruit of Baylor University in 2019. He

sat out his freshman year of college competition in spring 2020 and decided to have a "redshirt year." The term "redshirting" means a student-athletes can practice with the team and gain experience, but usually do not travel for road matches, saving a year of eligibility which may be needed later in their career as an upperclassman.

The current 21-year-old

elected to forgo his remaining college eligibility following the COVID-19 shortened season that he redshirted, to turn professional on the Association of Tennis Professionals (ATP) tour in 2020. The Carmichael native gained his first professional experience in August 2019 when he qualified for the main draw of the US Open.

The ATP Tour is a world-wide top-tier tennis tour for men organized by the ATP. Men's Grand Slam tournaments include the Australian, French and US Open championships and Wimbledon. He recently completed his first full calendar year as a professional tennis player and ranked as high as No. 33 in the world, ascending from outside the world's Top 300 to the fringe of the Top 50.

At the age of 20, Brooksby became the youngest American to reach the US Open Tennis Championships' fourth round since Andy Roddick did so in 2012. He battled through three tough matches and in the Round of 16, took the opening set from, at the time, World No. 1 Novak Djokovic 6-1 before the

Serbian rallied behind unrelenting physical play.

"We believe (Brooksby) is the perfect partner to represent our brand and inspire future generations of athletes," Sartori said. "It's an ideal pairing, and we're excited for what the future holds."

According to Brooksby, this is a mutually beneficial relationship between himself and MealPro.

"MealPro's commitment to creating high quality, nutritious and delicious meals is key to my fitness and training," Brooksby said in a news release. "MealPro offers a range of meal plan options that support the varied nutritional goals of athletes at all levels, and I am delighted to expand our partnership with MealPro to share those options across the tennis community."

MealPro is a vertically integrated meal delivery service. It delivers fully cooked meals directly to its customers' doors in all 50 states from its head-quarters in Citrus Heights. The founders of MealPro started the company in 2018 and recently achieved a long-term goal, buying the space it was leasing in Citrus Heights.

Its' online meal selections use organic, gluten and dairy-free ingredients in multiple categories for all diet types, including keto, paleo, custom and a la carte.

Construction of a new customer service call center will be finished soon, Sartori said. A new walk-in reception area offers touch pad ordering, serving local customers who prefer to place and pick up their meal orders in person. One-on-one consultation with a MealPro nutritionist, who can design a personal meal plan, is also available.

# **Board to Provide \$1M in Grants** to Area Nonprofits

SACRAMENTO COUNTY, CA (MPG) - The County Board of Supervisors will continue providing \$1 million through the Transient Occupancy Tax (TOT) Grant Program to support nonprofit organizations located in Sacramento County. This will be the sixth year awarding funds to organizations that carry out community-based programs and/ or services in the areas of economic and workforce development, arts and culture, community development, or health and human services.

The County began setting aside funding for this purpose in 2017.

Grants will be allocated through a competitive process and applicants must meet eligibility and funding requirements. Applications will be accepted online beginning July 29, 2022, through the County's Office of Budget and Debt Management with a deadline of Aug. 29,

Funding for the TOT Grant Program will come from County Transient Occupancy Tax (TOT) revenues. Transient Occupancy Taxes are levied on guests who occupy rooms in hotels, motels and other temporary lodging accommodations in the unincorporated area of the County.

when you look at them, and kind of step back and look at the suite of policies that have been made over several decades, it becomes clear that there's a sort of imbalance in the system," said Alamo.

Early in the COVID pandemic as joblessness rates soared, the department struggled to keep up with a surge of benefits claims — leaving some Californians repeatedly calling the department in frustration and waiting weeks or months for the money to arrive.

Then came sensational reports that the department had paid out as much as \$20 billion in fraudulent benefits.

Last December, the department froze 345,000 disability insurance claims due to suspected fraud. As it tried to root out disability benefits fraud, calls to the department with questions surged, and many went unanswered.

Despite an increase in fraud during the pandemic, fraud has historically been uncommon in California's unemployment benefits, likely "representing less than 1 percent of claims," the report found. The vast majority of fraud that occurred during the pandemic was concentrated in a temporary federal program that has now ended.

The report lays out evidence that unemployment benefits have become too difficult for workers to access.

When workers are denied benefits, for example, they're allowed to file appeals. The report found that more than half of denials are overturned on appeal, meaning those workers should have gotten the benefits in the first place. By contrast, "less than one-quarter are overturned in the rest of the country," the report found.

Also slowing the process: extensive, and sometimes confusing, steps to prove eligibility for California unemployment benefits.

The department's actions during the pandemic suggest that getting payments to workers is not its highest priority, the report said. For example, the department disqualified about 1 in 4 unemployment benefits claims during the pandemic for failing to respond to the department's requests for additional information — or because the department was not able to process the additional information provided in the allotted time frame.

Meanwhile, a September 2020 report written by a team assembled by Gov. Gavin Newsom, found that during the same period, each department field office "had an estimated 450 pounds of

unopened mail and had no system for processing unopened mail. Further, at the state's call centers, less than 1 percent of callers reached an EDD staff member."

The Legislative Analyst Office's report makes over a dozen suggestions to remedy the issues it identifies, including recommendations for how to limit improper claim denials, minimize delays and simplify benefits applications.

The Legislature is investing in modernizing the system and bolstering cybersecurity resilience, Assemblywoman Cottie Petrie-Norris, a Democrat from Costa Mesa who chairs the Committee on Accountability and Administrative Review, said in a statement. She added that she hoped that would lead to "major advances in how quickly the department can assess threats and resolve claims."

Making sure unemployment benefits work effectively isn't just important for workers who have been laid off — it's important for the whole economy, said Irena Asmundson, a research scholar at the Stanford Institute for Economic Policy Research and former chief economist for California's Department of Finance.

If people who lose their jobs in an economic downturn don't have unemployment benefits, she said, then they have to pull back on their spending — making a bad situation worse. So unemployment benefits are meant to act as a stabilizer, giving laid-off workers some money to spend and blunting a downward spiral for the whole economy.

The report "misunderstands EDD's recent activities to improve the process, and the deeper problems with (unemployment insurance) that go beyond the issues referenced in the report," said former department director Michael Bernick, who is now special counsel with Duane Morris, a law firm. Bernick, who has also worked as a volunteer helping people who are trying to get benefits over the past two years, agrees that the process is too complex.

Yet many of the anti-fraud measures that the report blames for slowing down payments are required by federal protocols, Bernick wrote in an email.

"The truth is that EDD must balance rapid payout and anti-fraud — a process that has become increasingly difficult with the heightened sophistication of identity theft rings, and the amount of money going through the system," Bernick said. He added that newer measures to combat identity theft, including the addition of online verification tool ID.me, are on the right path.

# Sleeping Cabin Construction for Homeless Begins

SACRAMENTO COUNTY - Sleeping cabin construction at Sacramento County's new concept "Safe Stay Community" to shelter persons experiencing homelessness has officially begun. The new project, located at 8144 Florin Road, on the corner of Power Inn and Florin at the former site of a now razed grocery store will have 100 sleeping cabins constructed on the site. Construction of the Pallet cabins is expected to take 10 days.

Once cabin construction is complete, infrastructure work such as running power and sewer lines will take several months to complete. In addition to the cabins, the site will have a sanitation trailer for restrooms and showers, staff quarters for the 24/7 on-site operator, a security booth to manage all persons on-site, a communal eating area, storage units for possessions guests bring that do not fit in their cabin and a pet relief area. The site is expected to begin welcoming guests late this fall. It will ultimately be able to shelter 125 people at any point in time.

"Seeing the Safe Stay sleeping cabins go up is very exciting," said District 2 Supervisor Patrick Kennedy. "It is it an important step forward in welcoming guests into this new sheltering model, and the community can begin to see how this will benefit

the neighborhood and local businesses."

Pallet has built nearly 100 communities in 50 cities across the U.S., with 76 currently operating in 45 cities including multiple locations in Northern and Southern California. The unique design and capabilities of the cabins such as a door that can be locked for privacy and safety, heating and cooling to protect guests from extreme weather events and the individualized areas that further provide a sense of space that allows people to shelter and receive services with dignity and respect.

In addition to the hard working Pallet staff, the Pallet structures are being put together by members of the Sacramento Regional Conservation Corps (SRCC) – a non-profit, workforce development and education agency. They provide an opportunity for 18-26 year-old young adults to acquire paid work experience and job skills on conservation projects in a four county region. Young adults, from diverse backgrounds, receive technical skills training and educational achievement. Their area of focus is recycling and conservation projects that enhance and protect our environment.

Ask the DMV - Let the DMV Simplify Your Wedding Season

Did you know that the most popular time for weddings is from May through October? Whether vou're headed to the altar, moving into a new home, or heading to a wedding out of state, learn how the DMV can help make wedding season more convenient and less stressful.

- Q: I just got married and want to change my last name. What are the steps to do so? Do I have to visit a DMV office to get my name updated on my ID?
- A: To change your name with the DMV, you'll first have to change your name with the local Social Security Administration (SSA) office. The DMV electronically verifies your name, birth date, and social security number with the SSA. After you've changed your name with the SSA, you'll need to complete a driver's license or identification card application, a process you can start online. Next, you'll need to visit a local DMV office to provide evidence of your name change and pay the application fee. At the time of this transaction, you'll also be required to surrender your current driver's license.

A name change is also an opportunity to apply for a REAL ID instead of a standard driver's license. For more information, visit realid.dmv.ca.gov.

- Q: I'll be moving into a new home after getting married. Do I need to visit a DMV office to change my address?
- A: You can change your residence or mailing address online in the DMV's Change of Address System. However, you cannot use this online service if you: Do not already have a California driver's license or identification card, do not have a social security number, have an army post office or fleet post office address, have an address outside of the US. or, have applied for but not yet received your REAL ID. For those, you must complete a change of address form and mail it to the address listed
- Q: My best friend is getting married out of state next summer and my passport has expired. Can I use it instead of a passport to fly to the wedding?
- A: Yes! A REAL ID is a federally accepted form of identification and may be used to board domestic flights and to enter secure federal facilities, such as military bases and federal courthouses. One benefit of a REAL ID is that it allows you to carry a single piece of identification that serves a dual purpose, as opposed to having to keep up with both a driver's license and a passport during travel, a time which is often already very busy and hectic. Starting May 2023, a standard driver's license/ID will become federal noncompliant, meaning you will not be allowed to board an airplane or enter secure federal facilities using it.

#### **Does University of California** undercut academic freedom?

Administrations and faculties at University of California campuses are embroiled in a searing controversy over requirements that applicants for faculty positions and candidates for promotion prove their active support, without reservation, of what's called "diversity, equity and inclusion."

Candidates must submit "DEI statements" that, under UC's policies, determine whether they will be considered for employment or promotions, regardless of their academic credentials.

While different campuses use slightly different "rubrics" for judging candidates on their DEI statements, they generally use a 1-to-5 scale to determine whether they should be allowed to advance.

One, at UC-Davis, provides the lowest score to candidates who seem to be unaware or uninterested in the need to promote diversity, while the highest score would be given to someone who "discusses diversity, equity, and inclusion as core values that every faculty member should actively contribute to advancing."

Another version, according to a recent history of UC's Advancing Faculty Diversity Initiative, establishes a 1-to-5 scoring system to judge whether the applicant should be rejected out of hand or allowed to advance. If he or she refuses to discuss gender or ethnicity issues, or contends that such issues are "antithetical to

academic freedom or the university's research mission," they will automatically receive a low score. In contrast, someone who embraces DEI as "core values that every faculty member should actively contribute to advancing" should get the highest score.

One UC Merced professor, Tanya Golash-Boza, even published a guide in the professional publication Inside Higher Ed, to help applicants frame their DEI statements in language that would pass muster with the authorities.

The use of DEI statements began at UCLA four years ago and has become virtually universal since, sparking an intense debate in academic and legal circles over whether the UC system is, in effect, elevating political correctness over academic achievement and in doing so damaging the concept of academic freedom.

To its supporters, DEI statements and other evaluations are necessary tools to ensure that the university system overcomes its historic imbalance in students and faculty that favors whites and Asians over Blacks and Latinos.

But detractors see DEI spirit, if not in letter, university policies that prohibit using politics as a litmus test — policies that were introduced to counter Cold War-era efforts to weed out faculty members with leftist tendencies by forcing them to take loyalty oaths.

In 1950, the Legislature passed the Levering Act, requiring all state employees to sign such oaths — a move obviously directed at the UC faculty. In fact, 31 tenured professors were fired for refusing to sign it.

After years of legal and Supreme Court, by a 6-1 vote, declared the Levering Act to be unconstitutional in 1967. Meanwhile, the UC Board of

Regents adopted a policy that "No political test shall ever be considered in the appointment and promotion of any faculty member or employee."

The DEI statements were mandated campus by campus because the UC system's administrators are under intense pressure from the Legislature, the Board of Regents and activist organizations to overcome ethnic imbalances in spite of voter approval of a ballot measure, Proposition 209, in 1996 that outlaws racial or gender preferences in public employment.

Moreover, in 2020 the state's voters, by a substantial margin, refused to repeal Proposition 209.

The history of how DEI statements became a powerful tool to weed out faculty applicants who don't conform is explored in a recently published and somewhat critical but remarkably objective monograph by two academic researchers affiliated with UC's Riverside campus. They are Steven Brint, a professor of sociology and public policy, and Komi T. German, who earned her doctorate at UC Riverside.

"We find ourselves with statements as violating in a university in flux," the two conclude. "Its commitment to the representational mission, and the progressive political demands that accompany it, is gaining traction as many find themselves disillusioned with the traditional mission of dispassionately searching for truth."

The irony — and perhaps tragedy — of the DEI statement mandate is that while it might, at least in theory, make UC's faculty more diverse in ethnicity, its conformism will make it even less diverse intellectually.

#### SACRAMENTO, CA (MPG) -

The California Highway Patrol (CHP) is celebrating the lifesaving collaboration of many partners behind the scenes, including members of the public, who have helped safely reunite hundreds of abducted children with their families during 20 years of the state's America's Missing: Broadcast Emergency Response (AMBER) Alert system.

"The tremendous success of this program would not be possible without the partnership of law enforcement throughout California, broadcasters. government agencies at both the state and federal level, and members of the public," said CHP Commissioner Amanda Ray. "When a child or at-risk individual goes missing, every second counts, and the AMBER Alert program provides

a critical resource for law enforcement and the public."

In July 2002, state law designated the CHP as the statewide coordinator for California's AMBER Alert program. Since the first AMBER Alert activation in August 2002, 376 children or at-risk individuals have been found safe because of the state's emergency alert system designed to recover missing children or at-risk individuals by employing the public's assistance.

The CHP issues an AMBER Alert at the request of a law enforcement agency investigating the abduction of a child or at-risk individual.

For an AMBER Alert to be issued, the CHP works with local law enforcement to confirm: a child 17 years old or younger, or at-risk individual, has been abducted or taken; • the individual is in imminent danger of serious bodily injury or death; and there is information available that if shared with the public, could assist in the safe recovery of the individual.

As the AMBER Alert program has continued to evolve and through the years, the CHP has added secondary distribution methods to supplement the emergency alert system. These include the Wireless Emergency Alerts program, which is operated by the Federal **Emergency Management** Agency and the Federal Communications

Commission; California Department of Transportation's Changeable Message Signs on freeways; @ CHPAlerts on Twitter; and the California Lottery displays AMBER Alerts on digital terminal signs and printed on lottery tickets.

The mission of the CHP is to provide the highest level of Safety, Service, and Security.



# **Correctional Officer Pleads Guilty to Civil Rights Violations for Assaults on Inmates and Cover Up**

U.S. Attorney's Office, Eastern District of California

SACRAMENTO, CA (MPG) - Arturo Pacheco, 40, of Elk Grove, pleaded guilty on July 25, 2022, to criminal civil rights violations for the on duty assault of two inmates entrusted to his care and to submitting false reports about those incidents in an attempt to cover them up, U.S. Attorney Phillip A. Talbert announced.

According to court documents, Pacheco was a correctional officer at California State Prison, Sacramento (CSP-Sacramento). On September 15, 2016, while escorting an inmate, Pacheco grabbed the legs of the inmate, pulling the legs out from under him. The inmate, whose hands were handcuffed behind his back, fell forward onto the concrete floor, breaking his jaw, several teeth, and suffering other injuries. That inmate was transported to UC Davis Medical Center where he received treatment for his injuries. Approximately two days later, the inmate suffered a pulmonary embolism and died. While the inmate was receiving treatment, Pacheco, a sergeant, and other correctional officers began falsifying reports to cover up the incident.

Following the death of the inmate, investigators uncovered a second incident involving Pacheco. In that incident, on May 19, 2016, Pacheco had, unprovoked, discharged a canister of pepper spray at short range

into the eyes of an inmate who was inside of a prison cell. Pacheco falsified his report in that case to make it appear as though his actions were justified in order to save the life of the inmate. In reality, the inmate was fully complying with commands, and any use of force at that time was unlawful.

As outlined in the factual basis to his plea agreement, Pacheco sent text messages to a friend after the May 2016 incident, commenting how "funny" the incident was and "[i] t's all about how u write ur report", "plus ur partners have ur back." As Pacheco said, "[b]lood, broken glass, n just u n ur partners. ... Green light!'

"Pacheco deprived inmates of their civil rights, abusing his position of authority as a correctional officer to harm them," said U.S. Attorney Talbert. "While Pacheco thought a 'green wall' or code of silence would protect him, he was wrong. His crimes have come to light and now he has admitted to his assaults and cover up. Those who violate the public's trust by harming inmates 'under the color of law' or by covering up wrongdoing must and will be held accountable.'

"The FBI is deeply committed to protecting the rights of all Americans, and those rights do not stop behind the walls of our prisons," said Acting Special Agent in Charge Dennis Guertin. "Today's guilty plea is the result of an intensive investigation conducted by the FBI and our partners at the California Department of Corrections and Rehabilitation and the United States Attorney's Office. Corruption and civil rights violations within our prisons are some of the most difficult to detect and investigate, and we encourage anyone who has knowledge of similar crimes to reach out to any FBI field office or submit information to tips.fbi.gov."

This case is the product of an investigation by the Federal Bureau of Investigation with the cooperation of the California Department of Corrections and Rehabilitation, Office of Internal Affairs. Assistant U.S. Attorneys Michael D. Anderson and Rosanne L. Rust are prosecuting

Pacheco remains out of custody pending sentencing. Fellow former California State Prison, Sacramento correctional officer, Ashley M. Aurich, charged separately, is pending sentencing as well.

Pacheco is scheduled to be sentenced by U.S. District Judge William B. Shubb on October 17, 2022. Pacheco faces a maximum statutory penalty of 20 years in prison on each of the false reporting counts and 10 years in prison on each of the assault counts and a \$250,000 fine per count. The actual sentence, however, will be determined at the discretion of the court after consideration of any applicable statutory factors and the Federal Sentencing Guidelines, which take into account a number of variables.

# **Arrest Made in Homicide** Attempt at Alta Arden and Glendale Lane

SACRAMENTO COUNTY, CA (MPG) - The Sacramento County Sheriff's Office Major Crimes Bureau arrested Chad Jones (36) of Sacramento County for the attempted murder (shooting) of an adult male subject on July 28, 2022, near Glendale Lane and Alta Arden. Major Crimes Detectives tracked Jones to the City of Sacramento and took him into custody at approximately 5 AM. The Sheriff's Office thanks the Sacramento Police Department's SWAT for

their assistance in apprehending Mr. Jones. Jones is well known to local law enforcement and was on Formal Searchable Probation (Until 2024) stemming from felony cases dating back to 2019; he was prohibited from possessing firearms.

Jones was booked into the Sacramento County Main Jail on a single count of attempted murder and is being held without bail. He will be in court (Department 62) on Tuesday August 2, 2022, at 3pm. No suspects are outstanding in this case. No further information is available at this time.

# San Francisco's shortstop stops by SacTown



WEST SACRAMENTO, CA (MPG) - It's not often that you have a three-time All-Star and four-time Gold Glove Award winner rolling through Sacramento and suiting up for the River Cats.

However, the uncommon occurred last week as San Francisco Giants shortstop Brandon Crawford played for the Giants' Triple-A affiliate, the Sacramento River Cats. Crawford was in town for multiple days to get in some game-action before returning to San Francisco following a stint on the injured list with a knee injury.

"The past week's been pretty good," Crawford told the media before taking the field on Tuesday, August 2. "I had three or four days where I wasn't really feeling anything in the knee. I'm hoping to continue that."

The Mountain View native had been on the IL since July 16 after aggravating the knee that had

previously sidelined him once before this season. Crawford aggravated the injury on June 21 during a 12-10 victory over the reigning World Series champions, the Atlanta Braves. He spent the minimum 10 days on the IL before returning on July 5.

Crawford may have rushed his return coming back after 10 days, because 11 days later, he was right back on the IL as the Giants continue to fight to keep their record above .500 following a National League West division title last season.

"I have to make sure the

knee is feeling good before I come off the IL," Crawford said. "Last time I came off the IL and felt good for a game, but the next week after that I wasn't feeling great. I feel like the only way to test it in a game like situation is to actually play a game. That's kind of what

we decided would be best. Hopefully going forward the next couple months it feels pretty good."

Before his return from the IL, the 35-year-old recorded a .215 batting average with five home runs, 33 RBI, 29 runs scored and 10 doubles in 72 games for San Francisco this season.

"We're not far out of the playoff race right now," Crawford explained. "Hopefully I can come back healthy, and Evan Longoria can come back healthy, and we can be at full strength for a little while. I think with the guys that we have, and we kept, we can make a push for the playoffs."

As for his time spent in Sacramento, this wasn't the veteran's first time experiencing the Capitol of California.

"It's definitely convenient," Crawford said about Sutter Health Park being within driving distance of Oracle Park. "I've always enjoyed Sacramento. I've had family that's lived up here. I have definitely played one exhibition here. I can't remember if I've played two. It's nice to come back out."

Crawford returned to the majors on Saturday, August 6. The timing couldn't have been any better for the man who was once a boy born in the Bay Area, as the Giants swept a two-game set on the road from their regional rivals, the Oakland Athletics, in the Battle of the Bay.

In eight at bats over the weekend, Crawford had three hits, two runs scored, one run batted in and one walk with three strikeouts. The Giants won Saturday 7-3 and Sunday 6-4.

As of Monday morning, August 8, San Francisco (53-55) was 6.5 games back of their rival, the San Diego Padres (61-50), who currently hold the third and final Wild Card spot. Both teams will need a WC berth to get into the playoffs as the Los Angeles Dodgers (75-33) are currently running away with the NL West crown.
