## Lawmakers Get Busy

State lawmakers have reconvened in Sacramento after a month-long summer recess – during which some traveled abroad on trips funded by special interest groups that lobby them on various issues – for the final, frenzied month of the legislative session.

Legislators face an Aug. 31 deadline to determine the fate of hundreds of bills. Hanging over the high-intensity process is the Nov. 8 general election, which could affect how some lawmakers – especially those vying for contested seats in the state Assembly and Senate – vote on hot-button proposals.

In a preview of the difficult decisions facing lawmakers, hundreds of fast food workers were set to rally at the state Capitol Sunday night in support of a bill that would permit the

state to negotiate wages, hours and work conditions for an industry that employs an estimated 700,000 people. A similar measure failed to pass last year.

The proposal, backed by labor unions and opposed by business and restaurant groups, has divided Democrats, some of whom are wary of broadly extending liability for labor violations from fast food franchise owners to the corporate chains they work with.

But that's just one of the many controversial bills before lawmakers, some of which face votes as soon as today. Here's a look at some of the key bills, broken down by subject area:

- **Abortion.** With California voters deciding in November whether to enshrine the right to abortion and contraception in the state constitution, lawmakers are considering more than a dozen bills to increase

access and strengthen protections. Perhaps the most contentious proposal is Oakland Democratic Assemblymember Buffy Wicks' to prevent women from being held civilly or criminally liable for their pregnancy outcomes. Opponents have argued the bill would legalize infanticide, which Wicks says is categorically false.

- **Guns.** Following the U.S. Supreme Court's recent ruling dramatically expanding gun rights, Democratic lawmakers countered with a bill they said would comply with the opinion while also making California's concealed carry law more restrictive. If passed, it's all but certain to be hit with legal challenges from gun rights groups.

- **COVID.** Legislators still have to determine the fate of some of the most contentious bills introduced by Democrats' vaccine working

## Oriental Fruit Flies Detected in Sacramento County

**SACRAMENTO COUNTY, CA (MPG)** - The Sacramento County Agricultural Commissioner, in cooperation with the California Department of Food and Agriculture and the United States Department of Agriculture, have initiated an extensive survey and eradication plan in response to the detection of four male oriental fruit flies (OFF), *Bactrocera dorsalis*, in the Wilton area of Sacramento County.

The initial detection was confirmed on July 19, 2022. The detections were made as part of our coordinated pest prevention system that protects our agriculture and natural resources from invasive species with early detection a key component to successfully eradicating an infestation before it can become established.

The extensive survey, also known as a delimitation survey, consists of multiple oriental fruit fly traps placed in concentric circles going out 4.5 miles in each direction from the oriental fruit fly detection sites. Additional OFF detections may trigger a quarantine.

Following the principles of Integrated Pest Management (IPM), agricultural officials use "male attractant" technique as the mainstay of the eradication effort for this invasive species. This approach has successfully eliminated dozens of fruit fly infestations in California. Trained workers squirt a small patch of fruit fly attractant mixed with a very small dose of an organic pesticide, Spinosad, approximately 8-10 feet off the ground on street trees and similar surfaces; male fruit flies are attracted to the mixture and perish after consuming it. The male attractant treatment program is being carried out over an area that extends 1.5 miles from each site where the oriental fruit flies were trapped.

While fruit flies and other invasive species that threaten California's crops and natural environment are sometimes detected in agricultural areas, the vast majority are found in urban and suburban communities. The most common pathway for these pests to enter the state is by "hitchhiking" in fruits and vegetables brought back illegally by travelers as they return from infested

## New 988 Number is The 911 for Mental Health Emergencies

**SACRAMENTO, CA (MPG)** - If you or someone you know is experiencing a mental health crisis, help can be reached 24 hours a day, 7 days a week simply by dialing or texting 988.

Within the United States, that number connects directly to trained mental health professionals at the 988 Suicide & Crisis Lifeline. The program, which began July 16, is modeled after the 911 emergency system. It's meant to be a memorable and quick number that connects people who are suicidal or in any other mental health crisis to a trained mental health professional.

The trained crisis counselors can help people experiencing mental health-related distress such as: thoughts of suicide, mental health or substance use crisis, any

other kind of emotional distress.

People can call or text 988 or chat 988lifeline.org for themselves or if they are worried about someone they know who may need crisis support.

Veterans can use the number to reach the Veterans Crisis Line by dialing 988 and then pressing 1. Spanish speaking counselors can be reached by pressing 2 after dialing 988.

UC Davis clinical neuropsychologist Angela Drake plans to encourage patients to use 988 in an emergency situation and as part of a broader self-care plan.

"There is a tremendous unmet need for mental health services in the United States, which has been exacerbated by the COVID-19 pandemic. We know that a significant number of people are experiencing mental health issues but lack

access to treatment," Drake said. "The new 988 system is a first step toward addressing some of those unmet needs and provides an important safety net for people who are experiencing a mental health crisis."

Calling 988 serves as a universal entry point so that no matter where people live in the United States, they can reach a trained crisis counselor who can help.

The new 988 dialing code is operated through the existing National Suicide Prevention Lifeline. The national network of more than 200 crisis centers helps thousands of people overcome crisis situations every day. These centers are supported by local and state sources and the Department of Health and Human Services' Substance Abuse and Mental Health Services Administration

(SAMHSA).

SAMHSA describes 988 as a first step towards a transformed crisis care system in America. The program is in response to the urgent mental health realities in the U.S. In 2020 alone, the U.S. had one death by suicide about every 11 minutes – and for people aged 10-34 years, suicide is a leading cause of death. In addition, there were more than 100,000 drug overdose deaths in 2021.

The launch of 988 follows a three-year joint effort by the U.S. Department of Health and Human Services (HHS), Federal Communications Commission (FCC), and the U.S. Department of Veterans Affairs (VA) to put crisis care in reach for people in need.

- Hospital man Emily Hoskins, a native of Sacramento, California, serves the U.S. Navy assigned to Navy Medicine Readiness and Training Command Pensacola operating out of Naval Air Station Pensacola.

Hoskins joined the Navy two years ago.

“I saw myself reaching a goal and thought the Navy would be a great stepping-stone to pursue my medical career,” said Hoskins.

Growing up in Sacramento, Hoskins attended John F. Kennedy High School and graduated in 2020. Today, Hoskins relies upon skills and values similar to those found in Sacramento to succeed in the military.

In 2001, a 2-story, 73,000 square foot Outpatient Clinic was added to the Naval Hospital.

NHP’s mission is to deliver high-quality healthcare to warfighters and beneficiaries, ensuring a medically ready force through strategic integration, innovation, and well-trained personnel.

Serving in the Navy means Hoskins is part of a team that is taking on new importance in America’s focus on rebuilding military readiness, strengthening alliances and reforming

business practices in support of the National Defense Strategy.

“The different branches of the military cover every aspect of defense from air, land and sea,” said Hoskins. “This allows us to maintain national security and keep our country free and safe.”

With more than 90 percent of all trade traveling by sea, and 95 percent of the world’s international phone and internet traffic carried through underwater fiber optic, Navy officials continue to emphasize that the prosperity and security of the United States is directly linked to a strong and ready Navy.

Hoskins and the sailors they serve with have many opportunities to achieve accomplishments during their military service.

“I am most proud of getting to where I am today,” said Hoskins. “I have learned to face different challenges and be mentally tough. I’m also proud of having the ability to help people and myself in the process to achieve all the goals that I have set for myself.”

As Hoskins and other sailors continue to train and perform missions, they take pride in serving their country in the United States Navy.

group, including proposals to allow kids 15 and older to get vaccinated without parental consent and another to categorize doctors’ “dissemination of misinformation or disinformation” related to COVID-19 as unprofessional conduct.

- Housing and homelessness. Gov. Gavin Newsom’s contentious proposal to force severely mentally ill Californians into treatment and housing is facing critical votes, as is a bill that aims to increase affordable housing construction but has divided influential labor groups.
- Nursing homes. Lawmakers will consider a bill to reform California’s nursing home licensing system, whose sponsors say it was watered down so severely they can no longer support it. After a CalMatters investigation last year, legislators warned that “people are dying as we wait.”
- Labor and workplace. Legislators have quite a

few high-profile labor bills on their hands, including one to allow their own staffers to unionize and another to force companies to publicly disclose more data about pay gaps. They will also decide, after two Newsom vetoes last year, whether to allow farmworkers to vote by mail in union elections and to increase payments from the state’s paid family leave program so more low-wage workers can take time off to care for a newborn child or sick family member.

- Criminal justice. Amid an ongoing debate over criminal justice reform, legislators will consider a proposal to block prisons, jails and private immigration detention centers from holding people in solitary confinement for more than 15 consecutive days. They’ll also decide whether to limit prosecutors’ ability to seek either the death penalty or life without parole for accomplices in certain felony murders who neither killed nor intended to kill.

- Environment. Not long after Newsom signed a law requiring all single-use packaging and foodware to be recyclable, reusable, refillable or compostable by 2030, lawmakers will determine whether to force online retailers to reduce the use of single-use plastics such as bubble wrap and styrofoam peanuts.
- Internet and tech. The Capitol is bracing for a showdown over a pair of bills — both of which are facing intense pushback from the tech industry — to significantly expand kids’ privacy rights online and to allow public prosecutors to hold social media companies civilly liable for intentionally addicting youth. Lawmakers will also decide whether to slap regulations on the cryptocurrency industry. The votes come as some legislators are set to gather with tech lobbyists later this week at a Napa Valley resort for a two-day event billed by organizers as the Technology Policy Summit. ★

regions of the world or from packages of home grown produce sent to California. Help protect California’s agricultural and natural resources; please Don’t Pack a Pest when traveling or mailing packages.

“Invasive non-native fruit flies are serious pests for California’s agricultural industry and backyard gardens,” said Sacramento County Agricultural Commissioner Chris Flores. “These recent detections on the heels of a recent oriental fruit fly detection in the community of Rancho Murrieta reminds us that we need to remain vigilant in protecting our agricultural and natural resources. When traveling abroad or mailing packages to California, we urge the public not to bring back or ship fruits and vegetables as they are pathways for oriental fruit flies and other invasive species entering our state.”

The oriental fruit fly is known to target over 230 different fruit, vegetable, and plant commodities. Important California crops at risk include pome, stone fruits, citrus, dates,

avocados, peppers, and tomatoes. Damage occurs when the female fruit fly lays her eggs inside the fruit. The eggs hatch into maggots, which tunnel through the flesh of the fruit, making it unfit for consumption.

The oriental fruit fly is widespread throughout much of the mainland of southern Asia and neighboring islands, including Sri Lanka and Taiwan, and has invaded other areas, most notably Africa and Hawaii.

Federal, state, and county agricultural officials work year-round, 365 days a year, to prevent, deter, detect, and eliminate the threat of invasive species and diseases that can damage or destroy our agricultural products and natural environment. The efforts are aimed at keeping California’s natural environment and food supply plentiful, safe and pest-free.

# Defendant Sentenced for Sexually Abusing Child in Multiple Cities

**SACRAMENTO COUNTY, CA (MPG)** - Edwin “Vin” Cuxeva was sentenced to 28 years in state prison. On June 30, 2022, Cuxeva pled guilty to 11 counts of lewd and lascivious acts with a child.

Cuxeva molested the victim when she was 12 to 17 years old and committed the abuse in multiple cities across the state, including Sacramento and Los Angeles. The sexual abuse included multiple acts of sexual intercourse, oral copulation and fondling.

During an emotional sentencing hearing before Commissioner Ken Brody, the victim, along with her siblings and mother, delivered poignant statements that detailed the trauma they endured over several years of abuse. In closing her statement, the victim articulated, “I am here to say that in spite of Edwin Cuxeva, today I have found my joy, my peace, and my justice. I know that nothing will ever give me back what he grotesquely stole from me and my family but we have many more branches we can grow beyond this garden.” ★




# Poppoff!

## Rescue

Let's talk about saving lives. I did with **Jeff Dobson** on POPPOFF. He is Executive Director of the Louisiana Humane society, and he shared ten good reasons why you should adopt a pet companion. I feature two pets from the Placer SPCA every Friday on the Noon News on FM-104.5 & AM-950 KAH1 because I truly believe they deserve a second chance through no fault of their own.



- 1. BECAUSE YOU'LL SAVE A LIFE.** A shelter pet is more than one in a million...she's one in 2.7 million. That's the number of adoptable dogs and cats who are still euthanized each year in the United States, simply because too many pets come into shelters and too few people adopt.
- 2. BECAUSE YOU'LL GET A GREAT ANIMAL.** Animal shelters and rescue groups are brimming with happy, healthy pets just waiting for someone to take them home. Most shelter pets end up there because of a human problem like a move, a divorce, not because the animal did anything wrong.
- 3. BECAUSE YOU'LL GET A GREAT BARGAIN.** When you adopt a pet, the cost of spay/neuter, first vaccinations, and sometimes microchipping can be included in the adoption price which means you've scored a major deal...a fuzzy deal who will thank you with kisses or purrs for years to come.
- 4. BECAUSE OF BRAGGING RIGHTS.** No one needs to see another selfie...unless it's a selfie of you with the adorable pet you just adopted, like the hero you are. Adopt a pet, post the pictures and let the love (likes) roll in.

- 5. BECAUSE IT'S ONE WAY TO FIGHT PUPPY MILLS.** Animals from puppy mills are often housed in shockingly poor conditions with improper medical care, and are often very sick and behaviorally troubled as a result. The moms of the puppies are kept in cages to be bred over and over for years, without human companionship and with little hope of ever joining a family.
- 6. BECAUSE YOUR DÉCOR WILL THANK YOU.** Many of the pets from shelters and rescues are already housetrained, which means you're not only saving a life, you may be saving your rug.
- 7. # Newsom's New Gun Control Bill Just a Stunt

Senate Bill 1327 has to be one of the strangest pieces of legislation to ever be passed by the California Legislature and signed into law. The brainchild of Gov. Gavin Newsom and modeled after an anti-abortion law enacted a year ago in Texas, the measure he signed last week would, at least on paper, subject manufacturers of unlawful firearms to steep civil damages. The Texas law allows private citizens to sue a provider, patient or anyone involved in an abortion after six weeks of gestation. The new California law would sanction private party suits against arms makers for selling what California defines as "assault weapons," plus "ghost guns" that are assembled from parts without serial numbers. "Texas and [Gov.] Greg Abbott and their Republican leadership, if they're going to use this framework to put women's lives at risk, we're going to use it to save people's lives here in the state of California," Newsom declared. In that sense, SB 1327 is just a political stunt, a piece of Newsom's very

obvious campaign to raise his national political standing by taking potshots at Texas and Florida and their Republican governors, rather than serious policymaking. As he was signing the bill in Los Angeles last Friday, three Texas newspapers were publishing ads taken out by Newsom's re-election campaign sniping at Abbott for restricting abortion while not reducing gun violence — a little gesture to help Abbott's Democratic challenger, former Congressman Beto O'Rourke, as well as garner some more national media attention for Newsom. The conclusion that SB 1327 is merely a publicity stunt is bolstered by the details of the legislation itself. First of all, SB 1327 would self-destruct if the Texas Supreme Court or the U.S. Supreme Court invalidates the Texas law. Secondly, there is very little chance that there would be a successful lawsuit. The firearms that are specifically targeted by the legislation are already illegal under California law and the major arms makers that Newsom implies would be punished take great pains not to sell the prohibited products. Makers of black market "ghost guns" could be sued — but only if one could find them, and even if they were identified, they are not likely to be wealthy enough to attract the attention of a fee-motivated attorney. Various elements of the bill try to make it impossible for anyone sued to

mount a defense, including one passage that would require damages — at least \$10,000 per gun — to be awarded even if a judge declared the law to be invalid. And if the lawsuit provisions of SB 1327 are declared unconstitutional, the measure would substitute civil penalties instead. Finally, a federal law — rightly or wrongly — protects firearms manufacturers from liability suits. The bill is so obviously drafted as a political gesture that the American Civil Liberties Union opposed it for using the "flawed logic" of the Texas statute. "We believe it is a serious misstep to further entrench that flawed logic," the organization said when the bill was going through the legislative process. "In doing so, California will be promoting a legal end-run that can be used by any state to deny people an effective means to have their constitutional rights protected by the courts. This will continue to be replicated in states across the country — and with California's endorsement." Gun control is a serious subject involving a specific right to bear arms in the Constitution, one that the Supreme Court has recently bolstered in a way that Newsom dislikes. It deserves thoughtful political discourse, not interstate political oneupsmanship. *Dan Walters has been a journalist for nearly 60 years, spending all but a few of those years working for California newspapers.* ★

DBW Reminds Boaters to Carry a California Boater Card

California State Parks News Release

**SACRAMENTO, CA (MPG)** - California State Parks’ Division of Boating and Waterways (DBW) reminds California boaters of the requirement to obtain and carry a California Boater Card when boating on state inland and coastal waterways. Applying for one is a simple process, it costs \$10 and lasts a lifetime. Operators who are not in compliance with the law and caught operating a vessel without their California Boater Card will be cited accordingly. This is considered an infraction and base fines can range anywhere from \$100 – \$500.

U.S. Coast Guard boating accident data show that states with some form of boating safety education have fewer accidents and fatalities than states without any boater education requirements. California is one of the last states to implement a mandatory boating education requirement. The law is being phased-in by age. By Jan. 1, 2023, all boaters 50 years of age or younger must carry a card. All boaters, regardless of age, will need to carry one by Jan. 1, 2025. The card is verification that its holder has successfully taken and passed an approved boating safety education course. It is important to note there are exemptions to the law. For example, those operating a rental vessel or possessing a valid marine operator’s license issued by the U.S. Coast Guard do not need to obtain a California Boater Card. To date, DBW has issued more than 143,000 cards.

“It’s not just novice boaters that benefit from this education program by

learning the boating rules of the road,” said DBW Acting Deputy Director Ramona Fernandez. “Even experienced boaters find that a boating safety course can help them improve their boating knowledge and stay up to date with current boating laws.”

Applying for a California Boater Card is a simple process. Boaters can complete their application by visiting [CaliforniaBoaterCard.com](http://CaliforniaBoaterCard.com). The card only costs \$10 and lasts a lifetime. Boaters have an option to complete an online, classroom or a home study course. Boaters only need to complete one of the approved courses. Once DBW has received your application, proof of education and payment, you will receive a 90-day temporary boater card by email. You should receive your official boater card by mail within 30 days from the time the application was approved. Detailed information on the process and information on available boating safety courses is available online at [CaliforniaBoaterCard.com](http://CaliforniaBoaterCard.com). A toll-free telephone support line is also available at (844) 421-8333.

CAL FIRE Awards Nearly \$118 Million in Wildfire Prevention Grants

**SACRAMENTO, CA (MPG)** - As part of California’s strategy to prepare properties and communities against the devastating impacts of wildfires, CAL FIRE announced it will direct nearly \$118 million in funding for 144 local wildfire prevention projects across the state.

“Drought conditions have once again taken hold of California and are already contributing to another year of early fire activity,” said Joe Tyler, CAL FIRE Director and Fire Chief. “This funding is a critical part of our overall wildfire strategy.”

CAL FIRE’s Wildfire Prevention Grants enable local organizations like fire safe councils, to implement activities that address the hazards of wildfire and reduce wildfire risk to communities. Funded activities include hazardous fuel reduction, wildfire prevention planning, and wildfire prevention education. These projects all meet the goals and objectives of California’s Wildfire and Forest Resilience Action Plan, as well as the Strategic Fire Plan for California.


In Los Angeles County, the San Gabriel Valley Council of Governments is one of many organizations receiving funding towards wildfire prevention efforts. Their project will work towards developing a Regional Wildfire Protection Plan that will help to protect over 31 cities and communities, 22 of which are identified as “Communities at Risk”. In Lake County, a grant has been awarded to the Robinson Rancheria Band of Pomo Indians for a hazardous fuels reduction project in the wildland-urban interface that will

incorporate professional training as well as a community outreach and education campaign to increase awareness of defensible space and fuels management. In El Dorado County, a grant has been awarded to the El Dorado Fire Safe Council for a project that will assist residents with hazardous tree removal to slow the spread of the bark beetle infestation. The project will also assist with removing stressed and injured trees damaged by the Caldor Fire.

“These 144 local wildfire prevention projects, along with the 105 projects we just funded in September 2021, will significantly increase California communities’ preparedness towards wildfires,” said Chief Daniel Berlant, CAL FIRE Deputy Director of Community Wildfire Preparedness and Mitigation.

The Wildfire Prevention Grants Program is funded as part of the State’s Wildfire and Forest Resilience Strategy, in part with Cap-and-Trade auction proceeds administered by the California Climate Investments (CCI) Greenhouse Gas Reduction Fund. CCI is a statewide program that puts billions of Cap-and-Trade dollars to work reducing greenhouse gas emissions, strengthening the economy, and improving public health and the environment - particularly in disadvantaged communities. These grants are part of the Governor’s unprecedented \$1.5 billion investment in wildfire resilience. The Governor’s Wildfire Resilience initiative has launched 588 projects to date, in addition to projects to be funded by these grants. ★

# 5 Sacramento-Area Locals Selected in MLB Draft

## Susac, Hjerpe, Vogt, Harvey and Saul chosen

**LOS ANGELES, CA (MPG)** - Five Sacramento-area baseball players were recently selected in the 2022 Major League Baseball (MLB) Draft that was held over three days at L.A. Live in Southern California from July 17-19.

Daniel Susac, a 6-foot-4, 218-pound catcher, was the first Sacramentan taken off the board with the No. 19 overall pick in the first round by the Oakland Athletics. Susac played collegiately at the University of Arizona for two seasons from 2021-22 where he was the starting backstop.

Prior to Arizona, Susac played at Jesuit High School in Carmichael before graduating in 2020. His senior season with the Marauders was drastically cut short by the COVID-19 pandemic.

Susac isn't the first catcher in his family to be drafted to an MLB team in the Bay Area. In 2011, Daniel's older brother Andrew was selected in the second round of the MLB Draft by the San Francisco Giants. Andrew played six MLB seasons for four teams and won a World Series with the Giants in 2014.

Cooper Hjerpe, a 6-foot-3, 200-pound left-handed pitcher, was the second Sacramentan taken off the board with the No. 22 overall pick in the first round by the St. Louis Cardinals. Hjerpe played collegiately at Oregon State University for three years from 2020-22 where he was one of the Beavers' best arms. Hjerpe came out of the bullpen in his shortened freshman season before becoming a starter in 2021.

Prior to Oregon State, Hjerpe attended Woodland High School where he pitched and played first base before graduating in 2019. He threw a perfect game for the Wolves against Mira Loma on March 26, 2019, striking out all 15

batters he faced in a dominant 11-0 win in five innings.

Hjerpe now joins the Cardinals organization which is noted as having one of the best fan bases in MLB according to some. Nick Vogt, a 6-foot-1, 185-pound outfielder, was the third Sacramentan taken off the board with the 210th overall pick in the seventh round by the San Diego Padres. Vogt played collegiately at the University of California, Santa Barbara for three seasons from 2020-22 as an outfielder.

Prior to UC Santa Barbara, Vogt attended Davis High School until 2019 where he was not only an impressive athlete on the baseball and football fields, but also a "model student" in the classroom according to Davis Athletic Director Jeff Lorenson.

"Nick was an amazing baseball player for us, but more importantly a model student athlete with the highest degree of character," Lorenson told MPG via email. "He always put his team first and made his school community a better place!"

In addition to his time at Davis, Vogt also spent time playing for another local team, the Yuba-Sutter Gold Sox, who are based in Marysville. Vogt is the grandson of Gold Sox Managing Partner, Al Montna.

According to Gold Sox General Manager Tommy Lininger, over 75 collegiate athletes have moved on to the pros from the Yuba-Sutter-based program. Vogt most recently played for the Gold Sox in 2020, where he played alongside Ryan Harvey.

"It is great to watch these college ball players develop and move forward in their careers," Lininger said in a recent news release. "We had a solid roster in 2020 and it is no surprise both Vogt and Harvey went so high in this year's draft."

Harvey, a 6-foot-3, 195-pound right-handed pitcher, was the fourth Sacramentan taken off the board with the 340th overall pick in the 11th round by the New York Yankees. Harvey played collegiately with Vogt at UC Santa Barbara for three seasons from 2020-22.

Prior to UC Santa Barbara, Harvey attended Woodcreek High School in Roseville where he pitched and played the outfield before graduating in 2019. Harvey played varsity baseball for the Timberwolves for three seasons, reaching the playoffs each year and winning the Capital Valley Conference League Championship once.

"From a very early age, Ryan loved baseball. If something was round, he would throw it. If something was long, he would swing it," Ryan's mom, Keri Harvey, told MPG via email. "Ryan grew up playing recreational sports but chose to focus only on baseball after his freshman year of high school. Endless hours of wiffle ball turned into hours of studying his favorite professional players as he looked to gain velocity as a pitcher in high school. He also changed his diet and spent a lot of time in the gym getting stronger."

"These habits led to his success at UC Santa Barbara where he was the closer for the team because of his pitching velocity. While we

were always there to support him, and he was blessed with some great coaches, Ryan's dedication, commitment and love for the game got him to where he is today, and we are incredibly proud of him."

Eli Saul, a 6-foot-5, 215-pound right-handed pitcher, was the fifth and final Sacramentan taken off the board with the 378th overall pick in the 13th round by the Arizona Diamondbacks. Saul played collegiately at Sacramento State for three seasons from 2020-22.

Prior to Sac State, Saul attended Prince of Wales Secondary School in Vancouver, British Columbia. According to Sac State Athletics, Saul is the seventh Hornet pitcher taken in the MLB Draft over the last four years. Additionally, this is the second consecutive year that Arizona has selected a Sac State pitcher joining Scott Randall who was taken in the seventh round by the Diamondbacks in 2021 and is currently at High-A Hillsboro.

Saul and Randall join Chris Kinsey in 2003 as the three Hornets drafted by Arizona. According to Sac State Athletics, the Hornets have now had at least one player selected in 10 of the last 11 MLB Drafts, with a player chosen every year except for the pandemic-shortened 2020 draft. Additionally, at least one Sac State player has been drafted or signed as a free agent in each of the last 15 years and in 19 of the last 20 seasons.

One Sacramentan who anticipated hearing his name called and never did is McClatchy High School alumnus, Malcolm Moore. The highly touted 6-foot-2, 210-pound catcher, is committed to play collegiately at Stanford. Due to his strong commitment, MLB teams shied away from risking a draft pick on the 18-year-old who was likely going to Palo Alto regardless of where he may have been selected. ★
