California Legislature passes 21 bills

The second year of the coronavirus pandemic in California was shaped by two political undercurrents at the state Capitol: a budget awash with cash, thanks to a booming stock market and federal aid, and have reflected unfavorably upon a looming recall election asking votout of office.

The massive budget surplus allowed Newsom and legislative Democrats to go big on a progressive agenda they believe will help the state recover from COVID hardships. They passed a \$262.6 billion budget that includes preschool for all 4-year-olds, health insurance for low-income undocumented immigrants age 50 and older, and \$600 stimulus payments for most Californians – landing in bank accounts just weeks before the Sept. 14 recall election.

mandates, which officials have said California is already not on pace to meet. Democratic Senate leader Toni Atkins told reporters after the last night of the session wrapped up that such ambitious legislation may take more time to negotiate, and she expects that to continue next year.

The final night was unusually subdued compared with the chaos of the last two years. At the end of 2020, Republican senators were forced to vote remotely because of a COVID infection while Assemblymembers were required to vote in person, prompting one to make a late-night floor speech cradling her newborn baby. Not to mention the previous year, when the Senate was evacuated and a hazmat crew called in after an anti-vaccine protester tossed a menstrual cup of blood from the overhead gallery, splattering senators.

Free County Flu Clinics **Going on Now**

SACRAMENTO COUNTY, CA (MPG) - With flu season approaching, Sacramento County Public Health urges everyone to get a flu shot to protect themselves and their families from influenza. From now through Nov. 13, the Sacramento County Immunization Assistance Program will host free Adult and Family Flu Clinics throughout Sacramento County.

This year it is especially important to get a flu shot as COVID-19 continues to spread. In an effort to fight both viruses, all Public Health clinics will offer flu and COVID-19 vaccines, including at existing COVID-19 vaccine clinics. It is safe to receive flu and COVID-19 vaccines at the same time, according to the

"Vaccines are proven to reduce the risk of severe illness, hospitalization and death," said Sacramento County Public Health Officer Dr. Olivia Kasirye. "Those who cannot receive the vaccine, including infants and individuals with a compromised immune system such as those going through chemotherapy, rely on others being vaccinated to help protect them."

All clinics take walkins, without the need for appointments.

Vaccination of people at high risk for flu complications is especially important to decrease their risk of severe illness. These include seniors and people with chronic conditions such as diabetes, high blood pressure, lung disease and kidney disease. The same underlying health conditions put people at higher risk for COVID-19. If you are at high risk, it is especially important for you to get a flu vaccine this year. Getting a flu vaccine will not only reduce your risk from flu but also help conserve potentially scarce health care resources.

Flu vaccine is also recommended for infants ages six months and older who do not have a medical condition that makes the flu vaccine inadvisable.

As with COVID-19, it's crucial to practice good health habits:

If you feel flu-like symptoms, limit contact with others to keep from infecting them:

Stay home for at least 24 hours after you fever is gone, except to get medical care or for other necessities; Cover your coughs or sneezes and wash your hands; Avoid touching your eyes, nose and mouth; Clean and disinfect surfaces and objects that may be contaminated with Continued on page 2

SACRAMENTO REGION, CA (MPG) - Carla Cruz Medina's pursuit of a science education has been fraught with obstacles. She was the first in her family to attend a university. As a woman of color from Mexico, she has been a minority in most of her courses. Her finances have been strained.

SACRAMENTO REGION, CA (MPG) - In one of the largest movements of American River sediment since the Gold Rush, a Water Forum project is relocating nearly 16,000 cubic yards of gravel in shallows near Ancil Hoffman Park.

Huge excavators, dump trucks and bulldozers have worked against the clock to restore diminished fish spawning habitats before this fall's salmon run. By November, giant Chinooks will return-hell-bent on reproduction-by the thousands to home waters. Soon after, steelhead arrive for the same purpose. Because Nimbus and Folsom dams curtail migration, spawning must occur in river shallows before these obstacles-or be achieved artificially at the Nimbus Fish Hatchery. "We have a narrow work window, as specified

by the Endangered Species Act," explains Water Forum Program manager Erica Bishop. "Our work is targeted over a time frame when it's least likely to affect resident fish."

Forming a giant alcove upstream from the golf course, the augmented Ancil Hoffman riffle will provide fish increased gravel areas for redd (nest) building.

"Salmon and steelhead have traditionally spawned in this area," Bishop explains. "Over time, rivers move sediment and these gravel beds have become degraded. Because of the dams, new sediment can't replace what's moved downstream. The lower American River is gravel-starved. Fish don't have sufficient breeding habitat. Some return to their home river and find nowhere to spawn."

The \$1.4 million Water Forum project is one of many restoration programs that

support endangered anadromous species that begin and end lifecycles in the American River. Thousands of tons of gravel - sorted to exactly the size preferred by nesting fish – will create an 11-acre alcove at Ancil Hoffman. When temporary levies are bulldozed and water rises, new riffles will accommodate salmon and steelhead breeding. The development includes a rearing inlet to host growing juveniles before their spring swim to the Pacific Ocean. Planting of willows, cottonwood and other native vegetation will bring insects to feed fry. Riverside trails at the Effie Yeaw Nature Center will be improved to allow public observation.

Similar restorations have achieved success at Sailor Bar, River Bend Park,

Sacramento Bar and at Nimbus and Sunrise stretches of the American River. "Our surveys count the number of redds in the river and juvenile fish," says Bishop. "We know restored habitats are being used. Although we have low water flows due to drought this year, our project is focused on long term improvement of river habitat."

The Ancil Hoffman project is funded by the Bureau of Reclamation. Sacramento City, Sacramento County and local water agencies fund the Water Forum.

Construction areas are off limits for public access. Work-in-progress may be viewed from trails at Effie Yeaw Nature Center preserve. Learn about the Water Forum at www.waterforum.org ★

Mental Health Professionals to Respond to Mental Illness-Related Calls

SACRAMENTO, CA (MPG) - The Office of Assemblymember Kevin McCarty issued the following statement:

"Governor Newsom signed my community policing bill, AB 1443, which will provide a much needed framework to allow members of community mobile crisis teams – instead of law enforcement - to respond to mental illness related calls.

In 2020, the Sacramento Police Department received about 18,000 mental illness and 5150-related calls of service. Despite the availability of municipal staff who are qualified and trained to respond to mental illness-related calls where a police presence is not warranted, under current law, these professionals need prior approval by the County before they are able to respond. AB 1443 will empower local governments to utilize health professionals, who have experience in mental health-related issues, to provide the proper care and service to assist individuals with mental health needs.

Thank you to the strong coalition of advocates and organizations who supported this bill and helped get this bill to the Governor's desk." ★

With more than 24 million unconnected households nationwide, the digital divide disproportionately affects minority and low-income populations. According to the Federal Communications Commission, 35 percent of adults who do not use broadband at home are older, poorer, less educated, more likely to be a racial or ethnic minority, and more likely to have a disability than those with a home connection. education and financial independence can be, especially for a woman. I wanted to be capable of making my own way in the

After graduating from Grant Union High School, Cruz Medina attended the University of California, Los Angeles, where she earned a Bachelor's Degree in Spanish and Biology. "There weren't many people who looked like me" in her program, she said, which "made me question whether I belonged."

She chose Sacramento State to pursue her master's and at first felt a bit lost.

"I didn't really know anyone from my background who had entered a master's program," she said. "I didn't even know what questions to ask of an advisor."

In short order, though, Cruz Medina grew comfortable as a Hornet.

"Even though there aren't a lot of people of color in my program, I still feel a sense of community," she said. "It's such a nurturing environment. The University and the professors really care about you and your education."

Cruz Medina has excelled not only in the classroom but outside of it. She founded an organization, Pacers United, that helps seniors at her high school alma mater apply for college and financial aid. She also works as a research assistant with Environmental Studies Professor Michelle Stevens to restore wetland and riparian acreage at Bushy Lake along the lower American River.

"Carla is a shining example of what it means to be a Hornet," President Robert S. Nelsen said. "She is an excellent scholar with a big heart."

Biology Professor Timothy Davidson, who served as Cruz Medina's advisor, called her highly motivated, curious, and enthusiastic about advancing her own goals and helping others.

"She is among the most collaborative, positive, and community-minded students I've worked with," Davidson said. "She genuinely cares about others and our community, which explains why she is so well-regarded by her classmates and professors."

As she advances in her education, Cruz Medina's focuses are on ecology, conservation, and biostatistics. She hopes to parlay her knowledge into a career promoting fair treatment of all people in the development and implementation of environmental regulations and policies.

"My dream job would be an intersection of conservation and environmental justice," she said. "I'm very passionate about those things."

She believes that the CSU Trustees' Award will help her achieve her goals.

"As a first-generation college student, a woman, and a person of color, I know that finances are a huge barrier to earning a degree," Cruz Medina said. "It's something we don't talk about enough. This scholarship will help me receive an education without having to go into immense debt. It will help ease my financial burden. That means a lot."

ShotSpotter Technology Coverage Expansion in Sacramento County

SACRAMENTO COUNTY, CA (MPG) - The Sacramento County Sheriff's Office is excited to announce its ongoing and growing partnership with ShotSpotter. Since 2018, the ShotSpotter technology has been active within specific areas of south Sacramento County. An expansion of the coverage area has been deployed in two distinct areas of north Sacramento County, Watt and Roseville Road and the area around Howe Park in the north central part of the county; both communities have historically been plagued by gun violence.

The ShotSpotter technology detects gunfire, through a series of strategically placed microphones, and notifies dispatchers and deputies of the location in real-time. The real-time digital alerts include a precise geographical location such as the address, number of rounds fired and the type of gunfire. This technology significantly reduces the 9-1-1 notification time as it can be difficult for community members to differentiate the sound of gunfire as opposed to similar sounds. It also

alleviates the occurrence when a community member is either too afraid to call and report or doesn't call because they feel someone else has reported it.

This technology greatly improves emergency response times getting deputies to the area in a tactically safe manner to assist the affected community and/or victims of gun violence. It also increases the likelihood of preserving and collecting evidence as well as apprehending suspects.

During the system installation process occurring August 1, 2021 to September 22, 2021, the expansion system recorded 146 discharged rounds in 56 separate ShotSpotter gunfire incidents. The 56 activations included 12 incidents with single gunshots, 36 incidents with multiple gunshots, and eight events of probable gunfire. Citizens generated twenty-four 9-1-1 calls to the sheriff's office during this same time frame/location or less than half of the legitimate instances of gunfire. The ShotSpotter expansion will be a game changer for the Sacramento County Sheriff's Office and the community in holding those engaged in gun violence accountable.

Rio Linda Resident Shares View of Early Ranch Life

FAIR OAKS, CA (MPG) - A collection of personal photos and historical papers of an early Fair Oaks founding family, Irving and Claudia Gum, former owners of 107 acres at the corner of Madison Avenue and Kenneth Drive offers a special look into what early life in Fair Oaks and Orangevale was like from the mid-1880s.

In its history, Gum's farm produced corn, strawberries, and hay. His pumpkin patch, called U-Pick Pumpkins, was a popular autumn destination. He remained an active farmer and rancher well into his 90s.

Irving Gum died in 2015, and his wife Claudia passed away in 2017. The couple had no children. Proceeds from the sale of the Gum Ranch property were given to the Shriner's Hospital for Children in Sacramento, per the couple's wishes.

Reed said she donated the collection to the Citrus Heights Historical Society because she was very fond of her Uncle Irving and Aunt Claudia throughout their lives, and said she wanted to see that their family legacy be properly preserved.

Before Claudia Gum passed away in 2017, she gave Wilma's personal diary and four banker's boxes worth of family photos, and other material to Reed.

Reed said she enjoyed discovering memorable family stories and anecdotes about her Uncle Irving and their shared family history as she read Wilma's diary. The historic materials illustrate the broader family tree which connects the Gum and Rusch families.

The diary tells how Fred and Julia Volle, Wilma's maternal great grandparents originally came to Citrus Heights in the 1850s and how Perry and Lilly Gum, Irving and Wilma's parents, first arrived in Fair Oaks in 1895.

A black and white family photo likely taken in the 1920s shows Irving in the center with his father, Perry Gum and his mother, Lilly Rusch-Gum. Wilma and Irving also had a brother Glenn.

Herman and Amelia Rusch were Irving and Wilma's maternal grandparents. One of their daughters, Lilly, was the mother of Irving, Wilma and Glenn Gum.

When Herman married his second wife, Amelia Volle, he left his two and Julia, from his first wife, Julia Volle (another Volle daughter), to be raised by their namesake grandparents, Fred and Julia Volle which is how they later came to inherit

Today, the Murphy bed frame which once Wilma slept in, is still in the Rusch Home, exactly as Wilma described it as a child.

"Between the two groups, we've scanned about 120 to 130 items," Fritz said. "We still have a way to go."

The Heritage at Gum Ranch, a new housing community developed by Elliott Homes, is under construction on the south end of the Gum Ranch property, northeast of Bella Vista High School, adding 250 new homes to the area. The community's main entrance, off Kenneth Ave is named Gum Ranch Road.



Your friends have given you WRONG information regarding Medicare that can lead you to choose the wrong Medicare plan for your medical situation. Medicare Supplements and Medicare Advantage Plans are completely different types of Medicare policies.

With a Medicare Supplement, there is not a network of any kind; you have the freedom to use any healthcare provider/facility that will bill Medicare. The Medicare Supplement will pay for your Medicare out of pocket that Medicare Parts A and B will not pay.

With a Medicare Advantage PPO plan, there are lower cost innetwork providers/facilities as well as out of network benefits that will cost you more. In 2021, a popular Medicare Advantage PPO plan has a maximum ranging from \$6,700 to \$7,500 in-network while out of network costs range from\$9,000 to \$11,500.

Most never consider that they could have an out of network provider/facility for their medical claim, but in these current times many healthcare providers/facilities are out of network with a Medicare Advantage PPO

Below are some of the differences in the two plans:

Medicare Supplement:

- 1. A Medicare Supplement works directly with "Original Medicare". Medicare pays its share of the Medicare-approved amount for "medically necessary "covered healthcare
- 2. Your Medicare supplement will pay its share. With a Medicare Supplement, you chose which doctor, hospital, home health agency, skilled nursing facility, etc. that accepts Medicare assignment for your healthcare. You and your healthcare providers are in control of your healthcare.
- 3. The downside to a Medicare Supplement is that you have a monthly premium that may increase the premium rate each year.
- 4. Medicare prescription (Part D) drugs plans are not included, so you may want to enroll and will pay separately for a "Stand alone" Medicare (Part D) Prescription drug plan.

Medicare Advantage PPO Plan:

- 1. To qualify for any Medicare Advantage plan: a) You must be enrolled in both Medicare Parts A & B. b) Live in the service area 6 months out of a year...
- 2. When you choose a Medicare Advantage Plan, then Medicare pays the insurance company a certain dollar amount every month for your care for the plan you are enrolled. Your Part B must always remain in effect.
- 3. When you go to the doctor, hospital or visit vour pharmacist, vou must only use vour Medicare Advantage insurance card, not your Medicare (red, white and blue) card.
- 4. A Medicare Advantage Plan must provide all your Part A and Part B benefits and some Medicare Advantage Plans have Part D prescription drug plans included. Also, has "extra" benefits such as gym membership, dental and vision.
- 5. Verify that your providers or facilities accepts the Medicare Advantage plan enrolled in.

Today we have two contrasting quotations from world leaders. One said: "Mandatory vaccinations will never be allowed because [this] is a free country and its people are sovereign." The other said: "This is not about freedom

or personal choice." The first was by Vladimir Putin. Russia, a free country! The second was by Joe Biden. The U.S. is no longer a free country, and the people are not sovereign. Nor are the once-sovereign states. If state governors won't cooperate with him, "I'll use my power as president to get them out of the way." It is not clear exactly how he would accomplish that. Invade the state and occupy its capitol and its courts? Arrest the govlegislature and throw them into prison without bail like some January 6 demonstrators? Already, many states are suing – perhaps we will learn whether the Tenth Amendment to the U.S. Constitution has any meaning.

California Experiments with Social Democracy

California, as everyone should know by now, has the nation's highest rate of poverty as determined by the Census Bureau when the cost-of-living is included in the calculation.

While family incomes in California are not particularly low vis-à-vis those in other states, our extremely high living costs, especially for housing, mean those incomes do not stretch as far as they would elsewhere.

The Public Policy Institute of California takes the issue a bit further by calculating how many Californians are living in near-poverty, using methodology similar to that of the Census Bureau.

third of the state's nearly 40 million residents experience severe economic distress. They are, for the most part, workers in low-pay jobs and their families, and their plight has been exacerbated by the nearly two-year-long COVID-19 pandemic, which has hit them the hardest both medically and economically.

Backed by unions, Gov. Gavin Newsom and his fellow Democrats have vowed to reduce the state's high levels of poverty and income disparity and this year generated a bushel basket of legislation they contend will narrow the gaps.

California is, in effect, as he signed a bill banning testing long-held beliefs of those on the political left that America should move closer to the European model of "social democracy" by expanding supportive public services and empowering workers in their dealings with employers.

The former include increasing eligibility for Medi-Cal, the state's health care system for the poor which already covers more than a third of California's residents, expanding early childhood education to both improve learning outcomes and free more parents to work, and increasing spending on housing for low- and moderate-income families.

The latter is a variety of bills that impose new workplace and compensation standards on industries that employ large numbers of low-paid workers, most notably garment production, agriculture and the ever-increasing distribution centers operated by Amazon and other big corporations.

"We cannot allow cor-Altogether, more than a porations to put profit over people," Newsom said as he signed legislation to ease production quotas in Amazon's massive "fulfillment centers."

"The hardworking warehouse employees who have helped sustain us during these unprecedented times should not have to risk injury or face punishment as a result of exploitative quotas that violate basic health and safety," Newsom added.

"California is holding corporations accountable and recognizing the dignity and humanity of our workers, who have helped build the fifth-largest economy in the world," Newsom said later piecework pay in the Los Angeles-centered garment

Newsom also signed bills to expand protections for household domestic workers, raise minimum pay for disabled workers, increase criminal penalties for "wage theft" by employers, and provide farm workers with protective gear for wildfire smoke.

It has not been, however, a 100% sweep for unionbacked legislation. Newsom vetoed a bill to allow mail ballots in elections for union organization of farm workers and another that would have expanded paid family leave.

Expanding government services will, of course, cost the state billions of dollars, which it can afford now as income taxes pour into its treasury, but whether it can be sustained is questionable. California is inordinately dependent on high-income taxpayers, which means its revenues plummet during economic downturns.

New benefits for workers, meanwhile, will increase employers' costs, which could drive some to shift operations and jobs to lowercost locales. The garment industry is particularly competitive, which is why so much of it has already gone overseas.

Higher public and private costs are the flip side of California's experiment in social democracy. Ultimately, Newsom and the Legislature cannot repeal the laws of economics.

Governor Signs SB 639 Prohibiting Work CLG NEWS UPDATES for Less than State Minimum Wage

SACRAMENTO, CA (MPG) - Governor Newsom has signed State Senator María Elena Durazo's (D-Los Angeles) SB 639 into law, which will phase out the use of the federal 14(c) certificate in California, and ultimately prohibit paying workers with disabilities less than the California minimum wage and transition workers with disabilities to competitive, integrated employment. California joins Alaska, Maryland, Nevada, New Hampshire, Oregon, and Texas, in outlawing paying workers with disabilities a subminimum wage. The bill is sponsored by Disability Rights California, the State Council on Developmental Disabilities, and Legal Aid at Work.

"California is ending the subminimum wage for people with disabilities," said Senator Durazo. "All work should be treated with dignity, and that means that nobody is paid less than the minimum wage. SB 639 develops a phaseout plan to ensure a path to competitive, integrated employment for these workers. I applaud Governor Newsom for recognizing the injustice that workers with disabilities are facing and remedying this clear violation of their civil rights."

Since 1938, Section 214 (c)(1)(A) of the Fair Labor Standards Act (FLSA) has given California employers the ability to apply for a certificate that allows them to pay employees with disabilities less than the federal minimum wage of \$7.25 an hour. This FLSA 14(c) certificate was intended to provide opportunities for employment for World War I veterans with disabilities, but instead created segregated workplaces, and the unemployment rate of persons with disabilities is twice as high as other workers.

What has actually materialized under FSLA is a pool of highly exploited labor.

Over 5,000 Californians with disabilities are currently working in sheltered workshops and are being paid as little as 2 dollars per hour.

Sheltered workshops were originally developed to provide employment opportunities for disabled World War I veterans returning from service. Since then, sheltered workshops have morphed into full-scale operations to primarily employ persons with intellectual or developmental disabilities in segregated settings. Beyond the FSLA, the federal Americans with Disabilities Act of 1990 made it illegal for employers to discriminate against workers who had disabilities. Yet, sheltered workshops remain in operation and the economic opportunities for people with disabilities continue to erode. SB 639 phases out sheltered workshops, develops a path to integrated employment, and ensures workers with disabilities earn no less than the California minimum wage.

"Today was a great day for Californians with disabilities who want to work in the competitive labor market," said Andy Imparato, executive director of Disability Rights California. "By ending the discriminatory practice of paying people with disabilities less than the federally-protected minimum wage, Governor Newsom has helped California reassert its role as a national leader in disability rights and worker rights."

"About 100 years ago, it was seen as compassionate to pay less to people with disabilities," said Aaron Carruthers, executive director of the State Council on Developmental Disabilities. "But times changed, views of what is possible for people with disabilities changed, and options changed. With the Governor's signature, people who were once trapped in sheltered workshops will now be able to design a truly meaningful day. This is the dignity the Governor spoke about when signing the bill."

The spill, first reported Saturday, originated from a pipeline off the coast of Huntington Beach connected to an offshore oil platform known as Elly. The failure caused at least 126,000 gallons of crude to spill into coastal waters creating a slick that spanned about 8,320 acres - larger than the size of Santa Monica -- and sent oil to the shores of Newport Beach and Huntington Beach early Sunday. Oil from the spill also infiltrated Talbert Marsh, a 25-acre ecological reserve in Huntington Beach that is home to dozens of species of birds.

Professor who was suspended after refusing to grade black students more leniently sues UCLA | 29 Sept 2021 | Updated: An accounting professor who was suspended from UCLA's Anderson School of Management for refusing to grade black students more leniently in the immediate aftermath of George Floyd's death has filed a lawsuit against the school for harming his professional reputation. Gordon Klein, who joined the Anderson school in 1981, is seeking compensatory damages, punitive damages, and attorney fees in a lawsuit filed with a state court in Los Angeles on Tuesday. Following the death of Floyd at the hands of police in May of last year, Klein received a letter from a non-black student asking that he provide more leniency in grading the work of black students... The lawsuit charges that some students in a pre-med Life Sciences course celebrated receiving "perfect scores" on a test they never even took, proclaiming: "We did it boys, [Life Sciences] is evil no more." "Yet another instructor boldly announced in writing to his History class 'you will not be required to write the final assignment because your [teaching assistants] have volunteered to write this final assignment for you...As a practical matter, you all will receive full points."

School boards group asks Biden to consider labeling opponents 'domestic terrorists' | 30 Sept 2021 | The National School Boards Association has asked Joe Biden to look into slapping a "domestic terrorist" label on "angry" parents and community members who speak their minds at board meetings. 'America's public schools and its education leaders are under an immediate threat," the group says in its letter to the president. "[As] acts of malice, violence, and threats against public school officials have increased, the classification of these heinous actions could be the equivalent to a form of domestic terrorism and hate crimes." The NSBA wants the Gun-Free School Zones Act, the USA PATRIOT Act, the Matthew Shepard and James Byrd Jr. Hate Crimes Prevention Act, the Violent Interference with Federally Protected Rights statute, and the Conspiracy Against Rights statute all invoked to help prevent alleged threats, Education Week reports.

More US Airlines Impose Vaccine Mandates: American, Alaska, JetBlue | 3 Oct 2021 | More U.S. air carriers - American Airlines, Alaska Airlines, and JetBlue - have announced that they'll be requiring employees to be vaccinated against COVID-19. The move comes as the Biden administration has ramped up pressure on airlines to require vaccines as part of a broader strategy to boost inoculation rates in the country. Joe Biden signed an executive order in September requiring federal contractors to mandate shots for employees, with the White House later setting a Dec. 8 deadline for them to get the vaccine. The airlines say they provide special flights and other services for the government, so placing them under Biden's mandate.

It's not available in the U.S. They even admit it. I sent them a letter three days later going "What are you doing?" What they did is they extended the emergency use authorization for the Pfizer drug vaccine that's available in the U.S., here that's more than 30 days later, they haven't asked that very simple question. If you're saying that the Pfizer drug is the same as the Comirnaty, why didn't you provide FDA approval on that? So, there's not an FDA-approved drug and, of course, they announced it so they could push through these mandates so that people actually think, "Oh, OK now these things are FDA approved." They are not and again, maybe they should be, but the FDA isn't telling me why.





Defendant Convicted for Brutal Rape, Be Prepared! Sign up **Sexual Assault of Two Victims**

SACRAMENTO COUNTY, CA (MPG) -Hawthorne McGee was convicted by a jury of rape, rape of a 14-year-old and oral copulation by force of a 14-year-old. The jury also found true a multiple victim enhancement.

In June 2006, the then 14-year-old victim saw a friend driving in a car with McGee. The victim and her friend ended up going back to McGee's house. McGee instructed the friend to leave the house and the victim stayed behind. McGee then forcefully and brutally raped the victim for approximately one hour in his living room. McGee's girlfriend was in the bedroom, but she could hear the victim crying and telling McGee she was only 14 years old. The girlfriend was able to drive the victim away from the house. In November 2009, a separate victim was waiting for the light rail when McGee began talking to her. McGee persuaded her to go have pizza with him. He then persuaded her to go back to a motel with him. The victim stated numerous times to McGee that she did not want to have sex and that they were just going to the motel to talk. The victim stated that once inside the room, McGee punched her several times and strangled her as he began to sexually assault her. The victim passed out and woke up in the bed several hours later with injuries all over her body. Evidentiary exams were conducted and DNA was collected after both sexual assaults. A CODIS hit later matched to McGee. After further investigation, charges were filed against McGee for both

McGee has prior convictions for domestic violence, gun possession, DUI and reckless driving.

McGee faces a maximum sentence of 45 years to life in prison. Sentencing is set for October 20, 2021, at 1:30 pm in Department 23 before the Honorable Laurie Earl.












Young Readers Fund Honors Retiring Library Director Rivkah


Friends of the Sacramento Public Library

SACRAMENTO COUNTY, CA (MPG) - Rivkah K. Sass will retire as Director of the Sacramento Public Library at the end of 2021, but she will be leaving behind a legacy that will help early readers for many years to come. Friends of the Sacramento Public Library has launched a campaign to raise funds to endow the Young Readers Fund, honoring Rivkah Sass and nurturing early readers. Future Library Directors will be able to use income from the endowment to fund books, materials and innovative programs and technology for young readers.

The Friends' fundraising campaign kicked off on September 15 and will wrap up on December 31, with a goal of raising \$100,000. Find out more and donate at: saclibfriends.org.

"When we asked Rivkah how she wants to be remembered, she did not hesitate," said Friends President Karen Wilson. "For Rivkah, it's always been about the kids." The Friends are entering their sixth year of partnership with the Library on Book First, a program that provides a free book to kids in underserved schools, with 60,000 kids receiving books in the program so far. More than 180 schools will take part in Book First in the 2021-22 school year.

A former children's librarian, Rivkah has made Sacramento's library a national frontrunner in its work to support early learning. Her dedication to connect libraries with schools led to the creation of the Student Success card, which gives all

students in a school district full access to the library's digital resources. The library's Summer Read-ing Program has seen a 400% rise in participation, with more than 33,000 a year people taking part.

In recognition of her leadership, the American Library Association awarded Rivkah its 2020 Charlie Robinson Award, given to a public library director who has been a risk taker, an innovator, or a change agent. Sacramento Public Library is a regular recipient of national recognition.

During her 12 years of service as Library Director, Rivkah has been a determined advocate for library services. Some examples include:

Adding critical staffing to support youth; Responding to the public's request to expand library hours, reworking limited resources to add more than 169 access hours across 28 locations; More than doubling

funding for books and materials to meet community demand for a robust and diverse collection; Leading the effort to launch the Career Online High School initiative at SPL, providing adults the opportunity to earn an accredited high school diploma; Introducing the Library of Things, allowing library users to check out everything from a GoPro camera to a ukulele to a leaf blower; Introducing the I Street Press, making it possible for local writers to self-publish more than 34,000 books since 2011; Installing makers spaces, which are creative spaces equipped with technology like 3D printers and sound equipment.

"Rivkah has done so much for our whole community, especially our children," Wilson says. "The Young Readers Fund gives the community a chance to say thank you, and keep her good work going."
