WEST SACRAMENTO (MPG) - A new program called Community Schools

held a kick-off event at Riverbank Elementary School. An estimated 800-900 people showed up for free food, free ice cream, free haircuts, free coats and access to resources that will soon be available through our school district.

## West Sacramento Man Facing Murder Trial for Fentanyl Poisoning

- A West Sacramento man has received the news that El Dorado County Judge Vicky Ashworth ruled, at a pre-trial, that there is sufficient evidence to merit a full trial for second-degree murder, for the death of 20-year-old Gillian Peterson-Murray. Kamaal Yusuf is accused of selling the 20-year-old counterfeit pills containing fentanyl and that those pills led to her death in May 2022.

According to an article in the Mountain Democrat, and verified by West Sacramento Police Department for their involvement in the case, Gillian Peterson-Murray and her live-in boyfriend, Michael Keane, began doing the drug known as M30's after a pain pill prescription ran out. Keane had suffered an injury and was prescribed OxyContin but after a 30-day prescription ran out, they

began seeking the drug elsewhere.

Keane testified in Yusuf's pre-trial that he and his girlfriend would do the drug once or twice a month, by his estimate. The couple would also drink on weekends, according to Keane's testimony. The couple used the Snapchat app to obtain a dealer after a friend was "promoting" someone going by "Mr. Sneeze". The couple's friend used "Sia Mosley" as their username. "Mosley" was allegedly advertising pills for sale.

Keane testified that he remembers using Snapchat messages to arrange the meeting with "Mosley", where they planned to purchase the pills. They arranged the meeting on a road in Folsom. It is reported that Keane's testimony in pre-trial contained inconsistencies regarding the date of the meeting, from his initial statement to the Police. However, El Dorado County Sheriff's Detectives were able to verify May 15, 2022, as the day when the meeting took place, through GPS data and license plate

recognition. Keane stated that the meeting was only a minute or two and that they were told to "take less than a whole pill because the pills were stronger than regular Oxy." Counterfeit (also called fake or pressed pills) pills that contain fentanyl are more likely to have inconsistent dosages: DEA.gov reports in 2022, that the DEA seized more than 58.3 million fentanyl-lace fake pills and more than 13,000 pounds of fentanyl powder. The 2022 seizures are equivalent to more than 387.9 million lethal doses of fentanyl.

Keane said that they went home and each snorted half of a pill. The following Wednesday night, Keane said that he and Peterson-Murray took the drug again, this time

using a full pill each as well as shared some alcoholic drinks and a bottle of champagne. Both passed out, and when Keane woke up he found his girlfriend not breathing. Fentanyl shuts down the respiratory system so quickly that most do not even feel it coming on.

Peterson-Murray was rushed to the hospital where she was pronounced dead. Toxicology showed she had nicotine, norfentanyl, caffeine, cotinine and sertraline in her system. Plus, her blood alcohol content was .123, and she had more than double a lethal dose of fentanyl (8.9 nanograms).

The investigation that was opened after Peterson-Murray's death led Police to plan an undercover buy from "Mosley", through Snapchat. Police went undercover and completed a deal in Folsom. The deal was planned for El Dorado Hills but was moved to

# Sacramento Weir Widening School Program Project to Affect Traffic to Span District

**Yolo County** News Release

WOODLAND, CA (MPG) -The United States Army Corps of Engineers' (USACE) contractor, Granite Construction, has begun work to widen the Sacramento Bypass flood control structure. The Sacramento Weir Widening Project is taking place along Old River Road, also known as County Road 22, just north of the City of West Sacramento city limits. This crucial step toward bolstering flood control measures along the Sacramento River aims to enhance flood stage management both upstream and downstream of the Sacramento Weir during high-flow events, thereby mitigating flood risks and safeguarding the areas adjoining the Sacramento River.

As this project gets underway, it is imperative for commuters to anticipate potential delays stemming from project construction, which is anticipated to persist until late 2026. Motorists are encouraged to exercise caution, adhere to construction signage. and reduce speeds while navigating through the construction zone. When possible, motorists are encouraged to take alternative routes.

Motorists will encounter a temporary all-way stop intersection situated at the northern end of the existing Sacramento Bypass bridge structure, where County Road 126 converges with Old River Road. This temporary measure, including the installation of stop signs and detour roadway, is anticipated to be implemented by August 21 and will remain until the weir extension component of the project is completed in 2025.

A key element of sures

the project entails the construction of a 1,500-foot-long extension of the Sacramento Weir, stretching northwest along Old River Road. This extension will be accompanied by essential improvements such as levee enhancements, roadway upgrades, utility enhancements, and fish passage improvements.

To accommodate the construction of the weir extension, a section of approximately 1,000 feet of Old River Road will be temporarily removed. In its place, a detour route will be established. This detour is projected to be operational for an estimated two-year period during the course of the weir extension construction.

Village Elkhorn Elementary, Riverbank Elementary and River City High School but the services are available to all students and their families in the Washington Unified School District. The program is described as a partnership between WUSD, United Way and Yolo County Children's Alliance. In reality, it is a partnership between a multitude of organizations in our community and will make services available to help with a huge variety of needs that our community members may have.

Focusing on our students and their families, an estimated 600 tickets were given out for free ice cream within the first half an hour of the event. In addition, the food trucks had agreed to make food for 200 people and found themselves hitting that number at just a short time into the event. Around 100 were fingerprinted and live scanned so that they can volunteer at their child's school. The school approved for

them to continue cooking until they ran out of food. It is also estimated that at least 50 free haircuts were done that day by the Mixed Institute of Cosmetology and Barbery.

Resources that partnered up for the event included Home Run, WUSD Adult School, Student Services Department, Yolo County Library, Yolo County Office of Education, Head Start, Three Sisters Gardens, Self-Awareness & Recovery, Wayfinder for Adoptive Families, Walmart Vision, Yolo County Oral Health Community, Catholic Charities, River Cats, Empower Yolo, COVID testing, Calfresh, Car Seat Safety Program and more.

With this group of partners Community Schools will have on-site resources to help with hunger, employment, domestic violence, adoptive support, diploma and GED education, healthcare, drug and alcohol issues and much more. The point of the community schools is that they will have access to

these resources from right there. This should make it easier than when they have to source out the help for reasons like transportation or follow up issues.

There will be a facilitator at each site speaking a total of five languages. They will work together to help our students and their families with their needs. The Community Schools Program is growing very quickly due to the many wonderful local businesses and organizations that are getting involved. In fact, it is growing so quickly, they couldn't even provide a complete list yet of partners that have joined.

## **YoloWorks! Career Centers Offer NorthStar Digital Literacy Assessment**

WOODLAND, CA (MPG) -YoloWorks!, the Yolo County Workforce Innovation Board, and the Yolo County Health and Human Services Agency will give jobseekers an opportunity to obtain a Northstar Digital Literacy Assessment, aimed at helping adults acquire the skills they need in today's workplace.

"People without basic computer know-how are at a disadvantage when it comes to finding a job because employers expect basic computer skills for most jobs, including many entry-level positions," said Workforce Innovation Board Director Erica Johnson. "We joined Northstar because it will help our clients have a better chance at getting jobs and getting ahead."

The free set of assessments includes self-guided modules: **Essential Computer Skills** (Basic Computer Skills,

Internet Basics, Using Email, Windows, Mac OS), Essential Software Skills (Word, Excel, PowerPoint), and Using Technology in Daily Life (Social Media, Information Literacy, and Creative Job Search). Closed captioning is available and screen readers are supported.

Anyone can access the modules and take the tests online at digitalliteracyassessments.org.

At the end of each test, the user receives a page of results, which lists the skills that have been mastered and the areas that need improvement. Many community organizations offer computer classes that are aligned with Northstar Digital Literacy Standards.

"The modules are based on a set of basic computer competency benchmarks developed by a diverse group of literacy providers, business representatives, and nonprofit agencies," said Erica Johnson. "These standards help ensure that computer classes are teaching adult learners the exact skills they need to succeed in the workplace."

To earn a certificate for one or more of the modules, adults must take the tests in a supervised setting at an approved test site. YoloWorks! Career Centers is among the community organizations using the standards as part of its programming and offering the certificates.

## **West Sacramento Man Facing Murder Trial for Fentanyl Poisoning**

Continued from page 1 Folsom to ensure Police coverage. Police bought 25 blue M30s for \$250.

After the transaction, the Police followed the vehicle to a house on Dover Street in West Sacramento. On the way, Police witnessed the vehicle pull over on the wrong side of the street, and with an unobstructed view, saw the drug deal that took place. An additional vehicle was located at the house that matched the description of the vehicle Keane had described to

the Police from their deal. Police later attempted to stop Yusuf at a Safeway but he quickly sped out of the parking lot and Police did not pursue him, in the interest of public safety. Using a search warrant and the aid of the West Sacramento Police, detectives served a search warrant on the Dover

Street home where they found two safes containing tens of thousands of dollars, more than 5,000 pills containing fentanyl, cocaine and Yusuf's social security card. In addition, they recovered multiple cell phones and marijuana packaged for sale with the logo of the Trix Rabbit with droopy features and bloodshot eyes.

Similar packaging was provided to the El Dorado Sheriff's Office by a 15-year-old from El Dorado Hills. The 15-yearold did not pick Yusuf out of a photo lineup for the person who sold him the drugs, but he did list him as one of two possibilities. Keane has had a little problem positively identifying Yusuf as well. Keane had stated that he specifically remembers an arm tattoo on the forearm. Yusuf does not have one,

but does have one on his upper arm.

Keane also said in court that he recognized Yusuf as "Mosley" when they were in the courtroom, but could not pick him out of a photo lineup prior to the pre-trial, even though "Mosley" was sitting nearby. Ironically, Yusuf shared a personal experience with Police while on the way to El Dorado County Jail, that in the past someone had slipped him fentanyl and he almost died.

Yusuf is being charged with second-degree murder and selling marijuana to a minor. His trial is estimated to last 9 days and is set to begin October 17th at 8:30 am, in Department 1 of the El Dorado Superior Court. Yolo County, to date, has not brought anyone to trial for murder due to fentanyl poisoning.



- Sacramento Regional Fire Museum held a dedication for its newest exhibit, a vintage 1857 hand pumper, on loan from the Suisun Fire Department. The dedication was held at the museum, located at 3650 Industrial Blvd. West Sacramento. The dedication ceremony consisted of a traditional push-in where firefighters and Museum members pushed the pumper into its new home.

The vintage 1857 Hunneman Hand Pumper has a very rich history. It was originally built in Boston and is one of a few remaining hand pumpers in the country that is still in operating condition. Initially built in 1857 for the Boston Fire Department, it was then purchased by the San Francisco Fire Department' Howard Engine Company and served as Engine 14.

The pumper was eventually sold to Suisun City's Union Engine Company in 1861 after it was deemed too heavy to be pulled by hand through the streets of San Francisco. It had ran away with its crew on one of the steep hills, ultimately crushing two

of the firefighters against a wall.

Transported to Suisun City by steamer, the pumper served as the city's primary firefighting vehicle until the 1880's. The name Hunneman comes from the name of the builder who was also believed to have been an apprentice to Paul Revere. Suisun named the pumper the S. R. Spinney after the crew's first Foreman.

The addition of this rare pumper rounds out the museum's collection of vintage fire apparatus from both hand and horse drawn to early motorized vehicles.

# FBI Announces Results of Local Operation Tied to Nationwide Sex Trafficking

SACRAMENTO, CA (MPG) - The Federal Bureau of Investigation (FBI) Sacramento Field Office, working with its state and local partners, identified, and located two victims of sex trafficking during a nationwide enforcement campaign, called "Operation Cross Country." The FBI-led nationwide initiative, in partnership with the National Center for Missing and Exploited Children (NCMEC), focused on identifying and locating victims of sex trafficking and investigating and arresting individuals and criminal enterprises involved in both child sex and human trafficking. Law enforcement agencies conducted targeted operations to identify and apprehend offenders, dismantling criminal networks and preventing further harm to victims. Those suspects identified will be subject to additional investigation for potential charges.

In the greater Sacramento area, FBI agents worked collaboratively with law enforcement partners from Sacramento Police Department, Sacramento County Sheriff's Office, California Department of Justice, Sacramento County District Attorney's Office, Yolo County District Attorney's Office during the two-week

operation. Two adolescent victims and more than a dozen adults who are possible victims of human trafficking were identified during the operation were provided access to services coordinated by operational partner Community Against Sexual Harm (CASH). Five individuals were also arrested for charges related to commercial sexual exploitation.

"The FBI's primary focus is ensuring every possible victim of commercial sexual exploitation has the opportunity to connect with service providers and move beyond the cycle of exploitation and violence," said Special Agent in Charge Sean Ragan of the FBI Sacramento Field Office. "We are grateful for the support of our law enforcement partners to provide the victims of human trafficking with the dignity they deserve and ensure their exploiters face justice.

The FBI remains steadfast in its commitment to combatting child exploitation and human trafficking. Operation Cross Country is just one facet of the Bureau's ongoing efforts to protect the most vulnerable members of society and hold offenders accountable. The FBI encourages continued vigilance, cooperation, and reporting from the public to help identify and recover victims and bring perpetrators to justice.

## Albertsons Ordered by Judge to Stop Offering Expired Products for Sale

WOODLAND, CA (MPG) - On August 3, 2023, the Yolo County District Attorney's Office, working closely with the San Joaquin and San Bernardino District Attorney's Offices, settled a civil law enforcement action against Albertsons and their affiliated California stores. Albertsons operates two Safeway stores in Davis in Yolo County.

Yolo County.

Albertsons owns and operates almost 600 retail stores in California which sell general merchandise, including over-the-counter drugs such as pain relievers, sunscreens, cough/cold/allergy medications, medicated shampoos, and skin treatments. Retailers in California are prohibited from selling any over-the-counter drug

past its expiration date. The civil complaint, filed in San Joaquin County Superior Court, alleged that Albertsons offered for sale and expired over-the-counter drug products over the past four years.

Once potified of the vio-

Once notified of the violations found during the investigation, Albertsons was cooperative and conducted internal checks for expired over-thecounter drugs at all their California retail locations. Albertsons further invested time and resources to prioritize the verification of expiration dates and re-train store personnel. There was no evidence discovered during the investigation that the sale of any expired over-the-counter drug products resulted in harm to consumers.

"California's District Attorney's Offices Consumer Protection Divisions are dedicated to protecting all Californians. Today is another example of those prosecutors working together to make real change. The public should be able to trust that what they buy at any California store will not be expired before they bring it home," said District Attorney Jeff W. Reisig.

Without admitting or denying liability, Albertsons agreed to be bound by a court order which prohibits any additional violations of California law related to selling or offering to sell expired over-thecounter drugs. As part of the judgment, Albertsons was ordered to pay \$3,300,000.00 in civil penalties and investigative costs as well as an additional \$200,000.00 in restitution.

You Need a Better Plan Dear Dave,

My husband recently opened his own commercial painting company. We know he will have three months or so every year when he's making very little, if any, income. We also started following your plan recently, too, and have \$1,000 set aside for our starter emergency fund. We were ready to begin paying off all our debt except our home in Baby Step 2, but now he wants to skip that, and move to Baby Step 3 to build a fully funded emergency fund of three to six months of expenses. I think I know why he feels this way, but would you give me your thoughts?

Dear Crystal,

Your husband's excited about the new business.

### **Dave Ramsey Says**

I get that. And in his own way, it sounds like he's trying to make sure there's extra money on hand for the down months he may experience as a commercial painter. But I wouldn't advise this approach, not for his business, and not for your family's finances.

Baby Step 3 is an emergency fund of three to six months of expenses. The scenario he wants to plan for, however, isn't an emergency. He knows it's coming. It's the same with things like Christmas, birthdays and stuff like that. You know they're coming, and you even know which months and days. Things like that aren't emergencies, and they don't catch anyone by surprise. They're things you plan for-and budget for—ahead of time.

But the first thing your husband needs to do is re-work his business model. He needs something to do during the down months, so that his income doesn't dry up completely. Setting money aside in a business for an expected down time is smart, but it's not a Baby Step 3 issue. It would

be a line in the budget where you set money aside because you know something's coming.

Again, if it's something predictable, something that happens at the same time every year, it is not an emergency. If you want to budget some household money for the down time, that's fine. But do you know what would be even smarter? Figuring out a plan for this time, based on his skill set, which will allow him to keep earning money!





## While Us Economic Outlook Improves, **California's Remains Muddy And Mediocre**

Late last month, the Federal Reserve announced the latest incremental raise in its key interest rate, pushing it to the highest level in 22 years, as it continues to battle what it calls persistent inflation.

The increase, a quarter of 1%, renewed the debate among economists and politicians over whether the Federal Reserve's anti-inflation actions will slow the economy into what's termed a "soft landing," or ignite a recession.

The recession that many economists thought would have happened by now hasn't raised its ugly head, leading to I-Told-You-So's from the ones who hadn't seen a downturn on the horizon.

"Much to the chagrin of those who have been predicting otherwise, the U.S. economy has stubbornly continued to grow and 2023 is shaping up to be a better year than 2022," one of the optimists, California economist Christopher Thornberg wrote recently.

"This isn't to say that we don't recognize signs of stress in the economy driven by higher interest rates and the recent bout of inflation," Thornberg continued. "Rather, we've never viewed these issues as rising to the level of



## **Social Security Matters**

## I'm a Veteran. How Do I Get My Extra Social Security?

Dear Rusty: As a military veteran, I was told that the final amount of my Social Security should be a little higher as a reward for military service. If so, I have two questions: 1. How much is the boost? 2. How can I know that amount has been applied? Signed: Unsure

Dear Unsure: We receive questions about this fairly often from our military veterans. I want to first thank you for your service to our country and then assure you that, as a military veteran myself, I have thoroughly investigated this subject - the so-called "Special Extra Credit for Military Service," which is widely misunderstood. Although someone suggested that your Social Security benefit "is supposed to be a little higher" because you are a military veteran, allow me to share how this somewhat

obscure rule actually works. Any extra money for military veterans does not come in the form of a special "boost" to their Social Security benefit because of their military service; instead, certain older veterans receive extra credit to their earnings for the years they served. Those extra earnings are applied only to those who served in specific years, as additional dollars added to their actual earnings record for their service-years. The amount added to the veteran's true service-year earnings varies a bit depending on

which years you served. For example, if you served between 1957 - 1977, your actual earnings for each service-year would be increased by \$300 for each full quarter you had active duty pay to a maximum of \$1200 additional earnings per service-year. The credit is computed a bit differently for those who served between 1978 - 2001, but the maximum annual earnings credit for those service years is the same - \$1,200. And, for clarity, those who served before 1957 get extra earnings credit under an entirely different formula, and those who served after 2001 receive no extra credits for their military service years.

So how might this affect your Social Security benefit? Well, when your benefit is claimed, Social Security reviews your lifetime earnings record, inflates each actual annual amount to equal today's dollar equivalent, and selects the highest earning 35 years from your lifetime record to calculate your "Primary Insurance Amount" or "PIA" (your PIA is the amount you are entitled to at full retirement age). If your military service-years are among the 35 years used to compute your PIA when you claim, then the "Special Extra Credit for Military Service" will result in a somewhat higher PIA (a slightly higher monthly SS benefit). If the highest earning 35 years in your lifetime record do not include your military-service-years, then those extra credits added to your earnings for your military-service-years will have no effect on your Social Security benefit (because using those service-years would result in a lower benefit). How Social Security applies those special extra credits to your service-year earnings also varies depending on when you served. Those who served

before 1968 needed to show their DD-214 to get the extra credits, but those who served in between 1968 – 2001 were automatically given the extra credits based on their military service records.

So, if your military service was between 1968 and 2001, your earnings during the years you served were automatically increased by SS to reflect your "special extra" earnings and - if those years are among the highest of the 35 years used to compute your SS benefit - you are now receiving the extra benefit amount you're entitled to from those credits. If you have at least 35 years over your lifetime where you earned more than your pay while serving in the military, your current benefit is more than it would be if your military service years were included. If you have questions about your earnings during your military service years, you may wish to obtain a copy of your lifetime earnings history from Social Security to review those amounts (easiest way to get your lifetime earnings history is via your personal "my Social Security" account at www.ssa.gov/myaccount.

#### Dairies Struggle As Milk Prices Plummet And Production Costs Surge

After earning record-high milk prices in 2022, dairy farmers have seen their earnings plummet in recent months, with more operations struggling to stay in business and some closing their doors for good. Their plight has prompted comparisons to the 2009 economic crisis that forced droves of dairies into bankruptcy. Some say it may be worse this time around due to additional inflationary pressures and higher interest rates that make it more costly for businesses to borrow money. Dairy farmers' costs for feed, labor, fuel and fertilizer have all skyrocketed.

#### Weather Pushes Melon Crop Past July 4 But Growers Happy With Quality

California farmers say this season's melon crop was delayed by about two weeks due to cool temperatures and wet fields affecting early harvest of watermelons, cantaloupes and honeydews. That slowed melon deliveries to supermarkets. "We missed the big marketing window for Fourth of July," noted Fresno County farmer Joe Del Bosque. But Del Bosque said the quality of melons this year is good, and that demand remains steady. He said he just hopes there is not "a bunching up" of melons hitting the market at once.

#### Cotton Acreage Drops To Historic Low In State Due To Weather, Prices

For the first time in a century, California cotton acreage will likely drop to fewer than 100,000 acres due in part to soggy ground at planting and better prices for competing crops. Aaron Barcellos, a partner in the family-owned A-Bar Ag Enterprises in Fresno County, said cold, wet weather along with low prices prompted them to reduce Pima plantings this year. Without those factors, he said they probably would have had double the acreage they planted. In the late 1970s and early 1980s, cotton was king in the San Joaquin Valley, maxing out at about 1.6 million planted acres.

#### Congress Takes Up Farm Labor Bills Stalled Amid Immigration Stalemate

A nationwide farm labor shortage is contributing to a flurry of legislative action in Washington this year. The House Committee on Agriculture has formed a bipartisan Agricultural Labor Working Group to study and propose changes to the H-2A temporary work visa program, which farmers have increasingly called upon in the absence of adequate domestic labor. Last year, Congress failed to pass the Farm Workforce Modernization Act, including immigration law reforms intended to boost agricultural employment. The Act was reintroduced this year. \*

West Nile Virus is in West Sacramento

Remember that West Nile Virus is in West Sacramento. Please dispose of any standing water and take proper precautions to avoid mosquito bites. This includes your children and pets as well. Yolo County is aware and treating the known areas, but please be diligent in prevention.

According to the Center for Disease Control No symptoms in most people. Most people (8 out of 10) infected with West Nile virus do not develop any symptoms.

Febrile illness (fever) in some people. About 1 in 5 people who are infected develop a fever with other symptoms such as headache, body aches, joint pains, vomiting, diarrhea, or rash. Most people with febrile illness due to West Nile virus recover completely, but fatigue and weakness can last for weeks or months.

Serious symptoms in a few people. About 1 in 150 people who are infected develop a severe illness affecting the central nervous system such as encephalitis (inflammation of the brain) or meningitis (inflammation of the membranes that surround the brain and spinal cord).

**Invasive Hammerhead Worm found** in Sacramento

You will know when you see one, they have a flat hammer-shaped head that's round on the front side. Here's what you should know 1. They come out after rain or sprinklers soaking the ground. That's when to look for them. 2. Do not touch it without gloves. Their mucus is a skin irritant to humans and can be toxic to pets and other small animals. # Senate Democrats Take One More Step Toward Socialized Medicine

It's been less than a year since Democrats enacted the Inflation Reduction Act, which gives Medicare the power to set the prices of contain medicines.

certain medicines.

Those price controls have yet to go into effect. But Democrats already want more. They've introduced new legislation in both chambers of Congress that would amp up those price controls, and even permit the government to refuse to cover drugs in order to drive a harder bargain with pharmaceutical companies. They say their bills would "build on" the IRA.

That law, which President Biden signed last August, subjects 10 medicines to price controls under Medicare in January 2026. The government will set the prices for 15 more in 2027, another 15 in 2028, and 20 more per year in 2029 and beyond.

The SMART Prices Act would take things even

further. It would empower Medicare to set prices for 20 drugs in 2026, instead of the current ten under the IRA. In 2027 and every year after, that number would jump to 40, many more than the IRA stipulated. The House bill is even more radical, extending Medicare's price controls to the private

insurance market.

The SMART Prices Act would also subject medicines to price controls five years after approval by the Food and Drug Administration. That's up to eight years quicker than under the IRA and significantly sooner than when generic or biosimilar competitors can enter the market.

This provision would gut the generics industry. Generic firms face substantial upfront costs.

They recapture those investments by underpricing their wares relative to branded drugs and capturing a small margin on each sale. Patients, of course, benefit from those lower prices.

But if Washington sets a rock-bottom price on a brand-name drug, there will be no incentive for a generics manufacturer to enter the market.

That's problematic for several reasons. For starters, the government's mandated price may not be as low as a competitive market could


generate. So, patients may end up paying more than they should.

Further, a market without competing drug makers is less resilient. If price controls result in a branded company being the only producer of a drug, then a production issue could render a drug that patients need inaccessible.

The IRA's price controls have already led a number of pharmaceutical companies to curtail research into new drugs. In May, the CEO of Novartis announced that the company would drop a few cancer drugs from its development pipeline. Alnylam cited the IRA when it put development of a rare eye disease drug on hiatus last fall.

How can Democrats look at this decline in drug research, and decide that more price controls are an appropriate response? Patients will pay the price for this misguided approach.



**BLM News Release** 

SACRAMENTO, CA (MPG) - The Bureau of Land Management is taking an ambitious and coordinated approach to accelerate fuels reduction projects on public lands with high wildfire risk throughout California and northwest Nevada. The signing on August 8, 2023, of the Statewide Wildland-Urban Interface Fuels Treatment Programmatic Environmental Assessment will streamline plans to protect communities, reduce wildfire risk and improve forest health.

"This plan helps reduce the intensity, severity and spread of wildfire near communities that border public lands managed by the BLM," said BLM California State Director Karen E. Mouritsen. "Through partnerships with local and state agencies we will prioritize and coordinate fuels treatments to protect people, property and vital infrastructure."

Under this plan, fuels treatment projects will be coordinated across land ownerships to provide the best results for communities, creating a landscape-level network of strategic fuels treatments and breaks within the wildland-urban interface.

The Statewide Wildland-Urban

Interface Fuels Treatment Programmatic Environmental Assessment conducted a broad analysis across 930,000 acres of public lands. As local communities and the BLM identify wildfire concerns, the new streamlined fuels treatment plans will permit on-the-ground work to begin in a matter of months. This will allow us to treat an anticipated additional 20,000 acres of public lands each year.

The plan covers 44 counties in California: Amador, Butte, Calaveras, Colusa, El Dorado, Fresno, Glenn, Humboldt, Imperial, Inyo, Kern, Lake, Lassen, Los Angeles, Madera, Mariposa, Mendocino, Modoc, Mono, Monterey, Napa, Nevada, Placer, Plumas, Riverside, Sacramento, San Benito, San Bernardino, San Diego, San Joaquin, Santa Clara, Santa Cruz, Shasta, Sierra, Siskiyou, Solano, Sonoma, Stanislaus, Tehama, Trinity, Tulare, Tuolumne, Yolo, and Yuba; and two counties in northwest Nevada: Douglas and Washoe. Projects under this program can begin as soon as this fall.

## The Real Fix for State Pension Woes: **Ditch Defined Benefit Pensions**

Last week, this column addressed the dilemma facing the California Public Employees' Retirement System (CalPERS) and the California State Teachers Retirement System (CalSTRS), California's biggest public pension retirement funds, involving "Environmental, Social, and Governance" principles.

Depending on how it is interpreted, "ESG investing" can simply mean evaluating investments in a broad manner "to assess potential risks."

Where ESG principles get problematic is when they are used to push a progressive political agenda at the expense of maximizing returns. This occurs when activists seek prohibitions against investing in fossil fuels, firearms, or in companies located in nations that have met with their disfavor for political or policy reasons, irrespective of the positive performance of the companies.

For current retirees and employees, there is little opportunity to influence the investment decisions of CalPERS and STRS. Some of the board members are elected by participants in the system but most are subject to the political pressures of the day.

What politicians in California and elsewhere ignore is a simple way

to avoid the entire ESG quagmire as well as many other problems inherent in California's "defined benefit" retirement plans. That is to begin shifting to "defined contribution" plans that reduce the risks to the state and taxpayers and which frequently produce better returns for the employees. In defined contribution plans, the employee's benefit is equal to his or her own contributions, plus those of the employer, plus whatever earnings the investments

accrue. Defined contribution plans come in many flavors, but they have one common element important to taxpayers. That is, the financial obligation of the employer (paid for with taxpayer dollars) is complete at the end of each pay

Another big advantage to defined contribution plans is their portability, especially in a changing workforce where employees change jobs frequently.

In a comprehensive policy paper published in 2020 by the Reason Foundation, "Defined Contribution Plans: Best Practices in Design and Utilization," the authors contend that, "When structured properly, [defined contribution] retirement plans—plans with individually controlled investment accounts with contributions made by both employers and employees—can offer

governments an approach to retirement plan design that garners retirement security for employees while actively working. Defined contribution plans accomplish this by modernizing the retirement option set and managing employers' financial risks that are inherent in traditional pension plans."

In California, the political power of public-sector labor renders the full adoption of defined contribution plans to replace CalPERS and CalSTERs extremely unlikely. In 2005, progressive outrage at then-Gov. Arnold Schwarzenegger forced him to drop his proposal before it even got started. But now, with economic realities setting in, it might stand a better chance, especially if offered only to new hires or as part of a "hybrid" system of combined defined benefit and defined contribution elements.

Defined contribution plans are becoming increasingly popular in other jurisdictions. Both Michigan and Alaska offer state employees defined contribution plans only. For the sake of the state's financial health, and to limit the risks to taxpayers, the shift to a defined contribution plan should be the cornerstone of California's public employee retirement systems. It's time to take the off-ramp from defined benefit pension plans.
