Board of Supervisors Approves Cesar Chavez Day and Juneteenth as **County Holidays**

YOLO COUNTY, CA (MPG) - On July 25, 2023, the Yolo County Board of Supervisors took a momentous step toward embracing diversity, fostering inclusivity, and honoring the significance and symbolism of two holidays within our community. By unanimously approving the official designation of both Cesar Chavez Day (March 31st) and Juneteenth (June 19th) as county holidays, Yolo County has reaffirmed its commitment to inclusivity, appreciation of its workforce, and acknowledges the invaluable contributions of diverse communities to the cultural fabric of American society.

Cesar Chavez Day, celebrated in California since 1995, serves as a tribute to the remarkable accomplishments of Cesario Estrada Chavez, a Mexican American labor leader and civil rights activist. By formally designating Cesar Chavez Day, Yolo County acknowledges Chavez's tireless efforts in improving the lives and working conditions of Latino farm workers across Yolo County and the nation. Juneteenth, a commemoration that has been observed by Black Americans since 1865, gained federal recognition as a holiday in 2021. By formally designating Juneteenth, Yolo County leads the nationwide recognition of this celebration of freedom, symbolizing the liberation of enslaved African Americans and honoring their enduring struggle for equality and justice. "Today's formal designation of Cesar Chavez Day and Juneteenth as county holidays serves as a catalyst for cultural understanding, reflection, and education. This milestone reflects our deep respect for the contributions made by individuals who fought for social justice and equality." Said Chair of the Yolo County Board of Supervisors Oscar Villegas. "By acknowledging these holidays, we foster unity and inclusivity within our community,

SACRAMENTO REGION, CA (MPG) - The newest members of the California Highway Patrol (CHP) were sworn in today during a graduation ceremony at the CHP Academy in West Sacramento. The 101 officers are part of the CHP's multiyear recruiting campaign to fill 1,000 vacant officer positions by hiring qualified individuals from California's diverse communities.

"I want to commend these men and women, not just for the hard work they put in the past several months while training at the Academy, but for their willingness to serve the public," said CHP Commissioner Sean Duryee. "These new officers are valued members of the CHP who are committed to improving safety in California for many years to come."

CHP Cadet Training

Class I-23 is one of six cadet classes scheduled to attend the Academy in 2023. After completing 26 weeks of instruction at the CHP's live-in training facility, the newly sworn officers will report to various CHP offices throughout the state.

At the CHP Academy, cadet training starts with nobility in policing, leadership, professionalism and ethics, and cultural diversity. Additionally, cadets receive instruction on mental illness response and crisis intervention techniques. Training also covers vehicle patrol, crash investigation, first aid, and the apprehension of suspected violators,

including those who drive under the influence. Cadets also receive training in traffic control, report writing, recovery of stolen vehicles, assisting the motoring public, issuing citations, emergency scene management, and various codes, including the California Vehicle *Continued on page 4*

Via – Questions Abound

WEST SACRAMENTO (MPG) - Back in 2018, West Sacramento City Officials thought that it would be helpful to the community if there were an inexpensive transportation system for when someone needed a ride to get groceries or a ride to work. Via was the company selected.

Via provides a convenient travel package that for \$3.50 (\$1.75 for seniors and disabled) a West Sacramento resident can get a ride from anywhere in West Sacramento to anywhere else in West Sacramento. Rather than scheduling your day's activities around the bus schedule, trying to bring groceries on the bus, and then walk all the way home with them, you could get a ride with Via. Or perhaps you need a ride to work and the bus schedule either gets you there late or far too early, Via sounds perfect. For the price, the convenience factor seems well worth it. In addition, if you are traveling outside of the city limits Via will provide a free transfer to YoloBus.

Via's hours of operation are Monday – Friday 6:00am – 11:00pm, Saturday 9:00am – 11:00pm and Sunday 8:00am – 8:00pm. You can order a ride from Via either by downloading the Via Rideshare App or by calling (916) 318-5101, press 1 when asked if you are a Via rider, and 1 again when it asks if you are an account holder that needs a ride. If you book a ride, you need to be sure to have your locator turned on your phone.

It all sounds great, right? Well, from this point Via is being accused of not being transparent in their practices. For this article, News Ledger staff interviewed 15-20 unrelated people who are customers, former employees, and current employees. About a quarter of those people have used Via and had no complaints. They were very happy with Via and used them often. Most of the riders thought that Via is owned, contracted, or in some way employees of the City of West Sacramento. That is not the case.

On the cityofwestsacramento. org website, it says "Via is not a taxi; it's not paratransit; it's not a bus; it's Via." The way it works is that the rider puts in a request for a ride and if one of the drivers is going to be near your location and wants to pick you up, they will give you a location of where to meet them (example; Northeast corner of Todhunter and Anna St.) They give you an estimated time that they will be there. According to the customers that were interviewed, the rider's wait time could be from 20 minutes to 2 hours. In addition, if the rider is not where instructed (the Northeast corner), Via will not stop, and the rider will still be charged for that ride.

According to one employee (who asked not to be named for fear of retaliation), "the rider can be at the intersection, but on the wrong corner and the company will tell us not to stop and not to pull over to a different corner." This driver said that she had to wait for an elderly woman, with a cane, to cross Jefferson Blvd. because she was not allowed to pull around to her. In addition, Via does not supply any child car seats, but will allow you to provide your own. However, it is also standard practice for parents to be allowed to ride with their child on their lap. This practice was described by five separate riders and two drivers. Most of the vans have a small storage space where you can put your groceries but remember, they will be dropping you off at a corner somewhere in the vicinity of your destination. You never know how close to your

destination that will be.

According to both the riders and the employees that were interviewed, if the person ordering the ride cancels, they still get charged. However, it is very important to keep a close eye on the app once you've ordered a ride because the driver can cancel your ride at any time. This practice was described in nearly all of the interviews, as it happens regularly.

We looked a little deeper into the Via company. Via is not actually the company. Nomad Transportation is the company that is contracted for the work. Employee Sandra Hazelwood explained that drivers get hired over an app and if the driver needs anything, they must call Customer Care, like everyone else. There is no training and no instructions on how to work the vans (even the vans with the wheelchair lifts.) No training on how to deal with people. There is no driving test, and they are not required to have a passenger driver's license (Class B) to drive for Via.

The Via employees explained that Via advertises that they pay \$27 per hour. But the reality is Nomad Transportation hires the drivers as independent contractors, not employees, and then rents those vans to the driver, by the hour. The van rental price is usually about \$12 - \$15 per hour. "The rental rate always changes, and we never know what the rate will be or who the new company is," said the employee. "The bad thing is, if we have to stop to use the restroom, we have to clock out, and if we take too long, they call and tell us to get back to our van," she said.

Employees said that it is policy that when the driver's shift ends, they are to clock out and then go fill the gas tank so that it's ready for the next shift. You are not allowed to do this while you are on shift. One employee explained that they got into an accident during that period of getting gas. The company would not cover the driver "because the employee was clocked out" and the driver was charged by Nomad, for four hours of rental fees. The time that it took to handle the accident (Police reports, etc.)

"There is no kind of regulations and no safety equipment, such as cameras, to keep us safe," said Sandra. "And the company doesn't watch out for us," she said. One employee explained that a man got kicked off her van for being sexually inappropriate with himself. "The company told me that he was not allowed to use Via anymore, but then I found out that he was still being allowed to ride Via. When I asked Customer Care about it, they said he just couldn't ride on my van anymore, but he can still use the service. People send their kids to school on here. That's not okay!" she said.

Passenger driving is an occupation where the workers often rely on their tips as part of their pay. However, perhaps because the ride is so inexpensive, Via drivers for some reason are not being tipped. Tipping is of course, optional. Nobody is required to tip their driver.

According to both drivers and passengers, if the passenger needs a van with a wheelchair lift, the wait is usually quite a bit longer. "They are scheduling us from another country (the Philippines), and they give us the same amount of time that they give the other drivers, so we are always running behind," said Sandra.

According to the City of West Sacramento June 7, 2023 City Council meeting agenda packet, the Via Rideshare Program is funded by funding that the city receives from the Transportation Development Act (TDA) and by Caltrans. Because of this, an audit must be done to check the efficiency of the program. There is a checklist with 11 categories that need to be checked off. West Sacramento is exempt from four of those items. Through the audit, our program was not in compliance with two of the remaining items and the program is being reviewed.

Community member Guy Stevenson asked the City Council at the July 19, 2023 meeting, why they just agreed to pay the rideshare program \$3.3 million dollars when there are items of importance (as those listed above) that need to be addressed. Via is a form of revenue for the City of West Sacramento, both in fare fees as well as governmental funding. If the amount collected should exceed the amount projected, that money is reinvested in the program. The Via program has grown from a twelve-month period in 2022-23 of 46,800 hours, to the 2023-24 twelvemonth period projected to be 57.200 hours.

The additional million dollars that the City Council approved this year will cover the increase. However, that money is not all coming from the City's account. Remember, two sources of funding come to us, in addition to the revenue from fares, meaning the city only put out \$560,118 as compared to the projected budget of \$2,464,205.

The environmental considerations are so great, that this program is likely to continue growing. By drivers and riders speaking up, changes may be possible. But it can only happen if it is reported to the city. If you have any comments, concerns, complaints or compliments please report to Cityofwestsacramento.org ★

YOLO COUNTY, CA (MPG) - The Yolo County Elections Office transitioned to election administration under the California Voter's Choice Act (VCA) in 2022. The Elections Office has developed a renewal draft Election Administration Plan (EAP) that is available on our website: https://www.yoloelections. org/voters-choice-act/2024-eaprenewal-draft. A public hearing

renewal-draft. A public hearing to take comments and update the renewal draft EAP will be held on Thursday, August 10, 2023, at 6:00 p.m. (https://yolocounty.zoom. us/j/82057931426: Meeting ID: 820 5793 1426.)

In accordance with the Voter's Choice Act, initial Public Consultation Meetings were held on Friday, May 5, 2023. Following the initial Public Consultation Meetings, the Elections Office incorporated community input and released the draft renewal EAP on our website on July 12, 2023. The EAP provides information to the voters of Yolo County about the VCA model. It describes the vote-by-mail (VBM) process, Vote Centers and Ballot Drop Box locations and the technology that will be utilized.

Public comment on the draft EAP was available over a 14-day public comment period (from July 12, 2023, through July 26, 2023). During this time, the Elections Office held Language Accessibility Advisory and Voters Accessibility Advisory Committee meetings and the public was able to provide public comments through email, online or by mail. The Elections Office will host a public hearing on Thursday, August 10, 2023, at 6:00 p.m. (https://yolo-county.zoom.us/j/82057931426: Meeting ID: 820 5793 1426.) Following the public hearing, the amended draft EAP will be published on Monday, August 21, 2023. There will be a 14-day public comment period that will end on Monday, September 4, 2023, when the final EAP will be submitted to

the Secretary of State. Report from U.S. Courts.com

Personal and business bankruptcy filings rose 10 percent in the twelvemonth period ending June 30, 2023, compared with the previous year.

According to statistics released by the Administrative Office of the U.S. Courts, annual bankruptcy filings totaled 418,724 in the year ending June 2023, compared with 380,634 cases in the previous year.

Business filings rose 23.3 percent, from 12,748 to 15,724 in the year ending June 30, 2023. Non-business bankruptcy filings rose 9.5 percent to 403,000, compared with 367,886 in the previous year.

Bankruptcy totals for the previous 12 months are reported four times annually. Filings over any 12-month period have increased only rarely since filings peaked in 2010. Bankruptcies fell sharply after the pandemic began in early 2020, despite some early COVIDrelated disruptions to the economy.

Road Maintenance Activities on County Road 31 and Russell Boulevard

WINTERS, CA (MPG) - The County of Yolo Community Services Department's Public Works Division will be repairing sections of County Road (CR) 31 and Russell Boulevard from August 7 through September 29. This maintenance is scheduled to occur between 7 a.m. to 4 p.m., Monday through Friday. Be prepared for intermittent lane closures during this time on CR 31 from CR 93A to CR 98, and Russell Boulevard from Interstate 505 to CR 93A.

Travelers should expect delays and are encouraged to use alternate routes. Detours will be set up to direct motorists around full road closures. Local access to properties and businesses along these road sections will be provided during construction.

The scheduled road repairs on CR 31 and Russell Boulevard are part of the County's ongoing efforts to ensure the safety and functionality of these roads for the community. This maintenance comes in anticipation of upcoming improvements to County Road 31, which will include the addition of bike lanes once funding is secured. This process can take time and involves collaborating with various stakeholders.

"The need to improve this major transportation corridor in District 2 is one of the top concerns consistently shared with me by residents in both Winters and in Davis. Beginning work on this stretch of CR 31 is long overdue, and I am grateful to the Yolo County Public Works team for taking this next step to address the conditions of this important roadway," said Supervisor Lucas Frerichs. "Improving the conditions of this corridor will continue to be one of my top priorities."



Legislation Introduced to Protect American Farmland and National Security Sites from Foreign Adversaries



WASHINGTON, DC (MPG) - On July 12, 2023, Rep. Mike Thompson (CA-04) and Select Committee on Strategic Competition between the United States and the Chinese Communist Party Chairman Mike Gallagher (WI-08) introduced bipartisan legislation to strengthen and expand protections around national security sites, critical infrastructure, and farmland.

"Protecting national security and food security go hand in hand in our region - which is why it is vital to know who owns land around national security sites," said Rep. Thompson. "The bipartisan legislation I am introducing with Chairman Gallagher will help identify foreign actors who are seeking to purchase land near military installations while maintaining food security throughout our country."

"The United States cannot allow foreign adversaries like the Chinese Communist Party and its proxies to acquire real estate near sensitive sites like military bases or telecom infrastructure, potentially exploiting our critical technology and endangering our servicemembers. This bill gives CFIUS jurisdiction over foreign adversary real estate transactions to guard against the threat of the CCP and other adversaries purchasing land for malign purposes, and it also encourages CFIUS to consider food security issues as it evaluates the national security risk of a given transaction," said Rep. Gallagher.

"Safeguarding our food supply chains and national security from foreign adversaries like the

most strategically valuable installations within the U.S. military. We must do everything in our capacity to ensure Travis is fully protected and supported," said Rep. Garamendi. "Though Flannery Associates claims that it is not controlled by foreign entities, they have shockingly failed to provide any proof to local and federal officials. This issue raises serious security concerns for our community and the critical military operations at Travis. That's why I greatly appreciate this important bipartisan legislation and look forward to continuing to work with my colleagues to protect our communities and defend our national security."

"Food security is national security, and I've been fighting to get the Secretary of Agriculture a seat at the purchases and their use of agricultural land, especially near our military bases and training sites. This will help ensure that the Committee on Foreign Investment in the United States can fully assess investments that can compromise our security and intelligence sites."

"Food security is national security. Communist China buying up U.S. agricultural land is just one of the CCP's many attempts to subvert our sovereignty and threaten our national security. I will continue to fight to protect our agricultural land and to ensure that our country's food security and national security are prioritized. I am proud to support this legislation that will mandate heightened scrutiny over adversarial land purchases near our military installa-

national security," said Rep. Lucas. "I'm pleased to be an original cosponsor and commend Congressman Gallagher for his work on this important legislation."

"Our geopolitical adversaries are exploiting loopholes in regulations to purchase farmland and other agricultural assets, threatening our national and food security," said Rep. Panetta. "I'm proud to join this bipartisan effort to ensure CFIUS has the jurisdiction and mandate needed to properly vet these foreign purchases as in the best interest of the United States. This is a necessary step to counter any malign efforts to weaken U.S. agricultural independence and security."

"The scope and scale of the Chinese Communist Party's activities in the United States is deeply alarming," said Rep. Wittman. "Entities with clear ties to foreign adversaries should not be permitted to purchase land near U.S. military bases, intelligence facilities, or national laboratories. I'm proud to join this effort to equip the Committee on Foreign Investment in the United States with the tools it needs to protect our national interests." American farmland belongs to American farmers — period. For the sake of our national, energy, and food security, we cannot let China, or any other foreign adversary, buy our fertile farmland, prevent our young producers from planting their roots, or jeopardize our agricultural supply chains,"

said Rep. Feenstra. "I am proud to work with my colleagues to introduce legislation to protect American farmland from foreign acquisition, particularly the Chinese Communist Party, and keep American farmland where it rightfully belongs — in the hands of American farmers."

An entity called Flannery Associates has spent nearly \$1 billion over the last five years to become the largest landowner in Solano County. The land purchases go up to the fence of Travis Air Force Base, the home of the largest wing of the Air Force's Air Mobility Command.

The United States Department of the Treasury Committee on Foreign Investment in the United States (CFIUS) is an interagency committee authorized to review certain transactions involving foreign investment in the United States and certain real estate transactions by foreign persons, in order to determine the effect of such transactions on the national security of the United States. However, there are significant gaps in the current process. The Protecting U.S. Farmland and Sensitive Sites From Foreign Adversaries Act would: Give CFIUS jurisdiction over all land purchases (with exceptions for real estate in urban areas and single housing units) by foreign adversary entities; This would avoid a repeat of the "FuFeng incident" where, despite a clear national

security concern to a military installation in North Dakota, CFIUS claimed it was unable to even review (let alone block) the transaction because the land was outside the scope of CFIUS jurisdiction;

Authorize CFIUS to consider U.S. food security, including via biotechnology acquisition, as a factor in its national security reviews and require the Secretary of Agriculture have a vote in CFIUS reviews of transactions that involve farmland or agriculture technology;

Establish a "presumption of non-resolvability" by CFIUS that raises the approval threshold for CFIUS transactions by a foreign adversary entity purchasing near sensitive sites (e.g., major military sites, acknowledged intelligence facilities, etc.); CFIUS will be required to review these transactions with the presumption that the national security concerns cannot be resolved.

Mandatory CFIUS filing for foreign adversary entities making land purchases near sensitive sites. This will ensure CFIUS remains apprised of ongoing real estate purchases by foreign adversary entities;

Expand the list of sensitive national security sites designated for CFIUS jurisdiction; Require CFIUS to expand the list of sensitive national security sites to all military facilities, acknowledged intelligence sites, national laboratories, and defense-funded university-affiliated research centers, critical telecommunication nodes, and more. Current CFIUS regulations only cover a limited number of sensitive sites, and does not include all military facilities, national laboratories, and other sites. CFIUS is also limited to sensitive

Chinese Communist Party will always be a top priority of mine. We must ensure our government agencies have the necessary resources to stop bad actors from gaining a foothold in our homeland. Our bill provides CFIUS will the tools needed to keep America's enemies away from our most sensitive areas," said Rep. Johnson.

"The People's Republic of China has an alarming history of leveraging foreign investment to gain access to sensitive information," said Rep. Case. "This type of foreign espionage is a serious threat to national security. This bill will help close the gaps in our oversight of foreign tions," said Chair Stefanik.

"Food is a national security issue. Increasing foreign ownership of American farms and farmland is a threat to our food security," said Rep. Costa. "We need to prevent foreign adversaries like China from undermining the American agricultural industry. This bill will ensure American agriculture is operated by American businesses."

"A resilient food supply is essential to national security, which is why the rise of foreign investments in our nation's farmlands deserves increased scrutiny. I have long supported adding the Secretary of Agriculture on CFIUS, which will equip the Committee with the expertise needed to identify potential threats to our sites that are US government property.

The bill is led by Rep. Mike Thompson, Chairman Mike Gallagher, Reps. John Garamendi (CA-08), Dan Newhouse (WA-04), Ed Case (HI-01), Bill Johnson (OH-06), Jim Costa (CA-21), Elise Stefanik (NY-21), Jimmy Panetta (CA-19), Frank Lucas (OK-03), Jason Crow (CO-06), Rob Wittman (VA-01), Salud Carbajal (CA-24), Randy Feenstra (IA-04), and Mary Sattler Peltola (AK-AL).



Drought-Stricken Farmers to Participate in Rice Commission

From the Office of Assemblymember Aguiar-Curry

SACRAMENTO, CA (MPG -Assembly Bill (AB) 454 by Assemblymember Cecilia Aguiar-Curry (D-Winters), which provides greater flexibility to the California Rice Commission to maintain district representation of all rice farmers, has been signed into law by Governor Gavin Newsom.

California Rice The Commission, established in 1999, functions as a quasi-governmental entity within the Department of Food and Agriculture, providing for the orderly production, milling, and

and the associated environmental benefits. The Commission's board is made up of rice producers and handlers. Previously, each board member had to actively produce or handle rice to maintain board eligibility.

marketing of California rice

Extreme drought and water shortages have severely constrained rice production in the Sacramento Valley. As California farmers confronted a third year of catastrophic drought impacts in 2022, less than half the state's typical 500,000 acres of rice were planted. Due to the massive drop in rice production, many producers and handlers were no longer eligible to serve on the Rice Commission's board. Likewise, because of reduced acreage in production, the allocation of Commission board seats by district was poised to be dramatically impacted.

AB 454 allows the Rice Commission to annually review and evaluate state drought conditions and, if warranted, issue a drought declaration. Under a drought declaration, a Commission member who is a rice producer or handler would be allowed to continue serving on the Commission and vote to issue a declaration if they historically produced or handled rice or if they participated in the Prevented Planting Program at USDA.

"Year-after-year, our rural family farms, agricultural communities, and businesses face mounting pressure from unprecedented climate events," said Aguiar-Curry (D- Winters). "It's imperative that we not lose the input of our farmers and handlers because of catastrophic droughts that they can't control. I want to thank the Rice Commission for continuing to be a close partner on public policy that affects our agriculture and rice industry communities. Their leadership is incredibly valuable to our State Department of Food and Agriculture, and to me as I continue to serve my farming constituents. The Governor's support will help us maintain the

rural voices that are so important to instructing decisions made by our state government."

"We greatly appreciate Asm. Aguiar-Curry's support of the rice industry. We are still feeling the impacts of last year's drought and this bill will help us include growers on our board who were not able to plant last year due to the lack of water," said Tim Johnson, President and CEO of the CA Rice Commission.

YOLO COUNTY, CA (MPG) - The Yolo Youth Commission is inviting youth-serving organizations to apply for new

grants designed to make a positive impact in the community by addressing the ongoing needs of youth and teens in Yolo County.

Managed by the commission, the \$160,000 "Youth Empowered Through Action (YEA!)" grant program offers the opportunity for organizations to apply for four competitive grants in the amount of \$40,000 each.

The YEA! grants are available to nonprofit organizations and public agencies, including school districts and county agencies. The grant program is funded by county cannabis tax revenue.

Applications must be received by 5 p.m. on August 7. The commission will review all submitted applications and invite select applicants to advance to a second application round. The grant application and additional materials can be accessed on the Yolo Youth Commission website at www.ycoe.org/youthcommission.

In May, the commission developed the grant process with input from youth collected during public workshops conducted in Davis and Woodland. From the workshops, the commission identified three

priority areas for the grants, which include offering free recreational activities, providing additional after school programs with life skills for teens, and expanding civic engagement opportunities for younger youth.

The three priorities identified by the commission were also presented to the Yolo County Board of Supervisors on June 27.

The Yolo Youth Commission is a partnership between the Yolo County Office of Education (YCOE), Yolo County, and the Martin Luther King Jr. Freedom Center in Oakland.

In May 2022, the Board of Supervisors voted unanimously to establish the youth commission as a two-year pilot program and authorized YCOE to administer the program. In November 2022, 15 teenagers were selected to serve on the inaugural

YOLO COUNTY, CA (MPG) -Yolo County Agricultural Commissioner Humberto Izquierdo announced on August 1, 2023, that the nut buying period has begun and will run through April 1, 2024, in accordance with the county's nut theft ordinance.

On May 13, 2014, the Yolo County Board of Supervisors adopted a nut theft ordinance to assist with the issue of nuts being stolen from orchards and sold illegally. The declaration of the nut buying period, and related proof of ownership requirements, assists the Agriculture, Weights and Measures Department in enforcing the ordinance through compliance checks at places where nuts are sold.

During this period, persons in possession of unprocessed "nuts" (almond, walnut, or pistachio) shall be required to The variety and condition able online

Under probable cause, the agricultural commissioner or any peace officer may inspect the commodity and request that proof of ownership be provided. Proof

of ownership shall contain the following information:

1. Name, address, telephone number, and signature of the seller; 2. Name, address, telephone number, and signature of the buyer; 3. The vehicle license plate number of the seller; 4. The driver's license number of the seller; 5. The weight of the "nut" commodity purchased; 6. The date and time of the transaction; 7.

8. Specific identification of the source of the commodity being sold is required. If the seller grew the commodity (nut), they should provide the address where it was grown. If the seller did not grow the commodity (nut), they should provide the name, address, and phone number of the person they got it from, along with the address where it was grown (if known).

The proof of ownership shall be retained with the nut commodity to which it pertains while the commodity is in any person's possession. Proof of ownership forms may be obtained from the Yolo County Agriculture, Weights & Measures Department, located at 70 Cottonwood Street in Woodland, or at the Yolo County Farm Bureau, located at 69 W. Kentucky Avenue in Woodland. Additionally, the proof of ownership form is avail-

Sen. Dodd's Presidential Election Bill Becomes Law

SACRAMENTO, CA (MPG) - Gov. Gavin Newsom has signed legislation from Sen. Bill Dodd, D-Napa, in partnership with Secretary of State Shirley Weber, to increase transparency in presidential elections, helping to ensure the integrity of the democratic process.

"Now more than ever, we must ensure our presidential elections are fair and

transparent," Sen. Dodd said. "With Gov. Newsom's signing of my bill, we protect the free election process that has become a bulwark of democracy. In a time of rising polarization and division, it will bring additional safeguards to this important tradition."

The California Elections Code specifies procedures for political parties to use when submitting the names of presidential and vice presidential candidates to the California secretary of state,

who's charged with generating ballots. However, current law does not provide a submission deadline. Also, the law lacks a provision for candidates to correct any mistakes to their names on the ballot. These issues could result in voter confusion.

Senate Bill 437 sets a clear deadline for submission of presidential and vice presidential names. Parties must submit the names to the secretary of state no later than 75 days before the general election. Additionally,

the bill clarifies that candidates for the two offices can change their names if they appear incorrectly.

SB 437 was signed Thursday, July 13th by Gov. Newsom after receiving overwhelming support in both the Assembly and Senate. It becomes the 101st law written by Sen. Dodd since he was elected to the Legislature in 2014.

"This bill would help ensure that political parties provide timely notice of nominee names and eliminate confusion about the candidate name change process," said Secretary of State Weber. "I appreciate Sen. Dodd championing good governance for California's role in presidential elections."
