Dept. of Water Resources Sued in Yolo Bypass Salmonid Habitat

WOODLAND, CA (MPG) - On July 18, 2023, Yolo County has taken the necessary step of filing a lawsuit against the California Department of Water Resources (DWR) in connection with certain undisclosed aspects of the Yolo Bypass Salmonid Habitat Restoration and Fish Passage Project. The lawsuit is necessary to safeguard the interests of Yolo County residents, protect agriculture, and maintain transparency throughout important projects.

The lawsuit asserts that DWR violated the California Environmental Quality Act (CEQA) by failing to disclose the conveyance capacity of operable gates at the Fremont Weir. Currently being built seven miles northeast of the City of Woodland, these operable gates will be able to convey twice as much water from the Sacramento River into the farm fields in the Yolo Bypass than DWR previously disclosed publicly. The County discovered that the Project is being built to release 12,000 cubic feet per second (cfs) rather than the 6,000 cfs rate DWR disclosed in public documents, which equates roughly to the entire Sacramento River flow at the Fremont Weir on a typical summer day. Additionally, the petition also asserts that DWR violated CEQA by making changes to the project after its initial approval. The elimination of levee cutoff walls, which serve as protective features against potential damage caused by water flow, raised concerns about potential impacts on groundwater levels, drainage, and agriculture in the Elkhorn area. Yolo County believes that these changes should have been subject to public notification and analysis of potential consequences. "We were disappointed Continued on page 2

Newsom's Mental Health Plan Could Strip More Than \$700 Million From Services

A major proposal from Gov. Gavin Newsom to overhaul the state's behavioral and mental health system is likely to take nearly \$720 million away from services provided by county governments annually, according to a new analysis from the Legislative Analyst's Office.

Although that money would be reallocated within the system, in part to house homeless individuals with severe mental illness and addiction disorders, the report authors note that Newsom and key legislators supporting the proposal have neither provided a complete justification for the changes nor have they published an analysis on how the changes may "negatively

impact current services."

"Consequently, as the Legislature considers the proposal, we recommend asking the administration certain questions to assess whether the proposal is warranted," the report states.

Newsom wants the Legislature to put his proposal before voters next year in tandem with a \$4.68 billion bond measure to add psychiatric treatment beds. It would change how the state allocates money under the Mental Health Services Act, which levies a 1% tax on income above \$1 million to fund behavioral health services.

Homelessness has become one of the most high-profile challenges plaguing California, increasing 32% in the past four years. Newsom, who promised to reduce *Continued on page 4*

California Department of Parks and Recreation News Release

SACRAMENTO, CA (MPG) - California State Parks' Division of Boating and Waterways (DBW) is now accepting grant applications for the Clean Vessel Act (CVA) Education and Outreach Grant Program. A maximum of \$276,937 federal funding per targeted region is available to organizations for educating coastal and San Francisco Bay-Delta Estuary recreational boaters about proper vessel sewage disposal and the use of pumpout facilities and monitoring pumpout and dump stations.

In 1992, Congress passed the CVA to help reduce pollution from vessel sewage discharges into U.S. waters. The grant program serves as an important educational opportunity for all boaters on how to help keep California's waterways clean. Discharging sewage overboard creates environmental and human health problems. To reduce the negative impacts of this harmful action, all recreational boaters are encouraged to use sewage management facilities, including pumpout stations, dump stations, and mobile pumpout services.

The grant program targets California counties including: Alameda, Napa, San Mateo, Sonoma, Contra Costa, Sacramento, Santa Clara, Marin, San Francisco, Santa Cruz, Monterey, San Joaquin, Solano.

Proposals that cover a portion of the above regions will be considered if, over time, the agency can expand

according to how each application proposal demonstrates comprehensive and proven methods for meeting grant program goals. The deadline to submit applications is by 10 a.m. on Thursday, Aug. 10, 2023.

Below are some examples of accomplishments from the CVA Education and Outreach Grant Program grantees San Francisco Estuary Partnership and The Bay Foundation from the last two grant cycles:

Created and aired ten episodes of the podcast Dockside to educate the public on clean and safe boating practices;

Participated in three boating events and conducted nine presentations on clean boating and sewage pollution prevention best management practices, reaching over 700 individual boaters and stakeholders;

Produced a variety of educational videos about sewage management such as "Consider a Marine Composting Toilet" video and the "Marine Sanitation Device & Y-Valve Information for Boaters";

Distributed more than 250 universal deck fitting adapter kits to boaters and marina managers. The adapter kit is a pollution prevention tool that helps boaters to pump out their boat hands-free;

Continued to provide boaters with a sewage pumpout Nav App (more than 19,800 downloads since March 2018) that helps them locate nearby participating, functioning sewage pumpout stations, dump stations and floating restrooms;

Monitored 152 sewage pumpouts

to learn that DWR appeared to withhold the true scope of the Project in public meetings and in the environmental review process over the course of several years," said Yolo County Supervisor Jim Provenza. "DWR released over 10,000 pages of material describing the Project and its potential impacts, always describing the Project as having a 6,000 cfs design capacity. I personally met with DWR leadership for years regarding the Project, only to recently learn it is twice the size they advised us and the public all along.'

Supervisor Gary Sandy agreed. "DWR has long known about Yolo County's concerns about the Project and its potential impacts on agriculture. A larger Project only increases those concerns and changing it to eliminate levee protection features is a step in the wrong direction with the potential for additional impacts to farming in the Elkhorn area to the east of the Yolo Bypass."

The County's lawsuit seeks various forms of relief, including a halt to the project's construction and its operations until DWR resolves the legal issues raised by the County.

Third Strike Offender Convicted of Sexual Assault Against Three Victims

WOODLAND, CA (MPG) -On July 14, 2023, a Yolo County jury found 48-yearold Eureka, CA resident, John Augborne, guilty of sexually assaulting multiple minor female victims. Augborne was found guilty of Attempted Rape, Forcible Oral Copulation, and seven counts of felony Sexually Battery for Jane Doe # 1. As to Jane Doe #2, Augborne was found guilty of two counts of Sexual Acts with a Child 10 Years or Younger by Oral Copulation. For Jane Doe #3, Augborne was found guilty of a single Count of Sexual Acts With a Child 10 Years or Younger by Rape, two counts of Sexual Acts With a Child 10 Years

or Younger by Digital Penetration, and one count of Sexual Acts With a Child 10 Years or Younger by Oral Copulation.

Over the course of a 15-day trial, deputy district attorneys David Robbins and Stephanie Allen presented evidence to the jury that Augborne targeted three minors between 2011 and 2021. The jury heard witnesses testify that Augborne committed one crime at a hospital and others while family members of the victims were inside the home. Augborne has a lengthy criminal history including two prior "strike" convictions. Prior to being sentenced to prison on unrelated crimes, Augborne had sexually assaulted two of the victims in this case. After being released on parole in

January 2020, he assaulted the third victim in February 2020.

District Attorney Jeff Reisig stated, "The three victims in this case showed tremendous courage. It is never easy to come forward with allegations of sexual assault and even more so as a child. Often times victims are scared that nobody will believe them. The jury thoughtfully listened to the testimony and reviewed the evidence. At the end of the trial, their guilty verdicts spoke loudly to the victims, 'We believe you.'"

Augborne is scheduled to be sentenced on September 8, 2023, by the Honorable Samuel McAdam in Department 10 of the Yolo County Superior Courthouse. Augborne faces a life term in state prison.



Council Hears Homeless Funding Kids Taking Care of Kids Proposal from Path to Humanity

WEST SACRAMENTO (MPG) - A program has been proposed to the West Sacramento City Council in hopes of adoption. Path to Humanity is a program that is designed to assist in the homelessness problem. In a document handed out by the company, it claims to be a self-funded program (no cost to the city) because it is funded by businesses creating special advertisements that can be placed on and around sidewalks, walkways, benches, fences, back of city signs, and other surfaces. To ensure that the advertisements are visually appealing and to decrease visual impact, documentation states that the ads can be strategically integrated into the media that they are placed in.

The idea presented claims that with the current plan, cities are primarily getting assistance for homeless programs from state and federal funding. In addition, the more homeless there are in a city, the more funding that city receives. However, with all state and federal funding comes parameters on how that money can be spent. Path to Humanity offers a program where the city can be target specific in their spending. With this program, they are running with the idea that the more the community experiences the benefits of decreased homelessness, the more open they will be to advertising areas.

Path to Humanity says that they are not another welfare program, but they are in fact a program that can empower the

The committee could be made up of experts in housing and social services, but should include community members. If the money is being mishandled, the businesses do not support the program.

Holy Cross Festival Returning





homelessness, announced his intent during his State of the State tour to divert nearly one-third of the state's Mental Health Services Act money to help address homelessness.

Since that time, local behavioral health providers and county officials have criticized the proposal because of its potential to cut services and pit mental health programs against homeless services. The state has spent more than \$20 billion on housing and homelessness since 2018.

Supporters, meanwhile, say reprioritizing how the money is spent is long overdue in light of the growing needs of the state's homeless population as well as the addition of new funding sources for mental health programs.

In a statement, Newsom's Deputy Communications Director Brandon Richards said "upsetting the status quo" was necessary in light of California's changing health care needs.

A recent study from UC San Francisco found that two-thirds of homeless individuals experience mental health conditions, although income loss is the driving force behind the state's homelessness crisis.

"What's more upsetting is watching people continue to suffer on the streets with ineffective interventions and inability to access much needed treatment," Richards said. "A California behavioral health system of care that is more focused, more transparent, and more accountable for results is what all Californians deserve and what this historic reform aims to achieve."

Roughly one-third of the county mental health infrastructure in the state is supported by the Mental Health Services Act, which was approved by voters in 2004 as a ballot initiative. Substantial changes to the act, like the ones Newsom proposed, require voter approval. Last year the tax generated about \$3.8 billion.

Critics of Newsom's proposal say the new analysis bolsters their argument that the changes will result in significant cuts to current programs, particularly those that support children.

Newsom's office has so far "danced around" how much money would be cut, said Adrienne Shilton, a lobbyist for the California Alliance of Children and Family Services, which represents behavioral health providers in every county. The report is the first to quantify how the proposal would impact programs statewide.

"We're seeing in real dollars what the impact would be," Shilton said.

The analysis estimates spending on current programs would be reduced from have less flexibility to determine how money is spent. Based on current expenditures, counties would be required to increase spending on housing by \$493 million and on "full-service partnerships" by \$121 million. "Full-service partnerships" include intensive wraparound services like case management, housing and employment support as well as clinical care.

•Program cuts likely: In order to meet spending targets and caps, counties would likely need to reduce spending on current programs including "outpatient services, crisis response, prevention services, and outreach."

•Less independent oversight: The proposed restructuring moves much of the program implementation and oversight authority to the Department of Health Care Services. The change "significantly limits" the independent oversight of the current Mental Health Services Oversight and Accountability Commission.

Sacramento Mayor Darrell Steinberg, who helped author the original law and who has been a key supporter of the changes, said the law was always meant to prioritize "the plight of people living with serious mental illness on our streets."

"It's appropriate, in fact, it's necessary to set priority status," Steinberg said.

Steinberg and Newsom's office also contend that the state has invested heavily in the mental health safety net in other ways, including changes to the Medi-Cal system and a \$4.4 billion one-time infusion into the Children and Youth Behavioral Health Initiative.

"It's no longer a funding source that stands alone," Steinberg said. "(Now), the opportunity is to weave all these pieces together so that everyone has access to care, and nobody is left out or left behind."

Still, advocates say it is premature to assume those investments have had a positive impact and that many have not yet been implemented. In an opposition letter, Lishaun Francis, senior director for behavioral health at Children Now said the state "has yet to demonstrate that it has delivered" on its promises and that the proposal deprioritizes children and youth.

Advocates also say those funding sources, particularly Medi-Cal, won't reimburse for the non-clinical programs like classroom interventions and family resource centers that have historically been supported by the Mental Health Services Act. Medi-Cal is the state's health insurance program for extremely low-income Californians.

Social Security Matters Will WEP and GPO Affect My Wife's Spousal Benefit?

Dear Rusty: My wife worked for the US Postal Service in New York for about 22 years, and then in the private sector for about 15 years. She began collecting her "deferred annuity" from the USPS at age 62 and she plans to collect her Social Security benefits at age 67, which is her full retirement age (FRA).

Her Social Security benefit before the Windfall Elimination Provision is less than 50% of my Primary Insurance Amount. so the plan is for her to start collecting a "spousal" benefit from me at age 67. My question is: will my wife's spousal benefit be reduced by both the Windfall Elimination Provision and the Government Pension Offset (GPO)? Signed: Inquiring Husband

Dear Inquiring Husband: Your wife cannot separate her personally earned Social Security retirement benefit from her Social Security spousal entitlement from you - whenever she applies for Social Security, your wife will be automatically deemed to be filing for all benefits she is entitled to when she claims.

Because your wife has a "non-covered pension" from the US Postal Service (USPS) - and assuming that pension is under the older "CSRS" (Civil Service Retirement System) - your wife's personally earned SS retirement benefit will be reduced by the Windfall Elimination Provision (WEP). WEP reduces Social Security retirement benefits for anyone who also has a pension earned while not contributing to Social Security.

The Government Pension Offset (GPO) is different: the GPO will affect any additional amount your wife is entitled to as your spouse, which we refer to as her "spousal boost." The "spousal boost" amount is the difference between your wife's pre-WEP FRA entitlement and 50% of your FRA entitlement, which is your Primary Insurance Amount. Because of her USPS pension, GPO will reduce your wife's "spousal boost" by 2/3rds of the amount of her non-covered pension, which may eliminate her potential spousal boost.

So WEP will affect your wife's personally earned SS benefit, and the GPO will affect her spousal entitlement from you. But, depending on the amount of her USPS pension, your wife will not be entitled to an additional amount as your spouse if 2/3rds of her USPS pension amount is more than her "spousal boost" amount. And if the GPO doesn't completely eliminate your wife's spousal boost, it will at least

drastically reduce it.

I have previously published several articles about both WEP and GPO and how each provision works, which you are welcome to review at the AMAC Foundation's special Social Security website - www.SocialSecurityReport. org. Social Security will make the final determination about vour wife's benefit entitlement under WEP and GPO when she applies for her Social Security benefits, but I'm afraid your wife's entitlement may be much less than you are anticipating because of these two provisions. 



Gives California an "F"

California Business Roundtable News Release

SACRAMENTO, CA (MPG) - In CNBC's annual "Top States for Business" ranking, California's ranking reflects the reality of our economy, which is led by our tech industry and venture capital dollars but bogged down by our ongoing cost of living crisis, high taxes, and unfriendly business policies.

"California's competitiveness, our ability to attract and retain businesses, as well as to provide employees with an affordable qualify of life, continue to show clear warning signs thanks to our ongoing cost-of-living crisis," said Rob Lapsley, president of the California Business Roundtable. "This ranking is an annual reminder of the state's precarious future and economic solvency. Just like the state budget, our business climate relies almost exclusively on the highly volatile Bay Area's tech region to grow or attract business."

According to the survey, California received an "F" in cost of living and business friendliness which directly reflect the impact of the policies that are being passed by state and local government. In addition, the state economy received

a "D+" and our cost of doing business scored a "D." The only categories in which California excelled were access to capital and technology and innovation, where we scored an "A+" for each.

"Our overall rankings should come as no surprise to the governor and Legislature, who continue to push higher taxes, fees, and expensive regulations onto businesses," Lapsley continued.

In just the past 30 days, the governor and Legislature have ensured businesses will pay one of the highest tax increases in state history by refusing to provide state funding to pay off the state-created Unemployment Insurance Fund debt (learn more here) and increased labor and litigation costs by proposing to refund the Industrial Welfare Commission in the state budget (learn more here).

"The governor and Legislature's policies continue to give clear signals that California is not a friendly place to expand or grow jobs. Technology and innovation, combined with access to capital, have disguised many of the major impacts that our policies are having on all other sectors in our economy. This report clearly reflects the harm these policies are having on businesses and working families," Lapsley concluded.

Governor Signs Bill to Strengthen Domestic Violence Restraining Orders

Office of Assemblymember Jesse Gabriel

SACRAMENTO, CA (MPG) - Governor Gavin Newsom recently signed into law Assembly Bill (AB) 467, a bipartisan measure authored by Assemblymember Jesse Gabriel (D - Encino) that will strengthen the ability of judges to grant and modify domestic violence protective orders.

"At a time in which violence against women and domestic abuse have increased to record levels around the world, it is crucial that we ensure domestic violence restraining orders are offering the fullest possible protection," said Assemblymember Gabriel. "This legislation will clarify a judge's authority over these orders, and extend the amount of time a court can modify the orders to sure that we are providing ample protectheir own court orders will help victims of domestic violence manage the protections to keep them safe. We are so grateful to Assemblymember Jesse Gabriel for championing this important new law."

Ambiguity in current law has left some courts confused as to when and for how long they have authority over domestic violence restraining orders and when they can modify provisions related to contact between the restrained person and the protected person, which can either be a "peaceful contact order" (PCO) or a no contact order (NCO). Victims often seek to modify the order from PCO to NCO or vice versa.

Some courts have determined that if the defendant is no longer serving a sentence and is not on probation, they do not have the jurisdiction to modify the order, even if both the victim and defendant request it. This confusion in current law is detrimental to both victims and defendants. AB 467 gives sentencing courts the authority to modify the terms of a peaceful contact order or no contact order and make modifications to the order throughout the duration of the domestic violence protective order.

Santa Clara County District Attorney Jeff Rosen, sponsor of the bill, hailed the new law as crucial to make sure that victims of crime can petition the court to change the terms of restraining orders during the 10-year lifetime of those orders. In some instances, victims will need more protections from the court, and in others fewer. District Attorney Rosen said, "Giving judges the ability to modify

Breeding May Boost Machine Harvests for Peaches

With the rising cost of labor and a shortage of skilled workers to hand-pick fruit, California canning peach growers are looking to science for solutions. They are breeding new varieties that are firm and flavorful and could lead to greater adoption of mechanization at harvest. Thomas Gradziel, a geneticist at University of California, Davis, says new varieties are essential to make peach farming economically sustainable. For more than 30 years, growers have funded breeding by Gradziel to develop new and improved clingstone peach varieties.

Colleges Prepare Agricultural Workers for High-Tech Future

California has led the way in developing cutting edge agricultural technologies, enabling farms to do more with fewer workers and to make farm work safer and more efficient. But these advances are also creating a challenge. "We need more skilled employees to be able to run this technology," says Johnnie White of Piña Vineyard Management, which manages winegrapes in Napa Valley. College systems and public and private agencies are collaborating to teach experienced farmworkers new skills and support farm interns working with new technologies.

Federal Lands Plan Could Limit Grazing, Public Uses

Ranchers, foresters and others who use public lands have urged the Bureau of Land Management to withdraw a proposed rule they fear would radically restrict activities such as grazing and timber harvesting. The new BLM proposal emphasizes conservation as the predominant land management priority. Those who hold permits on federal lands also say they were blindsided by the proposal. A coalition including the California Farm Bureau said BLM defines conservation so broadly that it creates unnecessary conflict among users of public lands.

Despite Weather Challenges, Slight Increase Expected In Almond Crop

California almond farmers are expected to harvest a slightly larger crop this year, according to a new report from the U.S. Department of Agriculture. The 2023 California Almond Objective Measurement Report published last week estimates the crop will come in at 2.6 billion meat pounds, 1% above last year's 2.57 billion pounds. The estimate is up 4% from USDA's subjective forecast in May and comes after one of the wettest winters on record, limited bee flights because of rain and wind, and a cool spring. The slightly bigger crop comes partly because of larger nut size, USDA reported.★
