WEST SACRAMENTO, CA (MPG) - Due to limited resources and dwindling demand associated with the conclusion of COVID-19 emergency declarations, Yolo County Health and Human Services' Public Health Branch is announcing the discontinuation of its COVID-19 vaccination clinics for the general public. Yolo County's free COVID-19 vaccination clinics in West Sacramento and Woodland will end this month, along with the free in-home COVID-19 vaccination program known as DoorVax. Residents are encouraged to get vaccinated for free at an upcoming clinic if they have not already received their COVID-19 vaccination.

The remaining clinic is scheduled as follows:

June 29 – 3:00-6:00 PM – 500 Jefferson St., West Sacramento; June 29 – Discontinuation of the in-home vaccination program. To schedule an in-home vaccination today, please call (530) 902-3230 for English or (530) 312-4139 for Spanish.

Vaccination against COVID-19
can benefit everyone aged 6 months
and older. To be considered up-todate with vaccination, individuals 6
years and older should have received
a single dose of the bivalent/updated
vaccine. Individuals who are immunocompromised or 65 years and older
should receive two doses of the bivalent vaccine. Children under 6 years
of age require multiple vaccine doses
to be up-to-date; please consult your

child's healthcare provider to determine their vaccination status.

The discontinuation of the clinics does not diminish the importance of COVID-19 vaccination. "COVID-19 has not gone away," says Dr. Aimee Sisson, Yolo County Public Health Officer. "Vaccination remains the best protection against severe COVID-19. If you or your loved ones have not received COVID vaccines, please visit a clinic this month and get vaccinated for free." Following the closure of County-run clinics, COVID-19 vaccines will still be available at retail pharmacies, healthcare provider offices, and community clinics. Blue Star Museums Offer Free Admission to Military and Families

- Six Sacramento area museums are participating in Blue Star Museums - a partnership between the National Endowment for the Arts and Blue Star Families, in collaboration with the Department of Defense and museums across America - to offer free admission to the nation's active-duty military personnel and their families, including National Guard and Reserve, through Labor Day on September 4, 2023. The six local museums participating in the 2023 Blue Star Museums program include the following: Aerospace Museum of California, California Automobile Museum, California Museum, Crocker Art Museum, Fairytale Town, and the Sacramento History Museum.

The free admission program is available for those currently serving in the United States Military-Army, Navy, Air Force, Marine Corps, Coast Guard, including Reservists, National Guardsman (regardless of status), U.S. Public Health Commissioned Corps, NOAA Commissioned Corps, and up to five family members. Qualified members must show a Geneva Convention common access card (CAC), DD Form 1173 ID card (dependent ID), or a DD Form 1173-1 ID card for complimentary entrance into a participating Blue Star Museum.

Before planning a visit, guests are encouraged to contact the individual museums for hours of operation and note some are normally closed on Mondays and in observance of holidays such as Memorial Day and Labor Day. The program is a caring and safe environment where mentors teach community building and sportsmanship.

"The Kings and Queens Rise program brings together trusted community organizations and leaders to provide a safe and supportive environment for youth to build relationships, develop teamwork skills and strengthen confidence," said Sacramento Kings Chief Operating Officer Matina Kolokotronis. "We are thrilled to host the tip-off event at Golden 1 Center and launch our sixth summer of youth basketball and mentorship opportunities.'

"Investing in youth is essential to any thriving community and is an important part of our comprehensive approach to

community-led violence prevention in Sacramento," said Chet P. Hewitt, President and CEO of Sierra Health Foundation and The Center, which manages Kings and Queens Rise, the Black Child Legacy Campaign and My Brother's Keeper Sacramento. The tip-off event will be an opportunity for youth to pick up their uniforms, participate in activities and enjoy food and music. The Kings and Queens Rise program is part of the Sacramento Kings Jr. Kings program presented Kaiser Permanente. WOODLAND, CA (MPG) - The Yolo County Central Landfill (YCCL) is proud to announce its partnership with LoCI Controls, Inc., the leading real-time data, and control technology company that focuses on increasing methane capture and reducing emissions from landfills. Continued from page 1 to learn how to fix things. Turner Library, located at 1212 Merkley Avenue, will be the place for that to happen. Saturday, June 24th from 9am – 12 noon, will be the day of the first West Sacramento Repair Café.

The first repair café will include how to work on a bicycle, and how to sew. Now this is not a place where you drop off your things to be repaired. This will be where you can come learn how to do it for yourself. All ages are welcome, however, children under the age of 12 should be accompanied by an adult. The workshops are free and will be taught and guided by an expert in that field.

The bike repair will be taught by skilled bicycle mechanics from Sacramento Area Bike Advocates (SABA). Just bring your bike in need of repair and you will learn how to fix it.

Clothing repair will be taught by skilled seamstresses and seamsters. This will not be a place to work on your sewing machine (that may come later), it will be a place to learn how to hem something, put in a zipper or button, or perhaps repair a hole in one of your pieces of clothing. You will also be able to learn how to make an old pair of jeans into a purse.

The Repair Café will take place on the last Saturday of each month. Ani Burst is the lady bringing this to West Sacramento. "It helps keep so much needless stuff out of the landfills, it saves people money, and it's good family bonding time," said Ani. She believes that the possibilities are endless in what can be taught at the café. Ani said that she would eventually like to take requests or suggestions of what people need help with. Some topics discussed were:

electronic repair, bike repair, small appliance repair, furniture repair/ upholster, keeping house plants alive, gardening, how to fix a watch/clock, how to replace something on your computer, cooking, and much, much more.

Ani explained that they would eventually like to have a place where people can comment on groups, request a topic, volunteer to teach, or just mingle with others. It'll be a good way for you to get to know your community a little bit better as well. In addition, since the schools no longer have wood shop classes and home economics, this will be a great place for kids to learn some basic skills.

YOLO COUNTY, CA (MPG) -The Yolo County District Attorney's Restorative Justice Partnership (RJP) program is celebrating its 10-year anniversary with a recognition ceremony at 12 noon on Wednesday. June 21, 2023. RJP held its first conferences in Davis on June 3, 2013. In ten years, more than 2,700 people have been diverted through RJP's volunteer-driven 3-step conference process. This process prioritizes accountability and making amends to victims and the community. Participants

avoid the barriers to future education, employment, licensing, housing, and more, that can result from a conviction.

RJP's conference model was designed with input from local law enforcement and leaders in the restorative justice field who would go on to establish the Yolo Conflict Resolution Center. RJP has helped raise the bar for thoughtful, innovative criminal justice reform. The RJP conference model is now utilized by Yolo's collaborative courts (Mental Health Court and Addiction Intervention Court) and has been replicated in counties across

the nation. This recognition celebration will honor the program's accomplishments and highlight the positive impacts it has had on the community. The ceremony will also serve as an opportunity to thank the program's partners, stakeholders, volunteers, and participants.





"I am proud to lead this resolution once again with my House Democratic Caucus Task Force on Aging and Families co-chair Congresswoman Schakowsky. Older Americans have worked hard their entire lives to contribute to our economy, care for our families and enrich our communities. It is now up to us to guarantee seniors the right to affordable, high-quality health care, financial security, and livable communities that allow them to retire and age with dignity. The Older Americans Bill of Rights will ensure that our older Americans maintain the fiscal and social stability they have worked so hard to acquire."

"Older Americans have spent their lives working to raise families, pay their taxes, protect our country, and build our communities. They have earned the right to retire with dignity and respect, and deserve high quality health care and financial security,"

said Congresswoman Schakowsky. "As Co-Founder and Co-Chair of the House Democratic Caucus Task Force on Aging and Families, I am proud to reintroduce the Older Americans Bill of Rights. As extremist Republicans threaten to take away hard-earned benefits like Social Security, Democrats are working hard to lower prescription drug prices, improve Medicare, protect Medicaid, expand Social Security, prevent financial exploitation, increase affordable housing, and strengthen longterm care. We must protect the earned benefits of older Americans and ensure that they, their families, and their caregivers have all the resources they need to not just survive—but thrive."



Treating ADHD is Harder Than it Should Be

Commentary by Dr. Ann Childress, M.D.

Approximately 6 million children in the United States have attention-deficit/hyperactivity disorder, better known as ADHD. As many as 5% of adults also live with the condition.

The good news is that ADHD is highly treatable. Medication and behavior therapy -- or some combination of the two -- can help people with ADHD manage their condition and lead healthy lives.

The bad news is that many ADHD patients are struggling to access these treatments. That is largely due to the actions of little-known middlemen in the drug supply chain: pharmacy benefit managers (PBMs).

Insurers hire PBMs to manage the prescription drug components of their health plans. PBMs negotiate with drug companies to decide which medicines to include on a plan's "formulary" -- the list of medicines an insurer will cover -- and at what prices.

PBMs use their control over formularies to play drug manufacturers against each other and secure the largest discounts possible. For a given class of similar medications, PBMs will often favor a small number, say one or two, out of a dozen potential treatments.

Drug makers are willing to offer substantial discounts for preferred treatment on insurer

formularies. In 2021, its coverage and replacing discounts to payers -- private insurers as well as other entities, such as the Medicare and Medicaid programs -- lopped more than \$118 billion off the list price of brand-name medicines.

The variable results of formulary negotiations, however, often end up leaving patients in the lurch. That's especially true with regard to the medications used to treat ADHD and other mental health conditions.

Most people think a generic medication is exactly the same as the brand-name drug on which it is based. But that's not true. For approval as an equivalent, the FDA allows generics to fall within the range of 80%-125% of the "bioavailability" of the reference drug -- essentially, the amount of the drug that is actually absorbed by the

This allowable variability can make the difference between relief from ADHD, the return of symptoms due to lesser bioavailability, or the onset of side effects due to greater bioavailability.

From a clinician and patient perspective, this can become a nightmare -a scramble to help patients find suitable relief at an affordable price.

For example, one of the largest PBMs, OptumRx, announced that it is removing several popular ADHD-treating drugs from

them with generic versions that might not offer the same bioavailability as their brand-name counterparts.

CVS's company-owned PBM plans to limit its coverage of Adderall XR -- the drug's extended-release formulation -- and another popular ADHD treatment, Concerta, likewise limiting treatment options for patients.

All this churning activity is highly lucrative for PBMs. Their gross profits totaled more than \$28 billion in 2019. But patients are getting a raw deal. The three largest PBMs together control 80% of the market. The list of their "excluded" drugs grew from 850 in 2020 to more than 1,150 in 2022.

Fortunately, lawmakers in Washington are beginning to show interest in standing up for patients. A new bipartisan "Patient Advocacy Caucus" promises to investigate the drug supply chain middlemen keeping prices high for patients. They've pledged to begin with PBMs. There's a lot more to be done, but that's a good place to start.

Imperial Valley Farmers Await Water Deal, Weigh Planting Decisions

California, Arizona and Nevada reached a long-sought consensus last month on how to conserve water and prevent the Colorado River from running dry. Farmers in the Imperial Valley, who are expected to shoulder much of the burden, had been readying to fallow some acreage to save water as early as this year. But many will plant as normal this year and look to reduce acreage next year. That's because a \$1.2 billion federal compensation plan is yet to be worked out for those curbing water use, including details on how much each water user will be paid to leave water in the river.

California Ranchers Have Ample Pastures, but High Costs for Rebuilding Herds

Short supplies of cattle nationwide have sent prices soaring at a time when California ranchers have less to sell after years of drought forced them to shrink their herds. With more rain and an explosion of feed on pastures this year, ranchers are eager to rebuild their numbers while the market is hot. But buying cattle at current prices may not be palatable for some. In its May forecast, the U.S. Department of Agriculture said it anticipates beef production in 2024 to decline 8%, resulting in the lowest per capita beef available domestically since records began in 1970.

Storms improved outlook for California farming, agricultural summit is told

The outlook for California's agricultural economy shows some signs of improvement after several years of supply-chain constraints, high input costs and a multiyear drought that forced farmers to fallow acres and remove orchards. Drenching storms that hit the state early this year turned the tide, contributing to a more positive outlook for agriculture this year, economic analyst David Magaña of Rabobank told attendees during a food and agriculture issues summit in Sacramento. The event featured discussions on topics including water, labor and farm policy.

Officials Hail Farm Grant Program to Safeguard Food Protection

The U.S. Department of Agriculture is partnering with states to offer a grant program to build resilience across the food-supply system, responding to lessons learned from supply-chain disruptions and food shortages that occurred during the COVID-19 pandemic. The USDA Resilient Food System Infrastructure Program is meant to create new revenue streams for producers and to strengthen local and regional food systems. The program was discussed during a recent California State Board of Food and Agriculture session on safeguards to protect America's food supply.

Workplace Angst Helping 'Job Killer' Bills Survive In California Legislature

In the 27 years of the California Chamber of Commerce's "job killer" project, it has followed a fairly predictable pattern.

The chamber would annually designate several dozen nonstarters. legislative bills that business and employer groups considered to be particularly onerous - usually the highest priority measures of labor unions, environmental groups, consumer advocates and personal injury attorneys.

One-by-one, most of the targeted bills would fall by the wayside and only a few, if any, would reach the governor's desk and be signed into law. Overall, the chamber and its allied business groups have achieved about a 90% kill ratio.

This pattern continued even after Gavin Newsom, arguably the most liberal governor in California history, took office in 2019. In the first four years of his governorship, the chamber tagged 94 bills as "job killers." Just eight of them landed on Newsom's desk and he signed six.

So far, 17 bills have made this year's list – an unusually small number - and more than half have already falcommittees.

One has reached Newsom of gender, age and other

and been signed, but it's a faint shadow of its original thrust. Newsom wanted to either tax or penalize oil companies for what he characterized as price-gouging, but settled for giving the California Energy Commission the power to investigate gas prices, set allowable profit margins and levy fines on those which exceed them.

There are two tax increases on the chamber list, one imposing a wealth tax and another increasing corporate income taxes. Both, however, are

The unusual aspect of this year's "job killer" battle is that the eight bills still viable, having cleared their first legislative houses, all relate to one topic - wages and workplace conditions - and are sponsored by unions or personal injury attorneys.

They are the political manifestation of what has become a very contentious labor relations atmosphere this year, not only in California but across the nation, due to high inflation and an overall shortage of workers.

In the main, the employment bills' sponsors contend they are needed to bring more equity to workers while the chamber and other opponents say they will raise costs and thus reduce the financial ability of employers to expand payrolls.

The eight, in brief:

 Assembly Bill 524, which would outlaw discrimination against a personal caregiver in employment, similar to tered, mostly failing to clear the protection granted to persons on the basis

personal characteristics;

•Assembly Bill 647, which would enhance the job protections of grocery industry workers who are displaced by mergers, sparked by the pending merger of the Kroger and Albertsons grocery chains;

•Senate Bill 365, which would make arbitration of employment disputes, which employers generally favor, less viable by allowing lawsuits to continue while employers seek judicial approval of arbitration proceedings;

•Senate Bill 399, which would prohibit employers from disciplining any worker who refuses to listen to employer presentations on political or religious issues;

•Senate Bill 525, which would increase minimum wages in the health care industry to \$21 an hour in 2024 and then \$25 in 2025. with cost-of-living increases thereafter;

•Senate Bill 616, which would increase the amount of paid sick leave employers must offer from a minimum of three days a year to seven

•Senate Bill 627, which would require retail and service chains, such as restaurants, to use seniority when deciding which workers to retain or transfer when closing outlets;

•Senate Bill 723, which would make permanent a temporary law passed during the COVID-19 pandemic to protect return rights of workers in the hospitality industry who are laid off.

Social Security Matters Will Work Earnings Affect My Social Security at Age 80?

Dear Rusty: I am 80 years old, and I receive monthly Social Security benefits, but I'm thinking about returning to work. At this age, am I limited in how much income I generate without affecting my benefit? If so, how much can I earn without affecting it? Signed: Spry Octogenarian.

Dear S p r yOctogenarian: Since you have already reached your full retirement age (FRA) for Social Security's purposes, you can earn as much income from working as you like without your monthly Social Security payment being affected. Social Security's earnings test applies only to those who collect benefits before reaching their full retirement age, which is somewhere between age 66 and 67, depending on year of birth.

However, although the earnings test will not apply to you, it's important to know that Social Security benefits are subject to income tax if your annual combined income from all sources (also known as your "Modified Adjusted Gross Income" or "MAGI") exceeds certain thresholds. Your income tax filing status is an influencing factor - if you file as a single and your MAGI is more than \$25,000, or if you file as "married/ jointly" and your MAGI is more than \$32,000, then 50% of the SS benefits you received during the tax year becomes part of your overall taxable income. And if your MAGI as a single filer is more than \$34,000 or, as a married filer more than \$44,000, then up to 85% of the SS benefits you receive during the tax year becomes part of your overall taxable income at your standard IRS income tax rate. Thus, returning to work may result in Social Security benefits unexpectedly becoming taxable income.

For complete clarity, your "MAGI" is your regular Adjusted Gross Income (AGI) on your income tax return, plus 50% of the Social Security benefits

you received during the tax year, plus any other non-taxable income (except Roth IRA withdrawals) you may have had.

So, while your earnings from working at age 80 (and beyond) will not affect your monthly Social Security benefit payment, you may - depending on your total income or "MAGI" - find that your Social Security benefits will become taxable if your combined income from all sources exceeds the above thresholds. And if your benefits will become taxable, you may wish to consider having income taxes withheld from your monthly Social Security payments, which you can do by submitting IRS form W-4V to your local Social Security field office. Is the City Trying to Shut Down the Port?

WEST SACRAMENTO, CA (MPG) - This is going to be a series of articles about the Port of West Sacramento. On a project that started in 1947, it took until 1963 before the Sacramento-Yolo County Port was open. At that time the Port commission consisted of 5 people: 2 from Sacramento County, 2 from Sacramento City and 1 from Yolo County. In 1987 the City of West Sacramento (COWS) incorporated but there were still no seats on the Port Commission for representation of West Sacramento.

In 1992 the Port Commission added two seats to include representation for the City of West Sacramento. This brought the commission to have 7 seats: 2 each appointed by Sacramento County and Sacramento City, 1 appointed jointly by Sacramento County and Sacramento City, 1 appointed by the City of West Sacramento, 1 appointed by Yolo County. Sacramento had full control of the Port, even though it is in West Sacramento, Yolo County.

Though the work done trickles out to Sacramento, it did not affect anywhere else like it did in the very town it is located. In 2006 the City of West Sacramento took over through Assembly Bill 2939. The Port Commission was consolidated and eliminated Sacramento City and County. The Commission now would consist of 5 members who would be appointed by City Council, 4 from West Sacramento,

and 1 from Yolo County. With the change in governance, it became the Port of West Sacramento, and it changed the requirements about money changed. It no longer went to Sacramento.

The Port is the largest single owner of land in West Sacramento, currently owning 292 acres. A Riverfront Enhancement Fund (REF) had to be developed and it was to be managed by City of West Sacramento (COWS) and Yolo County. The new governance also established new rules about the sale and use of Port property, as well as where the money for these sales must go. For the first 10 years it was supposed to go as follows: 1st \$50M to Port, Next \$23M to the REF and the next \$27M to be equally shared between the Port and REF. (The Lowe's property sold for \$8M in

In addition, the 2006 re-structure states that for the first ten years, the Port shall not sell or lease more than 10 acres North of Southport Parkway and West of Lake Washington for non-maritime (Water related) purposes unless a finding has been made that the transaction is necessary to maintain financial viability of the Port. It also stated that the percentage from real estate sold between ten and twenty years that had to go into the REF would decrease by 10% each year until the year 2026. In other words, in 2026 the City (who is in charge and in control of the money) will not have to share the money from the land sale with the Port. The City of West Sacramento

will get it all.

Recently, 3 of the 5 commissioners were City Councilmembers with County Supervisor Oscar Villegas as the Chair of the Commission. However, the fourth seat came up for appointment. As previously reported, Tim Campbell, President of the International Longshore & Warehouse Union (ILWU), Local 18, applied to be appointed to that seat on the Commission. Tim has decades of experience and lives and breathes the Port. He knows the ins and outs about every aspect of

At the April 4 City Council meeting, some 25 people got up and spoke to the City Council about the value of appointing Tim. When public comment ended, each of the City Councilmembers spoke about how touching and moving the comments were (even bringing some members to tears) and what a valuable resource Tim is. One of the speakers was even a former Assemblymember that helped write AB 2939. In the end, however, the appointment went to our Mayor Pro-tem Quirina Orozco, making the entire Port Commission (with the exception of Supervisor Villegas,) City Councilmembers.

The West Sacramento News Ledger intends on following this through. What does this mean about funding meant for the Port? Will the Port be closing? What does it mean for land development? Does the development plan include improvements and maintenance on the Port and deep-water channel? How does this affect our flood plan? Did the City Council plan for all commissioners to be councilmembers so there is no resistance in what is coming?

There is a recent land sale that is under scrutiny and there is documentation showing Port funds being diverted to add funds to other projects, like the Mike McGowen Bridge. Why isn't dredge money being used to dredge? (By going 5 ft. deeper, the Port could handle a huge

increase in business.) In addition, how does the Port affect West Sacramento economically? What kind of changes would a shutdown cause? How will changes affect traffic? Why would the City move forward with development that could hinder the growth of the Port when growth of the Port would be so significant? We will get the answer to these questions from both sides and bring them to you in upcoming papers.
