# University Professor Indicted for Trafficking Images of Child Sex Abuse

**FRESNO, CA (MPG)** - A federal grand jury returned an indictment on May 4, 2023, against Rodger Githens, 45, of West Sacramento, charging him with receipt and distribution of images of a minor engaged in sexually explicit conduct, U.S. Attorney Phillip A. Talbert announced.

According to court documents, in late March 2023, Githens, using the profile "Tall laid back," initiated contact with an account on the Grindr app controlled by an undercover FBI agent. Githens encouraged the undercover FBI agent to establish an account with the Telegram app, since it was considered more secure. Githens several times discussed traveling to Fresno to meet the agent and a supposed 7-yearold niece for sexual purposes, but law enforcement served a search warrant at Githens's residence on April 19, 2023, and seized multiple electronic devices. Agents discovered numerous Telegram chats on Githens's phone, including several in which he was exchanging and commenting on videos of young children being sexually abused.

This case is the product of an investigation by the Federal Bureau of Investigation with assistance from the West Sacramento Police Department. Assistant U.S. Attorney David Gappa is prosecuting the

If convicted, Githens faces five to 20 years in prison, a fine of up to \$250,000, a lifetime of supervised release, and forfeiture of any property used to facilitate commission of the offense. Any sentence, however, would be determined at the discretion of the court after consideration of any applicable statutory factors and the Federal Sentencing Guidelines, which take into account a number of variables. The charges are only allegations; the defendant is presumed innocent until and unless proven guilty beyond a reasonable doubt.

This case was brought as part of Project Safe Childhood, a nationwide initiative launched in May 2006 by the Department of Justice to combat the growing epidemic of child sexual exploitation and abuse. Led by the United States Attorneys' Offices and the Criminal Division's Child Exploitation and Obscenity Section, Project Safe Childhood marshals federal, state, and local resources to locate, apprehend, and prosecute those who sexually exploit children, and to identify and rescue victims. # They Say They Hear The Public

WEST SACRAMENTO, CA (MPG) - In a nearly five-hour long City Council meeting, one topic dominated the meeting. The Port Commission, its significance to our city, its structure and reasoning, its purpose and importance. In the often heated discussion, passions were all over the place. Discussion between council members became politely aggressive and hostile.

The Port of West Sacramento (changed in 2008 from the Port of Sacramento) has been opened for commerce since 1963. Today the Port's primary cargos are rice, cement and fertilizer. In 2006, the structure of the governance of the Port changed, when the City of West Sacramento assumed control of the management responsibilities. At that time, the Port was nearly bankrupt. The Port currently manages several maritime and non-maritime leases.

The Port of West Sacramento is the single largest land owner in West Sacramento with over 600 acres of vacant land, ready for development. It is for this reason that when the governing structure of the Port was redesigned it includes a statute that says of the five Port Commissioners, four are appointed by the West Sacramento City Council and can be City Council members, and one is appointed by the Yolo County Board of Supervisors. All must be residents of West Sacramento.

A position as a Port Commissioner is up for appointment and who should or shouldn't be appointed to that position is causing an uproar. A packet full of letters in support of Tim Campbell, a lifelong longshoreman, including some from various legislators. The letters list a long list of reasons why Tim Campbell would be good for the job.

City Manager Aaron Laurel got up to the podium to express to the council that he believes as City Manager and as head of the Port Commission, that Tim Campbell should not be given that appointment and that it should go to a city council member, because someone that is not a council member won't have the intimate knowledge of the city's plan for development. Speaker after speaker disagreed, along with some of the City Council members.

The other City Council members spoke of transparency to the community and that by having someone on the commission that was not a City Council member, that there would be better representation of the community and the wants and needs of the community members.

During the Council meeting, some 25 community members spoke regarding the Port. Dave Jones, former Assemblyman that represented West Sacramento in 2006 when the governing structure was redone, said that the restructure was formed with the idea of giving control to West Sacramento. It was not designed to say that the commission had to consist only of City Council members.

Rick Hart spoke and he

provided three documents to the council members, showing them examples of what has happened to other cities in this same predicament when either decision was made. The highlight being that when the commission is all city council members, they can change zoning, which can open them up to lawsuits.

One thing that was important to everyone is that these discussions are vital and that the City Council and the Port Commissions agendas have got to be clear to each other. The possibility of an increase in revenue is something that will benefit all. Councilmember Norma Alcala mentioned how important the relationships that Tim Campbell has with other ports and staff members at those ports would be incredibly beneficial.

After the public speakers, the City Council had a chance to speak again. Each spoke of the amount of passion, loyalty and love in the room. They spoke of how powerful and emotional meetings the members have ever sat in. Councilwoman Early asked "How can we continue to have meetings like this?" They all spoke of how much they learned.

The council put in a request for the City Manager to put together some ideas for developing an advisory committee.

The Council Members all spoke of how moved they were and how they "heard" the speakers, but not one of them changed their minds, after 25 people told them that they disagree. They did agree to possibly form an advisory committee.

# CVS Ordered by CA Judge to Stop Offering to Sell Expired Products

WOODLAND, CA (MPG) -On May 10, 2023, the Yolo County District Attorney's Office, along with other California's District Attorney's offices, settled a civil law enforcement action against CVS Pharmacy and their affiliated California stores. CVS operates three stores in Yolo County.

CVS owns and operates over 800 retail stores in California which sell general merchandise including over-the-counter drugs, food, infant formula, and baby food. Retailers in California are prohibited from selling or offering for sale after the expiration date an over-the-counter drug. Similarly, food retailers are prohibited from selling or offering for sale after the "use by" date, any infant formula or baby food that is required by the federal Food, Drug, and Cosmetic Act to have a "use by" date on its packaging. The civil complaint, filed in Santa Cruz County Superior Court, alleged that CVS offered for sale

and sold during the last four years, expired overthe-counter drug products as well as infant formula and baby food after their "use by" date.

Once put on notice of the violations found during the investigation, CVS was cooperative and conducted internal checks for expired over-the-counter drugs and infant formula and baby food which were past the "use by" date at all their California retail locations. CVS further invested time and resources to prioritize the verification of expiration dates and re-train store personnel. There was no evidence discovered during the investigation that the sale of any expired or past the "use by" date products resulted in harm to consumers.

"California's District Attorney's Offices Consumer Protection Divisions are dedicated to protecting all Californians. Today is another example of those prosecutors working together to make real change. The public should be able to trust what they are buying at any California store will not be

expired before they bring it home," said District Attorney Jeff W. Reisig.

Without admitting or denying liability, CVS agreed to be bound by a court order which prohibits any additional violations of California law relating to the sale or offer for sale of expired over-the-counter drugs or infant formula and baby food past their "use by" date. As part of the judgment, CVS was ordered to pay \$6,500,000.00 in civil penalties and investigative costs as well as an additional \$1,000,000.00 in restitution which shall be contributed to several charitable organizations serving California citizens throughout a wide swath of the State.

The settlement was developed, investigated, and negotiated in conjunction with the Contra Costa County, Fresno County, Marin County, Placer County, Riverside County, Sacramento County, San Bernardino County, San Joaquin County, Santa Cruz County, Shasta County, and the Solano County District Attorneys' offices.

# Parole for 1995 Murder

**WOODLAND, CA (MPG)** - On May 10, 2023, Board of Parole Hearings commissioners denied parole to convicted murderer Michael Todd. Mr. Todd, who lived in the greater Sacramento area at the time of the crime and is now 57, is currently serving his sentence at CA State Prison, Los Angeles.

In March of 1995, Mr. Todd and Kenneth Buffer brutally attacked the victim, James Williams, at a home in West Sacramento. During the trial, witnesses testified that Mr. Williams owed Mr. Buffer and Mr. Todd \$10,000, as a result of drug deal. Mr. Buffer severely beat Mr. Williams with his hands and feet until Mr. Williams went into a coma. While Mr. Buffer watched, Mr. Todd burned Mr. Williams multiples times with a knife that had been heated on a stove. Also, caustic liquid was poured over Mr. Williams' body which caused severe burns. Mr. Buffer later drove Mr. Williams, who was nearly dead, to his friend's house where he was abandoned in the back seat of his own car. Mr. Williams died

trauma," after being taken to the hospital. A jury convicted both Mr. Buffer and Mr. Todd of 1st degree murder and torture, and both were sentenced to 25-yearsto-life in prison.

For the past four years, Mr. Todd has been appealing his conviction based on a new law enacted in January, 2019. As a result of this law, changes were made to the felony murder law eliminating prosecution of an individual who agrees to commit a felony crime that results in a murder if that individual did not harbor actual malice or was not a major participant who acted with reckless disregard during specified felony offenses. Mr. Todd argued that he did not participate in any physical beating of the victim and denied burning the victim. He claimed his actions did not contribute to the victim's death and, as such, he did not act with malice.

On August 26, 2022, Judge Stephen Mock denied Mr. Todd's petition. Judge Mock found that while the victim's main cause of death was blunt force trauma, the death resulted from a constellation of injuries. Judge

ten days later of "blunt force Mock determined beyond a reasonable doubt that Mr. Todd's repeated burning of the victim with a hot knife contributed to the victim's death and supported a finding of implied malice murder. Records show Mr. Todd is appealing Judge Mock's decision to the Third District Court of Appeals.

During yesterday's parole hearing, Mr. Todd took full responsibility for contributing to the death of Mr. Williams. When asked about his petition and appeal to overturn the conviction, Mr. Todd said he believed he had withdrawn his appeal.

Yolo County District Attorney Jeff Reisig stated that he was pleased with the parole board's denial. "The family of James Williams have been suffering immeasurable pain since this senseless and brutal murder," said Reisig. "We will do everything we can on their behalf to honor Mr. Williams and to keep society safe. That is the very least we can do for this family and all families who have survived similar tragedies."

Mr. Todd will be eligible for another parole hearing in 2026.



## Should Octogenarians Tell Social Security They Married?

Dear Rusty: We were married two years ago at age 78 and 81. Do we need to do anything with Social Security? Signed: Blissfully Happy

Dear Blissfully Happy: Congratulations on your fairly recent marriage and, yes, there are some things you should do. Specifically, you should contact Social Security to inform them of your marriage, see whether any additional benefits are available, and to make any changes needed to your contact information. Here are some things to consider:

• If a name change has occurred for one of you, that person should contact Social Security to report the change. A copy of your marriage certificate (and other ID) will be required, and a new Social Security card will be issued.

• If a change of address has also occurred for one or both of you, that must be reported. It's important that Social Security has the correct mailing address, email, and contact phone number for every beneficiary.

• If there are any other changes to the contact Information on file with the Social Security Administration for either of you (e.g., your banking information), the affected person should inform Social Security of the changes needed.

• Social Security will evaluate whether any benefit increase is available as a result of your marriage, which may be the case if one of you is entitled to a "spousal boost" (an additional amount from the other now that you're married). A spousal boost may be available if one has a monthly Social Security payment which is more than twice the other's benefit. Social Security can answer that question for you when you call.

You can contact either your local Social Security office (find the number at www.ssa.gov/locator) or call the national number at 1.800.772.1213 and tell them you need to inform them of your marriage and update your contact information. If you have (or if you create) an online "my Social Security" account at www.ssa.gov/myaccount, you can initiate changes to your contact information online, but you will need to call Social Security directly via phone to record your marriage and see if any changes to monthly benefits are available. All of this can likely be done without requiring a visit to your local SS office.

It is very important that Social Security be made aware of your new marital status and to ensure that they have the correct contact information for both of you. Even if the contact information is unchanged for one of you, the other should contact Social Security as described above to update their contact information and to determine if any changes to monthly benefits are appropriate as a result of your marriage. Doing so now will avoid future issues and will make sure you are both getting the correct monthly Social Security payments as a married couple. And if one of you is entitled to a higher spousal amount, you should ask for the increase to be applied retroactively (SS will pay up to 6 months retroactively). I suggest you call Social Security as soon as possible to inform them of your marriage and make any necessary changes to your contact information.

# California Supreme Court Dismantles **No-Bid School Construction Contracts**

Last week, the California Supreme Court issued a unanimous decision in a very complex – but very importpercolating for more than a decade, dealing with how local school officials evade competitive bidding on construction projects.

The case began in 2010 when Fresno Unified School District persuaded its voters to approve a bond to build new schools and upgrade old ones. In 2011, the district sold more than \$100 million in bonds from that issue and an earlier one, and in 2012 awarded a \$36.7 million contract for a new middle school to Harris Construction Co.

The contract with Harris, which had been a major contributor to the bond issue campaign, was structured as a "lease-leaseback" deal in which the district leased the school site to Harris for a tendent who approved the nominal sum, Harris built the school and the district then leased the completed facility from Harris.

"Lease-leaseback" arrangements have been common for years, providing a way for school systems to build new facilities without borrowing money themselves. Typically, the "leaseback" runs for several decades, after which the district becomes the owner.

In the Harris project, however, Fresno Unified made payments to the contractor and once the school was completed in 2014, it used bond funds to immediately acquire ownership from Harris. Meanwhile, another contractor, Stephen Davis, had sued the district alleging that the Harris lease-leaseback deal was a subterfuge to avoid competitive bidding.

The district won two rulings from a local trial judge that the deal was legitimate, but both were overturned by ant - case that had been a state appellate court and eventually Fresno Unified asked the state Supreme Court to determine whether the Harris deal was a legitimate contract protected under state law. Last week, the court declared that it was not, sending the case back down the legal ladder to determine what damages will be assessed.

San Diego attorney Kevin Carlin, who represents Davis and has carved out a niche career of challenging questionable school contracts, says that Harris Construction may be forced to pay back the \$36.7 million it received for building Gaston Middle

The case has reverberated in other ways. The superincontract, Michael Hanson, was fired by the school board after the suit was filed. Critics cited Hanson's close personal relationship with Harris Construction's president, Michael Spencer, including the firm's sponsorship of a gala event to honor Hanson, and the hiring of Harris as a was awarded.

nothing official came of it. However, when Davis started winning his case, it sent shudders through other school districts that had used lease-leaseback in the same questionable manner.

In 2015, just a week after an appellate court ruled against the Harris contract, a lawyer for affected companies, P. Randolph Finch, outlined a plan "to mitigate our losses" by seeking legislation to legitimize questionable contracts.


"We have clients with well over a half-billion dollars of current backlog," Finch wrote, "and another billion in completed projects, at risk on the Davis case. Consequently, we need a devoted industry effort to press these legislative changes."

Using a parliamentary loophole known as "gut-andamend," a bill to absolve contractors of liability was drafted, but never enacted.

In 2004, the staff of the State Allocation Board, which parcels out school construction money, had described how lease-leaseback rules were being distorted, questioned the legality, declared "the integrity of the use of general obligation bonds... must be above reproach," and suggested that the lease-leaseback law be clarified.

Officialdom ignored that warning but now the Supreme Court is telling school officials and contractors to play fairly or suffer the consequences.

## **PG&E Wants to Help Customers Recognize Utility Scams and Avoid Falling Victim**

SACRAMENTO REGION, CA (MPG) - With reports of scams targeting utility customers at an all-time high, Pacific Gas and Electric Company (PG&E) shares tips with customers to help recognize the signs of a potential

A typical sign of a scam targeting a utility customer includes a caller claiming to be from PG&E and threatening disconnection if immediate payment is not made via a prepaid debit card or money transfer service like Zelle. As a reminder, PG&E will never send a single notification to a customer within one hour of a service interruption, and we will never ask customers to make payments with a pre-paid debit card, gift card, any form of cryptocurrency, or third-party digital payment mobile applications.

"If you ever receive a call threatening utility disconnection if you do not make immediate payment, hang up the phone and either log into your account on PGE.com or call our customer service number to confirm your account details. Remember, PG&E will never ask for your financial information over the phone or via email, nor will we request payment via pre-paid debit cards or other payment services like Zelle. End the call, end the scam" said Matt Foley, lead customer scam investigator for PG&E.

Based on data collected so far in 2023, scammers are stepping up their efforts to defraud customers. In fact, there have been over 19,000 scam attempts reported by customers to PG&E, and customers have lost nearly \$342,000 in the first four months of 2023 alone. During 2022, PG&E received nearly 23,000 reports from customers who were targeted by scammers impersonating the company, and customers lost approximately \$946,000 in fraudulent payments.

Scammers can be convincing and often target those who are most vulnerable, including senior citizens and low-income communities. They also aim their scams at small business owners during busy customer service hours. Another recent emerging scam trend involves scammers targeting real estate agents via their listings, and threatening to shut off power if immediate payment is not made. However, with the right information, customers can learn to detect and report these predatory scams

Signs of a potential scam Threat to disconnect: Scammers may aggressively demand immediate payment for an alleged past due bill.

Request for immediate payment: Scammers may instruct the customer to purchase a prepaid card, then call them back supposedly to make a bill payment.

Request for prepaid card: When the customer calls back, the caller asks the customer for the prepaid card's number, which grants the scammer instant access to the card's

**Refund or rebate offers:** Scammers may say that your utility company overbilled you and owes you a refund, or that you are entitled to a rebate, and ask you for your personal financial information.

**Scammers Impersonating Trusted Phone** Numbers: Scammers are now able to create authentic-looking 800 numbers which appear on your phone display. The numbers don't lead back to PG&E if called back, however, so if you have doubts, hang up and call PG&E at 1-833-500-SCAM. If customers ever feel that they are in physical danger, they should call 911.

#### How customers can protect themselves

Customers should never purchase a prepaid card to avoid service disconnection or shutoff. PG&E does not specify how customers should make a bill payment and offers a variety of ways to pay a bill, including accepting payments online, by phone, automatic bank draft, mail or in person.


If a scammer threatens immediate disconnection or shutoff of service without prior notification, customers should hang up the phone, delete the email, or shut the door. Customers with delinquent accounts receive an advance disconnection notification, typically by mail and included with their regular monthly bill.

Signing up for an online account at pge. com is another safeguard. Not only can customers log in to check their balance and payment history, they can also sign up for recurring payments, paperless billing and helpful alerts.

Customers who suspect that they have been victims of fraud, or who feel threatened duringcontact with one of these scammers, should contact local law enforcement. The Federal Trade Commission's website is also a good source of information about how to protect personal information.

## **Homeless Student Count Grows**

As the number of unhoused students in California's public schools continues to rise to pre-pandemic levels, experts and educators fear that today's economy paired with the state's unrelenting housing crisis will lead to unprecedented rates of homeless youth.

According to updated data released today by the California Department of Education, there are about 5.9 million students enrolled in public schools this school year, close to 40,000 fewer students than last year or a .7% drop. But the number of students experiencing homelessness increased by 9%, about 16,000, to a total of approximately 187,000 kids.

The overarching cause of homelessness among all Californians is the perennial shortage of affordable housing in the state, according to Angela James, a researcher at UCLA's Center for the Transformation of Schools.

"It's alarming to me, quite frankly," James said. "Housing instability may be deepening in California as a result of the pandemic."

The new data signals a return to pre-pandemic numbers. Last school year, about 2.9% of students qualified as homeless. The percentage is up to 3.2% this year, about the same as it was in 2019-20.

"As a state we have not made the housing and well-being of our population a priority," James said. "Sadly, social policies have not been responsive to the needs of young people and their families."

Experts struggle to explain why homeless numbers dropped during the pandemic. They said students and their families may have been moving around during the early months of quarantine, so they may not have been counted. Or unhoused students may have just been falling through the cracks.

"In some cases, districts could be getting better at identifying students," said Dion Burns, a senior researcher at the Learning Policy Institute.

Student homelessness rose this year for the first time since 2020. The count includes students living in motels, trailer parks, campgrounds or public spaces.

While statewide numbers indicate a

return to pre-pandemic levels, 13 of the 20 largest districts in the state have more students experiencing homelessness now than they did in the 2019-20 school year.

Since 2015, rates of homelessness were rising gradually up until 2020, when they started dropping steadily. Student homelessness rose this year for the first time since 2020.

The California Department of Education uses a federal definition of homelessness that includes students living in motels, trailer parks, campgrounds or public spaces.

School districts and county offices of education employ liaisons who keep tabs on students and families experiencing homelessness. James said they're often shorthanded, so collecting data may have been a challenge, especially during the chaos of 2020 and 2021.


Many unhoused students and their families have been evicted from their homes, James said. She recalled her own personal trauma of having her family's furniture moved out to their front lawn when they were evicted. With no home, students and their families might go from one temporary shelter to another with no sense of how long they can stay in one place.

"The degree to which that impacts a child cannot be underestimated," James said.

She added that teachers are fortunately better prepared to work with these students than they were in past decades. When a student acts out or even gets violent, a teacher might try to calm the student instead of resorting to disciplinary actions like detentions or suspensions.

According to the state's new data, the numbers of foster youth, students with disabilities and students from low-income households have all increased by between 2% and 3%.

The rate of decline for overall enrollment shows signs of stabilizing after plummeting in the first years of the pandemic. Kindergarten enrollment took the biggest hit, but is starting to climb back up. Enrollment went from about 71,000 in 2020-21 to about 130,000 this year, but state officials said it's partly due to the state's expansion of transitional kindergarten.
