## Yolo County Children's Alliance Prepares for Annual Backpack Giveaway

YOLO COUNTY, CA (MPG) -Thanks to the 2023 Big Day of Giving event on May 4, YCCA supporters raised enough funds to bring more than 700 children backpacks this summer... and counting!

Big Day of Giving is a program hosted by the Sacramento Region Community Foundation with the purpose of inspiring philanthropy in California's capital region. Also known as 'BDOG', the 24- hour fundraising effort occurred on May 4, 2023, and brought more than \$13.8 million 750+ nonprofits in the Sacramento region! Of those nonprofits, more than 120 are Yolo County based.

YCCA was amongst those nonprofits and raised funds specific to our annual Backpack Giveaway program. In 2022, Yolo County Children's Alliance family support services were accessed more than 75,000 times, and of those

services, 5,600 families were a part of our community resource event services, including our Backpack Giveaway Program, Community Giveaway Day, and Toy Distribution.

For the 2023 Big Day of Giving, YCCA focused on raising a goal amount of \$20,000 for their annual Backpack Giveaway program. In 2022, YCCA supplied more than 1,600 students with backpacks, supplies, and health resources throughout Yolo County. The need is rapidly rising as inflation disproportionately affects the families who are most in need of extra support, and YCCA is anticipating supporting more than 2,000 students this year. Big Day of Giving is a campaign that helps meet those rising needs, not only through monetary contributions, but also by helping bring awareness to our resources, and our mission.

"YCCA's Backpack Giveaway program has been a staple in the communities we serve for more

than seven years. Each year, especially since the pandemic, we've seen a significant increase in need for basic needs and concrete supports," said Jeneba Lahai, Executive Director of Yolo County Children's Alliance. "Over the years, YCCA has worked to build partnerships with sponsors like PG&E, in-kind supporters like West Sac Kids Give Back, the County's school districts, individual donors, and non-profit focused suppliers to be able to increase the supply for families to meet that need. YCCA leverages in-kind donations, partner and business support, and BDOG donations to ensure each child receives unique and complete support to be the best student they can be! With basic needs met, families and students can focus on strengthening their ties to each other, their communities, and their schools."

Big Day of Giving is about giving regionally; the idea is that if everyone gives a little, we can make a big impact. YCCA

is proud to support our partner nonprofits who we work with throughout the year: West Sac Mercy Coalition, Empower Yolo, Yolo Crisis Nursery, Communicare, RISE Inc., Downtown Streets Team, Yolo County CASA, Yolo Food Bank, Fourth & Hope, and the Yolo

Community Foundation. For Big Day of Giving, YCCA raised \$18,355 towards this effort, committing support to more than 730 children! Although BDOG is over, the efforts to raise funds, in-kind donations, and volunteer support is far from over. ### Farm Bureau **Applauds State Senate** Passage of **SB 505**

Farm Bureau Release

SACRAMENTO, CA (MPG) - The California Farm Bureau is applauding the state Senate for its passage of Senate Bill 505, which was approved with resounding, bipartisan support and now moves to the

state Assembly. Senate Bill 505 expands the insurance "clearinghouse" program of the California FAIR Plan, the state's insurer of last resort, to allow commercial insurance policies under the FAIR Plan to move back to the admitted commercial market. California Insurance Commissioner Ricardo Lara is a co-sponsor of SB 505, along with the California Farm Bureau.

The Farm Bureau previously worked with Commissioner Lara and Sen. Susan Rubio, D-Baldwin Park, to pass SB 11 in 2021. That bill allowed farmers and ranchers who lost or were denied coverage in the competitive insurance market after devastating wildfires to obtain alternative coverage through the California FAIR Plan.

SB 505, also by Sen. Rubio, would provide opportunities for agricultural producers to move back to the competitive market, with affordable commercial policies protecting farming and ranching operations.

"California's farmers and ranchers need insurance options to safeguard their ability to continue producing the food that America needs," said California Farm Bureau President Jamie Johansson. "Senate Bill 505 provides agricultural producers who turned to the California FAIR plan the ability to return to the competitive insurance market to protect farming and ranching operations. SB 505 is widely supported by insurers, brokers and agents. We applaud Sen. Rubio for her leadership on this issue, and we encourage the state Assembly to pass this important legislation so that it may be signed into law to provide affordable coverage options for California's vital food producers."

## Use Caution: American River Running Cold and Swift

**SACRAMENTO COUNTY, CA (MPG)** - With temperatures on the rise this weekend, swimming in the American River may sound like a great way to beat the heat, but, with the snowmelt causing the river to run so cold and swiftly, Sacramento County Regional Parks is advising residents to find other ways to beat the heat.

"Cold rivers are dangerous rivers, and right now the American River is running colder than most people realize," said Liz Bellas, Director of Regional Parks. "Water flowing through the American River right now is in the low 50 degrees. We typically see water in the high 50-/low 60-degree range at this time of year."

According to the National Weather

Service, "Cold water drains body heat up to four times faster than cold air. When your body hits cold water, 'cold shock' can cause dramatic changes in breathing, heart rate and blood pressure. The sudden gasp and rapid breathing alone creates a greater risk of drowning even for confident swimmers in calm waters."

Flows out of Nimbus Dam into the American River this weekend will be around 8,000 cubic feet per second (cfs), which is quite high. A typical Sacramento summer sees outflows into the American at around 2,000 cfs or less.

The cold water combined with the swift flows are a recipe for disaster. Don't be bold, the water is cold, so please stay off the river. For more water safety tips, visit LifeLooksGoodOnYou.org



## **Woman Under Investigation Found Dead**

YOLO COUNTY, CA (MPG) - A West Sacramento woman was found dead in her home Sunday morning. Madisen Renee Hanks, age 24, innocent until proven guilty, was under investigation by the Yolo County District Attorney's office pending a charge of Murder II for allegedly distributing drugs that caused the accidental Fentanyl overdose death of Mason Brazil. Hanks was also under investigation for an attempted murder charge in Sacramento County due to a shooting incident. It is reported, yet unconfirmed, that there was a Fentanyl related death investigation on Hanks out of Eldorado County as well. The cause of death for Hanks has yet to be determined by the

Yolo County Coroner.

## **Saving Power and Paying More**



California utility companies are working on a controversial pricing structure that would bill households a different fixed charge depending on their income — but the idea is catching heat from Republicans who argue it will hurt low-income families.

As you may have already noticed on your own bill, monthly electric bills come with a few fixed fees that are added on top of the charges proportional to your usage rate. These charges go toward operating costs for the state's electric grid, including maintenance.

Earlier in April, three companies — Pacific Gas & Electric, Southern California Edison and San Diego Gas & Electric submitted a proposal to the California Public Utilities Commission that includes an income-based pricing system for these fixed charges, as called for in a 2022 state law. According to KTLA 5, the monthly charge would vary between the companies, and range from: Households making less than \$69,000 a year: \$20 to \$34; Households making \$69,000 to \$180,000 a year: \$51 to \$73; Households making more than \$180,000 a year: \$85 to \$128.

The companies say the rate of kilowatt-hour usage will also lower for all customers, but low-income households will benefit the most. PG&E and Southern California Edison estimate

ers would, on average, save as much as a 21% on their bill.

But Republican legislators are skeptical that a plan from "a government sanctioned monopoly" will save customers money. On Friday, the Senate Republican caucus fired off a letter to the utilities commission arguing that the pricing proposal would "unfairly burden" low-income residents:

Senate GOP leader Brian Jones of El Cajon and other Republican senators, in the letter: "The goal of trying to stabilize the grid and lower electricity rates is something we support; however, the tactic of implementing a

structured fixed-charge system that diminishes individual responsibility and usage in favor of an 'identity' subsidization is not, in our opinion, an answer. More fees are not a solution to already ridiculously high utility bills."

The rising cost of natural gas has caused utility bills to surge, frustrating Californians across all economic levels. But lower-income residents end up paying a disproportionate share of utility expenses.

In the meantime, the first round of comments for the proposal will be due by June 2 and the Public Utilities Commission will be expected to make a final decision on the pricing structure by July 2024. ★







Never Have Just One

Dear Dave.

As a small-business owner, should I work with multiple banks to avoid what happened with Silicon Valley Bank?

Dear Matt,

You should work with multiple banks, but that has nothing to do with Silicon Valley Bank. SVB shouldn't be a business model anyone follows. It was a crash of high-tech. start-up and venture-capital players. It was a "players" bank. In other words, it was a bunch of Silicon Valley posers misbehaving under the heading of a bank – and it all came crashing down on their heads. But it didn't have anything to do with the kinds of banks you or I do business with.

Believe it or not, a bank is just another vendor. They are helping you, and

they are a supplier to you – whether it's a checking account, debit card or anything else. Anytime you're doing business, especially when it comes to key areas of your company, it's always good to have more than one vendor in that category. That way, you're not stuck if they decide to raise their prices or their quality of service declines.

Don't get me wrong: I'm not talking about jumping from vendor to vendor every time the wind blows. We have vendors we've worked with for 20 years at Ramsey Solutions. But I'm also not going to let myself or my business become a prisoner of one provider. Currently, we have three banking relationships. We have a primary bank, and we've been with them for 35 years. We also have two other minor banking relationships. Do you see what I'm saying, Matt? If you've only got one supplier for one of the key elements of your business and they suddenly go sideways, so do you! We deal with smaller, regional

and local banks at my

company too. That way, we get to talk with actual human beings who make reasonable decisions. The big banks? No, thank you. Small businesses, especially, are just numbers to them. You get no respect, no mercy and no real help.

Develop banking relationships with people in your own town and area. I'm talking about the kind of folks you could sit down with, have a cup of coffee, and engage in a real discussion about your needs and what's going on in your business. A bank is a key vendor relationship for a small business, but make sure you protect yourself and diversify. Never have just one!

## **Teacher Pension Fund Betrays Its Mission**

If you think that CalSTRS, the behemoth pension system that supports California's retired teachers, is focused on pensions, you are wrong. The largest teacher-focused pension system in the country is abandoning its core fiduciary role to chase left-wing political goals. Its mission creep will hurt teachers, taxpayers, and students alike.

In April, CalSTRS issued an extraordinary press release stating their priorities for the companies they invest in, including corporate greenhouse gas disclosures. CalSTRS is interested in achieving a "net zero" emissions portfolio. Of course, CalSTRS is also interested in corporate diversity, and states: "CalSTRS will vote against an entire board of directors that does not include at least one woman and against a board's nominating and governance committee if at least 30% of its board members are not women. Furthermore, CalSTRS will vote against the nominating and governance committees of Russell 3000 companies

that do not disclose their board members' diversity characteristics."

CalSTRS' Board has morphed into Alexandria Ocasio-Cortez with a \$300-billion billy club to swing at businesses that aren't sufficiently Progressive.

If you were scouring the news for a few words about supporting corporate boards trying to grow profits, entering or creating new markets, utilizing innovation, expanding geographically, then CalSTRS is not the investment entity for you.

Who has time for the actual business of business when you can be leading a social revolution?

CalSTRS might want to check out the work of Bjorn Lomborg, who shows that the climate catastrophists claims about global warming deaths, costs, hurricanes, polar bears, forest fires, etc. are routinely contorted to further the policy agenda of the anti-fossil fuel crowd.

They might want to ask teachers if they themselves are willing to pay out of their own pockets for these political goals.

They might want to ask parents if they are willing to take dollars out of their children's classrooms to diversify corporate boards.

Because the problem with CalSTRS lifting its leftist political banner above all others is that the organization has an actual role, which is fiduciary. Its job isn't to be in the political vanguard but to caretake and grow its investments to meet its payout obligations.

CalSTRS pension payments are funded by payments from the state, from teachers and school districts. If investment gains fall short, contributions need to increase.

The system was already facing a serious insolvency threat in 2040, which is a blink of an eye for a pension system. In 2014, the legislature crafted a plan to stave off the problem and mandated increased contributions from all parties.

California has seen an explosion of education spending in the past decade. Parents hope and assume that their taxpayer dollars go towards classroom enrichment, student activities, training that increases student performance, and so on. Some of it surely has.

But when investments fall short, school spending will go to backfilling pension obligations. That has also been the case. What good is that increased school spending if it doesn't benefit students?

Women and minorities should, of course, be welcome on every corporate board without a discriminatory roadblock. But their presence should indicate merit, not government fiat or race-and-gender box checking. Diversity itself should not be the goal for corporate governance.

Every single California government activity should not be Progressive activism. CalSTRS should honor the teachers, parents, taxpayers and students who are all affected by its decisions and stick to its fiduciary job.







### **Social Security Matters**

### "Survivor" Benefits vs. "Spousal" Benefits

Dear Rusty: I will be 70 in August and will file my application for benefits in May. I know I'll get my maximum possible amount at age 70, but I need you to clarify things I have read. Per an award-winning TV host, author, and host of a money podcast "if the higher-earning spouse delays until age 70 to claim Social Security, that guarantees the survivor the biggest possible benefit." But then I read in a different article that if a person delays beyond their full retirement age to obtain a higher personal benefit (like I have), my spouse's benefit would still be based on my FRA benefit amount. I am confused about which statement is the correct version. Signed: Confused About My Spouse's Benefit

Dear Confused: I'm not surprised that you are confused about these seemingly contradictory statements. It is, indeed, quite logical (and common) for a widow or widower to think they must apply for a "spousal benefit" from their deceased spouse. And while that's technically true, those of us who live in this often confusing world of Social Security jargon would say the widow or widower is applying for a survivor benefit, not a spousal benefit. What's the difference? Well, when you're speaking with a Social Security representative or an advisor, the term "spousal benefit" means something entirely different than the term "survivor benefit."

The two articles you mention are, I believe, referring to two different types of Social Security benefit. The term "survivor benefit" is typically used to describe benefits available to a surviving spouse when the higher earner dies, but the term "spousal benefit" is typically used to denote benefits available to a lower earning spouse when both partners are still living. I agree this is confusing, and that distinction was apparently not clear in the articles you read. Therefore, to clear your confusion:

• If the higher earning spouse dies and has delayed claiming until age 70, that does, indeed, "guarantee the surviving spouse the biggest possible benefit." The survivor's benefit is based on the full amount the deceased was receiving at death.

• If both spouses are living and the higher-earning spouse delayed until age 70 to claim, their living spouse's benefit, when the higher-earning spouse claims, will be a maximum of 50% of the higher-earning spouse's full retirement age (FRA) amount. A living spouse's benefit is based on their partner's FRA amount, regardless of when their partner actually claimed.

So, in your case, your wife's spousal benefit from you while you are both living will be based on your FRA entitlement, even though you waited longer to claim. But if you die first, your wife's survivor benefit as your widow will be based on 100% of the amount you were receiving at your death. In effect, both statements you referred to in your question are true considering that they refer to two different benefit types. It is a terminology distinction which frequently causes misunderstanding.

## When California Laws Go Too Far, The Courts Intervene

Early explorers believed California to be an island, and while its physical attachment to the rest of North America eventually became evident, it nevertheless has sought to forge an island-like cultural and political identity – a "nation-state" in Gov. Gavin Newsom's description.

There are, however, limits. Legally, California is still just subject to federal law, including the U.S. Constitution.

California politicians sometimes ignore that basic fact of civic life in their zeal to lead the parade. But when they cross the legal line, as defined in federal law, they get their comeuppance.

For instance, the federal appeals court that oversees California recently overturned an ordinance passed by city leaders in Berkeley, one of the state's more adventuresome jurisdictions, to ban natural gas service in newly constructed buildings.

The 2020 ordinance, cheered by environmentalists as a gesture to reduce greenhouse gases, was challenged by the California Restaurant Association for violating federal authority to set energy efficiency standards.

A federal trial judge upheld the ordinance but the 9th District Court of Appeals declared that federal law did, handguns that don't meet newspapers.

California's governors and legislators are also prone to enacting new laws that run afoul of the U.S. Constitution, federal law or, in some cases, the state's own constitution.

Chris Micheli, a lobbyist who is also a student of legislative procedure and teaches at the University of the Pacific's McGeorge School of Law, has assembled a lengthy list of legislative decrees that later fared poorly in the courts.

They include such recent laws as those mandating female and members of "unrepresented communities" on corporate boards and prohibiting doctors from one of 50 states and thus is making politically incorrect statements about COVID-19.

> One entire class of California laws, those imposing sometimes unique restrictions on private gun ownership, has fallen prey to constitutional challenges in recent months, thanks to the U.S. Supreme Court's expansive interpretations of the constitutional right to bear arms.

> While gun organizations have been challenging California's array of gun control laws for years, the Supreme Court's landmark Bruen decision last year, invalidating New York's almost total ban on the carrying of personal weapons, opened the door. One by one, California's laws are being invalidated.

> Just last month, for Southern California overturned the state's law

indeed, preempt the issue so stringent – and technically Berkeley could not strike it unworkable - safety requirements, declaring that it runs afoul of the Bruen decision.

> Even before the Bruen decision, a San Diego federal judge, Roger Benitez, had tossed out California's ban on magazines holding more than 10 rounds, the state's ban on assault rifles, and a law requiring background checks for ammunition purchases.

> Another law that fell recently was one dreamed up by Newsom and the Legislature as a symbolic stunt - authorizing lawsuits against some gun manufacturers with conditions that made defense almost impossible. It was patterned after a Texas law making it easier to sue those who performed abortions, and Attorney General Rob Bonta didn't even try to defend it when the inevitable lawsuit challenged it.


> Undeterred by the serial invalidation of California gun laws, Newsom and legislators are working on another measure that, they say, would fit within the constraints of the Bruen decision. Senate Bill 2 would create new standards for the issuance of concealed weapons permits and list a number of new places where carrying weapons would be prohibited, even by those having permits.

Whatever emerges from this year's session would face new legal challenges, and given the state's recent record, would also likely be shot down in court.

## SacRT Awarded \$45 Million by FTA for New Light Rail Vehicles

SacRT News Release

SACRAMENTO, CA (MPG) - The Sacramento Regional Transit District (SacRT) was awarded on May 5, 2023, a \$45.1 million grant from the Federal Transit Administration (FTA) to support the purchase of 16 new light rail vehicles.

The grant through the FY22/23 Rail Vehicle Replacement Program, a new program created by the Bipartisan Infrastructure Law, will help SacRT towards the purchase of 16 new low-floor light rail vehicles from Siemens Mobility in south Sacramento. SacRT is one of six transit agencies nationwide and the only in FTA Region 9 to receive this grant. SacRT previously purchased 28 new low-floor light rail trains from Siemens Mobility and has a contract to order up to 76. Those vehicles are currently undergoing a testing process before they can be put into service early next year. With the order of an additional 16 new low-floor trains, SacRT will have 44 new lowfloor vehicles, which is close to two-thirds of all the vehicles needed to operate on our light rail system.

SacRT has secured more than \$350 million for our Light Rail Modernization Project, which includes the purchase of new low-floor trains, modifications to station platforms and adding a passing track to provide 15-minute service to Folsom area stations.

"The Bipartisan Infrastructure Law is delivering federal dollars across the nation and here in Sacramento our innovators at SacRT are ready to capitalize on its benefits for the community," said Congresswoman Doris Matsui (CA-07). "I was proud to fight for this infusion of federal funds that will replace 35-year-old light rail vehicles with new modern trains

built right here in Sacramento by Siemens Mobility. This \$45 million grant is helping us build Sacramento's future and will enable us to continue leading the way on sustainable, clean, and equitable public transportation.'

"Sacramento Regional Transit is crucial for mobility in the Sacramento region, but the current light rail cars have reached the end of their useful life, said Congressman Ami Bera (CA-06). "I am proud to have helped secure funding through the Bipartisan Infrastructure Law for a new fleet of low-floor cars that will enhance the rider experience and make light rail accessible to all, including those with mobility restrictions, parents with strollers, and cyclists."

"As we celebrate SacRT's 50 years of service to the regionwe can also look to the future," Senator Alex Padilla said. "I have been proud to support and see SacRT's efforts over the finish line to secure federal funding for new, modern light rail cars. Today's grant announcement is a major investment in regional mobility, making light rail cleaner, safer, and more accessible for everyone."

"I want to thank Senator Padilla and Representatives Matsui and Bera for championing the Bipartisan Infrastructure Law that created this new grant program, said SacRT Board Chair and Sacramento County Supervisor Patrick Kennedy. "This significant funding award will help accelerate SacRT's light rail modernization program and puts us one step closer to replacing our aging light rail fleet with entirely new and modern, low-floor vehicles that will improve accessibility for all riders. These new vehicles are being built by Siemens,

right here in Sacramento, so this is also a significant boost to the economic prosperity of the region."

"We are very grateful to the Federal Transit Administration. FTA Administrator Nuria Fernandez and FTA Region 9 Administrator Ray Tellis for their extraordinary leadership for recognizing how important it is to replace our aging fleet of light rail vehicles," said SacRT General Manager/CEO Henry Li. "We also owe our gratitude to Senator Alex Padilla, Representative Doris Matsui and Representative Ami Bera for supporting this grant opportunity and SacRT in general. We are a stronger community because of the work they do on our behalf, and we will be even better when these new, modern low-floor light rail trains are in service early next year."

This new FTA funding along with other grant funding from the Sacramento Area of Governments (SACOG) and the state is being used for the new purchase of 16 low-floor light rail trains.

At the end of April, the state of California awarded SacRT \$8.5 million in grant funding through the Transit and Intercity Rail Capital Program (TIRCP) to help support improved train technology, including realtime train arrival, passenger announcement system and more. Furthermore, this week the SACOG Transportation Committee approved their 2023 Regional Funding recommendations which include nearly \$6.5 million for SacRT's Light Rail vehicles replacements and \$5 million for station conversions to accommodate the new vehicles. New low-floor light rail trains are expected to be in service on the Gold line by summer 2024. Learn more at sacrt.com/modernization.
