I Street Bridge Replacement Project Meeting for Right-of-Way Information

WEST SACRAMENTO, CA (MPG) - The City of West Sacramento has now posted on their website that an informational meeting is to be held on April 12, 2023, from 5:30 – 7:30 PM in the City Hall Galleria, located at 1110 West Capitol Avenue, regarding the right-of-way process for the impacted properties around the West Sacramento side of the new I Street Bridge.

Mayor Martha Guerrero assures the News Ledger that there are no other homes in danger, like the Sanchez home was, that you have read about in past months. The Sanchez Home was set to be destroyed in the previous plans for the bridge construction. When the Sanchez family went to the City, they were turned away. Then the press and City Council became involved and the city staff reworked the design plans to accommodate using property that would not take anyone's home needlessly.

meeting, where you will have the opportunity to meet the staff who will be responsible for the right-of-way process, and voice any concerns you may have as well as get answers to questions you may have.

The I Street Bridge Replacement Project is the plan for a new movable bridge that will go from the

same entrance in the Washington neighborhood of West Sacramento to Sacramento Railyards on the other side of the river. The plan is for the new bridge to provide safe crossing for vehicles, while the old bridge will still be used by trains, bicycles and pedestrians. The new bridge is to be

Nearly \$9,000 Donated to Furnish Homes for Local Foster Youth

YOLO COUNTY, CA (MPG) - Make It Happen for Yolo County has received a grant of \$8,962 from 100+ Women Who Care Yolo County of the Sacramento Region Community Foundation to furnish homes for local transition age youth in need, mostly foster youth, moving out on their own for the first time in 2023.

"We are grateful to these phenomenal women who have given generously to support transition age youth in our county as they move into their first homes and begin their adult lives, often without many resources," said Jan Judson, board president, Make It Happen for Yolo County. "The youth we work with are always floored to learn how many people in our community care about their well-being and are rooting for them."

Make It Happen for Yolo County provides transition age youth (ages 18-24) in Yolo County with the furnishings, household goods and resources needed to move into their first apartments. The group receives furniture donations from the community and purchases new appliances and household items to help youth involved with the Yolo County child welfare, mental health and probation divisions, as well as the UC Davis Guardian Scholars program for students who have experienced foster care. The nonprofit works with clients to complete a wish list of desired household items and then select items at the group's storage units. Since its founding in 2014, the nonprofit has served more than 190 youth. To make a financial or furniture donation, visit MIHYolo.org.

100+ Women Who Care Yolo County is a giving circle of local women who work together to magnify and focus individual philanthropy by pooling funds with others and making a collective decision. 'The Wall That Heals' Exhibits

WEST SACRAMENTO, CA (MPG) - On Veterans Day 1996, the Vietnam Veterans Memorial Fund (VVMF) unveiled a replica of the Vietnam Veterans Memorial in Washington, D.C., designed to travel to communities throughout the United States. Since its dedication, 'The Wall That Heals' has been displayed at nearly 700 communities throughout the nation, spreading the Memorial's healing legacy to millions.

Bringing The Wall home to communities throughout our country allows the souls enshrined on the Memorial to exist once more among family and friends in the peace and comfort of familiar surroundings. The traveling

exhibit provides thousands of veterans who have been unable to cope with the prospect of facing The Wall to find the strength and courage to do so within their own communities, thus allowing the healing process to begin.

The main components of 'The Wall That Heals' are The Wall replica and the mobile Education Center. 'The Wall That Heals' exhibit was on the road for more than 13,000 miles and visited 26 communities from coast to coast during its 2021 season. They were escorted by more than 3,000 vehicles into those communities and they were able to spread The Wall's healing legacy to nearly 200,000 visitors. Guided tours of the exhibit

were provided to more than 12,000 students.

\$476,725 Available in Clean Air Fund Grants

Yolo-Solano Air Quality Management District News Release

DAVIS, CA (MPG) - The Yolo-Solano Air Quality Management District has opened the application period for the 2023 Clean Air Funds program. This annual grant program has \$476,725 available in funding for local projects that will reduce emissions from mobile sources of air pollution within the district. Grants are awarded on a competitive basis by the District's Board of Directors.

The deadline to apply is April 21, 2023, at 4:00 p.m. Applications are available at <https://www.yoasqmd.org/Apply2023CAF>.

District staff will be hosting a virtual workshop on March 23, 2023, at 10:00 a.m. to discuss the program, application process, and answer questions. If you would like to participate, please register at <https://www.yoasqmd.org/2023CAFWorkshop>.

The Clean Air Funds program seeks to encourage private businesses, non-profit organizations, and public agencies to pursue cost-effective, impactful projects designed to reduce pollution emissions from mobile sources within the district through grant funding. There are four qualifying project categories: Clean Vehicle Technology, Alternative Transportation, Transit Services, and Public Education. Previous projects include pedestrian and bicycle infrastructure, EV charging installation, clean vehicle fleet purchases, and alternative transportation public outreach programs for District residents, students, and commuters.

Seniors Get Tax Help at the Library

WEST SACRAMENTO, CA (MPG) - Maria Sandoval, a library associate at the Arthur Turner Library in West Sacramento, greets senior citizens and other patrons visiting the library. "We serve different age groups," explains Maria. "Seniors who utilize the services are very important to us."

As a handful of patrons gathered in the entryway to the main regional library, located at 1212 Merkley Avenue in downtown West Sacramento. Some browse a selection of paperbacks offered for sale, while others inspect tax forms and other documents placed on tables.

The special Senior tax form, the 1040-SR, makes it easy for the elderly in the community to file taxes. The form features enlarged print and some bold print for easy viewing. More importantly, the 1040-SR highlights tax deductions that might pertain to the senior age group. It also includes normal deductions that all taxpayers utilize in calculating what they owe to the federal government.

This year, the filing deadline is April 18 for most taxpayers. A six-month extension of time to file is available to anyone for free. This extension can be made by filing Form 1127 before the April 18, 2023, due date. The library offers Form 1127. However, it is a good idea to call ahead at (530) 666-8005 to see if forms are in good supply. You may also call the library's reference librarian to acquire information on private or

nonprofit tax services at this same number.

The library is working hard to keep the senior tax forms in good supply. As the fax filing date approaches, the 1040-SR, otherwise called the U.S. Tax Return for Seniors, can be found on a table near the library door. Not only is this form simplified for convenient use by seniors, on the back of this special 1040 is a Standard Deduction Chart that helps taxpayers calculate appropriate deductions that reduces total taxable income.

No library card is needed to access tax forms or to call the reference librarian.

In addition to the tax information, other publications and services for seniors can be accessed at the library. Some of these resources though, require a library card. According to Maria, a library card can be acquired online. Anyone living in Yolo County can go to www.yolocountylibrary.org and follow the prompts to receive their

own library card to the various county libraries.

One thing is apparent, West Sacramento library is entirely senior-friendly. Maria, and other library employees, can be seen offering a greeting or smile to young and old alike. Book lovers who come in the door during business hours can expect to be greeted warmly and served efficiently. Library hours are Mondays from 12-7 p.m.; Tuesday through Thursday, 11 a.m. to 7 p.m., Fridays and Saturdays doors are open from 11 a.m. to 5:30 p.m. The library is closed Sunday.

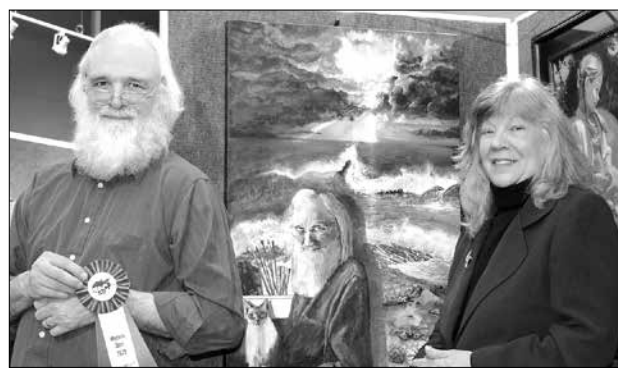
Artist's Selfie Best of Show

Property Tax Delinquent after April 10

WOODLAND, CA (MPG) - The Yolo County Tax Collector's Office reminds taxpayers who own property in Yolo County that the second installment of 2022-23 Secured Property Tax, due February 1, 2023, will be delinquent if not paid by April 10, 2023.

To avoid a penalty, property taxes must be paid by 5:00 p.m. on Monday, April 10, 2023, after which time, a 10 percent penalty will be added. Envelopes must be postmarked no later than April 10, 2023, if taxes are paid by mail. It is suggested that payments be mailed a few days before the April 10 deadline to ensure the envelope will have the proper postmark. The only acceptable postmark for deadline payments is a U.S. Postal Service postmark.

Taxpayers have the option of paying property taxes by credit card (plus a 2.34 percent convenience fee) or electronic check (no charge). These payments can be made online at www.yolocounty.org (select Pay Property Tax icon) or by phone at (877) 590-0714. Payments made using either of these two systems must be completed by 5:00 p.m. on April 10, 2023 to avoid penalties.

Current law does not relieve property

owners of payment responsibility or the imposition of penalties because of failure to receive a tax bill. If you own property in Yolo County and did not receive a tax bill, please call (530) 666-8190 or email taxinfo@yolocounty.org as soon as possible.

Property taxes are a critical funding source for local governments including cities, school districts, local cemetery districts, community colleges, rural fire districts and others. For example, more than half of property taxes received go to local school districts while the property tax portion that rural fire districts receive help fund over 90% of their revenue for the entire year. Yolo County receives about 9% of property taxes, which is 9 cents of every dollar. ★

County and PaintCare Partner on Call to Artists to Beautify Landfill

WOODLAND, CA (MPG) - The Yolo County Department of Community Services, Division of Integrated Waste Management is pleased to release a call to artists to paint a mural on two sides of the paint "Reuse Shed" cargo container, located at the Yolo County Central Landfill at 44090 County Road 28H in Woodland. A \$5,000 stipend, sponsored by PaintCare Inc., will be awarded to the selected artist. This project encourages the use of remanufactured paint, offered by Visions Quality Coatings, or free paint pulled directly from the landfill's Reuse Program.

"Our vision is for this artwork to embody the Yolo County Central Landfill's mission of promoting environmental protection while also integrating PaintCare's mission of providing Yolo County residents and businesses free and convenient access to recycle and reuse paint," said Interim Director of Community Services Leslie Lindbo. "We are looking for high quality art proposals that will appeal to a broad constituency as over 500 vehicles will pass by this artwork daily through the main landfill gates."

PaintCare Inc. is a non-profit 501(c)(3) organization which represents paint manufacturers (paint producers) in planning

and operating paint stewardship programs in states and jurisdictions that pass paint stewardship laws. Assembly Bill 1343 established the Paint Stewardship Program in California, requiring paint manufacturers to develop a take back system for leftover paint from household and commercial consumers.

Pathway to Permit Compact Mobile Food Vendors

WOODLAND, CA (MPG)

The Yolo County Environmental Health Division has created a Compact Mobile Food Operation (CMFO) retail food permit category as part of California's efforts to ease barriers to sidewalk food vending. CMFOs are food operations that operate a pushcart or other non-motorized vehicle in which food is prepared on the CMFO or in a permitted kitchen or restaurant.

Environmental Health will be holding free, in-person and virtual workshops for those interested in obtaining a CMFO permit. The workshops will be presented in English with Spanish translation available. A

virtual workshop will be held on April 18 at 1:00 p.m. The in-person workshop will be held on April 20 at 11:00 a.m. at Environmental Health, located at 292 West Beamer Street in Woodland. For more information on the workshops, visit: www.yolocounty.org/environmental-health.

Unpermitted food operations are unsafe because they are not regulated or inspected by Environmental Health. Selling food without a valid health permit and regular inspections can result in food-borne illness. Operating without a permit is also an unfair business practice. Yolo County Environmental Health inspectors respond to complaints about unpermitted retail food sales and

require vendors to cease operation and obtain a permit.

Environmental Health and Code Enforcement agencies will be conducting joint enforcement operations in the coming months for unpermitted food vending. Failure to comply can result in equipment and food being confiscated, fines and potential prosecution. Business owners that allow unpermitted vending to take place on their property may also be penalized.

\$4.29 Million Available Through Air District Incentive Programs

DAVIS, CA (MPG) - The Yolo-Solano Air Quality Management District has more than \$4.29 million of funding available through its 2023 Solicitation for projects that reduce mobile source emissions and particulate matter (PM2.5). The application period is currently open for on-road and off-road vehicle replacement projects, clean vehicle infrastructure, and the purchase of replacement low-dust harvesting equipment.

The 2023 Solicitation includes funding from the Carl Moyer Program, the Funding Agricultural Replacement Measures for Emission Reductions (FARMER) Program, the Community Air Protection (CAP) Incentives Program through California Climate Investments, and the U.S. EPA Targeted Airshed Grant Program (TAG).

The deadline to submit applications is Thursday, May 19, 2023, at 4:00 p.m.

Court of Appeal Sides with Farmers in Precedential Water Quality Cases

California Farm Bureau News Release

SACRAMENTO, CA (MPG) - In a legal win for California farmers, a state appeals court rejected all arguments brought by environmental groups and sided with the California State Water Resources Control Board, the California Farm Bureau and others related

to the Central Valley's Irrigated Lands Regulatory Program. In its March 17 decision, the Third District Court of Appeal addressed three cases brought by environmental plaintiffs against the California State Water Resources Control Board in which the groups challenged the adoption of general waste discharge requirements for growers within the Eastern San

Joaquin Watershed. "The Court of Appeal's landmark decision supports reasonableness and balancing in protecting water quality, while also maintaining our food supply and the economic viability of agriculture," said California Farm Bureau President Jamie Johansson. "The court's decision is precedential and applies

to irrigated lands regulatory programs throughout the state." Johansson added, "The decision upholds farmer anonymity for nitrogen application data, the use of township-level nitrate data and surface water representative monitoring." Farm Bureau was represented in the case by Senior Counsel Kari Fisher and joined

by fellow agricultural intervenors/respondents represented by Tess Dunham of Kahn, Soares & Conway, and Jennifer Spaletta of Spaletta Law. The California Farm Bureau works to protect family farms and ranches on behalf of nearly 29,000 members statewide and as part of a nationwide network of 5.3 million Farm Bureau members. ★

WOODLAND, CA (MPG) - After an extensive nationwide search process, The Woodland Opera House Board of Trustees is pleased to announce Tom Burmester as the new Executive Director. Burmester replaces current Executive Director, Angela Baltezare, who will retire at the end of June.

Woodland Opera House (WOH) Board of Trustees President, Lou Anderson said, "We are very excited to have Tom join our WOH family. Filling the many roles and responsibilities, as Angela has done so well for the past nine years, will not be easy. But we know Tom is well experienced and up to the challenge of continuing the WOH legacy of presenting excellent theatre productions and outstanding education programs, especially for youth, to our community." Tom Burmester's background as a producer, theatre-maker, and educator, in both northern and southern California, will help to further the mission of the organization that is an historical landmark in Yolo County, and home to an active theatre, and theatre education program.

Burmester will begin work at the WOH in May and assume the Executive Director role in July, managing all day-to-day operations for the nonprofit. His substantial experience in working with a variety of theatrical venues and programs has well prepared him to take on the Executive Director position. In Los Angeles, as Audience Experience Designer for Center Theatre Group, he created engaging participatory experiences for audiences at the Ahmanson, Mark Taper Forum, and Kirk Douglas Theatre. He was the founding Artistic Director of the Los Angeles Theatre Ensemble (LATE), where he produced and directed over 30 new plays and developed "one of the finest and most committed ensembles performing on any Los Angeles stage," according to Backstage. During LATE's residency, he served as Managing Director of the historic Powerhouse Theatre in Santa Monica. His work as playwright, director, and producer of The War Cycle earned awards and recognition, including three Ovation Award nominations and a Special Citation from LA Weekly for "Excellence and Breadth of Vision."

Most recently, in collaboration with UC Davis, he was a Founding Co-Director and producer of the Ground and Field Theatre Festival. This three-year sandbox project invited international playwrights to create new plays and musicals that centered on narratives of environmental, economic, and social sustainability. Burmester is an Adjunct Professor of Performing Arts at St. Mary's College, where he teaches Science Fiction Theatre and Season Planning. He has also taught acting, directing, design, and

theatre studies at UCLA and UC Davis. He earned his Ph.D. in Performance Studies at UC Davis, a Master of Fine Arts in Directing from UCLA, and a BA in Theatre and Dance from UC Davis. Burmester is looking forward to this new venture with the Opera House stating, "The Woodland Opera House has survived two fires, the advent of motion pictures, a global pandemic...and come out swinging. The strength with which Woodland Opera House has persevered is a testament to the resilient power of theatre and a demonstration that the arts remain vital to a thriving community. I am deeply honored by the opportunity to contribute to the history and legacy of Woodland Opera House by continuing to provide a welcoming home for artists and community members looking for a place to connect and create in a vibrant, diverse, and inclusive hub of artistic expression."

Baltezare became the Executive Director in February of 2014. During her 9 years in the position she helped the theatre realize its goal of adding a Theatre and Dance Annex (TADA) studio to house the flourishing education program. Since coming on board, the theatre has also added a new LED theatrical lighting system, a state-of-the-art sound system, and a new HVAC system to increase production quality and patron comfort. Focused on growth, Baltezare expanded the season to include Rising Stars Youth Theatre, allowing young actors to shine on the Opera House's historic stage. Prior to becoming Executive Director, Baltezare held the position of Education Director at the theatre, building a comprehensive theatre and dance program. With more than 40 years of experience in theatre, she will leave quite a legacy. Says Baltezare, "Preservation of our beautiful, historic theatre building, while allowing all ages to participate in, and to enjoy live-theatre performances, has been my priority. It has been an honor to serve my community at the Woodland Opera House for the past 26 years."

Located in downtown Woodland, the Opera House, as it stands now, was built nearly 127 years ago. It is a California State Park, a California Historical Landmark, and on the National Register of Historic Places. In addition, it is one of only four fully functioning 19th century opera houses in California. Known for providing "A Quality Live Theatre Experience in a Landmark Venue," the WOH produces an annual season of musicals, plays, and family-oriented shows, as well as concerts. Newsom Displays Penchant for Shiny New Things on California Tour

As a species, politicians love news conferences and other events that celebrate new programs or public works projects.

The syndrome may explain why officials often ignore long-festering problems in existing programs, such as the Employment Development Department and the bullet train project. Simply making things work better doesn't have the political appeal of something new and shiny.

Gov. Gavin Newsom is particularly prone to the affliction, declaring early on his love for "big, hairy audacious goals" and later adding, "I'd rather be accused of (having) those audacious stretch goals than be accused of timidity."

That proclivity led him, as a candidate, to pledge that he would try to solve California's housing crisis by building 3.5 million new houses and apartments by 2025 and make California the first state to embrace single-payer health care.

Later, when both proved to be unattainable, he declared them to be "aspirational" rather than firm promises.

Newsom's tendency toward the grandiose was very evident this month when he once again shunned a traditional State of the State

address to the Legislature and instead toured the state for serial announcements.

One is converting San Quentin prison into a laboratory to test whether a softer approach to preparing felons for release, modeled after a program in Norway, will be more effective in steering them away from crime. Newsom boasted that the renamed San Quentin Rehabilitation Center will be the "most innovative rehabilitation facility" in the nation, displaying another characteristic, his obsession with being the first to do something.

The splashiest of Newsom's new things is a multi-billion-dollar plan to house thousands of homeless and mentally ill Californians in new facilities that would combine shelter with treatment for their afflictions.

The project would be financed mostly by a bond issue in the \$3-5 billion range to be placed before voters next year and would be an adjunct to Newsom's "Care Court" program that allows the mentally ill to be compelled to accept treatment.

"It's unacceptable what we're dealing with at scale now in California," Newsom said. "We have to address and come to grips with the reality of mental health in our state and in our nation."

Even if implemented as hoped, the two mental health projects would make only a relatively tiny dent in the state's homelessness crisis. California still lacks a comprehensive approach and is mired in finger-pointing among state, county and city officials over who's responsible for dealing with it.

Billions of dollars have

been spent by all three levels of California government, plus no small amount of federal funds, but the number of unhoused Californians continues to climb, officially approaching 200,000 but probably much higher.

The exchanges between Newsom and county officials have been especially pointed. He's accused counties of dragging their feet on effectively spending state grant money while county officials say they need a dedicated and predictable revenue stream for long-term programs.

As Newsom was touring the state, the California State Association of Counties, or CSAC, issued what it said is a comprehensive approach to homelessness embracing housing, social services, education and employment with clear lines of responsibility and accountability for outcomes.

"No one level of government is solely responsible for the homelessness crisis," CSAC president Chuck Washington, a Riverside County supervisor, said in a statement. "But any and all efforts to address homelessness will fail without a comprehensive system in which roles and responsibilities are clear."

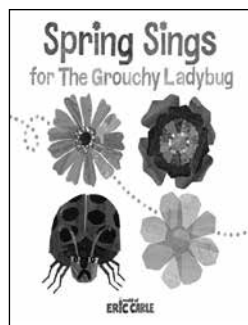
Fundamentally, CSAC is calling for making the systems and services already in place work better. That doesn't have much political appeal but is, to use one of Newsom's favorite words, "foundational" for progress on the homelessness crisis.
