Shani the giraffe gave birth to a female calf on Sunday, January 22, at 12:28pm. Her zookeepers noted signs of an impending birth on January 18, and Shani was moved into the maternity stall of the giraffe barn to be monitored. Although animal care and veterinary teams were suspicious that she might still be pregnant, just not on her original timeline, there were no definitive signs until very recently.


We are thrilled to announce that Shani's calf is healthy and nursing well from mom. The pair will be given bonding time but may be visible at their habitat's side yard periodically over the next few weeks. The official debut date will be dependent on the health and welfare of mom and calf. Keep an eye out on our social media pages for when this new addition to our herd will be visible!

Sacramento Zoo is now home to six giraffes: one post-reproductive female reticulated giraffe, one male Masai giraffe, three female Masai giraffe including Shani, and now the new calf. This is the 21st calf born at the Sacramento Zoo going back to 1954 when giraffes were first housed in Sacramento.

The Masai giraffe is the largest giraffe subspecies and is found in southern Kenya and Tanzania. When a calf is born, it can be as tall as six feet and weigh as much as 150 pounds. Within minutes, the calf is able to stand on its own.

Wild giraffes are experiencing a silent extinction Approximately 150,000 wild giraffes existed as recently as 1985, but it is now estimated that there are now fewer than 97,000.

WEST SACRAMENTO, CA (MPG) - The City of West Sacramento city council has chosen to rename a very busy street that will cost some taxpayers a lot of time and money.

The Brown Act reads: "In enacting this chapter, the Legislature finds and declares that the public commissions, boards and councils and the other public agencies in this State exist to aid in the conduct of the people's business. It is the intent of the law that their actions be taken

openly and that their deliberations be conducted openly. The people of this State do not yield their sovereignty to the agencies which serve them.

December New Home Sales Up 45% from November

SACRAMENTO REGION, CA (MPG) - New home sales rebounded in December around the greater Sacramento region, with 372 sales recorded in the eight-county area, a 45% increase from November, the North State Building Industry Association reported today. Excepting the past two pandemic years, that is the best December BIA homebuilders enjoyed since 2006 and the best month in 2022 since April.

The solid December figures pushed the year's total sales to 5,010, in line with the yearly totals recorded between 2015 and 2019.

Michael Strech, the BIA's President, and CEO said the yearly totals show that the demand for new homes in the region remains strong.

"It's clear that if we look at the year as a whole and not just the slowdown in mid-summer caused by the steep interest rate increases, sales continue to move towards levels we saw in the years before the pandemic generated the sharp increase in sales in 2020 and 2021," Streeh said.

"The demand for housing, particularly for new homes, remains as strong as ever in the region, so while we will see challenges in 2023, we believe the market will likely gradually improve as buyers continue to adjust to the new normal in mortgage rates."

Highlights of the monthly and annual sales figures (excluding the additional 120 sales during the year) include:

Sacramento County sales broke Placer County's six-month winning streak in December, but just by one sale, 169 to 168. Sacramento County sales narrowly outpaced sales in Placer County for the year as well.

Yuba County reported the third-highest sales totals in the region, outpacing El Dorado County.

Because very few homes are still available in the \$300,000-\$350,000 range as those older communities

are now nearly sold out, the monthly total was actually -3 in that price range as three previous sales were canceled.

Strech said the fact that most sales are in the \$500,000 range and above shows the impact of higher government fees, a limited supply of land on which to build, and regulatory delays and barriers that make production of more-affordable homes extremely difficult.

"As our poll showed last fall, an overwhelming majority of Sacramentoarea residents are deeply concerned that their children and grandchildren will not be able to afford to buy a home in our region," Strech said. "It's essential that state and local policymakers enact reforms to encourage new home construction to bring the market back into balance. Otherwise, the affordability crisis will only grow worse."

The BIA's sales figures cover Sacramento, Placer, El Dorado, Yolo, Yuba, Sutter, Amador, and Nevada counties. ★

Continued from page 1 The people, in delegating authority, do not give their public servants the right to decide what is good for the people to know and what is not good for them to know. The people insist on remaining informed so that they may retain control over the instruments they have created."

This is what the Broderick/Bryte Neighborhood Association (BBNA) believes was violated when it comes to the decision to rename the stretch of road that leads onto the Tower Bridge from West Sacramento. It has been decided by the council that Tower Bridge Gateway, which actually properly describes the stretch of roadway, will be renamed Christopher L. Cabaldon Parkway. Those that oppose the renaming say that it is ridiculous and that they don't mind if the council wants to dedicate something else to Mr. Cabaldon, such as a new street or roadway under future development, a new city building, or maybe even renaming the post office building. With all of the building and developing going on, why can't it be something that is not named yet?

They also say that the Brown Act was violated in the process of this very quick decision made by the City Council. It all comes down to whether a chance for public comment was given or respected, and whether they decided we know or don't know. As Chris Ledesma's last thing done before retiring from the City Council, he wanted to do something to honor Cabaldon. It was then said that a street renaming has been suggested. City Manager Aaron Laurel said that it normally would go onto the future agenda "Probably November" as a proposal for what form of recognition that would include. He said that in the future meeting they would bring the details. He further said if they wanted to have discussion, they could go ahead and have it then.

In the time between the October and November meetings, the City sent out notifications to the residents of the Tower Bridge Gateway Apartments with a deadline of within a ten days. However, it takes 2-3 days for that mail to arrive and 2-3 days to be returned. The City will later say that they reviewed all comments that they got that "qualified". Does that mean that those responses of the ten-day period did not qualify?

Residents of Tower Gateway Apartments, who would not give their names, said that they thought it was "junk mail." Another said he thought it was a survey because of how it was written. Members of the Broderick/ Bryte Neighborhood Association claim that what was done was not enough effort to notify those residents and get their proper feedback.

When the November City Council meeting was held, the item of renaming the street was listed as a resolution. It appears the council may have skipped a step. What happened to the actual proposal stage to reveal all details and the cost to taxpayers? When were the total responses recognized from the mailer reviewed by the council? What happened to other options for recognizing Mr. Cabaldon?

During the November 16, 2022 meeting proceedings included were the public comment speaking section, where the public is allowed to speak on topics they want to bring up to the council. One woman, Maria Grijalva attempted to speak about the renaming or the roadway and was stopped by the city attorney, being told she could not speak on it. Another gentleman spoke against the renaming of the roadway as well.

Mayor Guerrero said that before each item listed there would be an opportunity for public comment. During each topic Mayor Guerrero called for public comment. During this topic about renaming the roadway, no call for public comment was made. Only Councilwoman Alcala asked questions and eventually voted no for the reason of public comment being needed.

Since the vote and decision to change the name, the council has been accused of violating the Brown Act. In addition, a petition has been posted on Change.com that has more than 500 signatures. There is also a Facebook page called "Leave Tower Bridge Gateway Alone". The city attorney has reviewed the video of the meeting and says that the City did not violate the Brown Act.

The City released the following statement: "The City followed all applicable laws and policies for renaming Tower Bridge Gateway and notified all

that they received outside interested government agencies, including the U.S. Postal Service, as well as utility providers in advance of the City Council's decision to change the street name. The City is currently procuring new signage, the cost for which will be minimal. The official changeover is expected to take place this spring. The City will renotify all appropriate agencies as well as the owners and residents of 825 Tower Bridge Gateway, which is the only physical structure with an address on the street, well in advance of the official change."

Will the City reimburse all the taxpayers for their personal costs for making the change to their personal records? There is a real cost of time and money for everyone affected. It is not right to pass these costs on to taxpayers that didn't have the real opportunity to reply, especially when there were so many other options available to the city council. The real costs could be thousands of dol-

lars each. Isn't "Tower Bridge Gateway" a much more iconic name for the roadway that is a centerpiece to a city with a professional sports team? No offense to Mr. Cabaldon and his history of hard work for the city, but a building or new school would have been more appropriate for this effort.

The BBNA has asked if the council really considered the 77 people that will now have to change their address on their driver's licenses, bank accounts and other accounts. In addition, The Tower Bridge Gateway Apartments will have to change their letterhead, business cards etc. Additionally, anything that has a map on it, such as documents at Sutter Health Park showing directions will now need changing.

The BBNA believes that it is unacceptable to force these people to have to take the time and cost to make this change. To many this entire process was decided upon and was intentionally pushed through without any real public input. Actions like this are where recalls get started.

There is no question that Mr. Cabaldon did a lot for West Sacramento. The BBNA says if the City Council believe in this so much, they should have had full transparency.

He spoke about helping the community and mentioned that in his 25 years at WSPD, he has risen through the ranks and is now Deputy Chief. "If you don't believe you have the chance to make change, change will be made without you," said Crouch.

After the awards were given out, Chief Rob Strange said he was proud of the many individuals he works with. He highlighted the exemplary work these people do while shorthanded and underfunded. Strange was proud that

WSPD began making the necessary changes before the death of George Floyd which the nation has now demanded in the aftermath of his death.

Chief Strange noted that while shorthanded, officers and their families have sacrificed their time and made efforts to ensure empty shifts were covered. Strange said that more community outreach and programs with the community are important but has heard from community members asking for police work in the most traditional sense.

"They want crime being fought, sideshows busted up, mail and catalytic converter thieves caught and those that are filling our community with deadly fentanyl tracked down and arrested. They want crimes fully investigated and solved, they want us to crack down on bad drivers, they want us to be protecting their homes and their businesses, they want us doing all that we can to protect their children. They want us to be guardians and they want us to maintain a true warriors' spirit on their behalf because [they] want us doing all that we can for them. They want more of you and they want you to stay in West Sacramento," said the Chief. He said, this community values them and wants them to know they

are valued.

New Referendum Qualified for California's November 2024 Ballot

California Secretary of State

Press Release

SACRAMENTO, CA (MPG) - Secretary of State Shirley N. Weber, Ph.D. announced today that a referendum has qualified for the November 5, 2024, General Election ballot.

In order to qualify for the ballot, the referendum needed 623,212 valid petition signatures, which is equal to five percent of the total votes cast for governor in the November 2018 General Election.

The Attorney General's official title and

summary of the referendum is as follows: Referendum challenging 2022 law authorizing creation of council to set minimum wage and working standards for fast-food workers. If the required number of registered voters sign this petition and it is timely filed, a 2022 law will not take effect unless approved at the next statewide general or

special election after November 8, 2022. The challenged law:

Authorizes creation of Fast-Food Council (upon submission of 10,000 fast-food worker signatures) to set working standards and minimum wage (up to \$22/hour in 2023, with capped annual increases) at fast-food restaurants with 100+ nationwide locations.

Prohibits retaliation against fast-food workers for making certain workplace complaints.



Anti-Christian Bigotry in U.S. and Europe

Catholic League for Religious & Civil Rights

NEW YORK, NY (MPG) -Last July, Supreme Court Justice Samuel Alito, who had just recently written the majority opinion overturning Roe v. Wade, upset militant secularists when he spoke honestly about the fate of religious liberty. In his Rome address, he talked about a "growing hostility to religion, or at least the traditional religious beliefs that are contrary to the new moral code that is ascendant in some sectors."

What Alito said is true in the U.S. and Europe.

In a survey by Lifeway Research, it found that "nearly 60% agreed that Christians increasingly are confronted by intolerance in America today." Those who regularly attend religious services were even more likely to say this is true. Young people and those who are religiously unaffiliated were the least likely to agree.

In a survey of anti-Christian bigotry on the other side of the Atlantic, the Observatory on Intolerance

and Discrimination Against Christians in Europe investigated five countries: France, Germany, Spain, Sweden, and the United Kingdom. It found that anti-Christian hate crimes increased by 70 percent between 2019 and 2020. "These have a higher frequency in France and Germany, although they tend to be more severe in Spain and France, due to a reactionary form of secularism."

Why the increase in hate crimes against Christians in Europe? What they found is exactly what Alito was saying. "Secular intolerance and discrimination against Christianity seem to be based on the opposition against more traditional and conservative moral view of Christians." It also said that "It was uncovered that there is a high rate of religious illiteracy among state authorities, public

officials and journalists." The finding about anti-Christianity in Europe also applies to the U.S. It is not religious extremists who are responsible for most of the anti-Christian bigotry, it is militant secularists. Similarly, the high rate of religious illiteracy among government officials and reporters is a serious problem in this country as well.

In 2016, Dean Baquet, the executive editor of the New York Times, said on NPR that it is important for journalists to realize that they have to do a better job understanding the "anger and disconnectedness that people feel. And I think I use religion as an example because I was raised Catholic in New Orleans. I think that the New York-based, and Washington-based, too, probably, media powerhouses don't quite get religion." He added, "We don't get the role of religion in people's lives."

Nothing has changed. Christian bashing is sport in the very Western nations that gave birth to Christianity. That those doing the bashing fancy themselves as the tolerant ones, the "open-minded" secularists, makes the situation all the more perverse.

Gov. Gavin Newsom often boasts that California is a "nation state" that is - or should be -a model for the nation.

However, when it comes to implementing large-scale projects and programs, California is more a model of bumbling incompetence.

The list of failures to deliver what was promised on time and on budget is endless, but here are a few obvious examples:

—A bullet train was supposed to be whisking passengers up and down the state by now, but the state is still building an initial stretch in the San Joaquin Valley that is probably a decade away from working, if ever, while cost estimates have nearly tripled.

—The reconstruction of one-third of the earthquake-damaged San Francisco-Oakland Bay Bridge took a quarter-century to complete and cost 25 times as much as the original estimate.

The Oroville Dam on the Feather River nearly collapsed in 2017 when sections of its main spillway gave way and an emergency spillway eroded the base of the dam. In seeking re-licensing of the dam 12 years earlier, state officials dismissed concerns about the emergency spillway's

integrity. Later it also was determined that the main spillway had been poorly engineered.

-When the COVID-19 pandemic erased the jobs of two-plus million California workers, the Employment Development Department suffered an operational meltdown in handling legitimate claims for unemployment insurance, but gave as much as \$30 billion in cash to fraudulent claimants.

-Although California is the global center of information technology, the state has run up an almost perfect record of botched projects to use it, with long delays in implementation and immense cost overruns.

Again, this is only a partial list. A book could be written about how state and local governments have spent untold billions of dollars on homelessness without making any visible headway. Another could be written about how California reduced its prison population by dumping more felons into overcrowded county jails and/or releasing them to prey upon the public.

One massive failure that developed largely under the media radar deserves a place on the list -a completely bollixed program to provide long-term care insurance to California's public employees and retirees.

In 1995, the California Public Employees Retirement System received legislative approval to provide such insurance. Thousands of public workers signed up on promises that premiums would remain affordable.

However, when the program proved to be actuarially unsound, CalPERS began sharply increasing premiums, finally leading to a class action lawsuit alleging that promises were broken.

"These people were completely, completely misled," Michael Bidart, an attorney representing the plaintiffs, told the Sacramento Bee in 2019, just before a trial was to begin.

"We raised rates to sustain the plan and we believe they were properly increased in accordance with our contract," CalPERS General Counsel Matt Jacobs told the Bee, the only media outlet that has followed the

Negotiations led to a tentative settlement of \$2.7 billion in payments to the plaintiffs. However, last spring CalPERS pulled out because too many individual plaintiffs rejected the deal and a new trial is scheduled later this year.

Clearly, CalPERS didn't know what it was doing. Were it a private insurer, the Department of Insurance would have probably cracked down, but CalPERS is exempt from such oversight.

Many managerial debacles have been ignored by the Legislature and the longterm care insurance is one of them. But the affected workers and retirees are now pressing the Legislature to order an investigation by the state auditor and it's sorely needed to get the bottom of a multi-billion dollar mess.

The good news, though, is it sounds like things may be looking up. Support your husband all you can as he takes on his new job, and make sure you continue looking for work, too. A little extra money never hurts, so temporarily taking on a part-time gig while you're looking for a permanent position isn't a bad idea, either.

Of course, you need to

be honorable and pay your debts if possible. But that may have to be put on hold for a while. Right now, the important thing is keeping food in the house and the lights and heat on. Hug on each other, stay determined and keep each other's spirits up. You're a team, and you'll get through this.

Always remember, too, that prayer's a good thing.

"A MAN CALLED OTTO" RATED PG-13

Would it surprise you that Tom Hanks playing a cranky curmudgeon who no longer sees purpose in his life following the loss of his wife would eventually transform into a modern-day version of an essentially warm Jimmy Stewart?

On two fronts, the answer is probably not. For one, Hanks is usually the nice guy in films. The other reason is his titular role in "A Man Called Otto" is based on the best-selling novel "A Man Called Ove" by Fredrik Backman, which became a Swedish film of the same title.

True to its Scandinavian roots, "A Man Called Otto" tells the story of Hanks' Otto Anderson who lives in a townhome development where his daily routine is acting as the enforcer of homeowner rules even though no one asked him to

Recently widowed and having no other relatives, Otto lives alone in his gated neighborhood where he spends most of his time muttering that anybody he comes across is an idiot and confronting those who offend his sensibilities.

True to his "get off my lawn" persona, Otto yells at a young woman who has the temerity of not curbing her small dog. He chastises the UPS driver for parking on his street that is closed to anyone without a residential permit.

Forced to retire from his engineering job at an automotive plant certainly doesn't help his disposition. Buying rope at a hardware store turns into an ordeal when he argues with the clerk about being overcharged by mere pocket change.

What troubles Otto the most are the wistful flashbacks to his younger self (Truman Hanks) when he meets his future wife Sonya (Rachel Keller) after chasing her down on a train to return a book she dropped.

In the course of these flashbacks, Otto and Sonya become a loving couple who move into the townhome which they made home for their entire adult life together. A fateful bus trip to Niagara Falls has another lasting impact.

Depressed by the death of his beloved Sonya has caused Otto to lose the will to live to the point that he not only contemplates suicide but makes some attempts that are foiled by unforeseen circumstances or ineptness.

He can only rant so much at the other residents who fail to properly recycle their garbage. Harboring grudges against neighbors who were once friends makes him even more cantankerous and unpleasant. Even the sight of a stray cat on his porch is an irritating annoyance to

What could possibly happen that show in the world.

would give Otto a reason to live? The arrival of a Hispanic immigrant couple with two young daughters only seems to make him grouchier when the clumsy husband Tommy (Manuel Garcia-Rulfo) can't parallel park a small U-Haul trailer.

Yet, it's the pregnant Marisol (Mariana Trevino), possessing an ebullient good nature that eventually proves irresistible, who chips away at Otto's resistance to her neighborly friendliness.

Impervious to Otto's less-than-welcoming attitude, the charm offensive begins when Marisol drops off the gift of a homemade meal. The unassuming housewife is so spirited and feisty that rebuffs from Otto just don't register in a lasting manner.

Soon enough, Otto is babysitting Marisol's winsome daughters and teaching her how to drive. He reaches out to estranged friends and helps neighbors make household repairs. He befriends a teenage transgender who gets kicked out of the house.

A nice touch is when Otto takes up a fight against a predatory developer (Mike Birbiglia) trying to evict long-term residents who have become incapacitated and tricked into handing over power of attorney of their affairs.

"A Man Called Otto" has the comfortable ring of familiarity in its sentimental, heartwarming story, which has also its share of occasional humor with Otto's biting wit when he's most irascible.

Despite its PG-13 rating, "A Man Called Otto" is clearly made for an adult audience that welcomes a change of pace with moving performances and an inspirational story.

"FARMER WANTS A WIFE" ON FOX

That a dating series called "Farmer Wants a Wife" was an international sensational comes as a surprise. Until FOX announced its own version would come to the network in early March, I had no idea of its existence.

If you can have hit shows about baking cakes, I guess anything is possible. After all, a series that aired in 32 countries and resulted in 180 marriages and 140 children can't be a fluke.

"Farmer Wants a Wife" seeks to exploit the migration from city-centers to suburban and rural locales, and the romance that follows. Four farmers will embark on an adventure of a lifetime in the hopes of finding their future spouse.

Superstar entertainer and Grammy Award winner Jennifer Nettles, who has also performed in Broadway musicals, will host the "Farmer Wants a Wife" series. We'll see if this American series lives up to the claim of the international version being the most successful dating

Public Hearing Regarding Proposed Municipal Code Changes Pertaining to Retail Cannabis Sales and Microbusinesses (Tilley)

This item is a public hearing regarding proposed Ordinance 23-1 pertaining to retail cannabis sales (storefront and non-storefront) and microbusinesses. This Ordinance would amend Titles 5 and 17 of the West Sacramento Municipal Code to effectuate retail cannabis sales and microbusinesses in various commercial and industrial areas of the city. Retail cannabis businesses (storefront and non-storefront) and microbusinesses would require discretionary approvals and an administrative cannabis license to be able to operate. A hybrid selection process (merit/lottery) is proposed for storefront retail cannabis in the future. No retail cannabis businesses or microbusinesses are proposed at this time. The draft Ordinance also includes a provision to develop an equity pilot program. The project is categorically exempt from further environmental review pursuant to the "common sense" CEQA exemption set forth in CEQA Guidelines Section 15061(b)(3).

Social Security Matters

About Difficulty with Social Security's Sign-in Process

Dear Rusty: Last month I tried to contact Social Security who never picked up a phone on their end. The same with the IRS. When I finally got through, they said I had to join ID.me before they could help me. That took me over a week, and many applications and rejects, to get through. The last step was holding up my Social Security card and my driver's license on a Zoom call to an ID.me representative. I found this very peculiar - why do I have to go through this place to get information from my government agencies? Now I am receiving catalog offers to buy things from ID.me online. I think this is very strange and out of line. How do I get unregistered from this place? I am very afraid they will share my information with the world. Is this a government agency and why do we have to register there, only to have offers to buy things? Signed:


Frustrated Senior **Dear Frustrated:** Many others have shared with us their frustration when seeking enrollment in the federal government's newest credential verification programs so, though I know it's no comfort, you are not alone.

Social Security has, since September 18, 2021, required all newly created online accounts to use either ID.me or Login.gov to authenticate the user's identity. "ID. me" is a private company contracted by the government to ensure that you are who you say you are, thus avoiding any fraudulent activities. Login. gov is the government's own authentication program set up to allow access to multiple government agencies for the same purpose. The intent of both is to give you one set of sign in credentials which can be used to access multiple government agencies, rather than a unique login procedure for each agency. And, most importantly, the purpose is to protect you from any fraudulent activities which could cause you financial harm. Rest assured that your personal information is safe using either of these government-sponsored methods to verify your identity for government business.

Those who have a "my Social Security" account set up before September 2021 can still use their previous SSA-unique identity verification method (a "2-factor ID process") to access their "my Social Security" online account. This method is as secure as

the newer methods but is only good for accessing your Social Security account (not the IRS or any other government agency). Nevertheless, creating a new online Social Security account now requires you use the government's current identity verification methods - either ID.me or Login.gov. If you select ID.me (a private company) you do have control over the type of communication you receive from them and can opt out of receiving any offers for additional services. To do so, it is basically a matter of signing into your ID.me account, accessing your Profile, and selecting "Unsubscribe All" in the Preferences section. And in the meantime, you can also select "Unsubscribe" at the bottom of any promotional email you receive from ID.me.



Stealing is Stealing

A massive rise in retail theft is contributing to "shrinkage" at brick-and-mortar retailers, contributing to the growth of online sales.

"The National Retail Federation estimates that shrink an industry term for loss in inventory – amounted to roughly 1.4% of retail revenue in 2021, or roughly \$94.5 billion. Most of that shrink is caused by theft, the Wall Street Journal reports.

The Globe reported on California's retail theft last May: The escalation of organized "smash-and-grab" robberies in cities around the country has been costly. CNN reported in January that retailers across America say shoplifting is now 2% to 3% of their total sales, forcing the retailers to install new security systems, video cameras and security staff.

A 2021 survey of retailers found 65% acknowledged an increase in violence, while 37% said Organized Retail Crime gangs were much more aggressive than in the past.

With every legislative solution killed by California's Democratic supermajority, retailers and Chambers of Commerce formed Californians Against Retail and Residential Theft (CARRT), and launched a campaign to raise lawmakers' and the public's knowledge of the growing theft problem in the state. CARRT is a broad-based coalition of business associations, local groups, and victim organizations advocating for California officials to act now to undo the damage done by Proposition 47.

Not the Bee also addresses this shrinkage: the Covid lockdowns. "Whoever had the bright idea to shut down the entire U.S. economy, confine people to their homes indefinitely, foment

open-ended hysteria about a respiratory virus, and drive inflation to sky-high record rates - congratulations, your strategy is bearing fruit," Not the Bee reported.

"Brick-and-mortar retail's indisputable edge over e-commerce is that consumers can get what they want immediately, and can touch and feel the product before buying it. Rising theft and stores' measures to prevent it - could dull that edge," WSJ

The National Retail Federation report also found that the vast majority (89.7%) of respondents report that their Loss Prevention department is evaluated according to inventory shrink levels – in other words, shrink reduction is

part of their goals, objectives or performance measures. Just 10.3% reported that they were

"Retailers surveyed by the NRF said Covid-19 has worsened the risk of crime, partly because labor shortages have made it difficult to fully staff stores," WSJ said. "Moreover, supply-chain shortages made certain products more susceptible to theft because they fetched high value in secondary markets."

"Can you imagine a more predictable outcome from the pandemic policies we enacted to fight COVID-19?" Not the Bee asks. "We threw our entire way of life - our economy, our organizations, our social structures, our education - into a complete and total tailspin."

"Shrink can have a substantial impact on already thin retail margins. Target said that the rise in shrink, including theft, reduced its gross profit by more than \$400 million in the first three quarters of its fiscal year, compared with a year prior. For the full fiscal year, it estimates that its gross profit will take a \$600 million hit."

"Although shrink is a perennial problem in retail, it really took off when the pandemic hit. In the five years leading up to 2019, retail shrink grew at a compound annual growth rate of roughly 7%, according to data from the NRF," WSJ said. "In 2020, it jumped 47%, and rose another 4% on top of that huge jump in 2021. Some retailers, including

Ulta Beauty and Target, have said that shrink has gotten worse again this year. 'When times get tough, shrink goes up,' Ulta Beauty Chief Financial Officer Scott Settersten said on the company's earnings call on Dec. 1. We've seen that in retail over a long period of time."

And who will pay for these increasing retail costs? "Retailers will ultimately pay for shrink risk in some form or another – either on the top line if they want to keep stores completely accessible or on the bottom line if they spend heavily on labor and mitigation measures," WSJ said. "Finding the right balance will be key to preserving brick-and-mortar businesses."

And if you wonder why toothpaste, shaving cream and laundry detergent is under lock and key at many stores, it is a theft mitigation measure, according to

California's nonpartisan Public Policy Institute of California released a report that found a direct correlation between Proposition 47 and a marked increase in larceny thefts across California, despite many media reports attempting to refute the correlation, the Globe reported. As for any legislative support from the California Legislature, don't hold your breath:

The California Assembly Public Safety Committee heard and killed Assembly Bill 1599 by Assemblyman Kevin Kiley (R-Granite Bay) in March, which sought to repeal Proposition 47, and "make crime illegal again."

"Retail theft losses may be the straw that breaks the camel's back," said Julian Canete, President and CEO of the California Hispanic Chambers of Commerce. "Something needs to be done before mom and pop stores are stolen from our communities."

To Help Patients Save Money, Congress Farm Bureau President Re-Elected **Needs to Tackle the Middlemen**

As a Republicancontrolled House of Representatives with a small majority opens for business in January, one member has especially big ideas for saving patients money on prescription drug costs and the research to back it up.

A year ago, Rep. James Comer (R-KY) released a comprehensive report on the role of pharmacy benefit managers in the nation's healthcare system. The result does not make for pleasant reading. It is largely a tale of how greedy middlemen have taken advantage of existing legal loopholes and lax oversight to create an industry that raked in \$28 billion in profits in 2019 while providing no actual healthcare to patients.

Insurers use pharmacy benefit managers to negotiate with drug makers on terms for the inclusion of medications in insurance plan coverage. In fact, however, the three biggest PBMs, which account for nearly 80 percent

of prescription claims, are co-owned alongside respective massive insurers like Cigna and pharmacy behemoths like CVS Caremark. The result is an interlocking daisy chain for extracting maximum profit from consumers and payers such as employers and federal and state governments, all while deflecting blame for increasing drug costs away from themselves and onto drug makers.

There's evidence that to remain competitive with PBMs, drug makers have set list prices higher in expectation of large forthcoming discounts, a move that passes none of the discounts directly to patients but allows PBMs to extract increased revenue for their bottom line.

Insurers, meanwhile, charge coinsurance payments and count toward deductibles patient out-ofpocket costs based on the list price of the medication, not the discounted price the insurers actually pay. Insurers like this arrangement just fine because it allows them to crank up their own revenue without raising premiums.

Insurers and their PBMs also pressure consumers to obtain medications through their own respective pharmacy groups. That can take the relatively benign form of an endless barrage of emails from insurers urging beneficiaries to switch their prescriptions in-house. In more severe cases, PBMs can discriminate against independent pharmacies by offering

lower reimbursement rates and excluding them from

insurer networks. Altogether, this conduct has become so parasitic that more than 50% of each dollar spent on brand-name medicines now goes to

middlemen entities. If lawmakers and regulators at the Federal Trade Commission and elsewhere were doing their jobs, this would all be illegal and patients would save big. Instead, many lawmakers have been happy to look the other way while pointing a finger at "Big Pharma" and pocketing campaign contributions from PBMs and allied grifters.

Rep. Comer hits the nail on the head with his main reform push: meaningful transparency among PBMs. Consumers deserve to know who's paying what to whom for prescription drugs.

Healthcare reform must allow patients to make informed choices about their care. Greater transparency for PBM practices is the starting point. Next up should be the shocking requirement that drug discounts ostensibly for patients get passed on to patients, not sucked up by middlemen.

California Farm Bureau Press Release

SACRAMENTO, CA (MPG) -California Farm Bureau President Jamie Johansson has been re-elected to a two-year term as one of six executive board members for the American Farm Bureau Federation.

Johansson, who will represent 13 western U.S. states on the executive board for the national agricultural organization, was elected during the AFBF's 104th Convention in Puerto Rico this month.

"It is an honor to continue to serve during this critical chapter for America's farmers and ranchers," Johansson said. "We are working to pass a new Farm Bill in Congress to secure our food supply and to help our family farmers at a time when more than 50% are reporting negative earnings. I am also committed to ensuring that construction begins on long-overdue federal and state water storage and conveyance projects.

"For too long, our farmers have endured devastating water supply cuts during dry years. And now, after historic storms in California, we are watching uncaptured water simply flow into the ocean due to our state's lack of resolve for completing projects voters approved years ago. We can no longer accept inaction."
