

Lost Boats Memorial Unveiled

WEST SACRAMENTO, CA (MPG) - The unveiling of the Gold Country Base Submarine Veterans "Lost Boat Memorial" took place on Saturday, January 21st. Located in the military walk along the River Walk walkway, it stands tall and proud. Barry Wyatt, Base Commander and Public Affairs Officer, introduced himself, the Color Guard post the colors, the Naval Sea Cadets Honor Guard and Historian Roger Paul led the group in Pledge of Allegiance. A prayer was read by Chaplin Howard Grover and everyone took their seats.

Wyatt thanked the mayor, the City of West Sacramento and all the honored guests for attending the ceremony. He expanded on his appreciation to the City of West Sacramento by saying that the project would not have been completed without the amazing support of the City and guidance by its staff.

Mayor Martha Guerrero was introduced and humbly stepped up to the microphone. She said in part "We are honored that they chose West Sacramento for the memorial honoring the submariners who gave the ultimate sacrifice. The City Council and the West Sacramento community express gratitude to the servicemen who lost their lives at sea, and to the families who lost loved ones in the defense of our country."

The mayor was followed by Pete Juhos, the Western Regional Director of the United States Veterans nationwide. He is former Gold Country Base Commander of Western District 5 and served 21 years in the United States Navy on both submarines and deep submergence vehicles.

In a news release Gold Country said, "Over the history of the Navy, in both war and peace, 65 United States submarines have been lost and 4,000 American Sailors have paid the ultimate price and remain on Eternal Patrol. California Loses **Population** Again

California reigned for decades as the unmatched destination for people around the country. Now people can't leave fast enough. Recently released numbers from the U.S. Census Bureau indicate that between July 2021 and July 2022, California lost roughly 343,000 residents to other states. This number is a "domestic net migration" figure, meaning that 343,000 more Americans moved out of California over those 12 months than moved here from other states.

Where are they going? The number-one net migration winner over that period was Florida, which gained around 319,000 residents from other states.

It's too easy to say exclusively that Newsom is driving people out of state and Florida Governor Ron DeSantis is attracting them, but to the extent the two governors symbolize different approaches to taxation, regulation, and liberty, it holds true. People are leaving Newsomlike states and flocking to DeSantis-like states. If you want to handicap the 2024 presidential election, this is a good place to start.

The states shedding domestic population are progressive strongholds, with extensive regulatory regimens, strong public employee unions and other Democrat policy priorities. They are, simply, big government states. High tax, high cost of living states. Joining California in the top five net losers are New York, Illinois, New Jersey, and Massachusetts.

States attracting Americans are lower-cost, lower-tax, Republican strongholds. Trailing Florida in the top five net gainers are Texas, North Carolina, South Carolina, and Tennessee.

And even if your individual tax burden is not too bad in California, big government, supported by high taxes (regardless of who pays them) indicates a mindset that the state should always be doing more and additional money for government is inherently good.

This bigger-is-better approach leads to government solutions in search of problems.

UC Davis Health Improving Eye Care for People with Diabetes

SACRAMENTO, CA (MPG) -Diabetes affects 34.2 million people in the United States. Diabetic retinopathy, a diabetes complication that affects blood vessels in the eye, is the leading cause of blindness in adults. Early detection and treatment are critical to prevent vision loss but fewer than 50% of the 3.2 million Californians with diabetes undergo their recommended yearly eye screening. Glenn Yiu, a professor of ophthalmology at UC Davis Health, hopes to increase that number significantly.

The UC Office of the President announced Yiu received a \$2 million grant to lead an interdisciplinary program, the Collaborative UC Teleophthalmology Initiative, or CUTI. The project, part of UCOP Multicampus Research Programs & Initiatives, is in partnership with medical centers at UC San Diego, UC San Francisco and UC Los Angeles. CUTI builds on a screening program Yiu launched at UC Davis Health in 2018. The goal is to expand eye care access for diabetics, particularly for underserved populations. The project will utilize digital medical equipment for teleophthalmology or "remote" ophthalmology.

How Teleophthalmology can be used for Screenings

A key feature of the CUTI program is integrating digital eye screenings into routine care at primary care facilities or clinics for patients with diabetes. The screening is simple and just requires the patient to look into a special camera. Known as a fundus camera or retinal camera, the machine takes high-resolution images of the interior of the eye. The images can detect changes that may signal diabetic retinopathy and other eye conditions. After the digital image is

taken at the primary care office or clinic, the results are sent to an off-site eye care provider for evaluation and diagnosis.

vides a convenient way to get your eyes screened for diabetic retinopathy and other ocular disorders during a routine visit to the primary care physician," Yiu said. "It also enhances eye care access for those who do not live near an ophthalmologist."

Since launching a separate pilot teleophthalmology program at UC Davis in 2018, Yiu has improved diabetic eye screening rates by more than 15%, helping to make UC Davis Health one of the top performers in the country.

Screening for Underserved Patients

In addition to eye screenings at primary care facilities at UC health systems, the program Teleophthalmology provides a convenient way to get your eyes screened for diabetic retinopathy and other ocular disorders during a routine visit to the primary care physician.

Health is also working with Communicare Health Care Centers, a FQHC, to provide remote diabetic eye screening to rural areas of California's Central Valley. The region has limited eye care access. UC San Diego and UC San Francisco will also be engaging with community clinics in addition to primary care centers.

Training and Identifying Barriers

Because eye screenings are not a routine part of primary care, the program will train health care providers and identify the barriers that prevent the widespread adoption of remote eye screening. Yiu noted that the COVID-19 pandemic increased awareness and acceptance of telehealth. He thinks this technology can reduce in-person health visits and improve access and adherence to preventative eye care.

The interdisciplinary CUTI team includes members from the four different UC campuses with expertise in public health, clinical informatics, and health economics who can address obstacles in clinical workflow, technology integration, and financial sustainability.

The retinal images taken during the four-year study will be collected in a centralized repository for research using artificial intelligence. Artificial intelligence may be able to identify eye diseases and predict the risk of cardiovascular events and strokes simply from images of the eye's interior.

"The introduction of artificial intelligence is another exciting development in teleophthalmology," Yiu said. "The incorporation of AI for automated image interpretation allows for faster and more sensitive diagnosis of early eye disease."

Remote diabetic eye screening is already available at UC Davis primary clinics in Midtown, Folsom, Elk Grove, and the Lawrence E. Ellison Ambulatory Care Center. Yiu and his team believe that remote eye imaging may be used in the future to screen for other eye conditions such as glaucoma and age-related macular degeneration (AMD). Over the four-year program, they hope to spread the word to improve awareness about preventative eye care.

"We are excited to start this project and hope to find a way to scale it up for all of California. Our long-term goal is to make it easy for people with diabetes to get their annual eye screening, so we can help people avoid preventable blindness."

Rain Damage is Extensive Lost Boats Memorial Unveiled

WEST SACRAMENTO, CA (MPG) - As the City of West Sacramento continues to clean up and make repairs caused by the mass rain and winds that California sustained, the road conditions are on that list. Mass amounts of water made the roads swell and crumble, leaving behind many, and some very large, potholes in our roads. The Public Works Department is doing their best to get to them as quickly as they can, but they are relying on the public for help in finding them.

"We simply don't have the time to drive up and down every road in town looking for potholes," said Bill Roberts, Director of

Public Works. "We are relying on the community to notify us where they are," he said.

Roberts said the best way to report potholes, and any problem that is not an emergency, is online through West Sac Connect, either online or the mobile app, because then the report goes directly to the correct person.

"It not only keeps a record of all reports, but we can mark them as completed and add photos so that the concerned party can check the status of their report and know that we are taking care of it. It's just a really great thing," he said. Roberts also added that people should try to give as specific details as

possible to its location.

If you don't have access to WestSacConnect, you are welcome to call them at (916) 617-4850. However, if you think the pothole is big enough, or deep enough that it could cause an emergency situation, you are asked to call. If it is after 5 p.m., you can call the non-emergency dispatch number of the Police Department at (916) 372-3375 and they will send out workers right away to triage and assess the issue.

Public Works has staff on 24-hours-a-day and is available for emergencies when needed, and they truly feel "better safe than sorry" is the way to look at it if you are unsure if it is an emergency.

Continued from page 1 their country in the United States Navy Submarine Service and honors those brave men and women who are serving now and who will serve in the future, beneath the oceans of the world."

The idea for the monument began in 2017. They wanted it somewhere in the Sacramento Region. Similar monuments have been created nationwide, but most are concentrated on the submarines lost during WWII. This Monument is to recognize all 65 submarines that have been lost in service. They wanted to find a spot that was close to the water, somewhat safe from vandalism and easy

to access for public viewing. They decided that the Veteran's Plaza in West Sacramento would be the perfect spot. After years of ups and downs, fundraising the \$20,000 needed to get started, and then continuing the fundraising for additional costs, the monument has finally been built and installed.

Wyatt listed the many groups and organizations that took part in the construction and installation of the majestic monument. He then explained his personal connection to the monument. When he was 17 years old and in submarine school, the USS Thresher (SSN-593) went on a deep-diving exercise when she went down. He

discussed how the shock wave that hit those in school and how he still carries it to this day.

He quoted Dr. Joyce Brothers about submariners: "The tragic loss of the submarine Thresher and her men had a special kind of impact on our nation... a special kind of sadness, mixed with universal admiration for the men who chose this kind of work...." She said, "one could not mention the Thresher without observing, in the same breath, how utterly final and alone the end is when a ship dies at the bottom of the sea... and what a remarkable specimen of man it must be who accepts such a risk."

oversee how local governments within their county can ensure the efficiency of services such as water, sewer, fire protection, etc., by boundary changes. These include mergers, detachments, consolidations, and formations of existing or new districts. In other words, they try to keep local governments' spending more efficient by seeing what "departments" can be combined, and what

should be separated. In 2019, the City of West Sacramento and Reclamation Districts 900 and 537 were in disagreement about who would be more economically beneficial if left in charge of the care of our levees. Districts 900 and 537 agreed that the organizational structure of decision-making and all work done to our levee system should remain as it was. The City claimed that it would be more beneficial if they were to be in charge because they could consolidate different aspects of administration and cut administrative overhead. It would not just be one or the other, however. Either group will also be working with the Army Corp of Engineers and multiple city, county, state and fed-

eral agencies. Ultimately, LAFCo made a decision. The City of West Sac would be the more economical way to go. The question then became, would the integrity of our levees and the safety of our community be at risk? Could we count on the City to keep us safe when taking the place of experts on the topic?

Well, it seems that LAFCo's decision was a

good one. When the City much water hits the clay ple in the right positions. Bill Roberts is the Director of Public Works. He came from Sacramento after 21 years of being in charge of their levees.

"West Sac has a lot more employees as opposed to RD 900 who can actually help and fix, repair or prevent problems with the levees and we have certified people, like myself and Bobby Santos, who that's all we did over there was levees," he said.

Roberts and Santos have been trained by DWR (Department of Water Resources) and the Army Corp of Engineers on how to care for, repair, and build levees. They do four inspections per year.

With all the rain that the recent series of storms brought, there has been natural erosion to the levees. This has prompted an action of preventative

The City of West Sac explained it as "More than likely, the slump was caused by water entering into the very small cracks in the levee. This levee is a clay levee, which shrinks and swells; shrinks when it is hot outside, swells when the soil gets wet. If too

took over, they made sure levee too fast, the clay canthat they had the right peo- not absorb the water fast enough to swell closed, so water leaches into the levee. The clay gets over saturated, such that this extra weight caused the

The tarping of the slump prevents additional water from entering the damaged section. This prevents additional slumping and erosion. The sandbags are used as weights to keep the tarp from flying away in the wind. This portion of levee embankment along the Deep Water Ship Channel is quite wide, approximately 250 feet. The amount of material that slumped poses no threat to levee safety and there is absolutely no threat of a breach."

The City would also like to remind anyone who is along the river or deep water channel to be extremely cautious. It is definitely not recommended to have 4-wheelers out there. The ground is too soft and unpredictable. Though we are not in danger of a breech, there is a very real danger of a possible life-threatening situation occurring if the ground gave way from under your vehicle. Please stay safe.

Riverbank Elementary providing dental treatment for the kids

Smile Savers Virtual Dental Home is coming to Riverbank elementary next month. The children will receive all dental check-ups including the following services: teeth cleaning, radiographs, exam, fluoride, dental sealants and brushing instructions. If you have any questions, you can call Riverbank at (916) 375-7700, or the dental office at (916) 403-2960. There is registration paperwork in English/Spanish/Russian/Farsi that has been handed out to students. All parents need to do is fill out the registration forms and turn them into the school. The Smile Savers/Virtual Dental Home hygienist will be on campus 3 days a week and begin seeing students at the beginning of February. The hygienist collaborates with a dentist via the internet and can take X-rays, do screenings, sealants and treatments for students during the school day. Parents do not need to take time off work to take their students to the dentist (they can certainly come and watch the procedure if they want). Any treatments requiring anesthetics are referred to a local dental clinic. All procedures are covered by MediCal, whether they are at school or at the dental clinic. The hygienist plans to talk with all classes about dental care so that all students can benefit, but parents do have to sign off on having their students treated before the hygienist can see them.

Transit Ridership Falters, Posing a 'Fiscal Cliff'

California utopians, including those holding public office, envision a state that by 2045 will have achieved zero net emissions of carbon dioxide and other greenhouse gases.

The largest source of those emissions is transportation – the cars, trucks, buses, airplanes and railroad engines that carry Californians, the goods they need to live and the inputs and outputs of the state's \$3.4 trillion economy.

To that end, the California Air Resources Control Board has issued seemingly countless decrees, including one that would ban the sale of autos with gas- or diesel-powered engines by 2035.

Public transit is central to the state's hopes of reducing transportation emissions. Officials want more Californians to park their cars – or not buy them in the first place – and use buses and light and heavy rail systems for commutes and other personal trips.

Despite those hopes, transit ridership is going the other way, and transit system operators and advocates are using terms such as "fiscal cliff" and "death spiral" as farebox revenues decline and there is greater demand for taxpayer

operations.

Transit usage cratered when the COVID-19 panworkers either lost their jobs or shifted to working at home. Ridership picked up a bit when pandemic closures eased and employment finally returned to pre-pandemic levels. However, the California Transit Association says that as of the third quarter of 2022, overall ridership was averaging just twothirds of what it had been prior to the pandemic.

"Some agencies have returned to pre-pandemic ridership levels and above, while others continue to struggle with ridership counts that are one-third of previous totals," the organization says in a new 'strategic plan" it unveiled in December.

The plan "comes at a moment when our industry faces serious existential threats - slow ridership recovery, a fiscal cliff, and a widening workforce gap," Karen King, who chairs the organization's executive committee, said.

The plan makes obtaining more financial support, particularly from the state, its highest priority, citing not only declines in ridership and operational revenue, but the state's mandate that it get rid of its hydrocarbon-fueled buses and replace them with battery-powered vehicles. Transit officials and their supporters didn't like the budget's treatment of transit, particularly a \$2 billion reduction in transit infrastructure. The industry's top legislative advocate, Scott Wiener, a Democratic state senator from San Francisco, pledged to seek restoration of the funds and more money to cover transit's revenue declines.

Wiener said, "We must not let our public transportation systems go over the impending fiscal cliff and enter a death spiral – where budget shortfalls lead to service cuts that lead to ridership drops that lead to further budget shortfalls and service cuts. The state must serve as a financial back-stop against this fiscal cliff to ensure our transit systems survive."

The transit dilemma typifies the conflicts and tradeoffs that permeate the state's hopes for achieving carbon neutrality 22 years hence. As a recent CalMatters analysis of the state's ambitious but tortured plans to rid itself of hydrocarbon-fueled cars underscores, it's one thing to declare such a goal on paper, but it's quite another to make it reality when the precise steps needed are complicated, time-consuming and expensive.



The Importance of a Paper Trail

WEST SACRAMENTO, CA (MPG)

- With the homeless rate astronomically high, the importance of a paper trail has never been greater. The thought of losing your hard-to-find place is overwhelming. The housing shortage and the prices are crazy. How do you protect yourself and when do you have to?

A West Sacramento resident (who asked to exclude her name), who lives in an apartment complex, received a notice on her door of a 3-day pay or quit. In that notice it states that she owes for November, December and January's rent. Friday morning she gathered up her receipts and headed to the office. The notice was placed on her door after 5 p.m. on a Thursday. The office is generally closed on Fridays, and the upcoming Monday was a holiday. She was very concerned about taking care of this within the three days.

When the resident got to the office the lights were on, there were people inside working, but the doors were locked. She knocked on the door and the people inside looked at her, so she was sure they knew she was there. She stood and waited for someone to respond. She waited roughly 20 minutes before

someone came to the door.

At this complex it is mandatory that rent is paid with a money order. She knew she had the receipt stubs for every month. She remembers having to prove already that November's rent was paid, but couldn't remember why. The resident brought the receipts to the complex office and showed them to the manager. She reminded them that she had been in the office twice last month because there was an issue with the rent then as well.

After describing the interaction between the two that took place in December and producing two money order stubs for December, the Manager remembered and said that she would adjust the computer, but that the resident still owed for November. She began looking through her envelope of receipts/ money order stubs but did not see November's. She was absolutely sure that she had paid the

rent and still remembers proving already that she paid November's rent. She told the manager that she would go look through

her paperwork for November's receipt.

As she was leaving the office the Manager told her that even if she finds the money order stub it doesn't prove that she gave it to them or that they cashed it. The Manager proceeded to tell the resident that she would have to prove that they cashed it. The resident asked how she was supposed to do that, the Manager said that if she found the receipt stub, she would have to go to the place where she purchased the money order and have

> them retrieve a copy of the signed, cancelled money order.

The resident went home and within just a few moments she located both October's and November's stubs. They were both dated in October. Suddenly she remembered why she had to prove she had already paid November's rent. The resident had actually paid

November's rent in October due to the fact she was going to be out of town when rent was due. She went back to the office but this time they did not answer the door. The doors have glass windows and it didn't appear that they were on the phone or that anyone was in the office.

Frustrated, she left and decided that she would just see if getting proof they cashed it was even possible. This is not the first time that these kind of issues have taken place in the five years that she has lived there. She learned right away that she needed to hang onto paperwork, as it didn't appear that this practice of questionable bookkeeping was going to change.

So, who do you call when something like this, or other issues occur with your landlord/ manager? If you can afford it, there are of course Fair Housing lawyers. If you have any kind of housing assistance, you can call that program and they can usually fix the issue with a phone call. However, if neither of these options are available to you, there are still a couple of options. If you live in apartments, you can turn to the National Apartment Association at naahq.org. There are also www.hud.gov and www. fairhousingnorcal.org. Both of these organizations can guide you on your specific issue. In addition, if you are a renter, it is always a good idea to have the California Tenants Guide. It can be found at www.courts.ca.gov.

Nothing takes the place of a paper trail. Landlords may have you jump through hoops when they make mistakes. Try to be as gracious when they blunder as you would be when you blunder.



I'm going to be straightforward with you, ok? You and you husband need do the right thing, no matter how dad reacts to this. And the right thing, right now, is taking care of your family first and not putting your finances in jeopardy. If I were in your situation, my answer to dad would be no.

I understand there's a feeling of obligation to help your father. But it sounds like dad needs to learn a lesson or two about life and money. WOODLAND, CA (MPG) - The Yolo County Health and Human Service Agency's (HHSA) Public Health Branch has completed the 2023-25 Community Health Assessment (CHA). The CHA is a report that includes information about the overall health of residents in the county and identifies eleven significant health needs (SHNs). The CHA also contains information about the social determinants of health, such as education and income levels, and how they impact the health of various groups in the county.

The eleven SHNs identified in the 2023-25 CHA are listed below, in prioritized order: 1. Access to Basic Needs Such as Housing, Jobs, and Food; 2. Access to Mental/Behavioral Health and Substance Use Services; 3. Injury and Disease Prevention and Management; 4. Active Living and Healthy Eating: 5. Access to Quality Primary Care Health Services; 6. System Navigation; 7. Access to Specialty and Extended Care; 8. Increased

Community Connections; 9. Safe and Violence-Free Environment; 10. Access to Functional Needs; 11. Access to Dental Care and Preventive Services

The CHA is utilized to help the County, community, and other partners make decisions about how to improve health outcomes for all residents in Yolo County. The CHA is also currently being used to develop the Yolo County Community Health Improvement Plan (CHIP; a roadmap for improving some of the priority areas identified in the CHA over the next 3 years. A multi-sector workgroup of community partners, healthcare agencies, and county residents is currently collaborating with HHSA to develop the CHIP.

State Fast-tracks Groundwater Recharge **Pilot Project to Capture Flood Waters**

SACRAMENTO, CA (MPG) - The Department of Water Resources (DWR) is partnering with the State Water Resources Control Board to fast-track efforts to capture flood waters to recharge groundwater basins. Water captured during extreme wet periods such as the one California is now experiencing will be stored in groundwater basins for use during dry periods.

Governor Newsom's "California Water Supply Strategy, Adapting to a Hotter, Drier Future" calls on DWR and the State Water Board to work with local agencies to significantly expand the State's ability to capture water from winter storms and adapt to more extreme weather patterns caused by climate change. DWR and the board are working together to expedite the regulatory steps necessary to store significant rainfall and excess water underground, while still ensuring protections for the environment and other water users as required in State law.

"The State is capturing more water supply by accelerating groundwater recharge permitting and projects that mitigate the impacts of prolonged drought and support long-term sustainable groundwater management," said DWR Director Karla Nemeth. "Projects that capture available precipitation, stormwater, or floodwaters to recharge depleted groundwater basins need to be ready to capture high flows when they are available during each wet season, typically October through April in California."

The State's efforts reached a milestone January 6 when the State Water Board approved a six-month permit that will enable multiple landowners to divert excess flows from Mariposa creek near the City of Merced to recharge a key groundwater basin. The Merced Project permit, the first approved under a new pilot regulatory assistance program, is expected to pave the way for future projects to allow water from wet-weather storms to be captured and diverted. The permit will cover multiple diversions by multiple landowners in a coordinated fashion managed by a groundwater sustainability agency.

The pilot program began in August 2022 with an application from the Merced Irrigation District and the Merced Irrigation-Urban Groundwater Sustainability Agency to divert and store water from the Mariposa creek. The permit application authorizes diversion of up to 10,000 acre-feet of water from the creek during periods of high flows that would otherwise likely flow through the system. The Merced Subbasin is one of 21 basins in the state of California identified as Critically Overdrafted by DWR.

"The review process for these permits is complex and must consider impacts to the environment and existing water rights, including those dependent on specific Delta conditions and state and federal water project requirements," said State Water Board Chair Joaquin Esquivel. "In

acknowledgement of this complexity, we have streamlined the process so we issue them in a timely way and help local agencies succeed in capturing stormwater for recharge and bringing stressed groundwater basins into balance."

Since 2016, the State Water Board has approved 20 temporary permits. Currently there are five applications pending, with two more projected to be approved next week. The remaining three are going through a public noticing process.

The Merced Project's permit includes multiple points of diversion. Diversions will be directed to a number of agricultural fields to support groundwater recharge consistent with the Merced Subbasin Groundwater Sustainability Plan. Water diverted for recharge purposes will be applied to working agricultural lands only, and water stored will be accounted for in the upcoming growing season as the first irrigation water to be pumped from the

"Merced Irrigation District is excited to partner with DWR supporting GSAs with this crucial pilot project intended to help groundwater basins become sustainable by turning potential flood waters into groundwater recharge opportunities," said Hicham Eltal, Deputy General Manager, Merced Irrigation District. "The project is intended to show that the subsidence being experienced in part of the Merced Groundwater Basin along the San Joaquin River can be addressed while simultaneously reducing recurring flood events from local creeks tributary to the San Joaquin River. The goal is that this effort paves the way for acquiring temporary permits to divert flood flows by GSAs throughout the State to help groundwater basins reach sustainability."

As part of the Newsom's Administration water supply strategy, the State is looking to expand groundwater recharge by at least 500,000 acre-feet in potential capacity. By expediting groundwater recharge projects, the State can help local agencies prepare now to take advantage of future heavy precipitation events. Early pilot project efforts, like the Merced Project, will demonstrate the feasibility of capturing available high flows for groundwater recharge while minimizing flood risks, and provide insight to support further streamlining of this process.

Groundwater basins serve as the state's water savings account and are intended to provide a reliable water source when we have less rain and snowmelt. As weather patterns have become more variable and extreme from the effects of climate change, resulting in more frequent and consequential droughts and high flow events, replenishment of depleted groundwater basins is an essential part of California's long-term water resilience and drought mitigation efforts. Significant expansion of groundwater recharge projects such as the Merced Project will be required to support environment, agricultural uses, and ability to withstand future droughts.

Social Security Matters

What Counts for Social Security's Earnings Limit?

Dear Retired: Generally,

Dear Rusty: I retired on February 1st of this year (2022). I collect a pension from my employer plus a union pension, as well as Social Security, all of which started in February 2022. I am married and I'm 65 years old. I only worked 4 weeks in 2022 before retiring, but my income ended up being far more than expected. I got 5 weeks' vacation pay and a retroactive check from an overdue labor contract. I also got hazard pay and a small check for a class action lawsuit my union filed years ago. All of that brings my 2022 income to about \$35,000 which means I have exceeded what I can make as far as Social Security goes. My question is, should I contribute some money to my IRA to offset my earned income? And is it even possible for me to do that? Signed: Retired but

income earned before starting your Social Security benefits (such as accumulated vacation pay) doesn't count toward Social Security's earnings limit for those who have not yet reached their full retirement age (FRA), nor do your earnings from working in the 4 weeks of 2022 before your SS benefits started. Similarly, the check for retroactive labor contract benefits, hazard pay for past work, and income from the class action suit do not count toward Social Security's earnings limit. The only thing that counts towards the limit is earnings from working after your Social Security benefits started, which you apparently did not do. Thus, from what you've shared, you should not be subject to any impact to your monthly SS benefits as a result of your total 2022 income. Note, you may still get an inquiry from Social Security next year about your 2022 earnings, but only earnings from actually working after your Social Security benefits started (which you did not) would count toward Social

Security's earnings limit. You may, however, wish to consult with a qualified tax advisor because some of your Social Security benefits received in 2022 will be subject to income


tax on your 2022 tax return. Assuming you file your tax return as "married/jointly," if your combined income from all sources exceeded \$32,000 then 50% of the SS benefits you received during the tax year will become part of your overall taxable income; and if your 2022 combined income from all sources (including your wife's income) exceeded \$44,000, then up to 85% of your SS benefits received in 2022 will become taxable income. A tax advisor can give you more information on that, and also help you decide if it would be wise to contribute to an IRA. But, in any case, contributing to an IRA will not affect your monthly Social Security benefit.







SACRAMENTO, CA (MPG) - After a series of severe damaging storms and with more wind and rain expected to impact California, the Contractors State License Board (CSLB) is reminding homeowners to use licensed contractors for any construction repairs above

After a disaster, CSLB's mission is to help ensure unlicensed or unscrupulous contractors do not take advantage of consumers.

Homeowners should use CSLB's Find My Licensed Contractor feature

to build personalized lists of licensed contractors in their area. They should always check all contractors' license numbers on the CSLB website and check each contractor's pocket license to confirm the person representing the construction business is listed as personnel of record on the license. A CSLB-issued state license is required for any construction job of \$500 or more (labor and/or materials).

"Disaster survivors take a huge risk when they hire unlicensed contractors," said CSLB Registrar David Fogt. "Most are not properly insured and likely don't have the skills or knowledge to perform the work."

Homeowners should be aware that CSLB offers a designated Disaster Help Center section online, which provides publications that can be downloaded or ordered. These include "Debris Removal and Construction Scams," "After a Disaster, Don't Get Scammed," and "What You Should Know Before Hiring a Contractor." In addition, information can be requested by calling CSLB's Disaster Hotline, 800-962-1125, staffed Monday through Friday from 8 a.m. to 5 p.m., or via the automated assistance line, 800-321-CSLB (2752).

Californians seeking information about the state's response and recovery efforts should visit the California Governor's Office of Emergency Services (Cal OES) website.

About CSLB: CSLB operates under the umbrella of the Department of Consumer Affairs and licenses and regulates nearly 285,000 contractors in California. In 2022, CSLB helped consumers recover more than \$40 million in ordered restitution.

government seeps into every crack of your life, blocking the exercise of what you can eat, what house you build, what car you drive, how much you keep of the money you earn, down to such trivialities as what drinking straws you can get in a restaurant. Do you feel as though you personally need government monitoring your straw usage, or is that a decision you are competent to make as an adult? Florida trusts you to choose your own straw, California does not.

The California government mindset drives up costs in every area of living. Looking at taxes alone doesn't tell a complete story of government-imposed costs. How many taxes would have to move lower to make up for policy-driven expenses in California? Would a one-percent decrease make up for gas that's two-dollars-a-gallon higher than the national average? Would slightly lower sales taxes offset electricity costs 80-percent higher than the national average? Exactly what tax would offset the cost of an \$800,000 starter home, driven in part by extraordinary regulatory costs in our state?

California will always be desirable for the wealthy. I defy another state to produce a Yosemite, a Golden Gate, giant redwoods, Lake Tahoe, Big Sur, Santa Monica beach... the list of our wonders is long, if you can afford to enjoy them. But our unmatched beauty is apparently overwhelmed by policy failures of colossal dimension. People are voting with their feet and moving.

It says so much about our government's misguided agenda that hundreds of thousands of people last year abandoned everything this state has to offer because of everything this state takes away. It's time for an affordability revolution in California to turn us once again into a destination state.
