

Flooding Continues

SACRAMENTO REGION, CA - Raising questions about whether California's elaborate system of flood protections will hold, another dangerous storm is barreling toward the Sacramento Valley, where rains already punched through some levees and floods killed at least one person.

Last weekend's storms have already tested the flood-prevention infrastructure across the region, which sits at the confluence of two major rivers and bears the brunt of heavy rains. "It's a bathtub, basically," said Beth Salyers, deputy district engineer for the federal Army Corps of Engineers in Sacramento.

An estimated 1.3 million people and \$223 billion worth of property in the Central Valley are protected by the state-federal systems of levees, dams and other structures.

California spends \$48 million annually for operating flood protections but needs much more - "\$3.2 billion over the next five years of implementation," according to the state's Central Valley Flood Protection Plan, a document produced in 2012 and updated last month. Of that, the state's responsibility ranges from \$1.8 billion to \$2.8

An estimated \$25 to \$30 billion in funding over 30 years could help the catastrophic flooding in the Central Valley estimated to be as high as \$1

trillion, in addition to an incalculable toll on lives and public well-being," the plan says.

So far, this winter's storms have been severe but not catastrophic: The New Year's Eve storm "stalled out" over the watershed of the Cosumnes River. Portions of privately owned levees on the river gave way, flooding nearby areas. The levees, constructed to reclaim the land for agriculture, are generally rated only to handle a 10-year flood, according to Sacramento County officials. The breeching of the levees shut down Highway 99 and stranded motorists.

Traffic Stopped for Governor's Walk

WEST SACRAMENTO, CA (MPG) - Traffic was stopped at 5th St. and Tower Gateway, near Sutter Park, and rerouted to the I Street bridge on the morning of Friday, January 6, as many gathered to walk across the Tower Bridge with

Governor Gavin Newsom. Supporters for the Governor waited behind barricades and temporary fences for Newsom and his family to make their entrance. Crossing was not allowed on the bridge and the area was lined with West Sac Police, California Highway Patrol and Secret Service to ensure that even

pedestrians were directed to the I Street Bridge.

Among the roughly 200 people waiting to walk in support of the Governor were Lt Governor Eleni Kounalakis, a large group of legislators, and the River City High School Drumline. Governor Newsom enjoyed the drumline performance

during the Christmas Tree Lighting ceremony and invited them to be a part of the activities.

Also included in the crowd were members of the Carpenters Union, both North and South. Nor Cal Carpenter Union Executive Officer Jay Bradshaw explained why Continued on page 2

Preventing Crime in Your Neighborhood

WEST SACRAMENTO, CA (MPG) - Neighborhood Watch is a program that has an ugly history of why it began in the United States, but since the 1970s it has developed into a very beneficial program that brings neighbors and neighborhoods together, which in turn makes your community a safer place to live. It is a program where the average citizen lends a hand to their neighbors.

We're all aware of how West Sacramento continues to grow and yet our Police Department and Fire Department are not. That means that we need to step up and help out. West Sacramento is built on the strength of our community members. Those community members become stronger when they work together.

The best way to fight crime is to prevent it. The Crime Triangle identifies three factors that create a criminal offense. Desire of a criminal to commit a crime; Target of the criminal's desire; and the Opportunity for the crime to be committed. You can break up the Crime Triangle by not giving the criminal the opportunity to commit the crime. This could include simple things like locking your doors or not leaving highly desired items in plain view when left unattended. It can also be more structured and more effective by using programs like neighborhood watch.

'I'm no snitch' is a common phrase when talking to some about neighborhood watch. However, don't you want your neighborhood safe? What if it is one of your family or friends? Would you want someone to step up and give a description? Neighborhood Watch is not expecting you to watch everyone's neighborhood, it's just a way to watch out for your neighbors and know that they'll watch out for you.

Sac State and Street Soccer USA to Host 18th Homeless World Cup

SACRAMENTO, CA (MPG) -The Homeless World Cup (HWC) street soccer tournament, in its 20th anniversary year after a three-year pandemic interruption, will be played at Sacramento State July 8-15, 2023.

The event will be in a U.S. city – and on a college campus – for the first time. Cardiff, Wales, was the host city the last time the tournament was held, in 2019. Previous tournaments have been in Europe, Australia, South America, and Africa. The event traditionally draws thousands of spectators.

The tournament, first played in 2003 in Graz, Austria, is the landmark street soccer event presented by Homeless World Cup Foundation, an umbrella organization for a network of charities that conduct year-round street soccer programs for men, women and children experiencing homelessness.

Sacramento State President Robert S. Nelsen said the University's role as tournament host is another example of its commitment to "building deep and meaningful connections in our community and beyond."

"I am proud that we will host the Homeless World Cup in 2023, and I look forward to welcoming athletes from around the world to the Sacramento State campus," Nelsen said. "This event will reimagine the conversations surrounding the global issue of homelessness while transforming

well as the spectators." Up to 64 HWC partners from around the world will participate, featuring hundreds of players who are experiencing homelessness. Matches will be

the lives of the athletes as

played on three street soccer fields set up in Hornet Stadium. The playing areas are smaller than traditional soccer fields and enclosed, leading to fast-paced, continuous action.

University residence halls will provide housing for players during the competition.

Street Soccer USA, a national nonprofit working in more than a dozen US cities, is HWC's American partner and features a robust program in Sacramento led by Sac State alumnae Tiffany Fraser and

Lisa Wrightsman.

"These players are people deserving of respect," Wrightsman said. "They're not out there playing for money or cars. They are people who have very little in their lives, and they're working hard, and smiling, and lifting one another up. I hope that people watching them are able to appreciate that."

Lawrence Cann, co-founder and president, Street Soccer USA said hosting the Homeless World Cup for the first time in the United States is a signal of Street Soccer USA's ambition to drive social impact through soccer at scale and from the bottom up.

"Be prepared to feel the true power of teamwork and community before, during, and after this one-of-a-kind event," Cann said.

"The Homeless World Cup places those across the world who are most in need at the very center of our attention and showcases not their challenges, but their abilities and humanity. We are grateful to the leadership of Sacramento State and proud to partner with them to bring this event and its legacy to the California capital."

Mel Young, Homeless World Cup president and co-founder, said the tournament shows how sport can change lives while illustrating HWC partners' commitment to the work of ending homelessness.

"Everyone at the Homeless World Cup, our global Member Countries and our loyal supporters are delighted that Sacramento State and the city of Sacramento will be our host

Successful First Fighting Fentanyl Campaign

WEST SACRAMENTO, CA (MPG) - West Sacramento father, Rick Brazil, organized the first Fighting Fentanyl event on Saturday, January 7th at Muscle Systems Gym. This was the first time that Rick has ever done something like this, but he was willing to learn what it takes for the sake of the message advanced.

Rick's 22-year-old son, Mason Brazil, passed away from fentanyl poisoning in the spring of 2022 so Rick decided to hold the awareness campaign in the same gym they used to train in MMA style fighting.

"We started training to get out some teenage aggression," said Rick, "but then from there it became a place where we could talk, and it brought us even closer than we were before."

Training for both was almost every day, and Rick will forever hold the memories shared with his son deep in his heart.

Mason had enough fighting skill that he had competed in a few matches, but he also loved to share with others his many talents - such as his love for music. In fact, he has several rap songs on YouTube.

The father explained that his mission through this event was to bring awareness about how much fentanyl is in our town and that just one pill can kill an unsuspecting victim.

"We have to get the word out on the street that these pills all look the same, and one pill can kill," he said. "They (victims) do not choose to do this. This is not what they mean to do and not what they think they are taking."

Rick is a well-known figure in the West Sacramento community as a little league coach of many years. He says that he knows everybody's kids and wants them to know that Mason was a good man, his best friend, and he didn't mean to do this. He wants everyone to talk to their kids and make sure they know what's going on.

In addition, there were also two speak-

ers featured besides Rick.

WSPD Chief Rob Strange spoke saying that he was sad to be speaking on the back of Mason's tragic death, but that the community needs to come together on this matter. He said that everyone in the room probably knows someone that means a lot to them who is afflicted with an addiction of some sort.

Strange believes those with an addiction can beat it, rebuild their relationships as well as regain hope and that the only way to get them on that pathway is to normalize talking about it.

"Last year alone, we lost 16 West Sacramentans to overdose deaths," said Chief Strange. "The highest number we've had in the last five years by 25 percent."

Strange finished by thanking Rick for the event and said he was honored to speak as a member of the West Sac community.

Deputy District Attorney, Preston Schuab, spoke next. Preston is the West Sac Community Prosecutor, meaning he lives in West Sac and is the liaison between the DA's office and WSPD when there are problems in the community.

"Besides homelessness, I cannot think of any bigger problem than fentanyl in West Sacramento right now," said Preston.

Prior to COVID in 2018, fentanyl was not on anyone's radar, being that it was strictly in hospitals and used for pain relief by the microgram. In 2019 there was one death in Yolo County from fentanyl. In 2020 there were 8, in 2021 it was 13 and last year it was 28.

"By the time 2022 rolled around fentanyl deaths made up about 2/3 of our overdose deaths," Preston said, "And that matches up with the nation."

The DA Deputy's message was clear. Things are getting worse and will continue to get worse. Nobody can do this alone; community members must come together to share their knowledge and resources and tackle this. There must be open and honest communication about

The Fighting Fentanyl campaign provided literature explaining how easy it is to get the ingredients and supplies to make the fake pills. Fake Xanax, Oxy, and Percocet are made of fentanyl. Fake Adderall is made from methamphetamine. Furthermore, the literature stated that you must assume all M30s are fakes. Picture two grains of sand. That's how much Fentanyl it takes to kill you.

Free Fentanyl Test Strips were offered, and they can be obtained through Health and Human Services as well. During the presentations, Habitat for Humanity provided healthy snacks and Low Cost Liquor provided Gatorade and water.

Naloxone, or NARCAN, is a nasal spray and is the only thing that can reverse a fentanyl overdose. It can be found at schools, police departments, medical facilities and many other places.

Also available were cards that can be sent in for free NARCAN. However, during an overdose, individuals cannot self-administer the medicine. It is, therefore, advised to tell others around you so that if you need it, they know it's there. Additionally, it often takes more than one dose to reverse the effects – perhaps 5 or

How Environmental Law is Misused to Stop Housing

It's well known that the California Environmental Quality Act, signed by then-Gov. Ronald Reagan in 1970 and meant to protect the natural environment in public and private projects, is routinely misused to stop or delay much-needed housing construction.

Anti-housing NIMBYs in affluent communities misuse it to stymie high-density, multi-family projects, arguing that their neighborhoods' bucolic ambience would be altered. And construction unions misuse it to extract wage concessions from developers.

It's a long-running civic scandal and a major factor in California's chronic inability to reduce its severe housing shortage, one that cries out for CEQA reform, which former Gov. Jerry Brown once described as "the Lord's work." But neither Brown or any other recent governor has been willing to take on the task, which would mean confronting environmental groups and unions, two of the Democratic Party's major allies.

In the absence of comprehensive reform, governors and legislators sometimes grant CEQA exemptions for particular projects, such as sports arenas, or narrow categories of housing. However, CEOA misuse continues venues for battles over its application.

Two recent state appellate court actions in the crowded San Francisco Bay Area one expanding the use of CEQA by those who oppose housing projects and another that restricts its use – underscore the law's chaotic role.

Just before Christmas, one panel of the First District Court of Appeal issued a preliminary ruling that could open a new avenue for using CEQA to halt projects. It declares that a University of California student housing development in Berkeley violates the law because UC didn't consider the impact of having more people – 1,100 students - in the neighborhood, citing the potential of late-night parties and other gatherings that could worsen a "persistent problem with student-generated noise."

In other words, the court said that the presence of more people is an environmental impact – a novel theory that could hand anti-housing groups everywhere a potent weapon.

As UC law professor Chris Elmendorf tweeted about the draft decision, "The court's reasoning is devastating ammunition for racist white homeowners who would leverage CEQA to keep poor people and minorities out of their neighborhoods."

For example, he continued, "using the court's statistical-associations logic, white homeowners could argue that CEQA requires affordable housing developers to analyze and mitigate putative project in an affluent neighborhood. The homeowners would point to statistics newspapers.

and the courts have become showing that poor people, and African Americans and Hispanics, are statistically more likely than affluent people and whites to be victims of gun violence."

A few days later, another panel of the same appellate court rejected efforts by a group opposing a 130unit project in downtown Livermore, called Save Livermore Downtown, to employ CEQA. Attorney General Rob Bonta had interceded in the case, supporting the city's approval of the project and its win in Superior Court.

"Timing is critical for affordable housing projects, which often rely on time-sensitive funding sources like tax credits to finance development," Bonta said while intervening, adding, "Our state is continuing to face a housing shortage and affordability crisis of epic proportions. CEQA plays a critical role in protecting the environment and public health here in California. We won't stand by when it is used to thwart new development, rather than to protect Californians and our environment."

After the appellate court action, Bonta tweeted, "CA's housing crisis is dire. We won't stand by and let people misuse our laws to avoid being part of the solution."

The outcomes of both cases underscore the need for a fundamental CEQA overhaul to reinstate its original purpose, rather than continuing wasteful project-by-project skirmishes.



Every winter, when temperatures start to drop, people start having various health problems. Nobody ever thinks it will happen to them, but sickness and death are a real threat with severe temperature changes. Maybe it won't be you, but what if it's someone you love that gets stranded in the snow? It doesn't even have to be

Hypothermia can set in at temperatures as high as 40°F. As a result of getting wet from rain, sweating, or being submerged in water for any reason, due to the cold, hypothermia can set

in. When exposed to cold temperatures, the body loses heat faster than it can produce it. This will eventually use up the body's stored energy, which will in turn lead to lower body temperatures.

When the body's core temperature descends too low, it begins to decrease brain activity thus causing the victim's thinking abilities to be diminished. Additionally, low temperatures also slow down physical mobility, which makes hypothermia even more dangerous, causing an individual to often times remain unconsciously in the cold for even longer periods. The most common victims

of hypothermia are older adults with inadequate food, clothing or heat, and babies sleeping in cold bedrooms. Individuals who spend long hours outdoors like the homeless, hikers and hunters are also at risk. Those using alcohol or illicit drugs are at high risk as well since their senses are already dulled.

Some of the signs of hypothermia for an adult are as follows: shivering, exhaustion or feeling very tired, confusion, fumbling hands, memory loss, slurred speech, and drowsiness. For babies – look for bright red skin, cold skin and very low energy. If you are concerned someone may be hypothermic, DON'T

WAIT. Hypothermia is a medical emergency. If you notice any of the above signs, take the person's temperature. If it is below 95 degrees, get medical help immediately.

If you are unable to get medical assistance right away, try to warm the person up. Get the person into a warm space. Remove any wet clothing. Warm the center of the person's body – chest, neck, head and groin – using an electric blanket if available. If one is not available, use skin to skin contact under loose, dry layers of blankets, clothing, towels or sheets. Warm drinks can help but no alcohol

Even people that are not headed to the snow should have a winter kit in their car because you just never know what will happen. It may not be you who ultimately needs it. You may save someone's life. Keep a kit in your car that includes blankets, extra socks, juice and water. Other tips include keeping your gas tank full so that no ice forms in the gas tank or lines. Make sure your antifreeze levels are correct and keep extra containers of the fluid in your trunk.

Remember to weatherize your home and to bring your pets inside. Hypothermia can affect animals just as easily. Stay safe and be smart.



Our next-door neighbor was an older single man with no family, and

my wife and I always tried to look out for him and help with things. He died recently, and in his will, he left us his home, his car and the money he had in his bank account. The will was handwritten, and it said the house was worth around \$350,000, with \$150,000 left on the mortgage. The car is worth about \$10,000. Officials at our county office building said the money in the bank account wouldn't have to go into probate since I was listed as the beneficiary, and I was given a check for that amount. We've just never handled anything like this before, and my wife and I were hoping you would help us navigate things.

-Steven Dear Steven,

There are a couple hundred thousand dollars in equity involved here. The fact that the will is handwritten doesn't necessarily invalidate it, but it does increase the possibility of encountering some bumps down the road.

I'm not a lawyer, so the first thing I'd do is talk to a couple of probate attorneys in your county. Find out what they'd charge to handle things. I wouldn't spend thousands of dollars to get this done, but I would pay \$500, maybe \$1,000, to let someone who knows what they're doing handle things. If your county affairs people are right and everything's easy and straightforward,

it's not a lot of legal work for an attorney.

On top of that, if the attorney you work with knows folks at the courthouse and is familiar with how things work there, then it's kind of like traffic court, you know? It's almost automatic. I mean, we're only talking about three assets here — a bank account that's already been handed off, a car and a house that's mortgaged. For me, it'd be worth a little money to have someone on my side who knows the path through the woods.

WOODLAND, CA (MPG) - On November 17, 2022, Jovan Jones, a 29-year-old resident of Elk Grove, CA, was arraigned in the Yolo County Superior Court for sale and transportation of fentanyl.

On November 15, 2022, at 8:40 a.m. Davis Police Officers were dispatched to a person who was "passed out" in his vehicle at the Chevron Gas Station in Davis, CA.

on charges of possession Davis police stopped the driver as he was leaving the gas station. The driver was identified as Jovan Jones who was on probation in Sacramento. A probation search revealed over 47 grams of presumptive fentanyl and over 78 grams of marijuana

suspected of being mixed with fentanyl, as well as assorted drug paraphernalia. Jones was arrested and booked into the Yolo County Jail on charges of 11351 H&S Possession of Narcotics for Sales, and 11352 H&S Transportation of Narcotics.

At his arraignment, Jones pled not guilty to the charges. Judge Samuel McAdam set bail at \$20,000. A preliminary hearing was scheduled for December 5, 2022, at 9:00 AM in Department 8.

'BABYLON' A DEPRAVED, DEBAUCHED SLOG; EPIX BECOMES MGM+

A Film and TV Review by Tim Riley

"BABYLON" A DEPRAVED. DEBAUCHED SLOG

In the Paramount Pictures production notes for "Babylon," this epic film is described as a tale of outsized and outrageous excesses that traces the rise and fall of multiple characters during an era of "unbridled decadence and depravity in early Hollywood."

This description of the period in 1920s Los Angeles is on the mark as well as oddly candid for the usual adulatory promotion that oozes out from a studio's publicity machine. In fact, absorb the idea of rampant decadence and depravity as a warning.

From the beginning moments when an elephant defecates on a worker transporting the animal to the debauched party set for that evening at the mansion of a Hollywood mogul, you should know it's not the only grotesquerie that awaits.

The party scene introduces the primary characters whose lives will intersect in different ways as the silent film era transitions to the talkies. The top star is dashing Jack Conrad (Brad Pitt), who evokes the likes of Douglas Fairbanks, John Gilbert and Rudolph Valentino.

Jack arrives at the party with his soon to be ex-wife Ina (Olivia Wilde) and partakes in so much alcohol that he needs a ride home from Manny Torres (Diego Calva), a wide-eyed dreamer desperate for a spot in the film industry.

As a Mexican-American outsider, Manny needs all the help he can get for a break, but a series of circumstances will find him reaching the upper levels of studio management.

Another partygoer is Margot Robbie's free-spirited Nellie LaRoy whose rise to stardom will be marred by her gambling addiction and inability to maintain a sense of dignity and poise in certain social

Intriguing minor characters include Jean Smart's gossip columnist Elinor St. John, Tobey Maguire's creepy gangster and Eric Roberts as Nellie's dodgy money-grubbing father who fights rattlesnakes. Writer and director Damien Chazelle ("La La Land") spent years researching the darker side of the story of the shift from silent film to the talkies, and what he delivers in his film causes one to wonder what was his target audience.

"Babylon" revels in the depraved, hedonistic folly of the movie business in a way that will disturb many. The opinion of the critics as well as the audience seems to be split, at least according to Rotten Tomatoes.

In my view, "Babylon" is a three-hourplus slog that is such a struggle to endure that if it had an intermission the temptation would have been to leave and cut my

WSPD claims that the best crime-fighting tool ever invented is a good neighbor. With the Neighborhood Watch program neighbors are taught how to work with law enforcement, what to look for and how to report a crime. It includes when the report should go to law enforcement and when it goes to other agencies. They teach you when you should call 911 (when a crime is occurring

should call the non-emergency dispatch number (if the crime has already happened and there is no medical attention needed or threat of return by suspect). The program also teaches you what types of things you should report to West Sac Connect.

Most importantly, it's a good way to meet and get to know your neighbors. Once that happens you'll find that it is a good way to get reports on what crimes or incidents are taking place in your neighborhood so that you can protect yourself. At the meetings, you are introduced to neighborhood watch apps, taught strategies. In addition, many insurance companies will reduce your rates when they know you are part of

"The investments we've made to the flood system have absolutely helped," said Gary Lippner, the Department of Water Resources' deputy director of flood management and dam safety. "At the larger scale, our system is much more ready for high-water events."


The Central Valley has a long, painful history of deluges: The Great Flood of 1861-2, triggered by weeks of rain and snow, is still remembered as the worst disaster to ever befall California, inundating the entire valley, killing thousands of people statewide and devastating the economy.

The state's capital city was built in a floodplain and requires an extensive system of dams and levees to protect it. Even now, federal, state and local authorities are in the midst of upgrading those defenses, particularly in the Sacramento region, where multiyear, multi-billion-dollar projects are underway.

Major improvements have been made in the region and more are underway, thanks to about \$1.8 billion in state and federal funds. The Army Corps and state have been upgrading about 45 miles of levees over a 5-year period, and work on the final 2.8 miles is scheduled to begin in the spring.

Among the structural upgrades are raising levee heights, boring as deep as 150 feet to reinforce levees to prevent seepage and piling rocks on riverbanks to reduce erosion

the current situation. We are not seeing flooding off these rivers," Salyers said. The completed projects are now weather-tested, she said, and "performing the way we wanted them to."

State officials expressed confidence that the Central Valley's levees and bypasses will contain the deluges coming tonight and next week.

"We do have a significant amount of capacity within the bypass system in that 1,600 miles of levee, and I don't anticipate ... there to be emergency management needs," Lippner said.

But every flood-protection system has its limits.

Michael Anderson, a climatologist with the California Department of Water Resources, noted that impacts from the upcoming storm system could escalate to a "worst-case scenario" if it "becomes an unrelenting series of storms."

Forecasters are warning residents in the Sacramento region and the Bay Area to prepare today and Thursday for yet another assault, this time from a "bomb cyclone" spinning in the Pacific that will not make landfall but will amplify rain, wind and frigid temperatures along the coast and foothills.

Forecasters are expecting more atmospheric rivers — the powerful streams of tropical moisture that deliver most of California's winter rainfall.

In the mountains that supply California's reservoirs, snow levels are now above average. The Department of Water Resources' first snow survey of the season took place on Tuesday at Phillips Station, in the Sierra Nevada, west of Lake Tahoe. Scientists measured 55.5 inches of snow and a snow water equivalent of 17.5 inches. That's 177% of average for this location. Statewide, snowpack levels are at 174% of average for that date.

Statewide, this is the best start to the snow season in 40 years, according to Department of Water Resources officials.

It would be hasty, though, to assume the ongoing storms and wet forecast mark an end to the prolonged drought. In 2021, record rains and heavy snowfall arrived between October and December. Then, California experienced its driest January-through-March — typically the state's wettest months — in recorded history.

Experts say consecutive storms are made more dangerous by an already-soaked landscape's inability to absorb more water. In addition to creating swollen creeks and mudslides, incessant rain reduces soils' ability to hold vegetation, and California's millions of drought-ravaged trees can easily fall over. Areas with wildfire burn scars are at risk of flash-flooding, officials said.

The state has established emergency shelters in Sacramento and San Mateo Counties and has stockpiled 3.7 million sandbags.

The flood board updated Central Valley Flood Protection Plan, released last month, warns of "1,000-year storm events ... and the need to act with renewed urgency and purpose before the next large flood event occurs in the Central Valley."

The plan calls on naturebased solutions, like restored floodplains, and infrastructural improvements, like fortified levees near urban areas, to help reduce the impacts of higher-energy storm systems expected as a

result of the warming climate.

Most of the historic floodplains along the Central Valley's rivers have been separated from the water by levees. Scientists now say that restoring floodplains can be an effective flood control strategy by allowing surging rivers to spill their banks and shed their energy on unpopulated flatlands, rather than bursting through aging levees surrounding populated areas. Floodplains also provide fish and wildlife habitat and serve as groundwater percolation beds.

"It takes a lot of time for that water to find a way out," said Mark Dickman, associate director for data at the U.S. Geological Survey in Sacramento. "There's just nowhere for it to go."

It's a persistent and familiar challenge: What to do with water when there's too much and how to manage when there isn't enough.

"We are built for this," said Jeffrey Mount, a water specialist at the Public Policy Institute of California. "We built the system around the notion that we get occasionally wet years and mostly dry years. But, unlike the Colorado River Basin, where they can capture and control four years of runoff, we are full after one year. Our ability to store surface water is limited.

The ongoing rains are already boosting California's water storage system. Major reservoirs are rising, some rapidly. Folsom Lake was 29% full on Dec. 20, and as of Jan. 2 it jumped to 61%. The much larger Lake Oroville jumped from 29% to 38% in the same window — an increase of more than 300,000 acre-feet.
