#### SACRAMENTO, CA (MPG) -

The California Department of Public Health (CDPH) this week warned school leaders about a new and concerning "rainbow fentanyl" drug that may interest youth. In a letter to superintendents and charter school administrators, CDPH Director and State Public Health Officer Tomás J. Aragón warned that "rainbow fentanyl" is a potentially fatal drug found in pills and powders in a variety of bright colors, shapes and sizes that

YOLO COUNTY, CA (MPG) - On September 17, the Yolo County Office of Education (YCOE) held a COVID-19 vaccination clinic at their main administrative building, located at 1280 Santa Anita Ct. in Woodland. The five-hour clinic was held in partnership with Yolo County and First 5 Yolo.

The drive-thru clinic was one of the first local vaccine clinics to offer the new bivalent booster. In

Department of Public Health provided a taco truck," said YCOE public information officer Anthony Volkar. "We were also fortunate to have cooler temperatures and be able to offer a drive-thru format. For all those reasons, we had a great turnout throughout the day."

On August 31, the U.S. Centers for Disease Control and Prevention (CDC) and the U.S. Food and Drug Administration (FDA) provided emergency use authorization for the new bivalent booster, also referred to as the "updated booster". The booster has been revised to strengthen protection against the original COVID-19 strain, while also targeting the newer, dominant variants of Omicron that have spread so rapidly this summer.

Yolo Food Bank Names New Executive Director

The bivalent booster is a single dose vaccine that can be given at least two months after the initial two doses of the Pfizer and Moderna vaccines, or after a single dose of the Johnson and Johnson vaccine, or two months after a booster shot from the original vaccine.

For those seeking the new bivalent booster, the state's MyTurn registration system (myturn.ca.gov) allows individuals to make appointments or locate a walk-in clinic. Yolo County is also continuing to host weekly vaccine clinics on Thursday at 500 Jefferson St. in West Sacramento and Fridays at 137 N. Cottonwood St. in Woodland. You are advised to confirm the clinic time on the Yolo County website or on Yolo County social media.

"The vaccine clinic was truly a family-friendly event. Volunteers were distributing teddy bears to children in attendance. The California could attract young people.

"Rainbow fentanyl can be found in many forms, including pills, powder, and blocks that can resemble sidewalk chalk or candy," said Dr. Aragón. "Any pill, regardless of its color, shape, or size, that does not come from a health care provider or pharmacist can contain fentanyl and can be deadly," he said.

In its letter, CDPH points to a recent warning from the United States Drug Enforcement Agency that notes the highly addictive and potentially deadly "rainbow fentanyl" has been found in at least 18 states.

Anyone who encounters fentanyl in any form should not handle it and should call 911 immediately.

Recognizing the signs of opioid overdose can save a life. Here are some things to look for:

Small, constricted "pinpoint pupils"; Falling asleep or losing consciousness; Slow, weak, or no breathing; Choking or gurgling sounds; Limp body; Cold and/or clammy skin; Discolored skin (especially in lips and nails).

It may be hard to tell if a person is high or experiencing an overdose. If you aren't sure, treat it like an overdose. Here are the steps that could save a life: 1) Call 911 immediately; 2) Administer naloxone, if available; 3) Try to keep the person awake and breathing; 4) Lay the person on their side to prevent choking; 5) Stay with the

WEST SACRAMENTO, CA (MPG) - Construction is underway on Jefferson Blvd for the large apartment complex that is being built on Jefferson Blvd. Right around the Lake Washington Blvd area is where the project is taking place.

The City received a design review application from American Capital Group in December of 2018 for a 292-unit multifamily project at 2301-2425 Jefferson Blvd. The site is located along the east side of Jefferson Boulevard, south of Gateway Drive and

north of Lake Washington Boulevard. The Clarksburg Branch Line Trail is on the eastern side of the site and a Reclamation District 900 canal on the south side.

The application was reviewed for conformance with the zoning requirements in effect at that time which permitted multifamily by right on this property. After public noticing was completed, the project received design review approval determining it was in conformance with the Southport Framework Plan and Design Guidelines as well as the General Plan on October 2, 2019.

The applicant subsequently requested and received a Zoning Administrator minor modification to the project on May 6, 2020, for modifications to the site plan and unit count after public noticing was complete. The modification increased the number of units to 322 and condensed the number of buildings on the site from sixteen down to six such that the units are in fewer but larger buildings. The complex will be named Kinectat Southport/ Jefferson apartments.

# **Building More Apartments** Residents Encouraged to Purchase **Food from Permitted Food Facilities**

#### Yolo County News Release

WOODLAND, CA (MPG) - The Yolo County Environmental Health Division (Environmental Health) urges residents to purchase foods from permitted food facilities and avoid buying food from unpermitted street food vendors. Eating foods purchased from unpermitted food operators may cause foodborne illnesses, such as vomiting and diarrhea.

Food facilities - restaurants, markets, and mobile food trucks and carts - are permitted and regulated by Environmental Health. Environmental Health Specialists inspect permitted food facilities for safe food handling and employee hygiene.

Consumers can determine if a food facility is permitted in several ways. In addition to a prominently displayed health permit, fixed food facilities and food trucks have a color-coded placard. The placards are green (for 'pass'), yellow (for 'conditional pass,' or red (for 'closed'), and must be displayed at the entrance of the food facility or another approved prominent location. Permitted food trucks and push carts will also have a permit sticker. Find the most recent results of inspections on Environmental Health's website.

Unpermitted street food operations are unsafe because they are not regulated or inspected by Environmental Health. Grocerv carts used as makeshift food carts and tents or tables set up in a parking lot (e.g., pop-ups) are examples of unpermitted street food vending. These operations cannot be permitted for several reasons, including a lack of handwashing and toilet facilities and foods that may have been made or stored in unsanitary conditions.

Preparing and selling

most types of food made at home is not allowed in Yolo County. Selling food without a valid health permit can cause consumers to become ill and is an unfair business practice. Operating without a valid health permit can result in fines, penalties, and prosecution.

Environmental Health has seen an increase in illegal street vending complaints throughout the county. Inspectors will respond to complaints about unpermitted street food and require vendors to cease operation and obtain a permit.

# **Rural Community Receives Award** to Fix Drinking Water System

WOODLAND, CA (MPG) -On August 22, 2022, the California Department of Water Resources announced the Madison Community Services District will receive a \$3.8 million award to help rehabilitate the 60-year-old drinking water system in the rural town of Madison, located in Yolo County. The funding will help replace the existing water distribution system to ensure the community has a reliable supply of water during current and future droughts. Yolo County partnered with the Madison Community Services District (CSD) to submit the grant since the CSD has limited staff and funding.

"Yolo County is dedicated to partnering with local districts to help ensure

our small rural communities have a safe and reliable source of drinking water," said Angel Barajas, Chair of the Yolo County Board of Supervisors. "We are grateful to the State of California for recognizing Yolo County and the community of Madison's need for financial assistance for this important work."

Madison is a disadvantaged community of approximately 560 permanent residents and 300 seasonal farmworkers. Since Yolo County directs growth to cities to protect agricultural land and encourage compact development consistent with state land use planning principles, small rural communities such as Madison need additional resources to support critical public infrastructure. The aging Madison community water system lacks an appropriate structural

foundation and does not meet fire standards. The poor construction results in frequent fractures in the system, seriously disrupting the community's water supply.

Yolo County will continue to work with the Madison Community Services District to secure the remainder of funding needed for the \$7.1 million project from other sources. Yolo County is currently working with other small communities to apply for funding to improve water supply and quality. Earlier this year, the Yolo County Office of Emergency Services received \$559,500 from the Small Community Drought Relief Program to implement a dry well assistance program.



products to all customers regardless of age, lawmakers named it the "Stop Tobacco Access to Kids Enforcement Act." They claimed it was needed to stop underage tobacco use - because only kids, apparently, like flavor. To be sure, no one wants children smoking or vaping, but it's already illegal in California to sell or give tobacco and vapor products to anyone under the age of 21. If prohibition worked, then we

wouldn't have a problem. It's also immensely hypocritical. At the same time California is lowering taxes on marijuana and debating bills in the Legislature to decriminalize psychedelic drugs, it is placing bans on menthol cigarettes, flavored smokeless tobacco, and other flavored nicotine vaping products that don't even contain tobacco. Those non-tobacco vaping products, mind you, were determined by an "expert independent evidence review" published by England's public health agency to be "95% safer" than smoking.

Plus, Californians are smart enough to make this decision for themselves. Our state already has one of the lowest smoking rates in the country. In fact, California has lower cigarette use among adults than any state other than Utah - where the state's predominant religion frowns

on smoking. Only the fear of God can get you to smoke less than we do in California.

Youth vaping was down 59% before the ban and youth smoking rates are at 1.9% – an all-time low.

Also, while the issue, as I stated, isn't directly taxpayer related (and why HJTA hasn't taken a formal position on the proposition), a legislative analysis of a ban on these products found that it would lead to "significant revenue losses" (revenue is government-speak for tax money) that will exceed \$1 billion in the next four years. I'm sure the Legislature won't take that sitting down and will try to find more "revenue" in higher taxes elsewhere.

It's all about control and it's why voters should just say no to Proposition 31.

Why no? Because this measure is a referendum, which is one of the direct democracy powers that Californians have had since 1911, along with the power of initiative and recall. A referendum empowers voters to approve or reject at the polls any act or section or part of any act of the Legislature.

On Proposition 31, California voters will be deciding whether to approve ("yes") or reject ("no") the law that bans flavored tobacco products.

I'll be voting no – and I don't even smoke. Jon Coupal is presi-

Trade publications like "Variety" reported last month that the Nexstar president stated the average viewer of The CW is 58 years old. Hardly anyone could believe this until Nielsen data backed it up.

How to explain the interest of older viewers to tune into youth-oriented programming like "Riverdale" and "All American?" A plausible answer may be that the younger crowd are watching on platforms other than traditional television.

One of its most successful franchises, "Supernatural" ran for more than a dozen years. Now along comes "The Winchesters," a wild-west origin story to this big hit.

Told from the perspective of narrator Dean Winchester (Jensen Ackles, "Supernatural"), "The Winchesters" is the epic, untold love story of how John Winchester (Drake Rodger) met Mary Campbell (Meg Donnelly).

Putting it all on the line to not only save their love, but the entire world, when John returns home from the war in Vietnam, an enigmatic happenstance sparks a new mission to trace his father's past.

In his journey, John crosses paths with 19-year-old demon hunter Mary, who is also searching for answers after the vanishing of her father. Together, they join forces with young hunters-in-training to unearth concealed truths about both their families.

There's a ditty that captures Californians' attitudes about taxes: "Don't tax you, don't tax me, tax the fellow behind the tree."

It explains why California voters are usually willing to impose new taxes on the state's most affluent residents and why the state has, by far, the highest income tax rates of any state, topping out at 13.3%.

In this century, the syndrome has been evident in three elections, beginning in 2004 when Darrell Steinberg, then a state legislator and now mayor of Sacramento, and mental health advocacy groups proposed boosting the tax rate on incomes over \$1 million by one percentage point to expand services to the mentally ill.

Eight years later, in 2012, Gov. Jerry Brown sponsored a ballot measure that added four new tax rate brackets on incomes over \$250,000 for seven years, saying the proceeds, about \$6 billion a year, were needed to keep the state budget solvent.

Four years later, a coalition of public employee unions and program advocacy groups backed another measure to extend Brown's temporary increase until 2030.

All were successful, in part because the wealthy people who would pay the additional taxes didn't mount any opposition campaigns.

Once again, California voters are being asked to impose more taxes on high-income taxpayers, but this time, the dynamics are markedly different.

Proposition 30, primarily sponsored by the Lyft ride service company but with support from environmental and health groups, would raise the rate on incomes of \$2 million or more by 1.75 percentage points, pushing California's top rate to just over 15%. Proceeds would support climate change resistance efforts.

This time, however, wealthy Californians are donating heavily to a campaign against the measure. At least one reason might be that under a 2017 federal tax overhaul, they can no longer deduct state and local taxes (SALT) over \$10,000 on their federal tax returns.

In effect, that means that California's high-income taxpayers now feel the full brunt of state tax increases. The SALT cap also encourages some of the state's wealthy to leave California for low- or no-income tax states such as neighboring Nevada, Texas or Florida - electric car tycoon Elon Musk most spectacularly.

House Speaker Nancy Pelosi and other Democratic politicians have been trying to scrap the SALT deduction limit on behalf of California and other high-tax states, such as New York, but so far have failed.

This week saw another unusual wrinkle in the perpetual efforts to increase taxes on the wealthy: The campaign against Proposition 30 is broadcasting an ad in which Gov. Gavin Newsom denounces the measure, citing Lyft's sponsorship.


"Don't be fooled. Prop 30's been advertised as a climate initiative," Newsom says. "But in reality, it was devised by a single corporation to funnel state income taxes to benefit their company. Put simply, Prop 30 is a trojan horse that puts corporate welfare above the fiscal welfare of our entire state."

It bolsters the opposition campaign's contention that Lyft wants the new money for climate change programs because it would subsidize a state mandate that it and other ride companies convert their fleets to zero emission vehicles.

Newsom's opposition is just one of the strange bedfellows makeup of campaigns for and against Proposition 30. His Democratic Party has endorsed the measure, as have groups that have been Newsom allies on climate change. But the California Teachers Association joins him in opposition, improbably aligned with the state Republican Party and antitax groups.

This time around, therefore, one cannot say that raising taxes on the rich will be an easy sell.

the idea of you two getting your finances in order even more than she already is.

She's taking this whole thing pretty seriously if she's eyeballing interest rates, buddy. She loves the thought of you two having control of your money. Use this momentum to work together as a team, and knock out that debt!!







# **California Gets Green Light** for EV Charging Network

#### **Caltrans and CEC** Joint News Release

SACRAMENTO, CA (MPG) -California has the green light to start using federal infrastructure funding to expand electric vehicle (EV) charging stations along the state's interstates and highways following the recent federal approval of a joint plan by Caltrans and California Energy Commission.

The U.S. Joint Office of Energy and Transportation's signoff on the California Deployment Plan for the National Electric Vehicle Infrastructure (NEVI) Program makes an initial \$56 million in funding available to install charging stations throughout the state. Funded by the federal Infrastructure Investment and Jobs Act of 2021 (IIJA), California expects to receive a total of \$384 million for the program over the next five years. The federal funding will build on California's historic \$10 billion, multiyear investment to accelerate the transition to zero-emission vehicles by improving affordability and expanding charging infrastructure.

"Thanks to the Biden-Harris Administration's approval of California's NEVI plan, we can start putting historic levels of federal infrastructure funding to work to close

gaps in our state highway system's evolving EV charging network and improve availability and reliability for low-income and rural residents," said California Transportation Secretary Toks Omishakin. "Coupled with unprecedented levels of state investments in zero-emission vehicles, this funding will help supercharge California's nation-leading efforts to drastically cut climate-changing pollution from the transportation sector."

The IIJA funds will add to efforts to complete a 6,600-mile statewide charging network and deploy 1.2 million chargers by 2030 to meet the anticipated charging needs of the state's EV fleet.

"With this unprecedented federal investment. California can advance our vision of a unified network of charging stations along the state's busiest corridors," said California Energy Commission Commissioner Patty Monahan. "This new network will increase charging access, particularly in the rural areas of our state, and help EV drivers charge up on long trips."


The state's NEVI plan focuses on construction of fast-charging stations near interstates, U.S. routes and state routes throughout California.

These charging stations will increase the availability of charging options, improve the reliability of the charging network and remove barriers to accessing EVs. NEVI funding will also support upgrades to existing infrastructure, charging stations' operation and maintenance costs, community and stakeholder engagement, workforce development, and related mapping and signage.

California surpassed one million zero-emission vehicles (ZEV) sold in 2021 and leads the country in all ZEV market metrics including the highest level of public funding, the largest EV market share percentage, and the most extensive public charging infrastructure. The success of the state's programs has led to ZEVs becoming a top export and has spurred major advances in manufacturing and job creation.
