

# Point-in-Time Count Released



Yolo County Point-in-Time Count is an important tool in analyzing and addressing the current state of homelessness in our

WOODLAND, CA (MPG) - On September, 20, 2022, Yolo County released the complete report of its 2022 Point-in-Time (PIT) Count (PDF). The PIT is a survey of individuals and families identified as experiencing sheltered or unsheltered homelessness within the boundaries of Yolo County on a single night. The 2022 count identified 746 people experiencing homelessness on February 23.

This year's count represented the first unsheltered PIT since 2019 as a winter surge of COVID-19 delayed the 2021 count. The surveys collected demographic information on the homeless population in terms of

race, ethnicity, age, how long they have been in Yolo County, how long they have been unhoused, and other key information to help programs understand the needs of the overall unhoused population. While Yolo County experienced an overall increase of 13.9% in the 2022 count compared to 2019, Yolo County

WEST SACRAMENTO, CA (MPG) - Holy Virgin Mary Antiochian Church, located at 3060 Jefferson Blvd. held their 18th annual Mediterranean Food and Music Festival on Saturday, September 17th. ### **Bill Signed to Crack Down on Street Racing** and Illegal **Sideshows**

#### SACRAMENTO, CA (MPG) -

On Monday, September 19, Gov. Gavin Newsom signed Assembly Bill (AB) 2000, which will prohibit street racing and sideshows from occurring in parking lots across the state.

The bipartisan measure, authored by Assemblymember Jesse Gabriel (D - Woodland Hills), aims to crack down on dangerous driving including street racing, "sideshows," and street takeovers - which continue to cause injuries and fatalities across California.

"Far too frequently, street racing and illegal sideshows devastate families, harm innocent bystanders, and cut short young lives," said Assemblymember Jesse Gabriel. "Communities in the San Fernando Valley and across California are sick and tired of this reckless behavior. I'm grateful for Governor Newsom's leadership on cracking down on this dangerous activity and signing this commonsense measure that will save lives across our state."

"AB 2000 will help us save lives and prevent further crashes and drivers going to prison for manslaughter," said Lili Trujillo, Founder and Executive Director of Street Racing Kills, a non-profit created in 2014 after Trujillo's 16-year-old daughter, Valentina, was killed in a street racing incident. "An exhibition of speed in a parking lot is way too common now and people are being hurt and killed, AB 2000 is definitely a great tool to help us save lives."

"There are countless stories every week throughout California about illegal street races and dangerous sideshows shutting down streets, causing accidents, damaging neighborhoods, and endangering lives," said Assemblymember Vince Fong (R - Kern County), a joint author of the measure. "They are unpredictable, destructive, and can lead to senseless deaths that devastate families. AB 2000 is an

Continued from page 1 saw a decrease of 4.8% in unsheltered homelessness.

Yolo County has two main oversight entities that support coordination, strategy, and funding for homelessness in Yolo County. The Davis/Woodland/Yolo County Continuum of Care (CA-521), also known as the Yolo County Homeless and Poverty Action Coalition (HPAC), is a local nonprofit that provides leadership and coordination on the issues of homelessness and poverty in Yolo County. The County's Commission to Address Homelessness is comprised of elected officials from Woodland, West Sacramento, Davis, Winters, and the Chair of (HPAC). The Commission officially launched in March 2020. It supports countywide policy, strategy, and funding recommendations to address homelessness and housing

"The Yolo County PIT count plays an essential role in analyzing and addressing the current state of homelessness in our County," said County Supervisor Gary Sandy and Chair of the countywide Commission to Address Homelessness. "We thank our community partners who assisted in completing our 2022 PIT count and appreciate the effort to coordinate our resources better, maximize State and Federal funding, and strategically address the needs of those who lack housing."

Some of the highlights from the 2022 PIT include:

The decrease in unsheltered homelessness and the increase in the number of programs in Yolo led to a higher sheltered count this year; 22% of individuals surveyed lived in Yolo all their life, with an additional 16% having lived here for 7 or more years; Almost 50% of those surveyed came to Yolo because they grew up here or their family or friends are here; Less than 5% responded that they came here for good social services or affordable housing; 2019 saw a 43% increase in the homeless population. With our current efforts, we are hoping that the 2022

increase of 13.9% is a start of a downward trend; Some state and federal funding will be based on the 2022 PIT;

The PIT is one tool we use to identify health and racial disparities, allowing us to address systemic issues within our contin-

"When we look at the data from this report regarding the length of time individuals have been in Yolo, we see that these folks are a part of our community, often friends, neighbors, and loved ones," said Ian Evans, Adult and Aging Branch Director for Yolo County Health and Human Services Agency and staff to the Commission to Address Homelessness. "While we still have a lot of work to do in continuing to address homelessness, I am encouraged by the efforts of so many in our community to address the ongoing needs of those in our County experiencing unsheltered or sheltered homelessness."

"Looking at surrounding counties, we see overall increases of 30, 40, and in some cases as high as 70% homelessness. The fact that Yolo only experienced a 13.9% increase during this time and a decrease in unsheltered homelessness speaks to the collaborative efforts that occur in our community from those in leadership, jurisdictions, community-based providers, faith organizations, volunteers, and staff alike. This is a community issue, and we must continue to work as a community to address it," said Evans.

When considering the numbers in the count, it is important to recognize that they reflect only those persons identified as homeless within the County on a single day. Many people move in and out of homelessness during a year, meaning that the actual number of people experiencing homelessness in 2022 may be higher than the numbers included in this report.

# **Ghostly Shenanigans at The Historic Woodland Opera House**



WOODLAND, CA (MPG) -In memory of Paul and Barbara Taloff, Chris and Betsy Taloff present The Ghost of Woodland Opera House. This theatric work is inspired by the history of the WOH and the heroism of Woodland resident and volunteer firefighter William W. Porter. Porter was the single casualty of the fire of 1892 that resulted in the loss of the original Opera House along with many downtown buildings and residences.

Since Porter's death, there have been numerous reports of ghostly sightings throughout the years at the Woodland Opera House. Volunteers and visitors, actors and audience members alike claim to have experienced supernatural specters, strange smells, and startling sounds. Traditionally, many of these unexplained events have been attributed to William Porter whose spirit purportedly still inhabits the historic theatre.

A new comedy by Matthew Abergel and Bob Cooner, The Ghost of Woodland Opera House tells the story of a troupe of traveling actors in 1909 who arrive at the theatre to perform their latest melodrama. # **Retraction about Bryte VFW Hall**

WEST SACRAMENTO, CA (MPG) - In the September 8th issue of the News Ledger we released a story about the purchase and plans for the Bryte VFW Hall. I have since discovered that we printed incorrect information about the history of the building. I had combined history information about the West Sac VFW and Bryte VFW. I received a call about the mistake and someone sent me a letter with the correct information. It reads as follows:

"The Building on the corner of Lisbon and North Hobson is commonly referred to as the VFW Hall. But when it was first built in the mid 1940's, the two men Jordan Ramos and Art Sanders had planned for it to be a movie theater. Jordan Pappy Ramos (my husband's uncle) was very interested in the growing community of Bryte. He

sponsored baseball teams, held holiday parties for the volunteer fire dept. and really enjoyed being involved in many groups. His neighbor Art Sanders was a movie buff and told Jordan he could get films, run the projector, etc., so the design of the building included a projection room, a small stage and two rooms on either side for visiting entertainers. One later became a barber shop!

Well, the movie theater opened, local boys dropped flyers on every porch in Bryte and the cost was 25 cents. But the movies were not easy to get and soon other uses for the hall were growing. The Bill Rase Orchestra needed a place to practice, the only school in Bryte needed a large place for their 8th grade graduation, a new church, waiting for their building to be ready, held their services in the community hall. Families needed a large room for

birthday parties, receptions for weddings and funerals. A rental fee was reasonable and the community enjoyed the new place to gather.

In 1947, Post #9498 of the Veterans of Foreign Wars was instituted with Ray W. Fisher (a local newspaper writer) as Charter Commander. The veterans had a place to meet and often held events for the community. The post bought the building from Jordan Ramos and when Jordan Pappy Ramos was killed in an automobile accident, they placed a plaque on a large granite stone to the side of the front door of the building. The inscription says:

THIS PLAQUE ERECTED IN MEMORY OF JORDAN P. RAMOS 1902-1966 FOR HIS COMMUNITY SERVICE. GREATER LOVE HATH NO MAN THAN THIS, THAT A MAN LAY DOWN HIS LIFE FOR HIS FRIENDS."



important and needed step in cracking down on illegal sideshows to make our communities safer."

Across the state, COVID-19 has caused a sharp rise in illegal street racing activity as drivers took advantage of roads emptied by stay-at-home orders. In 2020, the California Highway Patrol responded to more than 25,000 calls involving illegal street racing activity statewide, an alarming increase of more than 3,500 calls from the year before.

In Southern California, street racing and sideshows have become extremely popular. In August and October of 2021, respectively, a Calabasas teen was among three people killed by apparent street racers in a three-vehicle collision in Burbank caused by street racing, and a Woodland Hills woman was killed and seven others were injured after a

driver lost control while racing. Just last week, police arrested three dozen people at several illegal street takeovers in and around Los Angeles and the San Fernando Valley.

Statewide law enforcement groups have identified driver's license suspensions as an effective tool for the deterrence of illegal street racing activity. Expanding on AB 3, which was signed into law last year, AB 2000 allows courts to issue a driver's license suspension for the exhibition of motor vehicle speed during a sideshow taking place in a parking lot – an area not currently covered under the law – and thereby helps to further deter individuals from engaging in these dangerous activities

# Criminal Justice Partners Engage in Voter Education & Outreach

**WOODLAND, CA (MPG)** - In partnership with the Yolo County Elections Office, the Yolo County Public Defender's Office and the Yolo County Probation Department will conduct voter education and outreach to individuals impacted by the criminal-legal system.

Voting allows people to have their voices heard and engage productively in their community. By engaging in the democratic process, voters practice pro-social skills, such as civic engagement and appropriate expression of beliefs and values. The two County offices want their clients and the general public to know that everyone in the community retains the right to vote, regardless of any misdemeanor or felony convictions.

Voters must register to vote by October 24 to be eligible to vote on election day – November 8. Probation will host their voter registration drive at their Woodland and West Sacramento Offices on October 6. The Public Defender's Office will host a voter registration drive on National Voter Registration Day – September 20, 2022. In collaboration with Yolo County Children's Alliance, the Public Defender's Office will host this voter registration drive at Project Homekey in West Sacramento.

The Probation Department and Public Defender's Office are putting up voting rights educational posters in their lobbies and making voter registration cards available to clients upon request. Many people have the incorrect impression that they lost their right to vote due to a criminal

conviction. However, even Californians who are being supervised by Probation or Parole or serving a jail sentence are eligible to vote.

"We not only want people to know about their voting rights; we also want to make voting accessible," said Emily Kochly, Chief Mitigation Specialist with the Public Defender's Office. "Access to voting empowers people with lived or direct experience with the criminal legal system and allows them a means of changing the system and their community for the better."

To target eligible voters who are currently in-custody, the Public Defender's Office is sending out a mass mailer to individuals currently incarcerated in the county jail. This mailer will include information about voter eligibility and how to request and fill out a voter registration form while in the county jail.

"There is a high concentration of eligible voters in our county jail," explained Public Defender Tracie Olson. "Since people of color are incarcerated at disproportionately higher rates, expanding voting access to individuals currently incarcerated advances racial justice."

#### WOODLAND, CA (MPG) - All are welcome to the Grand Opening of Northern Recycling's

Covered Aerated Static Pile Composting and Construction, Demolition, and Inert sorting facility on Wednesday, September 28, from 9 to 10 a.m., located at 44090 County Rd 28H in Woodland. Participants will learn more about the composting, construction, demolition, and inert recycling process while viewing the processing area and equipment.

The Yolo County Central Landfill (YCCL) currently provides diversion of organic materials, including food waste and green waste, from residential and commercial sources for Yolo County and the surrounding area at approximately 52,000 tons per year.

"This latest innovation from the Yolo County landfill more than doubles our ability to expand the many beneficial aspects of composting. It will also extend the life of our landfill, benefit local consumers. and reduce some of the troublesome aspects of composting, including air quality. We view this project as a major step forward in our continuing attempts to meet the challenges of

the future," said Supervisor Gary Sandy.

The opening of this new facility, run by Northern Recycling, will increase capacity to 182,000 tons of green and food waste diverted from local landfills annually. In addition, it will incorporate an emissions-reducing composting process called Covered Aerobic Static Pile (CASP). The CASP creates optimal composting conditions via positive aeration, automatic irrigation, advanced temperature control, and a biofilter layer.

Environmental benefits include: Eliminating the need to turn the compost; Reducing the release of air emissions and odors; Decreased ammonia emissions, capture, and reuse of

Completed compost will be marketed to residential and commercial clients. In addition, Northern Recycling's facility at the Landfill will decrease the carbon footprint of construction, demolition, and inert (C&D) material recycling posting, landfill gas control by eliminating the need to truck C&D to Sacramento for sorting.

"Yolo County is proud and committed to providing the best possible technology for diversion of waste from landfill and its conversion of waste to resource," said Integrated Waste Management

# Killer from 1989 West Sacramento **Murder Denied Parole Again**

**Yolo County** DA News Release

WOODLAND, CA (MPG) - On September 14, 2022, a two-commissioner panel of the Board of Parole Hearings denied the parole of 64-year-old Carl Williams. Williams is serving a life sentence with the Arkansas Department of Corrections, Tucker Unit. The hearing took place by video conference. This was Williams' fifth lifer hearing. The denial was for three years.

April 7, 1989, 31-yearold Williams was staying at a motel in West Sacramento. He was dealing and using crack cocaine. He met Evelyn Munoz who had been staying with him for a couple days. Ms. Munoz was working at the Department of Motor Vehicles and was going through a difficult divorce. Williams wanted to use Ms. Munoz' car to sell crack cocaine and he and Ms. Williams got into an argument. Williams became violently angry and strangled Ms. Munoz by stuffing a sheet down her throat. A witness in a nearby room twice heard Ms. Munoz beg for her life saying "Help, help

me." After strangling Ms. Munoz, Williams found her keys and left with her

A Yolo County jury convicted Williams of First-Degree Murder in 1990 and he was sentenced to 25-years-to-life in State Prison. Because he had family in Arkansas, and due to prison overcrowding in California, the California Department of Corrections granted his request to serve his prison sentence in Arkansas.

Chief Deputy District Jonathan Raven represented the District Attorney's Office. Ms. Munoz' granddaughter, her two daughters, and her son-in-law attended the lifer hearing. These family members made powerful statements to the Commissioners talking about how this brutal murder impacted their lives. District Attorney Victim Advocate Kenya Salazar-Campos attended the hearing to support the family members. Her eldest daughter, who was twelve when her mother was murdered, stated "All I want to do is hear her voice again and be in her presence, but that was taken from me because of him."

Board of Parole Hearings Commissioners David Long and Keith Betchley determined that Williams still poses an unreasonable risk to public safety and is therefore unsuitable for parole. Commissioner Long stated "your minimizing acceptance of taking responsibility and deflecting blame to the victim is indicative of your criminal thinking."

Yolo County District Attorney Jeff Reisig stated that he was satisfied with the three-year denial. "The family of Ms. Munoz has been suffering immeasurable pain since this senseless and brutal murder in 1989," said Reisig. "We will do everything we can on their behalf to honor Evelyn Munoz and to keep society safe from this dangerous man. That is the very least we can do for this family and all families who have survived similar tragedies."

Carl Williams will be eligible for a new parole hearing in 2025, however, the law permits him to request an earlier hearing date if circumstances change that would increase his likelihood of release.

# **Parole Rescinded for Murderer** by Board of Parole Hearings

WOODLAND, CA (MPG) - On September 16, 2022, a three-member panel of the Board of Parole Hearings (BPH) unanimously agreed that the previous grant of parole for 46-year-old Daniel Robinson was improper and not supported by the evidence. On December 15, 2021, a two-member panel found Mr. Robinson suitable for parole. Subsequently, Governor Gavin Newsom reviewed the decision and raised concerns about whether Mr. Robinson continued to be a public safety risk, if released. Specifically, the Governor asked the full Board of Parole Hearings to consider information of institutional misconduct, dated March 22, 2022, and additional "confidential information" dated April 19, 2022. Based on the request of the Governor, and the new information, BPH set a "recission" hearing to determine whether the two-member panel made the appropriate decision at the December 15th hearing. At a meeting on May 16, 2022, the full Board decided that the December 2021 decision needed further review and scheduled a "recission hearing" to decide whether the panel's decision was "improvident" or improper.

In 1996, a Yolo County jury found Robinson guilty of second-degree murder for killing 16-yearold Robert Castro in a gang related drive by shooting. At the time of the shooting, Castro was riding his bike in West Sacramento. Robinson and his friends were associated with the 29th Street Crips. Because they felt disrespected by the Broderick Boys, a West Sacramento gang, they decided to get revenge by shooting Castro, even though they had never seen him, didn't know him, and had no reason to believe he was in a gang. After the jury convicted him of second-degree murder, Robinson was sentenced to 18 years-to-life in state prison.

This recission hearing was conducted by video conference on September 16, 2022, before BPH Commissioners Catherine Purcell, Joe Sullivan, and Nancy Wong. During the hearing, Commissioner Purcell presented information concerning the fact the Mr. Robinson illegally possessed a Motorola phone in his cell on March 22, 2022. She also presented evidence that Mr. Robinson, with the assistance of his wife, committed EDD fraud and communicated with his wife through texts about this fraud as far back as August 2020. Commissioner Purcell stated that Mr. Robinson "received significant fraudulent money" which his wife deposited into his inmate bank account.

Chief Deputy District Attorney Jonathan Raven attended the recission hearing on behalf of the District Attorney's Office. Robert Castro's mother, father, sister, and cousins also attended the hearing. After deliberating, the panel unanimously agreed that the last panel's December 2021 decision to grant Mr. Robinson parole was improvident. Commissioner Purcell stated, "We find that there's good cause to rescind your parole grant. First, we have found true the 2020 cell phone violation, that you possessed the phone at the time of the grant hearing and actually well before that. The phone texts show that you engaged in EDD fraud as well." Commissioner Purcell continued, "We find that you engaged in criminal thinking because of these things. First you were not truthful under oath at your parole hearing and when you did so, you were untruthful in order to secure a grant of parole. We have found that the last panel's grant of parole was improvident because some of the panel's conclusions could not be reconciled with the evidence...."

Yolo County District Attorney Jeff Reisig expressed his satisfaction of the Board of Parole Hearing's decision. "Board members took the concerns expressed by Governor Newsom to heart, reviewed the evidence, and took note of Mr. Robinson's dishonesty and sophisticated criminal conduct," said Reisig. "This was a senseless and horrific gang shooting of 16-year-old boy who was targeted simply because Robinson and his fellow gang members felt disrespected by the Broderick Boys. Clearly, Mr. Robinson's very recent violations in prison and the EDD fraud are indicative that he still remains a danger to the public."

The current hearing was to only determine whether the December 2021 panel's decision was improper. Mr. Robinson will be entitled to another hearing to determining his suitability for parole within 120 days.

#### 'SAMARITAN' DYSTOPIAN ACTION; **SUBWAY RIDE CAN BE WEIRD**

#### "SAMARITAN" ON AMAZON PRIME VIDEO

You've seen men wearing a T-shirt or ballcap that says "Old Guys Rule" and yet, none of them hardly ever has the physical prowess of Liam Neeson, Arnold Schwarzenegger or Sylvester Stallone.

"Old Guys Rule" might as well be the title of Stallone's aging superhero film "Samaritan" in which his character of Joe Smith may not exactly measure up to the standard of someone who helps a stranger, or at least not without some prodding.

Does it seem like a stretch for septuagenarian Stallone to be playing an aging vigilante who can easily toss a grown man across a room? Who has time to think about this when the action gets fast-paced?

Though it seems incredible that a man of Stallone's age could be convincing in the way that superheroes half as old so easily pummel adversaries into a pile of human debris. Yet, he's not gone flabby, and maybe that's because his day job as a garbage man requires heavy lifting.

The introduction of Amazon Prime's "Samaritan" has a lot of quick cuts of animation inspired by a graphic novel. The setting is Granite City, a dystopian hellscape that's moving inevitably toward out-of-control chaos and looting.

Twenty-five years earlier, twin brothers Samaritan and Nemesis were so freakishly strong that the residents of Granite City grew to fear them and retaliated by trying to burn them alive by setting their house

The twins were unscathed, but their parents did not survive. At this point, Samaritan grew to fight as a protector of the innocent, while Nemesis, consumed by revenge, wanted the world to suffer.

Nemesis forged a powerful weapon in a hammer that he poured all his hate and rage into. His armament was like Thor's, but his purpose was malicious. This was the only weapon that could destroy his sworn enemy, Samaritan.

Eventually, the brothers engaged in mortal combat at a warehouse that was consumed by a raging fire, and it was presumed that both of them perished, or at least, that's the story for the citizens of Granite City.

Local journalist and bookshop owner Albert Castler (Martin Starr) has written a book about Samaritan that delves into conspiracy theories and speculation that the freakishly strong Samaritan is still alive.

A true believer of Samaritan's earthly existence is 13-year-old Sam Cleary (Javon 'Wanna' Walton), who suspects that his mysterious and withdrawn neighbor Mr. Smith is actually the legend hiding in plain sight.

Living in a tenement with his single mom Tiffany (Dascha Polanco), Sam is frequently bullied by local thugs led by the heavily tattooed Reza (Moises Arias) who goes so far that Mr. Smith intervenes, causing the kid to believe that he's found Samaritan.

Meanwhile, a psychotic gang leader named Cyrus (Pilou Asbaek), a worshipper of supervillain Nemesis, decides to incite a street rebellion of rioting and arson to entice intervention from Samaritan.

Coming as no surprise to anyone, the reclusive Mr. Smith is inexorably drawn to the fight, though getting to that point requires a test of his patience with the inquisitive Sam who goes so far as invading his apartment in search of clues.

Because this kind of film calls for escapist fare, the climactic showdown between Samaritan and the wannabe Nemesis seems much like a live-action replay of the introductory graphic novel animation.

Even though a streaming service like Amazon Prime may have a decent budget, "Samaritan" is nevertheless a B-movie that may be forgettable the next day but in the moment of its urban chaos and violence

#### offers entertainment value for action fans. WEIRD DIVERSION ON THE

**SUBWAY SYSTEM** This column is about entertainment, and diversion can be found in places other than film and television. Who knew that riding the New York subway system, as I did on a recent trip, would offer amusement with its

travel etiquette? Handy guidelines appear on certain trains with an electronic reader. "Stay off the tracks" should be obvious to anyone. That's a no-brainer. A better warning is not to stand too close to the platform.

The "Keep your hands and other parts to yourself" makes one wonder about lechers riding the rails. Avoid anyone wearing a trench coat during warm weather, or someone looking slightly crazed.

"Go before you go" is wise because even if you found a public bathroom in a subway station, the best warning would be "Enter at your own risk."

"Don't sell stuff without a permit" is widely ignored. Someone is bound to be selling packaged cookies or candy, or useless items like an 8-track player or VHS

The one guideline of "Don't smoke or set anything on fire" does have me worried. The ban on smoking is understandable, but has there been a rash of arsonist acts that should give one pause?

The subway is a great way to get to a Mets or Yankees game, but the best advice is to be alert and aware of your surroundings and don't travel in the middle of the night.

# **COVID-19 School Closures Undermined Learning**

Whether California's schools should remain open or be closed was a hot issue when the COVID-19 pandemic was raging in 2020 and 2021.

Although medical authorities quickly concluded that children had a much smaller risk of being infected or experiencing severe effects if infected, California schools were mostly closed, in large measure because teachers and their powerful unions insisted on it.

With schools closed, local administrators scrambled to provide on-line classes, what became known as "zoom school," but they were poor substitutes for the real thing — especially for English-learner students and those from poor families.

Those children roughly 60% of the state's nearly 6 million public already trailing their more privileged contemporaries academically when the pandemic hit. The closures made it worse, for obvious reasons.

They tended to lack internet access and proper equipment for on-line classes. Their parents were often compelled to work outside the home to make ends meet, so kids were often left to fend for expected, were the ones who themselves. Absenteeism have lost the most ground."

from on-line classes was widespread.

Affluent parents, particularly those who could easily work from home during the pandemic, made certain that their kids attended on-line classes, helped them with their school work, formed informal collaboration groups and/or hired tutors. Thus, the ill effects of closures were mitigated. And, of course, private schools, such as the one Gov. Gavin Newsom's kids attend, either remained open or

minimized closures. For months, politicians from Newsom downward quarreled over how the schools should function and angry parents formed the core of a movement to recall him from office. Newsom survived the recall, but the educations of millions of kids did not, as new data confirm.

While the Department of Education has not released 2022 academic test data that would allow comparisons with pre-pandemic results, individual school districts are doing so and the numbers from the state's largest school district, Los Angeles Unified, are stunning.

About 72% of the disschool students — were trict's students are not meeting state standards in math and 58% are behind in English, essentially wiping out five years of progress that it had recorded prior to the pandemic.

"The pandemic deeply impacted the performance of our students," LAUSD Supt. Alberto Carvalho said. "Particularly kids who were at risk, in a fragile condition, prior to the pandemic, as we

While the district released gross data, it did not break down the test results by ethnic or economic subgroups. The Los Angeles Times, however, gleaned the detail from a school board document marked "not for public


release." Why the secrecy? Apparently, it was to mask the particularly disturbing data about Black and Latino

"About 81% of 11th-graders did not meet grade-level standards in math. About 83% of Black students, 78% of Latino students and 77% of economically disadvantaged students did not meet the math standards," the Times reported.

We won't know how the state as a whole fared until — and unless — the Department of Education finally releases 2022 complete "Smarter Balance" test results. But there's no reason to believe that what happened — or, more accurately, what didn't happen — in Los Angeles isn't also true of other systems, particularly those with large numbers of at-risk students.

The educational deprivation that California inflicted on its kids is not only shameful, but will reverberate for decades. Children who fail to master the basics of education in lower grades will be ill-prepared for high school and post-high school training and education. If they are not prepared to take their place in the work force, the state's economy will suffer.

#### **The California DMV** offers specialized options for seniors over 70 years old

The Department of Motor Vehicles (DMV) wants to help you maintain your driving independence for as long as you can drive safely. The DMV offers resources to help you take care of your DMV tasks from the comfort of your home or at your local field office. California drivers, aged 70 years or older, have until the end of 2022 to take advantage of a temporary rule that offers driver's license or identification (ID) card renewal online or by mail, even if a renewal notice states that the driver is required to visit a DMV field office. If you still need to apply for your REAL ID for the first time you will still need to visit a DMV field office to complete the application process. You can shorten your in-person visit at the DMV by starting the REAL ID application online and uploading the required documents before making an appointment at a field office.

#### Q: Are there other alternatives for DMV services besides online or in-person?

- A: The DMV continues to develop innovative approaches to streamline processes and limit the time customers spend in field offices by offering many services online that used to require an office visit. In many instances, the customer starts the process online and then is contacted later by a DMV representative through email to complete the transaction. The DMV also increased the number of items that can be taken care of at a kiosk as well as increased kiosk language options.
- Q: I am 70 years old and need to renew my license, but do not feel safe coming to a DMV office. What can I do?
- A: Until the end of 2022, eligible senior drivers and REAL ID cardholders can renew noncommercial driver's license and ID cards at dmv.ca.gov/online or by mail, even if your renewal notice states a visit to a DMV office is required.
- Q: Once I receive my renewal notice in the mail, how long should I wait to renew my driver's license or ID card?
- A: If you choose to take advantage of the DMV's online services to renew, you should try to do so upon receiving your renewal notice in the mail. Keep in mind that driver's licenses and ID cards generally arrive in the mail within two to four weeks following renewal.
