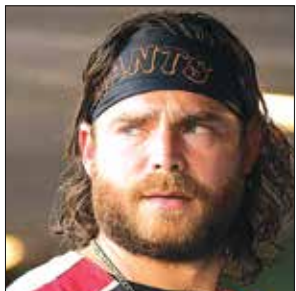

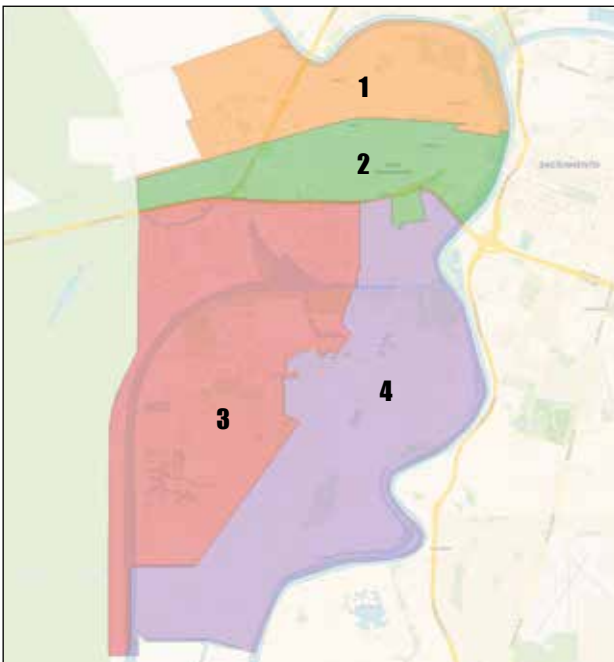
WEST SACRAMENTO, CA (MPG) - The nomination period for the November 2022 municipal elections is open now, through August 12, 2022.

Social Security Matters

Do My Canadian Earnings Count Toward U.S. Social Security?

Dear Rusty: I am a 62 year old Canadian holding a green card and I have lived in the US for nearly twenty-three years. For 19 years prior I contributed to the Canada Pension Plan (CPP) which is the equivalent of US Social Security. I am contemplating retirement in the US and have been told that I can draw my old age pension from either the US, or from Canada, but I cannot draw from both.

My 19 years of contributions to the Canadian Pension Plan are not accounted for in the calculation of my U.S. SS benefits. Conversations with the U.S. Social Security office suggested that my contributions to the CPP would “probably” be applied to my U.S. pension upon application for benefits. However, the individual I spoke with was not sure how that would work. Do you know the process for having my Canadian earnings transferred to my U.S. SS account and how I might find out what my combined benefits will be?

Signed: Retiring Canadian

Dear Retiring Canadian: Allow me to clarify how things work under the bi-lateral agreement between the U.S. and Canada. Although you worked and contributed to CPP while living in Canada, your earnings in

Canada do not count when computing your U.S. Social Security benefits (nor do your U.S. earnings contribute to your CPP benefit entitlement). Although the bi-lateral US/Canada agreement permits earnings credits from both countries to be combined to gain eligibility for benefits, computation of benefit amounts in each country uses only dollars earned in-country. Thus, your U.S. entitlement is based only on your U.S. earnings.

Because of your years contributing to the Canadian program, you are also eligible to separately collect a CPP pension, and you can apply for your CPP pension through your local U.S. Social Security office by submitting SSA form CDN-USA1. Your local SS office can provide the correct form and needed guidance to apply for your CPP benefits. You should be aware, however, that collecting your CPP pension will impact the amount of your U.S. benefit because of a U.S. regulation known as the Windfall Elimination Provision (WEP). WEP reduces the U.S. Social Security benefit for anyone who has a pension earned separately without contributing to Social Security (that includes some U.S. state & local government employees, as well as those who have a pension from another country).

Your U.S. benefit will be computed using a special WEP formula which considers the number of years you contributed to the U.S. program from “substantial earnings.” Assuming you have 23 years of substantial U.S. earnings from which you contributed to the U.S. SS program, your U.S. benefit will be reduced by approximately 35%. Your CPP

pension will cause WEP to apply, which will reduce your U.S. pension, but it cannot reduce it by more than 50% of your CPP benefit amount.

FYI, WEP and international benefits are complex topics, and it’s not especially unusual that SS representatives you first encounter (e.g., on the phone) aren’t fully versed in how those benefits work. You may wish to make an appointment to apply for your CPP benefits in person at your local Social Security office and at the same time obtain more specific information on how WEP will affect your U.S. Social Security benefits. That may require speaking with a senior person who is well versed in WEP and international pensions.

Finally, be aware that at age 62 your U.S. benefit will be further reduced because you haven’t yet reached your full retirement age (which is 66 years and 10 months). Be aware, too, that until you reach your full retirement age, you’ll be subject to Social Security’s earnings test, which limits how much you can earn before some benefits are taken away.

Does University of California undercut academic freedom?

Administrations and faculties at University of California campuses are embroiled in a searing controversy over requirements that applicants for faculty positions and candidates for promotion prove their active support, without reservation, of what’s called “diversity, equity and inclusion.”

Candidates must submit “DEI statements” that, under UC’s policies, determine whether they will be considered for employment or promotions, regardless of their academic credentials.

While different campuses use slightly different “rubrics” for judging candidates on their DEI statements, they generally use a 1-to-5 scale to determine whether they should be allowed to advance.

One, at UC-Davis, provides the lowest score to candidates who seem to be unaware or uninterested in the need to promote diversity, while the highest score would be given to someone who “discusses diversity, equity, and inclusion as core values that every faculty member should actively contribute to advancing.”

Another version, according to a recent history of UC’s Advancing Faculty Diversity Initiative, establishes a 1-to-5 scoring system to judge whether the applicant should be rejected out of hand or allowed to advance. If he or she refuses to discuss gender or ethnicity issues, or contends that such issues are “antithetical to

academic freedom or the university’s research mission,” they will automatically receive a low score. In contrast, someone who embraces DEI as “core values that every faculty member should actively contribute to advancing” should get the highest score.

One UC Merced professor, Tanya Golash-Boza, even published a guide in the professional publication Inside Higher Ed, to help applicants frame their DEI statements in language that would pass muster with the authorities.

The use of DEI statements began at UCLA four years ago and has become virtually universal since, sparking an intense debate in academic and legal circles over whether the UC system is, in effect, elevating political correctness over academic achievement and in doing so damaging the concept of academic freedom.

To its supporters, DEI statements and other evaluations are necessary tools to ensure that the university system overcomes its historic imbalance in students and faculty that favors whites and Asians over Blacks and Latinos.

But detractors see DEI statements as violating in spirit, if not in letter, university policies that prohibit using politics as a litmus test — policies that were introduced to counter Cold War-era efforts to weed out faculty members with leftist tendencies by forcing them to take loyalty oaths.

In 1950, the Legislature passed the Levering Act, requiring all state employees to sign such oaths — a move obviously directed at the UC faculty. In fact, 31 tenured professors were fired for refusing to sign it.

After years of legal and political wrangling, the state Supreme Court, by a 6-1 vote, declared the Levering Act to be unconstitutional in 1967. Meanwhile, the UC Board of

Regents adopted a policy that “No political test shall ever be considered in the appointment and promotion of any faculty member or employee.”

The DEI statements were mandated campus by campus because the UC system’s administrators are under intense pressure from the Legislature, the Board of Regents and activist organizations to overcome ethnic imbalances in spite of voter approval of a ballot measure, Proposition 209, in 1996 that outlaws racial or gender preferences in public employment.

Moreover, in 2020 the state’s voters, by a substantial margin, refused to repeal Proposition 209.

The history of how DEI statements became a powerful tool to weed out faculty applicants who don’t conform is explored in a recently published and somewhat critical but remarkably objective monograph by two academic researchers affiliated with UC’s Riverside campus.

They are Steven Brint, a professor of sociology and public policy, and Komi T. German, who earned her doctorate at UC Riverside.

“We find ourselves with a university in flux,” the two conclude. “Its commitment to the representational mission, and the progressive political demands that accompany it, is gaining traction as many find themselves disillusioned with the traditional mission of dispassionately searching for truth.”

The irony — and perhaps tragedy — of the DEI statement mandate is that while it might, at least in theory, make UC’s faculty more diverse in ethnicity, its conformism will make it even less diverse intellectually.

WOODLAND, CA (MPG) - For the second time, Yolo County Health & Human Services Agency (HHSA) collaborated with CommuniCare Health Centers, Dignity Health, Sutter Health, and Winters Healthcare, with support from Community Health Insights, to develop a new three-year Yolo County Community Health Needs Assessment 2022-2024 (CHNA).

“CHNAs are powerful tools for community leaders and residents to better understand our most significant health needs,” said Board Chair, Supervisor Angel Barajas. “We can now translate this information into action, creating or enhancing programs meant to help support greater access and more equitable health outcomes.”

The top health needs identified in the 2022 CHNA are:

Access to Basic Needs Such as Housing, Jobs, and Food; Access to Mental/Behavioral Health and Substance Use Services; Injury and Disease Prevention

and Management; Active Living and Healthy Eating; Access to Quality Primary Care Health Services; System Navigation; Access to Specialty and Extended Care; Increased Community Connections; Safe and Violence-Free Environment; Access to Functional Needs; Access to Dental Care and Preventive Services.

HHSA invites community partners, health care centers, and residents to join HHSA staff as part of a collaborative workgroup that will develop a three-year Community Health Improvement Plan (CHIP). The purpose of the CHIP is to create an action plan in response to the top significant health needs identified in the CHNA.

This process will begin in early Fall 2022 and will coincide with the release of the Yolo County Community Health Assessment (CHA). The CHA features the CHNA data and additional data sources that will help identify geographic areas or communities disproportionately impacted by health disparities to be addressed in the development of the CHIP.

First Human Case of West Nile Virus in Yolo County in 2022

YCHHSA News Release

WOODLAND, CA (MPG) - The Yolo County Health and Human Services Agency (HHSA) Community Health Branch has received confirmation of a human case of West Nile virus in Yolo County. The patient first became ill last month and is recovering from neuroinvasive West Nile virus disease.

“West Nile virus is spread to people by the bite of a mosquito, and there is a risk of contracting West Nile virus in Yolo County this time of year when mosquitoes are active,” said Yolo County Health Officer Dr. Aimee Sisson. “By making regular checks of their yards and draining standing water, people can help cut down on mosquito breeding areas. Wearing protective clothing and using insect repellent will also reduce the risk of mosquito bites.”

People typically develop symptoms of West Nile virus between two and 14 days after they are bitten by an infected mosquito. While 80 percent of people infected will not show

any symptoms, 20 percent of people infected have symptoms such as fever, headache, body aches, nausea, vomiting, and sometimes swollen lymph glands or a skin rash on the chest, stomach, and back. Symptoms can last for as short as a few days or several weeks, even for generally healthy people.

About one in 150 people infected with West Nile virus will develop severe illness. Their symptoms can include high fever, headache, neck stiffness, stupor, disorientation, coma, tremors, convulsions, muscle weakness, vision loss, numbness, and paralysis. These symptoms may last several weeks, and neurological effects may be permanent. People over the age of 50 and those who have diabetes or hypertension are more likely to develop serious symptoms of West Nile virus and should take special care to avoid mosquito bites.

The best way to prevent West Nile virus infection and other mosquito-borne illnesses is to prevent the bite of an infected mosquito. Following the 7

Ds decreases the risk of mosquito bites:

DRAIN any standing water that may produce mosquitoes; DAWN and DUSK are when mosquitoes are most active; DRESS appropriately by wearing long sleeves and pants when outdoors; DEFEND yourself against mosquitoes by using an effective insect repellent, such as DEET, Picaridin, or Oil of Lemon Eucalyptus. Make sure you follow all label directions; DOOR and window screens should be in good working condition. This will prevent mosquitoes from entering your home; DISTRICT personnel is available to address any mosquito problem you may be experiencing by calling 1-800-429-1022 or visit www.fightthebite.net.

The Sacramento-Yolo Mosquito & Vector Control District performs extensive control measures to reduce both larval and adult mosquitoes. Stay Alive by Staying Up to Date with COVID-19 Booster Shots

Yolo County News Release

WOODLAND, CA (MPG) - Yolo County recently recorded four COVID-19 deaths among older adults who had not received all COVID boosters for which they were eligible.

Of the seven COVID-19 deaths in Yolo County residents during July, all were in adults 70 and older. Only one of the seven was up to date with COVID booster shots. Being up to date with boosters may have prevented these tragic deaths. Yolo County Health and Human Services Agency's Community Health Branch reminds

older adults to stay alive by staying up to date with COVID-19 booster shots.

Adults 50 years old and older are eligible for and recommended to receive a second COVID booster four months after receiving their first booster. However, only one-third of eligible residents have received a second booster, leaving thousands of older adults at risk of severe COVID-19 disease, hospitalization, and death. Immunity from vaccination decreases over time, particularly among older adults, and staying up to date with boosters helps maintain a high level of immune protection. A high

level of immune protection is particularly important when COVID-19 levels in the community are high like they are now in Yolo County.

While vaccination may not prevent a mild infection with the BA.5 Omicron subvariant spreading across California, vaccination continues to provide strong protection against severe disease, hospitalization and death. An updated booster vaccine targeting Omicron variants is expected to become available this fall, but older adults need the added protection of boosters now and should not delay receiving a booster if

they are currently eligible.

"It is extremely important for older adults to receive a second COVID-19 booster shot as soon as possible. Do not wait for the fall to get a second booster. A booster in late September or October cannot protect you if you die from an infection in August. Get your booster now," said Yolo County Health Officer, Dr. Aimee Sisson. "I encourage family members and friends of older adults to assist older adults in scheduling appointments for a booster shot and helping them get to their appointment."

Anyone who is over the age of 50 can receive

a second booster, along with those 12 and older who are moderately or severely immunocompromised. Everyone ages five and older can get a single booster shot. To see the vaccination schedule, visit www.yolocounty.org/covid and look under the "When Should I Get a Booster Shot?" tab.

Vaccination and boosters are widely available in Yolo County, including through: Your healthcare provider; Local pharmacies at www.vaccines.gov; Local clinics at www.myturn.ca.gov; Clinics sponsored by Move It Up and the UC Davis Center for Reducing Health Disparities.

Yolo County also offers its Door Vax program for those unable to travel to a clinic. A vaccinator can come to your home or business to vaccinate anyone ages five and older for free. This can be a great option for older adults with mobility and/or transportation challenges. 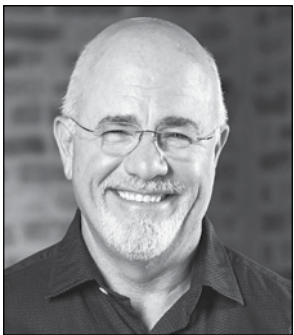

for a minute about the spiritual implications of a situation like this.

Proverbs 22:7 says the borrower is slave to the lender. Now, the Bible doesn't say debt is a sin, but it definitely discourages debt, and it teaches us to live our lives differently than the rest of the world. That's the case when it comes to handling money, too.

If you do this, you'd be turning your dad into your creditor in a very real sense. That's going to make family dinners taste different, because you'll be eating with your lender instead of just good old dad. Money has a way of changing the family dynamic, and it's almost never for the good. Suddenly, you're getting raised eyebrows if you buy something for yourself, because even the nicest, most generous folks have opinions.

If it were me, I'd say thanks, but no thanks. There's no way I'd be in financial debt to my dad.

Now, if he were to offer to make paying off

your debt a gift – one that was given with no strings attached to help you two get into the mission field quicker – I'd be okay with that and I'd be deeply grateful and honored.

But I would never tell you to go into debt to a parent. Your dad is probably thinking it's better for you to be in debt to him rather than some uncaring bank or credit card company. But I just wouldn't want to do anything that might jeopardize your relationship.

A: No. The TSA does not require anyone under the age of 18 to provide identification when traveling with a companion within the United States. However, the companion will need a form of federally accepted identification (REAL ID, U.S. Passport, U.S. Passport Card, DHS Trusted Traveler Card, etc.).

Q: Which documents will I need to get a REAL ID?

A: You will need 1 original or certified proof of identity and 2 different printed proofs of California residency. Follow the three simple steps below and visit dmv.ca.gov/realid to start your REAL ID application and view a complete list of acceptable documents:

• Gather your documents

• Complete your online application and upload your documents

• Make an appointment and visit the DMV office to complete the process

Available at the bar is water (\$4), juice (\$5), Blue Moon, Hazy IPA, Bud Light and White Claw (\$10 each), wine or champagne (\$10), chips (\$3) and a special cocktail called the 'Starry Night' (\$15).

Assembly Approves Sen. Dodd's College Student Hunger Bill

SACRAMENTO, CA (MPG) - The California Assembly today approved legislation from Sen. Bill Dodd, D-Napa, that would help provide food aid to low-income college students, ensuring the underserved population receives adequate nutrition to fulfill their educational goals.

"It's no secret that going to college is expensive, but students shouldn't have to starve to get a college education," Sen. Dodd said. "Many students today are struggling to make ends meet and put food on the table. My bill addresses chronic hunger, helping more Californians achieve their educational and career goals."

Nearly one in three California college students faces food and housing insecurity, according to a survey by the California Student Aid Commission. Students of color are more likely than others to report needs in both areas, the survey said.

Senate Bill 20 would require the Student Aid Commission to proactively notify students of their eligibility for Cal Fresh benefits. Many low-income students are not aware that they may qualify for food assistance through Cal Fresh. About 100,000 students would benefit from the proposal. It is a follow-up to SB 173, written in 2019 by Sen. Dodd, which streamlined the Cal Fresh application process for college

students enrolled in work-study. That bill was signed into law by Gov. Gavin Newsom.

Supporters include the Coalition of California Welfare Rights Organizations and the University of California Student Association.

The Assembly approved SB 20 with overwhelming support. The bill heads next to the Senate for concurrence before going to Gov. Newsom for a signature by Sept. 30.

Senator Bill Dodd represents the 3rd Senate District, which includes all or portions of Napa, Yolo, Sonoma, Solano, Sacramento and Contra Costa counties. More information on Senator Bill Dodd can be found at www.senate.ca.gov/dodd. ★

San Francisco’s shortstop stops by SacTown

WEST SACRAMENTO, CA (MPG) - It’s not often that you have a three-time All-Star and four-time Gold Glove Award winner rolling through Sacramento and suiting up for the River Cats.

However, the uncommon occurred last week as San Francisco Giants shortstop Brandon Crawford played for the Giants’ Triple-A affiliate, the Sacramento River Cats. Crawford was in town for multiple days to get in some game-action before returning to San Francisco following a stint on the injured list with a knee injury.

“The past week’s been pretty good,” Crawford told the media before taking the field on Tuesday, August 2. “I had three or four days where I wasn’t really feeling anything in the knee. I’m hoping to continue that.”

The Mountain View native had been on the IL since July 16 after aggravating the knee that had

previously sidelined him once before this season. Crawford aggravated the injury on June 21 during a 12-10 victory over the reigning World Series champions, the Atlanta Braves. He spent the minimum 10 days on the IL before returning on July 5.

Crawford may have rushed his return coming back after 10 days, because 11 days later, he was right back on the IL as the Giants continue to fight to keep their record above .500 following a National League West division title last season.

“I have to make sure the

knee is feeling good before I come off the IL,” Crawford said. “Last time I came off the IL and felt good for a game, but the next week after that I wasn’t feeling great. I feel like the only way to test it in a game like situation is to actually play a game. That’s kind of what

we decided would be best. Hopefully going forward the next couple months it feels pretty good.”

Before his return from the IL, the 35-year-old recorded a .215 batting average with five home runs, 33 RBI, 29 runs scored and 10 doubles in 72 games for San Francisco this season.

“We’re not far out of the playoff race right now,” Crawford explained. “Hopefully I can come back healthy, and Evan Longoria can come back healthy, and we can be at full strength for a little while. I think with the guys that we have, and we kept, we can make a push for the playoffs.”

As for his time spent in Sacramento, this wasn’t the veteran’s first time experiencing the Capitol of California.

“It’s definitely convenient,” Crawford said about Sutter Health Park being within driving distance of Oracle Park. “I’ve always enjoyed Sacramento. I’ve had family that’s lived up

here. I have definitely played one exhibition here. I can’t remember if I’ve played two. It’s nice to come back out.”

Crawford returned to the majors on Saturday, August 6. The timing couldn’t have been any better for the man who was once a boy born in the Bay Area, as the Giants swept a two-game set on the road from their regional rivals, the Oakland Athletics, in the Battle of the Bay.

In eight at bats over the weekend, Crawford had three hits, two runs scored, one run batted in and one walk with three strikeouts. The Giants won Saturday 7-3 and Sunday 6-4.

As of Monday morning, August 8, San Francisco (53-55) was 6.5 games back of their rival, the San Diego Padres (61-50), who currently hold the third and final Wild Card spot. Both teams will need a WC berth to get into the playoffs as the Los Angeles Dodgers (75-33) are currently running away with the NL West crown. ★
