WEST SACRAMENTO, CA (MPG) -Residents, partners, and Mercy Housing California (MHC) staff gathered on Wednesday, July 20, 2022, to celebrate the dedication of 1801 West Capitol, a permanent supportive housing community including 85 affordable, service-enriched homes for people exiting homelessness.

"These new homes demonstrate what happens when local government leaders have a strong vision for addressing homelessness and partner with Mercy Housing to make it happen," said MHC President Doug Shoemaker.

This new residence is the first permanent supportive housing development in the city of West Sacramento – a landmark achievement for the City, Yolo County, MHC, and the many other partners who contributed time and resources.

"This permanent supportive housing community is a key addition to our network of options which provide services and continued care for unhoused individuals in our City," said West Sacramento Mayor Martha Guerrero. "Already, we've had great success through our Community Outreach and Support Division, the City's work-readiness Downtown Streets Team, and our Homekey Program, which has provided interim supportive housing to more than 100 homeless residents. This new facility allows 85 formerly homeless families and individuals to experience stable housing and maximize self-sufficiency."

"I am pleased that Yolo County had the foresight to financially invest in providing a range of critical wraparound services essential to the residents to help them navigate the process of self-sufficiency, achieve stability and enable their confidence and self-worth to remerge. The first

step of this transformative process is providing a safe space to reside," said Yolo County Supervisor Oscar

"Yolo County Housing Authority is pleased to be a key partner in this much-needed new West Sacramento housing opportunity for low-income families," said Gary Sandy, Chair of the Yolo County Housing Authority Commission. "With the completion of the build, the Housing Authority provided 70 vouchers to the new residents, assuring a stable funding subsidy to the project for the next 20+ years, and allowing individuals – some for the first time in many years - to live in new, safe, decent and affordable housing.'

The 85-home community includes a large, landscaped courtyard, a community room, and meeting spaces. All residents will have access to free, onsite case management provided by Telecare and CommuniCare, as well Continued on page 3

## Dial 988 for the National **Suicide Prevention** Lifeline

WOODLAND, CA (MPG) - As of July 16, 2022, the National Suicide Prevention Lifeline number transitioned to an easy-to-remember and quick to dial 3-digit number: 988. The 988 Lifeline allows anyone experiencing a mental health or substance use related crisis to call or text 988 or chat at Lifeline (988lifeline.org) and connect with trained counselors.

988 Lifeline offers 24/7 access to counselors who are trained to listen, provide support, and connect callers to resources. They can also assist family and friends of someone who may be considering suicide or needs crisis support. There is tremendous need,

In 2020, about 1 in every 8 calls to the National Suicide Prevention Lifeline originated in California; In 2020, the U.S. had one death by suicide every 11 minutes; For people ages 10-34, suicide is a leading cause of death; From April 2020 through April 2021, over 100,000 people died from drug overdoses.

Behind each of these data points, there are people, families and communities who have been impacted. Yet, in the face of these urgent realities, there is hope. The 988 Lifeline helps thousands of struggling people overcome mental-health related distress every day. When Californians dial 988, they will be directed to one of 13 Lifeline crisis call centers based on the caller's area code. If a local crisis center is unable to take the call, the caller is automatically routed to a national backup crisis center. Suicide Prevention of Yolo County (SPYC) is Yolo County's local Lifeline call center and has provided critical crisis support services for Yolo County and beyond since 1966. Each year, SPYC provides immediate phone support to more than 5,000 callers who are contemplating suicide or experiencing severe psychological distress. These numbers are anticipated to increase with the implementation of 988.

## **Yolo Food Bank Receives USDA Funds** to Strengthen Local Food System and Advance Nutrition Security

WOODLAND, CA (MPG) Yolo Food Bank today announced that it is receiving a \$170,000 grant under the U.S. Department of Agriculture's Local Food Purchase Assistance Cooperative Agreement Program (LFPA), which it will use to create new purchasing agreements with diverse local farmers.

"The USDA funds will enable us to expand partnerships with local farmers and ensure broader and more consistent access to nutritious and culturally appropriate food for the vulnerable populations we serve," said Yolo Food Bank Interim Executive Director Karen Baker.

During a tour and press conference at Yolo Food Bank on July 27, United States Secretary of Agriculture Tom Vilsack announced the signing of a cooperative agreement between the U.S. Department of Agriculture and the State of California under

the LFPA, designed to bolster local food and agricultural supply chain resiliency. The Yolo Food Bank grant is part of that program.

Yolo Food Bank currently partners with dozens of large and small farmers countywide, who donate and sell fresh produce for distribution by the food bank. The new funding will be used by Yolo Food Bank to explore potential expanded partnerships with organizations such as Three Sisters Garden, an indigenous-led farm located in West Sacramento's Broderick neighborhood.

"We grow food for the people, by the people right where we live. We look forward to working with Yolo Food Bank on a strategy for making needed additional investments in underserved communities and supporting disadvantaged producers such as Native/Indigenous farmers and farmers of color," said Three Sisters Garden Founder and Operator Alfred Melbourne.

"Broadening our outreach to diverse local farmers creates a more resilient local food economy and also supports our Flipping the Food System initiative, which is designed to ensure that the food we distribute is accessible, nutritious, and culturally appropriate for all residents, including food-system and farmworker families" said Yolo Food Bank's Baker.

System distribution pilot program for farmworker families is being launched

A Flipping the Food on Saturday, July 30 at Durst Organic Growers in Esparto, CA. Both Muller Ag and River Garden

Farms will be future hosts of additional food distribution events in August and September. This effort will result in over 350 farmworker families receiving nutritious and culturally appropriate

Yolo Food Bank is the lead organization in fighting food insecurity in Yolo County. As a Feeding America partner, it coordinates the recovery, collection, and storage of more than 11 million pounds of food annually from grocers and retailers, farmers, processors, and distributors. Through collaborations with the private sector, governmental agencies and nonprofit organizations, the food is provided to those in need through monthly distributions, local food pantries, senior meal delivery programs, migrant centers, college campuses, and healthcare facilities.

## 2 West Sacramento Residents Join **United Way Board of Directors**

- West Sacramento residents Dr. Beverly "Babs" Sandeen and Tahira Cunningham have joined the board of directors for United Way California Capital Region. They will help lead the local nonprofit that is working to end poverty for local families, starting in school.

Sandeen, who served as West Sacramento mayor pro tem in 2016 and 2020, chairs the Los Rios Community College District Citizens' Bond Oversight Committee and serves as vice chair of the Sacramento-Yolo Port District Commission. She is an appointed member on Yolo County's Local Mental Health Board. Sandeen has served as executive director of the Yolo Community Foundation, vice chancellor of resource development at the Los Rios Community College District, chief regional and community engagement

officer at UC Davis and more. She has served on boards throughout the region and state and received numerous awards and commendations. Sandeen holds a doctorate in social ecology from UC Irvine, as well as a bachelor's degree in political science.

"I'm honored to be joining the United Way California Capital Region board of directors to support local families and end poverty," Sandeen said. "The work of United Way is critical to building compassionate communities." Cunningham is vice

president and chief of staff at Bivium Capital Partners, a Black-owned, BIPOC-led firm focused on values aligned investing. Prior to joining Bivium, Cunningham was chief of staff at Alluma, a nonprofit social enterprise. At Sierra Health Foundation, she led the development and implementation of a \$4 million investment strategy to improve health outcomes for boys and young men of color

in California. She also led the health policy agenda with the Greenlining Institute, California Pan-Ethnic Health Network and California Primary Care Association. Cunningham holds an MBA from the University of Phoenix and a bachelor's degree in psychology from Sonoma State University.

Continued from page 1 Covid-19 and the impacts of the pandemic, economic struggles, violence, and political tensions have placed additional strain on the mental health of our community. Having an easy to remember hotline enables those experiencing mental health and substance abuse crises to reach out sooner, and the results can be lifesaving," said Interim Mental Health Director Karleen Jakowski. "We are incredibly fortunate to have SPYC serving as Yolo County's local Lifeline

call center. Over time, the intention is to have the Yolo County Health and Human Services Agency's array of crisis services link seamlessly with SPYC, 988, and local dispatch to ensure callers receive the services and supports they need during times of crisis."

While this is an exciting time to reimagine how we provide crisis services, the full vision of a transformed crisis care system with 988 at its core will not be built overnight. Timely access to appropriate services and supports is critical

and has at times become increasingly challenging as the behavioral health workforce experiences unprecedented shortages, particularly for underrepresented populations. Transformation of this scale will take time, and we must all work together to make it happen.

## Newsom's New Gun **Control Bill Just a Stunt**

Senate Bill 1327 has to be one of the strangest pieces of legislation to ever be passed by the California Legislature and signed into law.

The brainchild of Gov. Gavin Newsom and modeled after an anti-abortion law enacted a year ago in Texas, the measure he signed last week would, at least on paper, subject manufacturers of unlawful firearms to steep civil damages.

The Texas law allows private citizens to sue a provider, patient or anyone involved in an abortion after six weeks of gestation. The new California law would sanction private party suits against arms makers for selling what California defines as "assault weapons," plus "ghost guns" that are assembled from parts without serial numbers.

"Texas and [Gov.] Greg Abbott and their Republican leadership, if they're going to use this framework to put women's lives at risk, we're going to use it to save people's lives here in the state of California," Newsom declared.

In that sense, SB 1327 is just a political stunt, a piece of Newsom's very obvious campaign to raise his national political

standing by taking potshots at Texas and Florida and their Republican governors, rather than serious policymaking.

As he was signing the bill in Los Angeles last Friday, three Texas newspapers were publishing ads taken out by Newsom's re-election campaign sniping at Abbott for restricting abortion while not reducing gun violence – a little gesture to help Abbott's Democratic challenger, former Congressman Beto O'Rourke, as well as garner some more national media attention for Newsom

The conclusion that SB 1327 is merely a publicity stunt is bolstered by the details of the legislation itself.

First of all, SB 1327 would self-destruct if the Texas Supreme Court or the U.S. Supreme Court invalidates the Texas law.

Secondly, there is very little chance that there would be a successful lawsuit. The firearms that are specifically targeted by the legislation are already illegal under California law and the major arms makers that Newsom implies would be punished take great pains not to sell the prohibited products.

Makers of black market "ghost guns" could be sued – but only if one could find them, and even if they were identified, they are not likely to be wealthy enough to attract the attention of a fee-motivated attorney.

Various elements of the bill try to make it impossible for anyone sued to mount a defense, including one passage that

would require damages at least \$10,000 per gun — to be awarded even if a judge declared the law to be invalid. And if the lawsuit provisions of SB 1327 are declared unconstitutional, the measure would substitute civil penalties instead.


Finally, a federal law - rightly or wrongly - protects firearms manufacturers from liability


The bill is so obviously drafted as a political gesture that the American Civil Liberties Union opposed it for using the "flawed logic" of the Texas statute.

"We believe it is a serious misstep to further entrench that flawed logic," the organization said when the bill was going through the legislative process. "In doing so, California will be promoting a legal end-run that can be used by any state to deny people an effective means to have their constitutional rights protected by the courts. This will continue to be replicated in states across the country – and with California's endorsement."

Gun control is a serious subject involving a specific right to bear arms in the Constitution, one that the Supreme Court has recently bolstered in a way that Newsom dislikes. It deserves thoughtful political discourse, not interstate political oneupsmanship.





## **Presiding Judge and Assistant Presiding Judge Announced for 2023–24**

Yolo Superior Court News Release

YOLO COUNTY, CA (MPG) - The judges of Yolo Superior Court have re-elected Judge Daniel P. Maguire as Presiding Judge and have elected Judge Peter M. Williams as Assistant Presiding Judge. Both terms begin January 1, 2023 and extend until the end of 2024.

With the assistance of the Court Executive Officer, the Presiding Judge, or "PJ," leads the court, establishes policies, allocates resources to promote public access to justice and promotes efficiency in court operations and service to the public. The Presiding Judge also maintains his regular judicial duties in the courtroom in addition to his PJ responsibilities.

Following his recent re-election, Judge Maguire said, "Like many other institutions, Yolo Superior Court was challenged by the COVID-19 pandemic, but we adapted by embracing remote appearance technology, which not only helped us to limit backlogs, but also increased access to justice by making it easier for everyone to appear in court. I look forward to continuing to work with our judges, staff, and justice partners to meet tomorrow's challenges."

Appointed to the bench in 2010, Judge Maguire received his Juris Doctor degree from Harvard Law School in 1992, and then clerked for Judge Andrew Kleinfeld of the U.S. Court of Appeals for the Ninth Circuit. He worked in private practice for 12 years, and then served as a Deputy Legal Affairs Secretary for Governor Arnold Schwarzenegger until his appointment. Judge Maguire has had criminal, family,

probate and civil assignments during his tenure, and currently has a juvenile court assignment.

Judge Peter M. Williams was appointed to the bench in 2019 by Governor Brown. Prior to his appointment, Judge Williams was Deputy Secretary, General Counsel at the California Business, Consumer Services and Housing Agency, and prior to that he was an attorney for 15 years in the California Department of Justice, Office of the Attorney General. He received his Juris Doctor in 1995 from the University of San Diego School of Law. Judge Williams has had judicial assignments in arraignments and master calendar, civil, and currently has a criminal court assignment.

### **Two Decades of Saving Lives** with California's Amber Alert

CHP News Release

SACRAMENTO, CA (MPG) -

The California Highway Patrol (CHP) is celebrating the lifesaving collaboration of many partners behind the scenes, including members of the public, who have helped safely reunite hundreds of abducted children with their families during 20 years of the state's America's Missing: Broadcast Emergency Response (AMBER) Alert system.

"The tremendous success of this program would not be possible without the partnership of law enforcement throughout California, broadcasters, government agencies at both the state and federal level, and members of the public," said CHP Commissioner Amanda Ray. "When a child or at-risk individual goes missing, every second counts, and the AMBER Alert program provides

a critical resource for law enforcement and the public."

In July 2002, state law designated the CHP as the statewide coordinator for California's AMBER Alert program. Since the first AMBER Alert activation in August 2002, 376 children or at-risk individuals have been found safe because of the state's emergency alert system designed to recover missing children or at-risk individuals by employing the public's assistance.

The CHP issues an AMBER Alert at the request of a law enforcement agency investigating the abduction of a child or at-risk individual.

For an AMBER Alert to be issued, the CHP works with local law enforcement to confirm: a child 17 years old or younger, or at-risk individual, has been abducted or taken: • the individual is in imminent danger of serious bodily

injury or death; and there is information available that if shared with the public, could assist in the safe recovery of the individual.

As the AMBER Alert program has continued to evolve and through the years, the CHP has added secondary distribution methods to supplement the emergency alert system. These include the Wireless Emergency Alerts program, which is operated by the Federal **Emergency Management** Agency and the Federal Communications

Commission; the California Department of Transportation's Changeable Message Signs on freeways; @ CHPAlerts on Twitter; and the California Lottery displays AMBER Alerts on digital terminal signs and printed on lottery tickets.

The mission of the CHP is to provide the highest level of Safety, Service, and Security.



Better died again. The legislation, if passed, would make permanent the wasteful Obamacare subsidies that went into effect in March 2021 under the American Rescue Plan. and that are scheduled to expire at the end of the

The legislation made Obamacare tax credits more generous for those making less than 400% of the federal poverty level, or about \$111,000 for a

family of four. In addition, it extended subsidies to people making more than four times poverty by capping what they'd have to pay in premiums at 8.5% of income.

The cost of these subsidies has far exceeded early estimates. Though the expansion is only scheduled to last until the end of 2022, the Congressional Budget Office originally predicted it would cost \$34.2 billion over the agency's 10-year budget of the country are newly window.

But a recent CBO report reveals the expansion will cost \$30 billion this year alone - 50% higher than original projections, per former Trump administration economic advisor Brian Blase.

Many of those taxpayer dollars will be funneled to disproportionately wealthy Americans. As Blase has pointed out, couples making \$500,000 in some parts

eligible for more than \$7,000 in exchange subsidies. It's no wonder more than 1 million Americans making over four times the poverty level have enrolled in Obamacare this year.

Forcing taxpayers to continue picking up their health insurance tab will come at an enormous cost. The CBO pegs the cost of a permanent subsidy expansion at \$220 billion.

That's senseless.

Cementing these ill-targeted subsidies in place would create an apocalypse for taxpayers.

## 5 Sacramento-Area Locals Selected in MLB Draft

## Susac, Hjerpe, Vogt, Harvey and Saul chosen

LOS ANGELES, CA (MPG) - Five Sacramento-area baseball players were recently selected in the 2022 Major League Baseball (MLB) Draft that was held over three days at L.A. Live in Southern California from July 17-19.


Daniel Susac, a 6-foot-4, 218pound catcher, was the first Sacramentan taken off the board with the No. 19 overall pick in the first round by the Oakland Athletics. Susac played collegiately at the University of Arizona for two seasons from 2021-22 where he was the starting backstop.

Prior to Arizona, Susac played at Jesuit High School in Carmichael before graduating in 2020. His senior season with the Marauders was drastically cut short by the COVID-19 pandemic.

Susac isn't the first catcher in his family to be drafted to an MLB team in the Bay Area. In 2011, Daniel's older brother Andrew was selected in the second round of the MLB Draft by the San Francisco Giants. Andrew played six MLB seasons for four teams and won a World Series with the Giants in 2014.

Cooper Hjerpe, a 6-foot-3, 200pound left-handed pitcher, was the second Sacramentan taken off the board with the No. 22 overall pick in the first round by the St. Louis Cardinals. Hjerpe played collegiately at Oregon State University for three years from 2020-22 where he was one of the Beavers' best arms. Hjerepe came out of the bullpen in his shortened freshman season before becoming a starter in 2021.

Prior to Oregon State, Hjerpe attended Woodland High School where he pitched and played first base before graduating in 2019. He threw a perfect game for the Wolves against Mira Loma on March 26, 2019, striking out all 15

batters he faced in a dominant 11-0 win in five innings.

Hjerpe now joins the Cardinals organization which is noted as having one of the best fan bases in MLB according to some. Nick Vogt, a 6-foot-1, 185-pound outfielder, was the third Sacramentan taken off the board with the 210th overall pick in the seventh round by the San Diego Padres. Vogt played collegiately at the University of California, Santa Barbara for three seasons from 2020-22 as an outfielder.

Prior to UC Santa Barbara, Vogt attended Davis High School until 2019 where he was not only an impressive athlete on the baseball and football fields, but also a "model student" in the classroom according to Davis Athletic Director Jeff Lorenson.

"Nick was an amazing baseball player for us, but more importantly a model student athlete with the highest degree of character," Lorenson told MPG via email. "He always put his team first and made his school community a better place!"

In addition to his time at Davis, Vogt also spent time playing for another local team, the Yuba-Sutter Gold Sox, who are based in Marysville. Vogt is the grandson of Gold Sox Managing Partner, Al Montna.

According to Gold Sox General Manager Tommy Lininger, over 75 collegiate athletes have moved on to the pros from the Yuba-Sutter-based program. Vogt most recently played for the Gold Sox in 2020, where he played alongside Ryan Harvey.

"It is great to watch these college ball players develop and move forward in their careers," Lininger said in a recent news release. "We had a solid roster in 2020 and it is no surprise both Vogt and Harvey went so high in this year's draft."

Harvey, a 6-foot-3, 195-pound right-handed pitcher, was the fourth Sacramentan taken off the board with the 340th overall pick in the 11th round by the New York Yankees. Harvey played collegiately with Vogt at UC Santa Barbara for three seasons from 2020-22.

Prior to UC Santa Barbara, Harvey attended Woodcreek High School in Roseville where he pitched and played the outfield before graduating in 2019. Harvey played varsity baseball for the Timberwolves for three seasons, reaching the playoffs each year and winning the Capital Valley Conference League Championship once.

"From a very early age, Ryan loved baseball. If something was round, he would throw it. If something was long, he would swing it," Ryan's mom, Keri Harvey, told MPG via email. "Ryan grew up playing recreational sports but chose to focus only on baseball after his freshman year of high school. Endless hours of wiffle ball turned into hours of studying his favorite professional players as he looked to gain velocity as a pitcher in high school. He also changed his diet and spent a lot of time in the gym getting stronger.

'These habits led to his success at UC Santa Barbara where he was the closer for the team because of his pitching velocity. While we

were always there to support him, and he was blessed with some great coaches, Ryan's dedication, commitment and love for the game got him to where he is today, and we are incredibly proud of him."

Eli Saul, a 6-foot-5, 215-pound right-handed pitcher, was the fifth and final Sacramentan taken off the board with the 378th overall pick in the 13th round by the Arizona Diamondbacks. Saul played collegiately at Sacramento State for three seasons from 2020-22.

Prior to Sac State, Saul attended Prince of Wales Secondary School in Vancouver, British Columbia. According to Sac State Athletics, Saul is the seventh Hornet pitcher taken in the MLB Draft over the last four years. Additionally, this is the second consecutive year that Arizona has selected a Sac State pitcher joining Scott Randall who was taken in the seventh round by the Diamondbacks in 2021 and is currently at High-A Hillsboro.


Saul and Randall join Chris Kinsey in 2003 as the three Hornets drafted by Arizona. According to Sac State Athletics, the Hornets have now had at least one player selected in 10 of the last 11 MLB Drafts, with a player chosen every year except for the pandemic-shortened 2020 draft. Additionally, at least one Sac State player has been drafted or signed as a free agent in each of the last 15 years and in 19 of the last 20

One Sacramentan who anticipated hearing his name called and never did is McClatchy High School alumnus, Malcolm Moore. The highly touted 6-foot-2, 210pound catcher, is committed to play collegiately at Stanford. Due to his strong commitment, MLB teams shied away from risking a draft pick on the 18-year-old who was likely going to Palo Alto regardless of where he may have been selected.





## The Forest Alligator Lizard

As I take a late spring, early morning walk at the edge of the woods not far from the creek in southern Middletown, it feels like a luxury to drink in the sounds of these surroundings. I note the scolding squawks of several blue jays in the oaks. They appear to be distressed at the sight of a pair of crows as they near the jay's nests.

In contrast to the cacophony above, the mellifluous sounds of the creek invite me to come closer. As I arrive at a clearing, a Forest Alligator Lizard is sitting as still as a stone in the sunlight. This is the second one I have seen this month! Wanting to watch this elusive and long-bodied creature I step ever closer. Each step I take is a prayer: Please stav awhile so that I may admire your beauty! Just look at those stubby limbs in contrast to its long body. If the lizard's tail has

never dropped then regenerated it will be extra long, with its tail being one and a half to two times its body length. Forest Alligator Lizards often grow to 12 inches in length.

The Forest Alligator Lizard is also known as the California Alligator Lizard, and wears quadrangular scales that are arranged in lengthy rows. The coloration of these lizards can be brown, yellowish, or

even grey. Their distinctive snake-like movements sometimes have them identified as a snake, but they have four legs with which to mobilize themselves near the oak woodlands, chaparral or grasslands.

Secretive, Forest Alligator Lizards can be diurnal, active during the day, crepuscular, or active during twilight or sometimes nocturnal when the weather warms sufficiently.

They are often thought of as secretive, since they can hide and blend in so well with their surroundings, usually on the ground among the leaf or twig litter, or among logs and rocks as they search for their prey. They prefer to dine on insects, spiders, smaller lizards and sometimes bird eggs. Since they are thigmothermic they gather strength and warmth via warm rocks, or by basking in sunlight where there is sufficient and safe cover in which to hide, if needed, nearby.

Alligator lizards are known for their first-rate stalking behavior, as well as their skills in climbing. As an alligator lizard hunts and stalks its prey, it resembles a snake, slithering along the ground while testing the air with a forked tongue. I would love to witness the Forest Alligator Lizard use its tail in a prehensile manner to hold itself safe and sound upon a tree's branches. Since it can climb, this is the

method employed as it sets its sights on a bird's egg for dinner.

What goes around, comes around though, so if the lizard is seized by a predator, it can dramatically thrash about and simultaneously cover itself and an enemy with feces, urine and nastv smelling material which they release from their scent glands. These unique creatures will hiss to inform you of their intense discomfort at your presence if you venture too close. Predators include hawks, bobcats, snakes and more.

If alligator lizards are caught, they have the ability to drop their tails in order to escape their predator. A new tail can grow in as soon as three to five weeks. This tail loss is known as tail autotomy or tail shedding. Then, the dropped tail will wiggle about for around five minutes acting just like a live creature which allows the lizard to escape. While losing a tail can be a life-saver. the down side is that he has

now lost a large store of fat and energy along with an aid to help the lizard keep its balance throughout its hunting and stalking of

All in all, I would consider this a perfect morning. By viewing any of the hundreds of animal species in Lake County I can sense my insignificance in the grand scheme of things, all the while with each natural sighting, be it deer, elk, newt or lizard a surge of gratitude fizzes and wells within me. Nature's gifts lay scattered about, unbidden, but thankfully still abundant, creating room for hope to take root.
