SACRAMENTO REGION, CA (MPG) - For decades the American Legion and its counterpart, the American Legion Auxiliary have been known for their tireless work helping veterans at home and overseas in a myriad of different ways.

County Library's Summer Reading Program Starts June

YOLO COUNTY, CA (MPG) -Join Yolo County Library's annual Summer Reading Program from June 1 to August 15. Children, teens, and adults can participate by logging reading, earning prizes, and enjoying summer camp-style programs and activities, complementing this year's theme, Read Beyond the Beaten Path.

All participants who register for the program at: https://yolocountylibrary. org/summer will receive a free book and welcome bag; everyone who completes their summer reading challenge by earning 1,000 points will receive a free book and prize, plus an entry into a final drawing for additional prizes.

This year's theme, Read Beyond the Beaten Path, evokes summer camp vibes, and the summer reading challenge activities relate to typical camp events, like arts and crafts, campfire, "flat on bunk" (quiet time), science and nature, and sports and recreation. In-person indoor and outdoor activities will be offered at many Yolo County Library branches, and all branches will provide take-and-make kits for all ages. Content changes monthly, and kits will be available while supplies last.

Participants aged 0-5 will also receive an activity booklet designed to engage young learners in fun pre-literacy activities, and thanks to a grant from the Davis Sunrise Rotary Club, ages 6-12 will get a Summer Badge Book filled with reading prompts, enhancement activities, and stickers to log their reading. The program has even more rewards; every week, participants will be entered into a drawing for a \$10.00 gift card, courtesy of Nugget Markets, Raley's, and Target.

Everyone who joins the Summer Reading Program is encouraged to participate digitally through the Beanstack platform on the web or via the app. They can track the books they have read, log reading hours and books, earn badges and prizes, and discover great books. Parents or caregivers can sign up and quickly log their own and their children's reading under one primary account. Instructions are available

on the Library's website. While Yolo County Library has been fine-free since April 2021, participants who still have old overdue fines on their account can select to have up to \$10 in fines removed from their account in place of their finisher prize. Books and prizes can be picked up in person at any Yolo County Library branch. Prizes are available until September 30 or while supplies last.

Research indicates that summer reading programs help children and teens retain and enhance their reading skills over the summer, provide a haven for community readers, and develop reading enthusiasm. Additionally, adult participation encourages caregivers to play a strong role in their

child's literacy development by reading aloud with their child and modeling good reading behavior. Kids read more and enjoy reading more when they can choose what they read.

As beloved poet and author Maya Angelou noted, "Any book that helps a child to form a habit of reading, to make reading one of his deep and continuing needs, is good for him." Yolo County Library joins libraries across the nation to encourage adults, youth, and families to read over the summer. The Summer Reading Program is a project of the California Library Association and part of California's statewide sum-

Meet District Attorney Candidate Cynthia Rodriguez

WEST SACRAMENTO, CA (MPG) - Cynthia Rodriguez has been a lawyer for 40 years and both defended and prosecuted cases, including prosecutions of misconduct in California prisons. She is currently running against Jeff Reisig for Yolo County District Attorney. Cynthia believes that the current policies at the Yolo County District Attorney's Office are biased and that they have been that way for a long

Cynthia has not been a DA before but has served in several other courts including the Appellate Court and Governor appointments. She believes this experience gives her better insight and more knowledge of the entire legal system than what the current DA. In addition, she has served as an advisor to CA Health & Human services and has managed an office with more than 200 employees and a multimillion-dollar budget. Cynthia feels that by not being limited to one position, she has a better understanding of longterm legal issues and would like to help the community with proper programs, rather than focus on convictions.

"I think the people are more interested in what my plan is," Cynthia said, "Reisig['s] got a few backers from big groups. I got a lot of backers from small groups or individuals. I don't have the time or money to run all of my donations against the registry. In addition, when we did find out about a donor being on the registry, we gave that money away. It

was a donation to my campaign, nothing

Cynthia has a plan to overhaul the way sentencing is done in Yolo County. Currently, the DA's office makes you take a plea prior to getting diversion. In many places, and what she would like to see, is diversion be offered when appropriate and if that diversion is not completed, then a plea is entered. This gives incentive to complete the programs and keeps the arrests off of people's records, possibly affecting future jobs.

Cynthia stated that a budget is a system of priorities. She believes that the DA's office should not spend the tax payer's money on inventing new programs or to file lawsuits to undermine what the county voted for. Instead, it should be applied to programs that have a track record of working. Props 47, 57 and 20 were clearly decided by the voters, yet Reisig filed lawsuits to proceed against those decisions.

The candidate stated that the recent inmates that have been released early were strictly in accordance to the law, not due to improper sentencing. She believes that cases need to be reviewed and those cases where the number of years attached to the sentence, due to enhancements, is more than the sentence itself, need to be reevaluated.

"Sentences to crimes are decided by the legislature, however, enhancements are decided by the DA's office. Society and the legal system have evolved, but they have not yet adjusted sentences. That needs to change," she said.

Cynthia wants to eliminate racial bias, fix past errors, decriminalize poverty and reduce poverty crime. She wants to advocate for equal treatment under the law, not sentence people because the office feels there will be future crimes. In addition, she wants cash bail to be based on real risk, not economic status. She wants full transparency by making all decisions made by the office to be available to the public, as well as transparency about the finances so that the public can hold the office accountable.

Yolo County Seeks Input on **Adult Community Corrections**

WOODLAND, CA (MPG)-— The Yolo County Community Corrections Partnership (CCP) will hold community engagement meetings to elicit input on the development of the 2023-2025 CCP Strategic Plan.

In particular, it seeks feedback on its ongoing efforts to reform corrections practices, emphasizing evidence-based practices and cost-effective strategies.

The meetings will take place virtually on Tuesday, July 19, from 2 to 3:30 p.m., and Monday, August 8, from 5 to 6:30 p.m. The community engagement meetings will provide participants background on the mission and goals of the CCP, an update on current projects, and relevant budget information for project funding in the coming years.

"A focus of Yolo County is to implement cost-effective strategies that are known to improve public safety," said Yolo County Chief Probation

Officer Dan Fruchtenicht. Penal Code §1229), "Fortunately, we benefit from engaged residents and a forward-thinking CCP to ensure the 2023-2025 CCP Strategic Plan meets the corrections challenges and needs of our communities."

In 2011, Assembly Bill 109 (Public Safety Realignment) made fundamental changes to California's correctional system to stop the costly, ineffective, and unsafe "revolving door" of lower-level offenders and parole violators. Among other things, AB 109 shifted responsibility for all sentenced non-violent, non-serious, non-sex adult offenders from state to local jurisdictions giving local law enforcement the right and the ability to manage these offenders in smarter, cost-effective ways. Community Corrections Partnerships throughout the state were tasked with planning for the change and implementing local

CCPs are led by county Chief Probation Officers and formed by representatives from the Court: District Attorney's Office; Public Defender's Office; a Chief of Police; Sheriff's Office; County Office of Education; County Heads for Mental Health, Employment, Substance Abuse Programs, and Social Services; a County Supervisor, Chief Administrative Officer, or Designees from the Board of Supervisors; a Representative for Victim Interests; and a Community-based Organization. With com-

munity input, the CCP has developed and implemented two strategic plans since its inception. Members of the CCP will attend the community engagement meetings facilitated and held via

Zoom on Tuesday, July 19, from 2 to 3:30 p.m., and again on Monday, August 8, from 5 to 6:30 p.m.

Faith that Endures Fires

Holy Relics Survive Fire for Future Generations



BRYTE, CA (MPG) - The rebuilding of the historic Holy Myrrhbearing Women Church, located at 833 Water Street, Bryte is progressing nicely after an electrical fire nearly destroyed it in 2018. It was St. Peter and Paul's Saints Day and there were plans for a service. As parishioners arrived for what they thought was going to be a Holy service they saw bibles, religious artifacts and structural pieces of their church in a water soaked pile. The fire was out but emotions had just begun.

Members of the congregation came into the church one after another with tears in their eyes, almost in slow motion, as they looked at the devastation. Many of them went back outside and went right to work, trying to clean up and salvage what they could.

A little girl, about four years old, dressed in a swimsuit and flip flops, and holding a baby doll of some kind, came skipping into the church with a light-heartedness that only a child has. She was swinging the doll back and forth as she playfully skipped in. Suddenly she came to an abrupt stop.

The doll fell to her side, her shoulders dropped, her eyes got big and her jaw dropped open. She stood in that spot and spun around ever so slowly, looking at the blackened, scorched building. By the time she completed the rotation, she had tears rolling down her cheeks. Her long eye lashes were separated from the wetness of her tears. Not a sound came out of her little mouth.

with a toddler on her hip, walked in and knelt down next to the little girl. The little girl fell into her arms and wept into her shoulder. The heart crushing despair was obvious. At four years old all she saw was soot and charred wood and had no idea it could be rebuilt. Almost everything was blackened. The lady tried her best to reassure the little girl, as tears ran down her face as well.

The church was completed in 1925

At about that time, a pregnant lady,

The church was completed in 1925 and was built by the wives of traders who were conducting business at the Sacramento Trading Post (Now known as Old Sacramento). While the men were doing business, the women were using the wood from their ships to build this church. It therefore became known as the Holy Myrrhbearing Women Church.

It was a small church, with only 2 pews for handicapped and elderly. It had a bell tower, a cathedral ceiling over the altar, beautiful stained glass windows and holy icons that covered the walls. The building was still standing, but the fire burned the inside almost to complete destruction. Luckily, that day's service had not started yet so the church was empty and nobody was hurt.

Though not a complete loss, there was significant damage. The fire got so hot that some glass shattered and some glass melted, yet the holy icons of Saint John of Shanghai, which was painted onto gold, did not melt. An icon of the Mother Mary and Jesus called Kazan Kia and St Nicholas (the Wonder Worker) painted into gold were also

undamaged. Their frames and glass were destroyed.

The walls, which were burnt almost to cinders, had fabric pictures of Jesus and the Last Supper that did not even have soot damage. Most things inside that building were completely ravaged by fire, yet these icons (which were located throughout the building) showed no damage.

It's four years later and the church is still under construction. The Church will now be called the Orthodox Church of America. It will have a new look but will still have a working bell tower and an 8-sided steeple holding a golden dome and cross. The new structure will now comply with all ADA requirements. There will be stained glass panels that hang inside, giving the appearance of stained glass windows. The congregation was hoping for completion by Easter, but funding has not allowed that.



National Police Week Remembers Fallen Officers

WOODLAND, CA (MPG) - The week of May 15th was National Police Week, honoring officers who have been killed in the line of duty.

National Police Week has evolved over the years. What began as a Memorial Service attended by 120 survivors and supporters of law enforcement has evolved into a weeks-long event that gives survivors and other supporters an opportunity to come together and honor those law enforcement officers who have died in the line of duty. Originating in 1962 with President John F. Kennedy signing a proclamation designating May 15th as Peace Officers Memorial Day, the week-long event held in Washington D.C. hosts thousands of law enforcement officers from around the world. The Memorial Day also offers several events honors those officers who have died and provides support and supportive services to the families and friends.

The National Law Enforcement Officers Memorial is the nation's monument to law enforcement officers who have died in the line of duty. Dedicated on October 15, 1991, the Memorial honors over 23,000 federal, state and local law enforcement officers who have made the ultimate sacrifice for the safety and protection of our nation and its people since the first known Line of Duty death in 1791. The California Peace Officer Memorial located at 10th Street and Capitol Mall in Sacramento was unveiled on May 13, 1988, as a memorial for these California officers who have paid the ultimate sacrifice. The Yolo County Retired Peace Officers Association spearheaded the effort to get a memorial erected for fallen Yolo County law enforcement officers. This effort led to the unveiling of the memorial in 2013 on the grounds of the old historical Yolo County Superior Courthouse on Court Street.

According to preliminary data compiled by the National Law Enforcement Officers Memorial Fund (NLEOMF), as of December 31, 2021, 458 federal, state, tribal and local law enforcement officers died in the line-of-duty in 2021. This is an increase of 55% from the 295 officers killed during the same period last year, and is the highest total line-of-duty officer

deaths since 1930 when there were 312 fatalities.

Yolo County has endured the loss of 12 of its community protectors since 1912. Most recently, the murder of Davis Police Officer Natalie Corona, which occurred on January 10, 2019.

Newsom's Rosy Budget **Ignores Troubling Trends**

The truly astonishing tax revenue numbers cited by Gov. Gavin Newsom last week as he unveiled a revised state budget bring to mind an old adage: "The bigger they are, the harder

they fall." So much money is pouring into state coffers from personal and corporate income taxes and sales taxes that Newsom said the state will have nearly \$100 billion more than it needs to finance ongoing spending, twice as much as his original budget, proposed in January, estimated.

"You've never seen a number like this," Newsom told reporters.

True enough, and it poses a potential problem that could be just as monumental. Big budget surpluses generate big demands for new spending from the advocates of educational, social welfare and medical services. But if spent on new entitlements, they become liabilities when, inevitably, the economy cools and revenues decline.

Boom and bust budgets plagued the state for decades as personal income taxes became the largest revenue source with much of them coming from a relative few high-income taxpayers. Their incomes, largely from capital gains

on investments, were and incidentally) advocacy are more volatile than those of ordinary people and when they declined, it had a disproportionately heavy impact on the state's finances.

The revised California budget projects \$214.2 billion in direct general fund taxes, with personal income taxes supplying 64% of that. Roughly half of those income taxes come from the top 1% of taxpayers, fewer than 200,000 people in a state of nearly 40 million residents.

In introducing the revised budget, Newsom said he is 'very mindful" of potential volatility and is responding by putting more money into reserves and making very few new permanent and long-term spending commitments.

About half of the projected surplus must, by law, go to public education and expanding the "rainy day fund" and other reserves to nearly \$40 billion. That leaves an estimated \$49 billion of so-called "discretionary income" that could be spent on anything he and legislators want.

Newsom says his budget would devote 94% of that pot of money to onetime allocations or paying down debt to avoid longterm commitments that could backfire should the economy cool and revenues decline. "This is important," he said of that strategy.

Yes it is, because the advocates of expanded entitlements and their legislative allies contend that the surplus is a golden opportunity to fill gaps. Within minutes of Newsom's budget press conference (which was 132 minutes long, groups were expressing disappointment.

The question posed by the astonishingly high revenue numbers is whether the good times — at least the good times for high-income taxpayers — will continue.

As the budget revision was being finalized, the world, the nation and California were experiencing some troubling trends that Newsom acknowledged.

"This May revision reflects a significantly upgraded revenue forecast due to recent cash trends and improvement in key economic indicators," Newsom told the Legislature. "However, the forecast has become more uncertain given Russia's war on Ukraine, high rates of inflation, and anticipated actions by the Federal Reserve to raise interest rates. In addition, capital gains as a percent of the state's personal income are at levels last seen in 1999 – just before the dot-com bust. Furthermore, the May revision forecast was finalized before the recent declines in the stock market."

California is not an economic island and those potentially negative factors are beyond the state's control. However, the budget's very rosy revenue projections ignore them and assume that the golden geese, California's high-income taxpayers, will continue to prosper and continue laying golden eggs.






My Wife is Missing by D.J. Palmer, St Martin's Press

Yolo County Microbusiness COVID-19 Relief Grant Open

YOLO COUNTY, CA (MPG) - On January 25, 2022, the California Office of the Small Business Advocate (CalOSBA) awarded Yolo County grant funding to administer the Microbusiness COVID-19 Relief Grant Program (MBCRG). MBCRG aims to prioritize \$2,500 grant funding for underserved small businesses. These businesses have faced historic barriers to accessing capital, including majority-owned and operated by women, minorities or persons of color, veterans, undocumented individuals, and individuals living in rural or low-wealth areas on low incomes.


Eligible microbusinesses are the smallest businesses that have been severely impacted by the COVID-19 pandemic. Eligibility requirements include:

Business had less than \$50,000 in revenues in the 2019 tax year; Business began operations before December 31, 2019; Business currently has fewer than five full-time equivalent employees and had fewer than five full-time equivalent employees in the 2019 and 2020 tax years; Business was significantly impacted by the COVID-19 pandemic; Business is currently operating or has clear plans to reopen once permitted to do so; Business owner is the majority owner of the qualified business; Business owner's primary means of income in the 2019 taxable year was the business: Microbusiness owner did not receive a grant under the California Small Business COVID-19 Relief Grant Program.

Documentation to verify eligibility includes but is not limited to a local business permit or license, bank statement, tax return, or trade account. CalOBSA limits the eligible uses of funds to costs incurred due to the COVID-19 pandemic and health and safety restrictions, such as business interruptions or business closures incurred due the COVID-19 pandemic.

Applications are reviewed and processed on a first-come, first-serve basis. The program will be open through October 15, 2022, or until all available funds are distributed.



Grant of Parole of West Sacramento Murderer Put on Hold

Office of Yolo County **District Attorney**

WOODLAND, CA (MPG) - On May 16, 2022, at the request of Governor Gavin Newsom, all members of the Board of Parole Hearings (BPH) decided that further review was warranted for the parole grant of 43-year-old convicted murderer Daniel

In 1996 a Yolo County jury found Robinson guilty of second-degree murder for killing 16-year-old Robert Castro in a gang related drive by shooting. At the time of the shooting, Castro was riding his

Robinson.

bike in West Sacramento. Robinson and his friends were associated with the 29th Street Crips. Because they felt disrespected by the Broderick Boys, a West Sacramento gang, they decided to get revenge by shooting Castro, even though they had never seen him, didn't know him, and had no reason to believe he was in a gang. After the jury convicted him of second-degree murder, Robinson was sentenced to 18 years-to-life in state prison.

Robinson had been denied parole at two previous lifer hearings which occurred in 2014 and

2019. On December 15, 2021, a two-member BPH panel granted Robinson a tentative parole date. Upon a grant of parole, the Governor has 60 days to review the Board of Parole Hearing panel's decision. In this case, Governor Gavin Newsom referred the decision to the full Board of Parole Hearings to decide whether the two-member panel's decision to grant parole was improper and did not serve the interests of justice, based on the concerns included in the Governor's referral dated March 25, 2022. The Board of Parole Hearings was also asked

to consider information of institutional misconduct, dated March 22, 2022, and confidential information dated April 19, 2022. Based on the request of the Governor, and the new information, BPH set a "recission" hearing to determine whether the two-member BPH panel made the appropriate decision at the December 15th hearing.

Chief Deputy District Attorney Jonathan Raven attended the May 17th hearing on behalf of the Yolo County District Attorney's Office. Robert Castro's mother, father, and sister also attended the hearing. Raven told commissioners that the Yolo County District Attorney's Office agreed with the concerns expressed by the Governor and that Robinson's very recent rules violations, which occurred after the two-member panel tentatively granted him parole, raised significant issues regarding how the release of Robinson could present a threat to the public.

Yolo County District Attorney Jeff Reisig expressed his satisfaction of the Board of Parole Hearing's decision. "Board members took the concerns expressed

by Governor Newsom to heart," said Reisig. "This was a senseless and horrific gang shooting of 16-year-old boy who was targeted simply because Robinson and his fellow gang members felt disrespected by the Broderick Boys. Clearly, Robinson's very recent violations in prison made the Governor and Board of Parole Hearings uncomfortable with releasing him back into the community."

Robinson's "recission" hearing, to determine whether he will be released into the community, will be scheduled for a date in the near future.








WOODLAND, CA (MPG) - The Yolo County District Attorney's Consumer Fraud and Environmental Protection Division obtained \$3,250.00 in restitution for First 5 Yolo as a result of the Division's recent prosecution of an illegal cannabis grower. First 5 Yolo's mission is to be of service to children during their first five years of life, along with their families, through direct services and systems change efforts.

service; not participate in the cannabis industry for ten years; and pay restitution to First 5

Yolo. Yolo County has dozens of permitted growers operating in compliance with applicable laws and regulations. However, the County remains susceptible to illegal operations that may damage our public and private lands and place into the stream of commerce unregulated and/ or possibly unsafe cannabis. This restitution payment, as ordered by the Court, should further assist First 5 Yolo in raising awareness for some of our County's more susceptible children through their existing programs.

District Attorney Reisig stated, "Our office is committed to pursuing appropriate remedies

against illegal cannabis growers. Criminal law penalties have been significantly reduced for illegal cultivation. Therefore, civil penalties often deliver greater deterrence and accountability in these cases. In addition, as part of such civil cases, we are able to negotiate beneficial payments to groups that advocate for children, like First 5 of Yolo. We support First 5 Yolo's goal of assisting the community to raise safe and healthy children, and we will continue, as appropriate, to assist First 5 Yolo in their mission."

Gina Daleiden, Executive Director of First 5 Yolo, expressed her appreciation stating, "First 5 Yolo is grateful to our District Attorney, Jeff Reisig, for taking action for mothers and their very young children. The dedication of funding for early childhood is a strong statement that DA Reisig understands that investments early in life prevent and reduce more entrenched problems later in life. This action is leading-edge in policy, recognizing the critical and foundational nature or early childhood."

The United Service Organizations (USO) and its work with veterans for 81 years was recognized.

Commander McGuinness honored Suzanne Winters, president of California's 6th district of the American Legion Auxiliary with an award for the work her units accomplished in helping collect food and other items for the victims of Northern California's fires in 2021. In the end 60,000 pounds of goods had been delivered to all the victims of all the fires. McGuinnes spoke of the often-unrecognized work the auxiliary does working side-by-side with the American Legion since its inception.

"As the war in Afghanistan winds down, U.S. military personnel are coming home where they join other recent veterans who served in Iraq. Many of these servicemembers have left the battlefield only to be faced with a new fight: a struggle to overcome the mental and physical wounds suffered during deployment.
