Yolo Co. Board of Education Seeks Replacement Trustee

WOODLAND, CA (MPG) - Matt Taylor, a West Sacramento resident, announced this week that he is resigning from the Yolo County Board of Education after serving for the past seven years. His resignation is effective Tuesday, December 14.

Taylor has represented Trustee Area 1 since 2014, which covers the majority of West Sacramento, excluding portions of the Broderick and Bryte neighborhoods. He is currently president of the Board.

In an email to County Superintendent Garth Lewis, Taylor

resigned from the position stating, "My overly busy schedule and role as a school leader has made it extremely difficult for me to continue serving our students to the best of my ability".

Taylor is in his second term on the Yolo County Board of Education. He was elected to the Board in November 2014, after beating thenincumbent Xavier Gamez by 332 votes. He was re-elected to a second term in November 2018. The term was set to expire in December 2022.

Taylor is Superintendent of the River Charter Schools, which operates charter schools in West Sacramento and Clarksburg. He is also a commissioner on the State Board of Education's Advisory Commission on Charter Schools and serves as an adjunct professor in the School of Education at William Jessup University.

During its regular meeting on Tuesday, December 14, the Board recognized Taylor for his long-time service and contributions. He was provided with an honorary resolution from Assemblymember Kevin McCarty.

The Board also determined the trustee vacancy would be filled by appointment. The state's Education Code states a provisional Continued on page 3

Stay Safe as **Temperatures Dip Near Freezing**

SACRAMENTO, CA (MPG) - Check on elderly family members, friends, or neighbors. Seniors and those with serious medical conditions are at risk. Check on community members that might be vulnerable to ensure they are safely keeping warm.

Where to get help. For information on warming centers and shelter services, call 2-1-1 or go to the 211 Sacramento website.

Sign-up for Emergency Alerts. The Sacramento Region Emergency Notification System alerts residents about emergency events and other important public safety information quickly in a variety of situations, such as severe weather, unexpected road closures, missing persons and evacuations of buildings or neighborhoods.

Heat your home safely carbon monoxide is a silent killer. It is not OK to heat the inside of your home with any kind of BBQ, propane heater, or any other fuel-fired equipment due to the risk of carbon monoxide poisoning. Only use heaters installed with your home and those designed to be used indoors. Make sure that your natural gas furnaces and other appliances are in good, clean working order.

Insulate outdoor pipes that lead into your home to prevent freezing. Seal with caulk around the pipes that lead into and out of your home. Inside your home, leave the bathroom and under-sink cabinets open to help warm the water. If your pipes freeze, leave your tap on and call a plumber. You can defrost your pipes using a hairdryer on a low setting, working your way slowly from the faucet to where your pipe enters the wall. County residents who need to have their water turned off in order to make repairs to their lines can go to 311 Sacramento Connect or download the mobile app or call 3-1-1 (or 916-875-4311 if calling from out of the area).

Ensure proper drainage by scooping up leaves and debris. Keeping storm drains clear can prevent street flooding and black ice from forming.

When raining, reduce your vehicle speed. Wet roads increase the distance and time needed to stop your vehicle. Be extra cautious on roads, bridges, and overpasses when temperatures are 32 degrees or below due to black ice - slow down and give yourself extra spacing between vehicles in front of you.

SACRAMENTO REGION, CA (MPG) - Take Action for Mental Health, a new campaign focused on improving the mental health and wellness of all Californians was launched December 15, 2021. Created to build off progress made by previous campaigns and developed with extensive community feedback, the campaign encourages Californians to take steps to check in, learn more, and get support for themselves and people they care about.

Take Action for Mental Health builds on established approaches and provides resources to equip all Californians to support their own mental health and the mental health of people they care about.

Take Action for Mental Health is the result of considerable in-depth research, focus groups, and stakeholder input. It incorporates input from diverse populations and subject matter experts. The campaign focuses on three key actions -check in, learn more, and get support; Check in: Helps people recognize the signs and symptoms of mental health challenges and identify when to seek help or start a conversation with someone they care about; Learn more: Supports understanding of the issues or challenges associated with mental health concerns and identifies self-care and support options available; Get support: Connects people with

tools and resources to help members, is a leading voice at any point along the mental health spectrum, from needing a mental health day off to securing professional help and everything in between.

The new campaign website, resources, and updated social media channels are going live today with plans to continue adding additional resources, partnerships, events, and programs throughout 2022 and beyond. New or updated resources available at launch include a Take Action Pledge, and overview of signs and symptoms, mental health self-care tips, and mental health guides. The California Mental



Access to Healthcare Expands Christmas Cheer in Broderick for Yolo County Residents

WOODLAND, CA (MPG) - Coinciding today with National Homeless Persons' Remembrance Day, Yolo County and its partnership with CommuniCare Health Center's Mobile Medicine Team announces an exciting expansion of services for all unhoused persons located in encampments, shelters, and migrant work centers countywide. The new team heads to the streets in Woodland on Mondays, Davis on Tuesdays, West Sacramento on Thursdays, and reaches into rural communities like Clarksburg, Dunnigan, Esparto, Guinda, Rumsey Indian Rancheria, Knights Landing and Monument Hills.

Originally, the Mobile Medicine Team's services were limited to Yolo County Shelter-in-Place Motels. Beginning in 2022, care will be delivered out of a new, state-of-the-art medical vehicle equipped for medical and dental care as well as mental health services. Staff includes medical. dental, behavioral health clinicians and peer advocates who provide treatment for chronic disease, acute conditions, wounds, substance use disorders, dental and mental health care. The team will strive to connect patients with ongoing primary care at their assigned or chosen medical home clinic.

"Mobile Medicine is an outgrowth of a unique partnership between the County and our health system partners, targeting services to those disproportionately impacted by poverty and limited access to healthcare," says Karen Larsen, Director, Yolo County Health and Human Services Agency (HHSA). "We are proud to have CommuniCare Health Centers on the streets and in our rural communities where access to care can be a challenge."

The need for mobile medicine will

continue to grow. As pandemic unemployment payments and the eviction moratorium end, more families are expected to slip into unstable housing. Yolo County has experienced a rise in unhoused population coinciding with pandemic-driven illness and job loss. Additionally, farm labor is one of the most dangerous occupations in the country and farmworkers suffer from occupational risks, disproportionate general health issues and extreme barriers to care. Mobile Medicine is an answer to many of the issues outlined for these vulnerable populations.

This service expansion is possible through community benefit investments from Sutter Health, Dignity Health and the Woodland Clinic Medical Group. HHSA is providing the equipment and the new outfitted van. Staffing and operational support is being provided by CommuniCare Health Centers. In total, a more than \$1 million initial investment has been made to care for Yolo County's most-vulnerable residents; this initial funding will last two

Since 1990, the National Homeless Persons' Remembrance Day highlights the plight of our unhoused population and encourages the public to act on their behalf. Each year, we remember those in our unhoused population who have passed away and we strengthen our resolve to build a community where no life is lived or lost experiencing homelessness. This day takes place annually on the longest night of the year, the winter solstice; in 2021, it takes place on December 21. Given the importance of these services for our unhoused population, the partners are excited to share this amazing program on such an impactful day.

Watch for tree limbs. As temperatures dip, trees become vulnerable to limbs snapping. For downed trees or branches in the roadway, County residents can go to 311 Sacramento Connect or download the mobile app or call 3-1-1 (or 916-875-4311 if calling from out of the area).

Prepare for wind. Secure

around and be prepared for the possibility of loss of power. For downed power lines, stay away and call 9-1-1 immediately.

Bring your pets inside when temperatures start to dip near freezing. A dog or cat left outside in severe cold weather can die quickly from exposure. Except for exercise and walks, all dogs and cats yard items that may blow are safer indoors during

the winter. Make sure they have a warm, draft-free place indoors with a dry mat or blanket that they can lie on. For additional winter weather tips for animals, check out the Bradshaw Animal Shelter's website.

appointment must be made within the Board member will serve until 60 days of Taylor's written notice of resignation.

The application to apply for the open trustee seat is available online at www.ycoe.org or in-person at the Yolo County Office of Education during regular business hours. Applications must be received by email, in-person, or postal mail by 12:00 p.m. on February

Interested persons are encouraged to apply for the vacant position and will be eligible to be provisionally appointed to the Board as long as they are 18 years of age or older, a citizen of California, a resident of Trustee Area 1, a registered voter, and free of any disqualification from holding civil

The Board is expected to meet in an open session on February 8, 2022, to review the received applications and interview the candidates. The appointment will become effective upon the Board's approval during the meeting.

After the appointment becomes final, December 2022, at which time he or she may run for election for a new four-year term in Trustee Area 1.

The Yolo County Board of Education makes decisions regarding the Yolo County Office of Education (YCOE), including approving the annual county office budget and acting as the appeals board for student expulsions, interdistrict transfers and charter school petitions. The Board also encourages the involvement of families and communities and is a vehicle for citizen access to communication about YCOE programs and services.

Other members on the Board are President Melissa Moreno, representing Area 2; Vice President Tico Zendejas, representing Area 3; Shelton Yip, representing Area 4; and Carol Souza Cole, representing Area 5.

Homeschooling Will Boom Melting The Coldest of Hearts **Long After COVID-19**

WASHINGTON, DC (MPG) - Student enrollment in public schools has nosedived as parent disgust with school controversial education policies has gone through the roof. In the wake of this enrollment implosion, homeschooling has boomed across

the country. current school year, the U.S. Department of Education estimated that 1.5 million students had left the public schools since the COVID-19 pandemic began.

If students are not enrolling in public schools, where are they going? The numbers show that many former public school students are now being homeschooled.

The U.S. Census Bureau found that the percentage of homeschooling households more than doubled in 2020 from 5 percent in spring to 11 percent in the fall.

According to a recent University of Michigan study, from 2020 to 2021, the enrollment at public schools in Michigan fell by nearly 46,000 students, which represented a more than a 3-percent drop. Among kin- Gomez, an immigrant from decrease of more than 11

percent. The increase in homeschoolers does not come from just a narrow segment of the American population. A University of Washington Bothell analysis found, "The diversity of homeschoolers in the U.S. mirrors the diversity of all students nationally," including all racial, religious, political, and income groups.

For instance, the Census

At the beginning of the Bureau found that among the increase in homeschooling was much steeper than in the country as a whole, rising from 3 percent to 16 percent, a five-fold jump.

This increase in African American homeschooling is not surprising given recent research by McKinsev & Company that found "Students in majority Black schools ended the [2020-21 school] year with six months of unfinished learning."

Demetria Zinga, one of the country's top African American homeschool YouTubers, says, "I believe homeschooling is growing and exploding amongst African Americans and there will be more and more homeschoolers."

Homeschool mom Magda dergartners, there was a Mexico, has become an activist for homeschooling in the Hispanic community.

> She observes: Hispanics as a culture are usually very protective and loving towards our children. However, I explain that love is not enough to raise our children. We have to educate ourselves in different areas of education, especially since we are not in our [native] country but are immigrants."

"It is my dream," she says,

"to see more Hispanic fami-African American households lies doing homeschool." Her dream is coming true with homeschooling doubling among Hispanic households, from 6 percent to 12 percent.

In addition to the racial diversity of homeschoolers, in 2021 the school-choice organization EdChoice found: "Many parents of children with autism, ADHD, and other neuro-developmental disorders report that public schools cannot effectively address their child's specialized learning needs."

Pediatric nurse and homeschool mom Jackie Nunes unenrolled her specialneeds daughter from public school saying, "There just wasn't enough of the things that matter - time, attention, patience, persistence, passion, support."

The COVID-19 pandemic has exposed all the flaws in the one-size-fits-all public schools, which is why the homeschool boom is shaking up American education.

Yolo County Health Order Requires More COVID-19 Testing

WOODLAND, CA (MPG) - With skilled nursing facility (SNF) residents vulnerable to severe disease caused by the rapidly spreading Omicron variant of the SARS-CoV-2 virus, Yolo County Health Officer Dr. Aimee Sisson issued a Health Order (PDF) requiring individuals working in SNFs to be tested twice weekly for COVID-19 regardless of their vaccination status. Visitors to SNFs must also provide proof of a negative test for COVID-19 regardless of their vaccination status. The Order goes into effect on December 27, 2021, and will remain in effect through January 31, 2022, unless otherwise ordered by the Health Officer.

Of the 266 confirmed COVID-19 deaths in Yolo County residents to date, 27% (72) have occurred among residents of SNFs. In order to prevent additional deaths among SNF residents this winter, the Health Officer is requiring SNFs to put additional protections in place. While vaccinations, including booster doses, provide vital protection against serious COVID-19 disease, older adults with underlying conditions may still develop severe COVID-19 illness despite vaccination. Testing all individuals entering SNFs will reduce introduction of the virus into facilities. Because even fully vaccinated and boosted individuals can become infected with the Omicron variant, verifying staff and visitor vaccination status is not sufficient to protect vulnerable residents.

The local Health Order is being issued in addition to the updated State Public Health Officer Order announced on December 22 that requires SNF workers who are eligible to receive a COVID-19 booster dose to get a booster shot by

February 1, 2022.

"We have a responsibility to protect vulnerable residents of skilled nursing facilities from COVID-19," said Dr. Sisson. "The highly transmissible Omicron variant will be difficult to stop once it is introduced into a skilled nursing facility, so we need to take additional steps to keep the virus out of these facilities in the first place. Requiring everybody entering a facility to have a recent negative test for COVID-19 is a critical step to keep residents safe."

Similar to State requirements for those attending Mega Events, visitors will be required to provide proof of a negative test within 1 day prior to the visit for antigen tests or within 2 days for molecular (including PCR) tests. Exceptions to the testing requirements will be made in the event of compassionate care visits, such as for a dying resident. For visitors, any of the following will be accepted as proof of a negative test:

A printed document from the test provider or laboratory

An electronic test result displayed on a phone or other device from the test provider or laboratory

A test conducted in the presence of skilled nursing facility staff.

Matsui Statement on Biden Administration's Tailpipe Emissions Rule

WASHINGTON, D.C. (MPG) - Congresswoman Doris Matsui (CA-06), issued the following statement following the Environmental Protection Agency's (EPA) announcement of its finalized Clean Cars Rule updating tailpipe emissions standards.

"As we work to aggressively combat the climate crisis, I have been unwavering in my calls for ambitious vehicle emission standards and bold federal policies that improve air quality," said Congresswoman Matsui. "Today's announcement by the Biden Administration and the EPA is a decisive action necessary to reaching our goal of cutting U.S. climate pollution in half by 2030 and protecting the environment, communities, and our public health. After four years of reckless rollbacks by the Trump Administration, there is no time to waste. We need to advance clean transportation technology, ramp up the deployment of zeroemission electric vehicles, and make the crucial investments necessary to protect our future. This is the time to think bigger and bolder on our climate goals. I applaud the agency's announcement and look forward to working with the Biden Administration to continue strengthening our transportation

emission standards, improving air quality for communities nationwide, and achieving our goal of electric vehicles accounting for 50% of new car sales by 2030 and 100% of new sales by 2035."

In August, the Biden Administration released their proposed tailpipe emission standards to replace the Trump rule that had rolled back Obama-era standards. During the public comment period - the Administration also considered two alternatives, including a stronger proposal that was closer to the original Obama-Biden standards. Last month, Congresswoman Matsui and Senator Markey led a letter to EPA Administrator Michael Regan, urging the agency to choose the stronger alternative. The rule announced incorporates many of the policies urged in the letter.

Congresswoman Matsui has long been a champion of bold climate action and the adoption of ambitious vehicle emission standards. In March of 2021, she led a letter with 70 of her colleagues urging the Biden Administration to take action to reinstate California's Clean Air Act waiver and restore the Obama-Biden tailpipe emission and fuel economy standards. She is also the author of the Clean and Efficient Cars Act, a bill that would codify the Obama-Biden standards which were rolled back during the Trump Administration.

Floodplain Restoration Areas Taking **Shape Along Southport Levee**

City of West Sacramento

WEST SACRAMENTO, CA (MPG) - The Southport Levee Improvement Project, completed in 2019, created two floodplain restoration areas. In just two years those areas are maturing into a rich riparian forest along the west bank of the Sacramento River.

The Project was designed to achieve 200-year flood protection for the City of West Sacramento and to provide project habitat mitigation. These mitigation areas are located upriver and downriver from Bees Lakes, an existing mature

riparian habitat. More than 76,000 plants were installed on 120 acres in 2019. River Partners is the West Sacramento Area Flood Control Agency's restoration contractor responsible for planting, irrigation, and removal of invasive species. Check out River Partner's drone flight overhead:

The restoration areas are planted with a variety of trees, shrubs, grasses, and forbs to mimic natural riparian development along the Sacramento River. In addition, there has been significant natural recruitment of willows, cottonwoods, and other riparian species.

Three Charged with Retail Theft **Crimes in West Sacramento**

Yolo County District Attorney

YOLO COUNTY, CA (MPG) -On December 23, 2021, Hank McGee, age 61, and Mark Ray, age 61, were arraigned in Yolo County Superior Court and pled not guilty on multiple charges alleging retail theft. A third person involved in the thefts, 45-year-old Satin Bowman, was scheduled to be arraigned but she did not appear in court. All three are from Sacramento.

The three were arrested by the West Sacramento Police Department on December 21, 2021, after a several month long investigation into a series of thefts in Sacramento and Yolo counties. The Yolo County District Attorney's Office filed a criminal complaint on December 22, 2021, alleging organized retail theft and one count of conspiracy for all three which occurred during the timeframe of August 19, 2021 to December 21, 2021. Bowman was also charged

with a felony count of robbery for an incident on December 8, 2021. Ray was additionally charged with having been convicted of prior strike offenses.

McGee and Ray are scheduled for a Preliminary Hearing on January 10, 2022. Bowman will be arraigned on Monday, December 27, 2021. All three remain in custody with bail set in the amount of \$10,000 on McGee, \$20,000 on Ray, and \$50,000 on Bowman.

Lessons of Socialism

As the second test came, the students who studied little, studied even less, and those who studied hard were now less motivated and studied less.

The second test average was a D! No one was happy. The third exam averaged an F grade.

As the tests proceeded, the scores never increased. Bickering, blame, and name-calling resulted in hard feelings, and no one would study for the benefit of anyone else.

To their unpleasant surprise, ALL FAILED, and the professor told them that socialism would also ultimately fail. "When the reward is great, the effort to succeed is great, but when government takes the rewards away, the motivation to succeed is taken away too!"

shell. And coincidentally, last night at dinner a contractor advised he cannot find any employees because they prefer to stay on the expanded unemployment. To lure a talented electrician to work, he finally had to pay him the \$600 unemployment bump out of his own pocket, PLUS his regular wage! And a nurse who works two jobs responded that nobody ever helps him with his bills and he's tired to supporting everyone else through his taxes! Unemployment sounded appealing to him!

Let's learn from history. Remember, after World War II, Britain, Israel, and India all turned to socialism, only to turn back to capitalism. Socialism's critical defect is that it ignores the power of incentives and basic human

UC Davis Genome Center Sees Increase in Omicron Variant

Yolo County Press Release

DAVIS, CA (MPG) - The UC Davis Genome Center detected and confirmed 42 cases of the B.1.1.529 (Omicron) variant of SARS-CoV-2, the virus that causes COVID-19 in Davis, El Macero, West Sacramento and Woodland. The Omicron variant had previously been detected in West Sacramento, but this marks the first known cases of Omicron in the Davis, El Macero and Woodland communities. The Omicron variant has also been detected in trace amounts in the City of Davis' sewage through Healthy Davis Together's wastewater monitoring initiative. The UC Davis Genome Center screens

every positive COVID-19 test conducted by Healthy Davis Together for all currently known SARS-CoV-2 variants of concern so that action can be taken to alert and protect the community. The individuals who had a positive PCR test result for the Omicron variant were tested between December 12-18, 2021. Several of the Davis cases are associated with a single workplace holiday party. The party, with approximately 50 attendees, and subsequent workplace spread are associated with an outbreak of at least 16 cases, of which 10 are known so far to be Omicron. Of the 16 cases, all were fully vaccinated and eight had received their booster. Currently all known Omicron cases are in isolation or have completed isolation.

"The Omicron variant is spreading quickly in Yolo County, and accounted for 41% of new cases detected by the UC Davis Genome Center last week," said Dr. Aimee Sisson, Yolo County Public Health Officer. "The spread of Omicron is coming at a time when many people are travelling and gathering for the holidays. Everyone, including fully vaccinated persons, should take additional precautions right now. Wear a mask that fits and filters well when you are indoors, improve indoor ventilation with portable air filters, and ask everyone attending a gathering to test right before the event. In addition, anyone who isn't vaccinated or boosted should get vaccinated as soon as possible in order to protect themselves against severe COVID-19 illness."

The detection of the Omicron variant through clinical testing comes as genetic markers of the variant have been identified in the city's wastewater by Healthy Davis Together and its partner the Sewer Coronavirus Alert Network (SCAN). Davis

is one of eight sewage treatment plants that SCAN monitors by testing daily samples of solids in wastewater, which carry signs of the virus and its variants if present in a community. Wastewater monitoring is another tool that can be used as an early detection system for new strains and future spikes of

"The information collected through Davis' wastewater monitoring program can be useful in our long-term community effort to reduce the spread of COVID-19," said Brad Pollock, Director of Healthy Davis Together, and Chair of the UC Davis Department of Public Health Sciences.

The Omicron variant has been previously identified as a variant of concern by the U.S. Centers for Disease Control and Prevention (CDC) and the World Health Organization (WHO). The CDC is working with other U.S. and global public health and industry partners to learn more about this variant, including how severe its cases are compared to other variants and the amount of protection provided by existing vaccines. Until more is known, it is important to take every precaution to prevent the spread of the new

Here are the most important things people can do right now to prevent the spread of COVID-19, including the Omicron variant:

Get vaccinated. With the recent approval of the Pfizer vaccine for children from 5-11 years of age, HDT strongly encourages everyone 5 years and older to get vaccinated; If you're already vaccinated, get boosted 2 months after a J&J vaccine and 6 months after the 2nd Moderna or Pfizer vaccine; Get tested if you have symptoms or have been exposed to someone infected with COVID-19; If you are planning to travel or gather, it's recommended that you get tested one to three days prior to and three to five days after traveling or gathering, even if you're vaccinated. If you aren't vaccinated yet, it's important to get tested regularly; Follow local mask guidance. N95s, KN95s, and KF94s provide additional protection and are a good option for those more vulnerable to severe disease, for example, older adults and people with underlying conditions.

Enrollment Declines Squeeze Local School Finances Lucai ociiuui i illalicco

The 1970s and 1980s were a tumultuous time for California's public schools,

• A tidal wave of kids from the post-World War II baby boom pushed school enrollment to well over 4 million, but the end of the boom in the mid-1960s and a slowdown in overall population growth drove enrollment downward in the 1970s. Throughout the state, local school systems pared back school construction, sold off school sites and even closed some

• At the time, schools were largely financed by locally imposed property taxes but in 1971 a successful lawsuit, Serrano vs. Priest, declared that widely varying taxable property values among the state's school districts unfairly disadvantaged children in low wealth communities. In response, the Legislature began overhauling school finances to provide what was called "equalization."

• Subsequently, however, in 1978, voters passed Proposition 13, which clamped tight limits on property taxes, compelling the state to assume the fundamental task of financing schools from income and sales taxes and thus shifting

wrangling over education finance to the state Capitol.

• California's population soared in the 1980s due to high immigration and birth rates and so did school enrollment, eventually topping 6 million. In 1988, a decade after Proposition 13's approval, the education community persuaded voters to pass Proposition 98, an extremely complex measure that dictates how schools' share of state revenues is calculated. It has dominated the state budget process ever since.

This snippet of political history is offered because it

could be repeated. California's once-soaring population has slowed to a trickle, or perhaps even reversed, due to sharp declines in immigration and birth rates. Also, school enrollment, which topped out at 6.2 million a decade ago and remained virtually unchanged until recently, is beginning what demographers believe will be a steady decline.

The COVID-19 pandemic is partially responsible for some recent declines but the state Department of Finance projects that underlying demographic trends will drop enrollment to 5.5 million by 2030, some 700,000 lower than the peak.

"Projected declines are greatest in Los Angeles and Ventura Counties roughly 20% lower by 2030 – 31," a recent study by the Public Policy Institute of California declares. "The declines in Los Angeles County are particularly noteworthy: county enrollment has already fallen over 10% in the past decade, and enrollment in 2030 - 31 is projected to be 30% lower than it was in 2010 - 11.

State aid to schools is largely driven by enrollment, so districts that are seeing major declines, particularly large urban systems such as Los Angeles Unified, are beginning to feel the financial pinch and confronting the unpopular task of shutting neighborhood schools.

At the moment, school finances have a respite. Gov. Gavin Newsom and legislators have decreed that state aid is temporarily based on pre-pandemic enrollment but the "hold harmless" gesture is due to expire next year. What happens after that is anyone's

Decreasing enrollment could be beneficial in the long run, because it could increase per-pupil spending. But that would depend on the willingness of state politicians to once again change the methodology of school financing, moving away from its enrollment base to some other model.

Given the tens of billions of dollars at stake, however, a major overhaul would be a tough political slog. Until and unless it occurs, the local systems seeing the most dramatic enrollment declines will have a difficult time balancing their budgets as their state aid shrinks and their fixed costs, such as pension fund contributions, continue to rise.

"BEING THE RICARDOS" TV GOLDEN AGE; "KING'S MAN" PREQUEL

A Film and TV Review by Tim Riley

Released theatrically, "Being the Ricardos" may now also be enjoyed from home on Amazon Prime Video. Watching this on television is fitting since this is the story of the production for the popular "I Love Lucy" series.

The Ricardos, of course, refer to the stars of the show, Lucille Ball (Nicole Kidman) and Desi Arnaz (Javier Bardem), real-life married couple in the parts of Lucy and Ricky Ricardo, respectively the quintessential dizzy redhead and the charismatic Cuban bandleader.

Written and directed by Aaron Sorkin as a behind-the-scenes drama, "Being the Ricardos" is structured to capture a single week of production from the Monday table read through the Friday live audience taping, interspersed with flashbacks of the couple's fascinating history.

During the course of a week during a second season in 1952, Sorkin has crammed enough crises into the story that would under normal circumstances sink the careers and professional reputations of all parties involved.

As if the short window of producing one episode is not filled with enough

predicaments, flashbacks and leaps into the future provide glimpses of the turbulent relationship of Lucy and Desi, from a whirlwind courtship to the burning ambition that made them leading television innovators.

Muckraking gossip columnist Walter Winchell drops a bombshell charge that Lucy's past is linked to membership in the Communist party, while a tabloid spreads rumors of Desi's alleged infidelity.

Meanwhile, Lucy reveals that she's pregnant and Desi wants to incorporate her pending maternity into a storyline, but executives of Philip Morris, the show's sponsor, object strenuously to changing the show's formula.

Nevertheless, plenty of spectacle consumes the actual show, with J.K. Simmons and Nina Arianda bringing humor and tension to the set as actors William Frawley and Vivian Vance in the roles of Fred and Ethel Metz, the comic foils as Lucy and Desi's neighbors.

The behind the camera action in the writers' room adds another enticing dimension to the "I Love Lucy" saga. Tony Hale shines as producer Jess Oppenheimer, and the writing team of

Madelyn Pugh (Alia Shawkat) and Bob Carroll Jr. (Jake Lacy) have standout moments of competitive banter.

One drawback to "Being the Ricardos" might be how Sorkin unpacks the storyline with an overabundance of subplots, which in reality did not converge during the same week. Liberties have been taken with the chronology of events, as Sorkin shuffled the deck to make a bet-

To build the film's narrative, Sorkin places obstacles in front of his characters with the end goal of informing and entertaining. As a result, there's a case to be made here that Lucille Ball and Desi Arnaz get their due as Hollywood pioneers in the Golden Age of television.

"THE KING'S MAN" RATED R

As is the case with most sequels in a franchise, the question is whether the latest installment is unnecessary or inevitably forgettable or just maybe a combination of both.

Reflecting upon the latest James Bond film "No Time to Die," I now ponder the notion that the beloved spy series enjoyed for so many decades has lost its impetus. At least, 007 had a good run, but the same may not prove true for the "Kingsman" franchise.

Set at the turn of the last century leading up to World War I, "The King's Man" can't decide what kind of movie it wants to be. Is it a war drama or espionage tale? Does it expose Britain's brutal colonialism? How does pacifism coincide with its violent action?

However, "The King's Man" is a

prequel to "Kingsman: The Secret Service" and the origin story for the autonomous intelligence agency designed to be cut loose from the bureaucracy of a government-run spy organization.

The leading character of the Kingsman organization, operating stylishly out of the eponymously-named gentleman's tailor shop on London's Savile Row, is Ralph Fiennes' aristocratic Orlando, the Duke of Oxford.

For one running an elite espionage outfit, that the Duke of Oxford is so committed to pacificism in the face of the looming World War I seems incomprehensible without the knowledge of his past experiences and concern to keep his son Conrad (Harris Dickinson) from joining the Army.

As a trusted ally to King George (Tom Hollander, who also plays Tsar Nicholas and Kaiser Wilhelm), Oxford comes to realize that global conflict is inescapable and hence a clandestine group must be formed with the help of Shola (Djimon Hounsou) and Polly (Gemma Arterton).

Conrad defies his father's wish and enlists with a desire to be sent to the front lines, ending up in fierce trench warfare that is as bleak and grim as anything seen in war movies such as "Saving Private Ryan" and more on point in "1917."

For his part, the Duke of Oxford rises to the occasion for a mountaintop showdown with a Bond-like villain, parachuting from a plane and jostling with a mountain goat. "The Kingsman" allows for the erudite, polished Duke of Oxford to be a different yet rousing kind

State Finalizes Groundwater Management Principles and Strategies

California Water Board Press Release

SACRAMENTO, CA (MPG) -The Department of Water Resources and the State Water Resources Control Board today issued final groundwater management principles and strategies to help protect drinking water wells from the impacts of

drought. Developed in response to Governor Gavin Newsom's drought state of emergency proclamation in April, the principles and strategies provide a framework for state actions to proactively address impacts on groundwater-dependent communities as droughts

intense as a result of climate change. These principles and

strategies incorporate

become more frequent and

hundreds of public comments received earlier this fall, including written comments submitted to DWR and feedback at public workshops and webinars.

"Ultimately, sustainable groundwater basins will help Californians manage through drought - especially those dependent on domestic wells. But we're simply not there yet. These principles will help state agencies, local governments and communities address very real domestic well outages that are starting to occur," said DWR Director Karla Nemeth. "A big thank you to the members of the public who shared their insights with DWR. We are ready to implement."

"We are in a severe drought that, with declining groundwater levels, threatens drinking water wells and makes harmful contaminants become more concentrated in certain areas," said Joaquin Esquivel, chair of the State Water Board. "Articulating clear principles and strategies to manage groundwater, while protecting drinking water, improves the drought resilience of our rural and often disadvantaged communities, who are most burdened and impacted by deteriorating conditions."

The final principles and strategies provide a shared policy framework of nearterm drought response and long-term resilience actions by state agencies for those that rely on groundwa-

islation (Senate Bill 552), the implementation of the tools, such as the recently Sustainable Groundwater Management Act (SGMA), and the Safe and Affordable Drinking Water Fund for Equity and Resilience (SAFER). Following these principles will result in increased coordination and engagement with non-government organizations, Tribes, water agencies, groundwater sustainability agencies, and other local entities to ensure state resources and action support state and local needs. California is committed to ciples describe how to

2021 drought planning leg- increasing the frequency of forecasting data and released California's Groundwater Live website, which supports data-informed decisionmaking and helps prioritize funding for emergency and long-term projects to support communities with drought resilience.

The framework prioritizes protection of public health and safety, as well as preparation and mitigation for the effects of drought conditions over the long term. Six prinaddress drinking well water impacts, and include strategies to achieve drinking water resiliency, integrate equity, identify underlying challenges, use best available data, build trusted relationships, and implement lasting solutions.
