

## Airshow Cleared for Take-Off

Limited Tickets Available to this Year's Event

SACRAMENTO REGION, CA (MPG) - The California Capital Airshow (CCA), presented by Sacramento County in partnership with the City of Rancho Cordova, announced details for a "reimagined" 2021 event on Sept. 24, 25, and 26 featuring the world-famous United States Air Force Thunderbirds, Royal Canadian Air Force Snowbirds and F-35 Lightning jet demonstration teams. These mighty military jets are ready

and raring to rock the skies over Sacramento, and the long-awaited ticket release is preparing to launch.

Returning to Sacramento County's Mather Airport for its 15th year, the Airshow offers more than four hours of thrilling flying performances on Saturday (Sept. 25) and Sunday (Sept. 26). Additionally, massive military aircraft will be on display and interactive STEM (Science, Technology, Engineering, and Math) experiences for kids and families to enjoy from 9:00 a.m.-5:00 p.m. each day. But that's not all; buckle up for

the addition of an all-new third day of Airshow excitement on Friday (Sept. 24)!

With limited capacity for this year and pent-up public demand, the CCA team developed an alternative to the more traditional event, a drive-in Airshow for Friday ONLY that will take place from 3:30-7:00 p.m. This unique event is likely the first and last of its kind. The performances, narration, and music will be different from Saturday and Sunday's events, and more than 25 military jets will

## Yolo County Issues Emergency Proclamation

WOODLAND, CA (MPG) - Yolo County has issued an emergency proclamation due to exceptional drought conditions in the unincorporated areas of the county and urges all residents and businesses throughout the county to immediately begin conserving water. Due to little rainfall, historically dry conditions, and exceptionally warm temperatures in April and May, Yolo County is in an 'exceptional drought,' characterized by dry wells, depleted reservoirs, and nearly dry surface water leading to insufficient water for agriculture, wildlife, and urban needs. In an exceptional drought, water quality decreases along water supply and fire season lasts year-round while increasing in intensity, threatening drinking water, irrigation supplies, wildlife habitat, and agricultural economic activity.

"The severity of the drought in Yolo County highlights the need to take simple actions to conserve water to ensure sustainable water supplies," said Chair of the Yolo County Board of Supervisors Jim Provenza. "As a community effort, we ask that residents do what they can to conserve water."

In May, Governor Gavin Newsom added 41 counties, including Yolo County, to the State's drought emergency list that was first announced in April. In July, the Governor signed an Executive Order, which expanded the drought emergency list to include 50 of California's 58 counties and called on all Californians to voluntarily reduce their water use by 15 percent compared to 2020 levels.

The issuance of a local emergency proclamation will allow Yolo County to set rules, regulations and other mandates as deemed necessary to reduce water usage during this emergency to protect the safety of persons and property within the unincorporated areas of Yolo County.

In conditions of exceptional drought, it is more

## Masks Required Indoors in West Sac and Yolo

YOLO COUNTY, CA (MPG) - Effective Friday July 30, face coverings will be required in all indoor public spaces regardless of vaccination status in Yolo County to help slow a rapid surge in the number of COVID-19 cases.

Since the statewide transition easing COVID related restrictions on June 15, Yolo County's COVID-19 case rate has risen eight-fold from 1.2 to 10.0 per 100,000 residents and has been followed by increases in COVID-19-positive patients in hospitals. Rising case rates, testing positivity, and hospitalizations are largely due to the predominance of the highly infectious Delta variant, which is more

than twice as contagious and may double the risk of hospitalization compared to the original virus. Since mid-April, the UC Davis Genome Center has detected 158 cases of the Delta variant, including several in West Sacramento, which made up 88% of positive samples collected during the week of July 18. The Yolo County Public Health Officer continues to recommend that fully vaccinated individuals get tested for COVID-19 following an exposure to someone with COVID-19, even if they have no symptoms.

The new Order will remain in effect until the case rate falls below 2.0 per 100,000 residents for 7 consecutive days. The same exemptions apply under the local universal

indoor masking order as the State's current face covering guidance and include persons under age 2 and persons with medical conditions or disabilities that prevent wearing a mask.

"With case rates as high as they are and rising, everybody needs to add an additional layer of protection in the form of a mask when they are indoors," said Yolo County Public Health Officer, Dr. Aimee Sisson. "Vaccines are still the best protection there is against ending up in the hospital or dying from COVID-19, and I continue to strongly recommend that everybody who is eligible get vaccinated. Vaccines are safe, effective, and free. But the vaccine alone may not be enough to prevent mild illness or infection, and that

is why everybody will now be required to wear a mask indoors, regardless of their vaccination status. Putting on a mask is a simple act that will help keep business open and protect residents from the highly contagious Delta variant."

All residents 12 and older are strongly encouraged to get vaccinated as soon as possible. Residents throughout the county who would like to get vaccinated for FREE at their home or place of business can call (530) 666-8665 to schedule an appointment.

# Sacramento Motorcycling: A Capital City Tradition

**SACRAMENTO REGION, CA (MPG)** - “Zip, Speed, Sport, Thrills.” These four words describe a sport which came roaring into the Sacramento area in the early 1900s bringing with it ready-made participants, audiences, and prominent men and women ready to become involved in its success in Sacramento and beyond.

The quote, printed in the Sacramento Bee on May 16, 1929 is from Frank J. Murray, the first exclusive Harley Davidson dealer in Sacramento.

The newly released book, “Sacramento Motorcycling: A Capital City Tradition,” written by Kimberly Reed Edwards, a native Sacramentan, is a page turner, full of local cities and addresses, sports venues, places of business, and residents from many walks of life who helped put Northern California on the map as one of the biggest motorcycle hubs in California.

As the author explains, this distinction was bound to happen. Sacramento had always been a racing town and its residents had a love affair with spectator sports. Before this “motorized bike” arrived on the scene, bicycle races put on by the Capital City Wheelmen brought audiences for competitions at Agricultural Park at G and 22nd, eventually moving to the new State Fairgrounds Riverside and Stockton. There, Sacramentans were roused by exciting motorcycle races more thrilling than ever seen here.

A love of the sport quickly developed that crossed ages, jobs, education, occupations, and social standing.

In 1913 two clubs merged to become the Capital City Motorcycle Club. The Capital City Wheelmen, formed in 1886, was the second oldest bicycle club in Northern California. But as their membership aged and became more social, their sights turned to the Sacramento Motorcycle Club, holding races as early as 1910. Members from both clubs realized that the Wheelmen had the political connections while the new club would provide new blood.

Two decades later, the Fort Sutter Motorcycle Club was formed primarily for Indian riders, but welcoming bikes of all makes and models.

Group rides travelled to destinations including Elk Grove, Folsom, Auburn, and Delta towns. Hill climbs, races, and scrambles took place from Placerville to Stockton,

Murray’s sister-in-law Irene Kaminsky was one of three sisters who started the women’s motorcycle club, the Sacramento Cyclettes. She and her husband Julius loaned money to the Cyclettes and the Capital City Motorcycle Club to build their respective clubhouses. At age 45, she learned to golf after attending a driving range clinic on Auburn Boulevard, now known as Haggin Oaks Golf Course. With practice and determination, she became

a consistent golfer. In 1953, she was elected to the Sacramento Golf Council, where she served as treasurer. By some accounts, she was the first female council member. Elected as a charter member of the Sacramento Women’s Golf Club, she served as president for two years. She helped to organize tournaments and banquets for area golfers and became known as the “Mother of Junior Golf.” Edwards’ book has a myriad of photos of women riders, prim and proper when not competing.

Norris Rancourt, a well-known West Coast competitor who rode the famous Orrin-Hall built “Gadget” in the 1960s, later became Sacramento’s first Honda dealer and the 29th in the United States, located on Fair Oaks Boulevard.

One element of society that the motorcycle industry impacted a great deal was law enforcement. In preparation for World War II, police officers trained for a possible invasion with steel helmets, gas masks and machine guns on their eighteen-inch Harleys.

According to Edwards’ biography in the book, “Her father owned a small motorcycle shop near the railroad tracks in downtown Sacramento. She compiled this history to honor the Sacramentans who shaped the early motorcycle craze, beginning with the Capital City Wheelmen, early dealers, downtown merchants and a group of ardent riders.” Edwards says her favorite part of compiling the book was learning about the many heroes right here in Sacramento. ★

Carmichael, Roseville and Orangevale and many others.

By December, 1919 Frank J. Murray had become Sacramento’s first exclusive Harley

dealer at 508 J Street. A rider himself, he brought credibility to his new business along with his many contacts which included the police department and newspaper reporters.

# Children’s Alliance Provides Students with Free School Supplies

**WEST SACRAMENTO, CA (MPG)** - For the sixth year in a row, the Yolo County Children’s Alliance hosted their Back-to-School Backpack and School Supply Giveaway for students in the West Sacramento community. This community-supported event supplied more than 900 students, from Pre-Kindergarten through 12th grade, with backpacks, school supplies, snack packs, health resources, and more, as families prepare for in-person learning for the 2021-2022 school year.

The majority of parents with school-age children that YCCA serves were hit hard financially when the pandemic was in full effect and are working with a much tighter budget as schools begin to reopen. This event provided much-needed relief, ensuring that these children have everything they need to start the school year strong.

The event was held in a drive-thru fashion at the Yolo County Children’s Alliance Family Resource Center, located at 1200 Anna Street in West Sacramento, from 9:00 a.m. - 12:00 p.m. Along with YCCA, additional vendors included the Yolo County Health and Human Services, who provided vaccines, St. Vincent DePaul, Out of the Box Ministries, Stanford Sierra Youth Solutions, Communicare, the West Sacramento Police Department, and Free Books for Kids.

“While our local economies are slowly recovering, many of the families that we serve are still struggling financially as a result of the pandemic. As an agency, our mission is to support these families, and especially the children in our community. With our annual backpack giveaway, we hope to offset some of the stress parents may be feeling when budgeting back-to-school expenses,” said Jeneba Lahai, Executive Director of the Yolo County

Children’s Alliance. “We want to give every child the tools they need to succeed during the 2021-2022 school year, especially since they will be in the midst of another big change as they re-adjust to in-person learning. We want all the children in our communities to experience a school year full of accomplishments, wonder, and growth.”

This event has been funded completely by community donations and support from our partners. On Sunday, July 18, Councilmember Quirina Orozco and the organization, West Sac Kids Give Back, hosted a school supply drive directly benefiting this event.

# Garamendi Co-sponsors Climate Legislation

**YOLO COUNTY, CA (MPG)** - Local members of Citizens’ Climate Lobby extend our hearty thanks to US Rep. John Garamendi for his co-sponsorship of HR763, the Energy Innovation and Carbon Dividend Act.

This bipartisan bill would cut CO2 emissions from greenhouse gases by 40% in 12 years by placing a steadily rising fee on fossil fuel at the

mine or wellhead. Among those with the lowest 60% of incomes, 83% would receive dividends greater than their increased fuel costs. For an additional 13% of these people, added costs would be less than .02% of income, \$100 on a \$50,000 annual income.

The gasoline and diesel fuel used in agriculture would be exempt.

Residents in District 3 want climate action. The Yale Program on Climate Change Communication estimates 69% of District 3 residents believe fossil fuel companies should pay a tax on carbon. And 62% say climate change is already affecting the weather.

President-elect Biden has said climate change is one of his main priorities. It appears that members of Congress will propose a variety of bills. The EICDA is comprehensive, fair, and can be implemented quickly.

Congressman Garamendi is wise to throw his support

behind a strong measure which can make a decisive difference. He recognizes it needs to be at the center of legislative action. Congress, state and local governments, and we as individuals will need to take many steps to curb the dangers of climate change, in addition to passing the EICDA.

We need to do a lot, but let’s do this first. ★

# Society for the Blind Receives \$15K from Union Bank Foundation

SACRAMENTO, CA (MPG) - Society for the Blind recently received \$15,000 from the MUFG Union Bank Foundation to provide alternative independent living and employment skills for youth and working-age adults with vision loss so they can continue their career paths or begin employment. The grant will fund the group's employment services that include its core blindness skills program and its CareersPLUS program with tracks for youth and adults.

"Though unemployment skyrocketed during the pandemic, most people are surprised to hear that unemployment for people with vision loss has been a whopping 70 percent for decades," said Shari Roeseler, executive director, Society for the Blind. "At Society for the Blind, we always say that people with vision loss can still do almost anything they want – they just have to adapt to do it another way. The same is true in the workplace. We are grateful to the MUFG Union Bank Foundation for helping us expand our employment training skills so we can raise the number of people with vision loss who are gainfully employed."

Through its core blindness skills program, Society for the Blind offers orientation and mobility training to help people navigate with and without a white cane, computers and assistive technology training, Braille literacy, and alternative techniques for cooking, cleaning, shopping, home maintenance, organization, personal finance and more. Society for the Blind's CareersPLUS program includes tracks for youth and adults, providing comprehensive, age-appropriate career readiness, career exploration activities, workshops and a mentor program for teens and young adults experiencing

vision loss. Society for the Blind has been expanding its employment-readiness program for youth and working-age adults, even more rapidly when the pandemic hit and services became remote. In addition to its in-house programs, the group is now partnering with the Blind Institute of Technology in Colorado.

"Helping provide these adaptive skills greatly enhances the opportunities for success in career and life for these individuals," said Ashley Abenoja-Bocek, MUFG Union Bank Foundation relationship manager for Northern California. "Additionally, this assists the business communities with developing qualified local talent to meet their growing needs."

For 67 years, Society for the Blind has created innovative ways to empower individuals living with low vision or blindness to discover, develop and achieve their full potential. Society for the Blind has grown from a dedicated group of volunteers to a nationally recognized agency and the only comprehensive rehabilitative teaching center that provides services for a 27-county region of northern California. The nonprofit provides low-vision eye care, life and job skills training, mentorship, and access to tools to maintain independence for nearly 6,000 youth, working-age adults and seniors experiencing vision loss each year. # California Educators Battle Over Woke Math

The modern world runs on mathematics.

From balancing a checkbook to calculating rocket trajectories, human beings rely on their ability to understand and use mathematical tools, and we expect our schools to develop those tools in their young charges.

But how and when? For the past eight months, a philosophical war has raged in California education circles over a plan to sharply, even radically, change math instruction at all grade levels.

In January, the state Instructional Quality Commission released a draft "mathematics framework" that would shift instruction from the traditional, and somewhat linear, approach to one steeped in race and culture, or "woke" in contemporary parlance.

The draft declares that traditional math instruction, in which students progress from counting and simple arithmetic into geometry, algebra, trigonometry and eventually calculus as they advance through the grades, "has much to correct (because) the subject and community of mathematics has a history of exclusion

and filtering, rather than inclusion and welcoming."

"There persists a mentality that some people are 'bad in math' (or otherwise do not belong), and this mentality pervades many sources and at many levels," the draft continues. "Girls and Black and Brown children, notably, represent groups that more often receive messages that they are not capable of high-level mathematics, compared to their White and male counterparts."

To counter that perceived shortcoming, the proposal would have students of all innate abilities remain together well into high school, essentially eliminating accelerated moves into higher-level mathematics, such as calculus, by those who exhibit desire and aptitude.

Moreover, math instruction would be reoriented from the linear manipulation of numbers into a tool for social justice.

"Mathematics educators have an imperative to impart upon their students the argument that mathematics is a tool that can be used to both understand and change the world," the draft declares.

The draft generated a backlash from advocates of traditional math, including an open letter signed by hundreds of academics.

"California is on the verge of politicizing K-12 math in a potentially disastrous way," the letter declared. "Its proposed Mathematics Curriculum Framework is presented as a step toward social justice and racial equity, but its effect would be the opposite – to rob all Californians,

especially the poorest and most vulnerable, who always suffer most when schools fail to teach their students. As textbooks and other teaching materials approved by the state would have to follow this framework and since teachers are expected to use it as a guide, its potential to steal a promising future from our children is enormous."

Rather than reframe math in social justice terms, the critics contend, California should do a better job of teaching math skills that students will need in the real world, particularly students from disadvantaged backgrounds.

The conflict mirrors a previous dustup over an ethnic studies curriculum as well as the current nationwide debate over whether "critical race theory" should be taught in school or banned.

Advocates of the new curriculum are playing with the lives of millions of children and the state's economic and societal future. Implicitly they are shifting blame for the state's embarrassingly low scores in nationwide math achievement tests from themselves to the traditional way math has been taught.

How, then, do they explain why kids in other states and nations are thriving with traditional math? Can they prove that their proposal will improve real world outcomes, or are they just indulging their ideological fantasies?

# IRS Refunds Nearly \$4 Million for Unemployment Compensation Overpayments

WASHINGTON D.C. (MPG) - The Internal Revenue Service began another round of refunds to nearly 4 million taxpayers who overpaid their taxes on unemployment compensation received last year.

The American Rescue Plan Act of 2021, which became law in March, excluded up to \$10,200 in 2020 unemployment compensation from taxable income calculations. The exclusion applied to individuals and married couples whose modified adjusted gross income was less than \$150,000.

Refunds by direct deposit began the week of July 14 and refunds by paper check began on July 16. The IRS previously issued refunds related to unemployment

compensation exclusion in May and June, and it will continue to issue refunds throughout the summer.

To ease the burden on taxpayers, the IRS has been reviewing the Forms 1040 and 1040SR that were filed prior to the law's enactment to identify those people who are due an adjustment. For taxpayers who overpaid, the IRS will either refund the overpayment, apply it to other outstanding taxes or other federal or state debts owed.

For this round, the IRS identified approximately 4.6 million taxpayers who may be due an adjustment. Of that number, approximately 4 million taxpayers are expected to receive a refund. The refund average is \$1,265, which means some will receive more and some will receive less.

Most taxpayers need not take any action and there is no need to call the IRS. However, if, as

a result of the excluded unemployment compensation, taxpayers are now eligible for deductions or credits not claimed on the original return, they should file a Form 1040-X, Amended U.S. Individual Income Tax Return.

Taxpayers should file an amended return if they:

Did not submit a Schedule 8812 with the original return to claim the Additional Child Tax Credit and are now eligible for the credit after the unemployment compensation exclusion;

Did not submit a Schedule EIC with the original return to claim the Earned Income Tax Credit (with qualifying dependents) and are now eligible for the credit after the unemployment compensation exclusion;

Are now eligible for any other credits and/or deductions not mentioned below. Make sure to include any required forms or schedules.

Taxpayers do not need

to file an amended return if they:

Already filed a tax return and did not claim the unemployment exclusion; the IRS will determine the correct taxable amount of unemployment compensation and tax;

Have an adjustment, because of the exclusion, that will result in an increase in any non-refundable or refundable credits reported on the original return;

Did not claim the following credits on their tax return but are now eligible when the unemployment exclusion is applied: Recovery Rebate Credit, Earned Income Credit with no qualifying dependents or the Advance Premium Tax Credit. The IRS will calculate the credit and include it in any overpayment;

Filed a married filing joint return, live in a community property

state, and entered a smaller exclusion amount than entitled on Schedule 1, line 8.

Taxpayers will generally receive letters from the IRS within 30 days of the adjustment, informing them of what kind of adjustment was made (such as refund, payment or payment offset for other authorized debts) and the amount of the adjustment. ★



### If you Need a Co-signer, You're Not Ready

Dear Dave,  
My fiancée and I want to make an offer on a house. She has a lot of late payments and a bad credit record, though, but she is working hard to manage her money better and get out of debt. I don't make enough money to get a home loan by myself, and I have some debt to pay off, too. In order to help us out, my aunt and uncle said they are willing to co-sign a mortgage loan for us. What do you think of that idea?

– Evan  
Dear Evan  
Here's a simple, solid piece of advice for anyone looking to make a purchase of any kind. If you need a co-signer, you're not ready

to make that purchase – period. I'm not trying to beat you up or anything, but it's way too soon for you two to be thinking about buying a home. I mean, for starters you're just engaged right now.

When a lender requires a co-signer, it basically means they don't believe you'll pay back the money. And besides, you two don't need a house now or right after you get married. The two of you should get married, and live in a decent, inexpensive apartment for a while. During that time, you both need to work hard on paying off all your debt. After that, save up an emergency fund of three to six months of expenses. Then, start setting aside cash for a down payment on a modest home.

When it comes time to buy a home, I recommend a 15-year, fixed rate loan with a down payment of at least 10%. Twenty percent is better, because it will help you avoid having to pay PMI (private mortgage insurance). Make sure

the monthly payments on the loan are no more than 25% of your combined take home pay. Keeping the payments at 25% or below will make it easier to address other important financial issues, like saving and investing.

Your aunt and uncle are obviously generous people, Evan, but they're a little misguided in their offer. At this point, helping you two buy a house – something you obviously can't afford – would be a huge burden instead of a blessing.

# Motorists Cut Driving Nearly in Half

**WALNUT CREEK, CA (MPG)** - New research from the AAA Foundation for Traffic Safety's New American Driving Survey (2020) showed the average number of all daily car trips at the start of the pandemic dropped by 45% as COVID-19 and associated restrictions led to a drastic drop in road travel. Daily trips rebounded in May and June but remained 20-25% below their 2019 levels during the remainder of 2020.

According to the research in April 2020: Trips by all modes of transportation plunged by 40 percent; The average number of daily trips for all modes of transportation fell from 3.7 trips per day (2019) to 2.2 trips.

### Other key findings:

**Daily Car trips:** Fell from 3.2 pre-pandemic to 1.8 in April 2020, before rebounding slightly to 2.6 trips for the rest of 2020; **Travel by Urban Areas:** Daily trips dropped 42% (compared to 25% for those living in Suburban areas), before leveling off to a 20%-30% reduction; **Travel by transit, taxi, or rideshare:** The proportion of people who reported making any trips by transit, taxi, or rideshare plummeted from 5.5% pre-pandemic to 1.7% in April of 2020, before leveling off at approximately 2.4% for the remainder of the year; **Commuter Travel:** Work-related travel by all transportation modes dropped by 40% in April 2020, likely reflecting a mix of layoffs, job losses, and telecommuting. Commuting trips made by workers on days when they worked decreased by approximately 22%. For the remainder of the year, commuting trips were approximately 26% below pre-pandemic levels.

### Car fatalities rise despite less travel in 2020

Despite fewer cars on the road and more people staying home, the National Highway Traffic Safety Administration (NHTSA) recently estimated that 38,680 people died in motor vehicle traffic crashes in 2020 — an increase of about 7.2% over 2019 and the largest projected number of fatalities since 2007.

The most recent AAA Foundation for Traffic Safety Traffic Safety Culture Index (TSCI) found that drivers perceive distracted, aggressive and impaired driving as

dangerous. Yet, many drivers admitted to engaging in at least one of these behaviors in the 30 days prior to the survey.

"As the U.S. climbs out of the COVID-19 pandemic, highway safety officials will need to double down on curbing speeding, substance-impaired driving, and failure to buckle up," said Sergio Avila, AAA Northern California spokesperson.

AAA urges drivers to keep everyone safe on the roads and warns drivers against falling back into bad driving habits.

**Methodology:** This study examined data from the AAA Foundation's New American Driving Survey (New ADS), which surveys a representative sample of U.S. residents ages 16 years or older to collect detailed information about all of the travel they did on the day before the interview. The current study examines the mean daily number of trips made by U.S. residents each month among 7,873 respondents who were interviewed between July 1, 2019 (start of data collection for the New ADS) and December 31, 2020. In the New ADS, a trip refers to any travel from one place to another.

## Disability vs. Survivor Benefit

**Dear Rusty:** I have a question regarding Social Security. I'm 54 and applying for disability. I've had rheumatoid arthritis since I was 19. My son, 16 years old, receives survivor benefits from my deceased ex-husband. We were married for 20 years. I was told by Social Security that my monthly payments, if they found me eligible for disability, would be \$1418 a month. When would I be eligible to collect my ex-husband's Social Security benefit? He made considerably more income over the years and his benefit will be a good deal more than my projected \$1418. **Signed: Disabled Widow**

**Dear Disabled Widow:** Your Social Security Disability Insurance (SSDI) benefit is based upon your own lifetime work record up to the point you became disabled. If awarded, the \$1418 amount would be equal to the benefit you would have been entitled to on your own at your full retirement age (FRA) of 67. At your FRA, your



permanently reduced. The reduction is 4.75% for each full year earlier than your FRA that the survivor benefit is claimed to a maximum reduction of 28.5%.

So, if your SSDI is awarded you will have a choice - to take your smaller SSDI benefit and allow your survivor benefit to continue to grow, or to take your survivor benefit early and accept the permanent 28.5% reduction to that survivor benefit. You will need to compare those two benefit amounts to decide which course to take. For clarity, you can switch to your higher survivor benefit at any later time, but you shouldn't wait beyond your FRA (when the survivor benefit reaches maximum) to claim it.

SSDI benefit will automatically convert to your SS retirement benefit at the same amount. However, if your SSDI is awarded you will be also eligible to apply for your survivor benefit at any time.

Normally, age 60 is the earliest a survivor benefit can be claimed, but those who are disabled can apply for survivor benefits as early as age 50. Whether to apply for your survivor benefit from your ex-husband this early is a question you should carefully consider, because the amount of your survivor benefit will be reduced by 28.5% if you claim it now. And to be clear, if you have remarried and remain married you are not eligible for a survivor benefit from your deceased ex-husband (even though your minor son is).

Your survivor benefit from your ex-husband will not reach maximum until you have reached your full retirement age. At your FRA you would be entitled to 100% of the benefit your ex-husband was receiving (or entitled to receive) when he died but taken at any age earlier than your FRA your survivor benefit will be

**SACRAMENTO COUNTY, CA (MPG)** - After an 18-month hiatus, the BARC team is back at Sacramento International Airport (SMF). These special pups' friendly faces and "Pet Me" vests are relieving the stress of travel for many passengers. The program was halted due to the pandemic, but as of July 7, the dogs are making a comeback.

RC - short for the Boarding Area Relaxation Corps - greets guests once they pass through security, with big smiles and wagging tails. Studies show spending time with dogs can reduce blood pressure and anxiety while boosting feelings of relaxation and well-being. Traveling can be stressful for some people - from a fear of flying to worrying about delays or cancellations - BARC dogs provide a furry dose of relief.

Rose Margolis and Sophie, a Cavalier King Charles Spaniel, have been with the program since the beginning. She was looking for a fun

activity to do with her dogs and wanted something interactive that gave them both a way to meet people. She knows Sophie helps those who are nervous about flying. "A little girl was completely terrified and wouldn't stop crying until she laid down with Sophie," Margolis said. "She was so much more relaxed, and we love being able to see that."

Jennifer Baer-Riedhart and Logan, a Great Pyrenees with soulful eyes, is a big hit with even the littlest passengers - even though he's much bigger than they are.

"When he lays down the little ones like to lay on him," Jennifer said. "He is so happy to be here with all the people. I'm so glad we're back."

Colbert, a 14-year-old black Lab, was one of the first dogs in the program and is nearing retirement. He is happy to pose for photos and get in a few snuggles with adults and kids before they head off to their gate. His handler, Jenniene Cheng says the BARC team helps create a sense of security.

"People stop to pet the dogs and then start up

conversations and share stories about their dogs," she said. "It's a great way to put people at ease."

BARC dogs have been lifting spirits and calming nerves at SMF since 2015. There are now 27 BARC teams making travel a little less "ruff" in both Terminal A and B.

"The BARC teams make the airport experience less stressful and more fun," said Cindy Nichol, Director of Airports for Sacramento County. "Travel can be a hectic experience and with these friendly faces around, passengers can't help but stop, take a breath and relax before continuing their journey."

They'll be at SMF on Mondays, Wednesdays, and first and third Fridays. Each dog and its handler are part of the Lend A Heart Animals Assisted Therapy organization, a Sacramento-area non-profit, founded in 1987, provides animal-assisted therapy throughout the region. The organization also has additional teams that visit hospitals, nursing homes and libraries.

"There's nothing better than seeing all these smiling faces," said Cheng. ★

## “WONDER WOMAN 1984” AN ELEGANT SUPERHERO SAVES THE WORLD

“WONDER WOMAN 1984”

The origin story of Wonder Woman was developed in the 2017 film named after the DC Universe superhero, delivering the elegant, stunning and strong Gal Gadot as the demigod warrior on a mission to thwart the Germans during the First World War.

“Wonder Woman 1984” places Diana Prince (Gadot reprising the role), whose alter ego is the superhero, into the thick of the Cold War era where a con-man utilizing the television medium to promote a Ponzi scheme may prove more threatening to mankind than the Soviets.

But first, the film opens with a flashback to the paradise island of Themyscira that is inhabited solely by Amazon warrior women. As a young girl, Diana competes in a grueling triathlon against adult women more than twice her size.

Showing grit and determination in a contest of skill and strength that represents a hybrid of Olympic competition and a fantasy match in a “Harry Potter” film, Diana learns a valuable and virtuous life lesson from her elders.

The year 1984 brings the still elegant Diana to the position of a staff archeologist at the Smithsonian Museum in Washington, D.C., where she studies and catalogs ancient artifacts, one of them being a seemingly ordinary stone object that is anything but mundane.

In a reflection of the solitary responsibility shouldered by one possessing superpowers, Diana appears to be a loner, even aloof from her colleagues. This also could be her still longing for the lost love of her life, pilot Steve Trevor (Chris Pine), a casualty of war.

However, she befriends Smithsonian colleague Barbara Minerva (Kirsten Wiig), a nerdy, awkward geologist who is overlooked or dismissed by workmates and harassed by louts on city streets.

Barbara takes an interest in the odd stone object that Diana has deemed to be of no significant value, at least not until TV con artist Maxwell Lord (Pedro Pascal) who peddles get-rich-quick schemes on oil prospecting wants to get his hands on it.

The stone has power to grant anyone’s wish, which leads to Steve’s return from the dead. Diana’s love has delightfully humorous fish-out-of-water encounters with the marvels of technology and the gaudiness of contemporary wardrobes.

As for her part, Barbara covets the confidence, strength and appeal of her glamorous colleague, not realizing that there is much more to Diana’s poise and beauty than surface appearances.

Meanwhile, the snake oil salesman Maxwell Lord, who cares about no one other than himself and his young son Alistair (Lucian Perez), ingratiates himself into the museum’s work for ulterior motives.

The beginning and middle parts of the story in the nation’s capital allow Diana to moonlight on occasions in crimefighting with random acts of heroism, like rescuing kids from deranged robbers at a mall or saving an oblivious pedestrian from being creamed by a speeding Pontiac.

But when Steve is back in the picture, the duo take flight in a pilfered jet and head to the Middle East for other heroic acts contra the dastardly plans of Maxwell Lord for world domination and supremacy in the oil markets, or something to that effect.

Truth of the matter is that in the middle part, aside from great stunts by Wonder Woman disrupting a hostile military convoy in the desert, a lot of the action, with the exception of fight scenes in the White House, becomes forgettable not long after the viewing.

What is not so unmemorable is the evolution of Barbara into full villain mode as the Cheetah, whose powers grow stronger while Diana’s appear to diminish. And yet, the Cheetah looks more like a cast member in an Andrew Lloyd Webber musical than true menace.

In his quest for self-aggrandizement, Maxwell Lord becomes more a caricature of overacting than a true threat to the world, even though he’s a megalomaniac destined to fail as he’s ultimately no match for Wonder Woman.

In this dreadful year of a global pandemic, movie studios have struggled with how or even whether to open any tentpole films that deserve the big screen experience. “Wonder Woman 1984” may be viewed on HBO Max and whatever theaters might be open.

Does this superhero movie lose its full impact by being seen on a flat screen in one’s family room? The hunger for blockbuster entertainment not on a streaming service makes it worth the effort for fans of this genre.

At a running time of two and a half hours, “Wonder Woman 1984” could have been trimmed, or at the very least, the wait to get to the climactic action with Diana in full superhero costume, whipping her mystical lasso, could have come sooner.

Be sure to hang through the end credits for a special appearance of an iconic figure, still looking marvelous after all these years and demonstrating that she’s still got it.

# Man Convicted of Human Trafficking and Pimping Minors

WOODLAND, CA (MPG) - On July 30, 2021, 35-year-old Jasyn Bigasan-Carter, of Sacramento, pled no contest to multiple crimes including sex trafficking a minor, pimping a minor, felon in possession of a firearm, and dissuading a witness.

In April 2020, West Sacramento Police responded to a domestic violence call at a motel on West Capitol Avenue. They contacted the first victim, who had recently turned 18 years old, and learned that she had been trafficked by Mr. Bigasan-Carter for the previous two months. West Sacramento Police Detectives immediately opened an investigation and discovered a second minor victim who lived out of county. The lengthy


investigation that followed, which was aided by Yolo County District Attorney Investigators, revealed that Mr. Bigasan-Carter had been involved in human trafficking since January 2020.

District Attorney Jeff Reising stated, “Survivors of human trafficking are affected by these crimes for the rest of their lives. Traffickers often target vulnerable victims, including minors, and use force, fear and coercion to control them. If it weren’t for the first brave victim who came forward and identified her exploiter to law enforcement, these crimes would have continued, likely victimizing more minors or young adults.”


Judge David Rosenberg is scheduled to sentence Mr. Bigasan-Carter on September 30, 2021. Mr. Bigasan-Carter is facing 29 years and 4 months in state prison. ★

## Regional Water Authority Press Release

**SACRAMENTO, CA (MPG)** - The Regional Water Authority (RWA) Board of Directors unanimously adopted a resolution urging its 20 water provider members to take actions to voluntarily reduce water use by a minimum of 15 percent.

The action follows RWA's call for 10 percent conservation in May and Gov. Gavin Newsom's July 8 executive order that expanded the drought to 50 of the state's 58 counties and asked residents to reduce water use by 15 percent.

"This is the worst drought since 1977," said RWA Executive Director Jim Peifer. "Water providers are doing a good job of shifting to environmentally-friendly and sustainably-managed groundwater for water supplies, but continued dry weather into winter could pose a challenge."

Folsom Lake levels are currently at 27 percent. Natural inflows into Folsom are zero and expected to remain that way through September. "For comparison, even in 2015 during California's most recent drought, water was still naturally flowing into Folsom," Peifer said.

Local water providers are asking customers to consider taking the following actions:

**Stress Your Lawn and Save Your Trees.** Try reducing lawn watering times by two minutes, but remember to take steps to protect your trees. Lawn can handle less water

and eventually recover while trees can be lost forever. You can find tips and videos for efficiently watering trees at [BeWaterSmart.info/trees](http://BeWaterSmart.info/trees) or [sactree.com](http://sactree.com); **Check soil moisture** with a moisture meter before turning on sprinklers – *saves 80 gallons of water per day*; **Water plants early** in the morning to reduce evaporation – *saves 50 gallons of water each time you water*; Begin the **transition to a beautiful low-water garden** by removing half of your lawn this summer. You'll be ready to add low-water native plants and drip irrigation this winter – *saves 90 gallons of water per day per 1,000 square feet of lawn removed each time you water*; **Contact your water provider about rebates** to replace older irrigation equipment, fixtures and appliances with high-efficiency models, including rebates on smart sprinkler timers, high-efficiency sprinklers, drip irrigation and more. Many have increased rebate amounts to help offset costs.

### Farmers Denied Insurance after Fires Now Eligible for New Coverage

Gov. Gavin Newsom has signed legislation to enable farmers and ranchers to use the state's insurer of last resort. Senate Bill 11, sponsored by the California Farm Bureau, is intended to help farmers who lost insurance coverage due to wildfires. After record-setting fires, many found that obtaining new coverage was extremely costly or impossible. They can now be insured under the California FAIR plan, a fire insurance pool for high-risk properties.

### California Cracks Down on Insect Harmful to Agriculture

California is imposing a quarantine against an invasive insect harmful to agriculture and natural resources. The state Department of Food and Agriculture announced the quarantine this month to prohibit entry into California of plants, materials or containers infested with the spotted lanternfly. The insects, first detected in Pennsylvania, produce a mold from feeding that can threaten grapes, apples and numerous plant and tree species.

### Western Farmers, Ranchers Thin Herds, Destroy Crops Due to Drought

Farmers in California and a dozen other states are increasingly selling livestock and letting fields go fallow due to severe drought in the western U.S. According to an American Farm Bureau survey, 85 percent of ranchers reported selling off portions of livestock herds due to drought impacts on water supplies and grazing lands. Some 77 percent of growers were destroying crops due to water shortages. Nearly 80 percent of the West is in severe drought.

### USDA Offering Grants to Timber Businesses Hard-Hit by Pandemic

Timber harvesting, hauling and processing businesses can now apply for grants to offset financial losses suffered during the pandemic. The U.S. Department of Agriculture is providing up to \$200 million in total relief to help timber businesses. Firms that suffered revenue losses of 10 percent or more in 2020 may apply for grants between July 22 and October 15 this year. ★
