Vaccinated residents are strongly recommended to wear masks in indoor settings where vaccination verification is not required and the vaccination status of others is unknown. Unvaccinated individuals are still required to wear masks in indoor public spaces. The Yolo County Health Officer also recommends that fully vaccinated individuals get

no symptoms. Data continue to show that fully vaccinated individuals are well protected from the Delta variant and that all three available vaccines are effective against the Delta variant, but some breakthrough infections do occur in vaccinated persons. Although vaccine breakthroughs with the Delta variant in Yolo are rare, preliminary evidence suggests that the affected persons may be able to transmit the vi-

or only partially vaccinated remain highly vulnerable to the highly infectious Delta variant. All residents 12 and older are strongly encouraged to get vaccinated as soon as possible. Nationwide data from the month of June showed that unvaccinated individuals were 79 times more likely to die from COVID-19 than those who were fully vaccinated.

Special election set for Sept. 14

A special election to fill the vacant seat on the West Sacramento City Council will be held on Sept. 14, 2021, in a consolidated election with the statewide Gubernatorial Recall Election. Voters will have the choice to mail it back, drop it in an official Ballot Drop Box, or vote in person at a Voter Assistance Center. In-person voting locations and ballot drop box locations will be announced once they are confirmed.



Yolo County Offers Opportunity to Earn Google Chromebooks and WorkSkills Certification via Loan to Own Program

YoloWorks!, Yolo County Workforce Innovation Board and Yolo County Health and Human Services Agency are providing job seekers the opportunity to earn a Google Chromebook and a WorkSkills Certification with digital badging via MetrixLearning. The YoloWorks! Chromebooks will be available for loan during the program and upon successful completion of the WorkSkills Certification, individuals are able to keep the devices. Individuals must have access to the internet as there is a limited amount

of Mifis that are available for loan.

Participants will actively participate with weekly check-ins with YoloWorks! Employment Services Specialists about their current employment, active job search, or participation in school/training program. The WorkSkills Certification via Metrix Learning allows participants to learn at self-pace, receive clear training milestones, and achieve customized badges. There is a limit of one Chromebook per household.

To be eligible interested participants:

- Must be a Yolo County resident age 18 and up and able to verify with identification.
- Have state-issued identification.
- Be employed, an active job seeker or enrolled in training programs or classes.
- Not have access to any other computers, laptops, or digital devices. Not eligible to receive a device from a community organization, community partner or state-funded program(s).

Yolo County Hosts Groundbreaking **Ceremony for Replacement County Road 40 Low Water Bridge**

County will be hosting a groundbreaking ceremony for the replacement of the County Road 40 Low Water Bridge.

Constructed in 1930, the Low Water Bridge on CR 40 crossing Cache Creek is set to be replaced with a new three-span, reinforced concrete slab bridge.

The nearly 100-year-old bridge was closed to vehicular traffic in 2008 following a Caltrans report that deemed the bridge to have a safe load capacity of zero tons.

Structurally deficient, the bridge could not be used by CAL FIRE and other fire agencies to move heavy machinery into areas of the massive wildfire in 2015, causing significant delays that inhibited the efforts of the firefighters.

As a key access point for firefighters crossing Cache Creek into the Capay Valley, the bridge is a critical rural infrastructure riverbank. On Aug. 3 at 10 a.m., Yolo tractor and trailer vehicle used to transport fire-fighting equipment across Cache Creek and into the Capay Valley.

With the assistance of Assemblymember Cecilia Aguilar-Curry and Senator Bill Dodd, the project received an initial state appropriation of \$800,000 for planning and preconstruction activities in FY2017-18 and a subsequent appropriation of \$2,200,000 for construction in FY2019-20. The total cost of the project is estimated to be between \$3.5 and \$4 million with the remaining costs covered by the advance construction program of the Highway Bridge Program.

From the beginning of the project, Yolo County has collaborated with the Yocha Dehe Wintun Nation to advocate for funding and identify cultural resource areas along the and road alignments while avoiding culturally sensitive areas.

"The Low Water Bridge is a huge win for fire protection and for public access to recreation," said Chair of the Yolo County Board of Supervisor Jim Provenza. "Special thanks to Senator Bill Dodd, Assemblywomen Cecilia Aguiar-Curry, Former Supervisor Duane Chamberlain, Supervisor Angel Barajas, the Yocha Dehe Wintun Nation, and county staff for their hard work on this project."

The new bridge will offer pedestrians, bicyclists, ATV users, and equestrian traffic access to public lands. The bridge will also provide a clearance of at least 8-feet for recreational rafters during summer irrigation flows in Cache Creek.

Local leaders call for food recovery and distribution amidst food insecurity and climate change

More than 160 stakeholders in the Yolo County social safety net - including Sutter Davis Hospital, Communi-Care, Nugget Markets, and multiple representatives of UC Davis and all three Yolo County community college campuses - have signed letters advocating for a comprehensive, countywide surplus edible food recovery and distribution program, to benefit both food-insecure residents and community health, as well as to reduce the environmental impacts of food sent to the Yolo County Central Landfill to rot.

This landmark show of support was sent earlier this week by Yolo Food Bank to elected officials and their staff members at the Yolo County Board of Supervisors and the City Councils of Woodland, Davis, West Sacramento, and Winters. Additional stakeholders include community members, civic and business leaders, donors, volunteers, and local nonprofit organizations, stating that a food secure Yolo County is a top priority. "Redirecting surplus edible food from the Central Landfill to nourish Yolo County residents lacking consistent access to fresh, healthy food, is well-recognized by these stakeholders as critical to improved health and socioeconomic outcomes, as well as environmental sustainability," stated Michael Bisch, Execu-

tive Director, Yolo Food Bank.

"Collectively, these letters are but one indicator of broad public support for a fully-funded, countywide edible food recovery program in partnership with Yolo Food Bank," Bisch added.

"Other powerful indicators of such public support recently have included panel and participant discussions during the recent Yolo Community Foundation tion of SB 1383, state COVID-19 Community Needs Series, Valley Vision polling results, Yolo County workshop conversations, and the experiences of the more than 80 Yolo Food Bank Nonprofit Partner Organization programs benefiting from our food recovery and distributions."

Statewide consulting firms and state agencies, such as CalRecycle, are on record expressing that Yolo Food Bank, together with its nonprofit partners, operates the premier surplus edible food recovery and distribution program in the State of California.

"Yolo Food Bank has both the necessary experience and expertise and has established surplus edible food recovery as the most cost-effective means of achieving food security in Yolo County," shared William Schoen, Project Director with R3 Consulting Group, a Roseville-based solid waste management firm. "This is because the food is donated, not purchased, leaving only the logistics costs to collect and distribute that food to be covered, such as transportation, appropriate storage, sorting

and packing, and related staffing. Every dollar invested in these logistics results in the distribution of approximately \$5 worth of food to food-insecure neighbors, changing lives in every city and community in Yolo County."

The ongoing logistics of Yolo Food Bank's food recovery and distribution work potentially could be funded in perpetuity as part of the January 1 implementalegislation mandating food recovery and distribution activity, amongst other initiatives to divert organics from landfills. Officials in Yolo County - and statewide - currently are grappling with implementation details and funding models, such as a rate-based approach.

Passed five years ago, SB 1383, requires all jurisdictions in the state to develop, fund, and implement plans for food recovery and redirection for human consumption in their communities.

Yolo Food Bank leadership believes that the organization's food recovery and distribution program is the single most impactful, cost-effective, large-scale social program in the county, while simultaneously and cost-effectively battling climate change. Once in the landfill, food is among the organics that ultimately emit methane gas, a pollutant 84 times more toxic than carbon dioxide, into the environment.

"It seems that local jurisdictions, and the consultants whom they've engaged, are concerned



with program expense," Bisch related.

"However, compared with the enormous community investments required to address the poor health and disease outcomes, diminished economic and academic results, negative impacts upon affordable housing and homelessness, and perpetual racial and cultural inequities that stem from persistent food insecurity - as well as the environmental impacts of methane gas emissions - a commitment to invest in a surplus edible food recovery and distribution program with Yolo Food Bank is a smart and logical choice."

Currently, Yolo Food Bank relies upon the generosity and capacity of private donors to fund the majority of the food recovery and distribution activity required to meet the food access demands of more than 60,000 Yolo County residents each month, a three-fold increase over the pre-pandemic service level. The size and frequency of donors' gifts are dependent upon their inclination to contribute and their own economic prosperity, meaning that the funding base is not dependable, particularly in the face of the elevated SB 1383-mandated food



recovery and distribution activity.

Bisch said it's understandable that the county and the cities find the implementation of SB 1383 food recovery mandates to be challenging, and empathizes with the temptation to view the compliance steps as "... boxes to be checked to stay ahead of penalties." But, he believes that the will of constituents and elected leaders' vision for Yolo County's future can make a difference.

"Our Yolo County Board of Supervisors, our mayors, and our city councils can be the leaders who ensured the expansion and continuity of the State of California's model food recovery and distribution program, and their legacy can be one of the bold actions to create change for generations of Yolo County residents," Bisch shared.

"As opportunities to influence and approve these actions occur over the coming weeks and months, Yolo Food Bank looks forward to deepening partnerships with local government to make it so."

Help Yolo County Achieve **Carbon Negative Status** by 2030

Yolo County is seeking eight additional members of the Yolo County Climate Action Commission to advise Yolo County on immediate actions to reduce greenhouse gas emissions, address equity issues, and update the Yolo County Climate Action Plan. The Yolo County Board of Supervisors created the Commission earlier this year to achieve the goals listed in Resolution No. 20-114, which declared a climate crisis requiring an immediate mobilization of resources to effect a just transition towards an inclusive, equitable, sustainable, and resilient local economy while also supporting and advocating for regional, national, and international efforts necessary to reverse the climate, social justice, and economic crises. Commission members will engage directly with County partners, staff, and the Board of Supervisors to help develop the policies and actions to achieve these goals.

The Commission is comprised of 11 members, with five members directly appointed by members of the Board of Supervisors, one from each district, and an additional two members directly appointed by the previously appointed five members from the County at-large. There are four current vacancies, for multiple categories of membership, including one member from Supervisorial District 3, one technical lead in the field of climate change or sustainability, and one environmental justice lead. Additionally, two at-large community members will be appointed by the five members who are appointed by the County Supervisors. Two additional climate scientists or subject matter experts may be appointed by the Commission to serve after the recruitment of the original nine members concludes.

Free monthly suicide loss support group to resume monthly meetings

Suicide Prevention and Crisis Services of Yolo County (SPYC) will resume monthly meetings for Friends and Families of Suicide Loss Support Group for survivors. The upcoming group in July will meet virtually but following groups may take place in person, at Yolo Hospice. Upcoming meeting dates and times can be found at SuicidePreventionYoloCounty.org.

The effect of suicide on friends and family can be overwhelming. Survivors of suicide loss often state that no other loss has been as painful or confusing. Additional feelings of guilt, anger, and sadness can create a complicated grief process. In a group with others who have shared a similar loss, support comes from exploring, sharing, and clarifying feelings.

If the loss is within two months, survivors are encouraged to access the benefits of an individual therapist first, to most effectively handle the immediate effects of the loss. Since suicide grief can have an ongoing impact, individuals are encouraged to consider attending no matter how long ago the suicide occurred. Privacy and confidentiality are respected. This group is offered free of charge.

The group is fully inclusive to all gender expressions and orientations, to all ethnicities, to all faiths and no faiths, to all bodies, and to all education and income levels; suicide does not discriminate and neither does this group. CHP Cadet class graduates...finally!

The long-awaited graduation of California Highway Patrol (CHP) Cadet Training Class I-20 took place Friday, July 16 at the CHP Academy. The CHP's 119 newest officers (18 women and 101 men) received their badges following a swearing-in ceremony 75 weeks after their training began.

Traditionally, cadet training at the CHP Academy takes place over 29 weeks. However, a little more than a month after arriving at the academy on February 10, 2020, safety precautions necessitated by the COVID-19 pandemic led to the closure of the live-in training facility in West Sacramento. While away from the academy, cadets were assigned to CHP Area offices throughout the

state to observe a wide variety of activities and tasks uniformed officers routinely perform, enhancing the knowledge they had gained in the classroom. Cadets also participated in online learning for the first time.

"To say these cadets have been well-trained would be an understatement," CHP Commissioner Amanda Ray said. "Today's graduates persevered through challenging circumstances over a lengthy period of time, demonstrating their commitment to serving the people of California." At the CHP Academy, cadet training starts with nobility in policing, leadership, professionalism and ethics, and cultural diversity. Cadets also receive instruction on

mental illness response and crisis intervention techniques. The training also covers vehicle patrol, accident investigation, first aid, and the apprehension of suspected violators, including those who drive under the influence of alcohol or drugs. The cadets also receive training in traffic control, report writing, recovery of stolen vehicles, assisting the motoring public, issuing citations, emergency scene management, and knowledge of various codes including the California Vehicle Code, Penal Code, and Health and Safety Code.

Upon graduation, these uniquely trained cadets will be reporting for duty to CHP Area offices throughout the state.

er of protection against COVID-19."

Study finds Sacramento area has 17th lowest wages for new hires


A new study conducted by Self looks at average monthly earnings for new hires throughout the United States. Amid the recovery phase from COVID-19, American businesses are opening new positions faster than they can fill them. The rapid growth-in addition to a smaller labor force and more generous unemployment benefits—is driving wages up. Researchers ranked metropolitan areas according to the cost-of-living adjusted monthly earnings for new hires in 2020.

New hires in the Sacramento metro area are averaging a cost-of-living adjusted \$3,036 per month, compared to the \$3,266 monthly national average for new hires. Out of all large U.S. metros, Sacramento reports the 17th lowest wages for new hires.

New hires in the information sector-which includes many of the country's computer programming and technology jobs-were paid the most, at \$7,060 per month or nearly \$85,000 annually. In comparison, all information workers (including new hires and existing employees) were paid an average monthly wage of \$8,825. New employees in the mining, oil and gas, and utility sectors also commanded strong wages when compared to new hires in other fields.

Despite experiencing strong wage growth at the start of 2021, new hires in accommodation and food services have historically earned the lowest average wages, at just \$1,458 per month or about \$17,500 annually. Unsurprisingly, industries with low wages overall also pay new hires less, but the gap between new hire pay and all worker pay ranges from a low of approximately 11% in the agricultural sector to over 50% in fields like

management, education, and the arts.

In addition to occupation and industry, location has significant direct and indirect effects on real wages. New employees in certain areas might command different wages for a variety of reasons, but differences in cost of living affect how comfortable it is to live on a given wage. When taking cost of living into account, new hires in Washington and Massachusetts earned the most in 2020, at \$4,045 and \$3,793 per month respectively. Other states with high adjusted wages for new hires included New York and Connecticut. Conversely, workers in Montana, Hawaii, and Idaho earned the least after adjusting for living costs.

To find the metropolitan areas with the highest wages for new hires, researchers at Self analyzed the latest data on new hires from the U.S. Census Bureau, cost-of-living data from the U.S. Bureau of Economic Analysis, and home price data from Zillow. The researchers ranked metro areas according to the cost-of-living adjusted monthly earnings for new hires in 2020. Researchers also calculated the unadjusted monthly earnings for new hires, the unadjusted monthly earnings across all workers, median home price, and cost of living.

To improve relevance, only metropolitan areas with at least 100,000 people were included in the analysis. Additionally, metro areas were grouped into the following cohorts based on population size:

- Small metros: 100,000– 349,999 Midsize metros: 350,000–
- 999,999 L
- Large metros: 1,000,000 or more

life tunnels, it's reported. But 'til now, no carefully planned huge crossing designed solely to protect endangered wildlife (by cutting down collisions).

Ι was riding with someone once who hit a deer. His van had some front end damage and, as I recall, got a realignment. Reflexively, the doe bounded away on three legs, then dropped and died. We both felt terrible

I've never seen a dead mountain lion .. yet. Some years back, tracks and scat confirmed a Southport sighting near the Nugget. I swear I saw tracks over in what used to be West Sac's golf course. I was told, I likely did, because wildlife 'follows the river.' When I walked my dog over

there, I purposely looked up in trees.

'Bridge', 'Crossing', whatever you want to call these manmade wildlife corridors, they're saving lives of not just animals ... but also, sometimes, drivers.

California mountain lions, afraid to risk traffic on the 101 to find an unrelated mate, have prompted what Caltrans says "will be the largest wildlife crossing in the world." Federal and state biologists explain that the mountain lions "need to regularly connect with other populations to increase their diversity." Two+ years ago, the National Park Service, UC Davis, and UCLA collaborated on a study. Due to 'isolation' in the Santa Monica Mountains, these cats are at risk of "imminent genetic collapse," say experts, adding that, without diver-

sity, SoCal's mountain lions could be extinct in 15 years or less.

The \$87-million wildlife crossing will boast native plants and other features the cats and other wildlife should find appealing. Construction will take place at night (to aggravate fewer drivers). Barring delays (such as, say, an earthquake), as of 2023, SoCal's Liberty Canyon cats should be going back and forth across the 101 to mix and mingle, their pre-101 'corridor' restored.

Wildlife, everywhere, has suffered from invasion of its habitat. Caltrans reportedly hopes this first large crossing will inspire more such crossings statewide. Nature matters. Maybe big NorCal money will partner with California Fish&Wildlife and UCD to do something nice for ours.

In collaboration with the U.S. Geological Survey and the Road Ecology department at UC Davis, Caltrans has published a 'wildlife crossings' manual. The guide, said UCD, is designed to help Caltrans comply with regulations, state and federal, while it protects the state's threatened or endangered animals, plants and habitats. Study shows California has 7th worst public schools

The pandemic transformed American life in many ways, but arguably none quite as severely as education.

In spring 2020, many schools across the country closed their doors to in-person learning as scientists and politicians grappled with the dangers of COVID-19. Globally, more than 1 billion students were affected by school closures. The effects of those closures were felt not just by students, but by parents and educators too.

Parents were forced to deal with tough choices: send their children to school or start an athome learning program? Educators had to manage the transition from teaching in a classroom to teaching on a computer. Many students transitioned from a pre-pandemic routine of going to class, seeing friends, and talking with teachers to a new reality of learning exclusively through a computer or mobile device.

Before the upheaval started, school districts already faced scrutiny over the quality of education they provided. Data from the Nation's Report Card showed that math and reading proficiencies were stagnant leading up to the pandemic. Many locations with less funding per student struggled to stay above national testing averages. With more than 90% of school funding coming from state and local sources, the pandemic highlighted disparities in the nation's education system and jeopardized the performance of students in communities that were already falling behind.

Even before the pandemic struck, national trends indicated that students' math and reading proficiencies were at con- (25%): the difference becerning levels. Data from tween the state reading the National Assessment score and the national

of Education Progress (NEAP) show that math proficiencies leveled off for eighth-graders at around 33% and increased slightly to 41% among fourth-graders in 2019. Reading proficiency peaked in 2017 but declined in the next round of testing. In 2019, both grade levels were at or below 35% proficiency.

Yet while the national data indicates that many students struggle with math and reading, state-level statistics show that certain states have found a way to buck the national trend. To determine the states with the best public schools, researchers at HireAHelper used data from the U.S. Department of Education and the Census Bureau to generate a composite score based on the following weighted factors:

NAEP reading scores

average for fourth- and eighth-grade students on the NAEP exam.

NAEP math scores (25%): the difference between the state math score and the national average for fourth- and eighth-grade students on the NAEP exam.

Total state spending per student (10%): the total elementary-secondary per-pupil spending on instruction, support services, and other functions.

Pupil-teacher ratio (20%): the number of public school students per teacher.

Graduation rate (20%): the public high school four-year adjusted cohort graduation rate.

In many cases, the states with the best test scores are also the states that spend the most money per student—as is the case for Connecticut, New Jersey, Vermont, and Massachu-

that have significantly above-average funding per student but report below-average academic results. On the other hand, Idaho and Utah have the lowest public education spending per student of all 50 states but achieve significantly above-average scores on the NAEP.

When taking all these factors into accounttest scores, funding, student-teacher ratios, and graduation rates—the states with the best public education systems are disproportionately concentrated in the Northeast.

California was issued a composite score of 62.6. Out of all states, California has the 7th worst public schools. Here is a summary of the data for California:

- Total state spending per student: \$14,035
- Pupil-teacher ratio: 23.1
- Graduation rate: 85%
