

Matsui, bipartisan, bicameral group of lawmakers pitch bill to save minor league baseball teams

The minor league baseball relief act provides federal relief for MiLB teams that were benched for 18 months due to the COVID-19 pandemic

Congresswoman Doris Matsui (D-CA), Rep. David McKinley (R-WV) and Senators Richard Blumenthal (D-CT), Marsha Blackburn (R-TN), Mark Warner (D-VA), and Tim Kaine (D-VA) introduced the Minor League Baseball Relief Act, legislation to provide emergency assistance to Minor League Baseball (MiLB) clubs who have been hit hard by the COVID-19 pandemic.

The COVID-19 pandemic forced the cancellation of the 2020 MiLB season for the first time in 120 years. However, because of the timing of the start of the season, MiLB clubs had fully invested in the 2020 season, employing staff and incurring overhead in anticipation

of a season and revenue that never materialized. The past year has left MiLB with catastrophic long-term losses that will devastate the small business teams and significantly harm the communities where they play and the restaurants, shops, and businesses that depend on them.

Unlike their counterparts in Major League Baseball and other major sports leagues, MiLB clubs cannot rely on TV ad revenues to supplement the loss of proceeds from ticket sales, concessions, and in-person advertising. Even with the return of fans this year, many clubs are facing immense financial hardship.

“In times both good and bad, our national

pastime of baseball connects us to one another and to the nation we love. Yet, the unprecedented nature of the COVID-19 pandemic has put many of our local Minor League clubs in distress, necessitating targeted support to keep our favorite teams afloat,” said Congresswoman Matsui. “In Sacramento, we take our sports seriously, and the Sacramento River Cats and their fans embody the passion, energy, and civic pride of our great city. The collective spirit and support for our team lift the entire region up, and this legislation will make sure teams like these across the nation will continue to bring our communi-

California Veterans Memorial has a West Sac connection

"Reflecting upon last month - Military Appreciation Month" (6/ 9/21, News Ledger), Eddy Salmons notes military monuments at the California State Capitol Park. But are we aware there is one with a Yolo County connection?

The California Veterans Memorial was created by Steve Gilman of West Sacramento and Katherine Keefer of Davis, both grew up there but now live in the Bay Area. They were the artists/sculptors for the 30-foot black granite obelisk. Steve attended schools in West Sacramento - both

elementary and high school. He graduated in the James Marshall High School Class of 1963 and was a classmate of mine. Steve went on to get his Masters of Fine Arts in sculpture at the University of Oregon, Eugene. Katherine got her MFA in Ceramics and Sculpture from Washington State University, Pullman.

Initially, the California legislature created a commission to oversee fundraising and construction of the memorial to honor all California veterans. Finally, after a decade of planning the project was completed. The obelisk

The two-day virtual workshop included 71 participants from a wide swath of stakeholders—farmers, policymakers, landowners, hunters, conservation scientists, educators, engineers, and ecologists. Led by consultants

ment-departments/county-administrator/county-administrator-divisions/intergovernmental-affairs/delta-elibrary).

“Charrette is a term used in landscape design and architecture. It's a fancy way of saying a design workshop,” explained Elisa Sabatini, Yolo County's Natural Resources Manager. “It was fascinating to be part of a process that involved so many people, who all came together around a vision for the Tule Canal in two days.”

The completed report was the final effort in a two-year update of the Yolo Bypass Drainage and Water Infrastructure Improvement Study Update published in December 2020. The County's aim through the Tule Canal Charrette in January 2021 was to bring diverse stakeholders together to come closer to a shared vision for this complex environment. The Tule Canal stretches the length of the 40-mile Bypass serving as water supply, flood protection, drainage, and habitat.

The outcomes included in the report provide support for three actions: a multi-functional Tule Canal, a Yolo Bypass strategic plan, and a Yolo Bypass governing entity. A vision was synthesized from the contributions of the 10 workgroups: We envision a transformed Tule Canal as an integrated corridor, which engages people, sustains farmers, protects property, and provides diverse wildlife habitats.

The next steps of developing a strategic plan for a multi-functional Tule Canal and creating a governing entity for the Bypass will be pursued by Yolo County Natural Resources Manager, Elisa Sabatini.

ties together for years to come.”

“Minor League Baseball is a point of pride to hundreds of small cities and towns across the country,” said Rep. McKinley. “Like many other small businesses in other industries, minor league clubs are struggling from the economic impact of the pandemic. Many of these teams are at risk of closing their doors if they don’t have additional assistance to make it through this crisis. This bipartisan legislation will ensure Minor League Baseball as we

know it can survive and keep America’s pastime alive.”

“This bill will help keep Connecticut’s cherished minor league teams in the game,” said Senator Blumenthal. “The pandemic put America’s past time on the bench and deeply strained already cash-strapped minor league teams. Communities rely on minor league teams across the country for local jobs and small business vitality, and young baseball fans first discover their love of the game there. I’m proud to lead the effort to provide an assist to these beloved teams when they need us most.”

“I can’t thank Rep. Matsui enough for taking the

lead and advocating on behalf of the Sacramento River Cats and all of Minor League Baseball,” said Jeff Savage, President, Sacramento River Cats. “This assistance will be critical in allowing teams to be able to hire back employees, ramp up operations, and provide the family friendly entertainment our fans and sponsors are accustomed to seeing.”

The bill is also cosponsored by Representatives Susan Wild (D-PA), Peter Welch (D-VT), James McGovern (D-MA), and Elissa Slotkin (D-MI).

Pre-pandemic, MiLB Clubs employed more than 3,300 full-time employees and nearly 32,000

part-time and seasonal employees. Additional COVID-19 relief would allow clubs to immediately return to full staffing levels and safeguard vital jobs in these communities

The Minor League Baseball Relief Act would allow Minor League Baseball to access up to \$550 million in emergency grants to be administered by the Small Business Administration (SBA) and made available through funding authorized under previous COVID-19 relief legislation that would otherwise be returned to the Treasury Department. This funding would only be made available to Minor League Base-

ball if it was determined that there was no longer a need for its originally intended purposes and it would otherwise go unused. The bill would distribute grants up to \$10 million for eligible clubs, and provide an opportunity for a second grant at 50 percent of the first if a club’s revenue does not recover and significantly

exceed its 2019 total. The bill requires strict oversight from SBA through documentation, review of use, and an audit on grant funding, and applies to any minor league baseball team previously part of the National Association of Professional Baseball Leagues but not to any club that is owned by Major League Baseball.

New online tools can help parents prepare for the upcoming school year

With the state's economy and businesses now fully open, many parents in Sacramento are wondering what to expect in the coming school year. This school year will look very different than the last, as all of California's schools are expected to return to full in-person instruction for the 2021-2022 school year. Locally, Washington Unified School District's first day of the 2021-22 school year will be Aug. 11, 2021.

To help parents get ready for the 2021-22 school year, California launched the Safe Schools Parent Page. It gives information about the health guidance schools are using in their safety plans to protect students and staff and minimize the spread of COVID-19 in schools. Parents can learn about school re-openings and COVID-19 vaccinations on the Parent Page, as well as schedule a vaccine appointment for their child. The site is also available in Spanish.

"It's been a really hard year for all, and especially for parents and their kids," said Dr. Naomi Bardach, Professor of Pediatrics and Health Policy at University of California, San Francisco, who is leading California's Safe Schools for All team. "Parents need to be empowered with accurate information about safety measures that are science-based for safely opening schools."

Parents can find a snapshot of school reopenings across California and information about their school district on the website's interactive Safe Schools Reopening Map. The map also shows the funding for school districts, provides data on school outbreaks, and, for many schools, provides direct links to their school COVID-19 Safety Plans.

"Getting kids back on campus will help them heal in so many ways," said Dr. Bardach. "With the right safety measures and getting people vaccinated, we can give our students all the benefits of being at school and continue to protect our families from COVID-19. It's time for our youth to fully return to school for the academic, social and emotional benefits."

"Vaccines will also give students 12 and older the opportunity to get back to enjoying the things they love, including school theater, clubs and social events. COVID-19 vaccines are free for everyone, regardless of insurance or immigration status," said Dr. Bardach.

The Safe Schools for All team gives the expertise to help schools create and follow their COVID-19 Safety Plans. All schools must post their approved COVID-19 Safety Plan to their school's website before reopening their campus. These plans outline how schools prevent people getting COVID-19 at school so families can rest assured they will be safe places to learn and grow.

Parents can request to see their school's COVID-19 Safety Plan. These plans can include a number of safety steps, such as:

- Masking requirements
- Improved ventilation
- Hand-washing
- Stay-home-when-sick policies
- COVID-19 testing

Again, similar to other California counties, Yolo County is grappling with how best to use its facility and other related resources to best serve youth.

"I encourage all that are interested in juvenile justice to be a part of this important conversation," said Yolo County Chief Probation Officer Dan Fruchtenicht. "We need the community's input on potential future use of the Juvenile Detention Facility to ensure we utilize our limited resources to serve youth wisely."

Yolo County Assessment Roll Tops \$31 Billion

Yolo County experienced another year of growth as reflected in the assessment roll data released by Yolo County Assessor/Clerk-Recorder/Registrar of Voters Jesse Salinas. Salinas announced today that the annual assessment roll hit \$31.52 billion, a 4.45% increase over the prior year. The assessment roll reflects the total net assessed value of all real and business property in Yolo County as of January 1, 2021. "Local entities and services depend on property tax revenue to operate, including public schools, community colleges, cities and the county. We as a community rely on these invaluable resources and the timely and accurate completion of the assessment roll," said Salinas.

The growth in the assessment roll is most notably due to continued rise in new housing development and construction throughout the county, leading to the ninth consecutive year of growth. The city of Winters reflected a 12.95% increase, the largest Yolo County increase for the fifth consecutive year. Woodland and West Sacramento experienced the second and third largest increases within the county at 5.77% and 5.21%, respectively. The city of Davis increased by 3.21% and unincorporated areas of Yolo County grew by 2.71%. These percentage increases reflect a comparison of this year's assessment values to the prior year. The Yolo County assessment roll was delivered on June 30, 2021, ahead of the statutory deadline of July 1, 2021, despite the unprecedented times of the COVID-19 pandemic. "I am proud of the extraordinary work done by staff during these difficult times to close the roll successfully," said Salinas.

The 2021-2022 assessed values are available online for review beginning in late August. Tax bills are typically mailed in mid-September. Please review your assessed value closely and contact the Assessor's Office with questions or concerns at (530) 666-8135 or by email at assessor@yolocounty.org. The Assessor's informal review filing period for residential properties is July 2nd – November 1st. Assessment appeal applications are accepted July 2nd through November 30th. was designed by Steve Gillman and Katherine Keefer and then built in collaboration with Harry Hallenbeck, California's State Architect who served as project manager.

The obelisk is surrounded by an arc of flags representing the various branches of the U.S. military. According to Steve, "We used the formal obelisk shape for the memorial and then photo-etched images of veterans onto the reflective black surface. The images are of soldiers at war, during peace, and with their family and friends. It was meant to honor all California citizen soldiers and their families, who were also affected by their service. Not just those killed or wounded in action, but all who served." The tall



fissures slice through each of the obelisk's four panels representing the devastation of war.

On December 12, 1998, Governor Pete Wilson addressed at the dedication of the memorial with the following words: "Our veterans... must not be forgotten. Their service, their sacrifice, their courage must be etched in America's memory...the legacy of freedom and glory that is America".

There is a large commemorative plaque embedded in the ground to the north

of the sculpture alongside the walkway to the Capitol identifying everyone who was involved with the memorial. The sculpture is located on N Street between 13th and 14th Streets across from Westminster Presbyterian Church in Sacramento.

‘Feel good’ stuff wasn’t considered ‘news’, either. Aiming for a more balanced image of our country via its news reports, I pitched the feel good stories. I figured if someone’s unselfishness touched my heart, it would also touch my viewers. The result? “Positively Chicago” – a brand new beat at WLS. I was the reporter.

The Emmy nomination for “Outstanding Individual Achievement” (for the body of my work) was nice, but what mattered most to me was this: ABC’s 20-20 picked up a couple of my stories and did their own. Across the nation, reporters were being assigned stories on kids, animals, and unselfish people.

So, that said, I want to tell you about a couple things I’m following now on NextDoor. First off, congratulations to West Sac and area for making it through the 4th with a minimum of fires sparked by illegal fireworks., or by revelers who forgot to douse spent stuff in water before they trashed it. In Sac, someone who threw spent fireworks in the trash caught their house on fire. I’ve only read of one wildfire CalFire blames on fireworks. Lightning strikes, it says, caused the others. So, extreme noise aside, credit’s due all those who were extra careful. And I have to say, we have a great many goodhearted people in our area.

Let’s start with Southport. Where, recently, a woman, Kassie, noticed a small skunk stuck in pipe with slippery sides, she went and got tongs to pull it out. Terrified,

the skunk sprayed twice inside the pipe, she said on NextDoor.

Once out, it just seemed grateful. Kassie said it didn’t spray her. Wildlife Care Association (WCA) across the river took in the skunk; picked off a bunch of ticks; and assured Kassie and her husband the half-grown animal would make a full recovery. (A side note: Infected ticks can transmit heartworms to a dog. Might want to check yours.)

Here’s another story. A Sacramento apartment dweller’s been trying to capture a recently fledged, limping Canada Goose she sees dragging three feet of nylon fishing line. She’s worried the goose might lose its foot. If she can catch it, WCA will take it. The parent geese, she says, are very .. protective .. and they scare

her.(<https://wildlife-careassociation.com>).

Several on NextDoor have offered advice, and the last I checked, one was trying to find a long-handled fishing net. Not seeing the goose post when I looked again, I’m the NextDoor group effort worked, and, if needed, WCA can rehabilitate the limping goose.

If you like stories with happy outcomes, you’ll like NextDoor. It’s free, and you’ll find lots of people who have skills for helping others – wildlife, pets and people (<https://nextdoor.com/find-neighborhood>).

Now, to wrap up, here’s some news from Front Street Shelter. Even before the 4th, Front Street was full. But now through the end of the years, if your missing cat or dog is at Front Street you can get it back – no fee. Just bring

a photo/documents that prove it’s yours. The shelter says 44 percent of the animals it gets it reunites with the owner. To open up kennels for hurt, lost, abandoned animals desperate for ‘forever’ homes, it hopes, with no fees, the number claimed will be even higher.


