

Yolo County Library's Summer Reading Program now underway

Yolo County Library's virtual Summer Reading Program (SRP), themed Reading Colors Your World is now underway until Aug. 14.

Children, teens and adults can join by logging reading hours, earning prizes, and participating in special virtual programs and activities that will get everyone looking at the bright-colored world with new eyes.

All participants who register for the SRP at: <https://yolocountylibrary.org/summer/> will receive a free book and themed activity bag and everyone who completes their summer reading challenge by earning 1,000 points will receive a free book and prize, plus an entry into a final drawing for additional prizes. In addition, adults who complete the SRP challenge can choose to have up to \$10 in late

fees that accrued before April 1 removed from their account in place of their finisher prize.

This year's program has even more rewards; every week that a participant logs their reading and/or activities and earns points on Beanstack, a web and mobile application that allows users to engage in reading challenges, log reading hours and books, earn badges and prizes, and discover great books, they will receive an entry for a weekly drawing for a \$10 gift card, courtesy of Nugget Markets and Target. Additionally, each library branch will provide a new coloring page every week to encourage participants to color their world.

This year's theme, Reading Colors Your World, focuses on color and the many ways that reading can expand our world through kindness,

growth, and community. It encourages participants to get creative, try new things, explore art, and find beauty in diversity.

"This theme delivers an especially relevant message after a year of isolation," said Youth Services Librarian Katrina Laws-Ewald. "Color is uplifting and vibrant, and it is also analogous with the idea of diversity. When we read stories in which we find ourselves, our families, and our communities reflected and valued, we feel a sense of belonging. When we read stories in which families, communities, and cultures that are different from us are also reflected and valued, we get to see a window into the range of possibilities out in the world. This insight into the minds and

This year's annual Juneteenth Celebration, themed "Still WE Rise," goes virtual on Sunday, June 6 from 1:15-3:30 p.m. at: <https://tinyurl.com/yolojuneteenth2021>. This family-friendly event will be recorded in Davis on DCTV and will feature a variety of entertainment and educational presentations by people from around the region.

This year's theme, "Still WE Rise," was selected by Juneteenth organizers to inspire community members to think critically about the world they live in and that they can make a difference. Juneteenth, also known as Freedom Day, does not coincide with the implementation of the Emancipation Proclamation in January 1863, but instead, the day when the Proclamation was finally enforced in Texas, June 19, 1865, finally freeing the population of enslaved African Americans in that state.

"This year's theme is a call-to-action to remind us that united we can rise and make a difference in the areas of social justice, equity, equality and inclusion," said Yolo County Library Regional Manager Scott Love.

The event will kick off with musical performances by Hisani Stenson, Mamadou Traore, and words of wisdom from UC Davis Chancellor, Gary May. The event's fea-

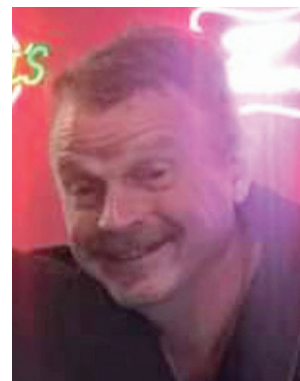

THIS 'n' THAT

Garden Update – Green Thumb Challenged

This is what I get for trying to start my garden on my balcony. The attempt failed. Miserably. And meantime, the perennial pollinator-attracting plants went wild in my outdoor space. It took three hired men an hour to cut it all back for me. By the time I was putting in plants and seeds May 1, other gar-

deners had been gardening for a month.

I should have had my clean up crew turn the base soil for me. Hard as a rock. Turning it with a shovel, though ... fact is, between the neck and shoulder surgeries and arthritis, I avoid tasks that make me hurt. Digging clay is one of them.

So even with adding compost and such in

my garden there's not but about six inches of decent soil that tops the clay. Clay, as you likely surmise if you have clay pots, tends to absorb moisture slowly. Which means six inches of top-soil dries out fast with heat and wind.

Nightcrawlers I've added will (hopefully)

Today, she's known as a trailblazer in the art world for the organic style and raw content depicted always in her paintings. Her life, experimental identities, and captivating story have influenced countless artists and individuals all over the world. This production not only illuminates and pays tribute to Frida Kahlo's incredible paintings but also to the masterpiece that was her own survival.

Through a unique presentation and thoughtful dialogue, viewers will have an opportunity to go deeper and examine the complicated and turbulent relationship of Frida and Mex-

ican muralist, Diego Rivera. Publicly known as a marriage fraught with deceit, affairs, and suffering but also with love, admiration, passion and artistic excellence, Frida and Diego's relationship influenced both of their lives and work evermore. The Museo of Frida Kahlo cites a quote by Frida: "Perhaps they expect me to wail and moan about 'how much I suffer,' living with a man like Diego. But I don't think that the banks of a river suffer by letting it flow..."

During a time of healing and redefining the state of being on many fronts, Frida's story of resilience and empowerment is sure to resonate in a timely manner with audiences. There's a parallel to be drawn about the period of rich artistic invention in Mexico after multiple uprisings and revolutions, seeking to redefine itself through political, social, and cultural reforms; and the period of crisis and reinvention we are experiencing collectively today.

"With this production, I hope to shine a light on Frida's raw and personal struggles that led her to create her famous paintings depicting her incredible pain, suffering, and her frustrating relationship with Diego Rivera. And, to share with the audience the Frida beyond the artist, the woman ahead of her time who knew love, strength, conviction, and up until her final years, learned to embrace her brilliance and purpose in life," says Teatro Espejo's Artistic Director Manuel Pickett. Also, as director of "Frida," in deciding to present this play, Pickett knows that for many Frida is a symbol of hope, strength and can be a source of empowerment for many who are facing adverse situations. Her resiliency is actively depicted in her work, against the backdrop of decades of emotional and physical suffering, and that will be evident to all who watch the show.

The full English production will take place on

June 11- 20, with Friday and Saturday showtimes at 7 p.m. and Sundays at 2 p.m. The Spanish-language reading will be July 9-11 with the same showtimes.

Adapting to the COVID-19 pandemic, Teatro Espejo along with many other performing arts organizations nationwide has prepared a virtual season for 2020-2021.

Joaquin Warmus is a 12-year-old boy that pitches for the Giants. He is very good. So good, in fact, that on Saturday he pitched a perfect game! For those of you that are not big baseball fans, a perfect game is pitched when every batter is struck out. Nobody gets on base by a hit or by being walked.

Pitching a perfect game is very rare. In fact, in the history of professional baseball, only 23 perfect games have ever been pitched.

Scott Burton, coach of the opposing Cubs, and President of West Sac Little League said, "It sucks that it happened against me, but it was awesome to watch and if I had it to do over again, I wouldn't change a thing!"

He continued by saying that the Cubs only had one batter that had a 3-ball strikeout (in other words the batter had 3 balls towards a walk but was struck out). In Saturday's game, Joaquin pitched a 5-inning game that included 15 strikeouts with only 65 pitches.

Joaquin was born in San Francisco and used to play in the same park as the late, great, Joe DiMaggio... now known as the Joe DiMaggio Park, according to

Joaquin's dad. The family moved to the West Sac/Clarksburg area a few years ago and Joaquin started playing ball about 4 years ago.

Joaquin plays travel ball as well as Little League. "I want to play as much baseball as I can," Joaquin said. "My favorite part of pitching is when they try to intimidate me by standing close to the plate and then I throw an inside pitch and make them move out. It makes me smile", he said.

When asked if Joaquin felt the pressure building as he pitched the perfect game, he simply said, "Not really, I didn't even notice I was pitching a perfect game until the fourth inning. I thought about all of the scenarios that could happen and then I just wiped it from my mind and pitched. At the last batter, I just had a smile on my face the whole time."

The coaches awarded Joaquin with the game ball, writing his game stats on it. Joaquin said he didn't think that he would have been able to pitch a perfect game without the support of the catcher, Jaelen Fuller. That's how this ballplayer is. He's not flashy or arrogant about it. He is excited but humble. He gives credit to the fact that his dad has always gone out and played ball with him as a small child, whenever he wanted to play. His father was quick to add in that

now Joaquin throws it too hard so he has a couple of teenage friends, Jordan Tarente and Xavier Wong, that like him and work with him a lot.

Joaquin's parents happen to be out of town, celebrating their anniversary so they were unable to see the game. They did, however, catch the second half of the game on Game Changer (a real-time baseball app) so they were cheering him on from afar. "We've been kind of celebrating since," said his dad.

On Sunday, Joaquin's family went to the River Cats game. Between the 2nd and 3rd inning a representative from the River Cats suddenly sat down next to Joaquin and conducted a short interview with them on the jumbotron, announcing Joaquin's perfect game. The baseball fans were extremely supportive and cheered for Joaquin's accomplishment. Joaquin says he's wanted to play in the Major League since he was about 7 years old, and that is still his goal. He said his favorite team has been the Marlins since he learned Giancarlo Stanton was a player and he likes the Giants because of Buster Posey. For baseball fans, Joaquin is going to be the one to watch. It won't be long until this young man has his own baseball cards to trade. Congratulations Joaquin.

lives of others helps build empathy and, in turn, a stronger community.”

Research indicates that summer reading programs help children and teens retain and enhance their reading skills over the summer, provide a haven for community readers, and develop reading enthusiasm.

play a strong role in their child’s literacy development by reading aloud with their child and modeling good reading behavior. 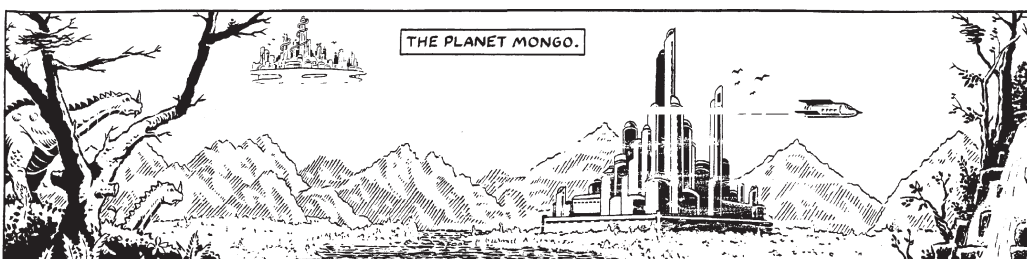

YoloArts and Gallery 625 present: The Hot and Cold of It

The Hot and Cold of It, a solo exhibition, will feature the mixed media artwork of Linda Nunes. The show opens June 4 at YoloArts' Gallery 625 in Woodland.

Nunes, a mixed media artist from the Bay Area, resides in the Sacramento area. She holds a Studio Arts degree from CSU Sacramento. Nunes has exhibited paintings, sculptures, large permanent and temporary installations locally and in the Bay Area, including several large commissioned pieces for restaurants and other commercial spaces. Her work is part of numerous private collections throughout California and the U.S. She currently serves on the board, and curates for, Sierra Wax Artists, a Sacramento region chapter of International Encaustic Artists (IEA). Nunes is a co-founder of Rancho Cordova Arts.

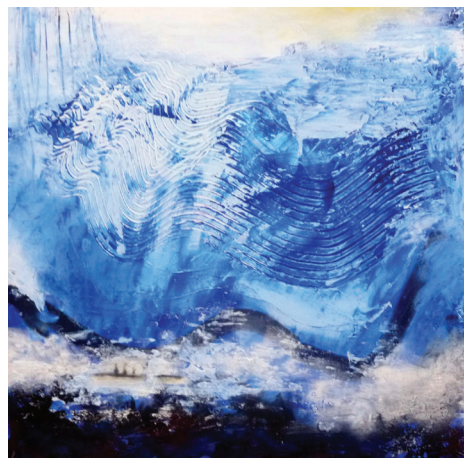
"Viewing my work placed along a gallery wall is a tour through shapes, marks, lines and color that carry symbolic and private meanings. I expect the viewer will translate these into something personal as well. Digging and scratching into a surface or adding layers of paint are my own method of either healing, understanding my world, or dealing with current issues," Nunes said in her artist statement for the show. "My desire is that these paintings offer an invitation for the observer to linger, to consider what is beneath, covered or peeking through these layers of tactile and complex surfaces of hot or cold bee's wax media."

The artist will be attending the opening reception, 5:30-8 p.m. Friday, June 4, coinciding with the downtown Woodland First Friday event. Music will be performed by solo guitarist Jon Spivack.

The exhibition can also be viewed virtually at yoloarts.org, and at noon on June 21, Nunes will be giving a talk about her work

when he slowed down to let the vehicle in front of him make a u-turn.

Once clear, the driver of that car heard Opie accelerate.

Witnesses say a vehicle backed out of a driveway, saw Opie and froze. Opie did not have time to stop; he hit the vehicle with enough force to shatter all of the windows, and he was killed instantly.

Police, at the time of publication, say neither drugs nor alcohol appears to have been a factor. There were no other known injuries.

Come watch the bats of the Yolo Causeway

Summer is right around the corner, and the bats are back! The maternity Mexican free-tailed bat colony under the I-80 Yolo Causeway is growing daily as they return from wherever they spent the winter. Although many of the bats over-winter in the bridge, most seem to leave.

As the weather warms, crops grow and insect populations explode, the bats return to the Causeway.

These amazing, winged wonders are mammals that can fly. Each summer the females give birth, in late June, to one pup. She nurses that pup for about 5 to 6 weeks,

and then it joins her as she flies throughout the Central Valley to consume crop pests and mosquitoes. There also are males that live in the Yolo Causeway bridge, but their groupings are smaller, so they are less noticeable.

Throughout the summer, Yolo Basin Foundation offers many opportunities to learn more about the bats. Registration is now open and some evenings have already sold out. This year the Bat Talk and Walk events are in a hybrid format.

The Talk is via Zoom and the Walk is in-person.

Maybe you want a more personal experience like Batty for Bats, or to learn to build a Bat House, or possibly you only want to hear the Talk to learn more about bats. All events and some fun fact videos about the programs and the bats can be found at yolobasin.org/bats2021.

May 28 declared "CASA Appreciation Day" by the California State Legislature

California CASA, the private, nonprofit organization overseeing 44 local Court Appointed Special Advocate (CASA) programs throughout the state of California, is honored that Senator Josh Newman (CA Senate District 29) put forth the bill SCR 49, which declared May 28 as CASA Appreciation Day in California. This is an opportunity for California to honor and thank the dedicated CASA volunteers who ensure children and youth in the foster care system have their voices heard every day. CASA Appreciation Day also gives the residents of California a chance to better understand the critical role a CASA volunteer plays in the lives of young people, and inspire others to contribute their time and resources to support children in foster care. Throughout California, there are nearly 9,000 volunteer CASAs providing court advocacy and dedicated support to 14,000 foster children and youth.

Sharon M. Lawrence, Esq., CEO of California CASA, said, "We are so honored and grateful that Senator Newman and the State Legislature are recognizing the extraordinary men and women who selflessly dedicate themselves to the

abused, neglected children in California's foster care system. These CASAs are changing children's lives every single day, whether by submitting thorough court reports to update judges on a child's status or just being a consistent, trusted adult in a child's life—genuinely interested in their well-being and providing hope and support during very difficult times."

CASAs advocate for the best interests of children in foster care (ranging in age from birth through age 18 or 21, when they "age out" of foster care). A CASA volunteer, trained by their local county's CASA program and appointed by a judge, provides the court with the comprehensive and objective information the court needs to make the most well-informed decisions and to help ensure positive outcomes for children and youth. These individuals not only advocate for children within the court, child welfare, and school systems but also form relationships with them that last for years. CASAs are trusted adults in these children's lives, giving them a "voice" in court, in schools, and in the community.

Our volunteers come from all walks of life; they are rigorously screened and trained extensively

by their local CASA program professionals, and receive 35 hours of training before they are assigned to work with a child. They receive ongoing support from CASA program professionals to help them advocate effectively on a child's behalf. CASAs take the time to get to know the child at the heart of each case. They work in partnership with legal and child welfare professionals, educators, and service providers to ensure that each child has what they need to heal and thrive.

Since the onset of the COVID-19 pandemic in 2020, California's CASAs have remained committed to providing best-interest advocacy for their case children who have experienced abuse or neglect, and, as an organization, California CASA has worked with all 44 local programs to ensure that they have the support, technology, personal protection equipment, and other necessities to allow CASA advocacy to continue to interact virtually with their case children and the court when that could not happen in person.

To recognize the dedication and resilience of volunteer court advocates nationwide, the California State Legis-

lature passed SCR 43, introduced by State Senator Josh Newman (who represents portions of Los Angeles, Orange, and San Bernardino Counties). The bill text reads:

WHEREAS, All children have the right to a home with loving people to care for them, but each year in the United States, children are abused, neglected, or abandoned by their families. These children are removed from their homes, placed in foster care or institutions, and eventually end up in court; and

WHEREAS, A judge has the power to decide the future for these children and whether they should remain in foster care, be reunited with parents, or adopted, but in many cases, the children become victims for a second time, lost in an overburdened child welfare system that cannot pay close attention to each child; and

WHEREAS, CASA Appreciation Day recognizes the important role played by Court Appointed Special Advocate for children (CASA) volunteers. These trained community volunteers are appointed by a judge as officers of the court to speak up for children in juvenile court and to help humanize the often frighten-

ing and confusing child welfare and legal systems for these children; and

WHEREAS, Eighty thousand of California's children are in foster care because they have been abused, neglected, or abandoned. In 2020, 8,798 CASA volunteers supported 14,150 foster children in California. CASA volunteers play an important role in their lives by getting to know a foster care child and letting the judge and others in the child welfare system know about the child's perspective and needs; and

WHEREAS, The CASA mission is to ensure consistency and support for children in the foster care system through the use of volunteer advocates advancing the best interests of each child; and

WHEREAS, The CASA vision is one where every child in need is appointed a CASA volunteer to champion the child in court, without compromise, on the path to a safe and permanent home; now, therefore, be it

Resolved by the Senate of the State of California, the Assembly thereof concurring, That the Legislature hereby declared that May 28, 2021, is recognized as CASA Appreciation Day in California.
