bers and over 35,000 clubs. The Rotary Club of West Sacramento, Centennial is one of 35 Rotary Clubs in the Sacramento region governed under District 5180.

Yolo County Seeks Public Input on Workforce Development Plan by June 1

The Yolo County Workforce Innovation Board (WIB), local workforce development board, is soliciting public input on the 2021-24 Workforce Innovation and Opportunity Act (WIOA) local plan to help identify strategies to achieve state goals related to workforce development. The deadline to provide feedback is June 1, 2021.

The federal WIOA offers a comprehensive range of workforce development activities through statewide and local organizations. Available workforce development activities provided in local communities can benefit job seekers, laid-off workers, youth, incumbent workers, new entrants to the workforce, veterans, persons with disabilities and employers. WIOA services are provided

to eligible applicants on a case-by-case basis with the priority of service status provided to recipients of public assistance and other low-income individuals for intensive and training services. Yolo County's original Workforce Innovation Board Local Plan and 2-year Modification was approved by the Board of Supervisors in 2017 and 2019, respectively. The Local Plan is required to be updated on a biennial basis, ensuring the plan remains current and accounts for any changes in the labor market and

State Still Requires Face Coverings in Yolo County

Until notified by Yolo County, residents are still required to wear face coverings in certain settings based on the California Department of Public Health's (CDPH) guidance for use of face coverings.

On Thursday, the U.S. Centers for Disease Control and Prevention (CDC) announced changes to its recommendations for fully vaccinated people, indicating that fully vaccinated people no longer need to wear a mask or physically distance in most settings. However, these recommendations do not go into effect locally unless

CDPH amends its current face-covering mandate. Residents of and visitors to Yolo County are required to follow the CDPH guidance for face coverings.

The current CDPH guidance requires that vaccinated individuals wear a mask indoors and when attending crowded outdoor events or other similar settings. In addition, unvaccinated individuals are required to wear a face covering outdoors any time physical distancing cannot be maintained, as well as indoors. There are

THIS 'n' THAT Homeless Camps & Wildfires – NOT OK

Long past the hours most of us were asleep May 2, West Sac and other firefighters were battling a wildfire at Discovery Park. By noon newscasts Monday May 3, 14 acres had burned. More still were smoldering.

A Nextdoor poster, driving by on I-5 about 2 a.m. May 3, called 9-1-1 to report a 'small fire' at

Discovery Park. His cell video showed a black night sky made red with flames. He called it in, he said, because he “knew it would get bigger.”

Responding firefighters said five acres were burning when they first arrived. Seven riparian (riverbank) acres “burned to a crisp,” said another Nextdoor poster. On the news, it said an ‘encamp-

ment’ was where the fire started.

So much for Red Flag warnings.

And here’s a fact. ‘Camper’ carelessness not uncommonly causes wildfires.

I’ll never forget daytime 2013 news video, taken from a chopper, of panicked wildlife,

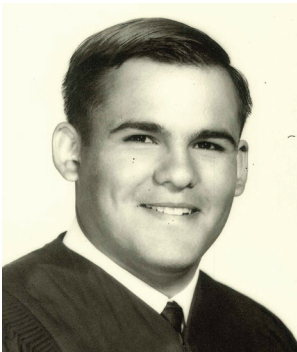

In addition to advising the county District Attorney on wheth-

er to bring indictments in select criminal cases, the Yolo County Grand Jury also conducts an annual inquiry into the condition and management of public jails. The Grand Jury is made up of 19 citizens selected by the Yolo County Superior Court after an application process. Jurors serve one-year terms that conclude on June 30 each year. a few exceptions for those who are vaccinated when visiting indoors with others who are fully vaccinated or low risk individuals.

"The updated CDC recommendations do not change anything on the ground in Yolo County," said Yolo County Public Health Officer Dr. Aimee Sisson. "Yolo County follows CDPH's masking order, which has not been updated. Unless and until CDPH changes its

masking guidance, fully vaccinated persons still need to wear masks indoors in California, including in Yolo County."

People with no or few symptoms of COVID-19 can still spread the disease and the use of face coverings, combined with physical distancing and frequent hand washing, will help reduce the spread of COVID-19.

Residents are recommended to get vaccinated as soon as possible, especially now that residents 12 and older are eligible in Yolo County. Current data show that the COVID-19 vaccines protect residents from circulating strains, including variants, signifi-

cantly reducing the chance of getting severely ill or dying from COVID-19. All of the COVID-19 vaccines have been shown to be safe and effective and are free for all residents. The more people who are vaccinated, the harder it is for COVID-19 to spread.

Partnership to Scale Use of Racial Data, Analytics by Prosecutors Offices to Advance Transparency and Accountability

Measures for Justice, the Association of Prosecuting Attorneys, and Tableau Foundation have come together to help prosecutors use data to pursue a more equitable criminal justice system.

The partnership brings a groundbreaking new public data tool, Commons, to participating district attorney (DA) offices nationwide. A community-facing dashboard, Commons invites residents and local organizations to engage with their DA on the same set of facts, to track progress via monthly data, and to benchmark the office's progress against a shared policy goal—all in pursuit of a more equitable and efficient criminal justice system. The partnership will also support the development of national metrics all prosecutors can use to assess their performance.

Commons serves prosecutors looking for a tool to make data transparency a key part of a reform agenda that advances public safety and ensures equitable treatment under the law. It also serves communities that are looking for avenues to increase accountability for the institutions and offices that serve them.

The partnership is targeting a pilot cohort of 15 DA offices for the program, and implementation ranges from providing complete Commons dashboards to helping DA offices improve their data management as they work towards data transparency. To kick off the partnership, East Baton Rouge Parish, LA; Jackson County, MO; and Bernalillo County, NM are committed to implementing complete Commons. Additionally, Fairfax County, VA will receive technical assistance to put them on the path to a public dashboard.

"Prosecutors must have adequate data to assess their decision-making, and communities need that data to hold their prosecutor accountable. Commons is a win for everyone. It's about finding a way to communicate with one another in pursuit of a shared goal: a better, more fair and efficient criminal justice system," said Amy Bach, CEO of Measures for Justice.

A national organization focused on making criminal justice data meaningful, actionable, and available to the public, Measures for Justice is leading the development of Commons, a co-created space for the community, police, prosecutors, and courts to make criminal justice data transparent and shared goals public. Measures for Justice designed the public dashboard as a template. Starting with an assessment, they work with the prosecutor agencies to improve data so that the agencies are prepared to adopt the Commons template.

Measures for Justice partnered with Yolo County, CA, District Attorney, Jeff Reisig, and the office's Multi-Cultural Community Council to design and build for the community its own Commons, which launched last month. The Yolo County initiative was funded separately but illustrates the impact that the dashboard is already making at the local level.

"Criminal justice leaders must take the responsibility for driving reforms that improve fairness and consistency in prosecutorial decision-making and justice system performance," said Raúl Torrez, Bernalillo County District Attorney in Albuquerque, New Mexico. "By collaborating with Measures for Justice we are advancing a national effort to build community trust in the justice system through transparency and accountability."

A complete Commons dashboard is co-created with local communities. The DA's office assembles a team of community leaders to share what data and policy goals are important to them. The dashboard, in turn, provides access to:

- Clear data about the cases that pass through the office (e.g., cases resolved on a monthly basis).
- Patterns and trends are broken down by defendant and victim demographics, and case characteristics (e.g., racial disparities in sentencing).
- Progress towards specific policy goals (e.g., monthly case diversions).

As the national leader in technical and training assistance, the Association of Prosecuting Attorneys (APA) will be critical for helping scale the widespread adoption of Commons.

"Often there is a lack of consensus around how prosecutors should measure their progress, which makes it impossible to replicate what's working," said David LaBahn, President and CEO of the Association of Prosecuting Attorneys. "[a]nd that lack of consensus around how prosecutors should measure their progress makes it impossible to replicate what's working. This is a terrific opportunity for data to take its place among the most valuable resources available to both the prosecutor's office and its community."

This partnership is the third major grant made under Tableau Foundation's Racial Justice Data Initiative, a \$12 million, three-year commitment to building the data capacity of national, regional, and community-based organizations working to fight anti-Black racism and to democratize access to racial justice data that advocates need to push for change at the local level. This partnership includes support that allows prosecutors' offices to more easily make this data publicly accessible and explorable by their local constituents.

"We're excited to be partnering with Measures for Justice and the Association of Prosecuting Attorneys on this initiative," said Neal Myrick, Global Head of Tableau Foundation. "We have a great opportunity to empower those offices to provide data in a way that is transparent, helps build community trust, and creates a point for meaningful engagement."

Dear Editor,

The Yolo County Board of Supervisors last week took a bold step toward increasing surplus edible food recovery in Yolo County, by adopting a new Sustainability Plan advancing this activity so critical to our mission at Yolo Food Bank. We are deeply grateful, and applaud Yolo County's emerging position as a statewide leader in food recovery, prioritizing the re-direction of this food to feed food insecure residents, rather than the landfill.

Adjusted for the cost-of-living, Yolo County has the third highest poverty rate in a state with the highest poverty rate in the nation. According to readily available online living wage calculators, 48% of Yolo County families struggle to make ends meet, and, according to the County, 56% of area school children live in these struggling families. It is heartbreaking to think that this occurs in a county well-known for its bountiful agricultural output.

By prioritizing the recovery of this fresh, nutritious edible food for distribution to children, seniors, veterans, farm workers, undocumented residents, and hard-working families, the Supervisors have charted a path to a food secure county, there-

by easing poverty. This same path also leads to increased housing security, and better health and wellness and mental health outcomes for chronically vulnerable populations county-wide, by offering them dignified access to the healthy food that they need to survive and to thrive.

A 2018 study by Cal-Recycle estimates that 1.1 million tons of surplus edible food fit for human consumption is sent to California landfills every year. Based upon Yolo County's population size, it can be inferred that Yolo County may send as many as 12 million pounds of surplus edible food – worth approximately \$25 million dollars – to the landfill each year, instead of re-directing it to neighbors in need. The disposal costs for these landfill trips are borne by County residents, and this practice perpetuates barriers to food access for too many struggling residents that aren't just, equitable, or inclusive.

Fortunately, current state law requires all jurisdictions statewide, including Yolo County and the cities of Davis, West Sacramento, Winters, and Woodland, to make plans no later than this January 1 to recover the maximum amount possible

of this valuable surplus edible food on an ongoing basis, and ensure its distribution to food insecure residents. This state mandate aligns well with the county's new Sustainability Plan.

By dramatically escalating food recovery efforts, Yolo Food Bank has been able to respond to both the sharp increase in food security needs during the COVID-19 crisis, as well as to the pre-existing needs in the community revealed by the pandemic. In partnership with the county and the cities, we look forward to sustaining and expanding this service thanks to this broadening commitment to surplus edible food recovery.

Together, we can “Nurture Yolo,” and develop an equitable, sustainable local food system for the health and wellness of ALL Yolo County residents.

Residents United to Demand a Cannabis Exclusion for Greater Capay Valley

(The following is an open letter to the Yolo County Board of Supervisors)

Dear Supervisors:

We are residents of the rural communities along Highway 16 west of the 505 in Yolo County, with most of us living and some of us farming in and around Madison, Esparto, Capay, Brooks, Guinda and/or Rumsey. This area is a special one, renowned for the quality of its produce and sustainable farming, and variously called the “Capay Valley” or “greater Capay Valley.”

We submit this letter to express our strong and united opposition to the cannabis industry in our communities.

Since the County first began experimenting with the cannabis industry four years ago and authorized cannabis cultivation without any prior analysis or environmental review, the greater Capay Valley quickly became overwhelmed with cannabis grows. As you stand ready to approve an Ordinance that will bring some permanence to this industry, we ask you to hear us. While we recognize the County wants this industry because of the revenues it will generate, the Board needs to consider the real costs this industry poses to our way of life.

Many of our families have lived in this region for generations. We have personally witnessed – and experienced – the harmful impacts of this industry. We want to make it clear to you, the elected Board of Supervisors, including our District 5 Supervisor Angel Barajas, that we want the cannabis industry out of the greater Capay Valley, which needs to be protected from cannabis cultivation and related uses with an express exclusion or ban.

Many of us have been attending community meetings and verbally commenting or submitting letters of concern to the Board since this idea was proposed. After the idea became reality with cannabis grows in our Valley, we continued to communicate our grievances to the County. Our concerns have gone unheard. Scores of Capay Valley residents submitted comment letters explaining how the industry was negatively impacting the quality of our lives. Of

the 78 letters submitted to the board regarding the CLUO/EIR, nearly half (48%) were from people who live in and between the greater Capay Valley, from Madison up to Rumsey, along Highway 16 west of the 505.

The County's staff continues to assure the Board they have adequately responded to our concerns. The reality is otherwise. No material changes have been made to the Cannabis Land Use Ordinance that was supposed to fix this problem, the Environmental Impact Report that was supposed to fairly analyze it, or the staff reports that supposedly addressed community concerns.

It is appalling to see community feedback so disregarded on a matter that so deeply affects our daily lives.

The communities of the greater Capay Valley are small, with a burgeoning agritourism industry that has been cultivated and supported with years of effort. We must preserve the character and culture of this place for generations to come, and we must be vigilant about how our actions will impact future generations. This region is simply not suitable for cannabis grows, which has a history of drawing miscreants and generating crime and exploiting already limited resources – including the precious and increasingly scarce water needed to grow food.

People, no doubt, solicited by the cannabis industry have appeared at a recent Board meeting and misrepresented our position. Their falsehoods bear correction. For the record, we do NOT oppose cannabis in Yolo County. We support people's right to grow and buy it legally, and the County's right to tax it. The issue for us is not whether it should be authorized, but where it should be grown. Our position is a common-sense one: it should not be grown in rural and residential communities where people live. Cannabis cultivation is simply incompatible with rural communities like ours, the Capay Valley, for reasons we have variously explained in letters to the County, again and again. And contrary to assertion, we have not been silent, but have advocat-

ed for the protection of our community for four years.

We have also been dismissed by persons in the cannabis industry as a “special interest” group. That is absurd. We are farmers. We grow food. We earn scant profits on our farms compared to cannabis investors, whose operations generate as much as \$6 million per acre. Our only agenda is to protect our families, our community, our rural culture, and our livelihoods. Also wrong – and ridiculous – is the assertion that cannabis is simply farming, another crop worthy of County support. To put a point on it, no other crop attracts criminal miscreants, and requires 24-hour security with armed officers and guard dogs to protect it from theft; no other crop must be so strictly regulated and requires law enforcement to accompany regulators; no other crop uses the kind of chemicals that create such serious wildfire risks, and no other crop generates non-stop light and noise and emits skunk smells for months on end to the misery of neighboring landowners.

When the County started this experiment four years ago, without any environmental review, we were assured that the licenses issued were temporary, interim only, creating no legal entitlements. The County needs to put its words into action, and approve a common-sense land use policy that protects the Capay Valley, an area whose unique brand, topography, limited accessibility, farming culture and lack of law enforcement makes it particularly unsuitable to cannabis cultivation.

This list of concerned community residents stands united to demand cannabis grows to be banned from the greater Capay Valley. That includes Madison and Esparto, and not simply the communities beyond the town of Capay. We ask Supervisor Angel Barajas, the person elected to represent our interests for District 5 – and all other Supervisors who helped create this problem – to stand with us to protect our beloved Valley.

tongues lolling, trying to outrun smoke and flames near Cal Expo.. A doe, a jackrabbit, a coyote. The fire’s cause? A homeless campsite. Some (maybe many?) campers, inebriated or high when they pass out – drop what they were smoking? Or don’t put out their cooking fire. Or the fire started to keep warm.

It takes just one spark to start a wildfire in tinder dry condition – like we have now – especially when it’s windy.

There were no reports of human injuries at Discovery Park’s fire. But wildfires, far too often human-caused, are deadly for wildlife, possibly for pets (like dogs left tethered to a tree), and are **always** dangerous for responding firefighters.

I don’t blame campers for every wildfire. Lightning. A cigarette tossed from a moving car. Even, recently, a gender reveal party start can start fires. But I know personally of two, maybe three, wildfires in West Sac where camper carelessness was likely. On Next-door, posters decried the camper-caused fire in Discovery Park. One described scouting possible fishing areas with her son and coming across “several HUGE encampments (like small cities that house 15+ people).” She added, “It’s incredibly sad to see what is happening along our beautiful rivers.”

Well, sad to say, it’s nothing new. When I first moved to West Sac in 2008, I asked the woman in my office about Sacramento River fishing. She gifted me with a canister of pepper spray. She said if I planned to fish across from Discovery Park, I might need it. “A lot of homeless camp back there,” she said.

Well, I like natural areas, my dog liked exploring along the trail, so, with pepper spray in pocket, I walked back to Bryte Beach (directly across where Discovery Park is bordered by the American and Sacramento Rivers). Weary of no bites, but losing hooks to submerged junk, I reeled it in. And noticed, up on the bank, a man there scowling at me.

My ‘fishing’ path was a distance from where I’d seen him, but I assumed he was inside a structure off to my right. A tall thick bush was its back wall; assorted branches were the sides and top.

Some social outcasts are rejected by long-established camps that boast tents and such. Others just don’t like people much. This solo camper’s campsite had no trash that I could see, but not far away, in an abandoned lot, there was a dumpster. Maybe he used that?

Campers have a way of repopulating favored sites. Despite ongoing efforts by cities and community groups to “connect the homeless with resources,” some resist help that comes with

strings attached. Shelters, for example, have ‘rules.’ No dogs. No booze. And look, would you want to pitch a tent in a hot parking lot if you could live under trees with a river right there bathe in? They like ‘freedom’ from interference – until their campsite starts a wildfire.

So here’s my thought: At all known camps post photos of homeless camps destroyed by wildfire. Above the photo, in great big **fluorescent** letters, put: DOUSE/SMOTHER CAMP FIRES, METH PIPES, CIGARETTES AND BLUNTS. IN CASE OF FIRE, UNTIE YOUR DOG.

Encourage creating ‘defensible space.’ Community groups could conduct a ‘tool drive’. Take collected tools like rakes and shovels to the camps. Volunteers, or better yet the campers, can level potential tinder down to dirt at least six, even 12, feet out from habitations. Maybe companies like Waste Management would contribute dumpsters: a community service gesture, or funded by the state. Reducing tinder around such campsites will buy campers come time if there’s a wildfire.

Let’s be honest. Without alternatives attractive to the homeless, it’s pointless to evict them from longtime camps. They’ll just set up elsewhere – or come back. So let’s protect our firefighters, homeless animals and wildlife.

Carol knows some may oppose this as ‘coddling’ and ‘encouraging’ the campers, but counters, “Do the math. Which costs more? Trying to change that which history shows us will not change? Or giving the homeless a few tools to make things better? Given the opportunity to have pride of place – a different lifestyle may, for some, seem possible. Questions, comments? The 2021 Yolo County Fair will not run as planned and will not be open to the public.

When discussing plans for the fair, CEO Vannucci, Fair Board & staff expressed concern for public health, as well as the financial impact of hosting a fair that would adhere to current safety protocols and the lasting impacts of the long-term sustainability of the event.

Although vaccination rates are improving significantly each day, California continues to fight the battle against COVID-19 including the new variants. Where we are today in this struggle makes it difficult to plan a large-scale entertainment event like the free gate Yolo County Fair, especially not knowing where we will be, or what Yolo County and the State of California will look like, in August.

In addition, the important safety practices that have been put in place to protect Californians, including indoor seating capacities, live events seating capacities, proof of testing or vaccines, and other restrictions may lead to attendance that is considerably lower than previous years. The financial im-

plications of hosting a typical Yolo County Fair with the same overhead costs as previous years, but far less revenue, could be devastating to our association. In a typical year, the Yolo County Fair’s budget is designed to break even or have a nominal profit. Holding a full fair this year would likely lead to significant financial loss.

While we wish we had the ability to see the future we do not. Taking all the above into consideration CEO Vannucci, the Board of Directors and fair staff feel that the best decision is to greatly limit the traditional aspects of the Yolo County Fair. While this is a difficult decision, we feel it is the best way to protect the long-term sustainability of the Yolo County Fair, as well as the safety of those involved.

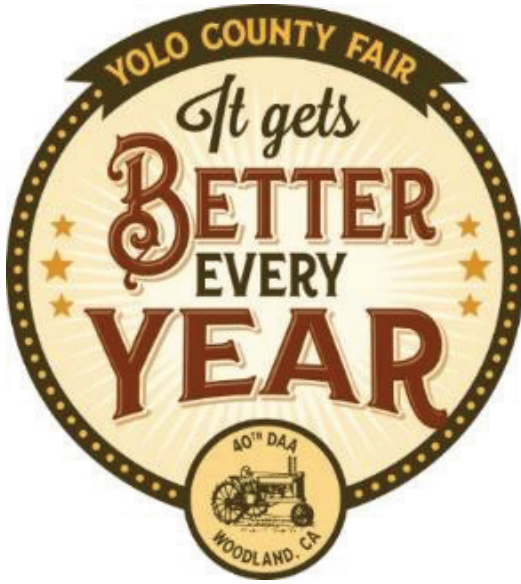
The 2021 Yolo County Fair will be limited to FFA Market Animal exhibitors and their family members for a week-long event that will culminate with a Live Auction on Saturday August 21st.

We fully plan on bringing back the full Yolo County Fair in 2022, with its carnival rides, the 2-night demolition derby, the ro-

deo, entertainment, food vendors including local beer booths, livestock shows and all the homegrown exhibits you have come to expect.

Detailed plans for the FFA Market Animal Event are forthcoming on our website.

Stay tuned for news on our website about a Family Event Center coming to our grounds complete with Carnival Rides & Food July 29th to August 8th, plus a Virtual Stills Showcase where you can enter your arts, crafts, sewing & photography and just maybe a Summer Rodeo.

ternational projects from providing clean water or solar cookers to small villages in Mexico to providing international emergency shelters for families victims of natural disasters or displaced due to ethnic genocides. The group continues to provide help, either through donations or volunteer services, to local organizations, provide dictionaries to 3rd grade charter schools, built garden boxes, installed irrigation lines, prepared walking path material for both Southport Elementary and River City High School garden clubs, and partnered with the local equestrian club literacy program for WUSD third grade classes about horses.

This past year the group contributed to the annual West Sacramento Christmas Basket Food Drive, provided needed supplies and financial support to Empower-Yolo family shelter, contributed and helped the city of West Sacramento hand out Halloween goodies and spent various weekends on roadway trash pickup. In addition, the group is coordinating with the Washington Unified School District administration to help finance several low-income families with their monthly internet service fees in order for students to have adequate access to online teaching programs. They purchased gardening and farming equipment, including hand tools to the Center for Land Based Learning tool program and Clarksburg-West Sacramento 4-H Club, and donate-volunteer with Yolo Food Bank.
