## Residents Urged to Get Tested and Vaccinated as Cases of COVID-19 Variants Rise in Yolo County

As more cases of the COVID-19 variants are identified in Yolo County, residents are urged to test regularly and get vaccinated as soon as they are eligible.

During the first week of April, two-thirds of Yolo County positive cases analyzed genetically were the B.1.1.7 variant, though the B.1.351 and P.1 variants have also been detected in California and locally. These variants spread more easily, may cause more severe disease, and may be resistant to available treatments. For reopening to continue safely, it is vital to prevent spread of these variants.

Testing is a critical tool in controlling the spread of COVID-19. Testing is the only way to know how much COVID-19 is actually present in any given community, since many people infected with coronavirus have no symptoms. By identifying positive individuals and asking them to isolate at home, testing stops viral spread. Testing also allows the public health department to monitor for variants and gauge the success of vaccination efforts. Unvaccinated residents are strongly encouraged to get tested on a regular basis. This includes those

participating in in-person learning. Free testing is widely available in Yolo County through OptumServe, with locations in West Sacramento, Winters and Woodland, as well as through Healthy Davis Together. More information about testing options can be found at: http:// covidtesting.yolocounty.org/.

Vaccination is another critical tool control the spread of COVID-19. Residents are recommended to get vaccinated as soon as possible, especially now that residents 16 and older are eligible in Yolo County. Current data show that the COVID-19 vaccines protect residents from circulating strains, including variants, significantly reducing the chance of getting severely ill or dying from COVID-19. All of the COVID-19 vaccines currently available have been shown to be safe and effective, with rare cases of serious side effects, and are free for all residents. The more people who are vaccinated, the harder it is for COVID-19 to spread. The best vaccine to get is the first one offered to you. Businesses and organizations that plan to host indoor private events or indoor live events and performances, including concerts, sports competitions, wedding receptions, or proms, need to be particularly cautious in light of spreading virus variants. Organizers of these events are encouraged to require all attendees of such events to show proof of full vaccination or a recent negative test. Rapid antigen tests at the door of such events are an option to ensure guests are not infected with coronavirus.

"Total new cases of COVID-19 in Yolo County are holding steady, but this is falsely reassuring," said Yolo County Health Officer Dr. Aimee Sisson. "The steady total masks a concerning increase in cases caused by more infectious variants. These same variants have caused tremendous surges in other counties and other states. To avoid a surge that could overwhelm the health care system and cause more COVID deaths, we need to be extra careful right now. Getting vaccinated and getting tested regularly until you are

vaccinated are the best defenses, along with wearing masks, staying 6 feet away from people you don't live with, and choosing an outdoor activity whenever possible."

With the State's announcements that larger gatherings and indoor private events can start April 15 and the Blueprint tiers may potentially cease June 15, it is now more important than ever that residents stay vigilant to prevent a surge in cases. Residents should continue following these health and safety measures:

Wearing a face covering when in public

Practicing physical distancing with others not in your house-hold

Avoiding large gatherings Opting for outdoor activities versus indoor activities

Yolo County Children's Alliance Hosts First Vaccination Clinic for Underrepresented Communities in West Sacramento

The State of California and Yolo County have been distributing vaccines widely, and YCCA, in coordination with Yolo County, held the first vaccination clinic in West Sacramento with an outreach focus on the Bryte and Broderick neighborhoods, distributing 542 vaccines.

(West Sacramento, CA) On Saturday, April 10, 2021, from 10:00 a.m. -2:00 p.m. the Yolo County Children's Alliance, in partnership with Yolo County, District 1 Supervisor, Oscar Villegas, the City of West Sacramento, and Holy Cross Church, held West Sacramento's first widely attended vaccination clinic, distributing 542 first-dose vaccines to residents in the 95691 and 95605 zip codes who were over 18 years old.

The outreach for this vaccination clinic focused on the Bryte and Broderick communities. In these neighborhoods, many of the residents may not be English-speaking, or may have limited access to internet or technology. To remove any cultural, language, or technological barriers and encourage residents to get vaccinated, YCCA and Yolo County distributed flyers in various languages, and CDC information about the vaccine, to clients of the Yolo County Children's Alli-

New West Sacramento Public Dock Completed

Boaters will now have access to amenities in the Washington and Bridge Districts

West Sacramento's public dock along the River Walk has been completed and is expected to open to boaters later this spring.

ance, along with grassroots efforts within the neighborhoods. Furthermore, the County and YCCA made sure to include several translators at the clinic who spoke Spanish, Russian, Farsi, and Urdu.

"The residents in the Bryte and Broderick communities are a large portion of the Yolo County population who have not been able to get vaccinated. With residents in these communities having English as a second language, or being lower income households, a lot of these people may not have access to the information about the vaccines or about clinics, and a lot may have technological or language barriers to getting that information," said Oscar Villegas, Yolo County Supervisor for District 1, who was pivotal in securing vaccines for this clinic. "Furthermore, when clinics are not within walking distance, many of these residents may not have a car to get them places. The pur-

pose of holding this clinic in such a central location is so that we reach these residents and get vaccination opportunities to the entirety of our community."

The Yolo County Children's Alliance centralizes their services on disadvantaged communities. YCCA focuses on acknowledging language barriers, cultural differences, religious concerns, and overall disadvantages when it comes to technology and resources. Holding a vaccination clinic is only the tip of the iceberg when it comes to services provided by YCCA. The organization offers family strengthening programs, housing assistance programs, parenting classes, tax preparation assistance, Medi-Cal and CalFresh enrollment assistance, weekly food distributions and so much more. - Recover at least 20% of currently disposed edible food by 2025.



## Come Find It...Sacramento History Museum has Reopened Indoors and Resumed **Popular Old Sacramento Underground Tours & Immersive Gold Fever! Games**

The Sacramento History Museum, which now has more followers on TikTok than any other museum in the world, has reopened for indoor visitation and resumed popular Old Sacramento Underground tours and Gold Fever! games that take place throughout the historic district and the Old Sacramento Waterfront.

Inside the museum, visitors can explore 7,000 square feet of display space with a spacious layout for easy physical distancing. In addition to making a stop at the historic print shop on the main floor – and possibly getting glimpses of the now-famous docent Howard Hatch busy at work - a must-see exhibit is titled California in Print: Highlights of the Eleanor McClatchy Collection that went on display in the R. Burnett Miller Gallery on the third floor just before the shut-down in March 2020. The exhibit showcases rare items and collectibles from the Eleanor Mc-Clatchy Collection that she donated to the City of Sacramento and the Center for Sacramento History. Eleanor Mc-Clatchy (1895 to 1980) was the granddaughter of James McClatchy who became editor of The Sacramento Bee in 1857, its founding year.

Later, Eleanor went launched in 2010 - proon to preside over the newspaper from 1936 to 1978. In addition to helping to run the family newspaper business (also known as the "three Bees" - Sacramento Bee, Modesto Bee, and Fresno Bee), she was also an avid collector of California history. While only a small percentage of her important and impressive collection will be on display, the exhibit highlights priceless items such as original Gold Rush era maps showing where gold could be found, first-edition rare books printed in California, letter sheets from 1850s miners, a page from the Gutenberg Bible, dime novels from the 1870s and 1880s, and more. The Sacramento History Museum is located at 101 I Street in Old Sacramento and is open Tuesdays through Sundays (closed Mondays) from 10 a.m. to 5 p.m. Tickets cost \$10 for adults, youth ages 6 to 17 cost \$5 and are free for children five and under.

In addition, two history-rich Time Travel Tours program offerings have recently resumed, and both start at the Sacramento History Museum. The interpretive Old Sacramento Underground tours – that officially

vide guests with the unique opportunity to explore what has been hidden beneath the city for more than 150 years, while uncovering the facts and legends that lie below historic buildings and sidewalks. Tour guests explore excavated foundations, enclosed pathways and interesting archaeology exhibits while hearing sounds of 1860 street life. Entertaining and knowledgeable tour guides lead the way while recounting tales of the devastation, perseverance, and determination that led to California's only successful street-raising project. Old Sacramento Underground Tours are offered Fridays through Sundays in April. Underground Tours take place at 11 a.m., 12:30 p.m. and 2 p.m. Saturdays and Sundays, and at 1, 2:30 and 4 p.m. on Fridays. Special safety measures are in place and tours are limited to 10 guests. Tour guide and guests are required to wear masks, sanitized sound equipment helps everyone stay physically distant, and complimentary hand sanitizer is available in the Museum and in each underground space. Old Sacramento Underground Tour tickets are \$18 for adults and \$12 for kids 6-17, free for children 5 and younger. In addition, guests to the Old Sacramento Wa-

terfront can experience what it was like to catch gold fever while getting actively involved in the intriguing Gold Fever! games. Participants take on personas of characters in history – or "real-life rascals" - who scratched and clawed their way to make this area the center of the Gold Rush. Never the same experience twice, Gold Fever! games relive Sacramento's early days when gold fever ruled amid horrible disasters that threatened fates and fortunes. To spice things up even more, elements of chance are introduced that could change the fate of tour guests. Through the course of the lively tours that meander through the historic district, visitors discover if they successfully escaped the many floods, if they managed to keep their gold dust (or lost it all at the gambling tables) and if they survived the fires, disease, and occasional steamboat explosion. Gold Fever! game slots are available on Fridays at 1 and 3 p.m. Groups are limited to 10 guests from the same household and need to maintain physically distancing from others. Tickets are \$12 per person and kids five and under are free (and need to be included in the 10 guest count). Guides and guest must wear masks and maintain physical distancing.

All Time Travel Tour tickets include complimentary admission to the Sacramento History Museum. Guests who book an Old Sacramento Underground tour and Gold Fever! game at the same time (even if the tours take place on different days) receive special combo pricing. Tour dates and times fluctuate with the seasons and during holiday weekends; please visit the website for the most updated schedule. ## Yolo County Seeking Grand Juror Candidates

Each year, on July 1, the Yolo Superior Court impanels 19 grand jurors and 11 alternates who serve as an arm of the judicial system, but act as an entirely independent body.

The primary civil function of the grand jury is to review the operations of city and county government as well as other tax supported agencies and special districts. Based on these reviews, the grand jury publishes its findings and may recommend constructive action to improve the quality and effectiveness of local government.

#### Eligibility requirements for grand jury service are:

- You must be a citizen of the United States.
- You must be 18 years of age or older.
- You have been a resident of Yolo County for at least one year before selection.
- You possess sufficient knowledge of the English language.
- You are not currently serving as a trial juror in any court of this state.
- You have not been discharged as a grand juror in any court of this state within one year.
- You have not been convicted of malfeasance in office or any felony or other high crime.
- You are not serving as an elected public officer.

Although grand jury service is important work and a considerable responsibility, it is also an exciting opportunity to serve your community and learn more about local government. It can be an incredibly rewarding and satisfying experience. If selected, the term of service is a period of one year, from July 1 through June 30. Applicants should be committed to serving the entire year. The average time commitment is approximately 25-40 hours per month Please submit all applications by May 7, 2021.

## Tax Relief for Homeowners Affected by Disaster Approved by Yolo County Board of Supervisors

The amendment to a local ordinance proposed by the Yolo County Assessor's Office was unanimously approved at the April 6, 2021 County Board of Supervisors meeting. The ordinance offers assistance to qualified property owners who have relocated to Yolo County after the loss of their homes due to the recent wildfires and floods in California. The ordinance allows those individuals who qualify to carryover their previous county's property tax base to their replacement property in Yolo County.

In recent years, our state has seen an increase in residents impacted by natural disasters. Victims have faced significant and sudden tax hikes when relocating across county lines, sometimes just a few miles from their damaged homes.

This ordinance allows for those individuals who lost their home prior to the timeline set by Proposition 19 to potentially qualify for tax relief. Less than a quarter of all the counties in the state have passed such an ordinance to date. "The Board of Supervisors approval of this ordinance will provide direct relief to qualifying disaster survivors who have already moved to Yolo County and made this community their home. We are proud to have worked collaboratively with the Board to initiate the implementation of this tax relief within Yolo County," says Jesse Salinas, Yolo County Assessor/ Clerk-Recorder/Registrar of Voters.

## Solano County Water Agency Extends Lower Putah Creek Salmon Study

Ongoing Study will Determine if a Self-Sustaining Chinook Population is Forming

The Solano County Water Agency (SCWA) has approved another year of funding through Fiscal Year 2021-22 for University of California, Davis researchers to continue their Lower Putah Creek Salmon Study.

As part of ongoing Putah Creek restoration efforts, SCWA and its partners have developed a robust program to monitor the abundance and population dynamics of salmon in Lower Putah Creek. This monitoring program will continue with the implementation of new monitoring tools to determine the presence and growth of a self-sustaining salmon population within the creek.

The study also explores best practices to manage the ecosystem into the future. Salmon runs are a critical part of the Putah Creek ecosystem health, and by creating the ideal habitat for salmon to spawn, whole foodchains stand to benefit as Putah Creek becomes a thriving ecosystem for invertebrates, birds, and fish alike.

"We are pleased to continue to fund a program that will give us a greater idea of how effective our restoration work is for Putah Creek's environment," said Roland Sanford, General Manager

at SCWA. "It's important that we continue to have this research-based feedback as we continue and refine our efforts to improve the creek's flows and habitat."

The project will involve five labs at UC Davis, with collaboration from the SCWA and the California Department of Fish and Wildlife with efforts to sample and track juvenile and adult fish.

"We will be able to use data from DNA comparisons to estimate how many Chinook salmon in Putah Creek originate from past spawners in the system. In addition, we will be able to track juvenile salmon migrations within and outside the system to understand their survival rates and outmigration dynamics, including potential methods for boosting survival," said Andrew Rypel, Associate Professor and the California Trout Chair in Coldwater Fish Ecology at UC Davis. "Increasing understanding of the salmon run on Putah Creek is critical to managing the health of this ecosystem in the future."

SCWA has championed decades of restoration efforts in this region to date, making Putah Creek the statewide model it is today for stream conservation and habitat restoration.

in horror as, with the bit clenched firmly in his teeth, he thundered toward the open barn door. Mom told me later they thought I would be decapitated. At full speed, he thundered through it.

I could see the jam was lower than my head. And remember thinking, "He's not going to hit that with his own head." At that last instant, I threw myself down across his neck as he cleared the door and skittered around on the barn's smooth concrete floor.

His eyes were wild, and mine were, too, but I learned a lesson. Always close and latch the barn door.

Just before I saw all the Nextdoor posts and comments and replies regarding lessons, I'd been reading 'The Horse Whisperer' (copyright 1995). I wish I'd read it before I got a horse. In it, the trainer tells a would be client: "I don't work with people who have a horse problem. I work with horses that have a people problem."

Before long, Ringo and I learned to 'read' each other and I could even ride him bareback. From a full gallop, if I said (calmly) 'walk' - he walked. He was mostly Thoroughbred and could be skittish, but I understood him. In the back wheatfield by the river once, five pheasants burst up right in front of him. I'd seen his ear twitch. My fingers had a tight grip on his mane when he reared and danced back three steps. He came down on all fours, wild-eyed and frothy. I sat back up, gave him a moment as I soothed him, then nudged him slightly with my knee, and we walked awhile, then cantered. Truthfully, I startriding bareback ed because it was such a pain to saddle him. He'd hold his breath, which puffed out his sides, and I couldn't get the cinch tight. Once I switched to bareback, it was both more comfortable than a saddle, plus his faint muscle twitch against my thigh told me we might have .. a moment.

Every horse is different so, to brush up on my skills, I'd like to do that on a horse I could one day really ride., but even nuzzling a soft horse nose again would make me happy.

As we got to know each other, Ringo and I worked things out. He only ran away with me once more. My dogs were chasing him. I felt myself slipping and didn't want to be trampled under flying feet, so launched myself off his side with my feet and landed, headfirst, on a soft sandy field furrow. When I caught up, he was standing by the barn door, head down, eyes penitent bogartonline.com.

when he saw me. "Not your fault," I said, and gently stroked his neck. I shot the dogs a look, and they, too, looked sorry.

4-H cautions, "Don't get attached to farm animals." I tried not to, but couldn't help it.

Ringo. My first and only horse. All these years gone.

And I still love him.



I began my walkabouts from Riverfront Street. I usually begin by walking past Drake's Barn, where I always admire the architecture and design of the building and grounds. It has a very laid-back atmosphere and is a great place to enjoy awesome food and beverages with friends and family.

As I continue to the River Walk trail to where it ends at that Mill Street Pier, I am received by the omnipresent "WEST" art piece that reminds me that they have finally arrived in the West.


It was unveiled on October 29, 2018, in West Sacramento's Bridge District. "WEST" was created and fabricated by artist Janet Zweig. It is a nice addition to the trail and a nice place for a quick selfie or to sit and collect one's thoughts.

An always intriguing landmark is the "Subtile" sculpture along the River Walk. I like to call it the 'disco ball tree' as that is what it resembles, yet it truly an amazing piece of art that reflects its surroundings and blends into the scenery becoming one with nature. There are 34,000 mirrors that sparkle and flash in the sun. It is 26 feet tall and was installed in 2017. It is the work of Czech artist Federico Díaz.

Just beyond the "disco-ball tree" awaits the iconic Tower Bridge, but before I reach it there are many sights and sounds that greet me. Besides the ever-present geese cavorting around the trail or just lounging in the grass, people are navigating the trail on electric scooters. I have never ridden one myself, but perhaps one day will take one for a spin. It looks like great fun and a convenient way to cruise the trail with friends.

Lastly, I have arrived at my destination, The Tower Bridge. I have always appreciated the 'Streamline Moderne' or 'Art Deco' architecture of this bridge. The bridge construction was begun in July of 1934. It had used some of the funds from President Franklin D. Roosevelt's New Deal funds project.

I simply think it is a landmark not only for Sacramento and West Sacramento but for California in general and stands as a visual reminder of the progress and pride of the people of this great state. The sight of people traversing the bridge and the vigilant pigeons that duck and roll overhead ever so gracefully, brings this bridge to life every day and makes me wonder for a moment. How many fish were caught under that bridge and how many boats have traveled along this magnificent river. I am sure those stories outnumber the tiles on the disco ball tree.
