## Yolo Bypass Wildlife Area Scavenger Hunt!

**Visit between March 20 and April 11**

Spring is a wonderful time to get outdoors and explore your local wetlands. Yolo Basin Foundation is hosting a family fun scavenger hunt! Find your way around the Yolo Bypass Wildlife Area using the provided Scavenger Hunt Map, labeled with the scavenger hunt stations. At each station, you will have a fun clue to solve, then hop out of your car to search the back of existing signs and posts for information about the amazing plants and animals that depend on these wetlands.

Visit at least five of the ten stations to enter the prize drawing. You can submit a hard copy of the form or fill it out elec-

tronically on your smart-phone or tablet as you go.

The Yolo Bypass Wildlife Area is almost 17,000 acres of restored wetlands and farmland managed by the California Department of Fish and Wildlife. That is about 25 square miles of habitat in the shadow of the State Capitol, and it's not just for the birds! Although many people visit to birdwatch, there are other things to view and to learn, such as the methods used for wildlife friendly farming – helping both wildlife and providing food for humans. During the Scavenger Hunt, you will explore the area to find clues about the birds and other animals that depend on these wetlands for their survival. You may find River Otter scat

or an owl pellet, learn about the restoration for the Monarch Butterfly or how farmers remove dams to help salmon in their journey through the Wildlife Area.

The Wildlife Area is open to the public daily from sunrise to sunset. You can complete the scavenger hunt on your own at any time between

Saturday, March 20 and Sunday, April 11, 2021.

## Rental Assistance Available to Local Renters and Landlords in State's COVID-19 Rent Relief Program

Income-eligible residents and landlords in Yolo County who need financial assistance for past or future rent and utilities will now be able to apply for financial help through the State of California's COVID-19 Rent Relief program at: [housing.ca.gov/covid\\_rr](http://housing.ca.gov/covid_rr).

Yolo County received \$13.6 million in federal rental assistance funds to enable local, low-income households most impacted by the pandemic to stay in their homes and prevent displacement. The State of California will be administering the rental assistance program on behalf of Yolo County through the CA COVID-19 Rent Relief program and their Housing is Key campaign, which connects renters and landlords experiencing economic hardship due to COVID-19 with helpful information and resources.

The program provides relief to both eligible landlords and renters. Landlords will be able to receive rent reimbursements for up to 80% of unpaid rent between April 1, 2020 and March 31, 2021 as long as they agree to waive the re-

## Center for Land-Based Learning awarded \$25K grant

**Grant will support launch of West Sacramento Urban Farm mobile farmers market**

Kaiser Permanente Northern California awarded \$25,000 to the Center for Land-Based Learning's West Sacramento Urban Farm Program to help launch its new mobile farmers market. The goal of the mobile farmers market is to improve access to healthy foods for West Sacramento low-income residents living in "food deserts" by encouraging the purchase and consumption of fresh fruits and vegetables, while supporting local farmers and promoting workforce development.

"Across the United States, neighborhoods and communities in both rural and urban settings lack access to fresh, healthy, affordable produce. This lack of access has serious consequences on the health and well-being of our community, translating into overwhelming rates of diet-related illness

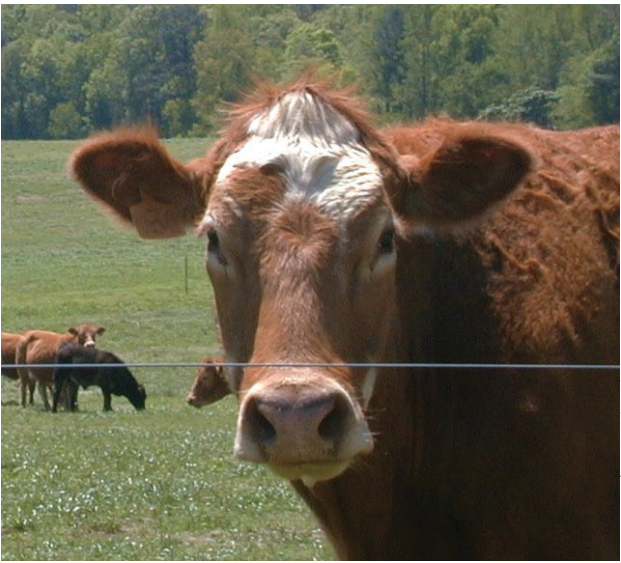

### Gaing Wing Chan

Gaing Wing Chan passed away on February 19, 2021, at the age of 98. He was born and raised in Oroville, CA. After graduating from Oroville High School in 1941, he enrolled at the University of California at Berkeley. However, his freshman year was interrupted when the United States entered the Second World War. During World War II, Gaing helped with the construction of Liberty

cargo ships at the Kaiser Shipyards, and also served as a U.S. Army technical staff sergeant at Camp Beale. He was a recent recipient of the Chinese American World War II Veterans Congressional Gold Medal. After World War II, Gaing continued his undergraduate studies at UC Berkeley, graduating in 1949. He was also a proud member and active alumnus of the Pi Alpha Phi Fraternity. After graduating from Cal, Gaing attended the University of California at San Francisco School of Medicine and earned his medical degree in 1952. He completed his residency training in general surgery at the Southern Pacific Hospital in San Francisco, and then moved to West Sacramento with his wife, Lily, in 1956 where he practiced family medi-

cine and general surgery for 44 years. In West Sacramento, he also served the community as a Kiwanis International service club member, a volunteer physician for the James Marshall High School football team, and a volunteer physician for Kamp Kiwanis. Dr. Chan was an active member of the medical staffs for Sutter and Mercy Hospitals in Sacramento and served a term as President and Chief of the Medical Staff at Mercy Hospital. In his spare time, Gaing enjoyed spending time with his family, working as a part-time “handyman and carpenter” around his home and office, traveling, and watching Cal-Berkeley football and San Francisco 49ers and Giants games. He was predeceased by his beloved wife of 64 years (Lily), his parents, and siblings. He is survived by his six children (Carolyn, Diane, Martin, Patricia, John, Alan), sons/daughters-in-law (Gordon, Kenneth, Lynn, Daniel, Lianne, Carol), 15 grandchildren, 4 great-grandchildren, and many brothers/sisters-in-law, and nieces/nephews. ## Third event in the Community Needs Series highlighted mental health

“[Mental health] problems we've seen in the past were exaggerated and increased by the COVID-19 pandemic,” said Diane Sommers, Suicide Prevention of Yolo County, while discussing the nearly 100% increase in monthly crisis hotline calls during the pandemic. Ms. Sommers spoke as part of the Yolo Community Foundation's March 11 panel on mental health needs, the third event in a five-part series on current needs in Yolo County. The panel featured Dr. Urmi Patel of Sutter Health, Diane Sommers of Suicide Prevention of Yolo County, Dr. Tico Zendejas of RISE Inc., and moderator Petrea Marchand of the Yolo County chapter of the National Alliance on Mental Illness. The series, sponsored by Sutter Health, focuses on current issues in our community that have risen in intensity since the start of the COVID-19 pandemic. The panelists discussed current challenges and opportunities for mental health treatment in our community for both individuals living with serious mental illness as defined in the “Diagnostic

and Statistical Manual of Mental Disorders” and situational mental health conditions caused by life events such as the impacts of the pandemic. The panelists identified challenges including racial disparities in accessing treatment, availability of critical resources, and persistent stigma. They also focused on opportunities to improve services, such as a continuously updated list of resources shared by nonprofits and healthcare providers, more widespread use of telehealth to increase access to care, and community members supporting each other with messages, calls, gifts, and social-distanced visits to ensure meaningful connection. Funding and volunteer support from the community are also key components for organizations to meet the increased demand for mental health services. The panelists identified the following specific opportunities:

**Opportunities to help individuals living with serious mental illness**

- Development of additional permanently supported housing, e.g. adult residential facilities with 24/7 care

- Additional hospital beds in Yolo County for treatment of mental health crises
- Additional case management services to provide assistance with medical appointments and other services
- Improved access to transportation, such as a contract with transportation network companies (e.g. Uber, Lyft) to ensure access to services

**Opportunities to help individuals living with situational mental health conditions**

- Increased outreach and development of community relationships to reduce stigma and build trust in existing mental health services
- Improved use of technology, including smartphone applications, to connect patients to a growing range of treatment options
- Development of clinics in rural communities, such as the new Esparto community center and medical facility being built in partnership between RISE Inc.,

such as diabetes, heart disease and obesity,” said West Sacramento Urban Farm Program Manager, Sara Bernal. “By bringing fresh, high-quality, locally grown fruits and vegetables to residents where they live, we hope to bridge that gap, meeting residents where they are and making it easy for our community members to increase their consumption. By focusing on sourcing from our local urban farms, we will help generate new market opportunities for small farmers while decreasing our carbon footprint. These are the building blocks of a resilient local food system.”

The West Sacramento Urban Farm Program will pilot the mobile farmers market beginning July 6, 2021 through October 2021. This project will serve 14,000 residents of the Broderick and Bryte neighborhoods in West Sacramento. In these communities, 32% of residents are either first-generation immigrants or non-citizens, making these areas ethnically diverse.

The area is classified as a food desert by USDA and has a Food Insecurity Index of 13.6%, according to



Kaiser Permanente’s Community Health Needs Assessment (CHNA). The new mobile farmers market will help improve health outcomes in the area by increasing access to locally grown fresh fruits and vegetables.

“We know access to affordable, healthy food is key to good health, and so is economic opportunity,” said Sandy Sharon, Senior Vice President and Area Manager for Kaiser Permanente in the Sacramento area. “As a founding member of the West Sacramento Accountable Community Health initiative, Kaiser Permanente is pleased to support this project, which will make it easier for people to

purchase fresh, local fruits and vegetables and provide opportunities to develop the local workforce, too.” The project is supported by Kaiser Per-



manente Northern California. With support from the California Department of Food & Agriculture’s Refrigeration Grant, CLBL secured the

resources to purchase the mobile farmers market in 2019. Partnerships with local non-profits including the Health Education Council, the West

Sacramento Housing Development Corporation, and the City of West Sacramento have all played key roles in developing this project.

# Yolo County Fire Safe Council hosts speakers from Solano and Napa Counties

On Wednesday, March 24 at 3 p.m., the Yolo County Resource Conservation District will host the second meeting of the Yolo County Fire Safe Council. Community leaders from the Green Valley Fire Safe Council near Fairfield and the Berryessa Highlands Fire Safe Council in Napa County will share their experience in starting and running their Fire Safe Councils. Fire Safe Councils are community-led organizations that mobilize residents to protect their homes, community and environments from catastrophic wildfire. Experts from the California Fire Safe Council will also be available to answer questions.

The countywide Yolo County Fire Safe Council is an effort being supported by the County of Yolo Office of Emergency Services and led by the Yolo County Resource Conservation District with funding from CAL FIRE. Key stakeholders include local government, Yocha Dehe Wintun Nation, County Service Areas, agencies, utilities, first responders,

local organizations and interested members of the public from Yolo and neighboring counties. The purpose of the Yolo County Fire Safe Council is to provide a venue for communication and collaboration after the devastating LNU Complex Fire and to develop a roadmap for identifying, prioritizing and completing projects that support wildfire preparedness and prevention so as to reduce the risk of catastrophic wildfire in Yolo County.

Through CAL FIRE, the State of California has released \$573 million dollars in funding for wildfire response and resiliency. Qualifying projects and activities include hazardous fuel reduction, fire prevention planning and education. The Yolo County Fire Safe Council will be applying for and administering funds to support local projects.

maining 20% of unpaid rent accrued. Renters making 80% or less of the Area Median Income (AMI) are eligible. In Yolo County, a family of four is eligible for rental assistance if their household income is \$74,000 or less. Income eligibility will be determined auto-

matically as part of the application process.

Eligible renters whose landlords don’t participate in the program can still receive 25% of unpaid rent accrued between April 1, 2020, and March 31, 2021 and can also receive future rent assistance equal to 25% of their monthly rent. Applicants will not be asked about their citizenship, nor will they be required to show proof of

citizenship. Applicants will need to turn in certain documents to show loss of income due to COVID-19.

The CA COVID-19 Rent Relief program is not on a first come, first served basis. Applications will be accepted on an ongoing basis and the State will prioritize funding for eligible applicants who are in most need of assistance. For a complete list of require-

ments, documents and how to apply, local renters and landlords should visit: [HousingIsKey.com](https://housingiskey.com). A statewide network of local community partners is being established to help answer eligibility questions and submit applications. For questions and application assistance call 1-833-430-2122 between 7:00 a.m. and 7:00 p.m. daily.

This is the second time that Yolo County

is offering rental assistance to local renters and landlords. In October 2020, Yolo County partnered with the Yolo County Housing Authority to support residents in the unincorporated and incorporated areas of the county who were at greatest risk of displacement due to unpaid rent related to the COVID-19 pandemic and to offset corresponding lost revenue

that landlords needed to provide housing services.
