City Council adopts anti-racism resolution

On March 3, the West Sacramento City Council joined the Yolo County Board of Supervisors, the City of Davis, the City of Woodland, several school districts throughout Yolo County, and communities across the country in adopting a Resolution (Resolution 21-1) for CONDEMN-ING AND COMBATING RAC-ISM, XENOPHOBIA AND IN-TOLERANCE AGAINST ASIAN AMERICANS AND PACIFIC IS-LANDERS (AAPI). This resolution has been brought before councils due to the uprise of attacks against people

that are, or appear to be, of Asian or Pacific Islander descent. Schoolyard bullying, vocal attacks, and sometimes physical assault are accruing by people that are accusing the victims of being responsible for the COVID-19 virus coming to America. In February, West Sacramento City Council unanimously passed becoming a Compassionate City. Adopting Resolution 21-1 met with the same response.

Woodland resident, Lisa Yep Salinas, presented Resolution 21-1 to the city council. Lisa is the wife of Yolo County's clerk-recorder/assessor/registrar

Police release video of officerinvolved shooting

West Sacramento Police released the following video, which provides footage from body-worn cameras of the fatal officer-involved shooting from Thursday, Feb. 25 around 3:42 p.m. at Reed Avenue and Riverpoint

While the independent investigation of the incident is continuing, this video is being released in accordance with the City of West Sacramento's policy and values for transparency with our community.

Some may find the subject matter disturbing. Viewer discretion is advised.

Dispatch received a call about a man, later identified as 24-yearold Adam Lundt, who staffed himself in the neck at the Walmart parking lot. In the video, the caller stated that the man killed himself, which according to the police statement, was "invaluable" information. Officer 1 located Lundt's vehicle. Officer 2 saw Lundt reaching around inside his car. Officer 1

if I do, I'll sign right up to get them. Plus, there's now a new variant confirmed in New York City. As of this minute (3/9), I don't know much about it.



Gaing Wing Chan

Gaing Wing Chan passed away on February 19, 2021, at the age of 98. He was born and raised in Oroville, CA. After graduating from Oroville High School in 1941, he enrolled at the University of California at Berkeley. However, his freshman year was interrupted when the United States entered the Second World War.

During World War II, Gaing helped with the construction of Liberty cargo ships at the Kai-

ser Shipyards, and also served as a U.S. Army technical staff sergeant at Camp Beale. He was a recent recipient of the Chinese American World War II Veterans Congressional Gold Medal. After World War II, Gaing continued his undergraduate studies at UC Berkeley, graduating in 1949. He was also a proud member and active alumnus of the Pi Alpha Phi Fraternity.

After graduating from Cal, Gaing attended the University of California at San Francisco School of Medicine and earned his medical degree in 1952. He completed his residency training in general surgery at the Southern Pacific Hospital in San Francisco, and then moved to West Sacramento with his wife, Lily, in 1956 where he practiced family medicine and general surgery for 44 years.

In West Sacramento, he also served the community as a Kiwanis International service club member, a volunteer physician for the James Marshall High School football team, and a volunteer physician for Kamp Kiwanis.

Dr. Chan was an active member of the medical staffs for Sutter and Mercy Hospitals in Sacramento and served a term as President and Chief of the Medical Staff at Mercy Hospital. In his spare time, Gaing enjoyed spending time with his family, working as a part-time "handyman and carpenter" around his home and office, traveling, and watching Cal-Berkeley football and San Francisco 49ers and Giants

He was predeceased by his beloved wife of 64 years (Lily), his parents, and siblings. He is survived by his six children (Carolyn, Diane, Martin, Patricia, John, Alan), sons/daughters-in-law (Gordon, Kenneth, Lynn, Daniel, Lianne, Carol), 15 grandchildren, great-grandchildren, and many brothers/sisters-in-law, and nieces/ nephews.

stepped out of his car; Lundt did the same.

Officer 1's camera on the patrol vehicle's dashboard showed an image of Lundt charging toward Officer 1 with a gun in one hand and a knife in the other. It was determined later that it was a pellet

Officer 2 initially deployed his

The perspective from his Officer 2's body-worn camera shows that, after the initial rounds were discharged by Officer 1, Lundt fell down and then stood up and again ran at Officer 1. Officer 2 then discharged his service weapon and ordered motorists and paramedics to back away from the scene, as it was unclear if Lundt still posed a threat.

When Lundt fell to the pavement, he was still pointing the pellet gun at Officer 1. When he

stood up, he pointed the gun at Officer 2.

A gas station security camera showed Lundt stumble to the ground twice, only to get back up and charge Officer 1 who fired multiple rounds as he re-

Paramedics were cleared to approach the scene once officers determined Lundt was no longer a threat. He was pronounced dead at the scene.

The following is a statement from Police Chief Rob Strange:

"The West Sacramento Police Department appreciates the community's patience and compassion for everyone impacted by this incident. Our administration continues to cooperate with the Woodland Police Department as they conduct an independent criminal investigation of the incident. Concurrently, we are conducting our own internal investigation of the incident and review of department policies. Several months from now, the Yolo County District Attorney's

Office will complete its assessment of this officer-involved shooting and issue its findings.

"Two weeks have passed since the events depicted in the linked video. The work compiled through the criminal and administrative investigations has begun to shed light on what occurred in the afternoon hours of February 25th. Pursuant to our policy and standard practice, I have assessed the information gathered through these investigative efforts and have determined that the involved officers will be authorized to return to duty. These officers continue to cooperate with all investigative efforts and other work readiness processes, while they also engage with supportive resources to enable a healthy return to their work serving the residents of West Sacramento. "

Study finds adolescents with autism may engage neural control systems differently

MIND Institute researchers used brain scans to measure proactive and reactive executive control

MIND Institute researchers suggests that executive control differences in autism spectrum disorder (ASD) may be the result of a unique approach, rather than an impairment.

Executive control difficulties are common in individuals with autism and are associated with challenges completing tasks and managing time. The study, published in Biological Psychiatry: Cognitive Neuroscience and Neuroimaging, sought to tease out whether these difficulties represent a disruption in proactive executive control (engaged and maintained before a cognitively demanding event) or in reactive executive control (engaged as the event

Using functional magnetic resonance imaging (fMRI), the researchers took brain scans of 141 adolescents and young adults ages 12-22 (64

A new study by UC Davis with autism, 77 neurotypical controls) enrolled in the Cognitive Control in Autism Study. During the scan, the participants completed a task that required them to adapt their behavior.

They were shown a green or red cue, followed by a white arrow (probe) pointing left or right. In half of the trials participants saw a green cue asking them to push a button that matched the direction of the arrow, and in the other half they saw a red cue that asked to push a button that didn't match. Trial order was randomized across the exper-

"Our brains are seemingly hardwired to be able to respond to a probe with a matching action more easily than doing the opposite," said Andrew Gordon, a postdoctoral scholar in the Department of Psychiatry and Behavioral Sciences and the lead author on the paper.

Participants with autism show a unique approach

Analyses of the brain scans during both the cue and probe phases found that participants with autism showed significantly greater brain activity than control participants during the cue in networks associated with proactive control processes, but on the less cognitively demanding trials - the ones with the matching arrow. On the more demanding trials – when the arrow didn't match - activity was similar across

"This suggests that proactive control is not in fact impaired, but that those with autism implement it in a unique - and not necessarily maximally efficient – manner, because they employ proactive control to prepare for the easier versus the harder trials," said Marjorie Solomon, a professor in the Department of Psychiatry and Behavioral Sciences and the senior author on the paper.

The researchers also found that during the arrow probe, connectivity between regions associated with reactive control processes was uniquely enhanced on the more-demanding trials in individuals with autism, but not in neurotypical controls.

The results were a little surprising, said Gordon. "Previous research suggests that disruption at a neural level may be responsible for behavioral differences. What we actually show is that participants with autism are simply engaging neural control systems differently to those with neurotypical development."

The researchers noted that the results do not explain why the participants with autism engaged in a different, less efficient strategy during the task than the neurotypical partici-

"Our findings suggest that, as in many other areas, those with autism use a unique strategy to complete a task," said

Solomon. "But it does leave open the question of why they exert more control during the easier task, and it may have to do with reductions in cognitive flexibility."

Solomon and Gordon added that future research would benefit from manipulating the order in which the stimuli are presented.

"These findings stand in contrast to a lot of prior work on this topic," noted Gordon. "Although no one study can be considered enough evidence to change how we think about executive control in autism, these findings suggest we need to be more nuanced with regard to this subject in the future."

Coauthors on the study include Marie K. Krug and Rachel Wulff of UC Davis, Matthew V. Elliot of UC Berkeley, Jeremy Hogeveen of the University of New Mexico and Tyler Lesh and Cameron Carter of the Imaging Research Center in Sacramento.



I WANT to be optimistic. For one, I need to get my taxes done and I'm so thankful the VITA program has resumed. VITA stands for Volunteer Income Tax Assistance. Preparers are certified by the IRS. Local partners are West Sac's Family Resource Center/Yolo County Children's Alliance (YCCA) and the United Way. Qualifying seniors get their taxes done for free!! These tax preparers have been doing this for years in West Sac; God bless 'em. And God bless YCCA's Katie Villegas, too. She's a long-time workhorse for the disadvantaged, as is her husband, West Sac's county supervisor, Oscar.

The VITA program, around for 50 years, is a godsend for my low income self and others. To make an appointment, call 1-(916) 572-0560. Before the pandemic, the preparers helped you at the former senior center on Cummins Way. Here's the drill for this year: At your appointed time, wear your mask and drop off your documents at YCCA or the library (no appointments left, though, at Turner). The YCCA/Family Resource Center, 1200 Anna St., is now located behind Alyce Norman School in Broderick, 95605. Behind the school you'll drive through a gate, and that's the building.

You can wait in your car in the parking lot, if you like. But take your cell. If they have questions/your return is ready, they will call you. When you make your appointment, they'll ask you for your phone number(s).

Now, as promised, here's my personal experience with

No pinch, let alone a 'jab' with Shot 1. The absolute 100 percent truth is, I didn't feel any different at any time in the weeks I waited for Shot 2.

Shot 2, in my dominant arm where the muscle is more developed - ow. But no immediate side effects, so I left and went to Raley's.

The after-vaccination instructions said to drink a lot of water. So, I did. At bedtime, I took my usual nighttime meds and added



The vaccinators caution that being vaccinated only protects you from severe illness and that you still can infect someone else. This is why the CDC's revised March 8 Covid 19 guideline leaves me bewildered:

"(Vaccinated) individuals can gather **indoors** with others who are fully vaccinated with no pre**cautions** (masks, handwashing)

but must still adhere to masking and social distancing in **public** spaces. Additionally, vaccinated people can visit low-risk unvaccinated people from a single household without masks and physical distancing." (emphasis

of voters, Jesse Salinas. Lisa explained in her presentation that she, herself, has been the victim of multiple attacks in Woodland grocery stores as well as at her gym.

Locally, the elementary school-aged children of a high-ranking West

Sacramento city official, have experience bullying at school. These are only two examples of the many assaults reported... not to mention the large number that is not reported.

Yolo County Supervisor Oscar Villegas said "Yolo County condemns any and all xenophobia and hateful and racist acts towards our Asian Pacific Islander community. We have all worked hard in this community to make it welcoming to all and anything less won't be tolerated".

According to the West Sac City Council agenda report, a United Nations report released in October of 2020, more than 1,800 racist incidents occurred against AAPI citizens just between March and May of 2020. That was a year ago and

the attacks don't seem to be subsiding.

By adopting the Resolution, the city is taking the first step in condemning and combating Racism, Xenophobia (prejudice against someone because of the assumption of where they geographically from), and intolerance against AAPI citizens.

Furthermore, the city allocates that these actions are unacceptable. In addition, the adoption of this resolution will allow West Sacramento to possibly be eligible for funding for programs to educate and eliminate unfounded fears created during the pandemic. Mayor Martha Guerrero said, "We will strive to get resources to provide an extension of support where it is need-

ed, to build back a stronger West Sacramento".

Resolution 21-1 begins with "Whereas, West Sacramento supports inclusion and belonging for people of all races, national origins, and ethnicities, which is critical to guaranteeing the safety and security of all people...."

The resolution includes that despite the increasing acts of intolerance, it recognizes that in Yolo County and throughout our nation, that Asian Americans and Pacific Islanders have been a significant part in the security of our nation throughout history and during the pandemic. It notes an estimated 2 million Asian Americans and Pacific front lines of the COVID

crisis as healthcare providers, first responders, and other essential roles.

The resolution ends

with "NOW, THERE-FORE, BE IT RE-SOLVED, by the City Council of the City of West Sacramento, that the City of West Sacramento, in accordance with the Presidential Memorandum, hereby condemns racism, xenophobia, and intolerance against Asian Americans and Pacific Islanders; accepts responsibility to prevent racism, xenophobia, and intolerance against everyone in City of West Sacramento, including Asian Americans and Pacific Islanders; and calls upon all citizens, city staff and community groups to assist in the Islanders serving on the furtherance of these objectives."
