# Sutter Health Park has gone to the dinos

More than 70 photorealistic dinosaurs have been stomping across California Southern since the New Year, and migrated north to West Sacramento for its showing at Sutter Health Park now until March 21.

Following sold-out showings in Los Angeles, Orange County and San Diego, Jurassic Quest Drive Thru transformed the Sutter Health Park outdoor parking area into an interactive, contactless drive-thru experience, featuring more than 70 moving and lifelike dinosaurs, as well as a 50 foot-long Megalodon. Jurassic Quest's herd of animatronic dinos are displayed in realistic scenes that allow guests to experience them roaring and moving as they drive through the tour. Although the drive-thru experience means visitors will stay safe inside their vehicle,



they'll still need to avoid the roarsome T-Rex.

The News-Ledger caught up with Dino Dustin and Bronto Brittney to learn what it takes to be a "Dino Trainer."

"It's very adventurous. There are a lot of unexpected things because they fast on their feet. But it's a lot of fun. There's a bunch of train.

And, yeah, you never know what's coming up," says Dino Dustin.

It's important to "start them young," said Bronto Brittney, while holding her baby T-Rex, Tyson. "That way when they get older, they know how to react to people and be safe. Tyson's newest trick is the ball catch. "He learned how

to catch a ball in his mouth, because he can't really use this little cute little hands as much," Bronto Brittney said.

Jurassic Quest worked in collaboration with leading paleontologists to ensure each dinosaur was replicated in every detail, depicting how we understand dinosaurs looked and moved. The

Jurassic Quest Drive Thru is the only place to encounter some of the largest dinosaurs to ever roam the Earth, and some of the eeriest marine creatures to ever lurk the ocean's depths from your vehicle.

adven-An ture-for-all-ages online audio tour in English and Spanish leads visitors through the thrilling dinosaur safari (special accommodations can be made for the hearing impaired). In addition to the life-like dinosaurs, guests can greet one-ofa-kind baby dinosaurs and their trainers as well as pose for a prehistoric safari-style digital souvenir photo (one per vehicle).

Dino Dustin shared some tips for visitors. "If you're thinking about coming, you always want to go and get those tickets right away because they do sell out; they go extinct fast.

continued use of \$0 bail, over 744 new crimes have been committed. In April of 2020, the California Judicial Council imposed the "\$0" Emergency Bail Schedule in response to the COVID-19 pandemic. Although rescinded in June of 2020, the Yolo County Superior Court continues to use the Emergency Bail Sched-

Since April 13, 2020, individuals released on \$0 bail have committed over 744 new crimes. Those new crimes include 317 felonies and 427 misdemeanors, including crimes such as Attempted Murder (2 new victims), Assault with a Deadly Weapon or Assault by Means

Boy, talk about being perched squarely on the horns of a dilemma.

Back to school, folks? Yes or no?

Younger kids. K-2. The ones whose immune systems are especially immature. And those with 'special needs' - such as the disabled. The state says they should go back

first. And teachers don't *have* to get the vaccine.

Services were provided by River Cities Funeral Chapel.




depression and mental health referrals are what is needed to help the family. Parents may feel overwhelmed and isolated, with no support system. YCCA can be that support system.

The Help Me Grow screening is free. After filling out the questionnaire, it will be analyzed. YCCA will then contact the parents, usually within 5 days. If any red flags were raised, YCCA can offer resources and referrals. The questionnaire is using ASQ-3 and ASQ-SE-2 screenings for developmental growth as well as the SEEK screening for environmental factors and the PHQ-9 screening for mental health factors.

The Help Me Grow program is just a great and free way to check on your small child's social, emotional, and academic development as you prepare for your child's school readiness. #### SB1383: CALIFORNIA'S SHORT-LIVED CLIMATE POLLUTANT REDUCTION STRATEGY

California is working to take organics out of the landfill which will help reduce methane emissions. The new law sets targets for organic waste reduction:

- Reduce organic waste disposal 75% by 2025.
- Recover at least 20% of currently disposed edible food by 2025.

#### How does this affect me?

- Starting in January 2022, ALL residents and businesses must recycle organic materials, such as food waste, food soiled paper and yard debris.
- Starting in January 2022, certain businesses must donate edible food to food recovery organizations.

catch anything more than childhood sniffles? Something serious? Even crippling, maybe deadly?

When I was little, parents worried about polio. There was no vaccine. A classmate of mine contracted it. In an iron lung, she died.

My parents made sure I got the polio vaccine and any other shot I needed. With Mike, vaccines were a given. No arguments. He got them.

These 'warp speed' vaccines are only available now because this virus is a national emergency. Fact is, health officials are learning as we vaccine how it affects us. So no one HAS to get one. Not teachers. Not school age children. On Dec. 30, 2020, the CDC posted this: "The true incidence of

known due to lack of widespread testing and the prioritization of testing for adults and those with severe illness. Recent evidence suggests that compared to adults, children likely have similar viral loads in their noses and throats and can spread the virus to others." (Emphasis added)

Most recently, just as Yolo's covid cases were down enough to open restaurants and lift the stay home order, California cases have started to edge back up. Even in Yolo's 'red' (not purple) "zone" - contagion remains 'substantial'. Fauci and others warn a new viral surge is coming, as early as mid-March, one that may include more infectious variants of the virus.

The bribe from the state is supposed to be used by schools for safety measures. Improved ventilation, masks that fit the kids, etcetera so on. For each day past the April 1 deadline the kids aren't back in school, the school loses 1 percent of the state's bribe, aka 'allocation' - the carrot/stick approach, they hope, will force a school's compliance.

Let's back up a little. Will school kids be getting there by bus? Who monitors how far apart they sit? Each time kids get on or off, will the pole they grab be sanitized? Are drivers cool with transporting what may be a bunch of superspreaders? Will the drivers be tested every couple days? How about the students?

I'm thankful Mike's not in school during this pandemic, and that, as yet, I have no grandchildren. But I feel for bored kids, weary parents, worried teachers, all anxious workers. Will older students again miss high school sports, prom and graduation?

All that said, my gut says now's too soon to take the risk. How often will classroom door knobs, desks, cafeteria tables, bathrooms, stair rails and more be deep cleaned with alcohol-based sanitizer? Will kids wash their hands a lot – or ever? If they can be persuaded to wear a proper mask (no gaps and filtered) that covers their mouth and nose ... and a child's nose itches ... will the child reach inside the mask to scratch it?

No parent wants a child to fall behind. Most value education. But now's too soon. Fauci says it could be late December before this thing winds down. Are we risking little kids to learn we should have opted for district-paid at-home tutors, shields and masks?

Bottom line: This is a 'new' virus with, still, a lot of unknowns. Until we get the 'all clear' -- the protocol for all 'group' settings should be both masks and eye shields - for everyone, including visitors to schools. Air circulation vents and ducts - how and when will they be cleaned? FIRST, and then other surfaces.

And, finally, all school workers got today's vaccines when they were kids. To be around kids, they should want this one.

of Force Likely to Product Great Bodily Injury (19 new victims), Robbery (10 new victims), Burglary (45 new victims), felony domestic violence (12 new victims), possession of an assault weapon, gang crimes, and dozens of other new felony and misdemeanor crimes. Since the COVID 19 pandemic began, 485 individuals have been released a total 623 times on \$0 bail. Of those released on \$0 bail, 41% have been rearrested at least one time, the highest percentage thus far during the \$0 bail period.

The Emergency Bail Schedule

assessment for dangerousness. Additionally, upon release on \$0 bail, offenders are given a court date 4-5 months in the future. This makes it nearly impossible to assess those individuals who are homeless, suffer from a substance use disorder, or from a serious mental illness in order to enroll them into one of the county's diversion programs such as mental health court or addiction intervention court.

The problems with the continued use of the \$0 bail schedule are easily seen in the multiple arrests of Jose Inda-Lopez.

Inda-Lopez, 37, of Davis, has been arrested 17 times since his April 17, 2020 arrest for felony vehicle theft. He was released on \$0 bail. Since then, Inda-Lopez has been arrested 10 additional times. Inda-Lopez was charged in 11 separate misdemeanor and felony complaints in-

cluding felony vehicle theft, felony vandalism, possession of a concealed dirk or dagger, theft, possession of drug paraphernalia, trespassing, and lewd conduct in public.

On December 11, 2020, he entered no contest pleas in three cases, one felony and two misdemeanors. Additionally, he admitted violations of probation in two additional misdemeanors. At the time of his plea, Inda-Lopez had credit for time served and was released the same day. Since December 11, 2020, he has been arrested six times, four of the arrests within six days of each other.

The continued use of the Emergency Bail Schedule is determined by the Yolo County Superior Court and is solely within their discretion. Anyone with concerns about the ongoing use of the Emergency Bail Scheduled should contact the Yolo County Superior Court.
