The community came together during the recent storm

The community rallied together during the PG&E power outage after the big storm on Tuesday, Jan. 26. Some residents reported the PGE power outage website said there is no power outage at their homes, even though that wasn't the case.

Meanwhile, neighbors came together to check on each other. The Yolo

Food Bank helped with food delivery; Whitey's Jolly Cone served as a free hot food pick-up location. Jean Baba and the Baba family cooked hot meals for residents in need, as many had food go bad in their fridges after the power outage. One hundred pounds of food was distributed by the Rotary Club and Council Member Quirina Orozco. Peggy Bell, organizer of the

West Sacramento Annual Picnic, provided detailed maps of neighbors to help volunteers take a section and check on neighbors and deliver supplies.

Mayor Martha Guerrero stated at the Feb. 3 city council meeting recognized the "major error" on the part of PG&E to notify residents and to acknowledge that there was a power failure going on at more than 4,000 homes in West Sacramento. She notified the California Public Utilities Commission, which immediately prompted them to take residents' calls and complaints seriously.

She said: "It was just a great time to be together with the residents but also disappointing for what we experienced with, you know, PG&E. We did try to help in some ways, but there were things that need to be recorded and I'm going to stay on top of that on behalf of the residents to make sure that this doesn't happen again."

At that meeting, City Manager Aaron Laurel recognized city staff for their "incredible work" handling the aftermath of the storm. He said operations center staff and fire departments responded to more than 100 calls.

Yolo County Announces Restaurant Fee Waiver

In an ongoing effort to support local businesses, Yolo County is launching a restaurant fee waiver program to assist local businesses impacted by the coronavirus (COVID-19) pandemic. Yolo County understands that businesses are part of the backbone of every community and have faced immense hardships during this pandemic. This program will provide waivers for eligible restaurants, bars, restaurant/bar combinations and bakeries who are renewing their yearly permit fees with the Yolo County Environmental Health Division. Businesses that have already paid their permit fee renewals between July 1, 2020 and January 31, 2021 can receive a refund through the program.

To apply for the fee waiver, businesses must meet the following eligibility requirements:

The business is a permitted business by the Yolo County Environmental Health Division that has or will pay fees for permit renewal for the period of July 1, 2020 – June 30, 2021.

The business is permitted or will renew their permit as a restaurant, bar, restaurant/bar combination, or bakery. The business was previously permitted and is not a newly permitted business (permitted in the prior year of July 1, 2019 – June 30, 2020).

Historic Southport Levee Improvement Project Wins Engineering Honor Award

For its work on West Sacramento's largest levee project and the city's first Envision verified infrastructure project, HDR Engineering Inc. in Sacramento has been awarded one of California's highest engineering awards by the American Council of Engineering Companies, California.

"In a year that has brought so much devastation to California's residents and economy, it is refreshing to step back and take a moment to honor the unwavering expertise and innovation in the Golden State," said Brad Diede, Executive Director of the American Council of Engineering Companies, California. "The engineering and land surveying firms and infrastructure projects showcased in this year's award program emphasize California's commitment to resiliency, sustainability, and the delivery and enhancement of transportation, water, healthcare, education, and LEED design projects that protect the public and deliver amazing results to both public and private clients." The \$180 million, Envision Platinum-verified Southport Levee Improvement Project is West Sacramento's largest levee project, providing nearly 6 miles of flood risk reduction measures to improve the city's most vulnerable levee. The

crown jewel is a 3.8-mile-long setback levee. Constructed landward of the original levee, it allows the West Sacramento Area Flood Control Agency to restore 212 acres of natural habitat, provide recreation benefits, build a mitigation bank, and reinstitute the city's flood preparedness. The new levee reconnects the community to the river while protecting more than 50,000 residents; 25,000 jobs; and \$5.3 billion in infrastructure.

Community members voiced strong support for the project, calling it "exemplary" and "a beacon in the community." It's consistent with the city's master plans for parks, bicycle and pedestrians, transportation, and land use, and will prove beneficial to residents for decades. The project offers a blueprint for other communities for restoring and improving critical levees. Moreover, as West Sacramento's first Envision verified project, it provides guidance for future infrastructure design across the city for environmental, social and economic benefits.

Council Member Ledesma named Mayor Pro-Tem

The West Sacramento City Council unanimously voted Chris Ledesma as Mayor Pro-Tem at the Feb. 3 council meeting.

Chris Ledesma was first elected to the City Council in the fall of 2010. Previously, he had served on the City's Planning Commission since 2001, including five terms as chair.

Through his leadership, Mr. Ledesma has worked to attract significant new employers such as IKEA, Target and Nugget Market. He was also instrumental in the City's approval of the Bridge District plan, an urban commercial and residential zone near the River Cats stadium that will create jobs and recreation opportunities for West Sacramento residents.

Larry was a disabled veteran and extremely patriotic, proudly serving in two branches of the military, the Army



sociated with COVID-19 which is greater than 25% of gross revenues.

Eligible businesses can access the application at www.yolocounty.org/environmental-health and must apply between February 5, 2021 and June 30, 2021. All applications must include the following documentation:

- A current copy of your W-9.
- A copy of receipt or invoice for fees previously paid between July 1, 2020 to January 31, 2021 (if requesting a refund for a permit fee already paid)

• Documentation of revenue loss due to COVID-19 consisting of accounting or tax records comparing at least one quarter of gross revenues in calendar year 2020 compared to the corresponding quarter in the prior year.

"Our restaurants, bars and bakeries are struggling to stay open due to various health restrictions since the beginning of the pandemic. Every time the state strengthens health requirements for restaurants, costs are incurred, and business is lost," said Chair of the Yolo County Board of Supervisors Jim Provenza. "The Board of Supervisors approved a temporary waiver of

county health permit fees for restaurants, bars, and bakeries, up to a total of \$200,000, using COVID contingency funds. We appreciate everything our restaurants have done to protect the community and are happy to provide some additional relief."

create additional habitat for several Endangered Species Act listed animals. The team also restored borrow sites with ongoing performance measures to verify crop yields and agricultural success. By relocating the roadway from the existing levee crown to behind the setback levee,

Farm and Flavor What are super-foods? Is it all just hype?

What is a superfood? Does the benefit justify the cost? Or is it all just a marketing campaign?

First, let me say, there IS too much inflated, hyperbolic information out there, making your search for helpful information a challenge. While knowledge is empowering, sorting it out is exhausting, which is why I'm trying to assist you here. The more extreme or instantaneous, the more exclamation points, the more something seems too good to be true, the more there is an expensive product on offer, the more I recommend looking twice at the source.

However, though respectable institutions have to have tons of laboratory testing before they will support any remedy, that doesn't mean other options are worthless. For example, Germany's Commission E publishes a reference guide on herbal medicine, pointing out

that these are the plant medicines they can solidly confirm in a laboratory setting under strict guidelines. They do not dismiss everything else. Traditional knowledge isn't backward or wrong just because scientists don't know about it yet. There are important plant benefits yet to be verified by science.

In any case, plant chemistry exists and interacts with our chemistry. It's not fairy-dust, just biology. Some plants have high concentrations of very valuable phytonutrients, and anti-oxidants in particular are well-recognized. Many of these nutrients are found to inhibit or fight cancer, to support a strong immune system, to help cleanse, support circulation, fight infection, etc. For example, dark purple plant foods have something called anthocyanins which are reported to have tumor-inhibiting properties. Bold orange and red foods have carotenes, a family of anti-oxidants with different super-powers, so to

speak. The more intense the color, the better. While watermelon and tomatoes are famous for having lycopene that is especially helpful for fighting breast and prostate cancer, the deep red watermelon has more than pink or yellow, and a tomato varietal called "Tangerine" has the highest lycopene content among tomatoes. Kale is considered a superfood due to the high levels of its glucosinolates, sulphurophane, vitamin K and other nutrients.

Some more exotic items have gotten a lot of attention lately from goji berries to açaí berries to pawpaw to moringa. Great! The more the merrier! They tend to be expensive, and if you don't know what to do with them and find them too costly, you won't eat enough to make a big difference. But they can be a beneficial treat in a big wellness menu.

Microgreens are a wonderful, light, and fresh addition to your routine as well. They may have up to 40 times the nutri-



ents of the full-grown food. If your appetite is uninspired and you couldn't possibly down a whole cup of steamed broccoli right now, but you could manage a quarter cup of broccoli microgreens, you'd get a good nutritional value.

Fourteen hundred doses are expected to be dispensed at Saturdays event.







Access to quality, timely healthcare is critical to ensure the long-term health of any community. Rural and indigenous populations face barriers to care that can have a profound and negative influence.

Historically, these communities have struggled getting access to healthcare. Financial inability to pay for services, a lack of transportation, or not being able to take time off work have made it so these communities do not receive the care and attention they need.

Forty-five percent of Medicare decedents in California received at least one day of hospice care in 2017, according to the National Hospice and Palliative Care Organization. Of that population, only 0.4% were of Native American descent.

These statistics are why both Yolo Hospice and the Yocha Dehe Wintun Nation want to start this project as soon as possible.

"This grant is about developing strategies to meet the unique needs for indigenous and rural communities in California," Craig Dresang, CEO of Yolo Hospice said.

The grant will fund a threeyear project headed by Yolo Hospice in partnership with the Yocha Dehe Wintun Nation.

Yolo Hospice will begin the first year of the project by performing research and collecting data so that the needs of these communities can be fully understood. An academic partner will be secured to work on the project alongside Yolo Hospice as well as other end-of-life care providers.

The second year of this project will then analyze these findings so that Yolo Hospice and other community leaders can strategize the best approach to bring these communities accessible, quality endof-life care.

Yolo Hospice and Yocha Dehe will use those years of research and planning to establish a program in 2023 that will make the services offered by organizations like Yolo Hospice — palliative care, hospice services, bereavement services, caregiver relief much more obtainable to populations that are routinely left out by urban-based practices and ideals.

"Providing comfort to a loved-one in their final days is one of the most difficult challenges a family will ever face. Those difficulties are compounded in rural and Native American communities where too often it's a struggle to find help with providing that care," the Tribal Council of the Yocha Dehe Wintun Nation said. "We are humbled to be part of the solution."

About Yolo Hospice

Yolo Hospice is a nonprofit, community-based organization that provides expert and compassionate hospice care, palliative care, bereavement services, and public education about end-of-life issues for all people in the region's culturally diverse community.

The organization has been serving patients and families in Colusa, Sacramento, Solano, Sutter, and Yolo Counties for 40 years. In 2017, it formed a strategic alliance with Citizens Who Care to expand its services, particularly in the area of caregiver support.

Yolo Hospice's palliative care program, YoloCares, became the first community-based palliative care program in Northern California to be accredited by the Joint Commission in 2018.

Modern Healthcare recognized the organization as one of the "Top 40 Best Places to Work" in the nation in 2020.

Yolo Hospice is the only provider in the region to be accepted into the National Partnership for Hospice Innovation.



Yolo County residents can receive virtual free tax help through United Way Qualifying residents can receive free help applying for up to \$8,000 in tax credits

Households throughout Yolo County are eligible for free virtual help preparing taxes and claiming credits this year, saving an average of \$200 in preparer fees and earning up to \$8,000 in credits. More households are eligible to participate in United Way California Capital Region's Free Tax Prep program this year, including those earning \$65,000 or less in 2020. Qualified households can upload documents online and a United Way IRS-certified volunteer will call them to help claim the maximum tax credits for which they are eligible before submission, including the federal and state Earned Income Tax Credits (EITC and CalEITC). The IRS will not begin accepting electronically filed returns until Feb. 12, but United Way recommends filing as soon as tax documents are in hand and it will submit the returns on Feb. 12. "After a year where many people lost employment and income, it's more important than ever for households in our region to take advantage of this program that helps people save money on tax preparation fees and ensures they apply for the maximum refund and credits for which they are eligible," said Stephanie Bray, president and CEO, United Way California Capital Region. "This program is an important way for our community to jumpstart the local economy in 2021, and it's a key element of our Square One Project that provides resources for local families so their children can graduate from high school prepared to succeed in college or career."

This year, more people are eligible to receive the CalEITC and Young Child Tax Credit, including qualifying ITIN holders, after Governor Newsom signed As-

Detection of Coronavirus B.1.1.7 Variant Confirmed in Sacramento Region

Local COVID-19 Testing Program Identifies and Confirms Variant by Genotyping and Sequencing Test Samples

Through its free community COVID-19 test operations, Healthy Davis Together and the UC Davis Genome Center identified the first known case of the B.1.1.7 variant of the virus SARS-CoV-2 in the Sacramento region. Scientists at the Genome Center began genotyping positive samples of the virus in January, as part of their COVID screening efforts to monitor for variants of concern. Researchers have found evidence that the B.1.1.7 variant virus is more contagious and predict that it will spread rapidly in the US, doubling in relative frequency approximately every 10 days. So far, studies suggest that antibodies generated through vaccination with currently authorized vaccines recognize these variants.

"Even though Davis has an overall low rate of COVID-19 positive tests, it has always been a matter of when, not if, we would see new variants in the area. A variant that spreads more easily, such as B.1.1.7 (which originally emerged and spread in the UK), will eventually displace other variants," said David Coil, Project Director of Environmental Monitoring for Healthy Davis Together and Project Scientist at the Genome Center. "The Genome Center added genotyping of positive samples to its testing protocol to monitor for any variants of concern so we can quickly alert the community and double down on community efforts to prevent spread."

"Given that the B.1.1.7 variant has already been found in Southern California and the Bay Area, it is not surprising that it has now been detected in Yolo County," said Dr. Aimee Sisson, Yolo County Public Health Officer. "However, detecting this more infectious variant locally is a reminder that even though case rates are declining in Yolo County, we must maintain our vigilance and continue using protective measures against coronavirus. Masking, distancing, and avoiding indoor gatherings are as important as ever, and will continue to be critical until most of the population has immunity. We cannot let down our guard."

The person who tested positive for the B.1.1.7 variant has already been notified and is under isolation, and contact tracing efforts were started immediately. This individual is an adult and may have acquired the variant through travel outside of the community. The B.1.1.7 variant, estimated to have emerged in the United Kingdom in September 2020, has now been detected in 33 states, including California, Florida, Nevada, New York and Texas. It was first reported in the U.S. in Colorado on December 29th 2020, reported two days later in San Diego, California by scientists at UC San Diego, and has been hypothesized to have been spreading rapidly in the US since late November.

Now, more than ever, people must continue to follow guidance to prevent the spread of COVID-19 and all its variants, including:

- Wearing a mask/face covering; making sure it fits properly
- Keeping physical distance; at least 6 feet apart and more if possible
- · Practicing good hand hygiene
- Getting tested at least weekly for COVID-19; even if you are asymptomatic (https://healthydavistogether.org/testing/)
- Avoiding crowds and indoor gatherings
- Staying home if you feel sick • Getting vaccinated when it is available to you

The test used to genotype virus samples is being done on the same instrument that Healthy Davis Together uses to screen COVID-19 test samples. The IntelliQube PCR System, which was designed as a genotyping instrument by LGC Biosearch Technologies, permits rapid genotyping of all positive samples, and in its first week of use revealed a virus sample with the N501Y substitution and 69/70 deletion, two of the mutations associated with B.1.1.7. Whole genome sequencing of the sample was done in the laboratory of UC Davis professor Samuel L. Díaz-Muñoz to confirm the identity of the variant as B.1.1.7. Professor Díaz-Muñoz, who studies viral evolution, noted that variants emerge during viral replication in infected individuals, and that widespread transmission of the virus contributes to the emergence of new variants. He said "These variants shouldn't be a sign that we should give up, but rather be a wake-up call" that people should take control measures seriously.

Importantly, the genotyping technology can also be used to screen positive samples for other important variants in the future, including variants with the E484K mutation, which has been associated in some cases with reduced neutralization of the virus by antibodies and present in variants first identified in South Africa (B.1.351) and Brazil (P.1).

"Although genotyping, unlike whole genome sequencing, will not discover new viral mutations, it is quicker and less expensive than sequencing and therefore more practical for screening large numbers of samples" said Dr. Richard Michelmore, Director of the UC Davis Genome Center. "All positive samples identified by the testing lab are now genotyped immediately for all currently known variants of concern. Samples of interest will

also be sequenced." Healthy Davis Together and Yolo County have been collaborating throughout the COVID-19 pandemic on COVID-19 testing, vaccination, and education to help reduce the spread of this virus among those who live or work in the Davis community.

sembly Bill 1876. Households may be eligible for CalEITC if the taxpayer is at least 18 years old and the household earned less than \$30,000 in 2020. Many CalEITC-eligible households are not legally required to file taxes due to low income; however if they file, they can claim

state and federal credits. Experts recommend evervone files early, noting that many people do not realize that unemployment income is taxable.

United Way's Free Tax Prep program was shifted online last year when the pandemic and stayat-home order hit. Even with the pivot to virtual services, United Wav's Free Tax Prep volunteers filed 7,060 returns for the 2019 tax year and put

\$10.5 million back in the pockets of local families through federal refunds. For nearly 100 years, United Way California Capital Region has brought local people together to make community change happen. Today, the nonprofit is bringing people together across Amador, El Dorado, Sacramento, Placer and Yolo counties for its Square One Project, a 20-year promise to sig-

At the time, I was anchoring and reporting for KMGH-TV. Sound asleep one morning, I heard the phone ring. It was 4 a.m.

Only semi-conscious, I thought the background noise when I picked up was the news desk. Multiple police scanners are monitored by news desks.

This conversation followed: Officer: "Is this Carol Bogart?"

Me: "Yes."

Officer: "Do you have a Camaro?"

Oh boy. NOW I was awake. Me: "I don't know, sir. Do I?" The officer told me this story: A patrol car's driver noticed something funny in Aurora (a

Denver suburb). Five late model sports cars were lined up at a

traffic light, ready to turn left without signaling. "Suspicious," thought the officer. He called for backup. The stolen cars had no signals because steering columns had been stripped. Overhead lights were smashed. Stereo systems were ripped out in the dark. Locked glove boxes pried open; contents stolen. Door locks had been damaged.

Some of the thieves, seeing that the police were closing in, ditched their cars and took off through the woods on foot. The one that stole mine kept going. So fast, the officer said, that my Camaro, sometimes airborne, bottomed twice in a spray of sparks. (This did not improve my undercarriage.).

He paused in his narration. "How did my car do?" I asked. "Not as good as he hoped it would," said the officer.

My Camaro was now in a parking lot. "It's drivable," he said. "We're sending someone to pick you up."

The officer told me all five thieves were teenagers, likely part of a ring being directed by adult criminals at the top. A juvenile car thief, he explained, gets a lighter sentence than would the adults, who promise easy money to recruit the kids. The five cars were likely going to a chop shop.

The officer who took me to the parking lot. We drove past another squad car. In the back seat sat the thief. Barely old enough to drive, he glared at me defiantly. This kid's life, I thought, is ruined.

Some months later, I was notified that the boy's sentencing was coming up. Did I want to make a victim statement? I did. My statement to the juvenile court was this: "If you give him probation, please include these requirements:

No more cutting school. Cs or better. No failed drug tests. Work a part time job. Pay restitution to your victim." If he learns crime doesn't pay, I said, maybe he won't end up in prison. Occasional reports on his progress would be appreciated.

The kid never missed a payment or a single day of school. About a year into the boy's 2-year probation, his probation officer mailed me a note the boy had written "without prompting." It said, "I'm sorry." The boy's mom wrote me, too. She told me, "Thank you."

Carol advocates this approach for kids who struggle with behavior issues: As ĂĎHD experts say, 'Catch them being good.' Let them learn that success is more fun than failure; and change from 'troubled kid' to lifelong achiever. Questions, comments? Contact Carol at carol@bogartonline.com.
