Rev. John Siden

Rev. John Siden, 81, passed away at home surrounded by family and friends on December 3, 2020, in West Sacramento, Calif.

John's record of community service in West Sacramento & Yolo County is long and deep. John was a founder and president of the Salud East Yolo Health Corporation, obtained funding for a senior citizens' center, and led efforts to create a publicly-funded parks and recreation agency. He served 17 years on the Washington Unified School District board of trustees and served terms as president of the East Yolo Friends of the Library, the East Yolo Community Council, East Yolo Ministerial Association, and was a member of numerous community, health & human service and faithbased nonprofits.



Before retiring from the Yolo County's Office of Administrative Services, John's professional leadership extended through executive positions at Opportunities for the Handicapped, Inc. (OFHI), Sacramento Association for the Retarded, Inc. (SAR), the Broderick (Calif.) Christian Center, and pastor of the Church of the Good Shepherd in West Sacramento.

John was recognized by many organizations for his dedication to helping people. The highlights include West Sacramento City Council's creation of the Salud Clinic "John Siden Award" for community service in 1998, and the Yolo County Board of Supervisors recognized him in 1991 "for the long-time dedication to the health needs of the people of West Sacramento, outstanding service to the County and the Salud Clinic Advisory Board, and reputation as a facilitator, a man of strong moral character and a wise counselor."

John loved vacations with family, gardening, music of many genres, and digging into his ancestry while maintaining relationships with relatives around the world.

Born in Southern California, John was a resident of West Sacramento, Calif. since 1965. Married to his wife of 58 years, Sharon, who survives him, John is also survived by son Scot & Renée Siden and their children Kyle and Owen of Sacramento; daughter Katie & Bill Garcia and their children Delaney and Jillian of Auburn, Calif.; and brothers Douglas (Marilyn) Siden of Alameda, Calif., and David Siden of Seattle.

West Sacramento Should Follow a Transparent, Democratic Application Process

LETTER TO THE EDITOR

We Voted for Transparency in November

Dear Editor,

West Sacramento recently had elections for School Board and City Council. Each election created a vacancy when incumbent WUSD School Board member Norma Alcala was elected to City Council and incumbent West Sacramento City Council member Martha Guerrero was elected Mayor. The people voted for change ousting longterm Mayor Christopher Cabaldon by a very large margin. Martha was supported by Norma Alcala. Cabaldon ran with a team of two people, Dawnté Early-West and Quirina Orozco. Martha and Norma won. I voted for Martha because I felt the City needed more transparency and accountability. I rejected Chris Cabaldon's team because I felt the new Mayor should have support for her agenda. If Martha had supported a second person for City Council, I would have voted for her in order to effect change, but Martha did not support a second candidate and that has created this

conundrum.

process. This allows people an equal opportunity to apply and be considered. This is Democracy. We applaud the school board for their community involvement and respect. To be sure the school board could appoint Tiffany McFadden to the vacancy. She lost by only 26 votes or Jameson Parker who lost by 33 votes. Rather the school board is allowing applications as they have done in previous vacancies. That is the right thing to do.

The City Council faces the same dilemma with its own vacancy. Two members, Mayor Martha Guerrero and Council-member Norma Alcala, want to follow the regular, normal, legitimate process of taking applications and allowing the public to apply.

Two city council members, Orozco and Ledesma, want to appoint Dawnté Early-West, who lost by 89 votes without any application process, no opportunity for others to apply, or opportunity for compromise. That is exactly the sort of lack of transparency that I and the ma-

jority of this city voted against. Martha Guerrero ran on a platform of transparency. I want the City Council to follow the normal, transparent, democratic process.

applications, including an application from Dawnté Early-West. Nothing precludes Early-West from applying for the vacancy. In fact, she states she will apply. Other candidates may apply as well. Do not let anyone put their finger on the scale. An open application process should be tried first. There may be many people who want to apply. Let them apply. If it fails to arrive at an appointment, then let the people decide in a November election. Early-West has already stated she will run for election to the city council in November 2021. That is also democracy in ac-

Sacramento Region Stay at Home Order Extended

The State's Stay Home health order for the Greater Sacramento region (including West Sacramento and Yolo County) has been extended due to a drop in ICU bed capacity. All individuals are currently ordered to stay home or at their place of residence, except for work, local shopping or other permitted errands or activities as otherwise authorized. All gatherings with members of other housholds are prohibited.

The following sectors will have additional modifications in addition to 100% masking and physical distancing:

Outdoor recreational facilities: Allow outdoor operation only for the purpose of facilitating physically distanced personal health and wellness through outdoor exercise, without any food, drink or alcohol sales. Additionally, overnight stays at campgrounds will not be permitted. City parks and playgrounds will remain open.

Retail: Allow indoor operation at 20% capacity, and 35% of capacity for standalone grocery stores, with entrance metering and no eating or drinking in the stores. Additionally, special hours should

be instituted for seniors and others with chronic conditions or compromised immune systems.

Shopping centers: Allow indoor access at 20% capacity with entrance metering and no eating or drinking in the stores. Additionally, special hours should be instituted for seniors and others with chronic conditions or compromised immune systems.

Hotels and lodging: Allow for COVID-19 mitigation and containment measures, treatment mea-

sures, provide accommodation for essential workers, or providing housing solutions, including measures to protect homeless populations.

Restaurants: Allow only for take-out or delivery.

Offices: Allow remote only except for critical infrastructure sectors where remote working is not possible.

Places of worship and political expression: Allow outdoor activities

Entertainment production: Industries, studios, and other related establishments such as establishments that provide content for professional broadcast can operate without live audiences.

In any region that triggers a Regional Stay Home Order, all operations in the following sectors must be closed(except to the extent that their operations fall within critical infrastruc-

- Hair salons and barbershops
- Personal care services • Museums, zoos, and
- aquariums • Movie theaters (except drive-in)
- Wineries, bars, brew-
- eries, and distilleries • Family entertainment centers

How To Help A Friend Or Relative With Their Anxieties And Depression

Do you know a friend or loved one who suffers from fear, anxiety, and depression and do not know what to do? It can be frustrating to watch someone you know suffer and not be able to help them. Here are 6 ways to help the person cope in these kinds of situations and the best way to deal with anxiety.

- 1. Learn as much as you can in managing anxiety and **depression:** There are many books and information that will educate you on how to deal with fear and anxiety. Share this information with the person who is struggling with their mental health is-
- 2. Be understanding and patient with the person strug-

gling with their fears: Dealing with depression and anxiety can be difficult for the person so do not add more problems than what is already there. Do not get into arguments with the person who is having a difficult time with their anxieties.

- 3. Talk to the person instead of talking at them: It is important not to lecture the person who is struggling with anxiety and depression. Talk to the person about their issues without being rude. Most people will listen if you approach them in a proper manner.
- 4. Get Help: Seek help from a professional who can help your friend or relative with their mental health struggles. A counselor can give you

advice and ideas on how to overcome anxiety, fear, and depression. Getting help from a professional is the number one priority in helping your loved one deal with fear and anxiety. Joining a local mental health support group can also be helpful. Talk to your doctor to get more information about potential groups in your area.

- 5. Talk to the person on what will happen if they do not get help: Another way to convince the person who is struggling with fear and depression is to tell them what may happen if they don't get some assistance. Anxiety and depression can make things worse and usually it won't go away by itself without some kind of treatment.
- 6. Find Out The Reasons Why The Person Won't Get **Help**: Address the issues on why the person will not get the necessary help. Many people who are struggling are fearful and frustrated. Try to find out the reasons why he or she won't get the help they need and then try to find ways that will overcome their resistance of seeking as-

- Tenant and Landlord Rights: The California Department of Real Estate has developed an online information app available here that provides a 2-minute interactive tool to help you determine your rights and options as either a tenant or landlord. Upon completion of the questionnaire, you will receive a customized report with guidance, program availability and applicable links for further information and assistance.
- Yolo County Housing Rent and Utility Relief: This Countywide program supports residents who are at greatest risk of displacement due to non-payment of rent related

to the COVID-19 pandemic and offsets corresponding lost revenue that landlords need to provide housing services. The program provides a one-time rent relief grant directly to landlords on behalf of low-income tenants. Additional information can be found on the Yolo County Housing website in English and Spanish.

seen the department through the COVID and reform actions over the last year as well as countless other issues.

Now, over a year after Interim Chief Strange took over, the City Council and City Manager Aaron Laurel are debating on whether they will keep Strange on as chief, or open the application process and begin a hunt for a new chief. In the pecking order, the City Manager is the one that is responsible for hiring a police chief. However, Mayor Martha Guerrero believes that the Interim Chief has done a good job and should remain there.

Guerrero said she's "extremely concerned with spending thousands of dollars to hire a search firm for a police chief at a time when the police department is understaffed in a challenging fiscal climate. My goal is to preserve stability, accountability, and continuity of effective leadership as demonstrated by our current interim police chief." In addition, our department typically pays less than most in our region. Tom McDonald was

making a little over \$169,000. Because of this, it may not be as easy as you would think, to find a replacement.

Sgt. Eric Angles, Chief Public Information Officer for WSPD and President of Police Officer's Association stated that Interim Chief Strange has a "good relationship with his department". He continued with "Any time I have ever needed to go to him with anything, he has treated me with concern and respect. I would support him staying on as Chief".

It is hoped that the topic will be discussed at the upcoming city council meeting.







day. For the sake of my mental health, I will, instead, share my chicken stories.

Last week, a Next Door poster asked for help in keeping Sacramento chickens laying eggs now that the days are shorter. Of late, she said, her mother-in-law's nine birds had produced just three eggs. How, the poster wished to know, could it be determined which hen in the flock was still producing?

Well, this interested me. I could share how I got my Ohio hens to lay in the dead of winter, plus fellow chicken aficionados shared fascinating tips such as: Dab a bit of food coloring, assorted shades, on the hens'"vents" (private part from which the egg emerges), and then match it to dye smears on the eggs. Voila. You've found the layer.

My contribution (somewhat amplified here) was this:

Add a full spectrum daylight bulb to the hen's enclosure. I had eight hens. More 'daylight' did the trick (be aware, though, that chickens naturally produce fewer eggs as they mature). In my experience, white chickens (Leghorns) produce white eggs and are the best layers. Rhode Island Reds (auburn-feathered chickens) lay tan eggs. Plymouth Rocks (black and white speckled) lay dark reddish brown eggs.

I was sorry I had to sell the farm before I had grandchildren. Chickens fascinate little

Whenever friends with young kids came over, off we'd go to see the creek and barn. I'd converted my milk house to a chicken coop with a roosting box on the wall. Each hen chose 'her' spot inside the box. That's where she slept and laid her eggs. The kids loved reaching un-

der a sleepy unprotesting hen to collect a fresh warm egg. Then, we'd go inside to wash the eggs and, most importantly, little hands (Salmo-

I'd mark each egg with a child's initials and they'd take 'their' egg home. In nice weather, I'd teach them how to fish for crawdads in the creek - but I'll tell you that story another time.

You can have chickens in West Sac, you know. If you want experienced advice on where to get chicks (try Wild West in the spring); coop materials and best construction (Tractor Supply. Or call, then shop local at Lowe's or Home Depot). Best feed

(Wild West) and so on. Other questions? Post on Next Door.

Oh! One last tip. If one of your chicks turns out to be a rooster, just know that not all roosters are mean. 'Roamer' was a really nice rooster at my parent's farm – but we had no hens. My last rooster, Red, WAS mean. He had a job to do. Protect his roosting hens. (I made sure Red was hanging out in the pasture with his buddy, a horse named Calvin, when showing kids the barn.)
