Norma has also registered high school students as far away as Eureka and Tuolomne. The League of Women Voters she started in Tuolumne now has 400 members.

Stabbing incident led to homicide arrest

On Oct. 7, at approximately 12:31 p.m., West Sacramento Police Officers responded to the 900 block of Sacramento Avenue regarding a report of a fight with weapons. Dispatch received several 911 calls reporting that two women were fighting, and one was armed with a knife, according to police.

Units responded to the scene and detained a woman who was pointed out as the suspect by independent witnesses. Officers performed life saving measures on the victim who appeared to have sustained at least one stab wound to the upper torso. Medical personnel transported the victim to an area hospital,

where she later succumbed to her injuries.

Since then, WSPD Detectives arrested Esther Garcia, 53, of West Sacramento regarding the stabbing/homicide. Garcia was booked into the Yolo County Jail for murder.

WSPD Detectives are conducting the follow-up investigation. The relationship between the suspect and victim and the motive for the assault are currently unknown. Further updates will be released as the information is obtained through the investigation, stated Sergeant Eric

115,260 Voteby-Mail Ballots **Delivered** to West Sacramento **Processing and** Distribution Center

Yolo County Elections officials delivered 115,260 Vote-by-Mail ballots to the West Sac-Processing ramento and Distribution Center. These ballots will be mailed to registered voters across the county beginning today. Elections officials toured the Processing and Distribution Center and met with United States Postal Service (USPS) representatives to ensure procedures and protocols are in place for the timely delivery and processing of ballots.

"The integrity of the delivery and processing of Vote-by-Mail ballots is our top priority. We have an excellent relationship with the local USPS representatives and have been working to ensure secure and smooth deliveries of Vote-by-Mail ballots to all active registered Yolo County voters," says Jesse Salinas, Yolo County Assessor/Clerk-Recorder/Registrar of Voters.

Per Governor Newsom's Executive Order and Assembly Bill 423, every active, registered voter will be mailed a ballot for the November 3, 2020 General Election. This is part of California's response to the COVID-19 Pandemic by providing every voter a safe, secure option for casting their ballot.

Every Vote-by-Mail ballot comes with a first-class postage paid return envelope. Cal-

She was a great-grandma to Elijah Hernan-




molded the rough-hewn lands of the West.







Knights Landing Boat Launch Reopens October 9

The Yolo County Parks Division is excited to announce the reopening of the Knights Landing Boat Launch. The site has been closed since July 27 and was expected to remain closed until October 30, however construction crews were able to finish three weeks early. Construction of the project was funded in part by a \$1.45 million grant from the California Wildlife Conservation Board.

New improvements at the Boat Launch include: a gangway and boarding float centered in the middle of the ramp to allow put-ins and take-outs on both sides; permanent vault restroom; water well and hook-ups for a park host; chip sealed parking lot; ADA parking stalls and walkways; rip rap along the bank of sycamore slough and the boat ramp; entrance sign; and landscaping. An upgraded security camera system will be installed shortly as well as an interpretive panel sign highlighting migratory fish found near Knights Landing. The Parks Division is still awaiting final permit approval from the State on the new vault restroom, in the meantime portable units will be available for the public to use.

"We had a small window of time to construct this project," said General Services Director Kevin Yarris. "State and

Federal permit requirements limited in-water construction activities to August 1 through October 15. We are thrilled that our contractor was able to finish ahead of schedule so that the public can again enjoy this space."

Day use parking fees are \$12 per vehicle and can be purchased at the automated pay station. Annual passes may be purchased at the Parks Division Office at 120 West Main Street, Suite D, Woodland, CA 95695 every Monday and Tuesday between 8 a.m. to 4 p.m. or by calling 530-406-4880. Discounted annual pass rates are available for seniors (65+) and Yolo County residents. There is no parking fee for vehicles displaying a disabled parking placard. Those that enjoy bank fishing at the site will have to wait approximately four weeks to allow for successful habitat restoration and seeding to take root.







ifornia has extended the time for completed Vote-by-Mail ballots to arrive back to county elections officials. Completed Vote-by-Mail ballots will be processed and counted as long as they are postmarked on or before Election Day and received by county elections officials no later than November 20, 2020.

Voters can also return their completed Voteby-Mail ballots to any ballot drop box, voting location, or county elections office.

Partnership between Elections Officials and USPS

 Elections officials and the USPS have regular meetings to prepare for the General Election. If any issues are identified with Vote-by-Mail ballots, USPS is

- contacted immediately.
 County elections officials work closely with the USPS to review and approve the design of Vote-by-Mail envelopes and other election mail pieces to ensure machine compatibility and the seamless delivery and return of ballots.
- Ballots featured the postal service's Official Election Mail Logo that allows postal workers and letter carriers to recognize it as essential election mail.
- USPS also conduct daily sweeps of processing areas and require staff to certify no unprocessed ballot mail remains.

What Voters Can do to Prepare for the November 3, 2020 General Election

Voters are encouraged to take the following

- 'Sign-up for Vote-by-Mail ballot tracking at WheresMyBallot. sos.ca.gov. Voters who sign-up will receive automated notifications about their Vote-by-Mail ballots by email, text (SMS), or voice call.
- Make a plan for voting. With the COVID-19 pandemic, voters are encouraged to vote early this year, and Vote-by-Mail if possible. Social distancing and other health guidelines may lead to longer than normal lines on Election Day.
- Make sure you sign and date the back of your Vote-by-Mail

ballot return envelopes. Every voter's signature on the Vote-by-Mail ballot return envelope is compared against the voter's registration record. If a signature is missing or does not match the registration record, elections officials will reach out to the voter to try and resolve the matter. If the voter does not respond and provide the missing or corrected signature, the ballot will not count.



Local high school student recants experience with NASA internship

Haanya Shirin Niazi was selected from a large pool of applicants internationally to be an intern at the NASA Stem Enhancement in Earth Science program that is based in Texas. Due to the pandemic, this internship was converted to an online option. A senior at St. Francis High School, Haanya researched the spread of Covid-19 in relation to human activity with a group of other students for an 8-week period.

"I was impressed by the multitude of experienced inspiring guest speakers ranging from astronauts to computer engineers to COVID-19 specialists. It was amazing to hear all of their stories and to see how incredible a career in the STEM field can be," Haanya said of the expe-

In the early parts of the internship, Haanya said she and her cohorts were responsible for completing four Earth science courses and an optional Python (computer language) course. "I think



these were excellent aspects of the internship because we were able to use NASA data and satellite imagery to explore in depth, not only our beautiful planet, but also the vast star-studded abyss that we call space," she said.

Getting accepted into the internship resonated in some shock for Haanya who said she was expecting everything to be canceled due to COVID-19. But, luckily for her, the SEES program was able to put together an extremely immersive and informative virtual experi-

ence through which she learned so much about both COVID-19 and Earth science. "Once I got over the initial shock, I was extremely excited because even just the idea of having such an amazing opportunity relating to STEM was mind blowing to me," she said.

part of the COVID-19 Safety & Health team, Haanya helped research the spread of COVID-19 in relation to human activity. A few things that her group discovered are that urbanized areas have a higher transmission risk,

that low socio-economic populations are affected more by the pandemic, and that as human activity and mobility increases, so does the number of cases, she explained. "In order to effectively combat COVID-19, we all must continue to wear face coverings and practice social distancing. This was such an amazing experience through which I learned so much about not only COVID-19, but also how to better collaborate with others, take initiative, analyze data, and manage my time," Haanva said.

Two of her favorite aspects of the SEES Internship were the NASA Earth Science courses and the NASA Speaker Series. Through the Earth Science courses, she was able to use NASA data and satellite images to explore Earth and the other planets from a whole new perspective. The NASA Speaker Series allowed her to hear firsthand experiences from NASA engineers and astronauts. "These speaker sessions were very inspiring and

helped me to better understand what it means to be a part of NASA," she said.

Haanya said she has known since a young age that she prefers subjects like math and science, however, never really was sure what she could accomplish with these interests until high school. She said at St. Francis, the knowledge that she gained from her amazing teachers helped her find opportunities. In the summer after her sophomore year, she was accepted into a competitive summer program at UC San Diego called COS-MOS, where she learned about the basics of mechanical engineering and CAD software. That summer, she realized that she wanted to pursue a career in the STEM field in the future. Then, this past summer, the SEES Internship increased her certainty and showed her what a career in the STEM field can become at NASA.

This year, Haanya initiated a club (STEM Club) at St. Francis, through which she hopes to give other students

the opportunity to learn about CAD software in a fun and creative environment. "I couldn't have accomplished any of this without the help of my teachers, whether it was just teaching me in class, encouraging me to be creative, writing me a reference letter, or helping me to make my club idea a reality," she

While an in-person internship would have been much more appealing and enjoyable to Haanya, she said given the circumstances and the health risks involved, the virtual program was very effective and informative (especially since it focused on the dangers of COVID-19).

Haanya wants pursue a career in the STEM field, most likely mechanical engineering. She's currently in the process of applying to and exploring strong engineering programs in many colleges and universities.

a poor choice of words for people seeking reform of police. I believe the public hears 'defund' and immediately says, 'how can we go with-out police?' I believe that people really mean, 'Make police more accountable."

Norma says that police training needs to emphasize de-escalation before shooting. "Not all police shoot first, but the problem is significant enough that we need to address it," she said. A police commission with public oversight is not a panacea, but independent review would help restore public trust and tell police we are serious about remedying this problem. A strictly internal review is not sufficient and sends the wrong message. We need to enforce the ban on lethal holds like choke holds. Body cameras

must always be on when police respond with force. Data must also be kept on police complaints, use of excessive force and incidents of racial bias.

Norma is running on a platform for the people to include affordable housing, more free preschools, neighborhood elections (op-

On affordable housing: The best way to end homelessness is to prevent it. California rents have increased at twice the rate of the average national rent hike: In the last year Californians have suffered an average 4.9 percent increase versus 2.5 percent for the nation as a whole. Rent has to be tied to inflation. West Sacramento has two or three families living in a single home. "We need to have housing that our residents can afford. An 'affordable house' West Sacramento is over \$300,000; well elected. I will fight for

over the ability of many working families to be able to afford," she said.

Free preschool: I worked to get free preschool at six schools in West Sacramento. When I was elected six years ago, West Sacramento had pre-school only at one school: Alice Norman Elementary. We are very far posed to at-large) and from achieving universal pre-school but in the six years that I have been on the Board, the WUSD has created many new pre-school slots increasing preschools to six- a 500% increase. Nonetheless, we have a long way to go, just ask any West Sacramento parent paying \$1000 per month for pre-school. Sacramento remains the Yolo County City with the greatest unmet preschool needs. We need to change that. In the past, West Sacramento City Council has resisted wider County wide pre-school programs that I will support if

real reform not sound

Neighborhood elec**tions:** I worked to bring neighborhood elections to West Sacramento, which have been wildly successful. Now candidates from every district are running for office. Neighborhoods that were unrepresented for thirty-three years suddenly find they are included in school decisions. But the City continues to employ at large elections that concentrate power rather than district elections that are cheaper and more Democratic, but upset old power structures. That has to change. Neighborhoods should choose their own representatives. The City of West Sacramento is the only major electoral district in Yolo County that does not have neighborhood elections because our City Council blocks them.

Equity: "When I was first elected six years ago (to the school board), old books and a different curriculum for poor kids was the norm. Now, no more old books or different curriculum for poor families. All are now treated equally. Bryte Park was an eyesore six years ago, but due to pressure for equal maintenance over the last six years, Bryte Park is livable again.

"West Sacramentans pay twice the national average for electricity because our city is in the York. In Times Square, PG&E monopoly. We need to fight for a Municipal Utility District. We pay \$1000 more per year to be in PG& E. West Sacramento businesses and families

pay nearly double what Sacramentans pay because we are not part of a municipal utility district. The price is \$1,000 more per year on average. I want to change that."

Norma says she's working on trying to get free internet for West Sacramento. Eleven cities like New York now have free wifi for the residents. New or in Central Park, or the subway, you can find free public Wi-fi in New York. The city
