

# Alvaro Venegas announces candidacy for WUSD trustee seat

Local business owner Alvaro Venegas threw his hat into the trustee race for Washington Unified School District 2 (Broderick/Bryte). The general election is Nov. 3.

“Earning a seat on the board will allow me to further engage with our families, mentor and elevate our youth. My plan is to continue to focus my work around equity and wellness for all,” Venegas said.

Also known as Coach Al, Venegas said has been honored to service the schools, connect with the families and mentor the youth. “Being a first generation Mexican American and the son of hard-working immigrants has allowed me the opportunity to understand this community and connect with its rich culture,” he said.

He said his campaign has been ignited, supported and encouraged by many of the parents of the Elkhorn and Westfield elementary communities. “My greatest influencers have been the teachers and educators that have worked beside me in my 12 years in education,” he said.

Among platform issues, Venegas wants to center the focus in educating the whole child and add a level of urgency and take action on a more equitable approach, especially during these challenging times of distance learning. “The wellness of our staff and administrators would be a priority and



we would begin by incorporating stress management and self-care. Above all, the focus will be on restructuring the resources and support systems to better align with the needs of the students, parents and teachers,” he said.

He said by earning a seat, he will bring representation to the Latinx community, which he acknowledges will have a strong presence in West Sacramento.

“I believe that I am the best candidate to represent the unique voices and needs of our

youth and their families. This community has been eager to be heard and they are tired of waiting for representation. Personally, I want to see my community win and I am prepared to show up, stand up and lead a community that has been underserved,” he said.

Born and raised in Salinas, California, Alvaro Venegas, known as Coach Al, has been serving in education since 2008. Through public speaking and writing, he has partnered with many educators and community leaders to impact hundreds of schools throughout California. He has also successfully founded a wellness and health organization that provides inspirational training and personal development to students in schools, teachers, families and military personnel. Venegas said his mission is to continue to support communities by elevating those who serve and contribute to a positive and unified culture.

With shelter-in-place orders, Venegas said he’s fully available to meet in person while following social distancing guidelines, as well as virtually and via phone.

Asked if there’s anything he’d like to add, Venegas said he wanted to “thank God for the many gifts given to me and for allowing me the opportunity to share and make impact in the lives of many. The West Sacramento community has shared nothing but love, support, and positive energy and for that I will always be grateful.”

# West Sac man trapped in his house for nearly two years

As the COVID-19 pandemic swept over the world and people began staying at home to reduce their risk of catching it, phrases like “shelter in place” and “the new norm” began to become a regular part of our vocabulary. People have adopted different degrees of compliance to sheltering in place.

Some people simply work from home, but still leave their house to purchase essential needs.

Others now order groceries and other needs online.

Nearly any type of business that needs to be conducted is done via the Internet. Many people only leave their

homes to go for walks or to get some form of exercise.

The reality is that we *can* leave our homes; we’ve just made the decisions not to.

Furthermore, when we start to feel the walls closing in, or are experiencing some other forms of cabin fever, we simply step outside for a little while. For many, the last five months have been a roller coaster of emotions. Five months, that’s it.

West Sacramento resident, Chuck Wood, has been trapped in his home for nearly two years. He is not sheltering in place. He’s been unable to leave

# THIS ‘n’ THAT Predator at Large in West Sac?

West Sac’s Linden Loop area has been in an uproar and for good reason. Last month, a 16-year-old girl, walking home, ran home as fast as she could when a man attempted to abduct her. On Nextdoor, her mother shared his description: 20- to 25-years old; Hispanic or white-deeply tanned; about 5’8, slight

build; light beard; gelled black hair.

The girl said he pulled over next to her in a late model small shiny black 4-door car, got out, and offered to take her home. When she refused, he offered to pay her let him hug her. The family lives across from River City High School.

A commenter on the mother’s ‘child abduction’ post said that his nieces took cell shots of such a car idling on the curb in front of a Southport elementary school. The girls thought it looked suspicious. You can see those on Nextdoor Linden Loop/nearby neighborhoods under the child abduction post.

I wish I could tell you such incidents are rare, but here’s a story.

A child went missing after being dropped off by her mom at an elementary school near Denver. While waiting to interview the investigating officer, I noticed a large map on the wall full of stick pins. The pins

surrounded the elementary school. The officer told me: “You’ll find that around any school, any park, any playground.” Each pin, he said, represented a known predator.

Also troubling under the child abduction Nextdoor post is the anecdotal report of such an

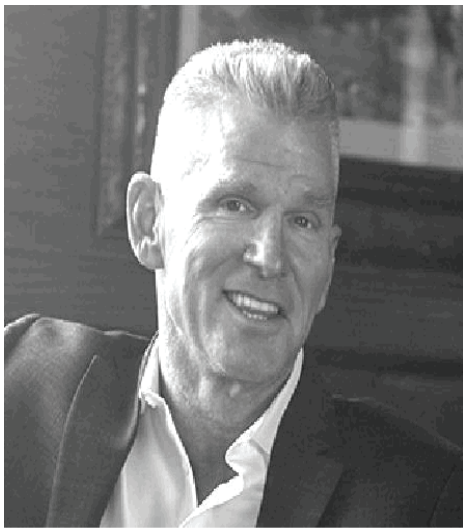

his home because he can't get out of it. Just under two years Chuck developed a blood clot in his leg and ended up an amputee. When Chuck got out of the hospital, he was brought home to heal, and he's been there ever since. You see, Chuck is now wheel chair bound, and his mobile home does not have a wheel chair ramp. In addition, the lip and drop off of the sliding glass door prevents him from even going onto his porch. He pays a friend to bring him groceries.

Chuck served in the Coast Guard during the Cold War. His unit was in charge of inspecting every ship that came into San Francisco to make sure they were not carrying any atomic bombs.

You would think that would mean that the VA would take care of a necessity such as a wheelchair ramp. Shouldn't that be included with insurance? How is that legal? What about the mobile home park? Don't ADA (American Disabilities Act) laws come into play here?

It seems there should be an entire list of reasons why and how this man, a veteran who served our country in a time of need, should have received a wheelchair ramp. Apparently, that is not the case.

Chuck has been a West Sac resident since 1966. He has contacted several organizations for help, including the VFW (Veterans of Foreign Wars) and Habitat for Humanity. Chuck said, "A couple of places came and looked at my place, said they would be in touch, and then I never heard from them again." So still, Chuck remains inside his home.

In February of 2020, Chuck's request made it to the Veterans off All



Wars Riders Corporation. The VAW Riders is a 501c3 non-profit organization with the primary goal is to fill the gap in support services that exist for veterans, their spouses, and family members of veterans. The organization intends to become that bridge of resources that provide support for veterans and their families. (You can learn more about the VAWRiders.org/About/)

The Riders have been working on getting this project completed. However, one contractor gave them a quote of \$7,000, and another gave a quote of \$7,000 to 12,000. A GoFundMe campaign was established to raise the funds. Home Depot has agreed to donate all of the materials for this project. This will relieve a massive burden of fund raising for the Riders. Since Chuck lives in a mobile home park, permits must come from the state rather than the city. It usually takes months to get a permit from the state for construction. However, there is a small list of items that are pre-approved and once you submit the paperwork on line, you may start construction. It shouldn't be long before Chuck is able to sit on his porch, go shopping, visit friends and simply get his life back.

#### Background

Kevin Luther was drawn to winemaking due to its confluence of his passions for nature, agriculture, and craftsmanship.

After earning his degree in Viticulture & Enology from the renowned UC Davis program, Kevin apprenticed around the world throughout his 20s to master the craft.

He then returned to California and spent ten years building startups into successful wineries for other people, while also returning to school and obtaining a degree in Wine Business and a WSET diploma while launching his wine consulting business.

Finally, Kevin decided it was time to launch his own winery, and started Voluptuary Wines to focus on his passion for organic & experimental small-batch winemaking. After his first release quickly sold out, Kevin launched the sister brand Lucid Wines to bring his wine to a crowd-pleasing style.

#### Near Business Death, Success

After launching his brands in 2019, Kevin finally quit his “day job” running wineries for other

people. He rented a single roller door in an industrial lot in urban Sacramento, his hometown and put his entire life savings into launching his brand from side project to proper business.

The launch party for the new winery was set for March 28th, 2020.

On March 24th, the stay-at-home order for COVID was issued locally. On the verge of losing everything, Kevin quickly pivoted and announced that in lieu of a launch party, he would do a virtual wine tasting on Facebook & Youtube, which folks could join by purchasing at-home wine tasting kits. The first 100 kits sold out in 24 hours after his social media post.

From there, the hockey-stick growth curve kicked in. Interest in the kits & tastings blew up, and interest in private Zoom tastings took off as well.

Now, Kevin & his staff host 20 or more virtual group tastings weekly for everything from the general public, private events such as weddings and baby showers, non-profit fundraisers, team-building, staff happy hours, conferences, and VIP events.

# Yolo County Announces COVID-19 Green Check Program

Yolo County is announcing a new, voluntary ‘Green Check Program’ for local businesses to apply for that recognizes and endorses businesses that are in compliance with the Yolo County and State COVID-19 health and safety requirements and guidelines. The intent of the program is to encourage COVID-19 compliance, publicly recognize local businesses that are helping to reduce the spread of COVID-19 among staff and customers, and to inform the public of COVID-19 compliant establishments.

Through this incentive program, businesses will need to fill out a simple application that says their establishment is COVID-19 compliant by implementing and following set guidelines. These guidelines include face covering requirements, proper signage and distribution, personnel training, handwashing and hand-sanitizing protocols, cleaning and disinfecting protocols, measures to maintain social distancing, and measures to prevent unnecessary contact. Businesses that have been certified as compliant will receive a certificate from the County featuring a green check mark and the text “Certificate of Compliance.” This signage means that the County has identified the business as following the guidelines and requirements set forth by the estate of California and Yolo County to help keep the public safe during the COVID-19 pandemic. These businesses will also be featured on the County’s website at <https://www.yolocounty.org/green-check>.

In order to apply, businesses must complete and turn in an application verifying that their business is meeting the established COVID-19 guidelines, which will be available in English, Spanish, Chinese and Russian. Upon submission, the business will receive the certificate and their name will be placed on the County’s website designated for this program. Businesses must continue to remain compliant with the COVID-19 guidelines in order to remain in the program.

“The creation of the Green Check Incentive program provides us with a way of recognizing and thanking the many businesses in Yolo County that stepped up and provided a safe and healthy environment for their customers and employees in the wake of the COVID-19 crisis,” said Gary Sandy, Chair of the Yolo County Board of Supervisors. “The creativity, responsiveness and innovation put forth by so many of our Yolo County businesses have been nothing short of extraordinary. We want to thank them and provide their customers with the confidence that when they enter these businesses they can be assured that health and safety are a top priority.”

incident in the Orangevale area. Same descriptions of car and predator. Perhaps the alleged perpetrator has family there. Or here. When released from prison, most sex offenders go back home.

Decades ago, as kids many of us were told, “Don’t talk to strangers.” Things like this Southport incident are why. Sadly, most child molestations are perpetrated by someone the child knows and trusts. Sadder yet, someone in their own family. Or a teacher. Or a pastor. But serial predators ARE out there.

When I was a middle-schooler in Ohio, our rather stiff, reserved Presbyterian minister, a married father, was caught exposing himself to two young girls one town over. The girls were sitting next to him in a darkened movie theater, with their mother. The mother called police.

The Sunday following his arrest, kids younger than 14 attending church were instructed to leave the sanctuary. I was 14, the secretary youth fellowship, in youth choir, and knew the basics of what had happened. So there I sat, with my stone-faced parents. The doors opened in the back and up the center aisle walked the minister.

He’d met with the Session and was relieved of his pastoral duties, turned in his robes, and told he must apologize to the congregation. His sweet shy wife sat listening without expression to his brief, clearly forced apology.

It was just before Christmas. The couple’s small son was in the Children’s Choir. During the Christmas program I watched as, for several minutes, his small head scanned the sanctuary. Not finding either parent, he started crying.

I knew it was right our minister should lose his robes. I knew he had to leave our church and face other consequences. But I also know, from watching that small boy, the public shaming hurt the wife and son far more than it hurt the predator.

Dad later told us that Reverend Mapes (that was his name) was spared a trial and prison because he agreed to every church condition and also entered treatment. Dad said the Presbytery then assigned him a small church, in a different state. Did he ‘learn his lesson’? Maybe.

On average, child predators molest 100 kids before they’re caught the first time. I learned that frightening statistic while doing a special series on child molesters for WLS-TV in Chicago. For one segment, the station flew me to Florida to report on a pilot program for ‘non-violent’ sex offenders. Those who ‘only’ raped or molested, but didn’t beat, mutilate or kill, their victims.

Here’s what the administrators of the program learned. Even after treatment, predators will still have the urge. They will ALWAYS have the urge. Even male offenders who undergo chemical castration.

The most the program hoped for, they told me, was to condition the offenders to think about how their actions would hurt their victim. Empathy. If they had empathy, the therapist explained, they might stop before they acted. Rapists and molesters, participating together in group therapy,

kept each other ‘honest,’ said the therapist. Each knew how the others’ minds worked. “They call them on their bull\_ \_ \_,” she said. The rationalizations, excuses and denials.

I sat in on one such group session. Many had, themselves, been victims. And decades later, could hardly talk about it. The therapist said re-experiencing the fear, pain, helplessness, and guilt made them feel what their victims felt as they were being raped or molested.

4. ## Valley Clean Energy issues warning about utility bill scam

Yolo County residents are advised to be on the alert for scam phone calls purporting to be from their energy provider.

According to one Davis resident who received such a call recently, the caller apologized for overcharging her on her utility bill, explaining that the overcharge was from a third-party supplier.

She was told to press 1 to apply for a rebate check, but the woman hung up, believing that the caller was attempting to gain access to her bank routing and account numbers.

Valley Clean Energy, Yolo County's public not-for-profit local electricity provider, would like to reassure its customers that it never asks for a customer's banking information over the telephone.

"We're concerned that our customers may believe we're offering refunds and fall victim to these unscrupulous impostors," said Don Saylor, chairman of the VCE board of directors and a Yolo County supervisor.

Added Don Malloy, an investigator with the Yolo County District Attorney's Office, "I doubt that any legit company would apologize for charging you too much — they'd just send you a refund check."

According to the AARP, scammers often make utilities a common subject of impostor scams, by far the most common type of fraud reported to the Federal Trade Commission. The scammers are after the customers' money or their identities.

While some impersonators call homes and small businesses demanding payment for supposedly delinquent bills and threatening to terminate service, others may say the customer has overpaid and ask for bank account or credit card information to make a "refund," the AARP reported.

# Fees relating to the recording of offensive restrictive covenant modifications to be waived

Yolo County Assessor, Clerk-Recorder, and Registrar of Voters Jesse Salinas, along with Yolo County District Attorney Jeff Reisig, announced that fees related to the recording of Restrictive Covenant (CC&Rs) Modifications will be waived in the future.

State law authorizes a person who holds an ownership interest of record in property that is the subject of a racially or otherwise unlawfully restrictive covenant to record a Restrictive Covenant Modification document to have the illegal language stricken (Government Code §12956.2). This law exists because before it became illegal to do so, many CC&Rs were recorded with language that today is outdated and inappropriate.

Prior to 2005 homeowners who found restrictive covenants on their property based on race, religion, sex, sexual orientation, familial status, marital status, disability, national origin, source of income, or ancestry had to apply to the Department of Fair Employment and Housing to have the language voided. In 2005, Assembly Bill 394 changed the process allowing homeowners to record a Restrictive Covenant Modification

with the County Recorder, upon verification by County Counsel that the language in the covenants violated state and federal fair housing laws. Assembly Bill 394 also stated that the County Recorder “may choose to waive the fee prescribed for recording.”

The Assessor/Clerk-Recorder/Registrar of Voters along with the District Attorney are informing the public of their intent to officially waive the County’s Recording Fee and the District Attorney Fraud Prevention Fee which are normally charged to the Restrictive Covenant Modification. At the Yolo County Board of Supervisors meeting on August 4, 2020, the Board of Supervisors thanked Salinas and Reisig for their proactive efforts and unanimously motioned in favor of permanently waiving the county imposed fees.

Jesse Salinas stated, “It is alarming that in 2020 we still have language in covenants that is discriminatory in nature. Our office researched what we could do and how we could remove the language from these covenants and shared it with Yolo County District Attorney Jeff Reisig. He was completely on board

and wanted to work as quickly as possible to waive these locally generated fees. Unfortunately, Yolo County cannot waive any State related fees to these documents, but we will be working actively with our legislative partners to address this issue in the future.” Jeff Reisig echoed Salinas’ statement and added, “We have a moral obligation to do what we can to remove the remnants of hate, discrimination and intolerance from these official recorded documents. Thank you to Jesse Salinas for his leadership on this important issue.”

If your CC&Rs contain racially or otherwise unlawfully restrictive covenants, the Yolo County Clerk-Recorder’s Office will work with you to prepare and record a Restrictive Covenant Modification as well as waive the standard fees associated with recording this document. # Early American carousel sculptures find new home at the Crocker

The Crocker Art Museum is delighted to welcome to its collection six hand-carved carousel animal sculptures by top makers from the Golden Age of carousels. The menagerie includes a deer, giraffe, horse, goat, bear, and greyhound, and is a generous gift from the renowned collection of the Freels Foundation.

The Golden Age of Carousels spanned the 1880s through the 1920s, when resorts and cities throughout the United States and England featured them in their amusement parks. Most carousel animals were horses and were based on the French 17th-century origins of the ride. Additional menagerie animals were later added, including lions, tigers, giraffes, deer, rabbits, goats, pigs, ostriches, bears, and dogs.

The best carousel carvers were highly trained, their work literally sculpture in motion. Today, carousel sculpture is grouped into three basic carving styles: the Philadelphia Style, the Coney Island Style, and the County Fair Style, the latter being

smaller, more simply carved animals intended for traveling fairs.

The Philadelphia Style includes figures by The Dentzel Company and is generally considered the most realistic and graceful. The Dentzel Company created the giraffe, horse, goat, and bear now in the Crocker’s collection. Daniel Müller apprenticed at the Dentzel company prior to founding his own company, D.C. Müller & Bro., in 1902. Müller’s training at the Pennsylvania Academy of Fine Arts is evident in the skillful carving of the deer.

In contrast to the Philadelphia style, the Coney Island style boasted flashier decoration, including silver or gold leaf and sometimes glass jewels. This ornate style is exemplified by Charles Loof’s classic greyhound.

The sculptures are now installed inside and just outside the Crocker Art Museum’s Setzer Foundation Auditorium.
