Family Emergency Scam During COVID-19

There is a common trick used by scammers who call posing as relatives or friends and need you to wire money for an emergency: to get out of jail, leave a foreign country, or pay a hospital bill.

During Covid-19, scammers are using a variation of the family emergency scams. They call or send a text message pretending to be a relative or friend who is on the other side of the border, are sick, and need money to return home. They make it sound urgent and plead with you to act quickly before you realize that it is a scam.

Joe, an older man in the community received a call from a man who kept calling him uncle but did not identify himself. When Joe asked the caller, "Is that you, Robert?" the caller said, "Yes, it's Robert, and I need \$2,000 to come back to Woodland." Joe wired him \$2,000, and then called his family to let them know that Robert was on his way back. Joe found out, to his embarrassment, that the call was a scam and he was swindled out of \$2,000. (The names have been changed to protect the anonymity of the person who reported the incident.)

Every year, in extreme heat of sum- ers mer, there are rescues of hikers in our region. Heat and dehydration can be life threatening, but rescues, which put our emergency personnel at risk and keep emergency resources occupied, can be avoided with just a little planning and common sense. Hiking in the midst of summer is possible, although COVID-19 makes it even more complicated. Here are some recommendations on how to hike safely.

Check the weather. Don't hike on high temperature days. Take LOTS of water. Know your route. Be pre-

crease and water runs low. Remem-This area gets HOT in the summer. ber physical distance from other hik-

> Get out early. If you can be on the trail at sunrise, all the better. Take lots of water because you will be sweating it out. Perspiration is essential to keeping your body temperature regulated. In this area, very few of the trails have water nearby. Some no-water trails, like the difficult 14.5-mile Berryessa Peak trail, should simply not be attempted on a hot summer day unless you plan to carry a couple of gallons of water with you. Getting out on the

Yolo Habitat Conservancy Wins Statewide Award of Excellence

The Yolo Habitat Conservation Plan (HCP)/ Natural Communi-Conservation Plan (NCCP), was recently selected as the recipient of the 2020 Award of Merit for Innovation in Green Community Planning by the American Planning Association (APA) California Chapter. This is the second win for the Yolo HCP/NCCP which, earlier this year, received the Sacramento Valley APA

Section Award of Excellence in the same category.

The Innovation in Green Community Planning Award honors efforts to develop sustainable communities while improving environmental quality. The Yolo HCP/NCCP is a countywide conservation approach that provides mitigation for infrastructure and development of activities identified for construction over

next 50 years in Yolo County, including Endangered Species Act permits. The Yolo HCP/ NCCP coordinates improvements to maximize benefits to sensitive species as well as conserves habitat above and beyond required mitigation. In addition, the plan will result in the conservation of tens of thousands of acres of habitat benefitting 12 species while providing developers a simplified

approach of mitigation through the Yolo Habitat

Conservancy. "This award shows that not only is the Yolo HCP/ NCCP an example of best practices locally, but statewide," said Yolo County Supervisor and Chair of Yolo County Habitat Conservancy Don Saylor. "We are honored by this recognition."

THIS 'n' THAT

We ALL 'See Color'

First let me say, never in all my life have I used the 'n' word. NO ONE in my family ever has. I was raised to, as Martin Luther King, Jr., said, judge people on the content of their character. NOT the color of their skin.

The first time, in my lily white upbringing, I ever saw a 'person of color,' I was very small. Curious about it, but knowing it was 'rude' to notice, my small self tried to be what we now call 'politically correct.' I was staring at her, though. Unoffended, she smiled at me.

Stumped for what to say, I said, "I like your tan."

Unless we're blind, how can we NOT see color? To say we don't is, well, a lie. Thankfully most, or at least many, of us agree that diversity is a GOOD thing. Variations in skin color and other differences, such as the shape of our eyes, are just genetics. That our brain reacts to 'differences' in our environment is, I suspect, rooted in 'the survival instinct.' Take a walk in the woods. When birds detect a 'foreign' presence' – they go silent. A large animal with teeth may attack. Our default is: This isn't me. This isn't my 'pack'. This is 'other'. And it may hurt me. It's a fear response.

Sadly, that fear response is present in ALL races, and bad things happen. Here's a story:

In 1979, in Atlanta, the mayor, Maynard Jackson, was running for reelection. His opponent was white. Jackson was much respected and admired throughout the city. His reelection seemed to be a slam-dunk. Nonetheless, the black police chief drove slowly through the city's Grant Park neighborhood with a bullhorn. He raged: "Vote right. Don't vote white." Perhaps he feared that if the white candidate won, the new mayor would replace less-than-popular police chief. NOT because he was black, but because of soaring crime and murders in black neighborhoods in Atlanta (then dubbed America's "Murder Capital").

Various things have been tried to right 'racial inequity' in housing. Section 8 vouchers, for example. And busing low income kids to 'better' schools (i.e. in predominantly white neighborhoods). The success of such programs has been uneven. In large measure, I think, because whatever the shortcomings of a family's 'home' neighborhood, like attracts like, and home is home. Adults may be living with family. Kids want to go to school with the kids they know. It's natural. It's nature. Financially successful people of color live wherever they want. Having money makes color differences disappear. And, typically, these homeowners are just as interested in protecting property values as are their neighbors. A note: I'm guessing no one would object if Harry and Meghan moved in

next door. Here's the moral to the story: To make things better for 'underprivileged' kids of ANY color, we should shift our focus to adding 'privilege' to their 'home' neighborhoods and schools. When Denver added a Montessori public school to a predominantly black neighborhood and made enrollment open to any Denver family. White parents enrolled their kids in droves.

That all animals, including humans, are initially distrustful of the unfamiliar was evident when I had a pond. I bought a bunch of ducks. Domestic ducks – the all-white kind – and also Mallards. As a group, they waddled to the pond. Once there, though, the Mallards stuck with Mallards, white ducks with white. During mating season, they co-mingled. Some of the ducklings were black and white. Things changed. The entire group swam together. All fear of the unfamiliar gone.

At this juncture, let me

share that, in my view, George Floyd's no hero. Lionizing him does a disservice to the many people of color who: marry the mother of their 6 year old; don't try to use money they know is fake; aren't high on drugs when they're arrested; don't claim they're claustrophobic to gain exit from a squad car, then claim they can't breathe and lay down on the street. The guy's brother admits Floyd was asthmatic. He was 6'6", built like a linebacker, to the cop's, what, 5'10"? And, as it's turned out, a carotid choke hold is STANDARD training for many police departments. Plus, what the cop told Floyd is true: If you

can talk, you can breathe. Now I'm not an apologist for a cop who, with his wife, now stands accused of tax evasion as well as 2nd degree murder in George Floyd's death. But I AM saying, when the trial gets underway, I'm betting there's a lot more to this story.

For 17 years, the cop moonlighted at a Latino dance club where, on "urban (largely black attendance)" night, 12 times, Floyd was the bouncer. Was Floyd a 'gentle giant' when he broke up fights? Fights so heated the moonlighting cop used pepper spray and called for backup? The other. Really? How do you miss George Floyd? Or a white security guy using pepper spray on an all-black crowd?

This same cop, who had his knee on George

Floyd's neck, stopped other officers from intervening. As taken from bodycams, he told them, "He's in delirium." You don't suppose he could see from Floyd's eyes that he was high on something? The 'something', according to the autopsy, being Fentanyl? With still traces of meth left in his system? How many times, do you suppose, do suspects in custody claim they're sick or the cuffs are hurting them, just to get a chance to, for example, grab a stun gun pointed at them? And let's not forget. These two had a history at that

Floyd's family said he'd moved to Minneapolis from Texas to 'start fresh'. He was in his 40s. Start fresh from what? Did he have a record? Is it politically incorrect to ask?

Yes, it was poignant when, dying, he called out, "Mama. Mama." Floyd's brother CNN she'd died two years earlier. I like to think that, as he died, he saw her. Arms outstretched. I also like to think his little girl will benefit from the "Go Fund Me" page the family set up for, they said, her 'college fund.' In the first two days it raised \$2+-million.

This skepticism is my instinct as a long-time reporter. In my first job as an editor, I supervised eight reporters. The best of them was Ricky. During our daily 1-on-1, he shared with me that, in his view, ALL white people are racists. As evidence, he said that whenever he passes a white woman on the sidewalk, she tightens up her grip

on her purse. I felt guilty because I do that, too, but have since realized: It's not because someone's black. I do that with anyone who might do ... what? Who knows? I also automatically lock my car doors at stoplights. ALL stopclub manager claims lights. For Pete's sake. they didn't know each I was a crime reporter! I know bad things can happen, and they do.

> Conversely, the other day at Petco, my elderly self parked in handicapped parking, I was struggling to straighten

out my bent front license plate. A car pulled into the space beside me. A young black man got out. Smiling, he approached me. I smiled and said, "This always happens when I go to Quick Quack." He said, "Me, too," and bent to help me.

Lionize THAT man. HE deserves it. Lionizing a George Floyd does a disservice to the vast majority of all people of color who have nothing to fear from the police because they don't break the law. Regardless of financial status, they make a **positive** contribution to the world we live in. Applaud and honor *them*. Meantime, let's pledge to do a better job identifying the troubled kids in troubled families. Kids of any color. Make school a positive place for them, in hopes they'll grow up with their self-esteem in-

Today's too often destructive protests prove how MUCH we need police. Instead of counting on the 'Brothers in Blue' to 'weed out' bad cops, let's give police MORE money. And use it for mandatory PTSD screening – at hiring, annually, and especially if an officer is forced to shoot someone, or watches her/ his K9 die in the line of duty, or her/his partner. Many cops are former combat veterans. I've seen for myself sometimes terrible things a police officer sees, to be forever etched in memory.

Carol Bogart strongly supports those who protect and serve. She also believes everyone should be treated with respect. Before she had Mike, she tried to adopt a little boy. 4 years old. Black. The male black social worker who came to do the home study sat her down and told her, not unkindly, "We don't adopt black boys to white parents. They don't teach a black child what to expect from police officers and how to act." That was in 1982. Carol's mother often told her unruly daughter, "If you look for trouble, you will find it." A funeral is being held for West Sacramento resident Brandon Daniel Bobo on Wednesday, August 12 2020. Brandon was born on May 10,1994 in Sacramento Ca. and died on August 4, 2020. Brandon was a son, a brother, an amazing father, a grandson, friend and neighbor . but those words don't get close to describing who Brandon realy was. As a young boy, he lived in Davis but spent most of his adolescence in Citrus Heights. He eventually moved to West Sacramento, where he graduated from Yolo High School. As a baby, Brandon was known as a "curtain climber'. There was even one morning when his family woke up to discover that Brandon was on the roof. (Nobody ever figured out how he got up there)The



child had no fear. It shouldn't be surprising that he grew up to be a steel worker. For the last year and a half he has worked for Cranston Steel Structures in Woodland Ca.. He has since learned to fear and being a steel worker made him nervous, but he loved his job. And they loved

In July 2016, Brandon met Jordon Hodge and fell in love. By April 2017, the two of them were engaged. Later that year Brandon met the true love of his life, his daughter Mia. Brandon loved being a dad and in his heart the sun and the moon rose in Mia's eyes. Brandon was good and dedicated dad, who "went above and beyond, especially for Mia. He always made sure we were taken care of before he was", said his fiance' Jordan. In 2018 Brandon completed the Nurturing Fathers Program. His brother Richard Bobo, who fondly called him "Brandoni", spoke about a time that the brothers went to get coffee. Brandon said he felt guilty about doing something like that for himself when his baby girl was at home". If he wasn't working, he wanted to be with his daughter. Brandon's other brother, Pat Bobo, said in part "his smile, easy going nature, him taking the time to teach pokeman to the next generation and him pushing Mia on the swing every day when he got home from work wil be the things we remember about him".

Pat said "Brandon was always friendly, quiet and unassuming, but below the smile was a complex and hurting soul who had gotten lost along the way of life and Brandon had forgotten who he was: a bright light, a radient soul who was special and very very loved". Like most people Brandon had some challenges in life. Some rough ones. But he was trying to face those challenges and overcome them... primarily for the sake of his daughter. He was a good, loving man that was dedicated to his family. His father, Don Bobo said "He wasn't just my son, he was my friend... and he always has been". In addition to his love for his family, Brandon's other love was for the Dallas Cowboys. A life long Cowboys fan prompted his family to make Cowboys gear (or at least a blue shirt) a requirement in order to

attend his service. Brandon is being buried at the Davis Cemetery in Davis California. He will be placed about twenty feet from his oldest brother, Clayton, who Brandon never met due to Clayton being a victim of Sudden Infant Death Syndrome before Brandon was born.

trail extra early has the added benefit of avoiding most other people who start on the trail at 9 a.m. or so. On the hottest days, plan to be finished with your hike and off the trail by 11

There are two main ways to keep cool while you're out on a hike: shade and evaporation. You can get shade from a tree, but you can also get it from a hat. Wear a hat! A lot of the trails around here are lacking in trees, but you will always have shade if you wear a nice broad hat. You don't see it here very often, but an umbrella can also be helpful. The best evaporative cooling is natural perspiration and a little breeze. However, a nice trick on an extra hot day

is to carry a mister spray bottle for extra cooling from time to time.

Hopefully COVID precautions are second nature to us all now, but please don't forget them when you are hiking. Have your mask ready if you cannot maintain a good physical distance. The guidelines say 6', but many places on the trail it's not hard to find a place to step aside and make it 10' or more if someone needs to pass. Don't talk while passing and look outward at the

One way to learn about hiking and the hikes in our region is to first go with others. Tuleyome, the Sierra Club, and many "Meet Up" groups may offer physically

hikes. Check them out. You will learn to enjoy the outdoors safely and you will meet fellow hikers.

Sometimes accidents do happen. We are truly fortunate to have dedicated public safety men and women who take time away from their families and incur personal risks to aid those in need. But let's be sure that we take personal responsibility to avoid unnecessary rescues and do our best to let them enjoy their time at home.

Top Twelve Safety **Pointers:**

Know where you are going - and let others know. There are maps online and trail books at outdoor stores. Plan your trip and let your family and friends know your plan. New hikers distanced can first take trips with

A whistle? Signal mirror? Cell Phone? It's nice to be able to call for help when really necessary but keep in mind that often trails can be well out of cell phone range. Before you make that "rescue me" call, ask yourself: Is somebody injured? Is this a life-threatening emergency? Do I really need help or can I figure this out for myself?

Take a hat, dark glasses and sunscreen with you – and use them.

It is good to have some basic First Aid supplies. Super glue and duct tape are invaluable but you can also purchase small First Aid kits at outdoor

Keep up your energy level. A sandwich, nuts, dried fruit and energy bars can give a quick

happier hiking experi-

Be aware of the nature dangers in our area. The two most common dangers around here are poison oak and ticks. The best way to keep away from both of them is to stay on the trail. If you're not brushing up against vegetation, you should be fine. However, it's always wise to shower with plenty of soap and check your skin for ticks after a hike.

Rattlesnakes: watch where you put your hands and feet. They don't always rattle. If you see a snake, just avoid it. It will be trying to avoid you too. Most likely, it's a harmless gopher snake not a rattlesnake.

Mountain lions and bears: yes, they do live around here. Attacks are extremely rare but boost and make for a it's wise to be particular-

ly aware at dawn or dusk to keep your dog and children close to you.

Take a flashlight. Starting your hike late and getting "be-nighted" is not a reason for rescue! Flashlights or headlamps can allow you to hike during those unplanned nights out.


Take lots of water; at least two quarts for a day hike. Also, drink it! Your goal should be to end the hike with an empty (or nearly empty) water bottle.

Weather can change dramatically on the trail so be prepared for everything. Thunder storms are rare here, although they can happen. Fire is a real danger. If a strong summer wind kicks in, you might want to think about heading home, and if you smell smoke, get out fast.





COVID-19 Creates Emergency for People Living with HIV/AIDS, Their Families

Non-profit Sunburst Projects struggles to respond to onslaught of emergency needs

Sunburst Projects, non-profit organization that has provided essential services to Northern Californians living with HIV/ HIDS for nearly 40 years, has been inundated with calls for help since the onset of the COVID-19 pandemic this spring, said Executive Director Jacob Bradley-Rowe.

Sunburst Project's clients live below the poverty line and have lost income and jobs due to the pandemic. "Our clients are hurting," Bradley-Rowe said. "They can't afford to feed their families, buy diapers and formula for their babies, or pay their rent and utility bills. Our clients are immunocompromised and face unique challenges during a pandemic. And some are sick with COVID-19."

In response to the extraordinary need, the organization has launched a drive to raise \$20,000 for its Emergency Assistance Fund as quickly as possible. Between now and August 17, 2020, all donations will be matched up to \$12,000 due to a matching challenge gift from the Loveall Foundation for Children and an anonymous donor. Donations can be made online at www.sunburstprojects.

"We need help building our Emergency Assistance Fund so we can provide immediate aid to our clients who are in financial crisis," Bradley-Rowe said. "Whether it's paying for childcare so our HIV positive mothers can see their doctors, giving food vouchers to clients who are hungry, or providing transportation to pharmacies for life-saving medications, our Emergency Assistance Fund is vital to our work in the community.

"Some of our clients are in dire circumstances, this fund allows our social workers to help in ways that are very impactful. Every donation helps, no matter how small. We are very grateful to the Loveall Foundation for Children as well as an anonymous donor for their generous matching challenge gift," he said.

Bradley-Rowe joined Sunburst Projects as Executive Director after 18 years in the non-profit arena, including Donate Life California, Capital City AIDS Fund and the Friends of the California State Fair. He has spent the last 15 years on various non-profit boards such as The Imperial Court of Sacramento, the Sacra-

mento LGBT Community Center, and NorCal AIDS Cycle. Bradley-Rowe and his alter ego, drag queen Precious Cargo, are wellknown in philanthropic circles and have been active in the LGBT and HIV community for many years. "Sunburst Projects has touched my heart for quite some time," Bradley-Rowe said. "I was a member of the first Team Sunburst to ride the NorCal AIDS ride. Hearing the stories of how the organization provided such crucial support to those in need left a lasting impression on me. It's an honor for me to step into this leadership role for an organization I have admired for so many years."

Bradley-Rowe has also begun work on expanding Sunburst Project's mental

health services. "We will be launching our new mental health clinic in late fall 2020," he said. "We are increasing our office space, hiring new mental health clinicians and social workers, and working with community organizations on a new HIV testing program at our facility. I am excited to work to meet the challenges of the next decade in the HIV/AIDS community. Our goal is, and always will be, no new HIV transmissions and supporting those living with this disease."

Sunburst Project's mission is to promote health, wellness, and social justice through services that strengthen and empower individuals, families and communities to ensure those living with HIV/ AIDS reach their highest

When to not call the police

In the 911 call that led to George Floyd being killed by police, he was described as "awfully drunk and not in control of himself." This is obviously not justification for his death--being impaired is not a capital offense. Calling attention to his impairment highlights a key factor in many incidents of police overuse of force: drug use or mental health problems by victims.

As former Dallas Police Chief David Brown and many other officials have noted, the police have unwisely been pushed to the forefront in "treating" those battling mental health and addictions. Police as the primary responders to those with mental health/addictions

disaster. A 2015 Treatment Advocacy Center study found people with untreated mental illness face a 16 times greater risk of being killed by

In the words of many a front-line officer, "I didn't go on the job to be a \$#@\$% social worker." Learning to use a gun, a Taser, a baton and handcuffs does not make for effective treatment of those struggling with mental illness and addictions. And most people under the influence of any drug, or suffering any sort of psychosis, anxiety, depression or PTSD, are going to be less compliant with an officer's commands.

Immediate reallocation of significant funds is essential. Police departments literally have growing billion-dollar budgetswhile social ser-

problems is a set-up for vice agencies wither. Treating the scourge of racism is a critical goal; infectious prejudice is a tragedy that has been too long overlooked or deprioritized. As part of that initiative, helping those who face the additional stigma of mental health/addictions problems is vital.

> We need culturally specific programs, including people with lived experience who understand hard times on the streets and living with mental health and/or addictions problems. There needs to be close collaboration with all first responders and a significant outreach component. In Portland and many other cities, programs pairing a police officer with a crisis worker show great success at preventing volatile situations from worsening.

do well with taking multiple medications on a regular schedule and showing up on time at various appointments, often in places hard to get to for those who may not drive. Investments in helping them will very likely significantly reduce 911 calls about someone acting strangely. If there are no weapons being brandished and no felony being committed, alternatives to a police response can save money,

Would George Floyd in Minneapolis have suffered such a brutal police response if he had not been under the influence? Would Andre Gladen, a legally blind African American man with mental health and addictions problems, been killed by a Portland police officer

Struggling people don't if he had gotten adequate treatment? How about Rayshard Brooks, who had been sleeping in his car and was killed by Atlanta police after failing a field sobriety test? Or Darell Richards, a 19-year-old with mental health problems killed by Sacramento

> An investigation by radio station KPCC and the San Bernardino Sun in 2017 found that more than 70 percent of those shot by police in that county showed signs of drug or alcohol use. The scarcity of good nationwide data tracking on what percentage of calls involve mental illness and/or addictions is part of the problem.

> Clearly, we need to attack the disease of racism to see an end to the murder of people of color by police. A Rutgers

University study found that about one in 1000 black men or youths can expect to be killed by police. Mental health and/ or addictions concerns increases their risk.

While we are doing everything we can to battle the systemic racism that has built up over hundreds of years, we must help those who are struggling with mental health and addictions, and are most likely right now to face excessive police force.

The Mental Health Alliance was formed in 2018, in connection with the federal lawsuit prompted by Portland Police Bureau excessive use of force against the mentally ill. Its members include people with mental illness, attorneys and mental health and addictions profession-

Those living in our nation's poor and minority communities have historically gone undercounted in the U.S. Census. For instance, nearly one million Black Americans went uncounted nationwide in the 2010 Census.

Fortunately, there's an easy step you can take that will go a long way towards ensuring everyone in our communities gets the representation and resources they deserve. By completing the 2020 census questionnaire -- online, over the phone, or by mail -- you can add your voice to the conversation and make yourself and your family heard.

Here are five ways your census response will help you and your fellow Americans.

It advances racial eq-

In recent months, millions have taken to the streets to call for racial equity and justice. These protests have helped amplify the voices of underserved communities. But real change will only take place when these demands become public policy. For that to happen, our government needs to see vou. And that can only happen if you stand up to be counted.

The racial inequities that undermine our nation can never be addressed unless you fill out the census and join the fight for social justice.

It directs funding to programs that save lives. As the COVID-19 outbreak continues to ravage the country, it's critical that we direct our emergency resources to those who need them the most. Black and Latinx Americans are disproportionately impacted by the virus and

are twice as likely to die

from COVID-19.

Wealth also factors into the survivability of COVID-19. Adults with an annual household income below \$15,000 are nearly 15 percent more likely to contract a serious illness following infection compared to those with annual incomes over \$50,000.

Your census response helps essential workers identify at-risk communities and directs resources to these vulnerable populations.

According to the results of a recent University of Michigan-AARP poll of adults between 50 and 80, one in three adults does not have regular companionship. United Way Covid-19 local relief fund helps 215 Yolo **County families**

In a span of three months, United Way California Capital Region's COVID-19 Local Relief Fund dispersed \$107,500 to 215 families in need in Yolo County through a one-time \$500 distribution to each family to help offset costs of rent, bills and other basic needs. United Way worked with Empower Yolo, RISE Inc. and Yolo County Children's Alliance to identify low-income families in the county whose lives were disrupted by the pandemic and ensure they received the help they needed. United Way raised a total of \$572,000 through the fund and worked with 11 nonprofit partners across the region to help 1,145 families in Amador, El Dorado, Placer, Sacramento and Yolo counties. The fund closed at the end of June, but the structure remains in place in case of a second wave.

"Stories continue to pour in from families across our region who have received help through our Local Relief Fund," said Stephanie Bray, president and CEO, United Way California Capital Region. "The vast majority of those we served lost income during the stay-at-home order and needed help paying rent and bills. With so many families in our region just one paycheck away from homelessness, gifts to our fund helped avert an immediate crisis for these families and our community."

communities are disproportionately impacted by a natural disaster. Accurate census data will prepare first responders, nonprofit relief organizations, and government officials to respond to future crises.

It funds everything from public housing to school breakfasts.
