# Yolo Basin Foundation celebrates 30th anniversary

In July, the Yolo Basin Foundation celebrated its 30th anniversary. Beginning in 1990, the Foundation led the community effort to create the Yolo Bypass Wildlife Area, now a 16,800acre gem showcasing the diverse habitats of the Central Valley. The News-Ledger reached out to Executive Director Chelsea Martínez recently for a Q&A.

Q: What was the catalyst for initially creating the Yolo Basin Foundation in 1990? Who originally started this project?

A: Yolo Basin Foundation was founded in 1990 by Robin Kulakow as a community-based organization to assist in the establishment of the Yolo Bypass Wildlife Area. We are universally

credited with being the driving force behind the public-private partnership that created the Yolo Bypass Wildlife Area.

President Bill Clinton dedicated this remarkable area in November 1997, and hailed the project as a national model for meeting the challenge of "trying to improve our economy and lift our standard of living while improving, not diminishing, our environment." He also acknowledged the extraordinary collaboration and effort that have enabled our mosaic of seasonal and yearround wetland ponds, grasslands, and riparian forest to thrive.

The establishment of the Yolo Bypass Wildlife Area and the work of the Yolo Basin Foundation have been widely regarded as a model for planning and completion

of other wetland projects in the Yolo Bypass.

Q: This summer, Yolo Basin Foundation will install two new bridges and restore 220 acres of new wetlands in the Wildlife Area. What will these projects accomplish for the area?

A: The Yolo Bypass Wildlife Area is managed for many uses and provides a wide variety of benefits. The main functions are flood control, wildlife and habitat management, agriculture, and recreation and educational uses. The Yolo Bypass Wildlife

Area is located within the larger Yolo Bypass, a flood control structure within the historic Yolo Basin floodplain, whose boundaries are defined by constructed levees. The Bypass carries Sacramento River

"The new norm" is a term we often hear these days due to all of the changes as a result of COVID-19. People in literally every aspect of life, in every part of the world, have made adaptations. The government seems to be walking a fine line in notifying the public in a way to get people to work together and cooperate without causing a panic. #### **Yolo County Issues Isolation** and Quarantine Orders to Prevent COVID-19 **Spread**

Effective immediately, the Yolo County Health Officer has issued a mass isolation order and a mass quarantine order. The isolation order requires all individuals with a positive COVID-19 test to comply with isolation health requirements for the length of their infection (known as the infection period). The quarantine order requires all individuals who have been in close contact with a positive COVID-19 individual to comply with quarantine health requirements. This order is intended to curb the recent increase in COVID-19 cases that has been seen both locally and across the State of California to prevent the spread of illness, and will complement extensive ongoing efforts to obtain voluntary compliance through education and guidance.

Over the past four weeks, Yolo County has seen a significant increase in COVID-19 cases due to family gatherings as well as interactions among a cross section of industries. In response, the County has increased testing and contact tracing efforts to ensure that individuals with COVID-19 are notified and directed to isolate for so long as they remain infectious and those who have been in close contact with a COVID-19 positive individual to quarantine. Self-isolation and quar-

# The Harsh Reality of Anxiety Medication

Millions of Americans are worried about the coronavirus and are now increasing the rate at which they use anxiety medication. The Wall Street Journal reported that prescriptions for anti-anxiety medication have risen during the pandemic. In March of 2020, prescriptions for Klonopin or Ativan rose 10.2% to 9.7 million from 8.8 million in March of 2019. Overall, health concerns, social isolation, job loss, and now going back to work are adding significant stress to Americans. Not to mention, the civil unrest, protests, and riots

that are taking place or that have taken place have also heightened people's stress. The constant news feeds, social medical, and just general conversation is enough to stress anybody out these days. Because so much of our culture revolves around taking a pill to solve our issues, it is no wonder more people are using these drugs.

The most popular anti-anxiety medications or benzodiazepines in the United States are brands like Valium, Xanax, Ativan, and Klonopin. According to the Health Policy Institute, more than 131 million people, or 66% of adults in the U.S. use prescription drugs. According to the 2018 National Survey on Drug Use and Health, an estimated 5.4 million people aged 12 or older were past year misusers of prescripbenzodiazepines,

which is two percent of the population from 2015 onward this has not changed much. Also, in 2018, 1.2 million people aged 12 or older misused prescription tranquilizers for the first time, and since 2015 onward, this has also not changed much. It seems that from 2020 onward; if we make it out of this unreal year, these trends could continue. In a report released by QuintilesIMS Holding Q.N, spending on prescription medicine in the United States will increase four to seven percent through 2021.

According to the National Institute on Drug Abuse, more than 30% of overdoses that involve opioids also involve benzodiazepines. Millions of Americans are prescribed these two drugs simultaneously. In an article published in the Journal of Clinical Toxicology,

it reported the rate of pediatric benzodiazepine exposure increased by 54% between 2000 and 2015. Half of all these exposures were documented as intentional abuse, misuse, or even attempted suicide. Many experts have stated that these drugs have fueled another drug crisis within the country. In an analysis done by GoodRx, in the United States, depression and anxiety medication accounted for seven percent of all filled prescriptions.

People are stressed, and that is understandable, but as restrictions ease, treatment providers, employers, families, and friends should all be aware of the potential danger of anti-anxiety drugs. The signs of a benzodiazepine overdose include trouble breathing, confusion and disorientation, blurred vision, weakness, tremors, stupor, and coma. Treatment providers within the country that offer detox should expect more people needing services. These drugs are not easy to stop using and cause dangerous physical dependence. Also, mixing benzodiazepines other central nervous system depressants, like alcohol, barbiturates, or pain medication, increases the risk of overdose.

Taking these drugs is a risk and a decision that should not be made lightly, especially if you have not explored healthier alternatives. The stress of what is happening in our country is not going away any time soon. Now is not the ideal time to become dependent, misuse, or addicted to anti-anxiety medication. Be aware, know the risks, and understand the harsh reality of these drugs.

# Hospice Makes a Difference in Many People's Lives

My neighbor's mother was 96. She appeared to be in good health for a woman of her age. But, as we all know, appearances could be deceiving. She had multiple illnesses and took over 23 prescriptions daily.

had diabetes She which required blood sticks four times daily, as well as multiple shots of insulin. Her health was not great but she was alert and active at an age when most seniors are in much worse shape. Her daughter got advice from her mother's doctor to put her mother under hospice care. This made me curious to see just what hospice was and what services they offered their clients. This is what I found out.

Hospice care is designed to give supportive care to people in the final phase of a terminal illness and focus on comfort and quality of life, rather than cure. The goal is to enable patients to be comfortable and free of pain, so that they live each day as fully as possible.

Hospice is on call twenty four hours a day.

There are four levels of hospice care, as defined by Medicare, to meet the varying needs of patients and their families. These four types of hospice include routine home care, continuous home care, general inpatient care, and respite care.

There are signs that your body could be shutting down. You could have different sleepwake patterns, little appetite and thirst, fewer and smaller bowel movements and less pee with more pain. There could be changes in blood pressure, breathing, and

Body temperature ups and downs that may leave their skin cool, warm, moist, or pale.

So, what exactly is hospice care? Well, unlike the other types of medical care that are out there, hospice care focuses on caring for a person who has a terminal illness as opposed to trying to cure them. While working with those who are terminally ill, hospice workers focus on providing them with pain management. They also strive to set them up with the emotional and psychological support they need during their final months, weeks, and days.

Hospice care is a concept that's still in its infancy compared to many other forms of medical care. The first hospice facility opened in London in 1967, and it took until 1974 for one to open in the U.S. But since then, hospice care has grown in popularity among many American families. More than 1.5 million people utilize hospice services every year with more than 40 percent of the deaths in the U.S. taking place while a person is taking part in a hospice care program.

So, what exactly is hospice care? Well, unlike the other types of medical care that are out there, hospice care focuses on caring for a person who has a terminal illness as opposed to trying to cure them.

While working with those who are terminally ill, hospice workers focus on providing them with pain management. They also strive to set them up with the emotional and psychological support they need during their final months, weeks, and

Hospice doesn't include the placement of feeding tubes, or any other steps taken to prolong life at this stage of care. However, patients who already have a feeding tube in place may benefit from hospice services. Sometimes, very close to the end of life, patients may choose to have feeding tubes removed.

Hospice is not for people who are dying. Hospice is for people who have a limited life expectancy. Hospice is for patients whose condition is such that a doctor would not be surprised if the patient died within the next six months.

There are rules for hospice. A doctor must certify that a patient meets all of these requirecondition for which the patient is not seeking curative treatment. An expected prognosis of six months or less. Assisting the patient and family members with the emotional, psychosocial and spiritual aspects of dy-

The medical definition of Hospice care: Care designed to give supportive care to people in the final phase of a terminal illness and focus on comfort and quality of life, rather than cure. The goal is to enable patients to be comfortable and free of pain, so that they live each day as fully as possible.

Do you know someone who was just diagnosed with a terminal illness? If so, you should know that you're not alone. Studies have shown that more than 40 percent of people have had either a close friend or family member diagnosed with a terminal illness over the last five years. Knowing when to put someone in hospice care is one thing you can do to help someone who is suffering.

But in many cases, it becomes too difficult for families to care for their loved ones on their own, which is when a hospice facility can come in handy. Hospice care is available to those of all ages and has proven to be extremely beneficial to those who take advantage of it. It's designed to ensure that your close friend or family member is well taken care of towards the end of their life. There are ten signs that your loved one needs Hospice Care. Despite the many benefits that come along with hospice care, there are still some families that are hesitant about using it. They don't want their terminally ill friends and family members to feel as though they're giving

person's mental health and make them feel miserable just about all the time. Hospice care can help these people manage their pain more effectively. Hospice workers specialize in figuring out why a person is in pain and showing them what to do to take care of it. It's not always possible to eliminate pain with hospice care. But most people can make improvements with their pain within just a few

2. Take Regular Trips to the ER or Hospi-Does it seem like your loved one is always checking in and out of the hospital for one reason or another? You should speak with their doctor about what you can do to prevent some of the issues that are taking place. In some cases, your loved one might not be taking their medications as instructed (more on that later), or they might not be taking good enough care of themselves at home (more on that later, as well). But either way, you need to do something to prevent your loved one from checking into and out of the hospital all the time. And a hospice care facility might just do the trick. A good hospice care facility will give your loved one the <u>long-term</u> care they need to manage their terminal illness better. It'll increase the chances of them staying out of the hospital for long stretches of time.

3. Can't Take Care of Themselves Anymore There are a bunch of daily tasks that people need to be able to do to live at home on their own. They must be capable of: eating, bathing, dressing themselves, using the bathroom, walking and

more. When your loved one is initially diagnosed with a terminal illness, they might be able to do all these things with ease. But over time, they could start to struggle with one or all of them. And it'll begin to affect their health. If, for example, your loved one isn't bathing on a daily basis anymore, they'll make themselves more susceptible to certain infections. They'll also likely suffer from different skin conditions as a result.

Hospice care centers can help those with terminal illnesses to take better care of themselves. From eating regular meals to take baths every day, you'll sleep better at night knowing your loved one isn't suffering needlessly because they can't do daily tasks anymore.

4. Forget to Take Medications Hospice care workers will not recommend new medications for people to try to combat a terminal illness. Your loved one's primary doctor is in charge of doing that.


However, workers can and will encourage your loved one to take their prescribed medications regularly when watching over them. This will prevent your loved one from forgetting to take their medications and suffering because of it.

Taking tions might seem like a no-brainer to you, especially if those medications are helping keep your loved one alive. But believe it or not, about 50 percent of people with chronic conditions fail to take their medications as prescribed.

into that category by entrusting a hospice care worker to make sure they take their medications. It'll stop them from suffering any more than they have to.

5. They Slip and Fall As we mentioned earlier, the pain associated with some terminal illnesses can make it just about impossible for some people to get around. They end up spending entire days in bed or in a chair because their pain won't allow them to stand up and walk.

The pain can also lead to slips and falls. It can cause injuries to occur and, in some rare instances, it can even lead to death.

If your loved one is over the age of 65, potential slips and falls should already be on your radar. Approximately 40 percent of the fatal injuries involving those over 65 are the result of slips and falls.

But you need to be especially mindful of slips and falls involving people with terminal illnesses. They're often at an increased risk of falling and hurting themselves due to their pain. A hospice care facility can reduce the risks associated with them moving around.

6. Losing Weight at a Rapid Pace Have you noticed that your loved one has lost a ton of weight in recent weeks? It could be due to the medications they're taking to the terminal illness that is wreaking havoc on their bodies. There is also a chance that they're not eating enough and losing weight because of that.

Whatever the case, your loved one's rapid weight loss should concern you. It could cause them to become very weak and make it even more difficult for them to live a somewhat normal life. By looking into your hospice care options, you can help them maintain a healthy weight. That alone could improve their life by leaps and bounds.

7. Also Losing Their Abilities Those with a terminal illness will often lose more than just weight. They'll also start to lose their mental abilities in some cases.

This can, as you might imagine, affect them in all kinds of ways. It will: Cause them to become confused at certain times of the day, Make it even more difficult for them to carry out daily tasks, Impact their ability to stay on top of their med-

If your loved one appears to be struggling to keep things together mentally, it might not be long before it's impossible for you to give them the care they need. You'll need the assistance of a hospice care professional to guide the way.

8. Constantly Dealing With Infections niors are more susceptible to infections than the rest of the population.

Part of it is because many of them suffer from several different health conditions at once. All of those conditions can attack different parts of their bodies and make it difficult for their immune systems to stave off infections. But part of it is also because many of them don't take good enough care of their bodies. They don't bathe themselves properly and don't move around enough, which leaves them open to in-

If your loved one is dealing with lots of infections on top of their terminal illness, it's going to wear their bodies down over time. It's also going to force them to spend more time in the hospital than they want. By taking them to a hospice care facility, you can eliminate at least some of the risk of infections setting in and allow them to stay a little bit healthier.

9. Struggling to Sleep Older adults should be getting anywhere from seven to nine hours of sleep every night. But some studies have suggested that up to 50 percent of them struggle to sleep at night.

Has your loved one told you that they can't

sleep well anymore? It could be a result of their constant. There are some medications that can also cause insomnia.

When you place them into hospice care, someone will work with them to figure out why they struggle to sleep so much. A hospice worker will contact their primary doctor and come up with a solution to this problem.

10. Living With a Very Low Quality of Life It's often hard for those living with a terminal illness to find joy in life. Amongst all the problems that the terminal illness causes and the grim outlook for their future, people have a tough time seeing the positives day in and day

If your loved one doesn't ever seem happy, hospice care might be able to change their outlook on life. It'll remove some of the pain they're feeling and give them the comfort they crave. And it could very well restore their quality of life and make them feel alive again for the first time in a long time.

Understanding When to Put Someone in Hos-

pice Is Important The idea of hospice care might seem scary, both to you and to your loved one. Initially, it might feel like you and your loved one are both giving in to the harsh reality that comes along with having a terminal

But look at it another way. Hospice care can actually give your loved one their life back in many ways and let them enjoy life while they still can. You need to understand when to put someone in hospice and make the decision to do it before it's too late.

prived of paychecks, are struggling to make ends meet. (Especially now that the \$600 unemployment weekly 'bonus' has expired.) Add to that the uncertainty of a faltering economy. Are these workers only furloughed? Or outright unemployed? Indefinitely?

And then there are those who still have their jobs IF they can do those jobs at home. A wonderful thing, for many, who don't have kids. Fun, at first, for those who do. Not so much when kids are bored with video games and movies.

Having Mike at home with me was great, except when I needed quiet to focus on my writing. As early as preschool, I learned to write when he was gone. Today's parents can't even tell their kids to go out and play, or encourage other kids to come over to keep them occupied.

I still have the sign I bought when Mike was young: **Grand Central Station**. I intentionally made my house kid-friendly to encourage his friends to come over. Mike was an only child. It taught him how to share. To be honest, there was a lot of breakage, but it was worth it and, between cleanups, I got a breather.

I couldn't do that now. "Gatherings" are blamed for resurging virus spread that, currently, has sent more than 200 area people to Sac County hospitals.

All that said, 'protecting high risk groups' (which many still think are those who have underlying health conditions, are over 65, or both) is a flawed argument for shutting down again. This virus omits no one. Yes, old people and staff in nursing homes bump up Yolo and other counties' virus-positives and deaths – because such facilities are GROUP settings. Taking temperatures, even doing tests, is no assurance someone without symptoms won't infect the group. Like visitors. Some, maybe many, have the virus but have no fever. Or will pass the test - with a false negative – not get retested, and promptly infect others.

With even the president not putting on a mask now, you know there is a LOT of pressure on companies to 'warp speed' a vaccine. And not just any vaccine. Human trials must prove it consistently kills the virus but won't kill YOU. Some contenders look promising in the lab. Some clinical trials will PAY you to be inoculated, then intentionally be exposed to the virus. Let's say they find one that passes muster in ADULTS. Will it be safe for kids? At what dose? And what if the vi-

And if that's not enough, there's a new flu circulating overseas that threatens to become a NEW pandemic. Combo swine and Spanish flu. yippee.

Frightening times. But some now are saying (even Fauci) a safe, effective vaccine may be approved by January 2021. Even then, though, it won't be universally available. High risk groups first, is what they're saying.

Well, I'm in both groups and I'm stay home-weary. But if there's a safe, effective vaccine, I'd rather my son get it. Young people his age (34) and younger are suffering virus-induced STROKES. Some are dying.

I haven't seen him since Christmas. We touch base weekly to make sure we're both still virus free. He tells me he's being safe (example: stays far away from street protests), and cautions me, "Be careful."

Here are just some of the things I think kids lose when schools stay

Learning social skills with other kids. Participating in music programs (research has shown such programs help the developing brain learn math). What if neither parent is good at math? Who teaches algebra?

No structured setting for distance learning because both parents are 'essential' workers.

No 'group' school projects.

Who pays for school supplies if both parents have lost their jobs?

After school programs, such as Fall sports. What will that mean for athletes who excel and count scholarships to go to college? And how far behind will they be from other students whose schools stayed open?

I hope the 18-million child-size masks the state has ordered prove better than the PPE medical provider masks our governor bought early on from China. And the Covid 19 test kits clinics got from the CDC that proved to be defective.

I love my son very much and always have. Thank God he was out of school before all this happened. To parents trying to stay patient with your homeschooled kids, chin up. This won't last forever.

Carol Bogart plans to, again this year, get the multi-strain flu vaccine designed for old, sick people. Out of pure desperation to again be active, she'll likely want an FDA-approved Covid vaccine. Until there's such a vaccine, except for essentials, she's staying home, has no one over, doesn't make appointments, and maintains contact with the outside world through social media. Comments? 

antining are extremely important in curbing the spread of COVID-19 because a person with COVID-19 can easily infect others they interact with, such as friends, families and coworkers. For this reason, compliance with COVID-19 isolation and quarantine requirements is vital. Unfortunately, in recent weeks county staff have identified instances where voluntary compliance with these requirements has not been adhered. This hinders contact tracing efforts and threatens the overall health and safety of the community.

Also hindering case investigation and contact tracing efforts is the delay in receiving test results. Because the current turnaround time for test results has been prolonged, Public Health often receives positive test results after a patient's isolation period

will have already been completed. As part of this mass isolation order, the County is also releasing instructions for isolation and quarantine that will be provided at various testing sites and also available on the County's website at https://covidtesting. volocounty.org. These instructions will allow a person with symptoms or who is a close contact to a COVID-positive case to begin isolation or quarantine before even receiving test results. This pro-active action will help curb the spread of COVID-19 from a potentially infectious person before they even receive their results.

The Yolo County Health Officer mass isolation order will focus on those residents who have already received their test result. This order requires all individuals with a lab confirmed positive COVID-19 test to comply with self-isolation instructions for their infectious period. The period of isolation for those

without symptoms is 10 days from the date of a positive test. The isolation period for those with symptoms is at least 10 days from the onset of symptoms and at least 24 hours since recovery (meaning resolution of both fever without the use of fever-reducing medications and the improvement of cough and shortness of breath, if present).

Under the isolation order, COVID-19 positive individuals are required to do the following:

Isolate themselves in their home or another residence for 10 days. They may not leave their place of isolation or enter any other public or private place, except to receive necessary medical care or during an emergency that requires evacuation to protect the health and safety of the person.

Tell their close contacts that they need to quarantine themselves. Close contacts of an individual who has COVID-19 are persons who, during the individual's infectious

period, were within six feet of the individual for 15 minutes or longer The infectious period commences 48 hours before symptoms began (or, in the absence of symptoms, 48 hours before the date of administration of a positive test) and ends when the isolation period is over.

Carefully review and follow the "Home Isolation Instructions" posted at https://covidtesting.yolocounty.org (and included in the order). The individual should also refer their close contacts to follow these instructions.

The mass quarantine order is directed at residents who have had close contact with a positive COVID-19 individual. Close contacts are required to do the following:

Stay in their home or another residence for 14 days from the last date that they were in contact with the case. Persons are required to quarantine themselves for the entirety of the 14-day incubation period because they are at high risk of developing and spreading COVID-19. They may not leave their place of isolation or enter any other public or private place, except to receive necessary medical care or during an emergency that requires evacuation to protect the health and safety of the person.

Carefully review and follow the "Home Quarantine Instructions" posted at https://covidtesting.yolocounty.org (and included in the order).

Health workers and first responder agency workers, may exempt from quarantining if they inform their employer, are showing no symptoms, and the employer determines they are needed at work based on staffing need.

In an effort to protect the health of the community, individuals that do not comply with the isolation and quarantine requirements under the orders may be subject to penalties including citation. Prior to the use of any enforcement measures, efforts will focus

on providing education, resources and/or guidance to that individual on compliance.

water at overflow to the Delta and is operated as part of the Sacramento River Flood Control System.

The two new bridges being installed this summer are along the gravel roads within the Yolo Bypass Wildlife Area to improve drainage and alleviate flooding of the roads to improve public access.

Q: What educational resources or opportunities do you offer now for parents and students approaching several months of online crisis learning?

A: Yolo Basin Foundation's mission is to expand public appreciation and stewardship of wetlands and wildlife in the Yolo Basin through education and innovative partnerships. We offer many in-person educational events and programs throughout the year including Discover the Flyway school field trips, California Duck Days festival each February and our popular summertime Bat Talk and Walks.

While we are unable to meet for our popular Bat Talk and Walk summertime events due to Covid

Foundation is offering interactive, virtual opportunities for all ages to learn about and see live bats up-close through our new Yolo Bat Chat events. Participants will get to see three species of local bats and are able to ask their questions about these amazing and essential animals. You can also join us for a Facebook live event to watch the sunset fly out of 250,000+ Mexican freetailed bats as they leave their daytime roost under the Yolo Causeway to search for food.

We successfully transformed our summer camps into virtual gatherings where campers became scientists for an hour each day with athome experiments and nature crafts using provided camp material boxes. Visit our website at www. yolobasin.org for more information and schedules of our programs.

The return of students to the classroom is likely to look different this year. Physical distancing and a combination of in-class and remote learning is expected. Reducing the risk of coronavirus infections combined with proposed funding cuts, make field trips unlikely.

As a result, our flagship K-12 environmental education program, Discover the Flyway, is preparing virtual, flexible options to continue providing important wetland science

and social studies learning activities to inspire students. Our plan includes virtual, live field trips where teachers can invite Discover the Flyway into their classrooms or students' homes with interactive science or social studies learning activities led by an education team member and docent live from the Yolo Demonstration Wetlands!

woke up several hours later in the hospital with no memory of what happen and had no idea where he was. He was able to provide the emergency staff with his name and birth date, but no other information. He was confused and disoriented, but the information that he told them was enough that they released him from the hospital at 4 a.m., without notifying anyone of the accident or arranging a ride for him. He was found by his wife, staggering, and falling off of the sidewalk. Joe has no memory of that night or the following day. We wondered if this was because the hospital was anxious to get him released due to COVID threat, or just an isolated incident of bad judgment? The hospital where this happened was a Dignity Health facility. We reached out to them many times, but continued to receive no response.

Sutter Health and UC Davis Medical Center were happy to talk with us. UC Davis Med

Information Center's Representative stated that "patients are admitted and released when needed and they have no changes to this process" and that "each patient receives necessary care without a timeframe attached." Furthermore, if you feel that you need to be seen at their Emergency Room, please do so. Everyone is expected to have on a face covering before they enter. If you do not have one, one will be provided. You are also required to practice social distancing. All ER cases (COVID or not) enter through the same entrance and are triaged inside. In addition, whether in the ER or an admitted patient, only one visitor is allowed. UC Davis Med Center would also like to assure people that all of their staff have always practiced proper personal protective equipment (PPE) for the safety of their staff and patients and will continue to do so. They urge that if your medical needs can be met by your primary physician, you should first seek help from them. However this is not required. They also asked to remind the pubshots and any other vaccinations you may need."

A spokesman for Sutter Health explained that their policies may vary depending on the location. In some instances, there is a separate entrance for COVID emergencies. Whether there is a separate entrance or not, there is someone at the Emergency Room entrance that will triage people coming in. During the current pandemic, precautions are in place at Sutter-affiliated hospitals to protect the health of patients and our staff. Upon arrival to the emergency department, the medical team will place patients with respiratory symptoms in special areas away from the general population to avoid the possibility of spreading the virus.

Sutter facilities have put in place safety measures for masking patients and visitor restrictions; keeping patients with COVID-19 symptoms away from common waiting areas, entrances and other patients; arranging for environmental services staff to perform extra cleaning and disinfecting; and requiring all staff to have their temperature taken before each shift.

Sutter Health operates in 22 counties, with a single electronic records system. Because of this, Sutter can move resources, staff, equipment, even patients to where needed, allowing caregivers full access to every patient's health information wherever that care is provided. They also stated, "At the same time, we have been gradually broadening clinical services and caring for those patients with medically necessary, time-sensitive procedures and preventive care needs like cancer screenings, immunizations and other necessary clinical services. We are taking a careful, phased approach that prioritizes the safety of our patients, employees and clinicians. We are experiencing an increase in cases in some areas of our footprint. Because of the breadth of our network we are able to care for both COVID-19 non-COVID-19 patients across our communities." To access the right level of care with Sutter you can access their website. What to do when you are feeling (Including chronic conditions, colds, flu,

etc.): Send a message to your care team via My Health Online, Consider a Sutter same-day video visit. They're available 8 a.m. to 8 p.m., seven days a week, Call the Sutter COVID-19 Hotline at 866-961-2889 available from 8 a.m. to 6 p.m., seven days a week, Sutter's Medical Symptom Checker can direct you to the right healthcare for your symptoms.

For Healthcare Concerns Not Related to COVID-19: For other illnesses and injuries, you can also access Sutter walk-in clinics and urgent care centers. Find locations at sutterhealth. org. And of course in a true emergency call 911.

Urgent Care is also a cost effective and less traumatic option. If you are unsure of whether you should go to the emergency room or to an urgent care, here are some guidelines: Some common conditions treated in an emergency room – difficulty breathunconsciousness, spurting blood, poisoning, chest pain or pressure, severe allergic reactions, moderate to severe burns or wounds, convulsions or seizures, serious head, neck or back injury, sudden inability to speak, walk or move, high speed car accident or high fall. Urgent care situations include: A cut that needs stitches, abdominal pain, fever, sore throat, ear pain, vomiting or diarrhea, an eye scratch, worsening of existing condition such as asthma, spike in blood pressure, general injury such as sprained ankle or back problems, simple broken bones, a non life-threatening accident or fall.

Regardless of where you go, remember this... Though it is true that the doctors have the education and hopefully skill to know the best way to treat your illness or injury, nobody knows you better than you. You know when things are not right. The human body is good like that. It tells you when things are not right. But that doctor works "for you". If you feel that they are not helping, or like they are "blowing you off", or if what they are doing is just not helping... speak up! If you have to, ask for a second opinion (demand it if you have to). By law, your insurance must cover a second opinion. Stay healthy everyone!


