On July 16, 2020, a two-commissioner panel of the Board of Parole Hearings denied parole to 49-year-old Ronald Martin who was sentenced to prison for 33 years and 4 months in 1997. The hearing commissioners were Deborah San Juan and Teresa Meighan. The hearing took place at California State Prison at Solano in Vacaville, California.

On February 22, 1996, Martin entered the Davis Food Co-op armed with handguns and forced employees into the cooler. He and his accomplice demanded that the manager open the store safe. Martin discovered that officers had arrived and attempted to leave the business through the rear door. He began firing at officers when he was confronted at the rear of the store. In an attempt to avoid the police, then Martin used the store employees as human shields, herding them outside a rear exit attempting to protect himself from officers. He threatened to kill the employees if not allowed to pass. Martin subsequently released the

# VFW at risk of permanent closure

On Sunday, July 12, West Sac Veterans of Foreign War (VFW) Post 8762 suffered another bout of vandalism. In the last 12 months, VFW's outside water pipe has been vandalized 15 times. According to the video surveillance, it appears to be happening by transients trying to have access to water.

Each time it occurs the building has suffered extensive water damage. Sunday's incident was no exception. The pipe was broken by a man wanting to take a shower. It was then left spraying water into the air for seven hours. The pipe is located inside of a locked, fenced yard. The members of the post have enclosed the pipe with a wooden cover, and have even built a metal cage around the pipe to protect it. The wooden cover was torn apart and the cage was ripped out of the wall, leaving a big hole in the outside wall. VFW has even tried leav-

ing the water on so that people had access, but it still got vandalized. This has been just another blow to trying to keep the VFW alive. With COVID closures, the VFW is yet another establishment trying to keep from going bankrupt.

Prior to COVID closures, the VFW's monthly expenses generally totaled around \$23,000. This is for all expenses. Those expenses are not only for the overhead, but they also covered the cost of aid to veterans for things such as temporary housing, food, bills, medicine, car repairs, etc. The bar, the meals and the hall rental have done pretty well on covering the expenses, but with the COVID closures most of that income is lost. VFW 8762 has still been preparing meals Monday thru Friday. That has been the only income. However with no water, that came to a halt. Since COVID closures the monthly expenses have been shaved

# Suicide: Permanent Solution to a Temporary Problem

He left new track shoes behind. And what looked like a soccer shirt. In one pocket, a small, still-playing, radio. A jogger, noting the belongings on Tower Bridge, and called

Ace Young, a retired journalist, walks his dog daily across the bridge and was present as police arrived. Within 15

minutes, West Sac search and rescue (DART) combed the Sacramento River. With no trace of the jumper and no ID, Sac police told Young the report would be filed as a missing person.

Seeing the size of the shoes and shirt, Young assumed the jumper was a man. In a NextDoor post, he wondered: "If I'd gotten there 10 minutes earlier ... ? When I crossed the bridge the other way, did I pass him?" His post concluded,"... in this COVID-19 era, I would urge any and all to reach out to others who may be struggling."

Young's post struck a chord with many. One shared the death of her friend of 30 years. "A

strong man," she said. "Great sense of humor." Until the pandemic-forced restrictions.

His wife told her he "missed playing handball." It was the pandemic, said his long-time friend. He just couldn't it. This month, he committed suicide.

And here's one, too. An area combat vet

who'd lost both legs and counseled other veterans. Then came the Stay Home order. No more 'group' meetings. No social interaction. "He killed himself," my friend told me. "One bullet to the head." He lost his purpose.

# Garden guru shares advice on gardening with children

Plant whatever brings you joy. I read that book and I like the title, but the very idea is problematic since planting anything is wrought with the opposite of joy – horrible sinus pain.

Give me my Benadryl, a glass of wine, draw a bath and I'll see you in the morning.

When toilet paper became a rare commodity due to the corona, I freaked out and became a TP hoarder. I even joked on Facebook about how I use a roll a day to keep the boogers at bay. I had folks volunteering to make me hankies!

Sometimes my allergies actually make me sad because I want to be that mom, the one with the beautiful victory garden tended to with help from her 8 year old daughter. You, know, that Waldorf mom who also likes crafts and could sew her own darn hankies (and Covid-19 face masks, which could also be helpful with the allergies when gardening, I suppose). When I think of my dear mom friend (and friend in general) Sara Bailey I have an image of her wearing her gardening shoes, hat and gloves while her two children play in the dirt and watch the grass grow. She is *that mom* who plants joy at school. She's also my friend whose children sewed me some hankies and gave me a packet of harvested sunflower seeds. Sunflowers do bring me joy. She must have known. Afterall, Sara has two children and runs the garden program at our children's school.

Over the phone she explained the Mexican Sunflowers are easy to grow; even children have success with them. Excellent.

Also a community seed-sharer, Sara saved seeds from last year's harvest, including Mexican Sunflower, to basil, squash, pole and bush beans beans, making for neighborly exchanges during the quarantine. "Some were from seeds I saved and some were from friends and family that we exchanged with. I planted so many seeds, so I had so many to share. It was one thing we could do – share. That was like 'elevendy' years ago. It feels like 400 years ago we were planting seeds."

Her expertise working with children in the garden has grown over the years. Sara says Soil Born Farms in Rancho Cordova has helped instruct grown-ups, like herself, on how to explain plants to them. She learned that teaching kids how their hands are tools and how they can use them in the

garden have born fruitful results. And, planting different size seeds requires specific handling; you can plant that one seed with your finger. "Otherwise you end up with 4 million seeds all over the place, which happens anyway, and that's totally fine. That's all part of it," she says.

If you actually want to get some gardening done, Sara recommends having a clear plan and supplies at the ready. That said, sometimes it's best not to have a plan and be more open-ended and ask them to use their senses to see what's there. "That doesn't have to be so structured. It's a balance of figuring out what needs to get done and what makes sense to do with kids and just having it really planned out."

Bringing her to a total let-go of control, Sara said gardening with children will never be the way you planned it in your head no matter how much planning you do. So much of it

is going with the flow. For instance, when they ask questions, she doesn't always answer them. Rather, she lets their curiosity stay in that zone and asks them what they think.

While children at the school always ask to grow carrots, Sara advises against it. "It's not that I don't do carrots with kids - they're just hard. They don't germinate really easily and they take forever to grow." On the flip-side, radishes although aren't typically a crowd-pleasing vegetable, Sara likes to plant them with children because of how quickly they germinate. "In a short amount of time, you will have radishes, which is not a thing kids necessarily love. If you cut them up and offer them to a bunch of kids, and a couple of them like them, then more kids will try them. They are just fun to do because they happen really fast."

Additionally, she says sweet peas are fun and

any type of squash are great because they grow really fast. Sometimes things in school gardens you have to think about because things like summer squash and tomatoes do most of their growing in the summer when kids aren't there. On the other hand, pumpkins are great if someone on campus can do the watering over the summer. So, in theory when the kids return to school,


they have pumpkins. One of her favorite things to plant with children is borage, an annual that re-seeds itself easily. "They have awesome purplish blue flowers on them and you can pop the flower off; it's edible and tastes almost like a cucumber. Some people make tea with them. They don't take up a lot of space and they're super fun. That's one people don't know a lot about and they're cool."

Sara says that when she's at school she no-

tices big differences in some children's behavior when they get a chance to go outside. "When you're at a school in your classroom, these walls are around you. Outside, you get to see a different part of kids. There are kids if you are sitting next to them and not looking at them and you're just digging in the dirt together, they will talk to you. You could spend a lot of time in the classroom with them and not ever hear from them directly. The garden is a really safe place for kids to be who they are. There is something for every kid. There's something that they're good at. There are some kids that are really great at ripping out weeds, some who like heavy lifting, and there's things that are more finesse like weeding in between the teeny tiny flowers."

Sara says there's a place for everybody in the garden. Perhaps there's hope

Maybe you're worried a loved one is feeling hopeless, or you have Covid-induced depression? In hopes this helps you, here's what I learned when, at age 19, I wanted to die so tried to kill

I was 14 and already troubled when I lost my favorite uncle and my grandma. A Catholic friend told me suicide was the only unforgiveable sin, so I started asking God to please let me die in my sleep. Another and perhaps the biggest factor: back then, ADHD had not been labeled. As far back as I could remember, I was 'difficult' - for my parents, teachers, camp counselors – and espe-

By 19, I had no self-es-

Away at college, I lost my bearings. I couldn't think of a single I cared about. I just felt nothing. I called my mom and said, "Mom, I need help."

The psychiatrist I started seeing weekly prescribed antidepressants and valium. He told me to avoid serious relationships for at least a year.

Back home for the summer, I met and dated a nice young man. But he started getting serious. So, I ended it. Wanted to hug him as, shoulders slumped, he walked away to his car.

The next day, to keep my mind off Jerry, I took the dogs to the river, rammed around a bit then came back home. Mom was waiting for me at the door and said, "Come sit down." Her expression filled me with foreboding. Mom handed me the paper. When Jerry left me the night before, he'd gone by himself to Marblehead. That's where we always went to talk: sitting on the rocks, looking out across Lake Erie.

The story didn't say all that, of course. Only that, coming back, he took the route that passed my parents' farm. CR 6. At night, a dark and lonely road. Why his speeding car ran off the road, crossed a field and slammed into a tree, no one could say. But I knew. I knew I'd killed

For three days, all I did

At 19, you don't know agony won't last forever. I couldn't take it another day. I swallowed what was left of my own prescriptions, then all of dad's Phenobarbital. Hoping God would forgive me because I loved little kids and animals, I yearned for heaven. To see my grandma and my Uncle Chuck. To tell Jerry I was sorry.

To wait for death, I went deep into the Catalpa grove to lean against a tree. Nothing happened. The bark was rough; the ground was sticks and rocks; I was uncomfortable and going unconscious took too long. So I went back inside and laid down on my bed. If mom looked in, I thought, she'll just think that I'm sleeping.

Complication. The pills, interacting with each other, played havoc with my stomach. Mom, downstairs in the kitchen, heard me screaming. The ambulance came but I was already blue, she said. For three days, she sat vigil by my bedside. She was told my chances were 10 percent and, if I woke up,  $\bar{I}$  might try again.

I didn't. My first thought was, "God has a plan for me. He must, if I tried this hard but didn't die. I don't know what it is right now, but, in time, I will." And then, I saw my poor mother's haunted eyes. We both cried as I said, "I'm sorry, mom."

And here's what I learned from my failed

suicide attempt: When I'm down, I shift my focus to things that lift my spirits. I'm confident there will always be love and beauty, joy and laughter. Look now for ways to have 'purpose' in a post-Covid world. And keep the faith: This too shall pass.

Feeling hopeless? Call the national suicide hotline 1-(800)-273-8255 or visit Suicideispreventable.org. Do you worry someone you love is on the brink? Experts say, just ask them: "Are you thinking of killing yourself?" The answer 'yes' is a mental health emergency. Call 9-1-1 and ask for a welfare check. an adjacent residential neighborhood. An extensive search was conducted, and the Martin was found hiding in a backyard by the Davis Police Department Swat Team at 2:30 a.m. He entered into a negotiated plea of no contest to seven felony counts and admitted personal use of a firearm in connection with each offense. Martin, based on his plea bargain was sentenced to the California Department of Corrections for a term of 33 years, 4 months. His accomplice has never been apprehended.

The hearing took three hours and after the commissioners deliberated Commissioner San Juan stated that Martin would still pose a continued risk to public safety should he be released from prison. Commissioner San Juan told

Martin that his insight was cursory, his conduct in prison evidenced lingering problems with anti-social activity, he lacked self-control and he hadn't developed the tools to avoid returning to prison, if released.

Yolo County Chief Deputy District Attorney Jonathan Raven represented the Yolo District Attorney's Office at the hearing by Skype conference, due to the COVID-19 crisis.

District Attorney Jeff Reisig commented on the parole denial: "This was an atrocious crime that has no doubt caused severe emotional damage to these victims. Our office is committed to representing the interests of victims' families and public safety at these parole hearings, and when it's appropriate we argue against the release of inmates who are a danger to the public." Martin will be eligible for parole again in 2027.





## Yolo County Increases Enforcement Measures to Prevent COVID-19 Spread

Yolo County is now increasing implementation of enforcement measures focused on businesses and organizations to prevent the spread of Coronavirus Disease (COVID-19) in the community. These efforts are an attempt to curb the recent increase in COVID-19 cases that have been seen both locally and across the State of California and will complement extensive ongoing efforts to obtain voluntary compliance through education and guidance.

Over the past four weeks, Yolo County has seen a significant increase in cases with the total number of confirmed cases in the County growing by more than 200 percent. Initially, the majority of these new cases occurred due to family gatherings. However, cases have also begun to arise amongst a cross section of industries including workplaces, education, social gatherings, and religious services. These increases display a shortcoming in implementing mandated

health and safety measures, such as wearing face coverings and social distancing.

In an effort to protect the health of the community and curtail the increase in cases, the County in collaboration with the cities of Davis, West Sacramento, Winters, and Woodland have developed an enforcement strategy to ensure businesses and organizations comply with state and local health orders. Prior to the use of any enforcement measures, efforts will typically focus on providing education, resources and/or guidance to that business or organization on compliance. If violations or non-compliance continue, the following enforcement actions may be taken:

Public Communication: Provide information to the public identifying any organization or business in non-com-

**Urgency Ordinance/Fines:** Enforceable by the County. The County's Board of Supervisors adopted an urgency ordinance on July 7 allowing for the enforcement of penalties for violating Public Health Orders ranging from \$25 -\$500 for non-commercial violators and from \$250 - \$10,000 for commercial violators. The ordinance is enforceable by the County within the cities, which may also adopt similar ordinances to expand the enforcement options available to their staff.

Misdemeanors: May be issued by city police departments or Sheriff's Office with prosecution by the District

Business Closure: Enforceable by County Counsel or the local Health Officer.

Civil Action: Enforceable by County Counsel or City Attorney and may include seeking court orders to shut non-compliant businesses down until compliance is as-

"The recent rapid spike in numbers of individuals testing positive for COVID-19 necessitates an increase in enforcement," said Chair of the Yolo County Board of Supervisors Gary Sandy. "These efforts will primarily focus on those that fail to take appropriate measures to protect the public. It is in everyone's interest to promote a safe and healthy environment. Fortunately, the majority of our Yolo County community has been supportive, aware and engaged. We are grateful for their support and cooperation."

It is anticipated that, as has been the case over the past few months, local government education efforts will work in the vast majority of cases and that enforcement will typically proceed only when violations are severe or ongoing despite repeated counseling efforts. The County also continues to emphasize that all members of the community are responsible for adhering to the rules or guidelines that are set by these entities as well as practicing social distancing and wearing a face covering. Everyone has a role to play in keeping our communities safe and healthy, particularly to protect people who are considered high risk or have compromised immune systems.

# Matsui sends six bills to the House floor

Last week, the House Energy and Commerce Committee unanimously passed six bills authored by Congresswoman Doris Matsui (D-CA). In total, the Committee voted favorably to report 30 bipartisan bills to the full House of Representatives, including 17 bills aimed at improving quality and access to health care. These bills are now ready to be considered on the House floor.

"As we face the uncertainty of this time, we are continuing to take meaningful steps to advance legislation that will have an immense impact for Sacramento and across the nation," said Congresswoman Matsui. "Mv six bills passed by the Committee today deliver concrete solutions – from our communications networks and emergency preparedness, to improving telehealth access, mental health care and the safety of prescription drug and food labels. I am committed to working on the issues that will lead to significant, positive change for Sacramento, and I urge the full House to vote on these important bills immediately."

The six bills are: The Telemental Health **Expansion Act:** This legislation would permanently include a patient's home as an eligible originating site for mental health services delivered via telehealth and remove Medicare's geographic restrictions for such services, enabling providers to be reimbursed by Medicare for mental health services delivered via telehealth in urban areas like Sacramento and in the patient's home.

The Suicide Prevention **Act:** This legislation establishes two grant programs to enhance the data collection of suicide attempts and self-harm, and to provide a better training program for hospital emergency room staff to implement suicide prevention strategies, screen at-risk patients, and refer patients to appropriate follow-up care.

The Food Allergy Safety, Treatment, Education, and Research (FASTER) Act: This legislation requires sesame be added to the list of allergens that the Food and Drug Administration (FDA) requires be labeled by name in packaged foods. The FASTER Act is the first meaningful food allergy legislation at the federal level in more than a decade and would improve the lives of mil-

The Making Objective Drug Evidence Revisions for New (MODERN) Labeling Act: This legislation allows the U.S. Food and Drug Administration (FDA) to update outdat-

lions of Americans.

ed generic drug labels to reflect new clinical information that would benefit how a provider prescribes or patient uses a prescription drug.

**Emergency Reporting** Act: As we prepare for wildfire season, this bill would require the Federal Communications Commission (FCC) to conduct field hearings, reporting, and policy recommendations in order to help ensure that all disasters, regardless of their location, receive the necessary time and resources. Additionally, the Emergency Reporting Act would

improve standards that require mobile carriers to report network outages to 911 centers.

USA Telecommunications Act: This legislation would authorize up to \$750 million for a grant program administered by the U.S. Department of Commerce, in consultation with the FCC and other federal agencies, to promote and accelerate deployment and use of open interfaced, standards-based, and interoperable 5G networks throughout the United States.
