Local to release never-before-heard album of WWII-era big band music

The News-Ledger recently caught up with local Jason Burt. Jason's grandfather was longtime West Sac resident Richard Burt. Richard was a Juilliard-trained trumpet player who taught music in the Washington Unified School District from the late 1950s-1984.

After Richard and his wife passed away in recent years, the Burt family discovered a treasured part of their family history they had believed to be lost: a 75-year-old recording of big band music created by Richard's Air Force Band during their WWII campaign.

Now Jason, a middle school history teacher, is working to share his grandfather's long-lost music with the world. We interviewed him to get the full story on the

Q: We understand you're working on releasing an album of music that was created 75 years ago. Tell us the history of this music and how you came to be involved with this proj-

A: The music was created by the 746 th FEAF (Far East Air Force) Band at Fort McKinley, an Army Air Force Head Quarters base in Manila, Philippines. This 20-piece orchestra played together throughout the Philippines campaign while the United States was retaking the Philippines from the Japanese. They played shows with the USO (United Service Organizations) to entertain front line troops and make them feel a little closer to home in the middle of the war.

Prior to the band heading home, they recorded themselves playing these popular big band songs. My grandpa, Richard Burt, was the lead trumpet player of the band. He asked his commanding officer if he could have the recordings. The commanding officer gave permission for him to take the recordings and my grandpa brought them back home.

Grandpa lost track of the records at some point as he got older. He thought he had lost them in the 1980s. However, after my grandparents passed, we found the recordings while cleaning out their attic. My dad and his brothers gave me all of my grandpa's military items, including the recordings, because I am a history teacher and had done extensive family history research on my grandpa's military ser-

After finding out the records still played mu-

sic, I began to formulate ideas about how I could honor my grandpa and the band members of whom he was so fond. They played such an important role over-

seas with morale during WWII, yet civilians don't hear much about them.

I decided to make their music available to

On Monday, June 15, Yolo County Library began offering curbside pickup for library cardholders since branches are still closed based on the State of California's Resilience Roadmap. The following procedures allow cardholders to easily use the Library's curbside during transactions. pickup service:

Request items in advance through the library's online catalog.

Wait for an email or phone notification that the materials are available for

For people driving, text "Here" to the phone number posted after parking in the designated curbside pickup

For those on bikes or walking, look for the walk/bike curbside pickup area and text the number on the sign when it is your turn.

Receive a text reply from staff for reservation name and space number.

Materials are checked out and delivered for contactless pickup.

Face coverings must be worn and physical distancing must be observed

"Our new contactless Curbside Service makes it possible for us to distribute books, WIFI hotspots, and other items and protect the health and safety of our customers and staff. State testing site in West Sacramento extended to July 3

Coronavirus by OptumServe in conjunction with the State of California, will be extended an additional

week to Friday, July 3. The site has been located in West Sacramento since June 2 and, with this extension to July 3, will be in West Sacramento a total of five weeks. The Optum-Serve site was previously in Woodland for four

extended weeks of testing, from to June 27, the no-cost May 5 – 30. As of June Disease 22, a total of 3,507 res-(COVID-19) testing site idents have been tested in West Sacramento, run through OptumServe in Yolo County, with 1,856 people being tested in Woodland and 1,651 in West Sacramento. The County is working on extending the Optum-Serve testing site in Yolo County and moving the location based on accessibility and health data.

Transfer of **Yolo Habitat** Conservancy Administration

After unanimous votes by both the County Board of Supervisors and the Yolo County Habitat Conservancy Board, there will be a transfer of administrative responsibility from the Conservancy's Interim Executive Director to the Office of the County Administrator, effective July 1, 2020. The primary reason for the shift in Conservancy administration is due mainly to a lack of appropriate funding for the current administrative structure and the need to reduce administrative costs. Secondarily, the administrative support the County will provide to the fledgling Conservancy will allow for greater flexibility and growth opportunity throughout the organization. The oversight role of the current Conservancy Board will remain.

Going forward, Alexander Tengolics with the County Administrator's Office will oversee the day-to-day Conservancy activities and Charlie Tschudin (a transfer from the County's Community Development Department) will lead all Conservancy permitting work. In an effort to ensure continuity of existing permitting and conservation easement work, the Conservancy Board renewed all existing consultant contracts for the next fiscal year. Conservancy staff will continue to work toward meeting the existing board-adopted goals and objectives related to plan implementation. It is our sincere desire that the

West Sacramento Man Charged with Attempted Carjacking After Being Released as a Result of California Judicial Council's Statewide Emergency "0" Bail Schedule

West Sacramento man Vladimir Moscaliuc, age 32, has been charged with attempted carjacking by the Yolo County District Attorney's Office after being arrested by Woodland police on May 5, 2020. Moscaliuc is currently being supervised on Post Release Community Supervision (PCRS) by the Yolo County Probation Department after serving a term in State Prison. He was arrested on April 29, 2020 for violating his conditions of PCRS. Moscaliuc was released that same day as a result of California Judicial Council's Statewide Emergency "0" Bail Schedule. The "0" Bail Schedule became effective April 13, 2020 in response to the COVID-19 pandemic.

Moscaliuc is currently being held at the Yolo County jail. Moscalius was arraigned on the new charge and the PCRS violation on May 7. The court set bail at \$20,000 and set the matter for Preliminary Hearing on May 28 in Department 14 of the Yolo County Superior Court.

Beware of Medical Scams During COVID-19

While many people have rallied to help others in response to COVID-19, there are others trying to make money off of the fear and uncertainty surrounding it. The Federal Trade Commission and Federal Drug Administration have issued warning letters to several companies which have stated that they are able to treat or prevent COVID-19. These companies are marketing products such as aromatherapy, teas, colloid silver, essential oils, and vaccines and medicines allegedly under FDA testing.

There are no known products to treat, vaccinate, or prevent COVID-19. No at-home tests for COVID-19 exist. Do not give any money or insurance information to anyone claiming otherwise. Other states have also had reports of fake drive through "testing" where fake test kits were sold for over \$200 each. In addition to losing your money for something that will not work, it is extremely dangerous to use any untested medical products. In general, you should not purchase medical products through ads, calls, texts, or emails. Only

make purchases on the advice of

your doctor, and then only through

trusted retailers like a local pharmacy. Do not participate in any drive through COVID-19 testing unless it is backed by a legitimate company or advised by your doc-

The best way to avoid contracting or spreading COVID-19 is to follow the guidelines set by public health officials. Wash your hands often for at least 20 seconds. If soap isn't readily available, cover your hands with hand sanitizer and rub them until they feel dry. Clean and disinfect frequently used surfaces. Stay home as much as possible, and avoid contact with other people. Wear a cloth face covering or mask whenever you go out in public.

You can also take basic steps to avoid being scammed. The most effective prevention is to not make contact with scammers in the first place. Do not pick up or respond to calls, emails, or text messages from unknown numbers. It can be more tempting than ever to pick up the phone while home alone. Instead, if you want to reach out while sheltering in place, there are other ways to do so safely. To access local resources while sheltering in place, contact 211. If you are feeling stressed about the pandemic, you can call the Federal Disaster Distress Helpline at 1-800-985-5990. For general emotional support, call the California Peer-Run Warm-line at 1-855-845-7415. Seniors can call the Yolo Healthy Aging Alliance at 530-757-5583 to be matched up with someone to chat with daily.

If someone contacts you about a COVID-19 related product, do not give them any money or personal information. If the caller says not to tell anyone, or that you will miss your opportunity if you don't act quickly, that is a "red flag" that you are being scammed and you should hang up immediately. If you have been contacted through E-Mail or social media, immediately stop replying, print out all conversations and contact your local authorities. You may call the Yolo County District Attorney's Office Fraud Hotline at 855-4-YOLO-DA to get a second opinion, or to report a scam call. While there are people looking to take advantage of others in this uncertain time, taking precautions and being aware of recent scams can protect you and others from being the next victim.

distance to the building. Optum-Serve will be able to test up to 135 people a day with test results avail-

Roadkill Declines as COVID-19 Continues

Thousands of Large Animals Spared Under Shelter in Place, Finds Report on Three States

Fewer wild animals, including threatened mountain lions, are becoming roadkill during shelter-in-place orders, finds a study on three states from the University of California, Davis.

Using traffic and collision data collected from California, Idaho and Maine, the researchers found that wildlife-vehicle conflict has declined by 21-56 percent from early March to mid-April, following government stay-at-home orders.

This respite, if it continued, could amount to about 5,700 to 13,000 fewer large mammals killed each year in those states alone, and 50 fewer mountain lion deaths per year in California.

The report, published today on the UC Davis Road Ecology Center website, is the first evidence that wildlife-vehicle conflict decreased along with reduced travel during the COVID-19 response.

"There is a statistically significant decline in wildlife deaths on highways in all three states following reductions in traffic this spring," said report author Fraser Shilling, director of the UC Davis Road Ecology Center. "This has not been the case for any of the previous five years for these three states. If anything, there is usually an increase in spring."

Traffic on all roads — not just state highways — in California decreased 71 percent during the study period.

Before stay-at-home orders, 8.4 large wild animals per day were killed by vehicles in California. After the order, the number fell 21 percent to 6.6 animals.

Mountain lion deaths in particular showed large decreases. At a time when the state is considering permanent legal protection for cougars throughout California, 56 percent fewer mountain lions were killed between the 10 weeks before stayat-home orders compared to the 10 weeks ity on roads put them at after.

"The reduction in numbers of wildlife killed is surprising, and is a silver lining for both wildlife and people at this difficult time," said Winston Vickers, who directs the California Mountain Lion Project, a program of the Karen C. Drayer Wildlife Health Center in the UC Davis School of Veterinary Medicine. "For Southern California mountain lions, even one lion making it across a road instead of being killed can be very significant for populations like the ones in the Santa Monica or Santa Ana mountain ranges."

In April, the state granted temporary protective status to mountain lions in Southern Cougars California. in the Santa Ana and Santa Monica mountains are isolated from other populations by freeways. The resulting low genetic diversity combined with mortal-

risk of local extinction, according to UC Davis and other research. Measures underway to reconnect these populations of lions with others in the state include underpasses, wildlife fencing and proposed land bridges across busy freeways.

Traffic on all roads in Idaho decreased up to 63 percent during the study period.

Before stay-at-home orders, 8.7 large wild animals were killed daily by vehicles in Idaho. After the order, the number fell 38 percent to 5.4 animals per

In Maine, travel on all roads decreased up to 73 percent during the study period.

Before shelter-inplace directives, 15.2 large wild animals were killed daily on Maine roads. After the order, the number was reduced by nearly half, to 8.4 animals.

Tip of the iceberg, but traffic returning

As more restrictions lift, traffic is on the rise again. The states analyzed in the report have experienced a two- to three-fold increase in traffic in recent weeks, and traffic is now about half of pre-order levels. Shilling will continue to watch closely for related impacts to wildlife.

"Given the five- to 10-fold under-reporting of large animals involved in collisions with vehicles and the lack of systematic reporting of smaller animals killed on roads, the positive impacts we report are likely to be just the tip of the iceberg of reduced deaths of wildlife on U.S. roads and highways," wrote Shilling in the report.

This is the fourth special report for the Road Ecology Center regarding the traffic-related impacts of shelter-in-place ders. Additional recent reports cover the impacts of COVID-19 mitigation on traffic accidents, greenhouse

tax revenues.

The report was co-authored by David Waetjen in the UC Davis Department of Environmental Science and Policy, with

Now, before you find me shallow, let me explain. I'd been working since I was 14 years old. My first job was stacking baskets at a swimming pool. Before I was out of high school, I waitressed part time at Big Boy; full time while taking college classes at the local branch. One semester, and then I left for college. My folks told me what the deal would be. They paid my tuition and my health insurance. Everything else was me.

And so, I waitressed at night, went to school by day. When the restaurant closed, I worked other low paying jobs split expenses with three roommates. Meantime, the campus radio station took me on as an announcer. No pay, but I liked it.

As an upper classman, I could take TV production. Our final project: a 10 minute newscast. The professor said we could use the AP wire. Instead, I went out and found some stories. Took photos. Wrote, voiced and anchored everything. (My anchoring, stiff and scared, was very bad.) The show itself was good. Turned out none of the other students thought to do original reporting. Just ripped stuff from the AP wire. The university president asked to see a newscast. The professor showed him mine. "OK," I thought. "I have an aptitude. I can become a voice for the voiceless. Help kids and animals."

With the goal of becoming an on-air reporter, I took a job as newsroom secretary at the Cleveland station owned by NBC, where I weaseled my way into several stories. The investigative reporter told his buddy, a news director in Scranton, about me. "No experience," he said, "but a lot of determination." His buddy hired me. I packed everything I owned into mom's station wagon, including Rags, my dog. In Scranton, I anchored, produced, reported and won a first place Community Service AP award. In response to my series on child abuse, Pennsylvania legislators enacted what would be the state's first Child Abuse Reporting Ho-

By the time I was 28 I'd won double Emmys in Atlanta and was working in Chicago.

In Chicago, there were more awards. The logical next step was netcorrespondent. There had been some interest at ABC. But I didn't want that. A network correspondent, I knew, lived out of a prepacked suitcase. 'Home'

was whichever plane the network put you on. So, when Denver told me I could self-assign and anchor, I went to Denver. And learned I didn't want to anchor, either. Lousy hours (morning show anchors have to be at work by 4 a.m. 'Prime time' is a night job. yuk). self-assign-

ing – that was nice. My videographer and I won bronze medals at the International Film & TV Festival of New York for our series on children of alcoholics. ABC's 20-20 picked up my research for 'All Bottled Up' and did its own documentary. Nationwide, viewers learned why kids who blame themselves for a parent's drinking need groups like Ala-tots and Ala-teens.

Meantime, biologically, my clock was ticking. Fixing fertility problems became my focus. Saving the world would have to wait. I wanted to be a

No siblings for Mike, though. Secondary infertility. Watching him

sleep, I'd whisper, "You're my miracle boy. Just wait. God has big plans for

With an inheritance from my parents, I was able to stay home with Mike through his toddler years and grade school. My folks had wanted his childhood to include their farm, but had made no provision in their wills. So, I bought

From there, I reinvented myself as a small town print (newspaper) journalist. Started saving the world again with my stories but also served on the high school's parent advisory council, attended all Mike's hockey games, and helped out with music boosters. Important to me: he never came home to an empty

And then, my inheritance ran out.

My job didn't pay enough to support the farm, and so, I sold it. finished school in California, played hockey and left for college. That was 17

years ago. Today, for both of us, California's home.

So, you see, I can relate to workers eager to leave expensive cities to work from home in bucolic less expensive settings, without having to sacrifice their jobs.

My last California newspaper didn't pay much, but, again, I could do most of it at home. It was my dream job. Used all my skills plus rarely second guessed me. Grateful, I worked far more hours than I was paid for, and the product never suffered.

Employees appreciate trust. Employers appreciate employees who are trustworthy. This 'new normal' of work-fromhome people living where they want should prove win-win-win: for employers, families and the family dog.

the public for purchase. Initially, I emailed the National WWII Museum in New Orleans to gauge their interest in an item like this. I received a response that said they were very interested, but they do not produce music. However, they told me they would love to hear and see a finished

As I thought more about the project, it evolved into something much bigger. I wondered, "How can a band of "amateur" musicians compete with the likes of the Glen Millers and Duke Ellingtons of the time period - let alone modern music? body would hear their story or their music if a CD was just placed on a shelf."

Then the idea was born to connect with the USO, who continues to serves the same role as they did during WWII, making Veterans overseas feel closer to home. [The United Service Organizations is a nonprofit that provides live entertainment, such as comedians, actors and musicians, social facilities, and other programs to members of the United States Armed Forces and their families.] Thus, my campaign to make regular everyday soldiers become platinum artists was born.

Q: You mentioned you're working with 4-time Grammy Award-winning sound engineers to digitalize, clean up, and master the album. How did you connect with

A: It was no accident that I connected with a Grammy-winning sound engineer. I needed somebody who was the best in their field to take on something like this because of the age of the

I researched Grammy winners for Best Historical Album, particularly those who won for Jazz albums. I began to send out emails to multiple winners, telling them about the

I heard back from four within a week, all excited about the prospect of working on the project. Three of the sound engineers emailed me back, but one called – Lurssen Mastering. Gavin Lurssen and Reuben Cohen were so excited at the prospect of doing the work that they were the obvious choice. The idea of working on something that old and making it modern really appealed to their love of their pro-

Since their studio is down in Burbank, we are waiting for Covid restrictions to ease so that the same time and watch them work.

Q: What are your goals in releasing this album? What do you hope to accomplish?

A: I have a handful of goals with this project.

1. I hope to pay tribute to my grandpa and his band mates by teaching people the role of musicians during World War II.



Davis Farmers Market open on July 4

While the Fourth of July won't have the traditional fireworks, the Davis Farmers will be open, featuring all of the flavors that make the holiday memorable.

On July 4, the market is open for its regular Saturday hours – 8 a.m. to 1 p.m. – in Central Park, 301 C St., in Davis.

Vendors will have all of the components for the perfect household barbecue, including farmfresh corn, watermelon, tomatoes, meats, fish, breads and cookies and cheeses. Come stock up on produce, eggs, beans, rice, nuts, dried fruits and flowers. Fruit in season includes berries, melons and stone fruit. There are tons of veggies at the market, like cucumbers, summer squash, eggplants, Brussels sprouts and avocados.

There are also tortillas, pizza crust, pita breads and dips, baked goods, olive oil, jams, honey, kettle corn, almond milk and almond butter, fresh apple juice, juice pops, coffee, tamales, hot dogs and Indian food.

The Davis Farmers Market remains open as an essential grocery provider. The market has reorganized vendor booth setups and added significant spacing between sellers. Masks are required. Sellers wear gloves and masks, and typically select the produce for the customer.

The Washington Post called farmers markets "fresh, healthy and safe" during COVID-19. The June 18 story said, "Farmers markets can be a safer space to shop ... due to their outdoor locations, and your food will pass through fewer hands, too, since markets are part of a shortened supply chain."

Davis is known for its farmers markets, especially its flagship one in Central Park. Its Saturday market runs year-round from 8 a.m. to 1 p.m. Its Wednesday market is 3 to 6 p.m. through March 2021. The summer Picnic in the Park and UC Davis Farmers Market are on hold during the pandemic. Sutter Davis Hospital's Farmers Market is 10 a.m. to 1 p.m. on Thursdays through October, at the hospital entrance.


