Individuals who are not low-income are urged to contact a for-profit grocery delivery service, so that Yolo Food Bank can prioritize the needs of low-income residents during this time of crisis.

"The Coronavirus social distancing measures being implemented in Yolo County and elsewhere are creating unforeseen barriers preventing seniors, residents with underlying health conditions, and other vulnerable popula-

tions from meeting their basic needs," stated Yolo Food Bank Executive Director Michael Bisch. "California's food banks are among the first responders to 'mitigating' the Coronavirus public health mitigation measures. Yolo Food Bank has been mobilizing since last week to provide food delivery services for these residents disproportionately impacted by social distancing measures."

All other individuals who regularly access food via Yolo Food Bank's more than 100 ongoing public distributions each month throughout the county should continue to visit these locations. 

Advised by his doctor not to fly, a neighbor had to cancel a planned trip to Arizona. His doctor also told him to quit post-operative workouts in the Mercy Hospital gym. Too much risk. Yes, the neighbor is 79, and a recovering cancer and cardiac patient. But he thought a short, domestic flight would be okay. He thought his medically supervised workouts were safe. He hadn't factored in the new phrase that changes everything for millions: co-morbidity (two or more illnesses occurring at once in the same person). My neighbor has vulnerabilities that double the potentially lethal

punch of the Corona Virus pan-

I have asthma, well controlled, but I factored it in with locality (Sacramento was one of the three chief hot spots on the CDC Virus Map), age (in the danger zone) and communicability risk (high), and called the Kaiser Advice service. It was recommended I self-quarantine until the government got a handle on this. Well, hell. That's a long quarantine sentence. The problem is that the government's tardy and inadequate response had been further retarded by the president, whose mindless posturing would be funny were it not so deadly. First he said, at a Feb. 28 rally in Charleston, South Carolina, "This is their (the Democrats) new hoax."

A hoax. Well, nobody wants to catch this hoax that has already killed thousands and daily kills more. I don't want the highly communicable "hoax" to stalk family and loved ones. Yolo County Public Health is recommending the cancellation of non-essential programs to facilitate social distancing, which will help prevent further spread of COVID-19 in our community.


Accordingly, the Library is canceling all non-essential programs, classes and events, including community use of meeting rooms, through March 31.







# **Elections Office Canvass Process** Update

The Yolo County Elections Office began the canvass process for the 2020 Presidential Primary Election on March 5, 2020 to ensure every eligible ballot is counted accurately. The time allowed to complete the canvass for this election is thirty days

The Elections Office conducted a public manual tally of 1% of the Election Night precinct results that began on Friday March 6th and was completed on March 10th. The counts balanced and there were no inconsistencies.

On Election Night in Yolo County, 32,266 ballots were processed and tallied for the 2020 Presidential Primary Election. This figure included Vote by Mail ballots that were received through March 1st and precinct ballots cast at the polling locations.

During the canvass period the Elections Office reconciles all provisional and conditional ballots, in addition to all the Vote by Mail ballots that were submitted just prior to Election Day, on Election Day at polling or satellite locations or postmarked on Election Day and received by the Elections Office within three days (by March 6th). During the canvass period, Vote by Mail ballots that were returned to other counties are also forwarded to their respective counties. To give a context, Yolo County has forward Vote by Mail ballots to 40 other counties over the last few days. of Tuesday, March 10, 2020 at 2:30 p.m., the grand total of ballots remaining to process in-

creased by 7,155 above

initial post-election figures for a new total of 32,024 ballots to be processed during the canvass period. A more detailed breakdown of the ballots being processed is provided below:

# Curbing U.S. population growth would fight climate change

Millions of young Americans want to shrink their carbon footprints.

The best way for them to do so? Limit their family size. Having one fewer child can be up to 30 times more effective at cutting greenhouse gas emissions than the nextbest action, "living car-free," according to a series of recent studies from the American Association for the Advancement of Science, the "Drawdown Project," and other academic papers.

These studies, coupled with heightening anxiety over climate change, have even spawned a global #Birthstrike move-Across ment. world, young people are realizing that the planet simply can't sustain endless population growth.

However, these reports, as well as #Birthstrike members themselves, often overlook the science behind who actually emits the most greenhouse gases -- and therefore whose population growth needs to be curbed.

Point blank: Citizens in developed countries, especially here in the United States, emit dramatically more greenhouse gases than citizens in developing countries. The Union

of Concerned Scien- house gas emissions tists reports that the average American produces five times more greenhouse gases than the average Mexican and ten times more than the average person in India.

This excessive consumption -- and the rampant materialism that fuels it -- is depleting our natural resources. Household consumption contributes to "more than 60% of global greenhouse gas emissions and between 50% and 80% of total land, material, and water use," according to a recent study published in the Journal of Industrial Ecology. A report by the Sierra Club indicates the average American consumes 35 times more natural resources than the average person in India and 53 times more resources than the average per-

son in China. And the Center for Global Energy Policy at Columbia University published a report indicating that population growth necessitates reliance on high greenhouse gas-emitting energy sources for new construction of buildings, roads, and other infrastructure -all of which is far more intensive in the United States and other developed countries.

Simply put, if we want to curb greenand stop depleting our natural resources, we should focus on limiting population growth in industrialized countries, especially the United States.

America is adding people at a rapid pace. The population has grown by 72 million people since 1965, according to Pew Research. And we'll add another 100 million people by the year 2065, almost solely due to immigration.

Nearly all grants come countries that have far lower greenhouse emissions rates. But once they arrive here, most adopt the prevailing American culture of ravenous energy consumption and consumerism, causing greenhouse gas emissions to soar.

It's time we look in the mirror and quit ignoring the devastating, planet-destroying impacts of America's population growth.







vagaries in the market the prior year: Specifically, October.

When my parents died and left me some money - it was largely invested in blocks of stock. Dad made most of his money in the stock market, investing in companies he knew well from his decades in the auto parts business.

Since I knew nothing about those companies or investing, I figured I better educate myself about stocks and bonds. The following may interest those of you tempted to try the market in these uncertain times.

When I made that decision, I had enough money to buy stocks in quantities of no less than 100 shares. A stock broker helped me learn the ropes. I also signed up for a seminar on bonds. Went to a 3-day "Workshop for the Wealth Adjusted" where I met people who had last names like Kellogg and Honeywell. Read a small book titled "The ABZ's (Z for Zero Coupon Bonds) of Money & Finance." (It's a good one if you need to learn the basics.) Subscribed to the Wall Street Journal. Barron's. Money Magazine. The Kiplinger Report (dad's favorite). Standard and Poor's "Outlook" (which I liked a lot, but it's pretty pricey). Oth-

I also immersed myself in investing-related cable TV shows. I listened to the show, but watched the stock ticker crawling across the bottom of my screen. By then, I had a portfolio of stocks, mutual funds, and so on. The ticker is symbols that are shorthand for assorted stocks. I memorized those of stocks I held, and also those I was watching.

For hours I'd watch the ticker for slight changes in a share price. Felt pretty comfortable buying Berkshire-Hathaway. Figured if legendary investor Warren Buffet (founder of Berkshire-Hathaway – a sort of mutual fund for rich people) was betting on a company, that was good enough for me. On the opposite end of the 'risk' spectrum, I liked Gilead Sciences – a California company that, today, is working on getting FDA approval for its Covid-19 vaccine. (Important to note: Other companies are, too. Who gets there first is the gamble.)

The key to 'reading' the market, I decided, was paying close attention to the news – such as rumbles that the fed would change the interest rate. And, at that time, NAFTA North American Free Trade Agreement).

By the time Mexico

Fund was trading on the Nasdaq (American Stock Exchange: www. nasdaq.com), I an on the 'fast desk' at Charles Schwab. 'Fast desk' traders made (or lost) money by moving quickly on changes in a share's price. Mexico Fund was invested in companies like Telefonos de Mexico. When I sold my shares in a 'block' (all of it at once), I made \$30,000, after fees and taxes. Thank you, NAFTA! With the money, I funded an investment account for my minor son. And used money in it to pay for ADHD specialists, physical therapy and other activities to improve his fine motor skills; camps, preschool, and technology such as computer games. Whatever experts told me would help him compensate for deficits related to being nearly stillborn. An investment in his future.

When Mike was 13 or so, I went back to work in journalism and hired an investment adviser, because I knew day trading would take more attention than I could give it with a full

The investment adviser insisted I couldn't afford to hold a pricey stock like Berkshire Hathaway. I'd paid about \$8,000 per share for four shares. I reluctantly let him gut and reinvest much of my carefully constructed portfolio. (I stopped following Berkshire-Hathaway when it was selling for \$55,000 a share. Doing the math made me too depressed.). The investment adviser said he could feel my 'antipathy'. We parted compa-

Not all my money was in the market, though. Some was wrapped up in real estate. I bought properties outright. Remodeled, updated and then we lived in them. Mortgage free. Made money when I sold them.

The last property I purchased was the farm. A neighboring farmer paid me per acre to farm my fields. Still was making money in the market. And then 9-11 knocked the stuffing out of my portfolio. (I'd cashed out Gilead to try to save the farm. Made money. But, if I'd held onto it, would

have made a whole lot more.) Finally, with animals to feed and a teenager playing travel hockey, I took out two home equity lines of credit (contrary to my Depression-era dad's advice: "If you can't pay cash, you don't need

In 2003, I faced facts. Liquidate the farm, or lose it to foreclosure. Surveyed and subdivided it. Did OK. A family bought each of two creek-front parcels. I like knowing a new crop of kids grew up making forts in the woods.

It's been nearly 20 years since I was a day trader. I've learned, that which goes up definitely will come down. Today, I'm in low income senior housing. I know my pension's taking a hit May first. and I'll have to 'pay back' - all at once – the amount I've been 'overpaid' since January 1. Am I worried? Oh, you bet.

Savvy investors I've known say this:

The casino's always open.

"I got out too soon." So, about this virus. WHO (World The Health Organization) has declared it a pandemic. (Its rapid spread now spans the globe.) Do the resulting wild swings in the stock market seem like a chance to make a fortune? Not unless vou can afford to lose it. If in doubt, don't. Before you roll the dice, might wait for the world economy to stabilize.
