Yolo County reports first confirmed case of COVID-19

Last week, public health experts at the Yolo County Health and Human Services Agency (HHSA) received confirmation that a Yolo County resident has tested positive for Coronavirus Disease 2019 (COVID-19). This is the first case in Yolo County.

This individual is an older female with underlying health conditions. She is currently hospitalized and is improving. From initial interviews, she acquired the disease through community transmission.

"Given the rapid spread of COVID-19 around the world, I am not surprised that the virus is in our county", stated Yolo County Public Health Officer, Dr. Ron Chapman. "Unfortunately, there is a lot of misinformation driving fear in our communities. We will continue to provide COVID-19 education, support, and advice to the community while using appropriate measures to protect the public's health."

manage this confirmed case and has been partnering with the Centers for Disease Control and Prevention (CDC), the California Department of Public Health, local jurisdictions and health care providers.

HHSA has already stepped up disease-tracking capabilities and staff are working with local healthcare providers to quickly identify potential cases. HHSA is following established disease investigation protocols to ensure that any affected persons and their close personal contacts are monitored as necessary. HHSA will continue to implement public health strategies, provide public and professional education, and collaborate with local and State partners to control the spread of COVID-19.

Yolo County has been continually evaluating the situation and will be issuing two proclamations, a local health emergency and a local emergency.

Yolo County is prepared to The local health emergency proclamation may open additional resources while the local emergency proclamation may open funding, both will provide tools for the County to effectively manage the situation.

> The CDC recommends individuals and families follow everyday preventive measures to limit the spread of respiratory diseases such as COVID-19:

> Stay home when you are sick with respiratory disease symptoms. Cover coughs and sneezes with a tissue, then throw it in the trash can.

Wash hands often with soap and water for at least 20 seconds; especially after going to the bathroom; before eating; and after blowing your nose, coughing, or sneezing.

If soap and water are not readily available, use an alcohol-based hand sanitizer with 60% to 95% alcohol.

Routinely clean frequently touched surfaces and objects.

"This is obviously a challenging situation which makes it all the more important to remain calm, practice the public health guidelines and rely only on factual information from trusted medical sources," said Yolo County Board of Supervisors Chair Gary Sandy.

If you are concerned about your current health, you should contact your Primary Care Provider directly for additional guidance. People without health insurance can apply for Medi-Cal health care coverage by calling 1-866-226-5415. Healthy people do not need to use a face mask to protect themselves from respiratory illnesses like COVID-19.

Yolo Bypass flood system tour announced

The Sacramento River, between Davis and Sacramento, historically has experienced major floods, turning the Sacramento Valley into an inland sea of floodwaters. The City of Sacramento, as well as many other cities and farms in the Sacramento Valley, are now protected from this flooding by the Yolo Bypass and other parts of an extensive flood control system.

Join Marc Hoshovsky to explore several key sites in the Yolo Basin to learn how this flood control system works. The group will carpool to the Fremont Weir, located at the floodwater entrance of the Yolo Bypass, and the Sacramento Weir, the last diversion of the Sacramento River upstream of Sacramento.



Along the way, participants will learn about the history of flooding in the area, how local people either adapted

or fought back against the flow, and how the present-day flood control system was developed. Participants will enjoy lunch at the Yolo Bypass Wildlife Headquarters in Davis. After lunch, the group will visit the floodway along

lower Putah Creek and areas south where the Yolo Bypass waters flow



THIS 'n' THAT

A Sense of Wonder

Breast cancer. Some months back, my friend, who has it, faced a tough decision: double mastectomy or chemotherapy. Opted for chemo because she didn't want to lose the muscle in her chest. She's a union longshoreman at the Port of West Sacramento. It pays good money – and requires heavy lifting. The chemo, though, is rugged. She holds out hope a less brutal option will come along.

I hope so, too, but, recently, the American Cancer Society said some cancers today do

have better therapies. Breast cancer isn't one of them. What researchers have found is that some people carry a 'breast cancer gene.' Those who do sometimes have prophylactic mastectomies, for fear they might get breast cancer.

In my family, I can't think of anyone, through three generations, who's been diagnosed with breast cancer. No one. Until me. Last year, the radiologist who read my MRI noted "spiculations" in my left breast. Since I'd never heard of spiculations, I was more concerned about the lesions in my kidneys and small lumps forming on my cervix. "Probably cysts," said the report. "OK," I thought, "Let's go with that," and forgot all about the spiculations.

In reviewing the radiologist's report, my primary doc explained

have better therapies. the spiculations. She told me, "Not to scare you, them. What researchers but 'spiculations' means

More tests followed. Yep. Cancer. I saw specialists. It came down to this: Lose a third of my left breast, or take Tamoxifen (a chemo drug) for the next five

I told one of these specialists that, at my age (70 at the time), combined with multiple other chronic medical conditions and aging's risks, such as, in my case, Alzheimer's, I had zero interest in hopping on the cancer hamster wheel. I know cancer. I've lost close friends to breast cancer. I know chemo. And heart scans (to check for damage from the chemo. And a line in your chest to deliver chemo in a cancer's later

stages).

I met my friend, Delores, when she was a volunteer Bald Eagle counter to, she said, keep her mind off her breast cancer. I was doing a story on her eagle counting after she did a presentation for the Optimists Club, of which, at that time, I was a member.

I asked if she'd be interested in doing a story with me. A few days later, we met at one of the nest sites she was watching with a scope. As it turned out, she lived not far from me.

In my basement, we reviewed, together, the photos I had taken. She explained the headscarf she was wearing covered the hair loss from her chemo. She had breast cancer and was enduring yet another round of chemo.

Three times, her cancer was in remission. Three times, it came back. The 'Stage 4' and final time, it spread to her liver, bones and brain. (Here's something I didn't know until she told me. When a cancer metastasizes to another organ in your body, it's still, for instance, breast cancer.) Delores worried most about her husband. How would Bob get along

without her? They were long-time family farmers. Partners in every way. Bob said, "Cancer is big business." Her treatment, he said, had been "13 years of hell."

My friend, Charlotte,

an RN with breast cancer, intentionally discontinued her chemo in advance of a longplanned trip to Ireland. She wanted to feel good, not sick, on this dream vacation. Not long after she returned, her only daughter had a baby her first child, after years of trying. Charlotte resumed her chemo. The cancer's hold was strong. Learning she was terminal, Charlotte gazed at the baby in her arms and said, "I wish I'd had more time with you." Three days later, Charlotte died.

Both Charlotte and Delores took Tamoxifen. So, for me, what a choice. A biopsy that would leave me visibly disfigured (because Medicare doesn't pay for reconstruction after an excisional biopsy. A lumpectomy, it will), or a treatment that would make me feel like I had the flu every day for five years, IF I lived that long. I decided to wait six months and see what the 'a-typical ductal hyperplasia' would do.

sigh It's grown. Only a little, but ...

As I write this (March 4, for publication March 11), I've not yet had the scheduled repeat face-to-face with the surgeon and oncologist. I meet with them March 9, my birthday. (Happy Birthday to me. Ha!)

Seriously, though, I didn't expect the cancer to grow in just six months.

An aunt, when diagnosed with bone cancer, was philosophical and said, "You play the hand you're dealt." After I revisit my cancer team, I'll revisit how to play my hand.

Two Exhibitions in March at the Gibson House and Property

In honor of Women's History Month, YoloArts will be debuting two exhibitions with a reception on March 12 from 5:30 to 8 p.m. at the Gibson House and Property, located at 512 Gibson Road in Woodland. Participants will enjoy music by jazz guitarist Jon Spivack in the Barn Gallery and classical music by The Dolcetto Quartet in the Gibson House. An exhibition talk is scheduled at 6 p.m. in the Gibson House.

The first exhibit, Women Eco Artists Dialog: The Legacy of Jo Hanson, runs March 12 through June 18 and will be located in the Barn Gallery. Women Eco Artists will showcase the artwork of 16 members of WEAD (the Women Eco Artists Dialog), an Oakland based nonprofit that focuses on women's unique perspectives in ecofeminist and social justice art, and works to further the understanding of environmental and social change through visual art. The exhibition pays homage to the legacy of WEAD co-founder, the late Jo Hanson, and the growing movement of artists who use their voices and creative actions to focus attention on issues of social and environmental concern and is co-curated by Janice Purnell, creative director at YoloArts, and Nanette Wylde, a WEAD board member.

"This exhibition presents a wonderful diversity of media and mood;

each artist provides us with accessible and thought-provoking pathways using humor and transformation to reflect and consider how we can take action to salvage environmental health," said WEAD Board Member Nanette Wylde. "It offers a vital perspective as we work together toward a just, sane, and healthy world for all."

The second exhibit, Fashion Forward: Women's Wear and Social Reform, runs March 12 through June 26 and will be located in the Gibson House. This exhibition celebrates the centennial anniversary of women's suffrage in America and features unique objects of clothing archived in the Yolo County Historical Collection. The public will be able to explore the emergence of the "new woman" and political and social change brought about by the suffrage movement and view articles of clothing, of which many will be on display for the first time

in Yolo County. This collaborative exhibition with Yolo County Archives and the Paul W. Hollingshead Archives, courtesy of Bill and Sharon Dianne Hollingshead, is funded in part by the Yolo County Wom-en's History Month Committee, and includes fashion photography from Paul W. Hollingshead, who had a prolific career in Woodland from 1932 to 1969.

"This exhibition features women's garments from 1880 -1920 and looks at how fashion and politics were changing at the turn of the twentieth century," said Yolo County Historical Collection Čurator Iulia Bodeanu. "The exhibition also features profiles of Yolo County women involved in civic and women's groups which promoted social causes and supported the suffrage movement at a local level."

post comments and ideas, ask questions, make suggestions and complaints. Basically, it allows one on one interaction with your representatives, at all levels.

Texting people may have a price of phone number lists, and in some instances may cost for each text, but it will only cost pennies. However, if you are registered to vote, then your phone number may be public record. In addition if you have ever made an online purchase and provided a phone number for delivery, or played an on-line game, your number may have been available through that.

According to Eric Beans, CEO of Texting Base (acloud-based software company), the difference between campaigning on social media and texting is that it's estimated that 67% of people targeted will get

the message from social media, but a whopping 98% will read a text, and have 6 to 8 times the response rate of emails. They may not respond, but the information was read by the recipient, and that's what they were after. But is texting people without their consent legal? What happens if we don't want to hear from them? Is there anything we can do to stop them? Robocalls (computerized phone calls) are a pain. Most people hang up as soon as they hear that the voice on their call is a computer. Now we have a new nuisance to deal with... text messages from political candidates! How invasive are they allowed to get?

There are two kinds of text message advertising: Peer-to-peer (P2P) and Blast texting. Simply put, P2P tex-



Blood Clot Awareness: Learning the signs, symptoms and treatment

In recognition of March as • Swelling of your leg or arm National Blood Clot Awareness Month, the News-Ledger is sharing signs, symptoms and prevention measures as developed by The National Blood Clot Awareness Alliance, which promotes awareness blood clots through the "Stop the Clot", Spread the World Campaign. We can all come together to aid the NBCA's vision: "A future in which the number of people suffering and dying from blood clots in the USA is reduced significantly."

Recognize the signs and symptoms: Blood clots can be safely treated

DVT (Arm or Leg): If you experience any of these, call your doctor as soon as possible

- Pain or tenderness not caused by an injury
- Skin that is warm to the touch with swelling or pain
- Redness of the skin with swelling or pain

PE (Lung): If you experience any of these seek medical attention immediately

- Difficulty breathing
- Chest pain that worsens with a deep breath
- Coughing up blood
- Faster than normal or irregular heartbeat

Understanding blood clots

Blood clots can affect anyone and blood clots can be prevented. On average, one American dies of a blood clot every six minutes. A blood clot in one of the large veins, usually in a person's leg or arm, is called a deep vein thrombosis or DVT. When a blood clot like this formsm, it

can partly or completely block the flow of blood through the vein. If a DVT is not treated, it can move or break off and tavel to the lungs. A blood clot in the lung is called a pulmonary embolism or PE, and can cause death and requires immediate medical attention. Blood clots do not discriminate by age, gender ethnicity or race. Blood clots can affect anyone. Three major risk factors are: cancer, hospitalization and surgery, and pregnancy. Other risk factors include: birth control that contains estrogen, hormone replacement therapy that contains estrogen, trauma (particularly when the vein is injured), immobility or sitting for long periods, being overweight, a family history of blood clots, and smoking.

Moderate risk

Older than age 65; trips over four hours by plane, car train or bus; active cancer/ chemotherapy; bone fracture or cast; birth control pills, patch or ring; hormone replacement therapy; pregnancy or gave birth; prior blood clot or family history of a clot; heart failure; bed rest over three days; obesity; genetic hereditary or acquired blood clotting

What is the treatment for blood clots?

The primary treatment is medication that prevents abnormal clotting, known as an anticoagulant or "blood thinner." Blood-thinners increase the time it takes for

blood to clot. They stop new blood clots from forming and keep existing clots from growing larger. They do not dissolve a clot. However, by preventing clots from getting bigger, they allow your body's own clot busting system time to dissolve existing blood clots. Blood-thinners may be given as: a pill by mouth, an injection into either the skin or a vein.

Blood clots can be prevented. Know your risks and recognize signs and symptoms. Tell your doctor if you have risk factors for blood clots. Before any surgery, talk with your doctor about blood clots. ting is just as it sounds. If a husband and wife, or two friends, etc are texting, it is considered P2P texting. The Federal Communications Commission created the Telephone Consumer Protection Act (TCPA) in 1991 to protect consumers from being bombarded with unwanted emails, phone calls and texts, but P2P texting falls into a gray area. Political campaigns say that they are "texting voters to start conversations, funds, answer questions, mobilize supporters and offer rides or directions to the polls." Because of the personal nature of these reasons, it is considered P2P texting.

There are some basic rules. Campaigns are not allowed to blast text voters. The FCC law specifically states that telephone automated dialing systems used to make calls, send text messages and recorded voice calls are known as robocalls. The rules of robocalls apply to campaigns. However if the texts are sent individually, even though it's to thousands of people, they are considered P2P texts.

"Texting is very personal. People can very easily get angry about receiving that message

... The down side is that you annoy the people you are trying to entice," says Bean. So how do you get removed from their lists?

Charities, political parties, and political candidates seeking donations are all exempt from the national Do Not Call registries. You can join the registries at donotcall.gov and fldnc.com. Some feel that the texts violate the spirit of the law, but politicians claim that it opens them up to being able to answer specific questions that people have and engage in real conversations with







BE A GRAND JUROR • Resident of Yolo County FOR YOLO COUN-TY: Yolo Superior Court is now accepting applications for the 2020-21 Yolo County Grand Jury. Each year, on July 1st, Yolo Superior Court impanels 19 grand jurors to act as an independent body of the judicial system. Although grand jury service is important work and a considerable responsibility, it is also an exciting opportunity to serve your community and learn more about local government. The primary civil function of the grand jury is to evaluate the operations of city and county government in addition to other tax supported agencies and special districts. Based on these evaluations, the grand jury publishes its findings and may recommend constructive action to improve the quality and effectiveness of local gov-

Another responsibility of the grand jury is to consider criminal indictments based on evidence presented. The grand jury also investigates complaints from private citizens, local government officials, or government employees.

Eligibility requirements for grand jury service are:

- Citizen of the United
- 18 years of age or older;

for at least one year;

- In possession of natural faculties, of ordinary intelligence, of sound judgment and fair character;
- Sufficient knowledge of the English language;
- Not currently serving as a trial juror in any court of this state;
- Have not been discharged as a grand juror in any court of this state within one year;
- Have not been convicted of malfeasance in office or any felony or other high crime;
- Not serving as an elected public officer.

All applications are due by March 27.
