Grant cycle now open for local students to "Go Visit a Farm!"

Local nonprofit Yolo Farm to Fork is accepting grant applications for Yolo County public and private schools to "Go Visit a Farm!" The grants will send 4th, 5th, and 6th grade classes on a field trip to a local organic farm and provide \$300 per bus towards transportation. The grants are sponsored by local family-owned grocery chain Raley's.

Classes visit one of three Yolo County farms. Full Belly Farm is a 400-acre diversified organic farm in Guinda, while Fiery Ginger Farm and 3 Sisters Gardens are small organic urban farms in West Sacramento. Every student will harvest and sample produce grown on site. Other learning activities may focus on identifying parts of a flower, growing vegetables at home, pruning and caring for fruit trees, keeping livestock, vermicomposting with worms,

Winters man convicted of inflicting injury on his girlfriend and dissuading two witnesses

Late afternoon on January 30, 2020, a Yolo County jury convicted Jesus Reyes of inflicting corporal injury on his girlfriend, false imprisonment with force or violence, and two counts of dissuading witnesses from calling law enforcement

On April 4, 2019, at approximately 6:30 p.m., Winters resident Jesus Reyes drove to an apartment complex in west Davis. Reyes was driving with his girlfriend in the front passenger seat. He started to violently punch, slap, and head-butt his girlfriend. One of the witnesses described it as a "continuous beating." Reyes' girlfriend struggled to get out of the car, but he pulled her back in the car and tried to drive away.

A Davis mother and her son who were outside saw the brutal assault and started to yell at Reyes to "Let her go, let her go." Reyes pulled out of the apartment complex and pointed his finger directly at the mother and her son. He yelled, "You don't tell anyone." Reyes drove off with the victim in the car before law enforcement could arrive.

With the help of the mother and her son who were able to get the license plate number of the car, the Davis Police Department was able to track down where Reyes and his girlfriend were. The Davis Police Department and Winters Police Department worked together to locate the girlfriend, who was actively bleeding from her face two hours after the assault. Reyes barricaded himself in his house and lied to officers about where his girlfriend was. Winters police saw her crouched down behind Reyes in the home. Reyes has a violent history, including prior domestic violence charges.

Joe Sokolich, a long-time resident of West Sac-ramento, and member of the United Brotherhood of Carpenters for almost 80 years, drove his final nail home when he passed away peacefully on January 15, 2020, at the age of 98 years.

Born in Portland, Oregon, in April 1921, Joe grew up in San Pedro, California among the town's Croatian community. Joe attended San Pe-



dro Senior High School, excelling as a runner on the track and field team. When not in school, he assisted the family by working odd jobs and helping with maintenance

In 1978, Joe retired and moved to Sacramento where he married Betty Fairbairn Finlayson Turner Vogel. He became Grandpa Joe to Betty's grandchildren, step-dad to her kids, and Grandpa to extended family and friends. He also became part of the art world in which Betty lived. He used his skills to hang art shows, build display stands, assist in making stained glass windows, and in his own art form of woodturning. Additionally, Joe and Betty traveled

all over the world visiting family and friends, as well as making new ones.

Through all of their activities and travels, West Sacramento was home. Joe spent many years serving Trinity Presbyterian Church using his knowledge and skill to help maintain the facilities. He served as the longtime host of their Men's Prayer Breakfast on Saturday mornings. or recognizing beneficial insects and birds.

After the farm visit, some classes will visit a local Raley's store that purchases vegetables directly from the farmers. At the grocery store, students will learn how to read a nutrition label, identify seasonal produce and egg sizes/categories, and complete the full farm-to-market-to-fork cycle.

Full Belly Farm's Director of Outreach and Education Haley Friel says students love tending the newborn piglets and gathering freshly laid chicken eggs on the field trips. "Some students bravely reach under the chickens to grab the eggs. Others have seen eggs being laid right before their eyes." Friel says that visiting a work-

ing farm teaches the students "where their food really comes from and all the effort and energy that goes into bringing it to them".

According to Friel, many young people are surprisingly detached from our food system. "Even students that live in rural areas are often disconnected from the realities of our food system and have no context or connection to it." The farm visits, she says, provide "engaging, exciting experiences" that help students connect to the food they eat and spark "curiosity and interest in the agriculture on which they depend."

Yolo Farm to Fork created the "Go Visit A Farm!" program eight years ago. President Suzanne Falzone explains,



"We've been doing farm visits from our very beginnings in 2012. We want kids to experience where food originates and how it grows. We also want to acquaint them with our county's rich ag heritage." With about 800 students participating each year,

the grant program has provided over 6,000 farm visits since its inception.

THIS 'n' THAT

The Case for Cursive

So there I was. Debating whether I really had to vacuum when the doorbell rang.

It was a uniformed policeman.

With my son, age 8.

I confirmed I was his mother. The policeman said he needed me to bring Mike to the station to write a statement. Here's the background:

In Bay Village (a bedroom community not far from Cleveland), the wide driveways typically are marked with driveway stakes, topped with small round red reflectors that peek above the snow. An unplowed driveway is undistinguishable from your lawn. A visitor can get stuck, or leave deep unsightly ruts when

snow is melting. (Bay Village homeowners are quite particular about their lawns.)

Mike and two other neighborhood delinquents decided to pull up a bunch of driveway markers. They noted that each stake had a pointy tip. Next stop: 'Marking' cars at the Park'n'Ride.

The older boys drew lines and squiggles.

officer said 'MIKE' was easy to track down. He'd drawn his name.

I called the police sta-

tion spoke briefly with the officer who would take my son's written statement. I shared that my son had ADHD plus delayed fine motor skills (severe birth asphyxia). At a small table, Mike and I sat on one side, the officer on the other. As he handed Mike a blank sheet of paper, he instructed him to write down what he did. Mike paused, then looked at the officer and asked, "In cursive?"

The officer and I exchanged a glance. "No," the officer said kindly. "You can print it."

My insurance covered all the damage, but I wanted Mike to have a consequence he'd remember. I asked the officer to please give my phone number to the victims, in hopes they would call Mike and tell him how they felt when they saw their damaged

One said it was his 'dream car.' That he'd loved its perfect, gleaming finish. Another, near tears, told Mike she'd taken the train from the Park'n'Ride to go see her mom, who was in the hospital. With cancer. Mike's face crumbled.

All four people called. No was angry. No one was mean. My son, devastated by the pain he caused, was genuinely, truly sorry. I thanked each for helping him learn that actions can have consequences we don't intend. Like hurting someone.

Looking back, Mike's earnest "in cursive?" is poignant/funny. Made more so by something I read recently in the Bee. In many California classrooms, learning cursive (longhand) writing is not required.

It's a tech thing. Tablets, laptops, computers. Some argue cursive writing is no longer needed.

"You need to be able to sign your name on checks," say others. (And here's a question: Isn't forensic analysis of written 'evidence' – such as a signature on a will – still valid?)

For its story on the controversy, the Bee contacted the California Department of Education. Here's the deal. Districts can *choose* to require cursive instruction, but there's no state mandate.

Hm. I remember being in awe of my grandmother's florid Victorian script. Back then, children spent hours copying letters on their slates until they got them perfect. calligraphy-ish. Fancy. Lots of curlicues.

In 2011, CBS interviewed a handwriting expert, Michelle Dresbold, about cursive writing. I asked. "Everything!"

She said cursive writing that trends downhill indicates emotion. "People will write in a downward angle when they're depressed," she said, adding that when you're happy, the ends of sentences slant up.

She said, too, that handwriting often changes as we age. For those with Alzheimer's, she explained, handwriting becomes 'less fluid.' She pointed to President Ronald Reagan's writing. Compared to his pre-Alzheimer's cursive writing, his post-Alzheimer's writing "blobbed up," she said.

My dad, a southpaw, spent his grade school years with his left hand tied behind him to force him to use his right. Eventually, he wrote left handed anyway. In college, he'd wanted to become a sports writer, but it was the Great Depression. He opted for a 'more practical' career in business.

During one of my folks' visits to Colorado after I had Mike, I asked dad what he wanted to do when he retired. "Write!" he said. "What will you write about?" he answered promptly. I cocked an eyebrow. "I know everything," he said, eyes twinkling.

Dad, though, was fading fast. I suspected Alzheimer's. In Denver, I sent lots of cards and notes - signed "from Mike" in large, scrawley childlike print. Mike, 2, put stickers on the cards, or drew 'pictures.' (In cursive, I explained the drawings.)

One day, a 'letter' came for Mike and me from my dad – as dictated to my mom. He did have Alzheimer's and no longer could write it for himself.

'Dad's' letter, in its disjointed way, told me how much he enjoyed Mike's cards, my calls. Mom, as herself, added: "I asked your dad if he wanted to sign this but he thought it somewhat confused. I thought you might like to know he had the idea to write."

Yes. Write. My father's words - in my mother's cursive writing. I would have treasured it, either way, but love that she didn't type it.

District Attorney Jeff Reisig stated: "We pursue justice for victims and witnesses of domestic violence crimes. People who physically abuse their significant others can be extremely violent. When this type of violence is seen in public, it is not usually the first signs of physical abuse in the relationship. We are fortunate there are people in the community who will stand up and call law enforcement when seeing such extreme violence."

Reves faces around 20 years in state prison because of his prior strike conviction. Sentencing is set for March 2, 2020.

Delaine Eastin Named Speaker for the 2020 Yolo County Women's **History Month Luncheon**

She was a member for eight years in the California Assembly and a candidate for governor of California in 2018.

The exhibition highlights the changing role of women in society and their involvement in the suffragette
