# May Exhibition at YoloArts' Gallery 625 Honors Asian-Pacific American Heritage Month

Antique photographs, ancient Chinese opera masks, the Buddha, dragons, and American history inspired the art created for the May exhibition at Gallery 625 in Woodland. The exhibition has been assembled in honor of Asian-Pacific American Heritage month and includes painted screens, brush paintings, photographs, and mixed media art of seven regional artists.

The artists showing their work include Ann Marie Campbell, Yuko Carson, Alan Fishleder, Ron Hall, Irene Leung, Lyla Paakkanan, and Randy Won. The Asian art theme was chosen for May as it is Asian-Pacific American Heritage month. According to the Library of Congress, this nationally recognized heritage month commemorates the immigration of the first Japanese to the United States on May 7, 1843, and marks the anniversary of the completion of the transcontinental railroad on May 10, 1869, as the majority of the workers who laid the tracks were Chinese immigrants.

### Some Eastern Inspiration show highlights:

"Through my work, I explore and communicate and heighten what exits already in these fascinating cultures - beauty, strength, hope, and longevity," said Ann Marie Campbell in her artist statement for the show. Campbell's paintings are sparked from antique photographs from Japan and China and her medium is oil, egg tempera, and acrylic paints.

Artist Leung will be exhibiting three works from a series of twelve acrylic painitings called "The Masks." This series on canvas paper draw inspiration from ancient Chinese opera masks, where the colors of the masks are intended to function as a universal language communicating to the audience character, intent, and origin. The masks provide a bridge to the realms of western modern art and ancient Chinese traditions, according to Leung's artist statement.

Paakkanen's dragon screens are the result of her love of dragon lore and fascination with reptiles. She studied herpetology as an undergraduate, and found sea snakes particularly fascinating due to their graceful movement. According to her artist statement, her dragon screens evolved from "my drawings, then paintings of kimonos, then just dragons on large swaths of heavy paper to be hung." She later switched to canvas due to the weight of the paint on paper, and the dragon screens are painted on both sides.

Artist Yuko Carson will be demonstrating brush painting throughout the exhibition's opening reception.

do Budoyo will perform Indonesian orchestra music featuring bronze gongs, chimes, and other melodic percussion instruments. The university ensemble will be performing from 6 - 6:30 p.m. during the reception.

Eastern Inspiration will run through May 31 at Gallery 625, the public art gallery cu-

# **Proposed City Charter Will Need Voter Approval**


When the City of West Sacramento (CWS) was incorporated in 1987, the city was considered to be a "General Law City" (GLC) as there was no City Charter in place. Cities in California are classified as either a Charter City or a General

In June of 2015, Mayor Cabaldon, in a letter to the City Council, requested "concurrence with the scheduling of a future agenda item to propose a City Charter to the voters following its development by the City Council, convened as a committee of the whole".

Mayor Cabaldon felt that the "basic structure of city government has served the West Sacramento community well". He does not want to consider any fundamental changes, such as moving from a council-manager form of government to a strong-mayor form, or to a full-time mayor and/or council. He believes that "we should strive to develop a lean charter, but no other matters would be excluded from consideration prior to the council's scoping sessions".

The Charter Adoption Timeline indicates the scheduling of two properly noticed public hearings on the proposed charter in May and June of this year. July 19, 2016 is the expected Yolo County deadline for the CWS to adopt a resolu-

tion submitting the charter measure to the voters and requesting consolidation of election with Yolo County. Election Day is November 8, 2016. If the City Charter is approved by the voters it will be effective when filed by the Secretary of State.

While operating as a GLC, the CWS is bound by the State of California's General Law, and has conducted its municipal elections in accordance with CA Elections Code. At-large elections are held and voters vote for any candidate

on the ballot. The cities may choose to elect the city council "by" or "from" districts. The Mayor may be elected by the City Council or by a vote of the people. A Charter City (CC) may establish procedures for selecting officers and may hold at-large or district elections.

Charter Cities can establish their own criteria for city offices, provided the city does not violate the U.S. Constitution. Both GLC and CC may provide for term limits. Both forms of cities may establish rules and procedures for adopting, amending or repealing ordinances.

There are benefits for a city to be a Charter City. CWS may transfer some

of its functions to Yolo County. This would include tax collection, assessment collection and sale of property for non-payment of taxes and assessments. A Charter City is not required to comply with bidding statutes provided the city charter or a city ordinance exempts the city from such statutes, and the subject matter of the bid constitutes a munici-

Charter cities have not been found by state law prevailing wage requirements as long as the project is a municipal affair, and not funded by state or federal grants. A Charter City may impose real property transfer taxes. Zoning ordi- 12/16/15,02/17/16,04/6/16

nances are not required to be consistent with the general plan unless the city has adopted a consistency requirement by charter or ordinance.

Voters in the CWS will make the decision as to how their city is classified. It is important that they participate in the public hearings so that they can decide how they want their city to be operated, and the procedures that will be established for them and future residents. 
