## Schools Chief Tom Torlakson Announces Start of Annual CAASPP Testing

Last week, at Bridgeway Island Elementary, State Superintendent of Public Instruction Tom Torlakson announced that students have begun taking the California Assessment of Student Performance and Progress, the state's computer-based, online assessments given in grades three through eight and eleven.

"These tests in mathematics and English language arts/literacy are one of the many ways we measure how well students are doing at the challenging job of preparing for college and a career," Torlakson said. "I encourage all students to take advantage of this opportunity to put their learning and their skills to the test."

2016 marks the second year more than 3 million California students will take part in CAASPP, which was designed to gauge their progress toward the learning goals set for California students. Districts and schools select their individual testing dates.

The CAASPP asks students to demonstrate the kinds of abilities they will need to do well in college and the 21st century workplace—including analytical writing, critical thinking, and problem solving.

"Because CAASPP tests are given state-

wide, they provide an opportunity to gauge students' skills against the same academic standards in the same way, measuring millions with one common yardstick," Torlakson said.

California moved to new, online, computer-adaptive assessments last year based on more challenging academic standards as part of its comprehensive plan to give every student the opportunity to graduate ready for college and to pursue a career. California is one of 20 members of the Smarter Balanced Assessment Consortium, which developed the assessments.

"Teachers and schools need more than a single end-of-year assessment to know how students are progressing and to tailor instruction to meet their academic goals," Torlakson said. "That's why California also provides both interim assessments and a Digital Library of high-quality materials and resources to help schools measure student progress throughout the year."

Computer-based assessments, coupled with an online system to report results, can give school districts access to results earlier than the pencil-and-paper tests they replaced, allowing schools to make adjustments to improve learning and instruction.

CAASPP is particularly important for eleventh grade students to gauge college readiness. Under the Early Assessment Program, more than 100 California State Universities and California Community Colleges will use CAASPP results to determine whether students are ready for college coursework or need additional courses in their senior year of high school.

"California is leading the way in moving from a top-down approach to testing to a system focused on gathering useful insights and helping schools put them to use by improving teaching and learning," Torlakson said. "These changes take time to carry out, and it is important

to remember that schools, teachers and students are still adjusting to our new standards and assessments. We know that real progress takes patience and persistence."

Committed to addressing the digital divide by ensuring access to technology and digital resources for our students at every school, Washington Unified School District Superintendent Linda Luna explained that the Innovative Educators Program has shown great success in the district in transitioning technology for teaching and learning. "We have teachers at each school that participate in the Innovative Educators Program in which teachers and students learn and grow using technology in the classroom," she





## **Universal Truth**

West Capitol Avenue has had a rich history. Back in the day, the stretch of West Capitol extending east from Harbor Boulevard was a wonderland of dark intent. Citizens with ulterior motives populated the sector, either living on the street or maintaining headquarters in any one of numerous motels.

In 1992, ironically enough, the City of the Dharma Realm Buddhist Education Center, founded by the Venerable Master Hsuan Hua, was established at Merkley and West Capitol. A calm place in the eye of a hurricane, if you will. Master Hsuan Hua was a direct lineage from Bodhidharma, who brought the dharma ("universal truth") from India to China.

Since the arrival of the brand new City Hall, the West Sacramento Community Center and the West Sacramento campus of Sacramento City College, things have greatly improved. More recently, the iconic Capitol Bowl has undergone an aggressive make-over and features an outdoor patio and an upscale menu.

Across from the City of the Dharma Realm, a non-descript Community Church (no denomination posted) sits modestly. In its lobby, a small but bright gold statue of an angel stands guard.

A constellation of motels continues to decorate the avenue, with a dizzying turn-over of occupants, but West Capitol Avenue is diligently monitored by the local police these days.

Still, from time to time, the disenfranchised, disheveled, and disoriented who are not blatantly breaking any law can be observed moving freely along the thoroughfare. One tries to imagine these individuals in a more innocent time. The man with a buzz cut and no shirt, clutching a large stuffed panda bear and shouting at thin air, was once a child on Christmas morning, eagerly unwrapping presents and blissfully unaware of the rabbit hole of addiction or mental illness. Some fringe dwellers do their best to preserve their dignity, stu-

diously applying make-up at bus stops

or carrying a sense of style in their attire or attitude.

On one particular drizzly Saturday afternoon, in the parking lot of a popular eatery, a young woman comported herself in an audacious manner directly outside one of the windows. She couldn't have been more than 20 years old, and was dressed in shabby camouflage pants and a worn wool sweater. Her hair was like a crow's nest and her eyes shone brightly in defiance, mocking the diners inside.

This went on for several minutes, before the manager was summoned. A burly, no-nonsense individual, he made his way outside and confronted the homeless urchin. Much waving of arms and contorting of faces on both sides commenced. From inside the eatery, one could only guess and add one's own subtitles to the mute, frenetic scenario. Naturally, by this time, the West Sacramento Police had been called. A sort of checkmate ensued where neither player gave an inch of ground. The young woman only became more incensed, and hopped up and down as if on hot coals.

The manager threw his hands frantically in the air and made shooing motions, his face turning red.

Abruptly, the urchin backed off and took off running down the street, hurling words over her shoulder as she went. She crossed West Capitol, amidst traffic, and scooped up her belongings: a knapsack, a blanket, and a stuffed dachshund toy, and headed around the back of a supermarket.

Minutes later, a police car glided up and made a thorough search of the area. The urchin had adjourned to some secret hiding place. Whether a victim of mental illness, substance addiction, or something inexplicable, this young woman was once a small child, waiting up into the wee hours of Christmas Eve, eagerly listening for Santa and anticipating a stuffed toy, wrapped in festive, fanciful

Perhaps, one of these days, she will find her way out of the rabbit hole. We can only have faith.

## Resource Fair coming to Sac City College

Positive Reflections: From combat to community travels to West Sacramento

Veterans from all branches of the United States military service will be showing their art in West Sacramento at the upcoming traveling art exhibition Positive Reflections: From Combat to Community. The YoloArts curated exhibition opens at the Sacramento City College, West Sacramento campus on April 8 and runs through April 22. The art exhibition will be part of a Veterans Resource Fair hosted by the community college campus.

"We are excited to be hosting the veteran's art exhibit along with our Veteran's Resource Fair. We hope that the community will take advantage of the educational access they have at the Sacramento City College - West Sacramento Center and the opportunities that will be offered during these special events," said Art Pimentel, dean of SCC's West Sacramento Center.

The 27 veterans showcasing their work include: Amber Alls, Robert Brownson, Albert Careyette, Paul DeVol, Alan Fishleder, Doug Glover, William Hollingshead, Lee Jones, Dallas Kassing, Adam Kroh, Diana Lee, Justin Lee, Charles McDonald, Jim Painter, Art Perez, Alvin Pruitt, Richard Racki, Chris Ring, Michael Rottmiller, Billy Shea, Bernard Stallings, Danesha Stallings (military spouse), Sean Stevens, Nina Thi Strom, Larry Swanson, Eileen Udovich, Elizabeth West. Many of the veteran artists will be present at the West Sacramento event.

Several of the exhibition's veteran artists have worked with Nina Thi Storm, a Behavioral Health Clinician at Veterans Resource Centers of America in Sacramento.

"There is a study about the similarities between war vets and refugees... intuitively I was aware...but truly appreciate the validation of the study. Our human experience and collective suffering as well as celebration, is vital to our survival. This show is a way to acknowledge their bravery to do the work," said Storm, whose mother was a refugee from Vietnam, and flew out of Saigon the day it fell, in April 1975.

YoloArts commissioned a poem specifically for this project and written by Dr. Andy Jones, who will be reciting it at 5 p.m. during the meet-the-artists reception. He first presented the poem at the project's opening February event at Gallery 625 in Woodland. Inspired by what he saw at Gallery 625, Jones decided to fund an annual creativity prize for veteran students at UC Davis to be funded through sales of the book he published for this project. Copies of the book will be available for sale at the West Sacramento event.

The show is made possible by the Veterans Initiative in the Arts program of the California Arts Council, and features the art work of veterans who served in the U.S. Marines Corps, Coast Guard, Navy, Army Navy Reserves, and Air Force. Yolo County Veterans Services is a partner on this exhibition that includes the work of citizen artists from Davis, Sacramento and Woodland. The range in time for their war experiences includes World War II, the Korean War, Vietnam, Iraq and Afghanistan. Some of the veterans whose work will be on exhibition are currently experiencing homelessness.

The April 8 Veterans Resource Fair will be held from 1-4 p.m. in the downstairs courtyard of the West Sacramento Center. The resource fair is open to all veterans. Organizations hosting



resource tables include: CalVet, Ride 2 Recovery, Dept. of Veterans Affairs, Volunteers of America, Yolo County Neighborhood Court, UC Davis, the Yolo County Veterans Service Office Sac City College Veterans Resource Center and the Rivercats.

The art exhibition, in room 322 of the college center will offer refreshments and the poetry reading from 4 - 6 p.m. Music will be provided throughout the afternoon and during the reception by Joe Lev and Friends. Band members and military veterans Jimmy Bagshaw and Dave Croall will be joined by Lou Freitas, Jeffrey Felsher, Gary Bennett and Joe Lev playing jazz, western, blues, country, and rhythm and blues. said.

Teachers trained in this program receive a Chrome Cart (a class set of Chromebooks) to use for their students' learning. There are first grade students doing research, sharing Google docs and creating power point presentations in their classrooms. "We have 98 teachers in this year's cohort of Innovative Educators. We start with another bunch next year. Our goal is to build capacity within our teachers and students until we reach 100 percent in the dis-

In addition to the Smarter Balanced assessments, schools will be administering other exams throughout the spring including:

#### California Alternate Assessment (CAA)

These tests in English Language Arts/literacy and mathematics will be administered to students in grades three through eight and eleven with significant cognitive disabilities. It replaces CAPA—the California Alternate Performance Assessment. These computer-based assessments are built around new, deeper learning goals - called the Core Content Connectors—which are linked to the Common Core State Standards (CCSS). The connectors focus on the main academic content from the standard for each grade and subject-with three levels of complexity to give all students an opportunity to demonstrate what they know.

#### California Standards Test (CST), the California Modified Assessment (CMA) or the California Alternate Performance Assessment (CAPA) for Science

Students in fifth, eighth, and tenth grades will be administered a science examination. Students will either take the CST, CMA or the CAPA depending upon a student's individualized education program.

#### Standards-based Tests in Spanish (STS)

The STS is an optional assessment for English learners at no cost to an LEA or non-English learners (e.g., pupils in dual immersion classrooms) at the cost of the LEA. The STS for reading/language arts may be administered to students in grades two through eleven.

I Saw the Light

Sony Pictures Classics offers "I Saw the Light' a screen visualization of the life of singer-songwriter Hank Williams, who in his tragically short career, made an indelible mark in country music in the USA with 33 hit song singles, 30 of which were in the Top Ten, including eight number one hits. This is the first of three movies to come out this month about music personalities of the past which coincidentally had substance abuse problems. The other two movies are about jazz legends Chet Baker and Miles Davis. Based on the book "Hank Williams: The Biography" by Colin Escort with George Merritt and William MacEwen, this movie's screen play was adapted and written by the director, Marc Abra-

ham. Tom Hiddleston stars as Williams, bringing the clearly defined music personality back to life for this movie. His somewhat domineering mother, Jessie Lillybelle Skipper Williams Stone, who was also his early manager, is played by Cherry Jones, who you may remember from the "Horse Whisperer" or "Erin Brockovich". The movie begins with a faux documentary approach, with men integral to Williams' career being interviewed about the singer in black and white and in a nice touch, the classic academy ratio of 1.37:1, a rather square screen shape. The production returns to this shape later in the feature for the clever recreations of Kodachrome home movies of Williams' family, a nice element in a movie in which Tom Hiddleston is completely believable in the part he is playing. Williams' life of wandering, drug and alcohol abuse destroyed much around him but he had moments of joy with one of his wives, Audrey, who was the mother of Hank

Williams, Jr. Audrey fancied herself a singer and wanted much to be teamed with her husband in records and radio, but lacked the ability to hold a tune. She's played in the movie by Elizabeth Olsen.

During Williams' marriage to Audrey, what started as a little pain in his back would eventually be Hank's undoing. Suffering with Spina bifida occulta, Hank began to self-medicate, combining alcohol, morphine and chloral hydrate, eventually leading to a heart attack which took him at just 29 years of age in 1953, when en route to a performance.

We see the years 1944 to 1953 covered during the course of this movie, and it well establishes the feel of the period, recreating the mood and times from which Williams' singular voice became an indelible part of the passing parade. Hiddleston's own voice is used in the picture, rather than the actual Hank Williams recordings, and he does quite well, making you believe he is the genuine article.

Though there are uncomfortable moments to watch, Hiddleston really gives a great performance here and proves yet again what a great talent he is in the worlds of cinema. I hope you see this picture and enjoy his performance as much as I did. In Sacramento at the Tower Theatre.
