# Using science to make the world a better place:

Westmore Oaks students made “solar suitcases” to energy poor schools in the Philippines

Jennifer Garcia and her students over at Westmore Oaks are at it again – using science to make the world a better place. Recall the recent story on the rain barrels? Now, in Garcia's words they are “doing an even more amazing project,” building six life changing solar suitcases for folks in the Philippines



and given to schools that do not have electricity. The suitcases will be used to provide light and a charging station for lap tops, cell phones, and lights to lend out to students. We Share Solar is the nonprofit organization that does this. They have been doing this in many other places that are rebuilding after disasters or are developing countries. Asked how the project came to be, Garcia said that colleague, Deb Bruns, invited her to attend a solar suitcase

training earlier this year. “She is from YCOE (Yolo County Office of Education) and has been an amazing asset to my teaching for a few years. I want to thank Deb for her continued support. She also brought several amazing people that were a tremendous help.”

Solar suitcases are portable solar systems from We Share Solar that will be donated to energy poor schools in the Philippines. They are a 12-volt DC

# March Drought Spotlight Honoree – Diane in Southport

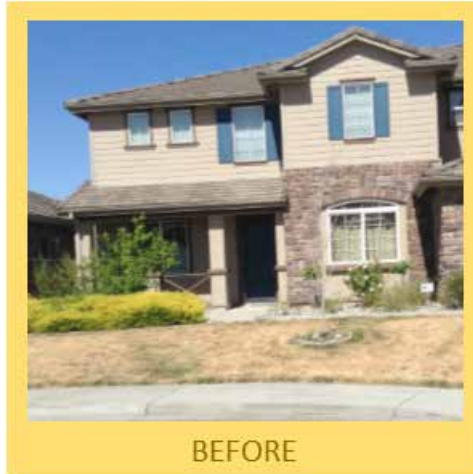

Steve is survived by his loving and devoted wife of 23 years, Kristen, his daughter Stephanie McKay (Jim), sister Deborah

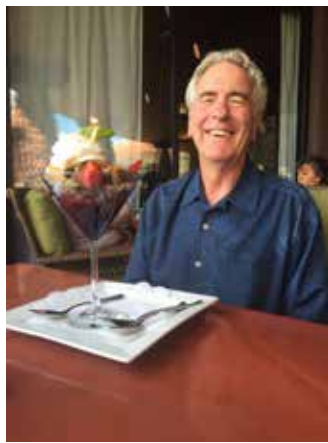

# Ducks and Geese

The Bridgeway Lakes/Southport area of West Sacramento used to be a vast hog farm. Since then, the sector has been given over to at least two spectacular man-made lakes and a galaxy of upscale housing developments. Along the western border of the sector, a channel guides massive freight liners in from the ocean, by way of the Sacramento River, culminating at the sprawling Port of Sacramento. The channel is technically known as the Sacramento River Deep Water Channel: about 30 feet deep, 200 feet wide, and 43 miles long. But, to a dedicated clique of locals who use the eastern bank of the Deep Water Channel as a combination fishing spot/barbecue pit/saloon/town hall meeting, it is simply known as The Channel.

Looking out the back of one’s kitchen, one may spy the occasional freight liner making its way indolently along the channel; in no hurry at all. Some of the ships reach surreal heights of seven or eight stories.

Driving past the Port, on Industrial Boulevard, one may notice a freighter with proud Spanish or European or even more exotic logos stenciled ten feet high on the bow.

As we have noted, the Bridgeway Lakes/Southport sector used to be the domain of hogs. They are long gone now, but this area is ever-abundant with wildlife. Occasionally, a “Wildlife Crossing” sign will notify drivers of possible turkeys, raccoons, possums, and wild dogs in the vicinity of a particular road. Turkeys can be seen wandering aimlessly along the shoulder of the road, tempting fate. Unfortunately, every once in awhile, a possum or raccoon pressured into a dare by his or her fellow creatures, will attempt a road crossing at the last moment before an eighteen-wheeler arrives.

And, late at night, wild dogs and even cattle can be heard howling and mooring beyond the western bank of the

Channel. Seasonally, a thousand-voice chorus of frogs takes over a swampy area near the Channel. Jackrabbits can be spotted leaping maniacally here and there, amongst the tall weeds.

Now, the most interesting of all the fauna are the ducks and the geese. A seemingly highly-organized telepathy is employed within large groups of these birds: “Let’s all go over here and float on this side of the lake.” “Aren’t you glad the hogs are gone ? So unpleasant.” “Did you hear what happened to Rocky the Raccoon ? Played chicken with an SUV and lost, over on Marshall.” “Okay, now let’s all get out of the water and head over to the outfield on the baseball diamond. Any questions or concerns should be brought up at that time. It’s an open forum, don’t be shy.”

At this point, it should be clarified as to the difference between ducks and geese. Duck is a common name for every bird that belongs to the Anatidae family, including swans and geese. So all geese are ducks, but not all ducks are geese. Ducks are generally stouter and more colorful. Only the female duck makes the ‘quacking’ noise. Anthropomorphic ducks are popular in cartoons.

Geese, on the other hand, have elongated necks, and appear in mythology or children’s stories. For instance, when Aphrodite, the Roman goddess of love, first came ashore she was welcomed by Charites with a chariot pulled and drawn by a goose. (Remember all this trivia for the next cocktail party.)

Finally, one of the most majestic displays of nature in the West Sacramento sky: thousands upon thousands of geese, linked telepathically or by a complex network of honks, creating a stunning mandala of flight patterns in the morning air. Geese have strong urges to return to where they hatched and even as they grow up, they tend to return home. Not unlike some other species. We have more in common with the animals than we think.

stand-alone solar power system. (Basically the Photovoltaic cell charges the battery in the case. There are four ports to charge electronic devices or power lights that are also included).

This educational experience encouraged civic engagement through building awareness of energy poverty and sustainable development. This also teaches students more energy literacy while reinforcing STEM skills through the assembly process, Garcia said.

The students completely wired the suitcase. They followed a process just like engineers to inventory the materials and all the way through the wiring process. The students even went through the steps to commission their suitcase and ensure it was working properly. Final steps were installing the components into the transportable and mounting cases (after writing greetings inside to the recipients).

Garcia said her class prepped for about a week and spent two, three-hour days to build. “I had worked out a temp schedule with the other teachers so I could keep this class for three periods both days,” she said.

Describing the students’ reactions

as “priceless”, Garcia said when she first explained where the suitcases were headed and how they were to be used in schools without electricity and how hard that is for us to imagine (not having electricity), it was a very touching moment.

“I really saw empathy in my students. My students understand that they made something that will drastically change another person’s life for the better. My students know that they are making a difference,” she said.

“Once we were completed with the build, commission, and lighting up... everyone was so proud!!!! We were also a bit exhausted. It was a lot of hard work, mentally and physically. But, the feeling of accomplishment were all worth it!”

Sunpower actually paid for the teacher kit and the six student kits. They also will be adding photovoltaic cells and batteries to each of the student’s kits once they arrive in the Philippines. So, an additional big thanks goes to Sunpower!

“This was an amazing experience for my students! It was an amazing experience for me! They made something that will be a life changing tool for many!! My students changed the world! I am so proud of my students!”

Bleeker Street releases one of the most gripping pictures I’ve seen up to this point in the year, “Eye in the Sky”. Helen Mirren stars in a role originally intended for a male actor, a UK based military officer in command of a top secret operation in Kenya, where they intend to capture terrorists that they have been watching through drone surveillance. It is noticed through this electronic invasive eye in the sky that a terrorist bombing is eminent, which switches the urgency to action.

The late Alan Rickman appears in his last movie role as General Frank Benson, trying to be the buffer between politicians and the military force in the command of Mirren’s character, Col. Katherine Powell. After many referrals up to the next level of authority, they agree to strike the target. This conclusion is reached with much difficulty as no one politician wishes to make a choice and be responsible for the outcome. Once you are well on the edge of your seat with tension excellently built up through this process, there is a fly in the ointment.

A young Kenyan girl, first introduced to us in the opening scenes of the

movie as a street bread monger, selling round loaves made each day by her mother, sets up her table of bread for sale directly next to the intended target of this military action and she will not budge.

Lt. Steve Watts (Aaron Paul) is the man on the trigger who delays firing until a new calculation of collateral damage may be obtained. As the Lieutenant whose compassion for the safety of a girl he has never met who is now in the line of fire adds incredible tension to this story which will then KEEP you on the edge of your seat from start to finish.

This is an outstanding bit of ensemble acting which brings back the tension of a movie like “Fail Safe” into the modern cinema mix. Director Gavin Hood effectively realizes the screenplay by Guy Hilbert. Not since Patricia Holt’s book “The Bug in the Martini Olive”, about Hal Lipset, do you get to see such neat and precise technology for spying revealed.

The final send off for the beloved Alan Rickman is one I am sure he would have been most pleased with, he’s great in it. His last line in the film and indeed the closing of the movie, is the perfect point for you to consider as you walk out of the theatre.

### Batman v. Superman: Dawn of Justice

What a mess! Warner Bros. brings us the latest action adventure mingling of superheroes with “Batman v Superman: Dawn of Justice” in which Ben Affleck stars as the caped Crusader and handsome Henry Cavill is the man of steel. Returning in roles you’ve seen recently are Diane Lane as Superman’s mom, Amy Adams as Lois Lane, Laurence Fishburne as Perry White, Michael Shannon as Zod, or at least the corpse of Zod and Kevin Costner as Superman’s pop. This movie has excellent production values and more explosions per scene than any other picture I’ve witnessed.

Not long after we are reacquainted Batman’s sad reason of orphanage

in an opening flashback to the loss of his parents, in a somewhat convoluted story element we see that batman has gone rogue marking victims with a bat marking on their flesh for reasons not explained in this movie’s narrative.

Superman intends to set his straight, amid growing public opinion against him. It seems the superheroes in this movie have to deal with as much political spin and grief as presidential candidates. One nice thing about this picture is the most recent “Alfred” to reach the screen, Batman’s man, played by an actor whose talent far exceeds the material, Jeremy Irons.

Other elements at play include the evil daring-do of Lex Luthor, played in this movie by Jessie Eisenberg. It is he who is behind the pitting of the two, which in spite of their super powers, did not realize Luthor was playing them against each other. We are introduced to a young lady of wonder (Gal Godot) appearing throughout the movie, always in key scenes but with no explanation of who she is or why. In fact, it is Wonder Woman. No where in the movie is her name even mentioned once, even by Batman or Superman. There is one moment where Batman finds a computer file with information marked “WW” and that was the clue I used to figure out who this woman was who later shows up in the climax to help out. I don’t read comic books, so I relied only on the images that director Zack Snyder

put in front of the camera to try and figure out what was happening.

No plot to this mess of a movie, a terrible hodgepodge of too many story elements exploding like too many musical crescendos into an overlong series of loud bangs, though handsomely realized cinematically. Too much going on in too many directions.

To compound this, the horrible and annoying presence of Jessie Eisenberg is a real turn-off in this movie. When I saw him in “The Social Network” I thought his performance of the Facebook tech giant a sensation. Little did I know until multiple performances later that his tick ridden, repetitive and pausing line reading is actually the way he does every single role... exactly the same way. I have to watch these movies to offer a review. If I did not, I’d avoid any movie he ever appears in, he’s box-office poison. This picture suffers much already, Eisenberg sends it down in flames. Makes you long for the brilliance of the Lex Luthor played by Gene Hackman.

There are good actors here. If you want to see Diane Lane and Laurence Fishburne in something good, see Francis Ford Coppola’s “The Cotton Club” they are both excellent in that. Holly Hunter’s brief moments as a US Senator are excellent. This movie begins with a funeral and ends with a funeral, setting the tone for what should be done with this move: buried and forgotten as soon as possible! A real Stinkeroo!

you may relate to one or another of these iconic family types. The patriarch of the Portokalos family is Gus, and he's played again by wonderful Michael Constantine, who has had a splendid career in the movies. He's good in this movie, reminding me a bit of my own father. He's been in good movies and bad movies. One of the best; "The Hustler" in 1961 where he played Big John, the worst, "Skidoo" in 1968 where he appeared as "Leech" in prison stripes

opposite Jackie Gleason. That movie is best described as "a real trip, man". "My Big Fat Greek Wedding 2" continues 15 years after the first left off and there's another wedding of course, the need for which develops when Gus notices that his wedding license was not signed. He'd not been married to Maria, played again by Lainie Kazan, officially. The priest will not sign the old certificate, and thus a new wedding must be performed. After the in-your-face family sends the wedding planner running away, they decide to take things in their own hands. You'll just have to see how that works out. Sadly this movie does not capture the magic of the first movie and although there are endearing family moments that are real and to which you may relate, the thin plot and story development fails here, which make it seem like a bunch of family vignettes strung together with no real story, in spite of the two directional elements that story does have: Where the family daughter will go to college and Gus and Maria's marriage. Fringe characters are one dimensional and not developed enough to care about. But for the wonderful and natural performance of Michael Constantine, this picture would have caused me to invoke a real stinkeroo status. It skates just above it. A gyro sandwich is more satisfying.

**NAMI - Yolo Announces Class for Caregivers of Children and Teen with Emotional Difficulties**  
NAMI-Yolo is offering a free six-session education class, NAMI Basics, designed for parents and other caregivers of children and adolescents with emotional and behavioral difficulties. The course is taught by a trained team with lived experience - they know what parents are going through because they’ve been there. The program provides critical strategies for taking care of children with mental illness and helps participants learn the ropes of recovery Basics provides participants current information about attention deficit disorder, major depression, bipolar disorder, conduct disorder, opposition defiant disorder, anxiety disorders, obsessive compulsive disorder, childhood schizophrenia, disordered eating, self-mutilation (cutting) and substance abuse disorders. Participants learn about current treatments, including evidence-based therapies, medications and side effects. They are given an overview of the public mental health care, school and

juvenile justice systems and learn how to manage crises, solve problems and communicate effectively. In addition to discussions of the clinical treatment of mental illnesses, guidance will be given on locating appropriate supports and services within the community. Participants gain the knowledge and skills needed to cope effectively with the impacts that mental illness has on their child and family as they gain tools for making the best decisions possible for their child’s care. During the class, participants also learn to take care of themselves and to handle stress as they develop the confidence and stamina to support their child with compassion. They also gain an understanding of the challenges and impact of mental health conditions on the entire family and learn how to advocate for their child’s rights at school and in health care settings. The Basics class will be offered in Woodland Monday evenings from 6:30-9 p.m., April 18, through May 26. Pre-registration is required. 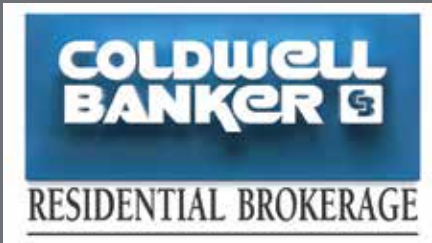

Mustard Seed is a free, private school for homeless children 3-15 years old which provides a safe, nurturing and structured environment, a positive learning experience, happy memories, survival resources of food, clothing and shelter referrals, medical and dental screenings, immunization updates, counseling for children and their parents, and assistance entering or reentering public schools.

Mustard Seed School was established in 1989 to help meet the needs of homeless children. Many school age children do not attend school because of their homelessness; some lack immunizations, birth certificates, or other documents, some are in transit, and almost all lack a support system. In spite of their situations these children are eager to learn and to be accepted.

Many homeless children are not enrolled in school because the places their families find to sleep are often not near a child's school and the family only plans to be there a short time. Sometimes the school needs an address or updated immunizations which homeless families cannot provide.

From fifteen to thirty-five children may not attend our school each day, and an average stay is just three to four weeks. Some children have been out of school for a long time and need help to go back. A major goal of the Program is to prepare and enroll homeless children into public schools, and preschool for younger children, when families have found housing stability. Since the school began, over 4500 individual children have participated in Mustard Seed.
